FIG. 2 is a front view of an icon, shown separately for ease of visibility;

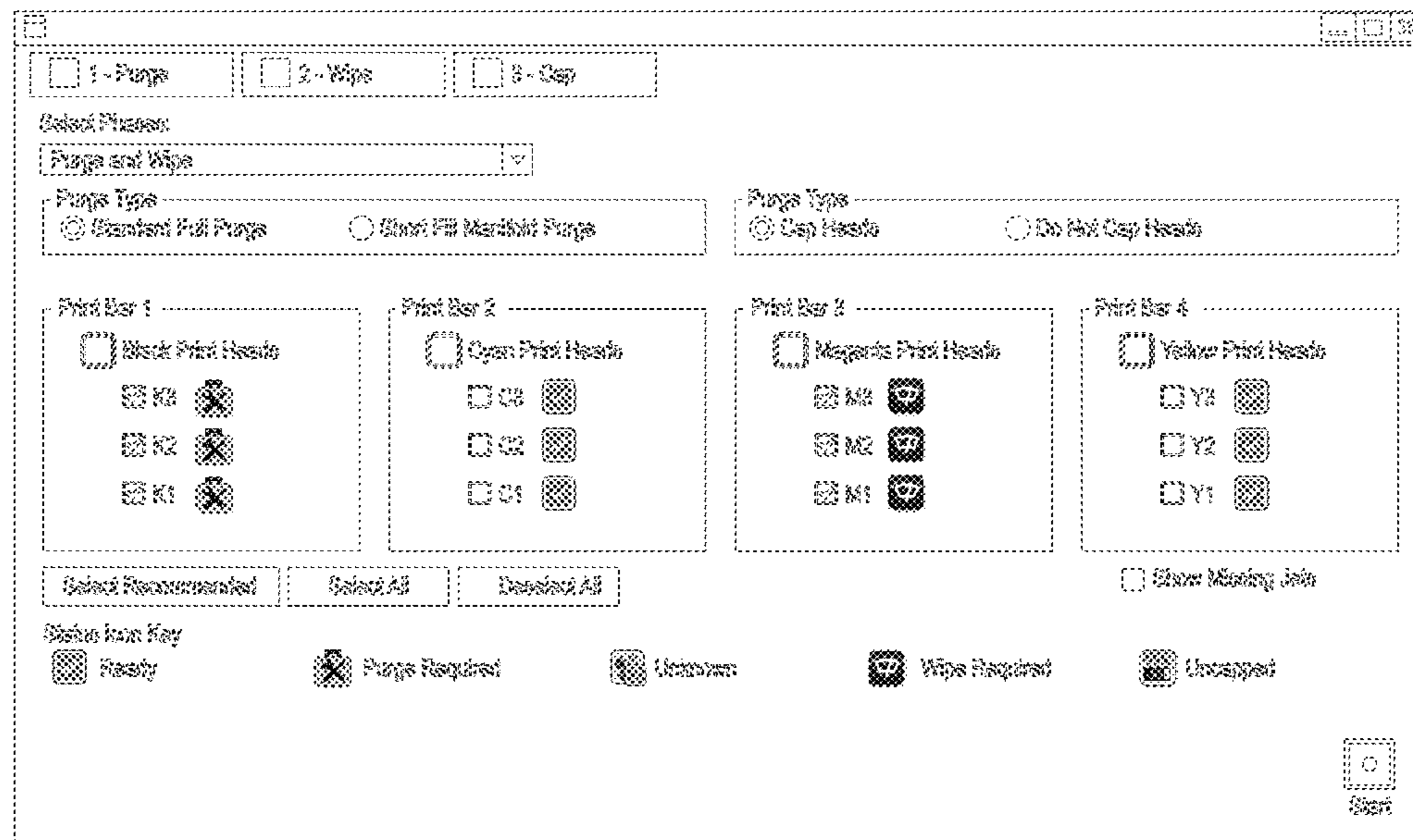
FIG. 3 is a front view of an icon, shown separately for ease of visibility;

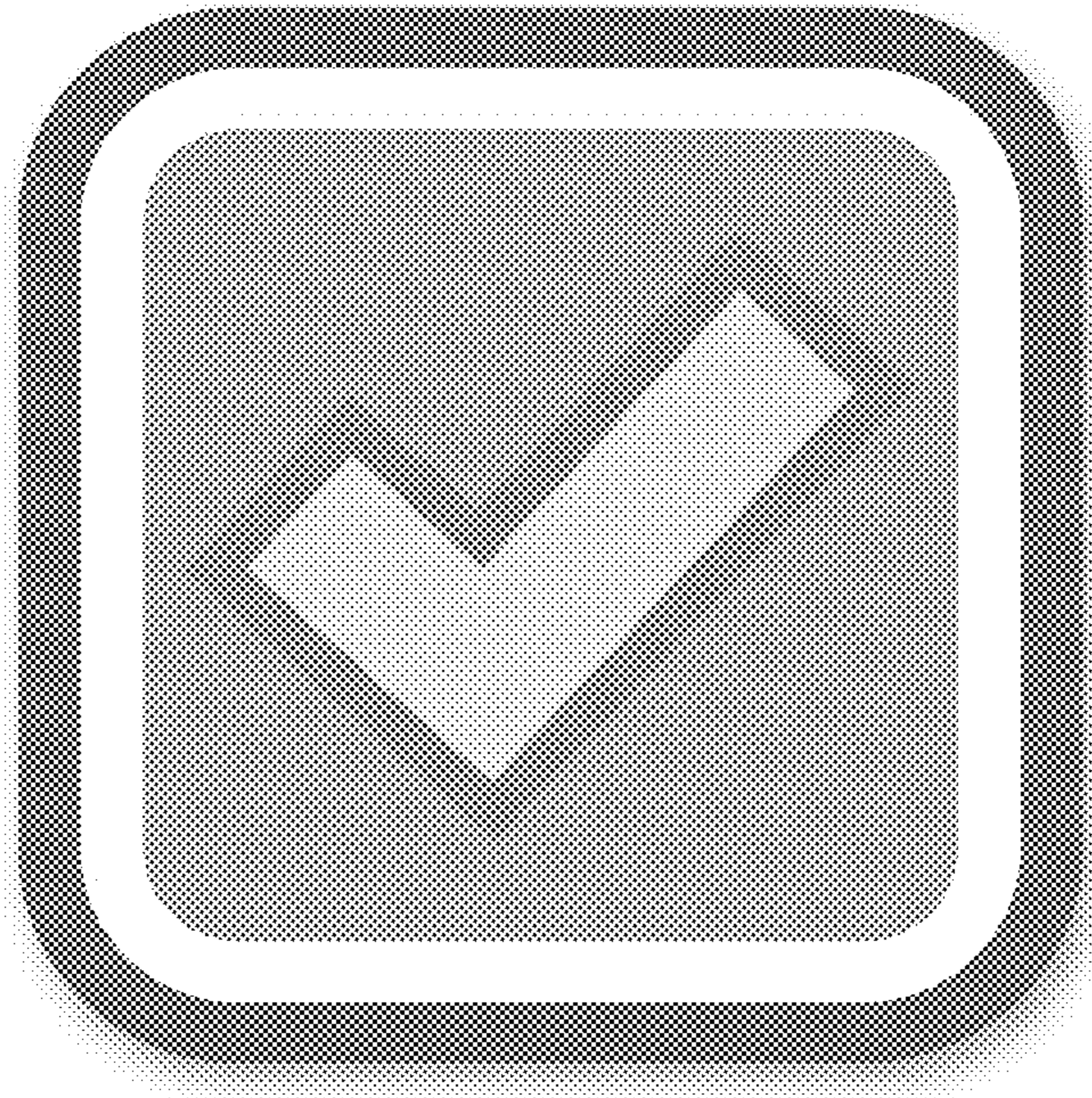

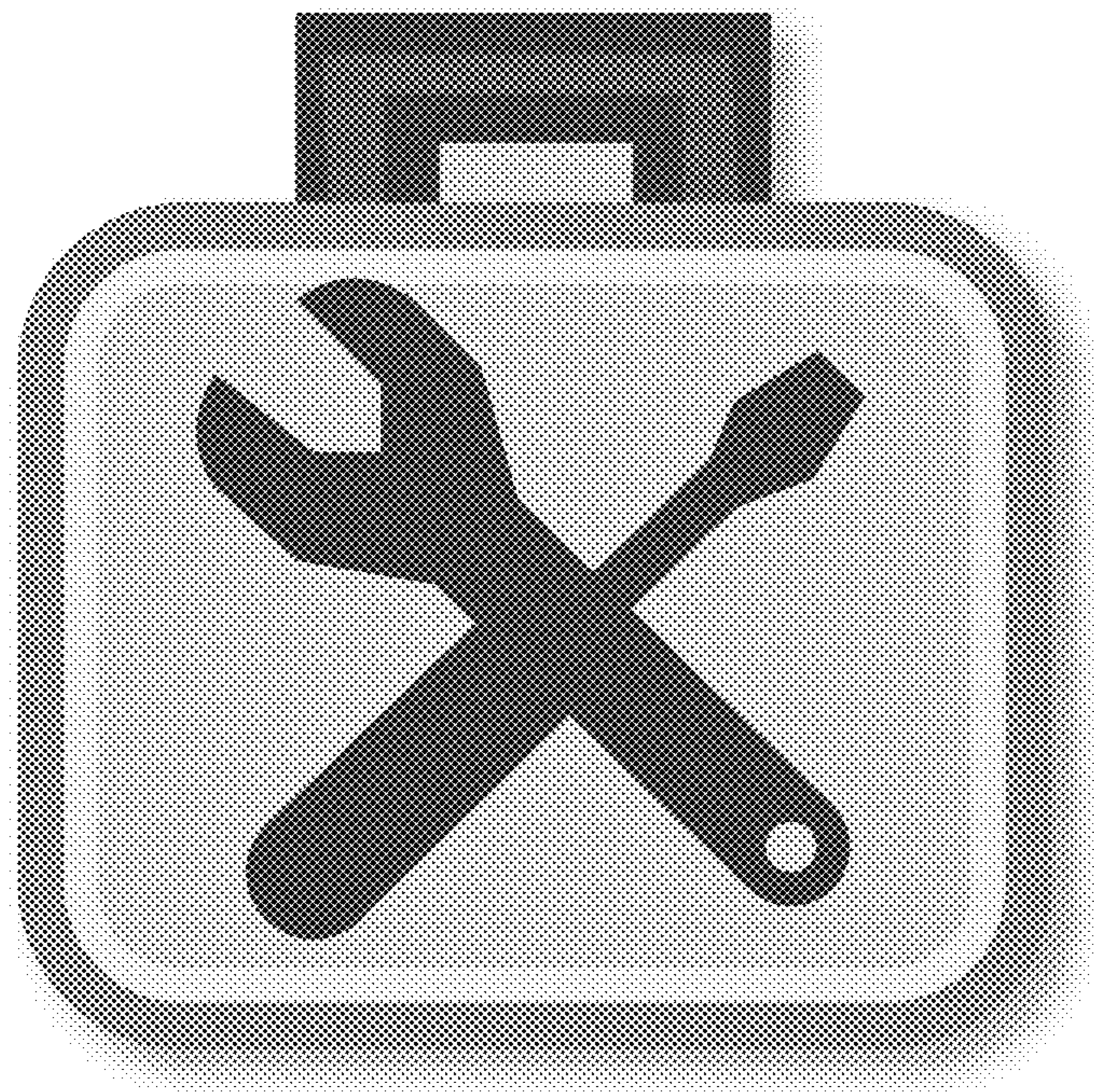

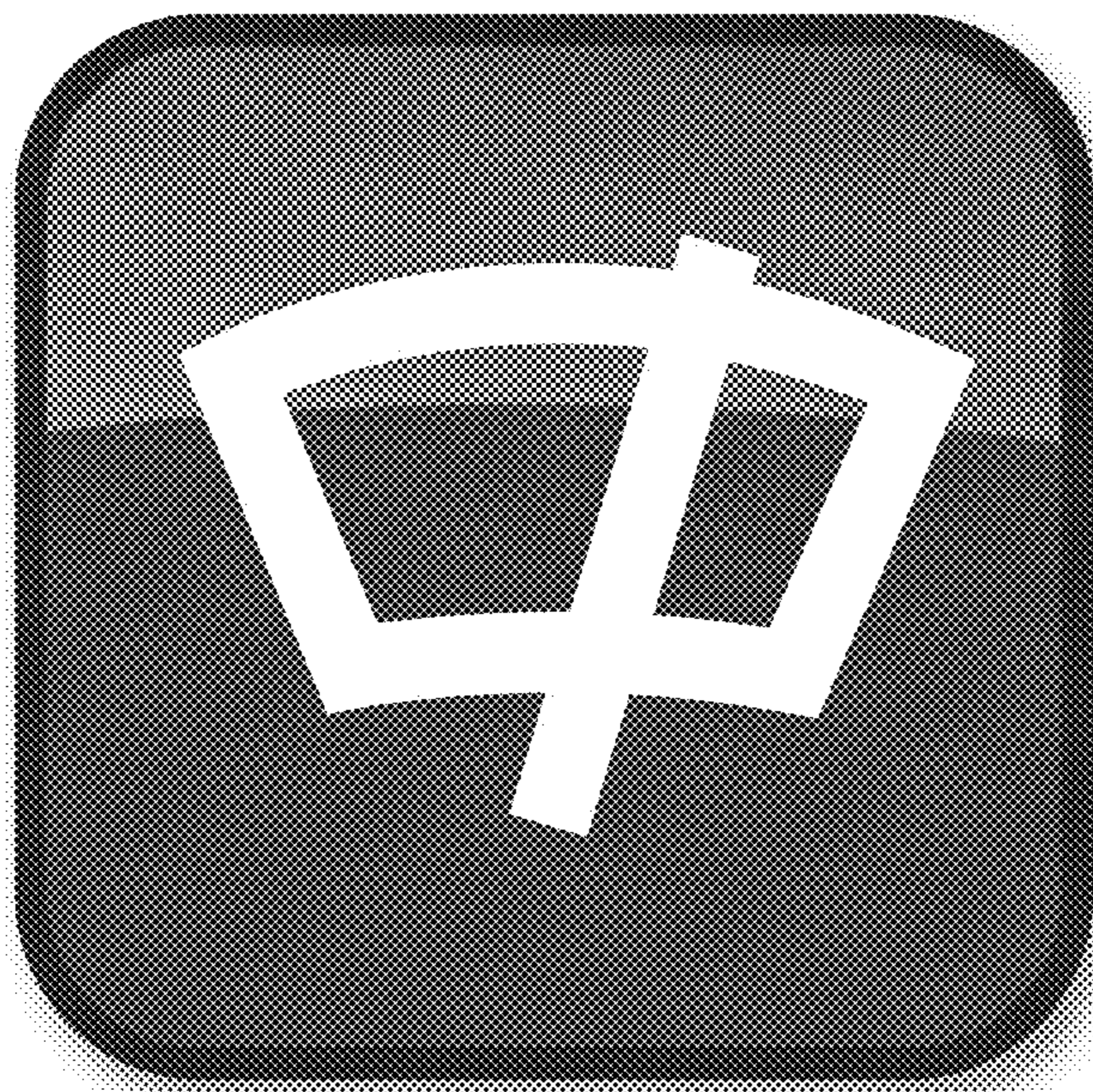

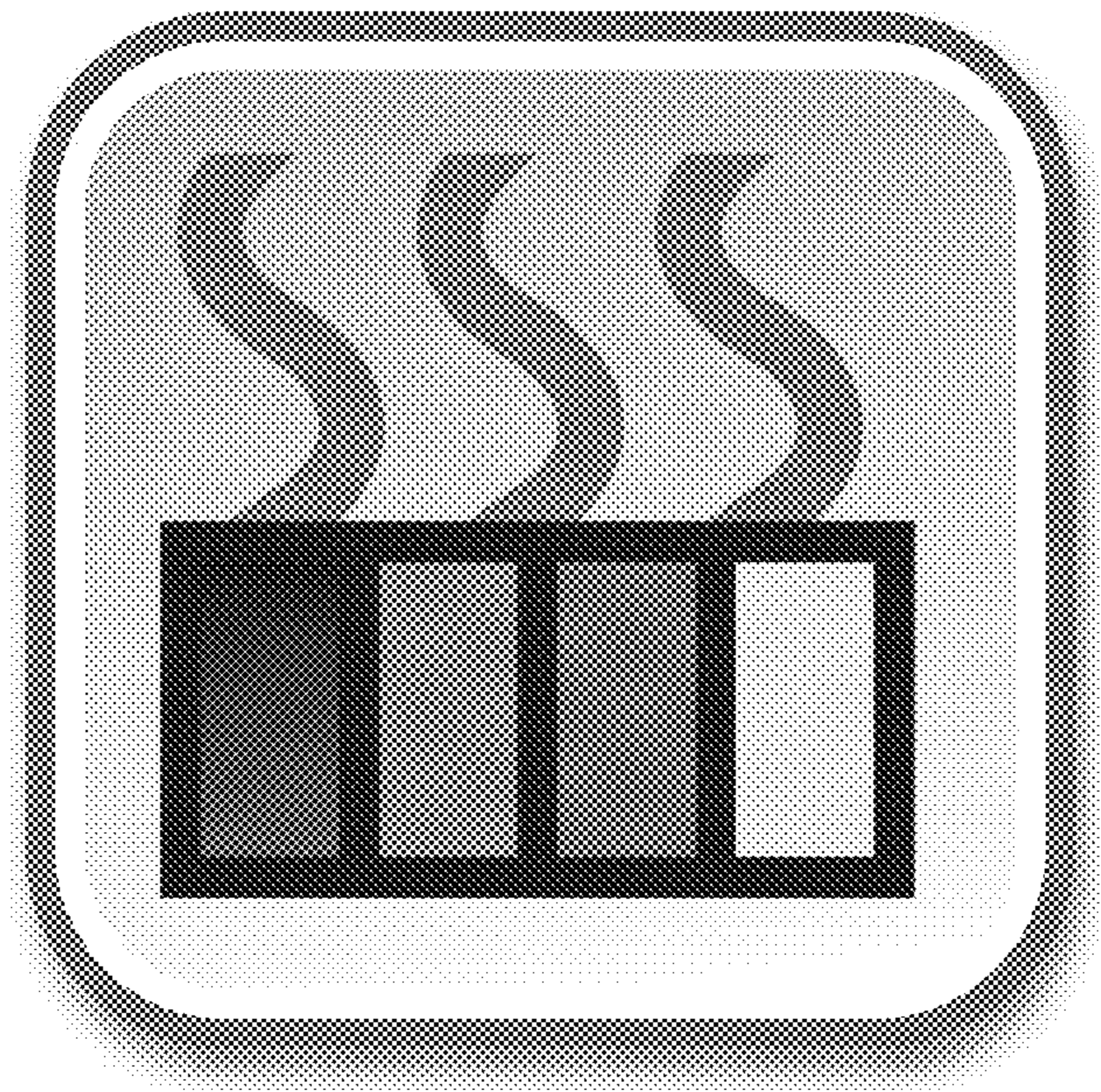

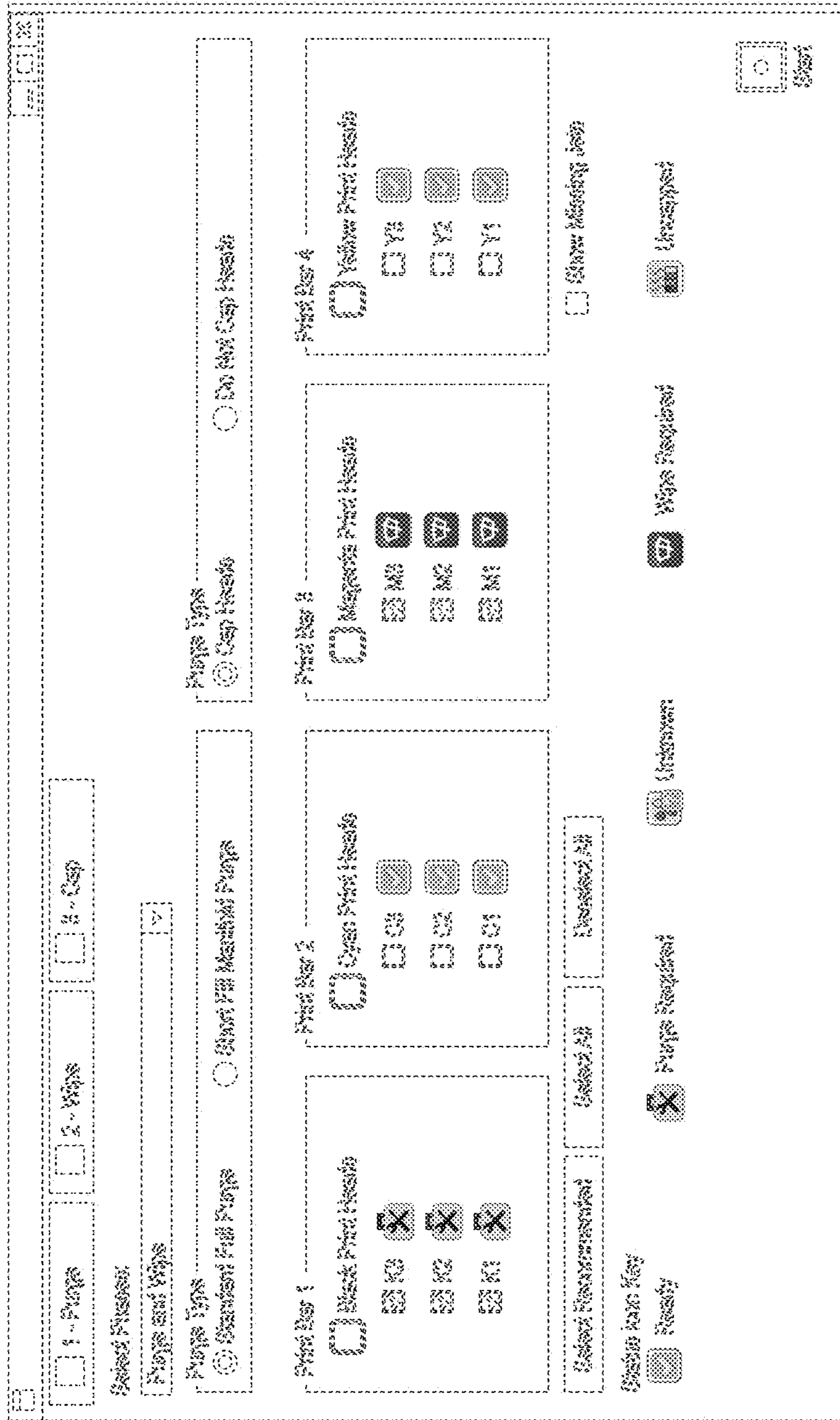
