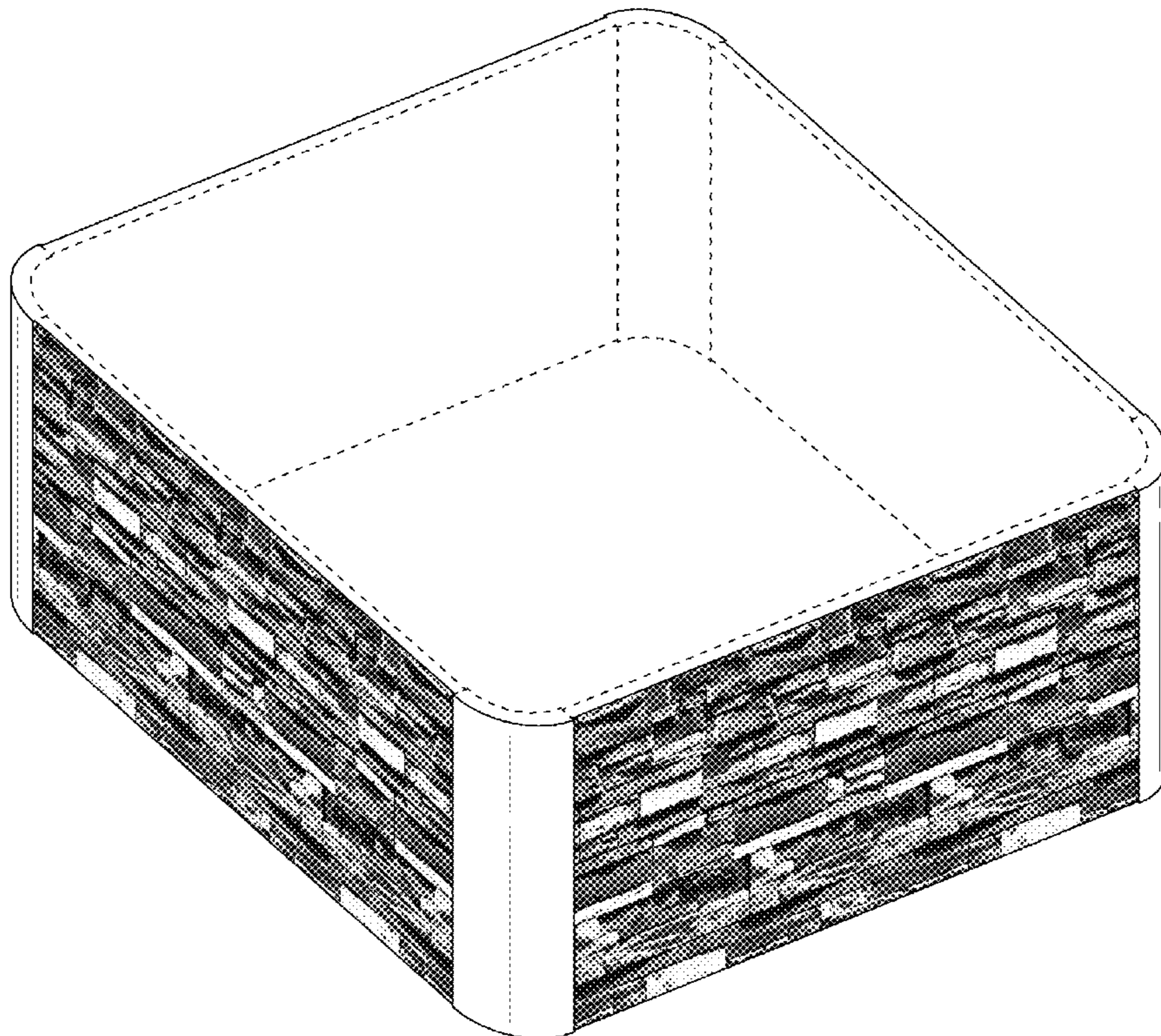
The ornamental design for a hot tub with decorative exterior panel, as shown and described.

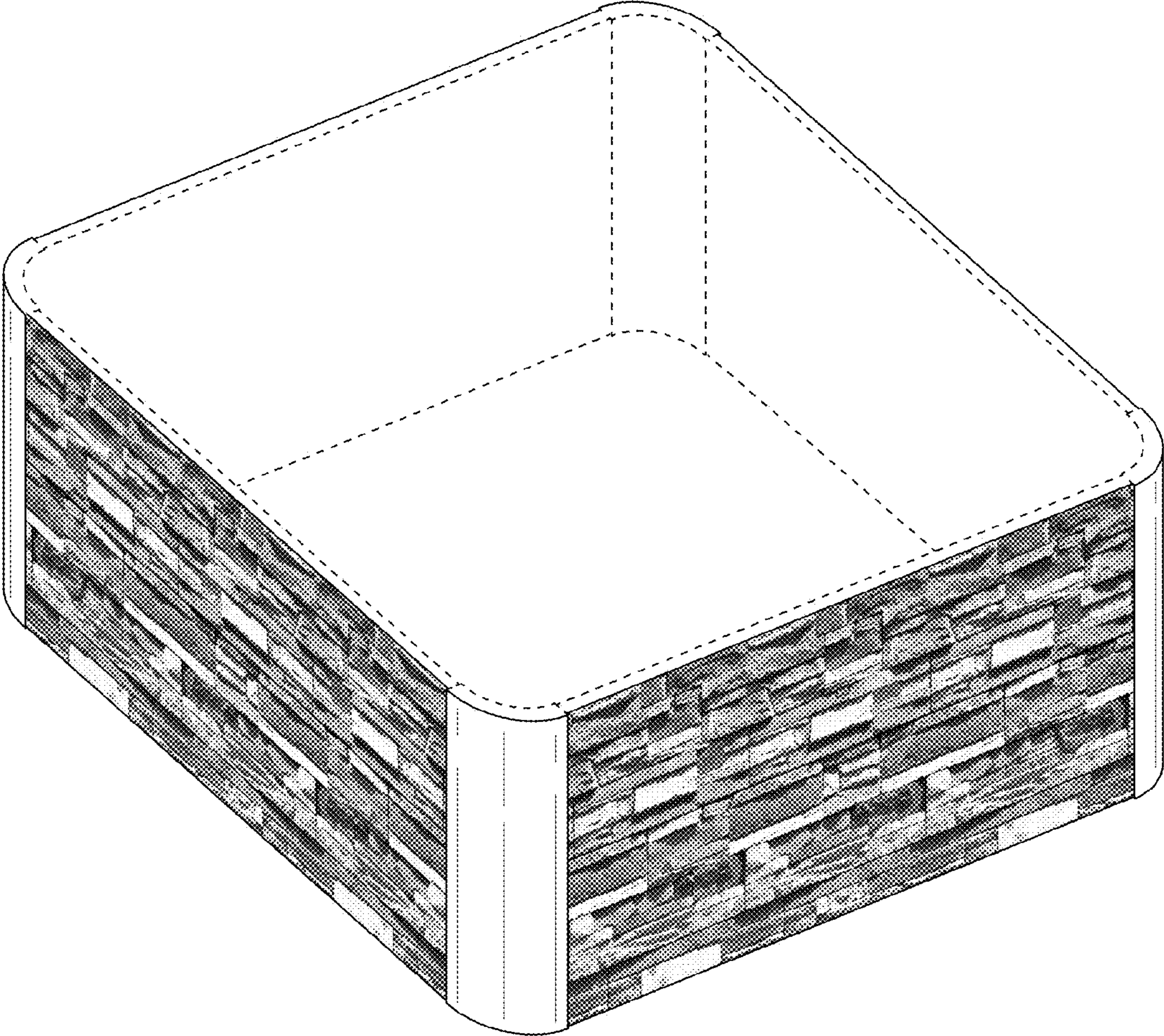

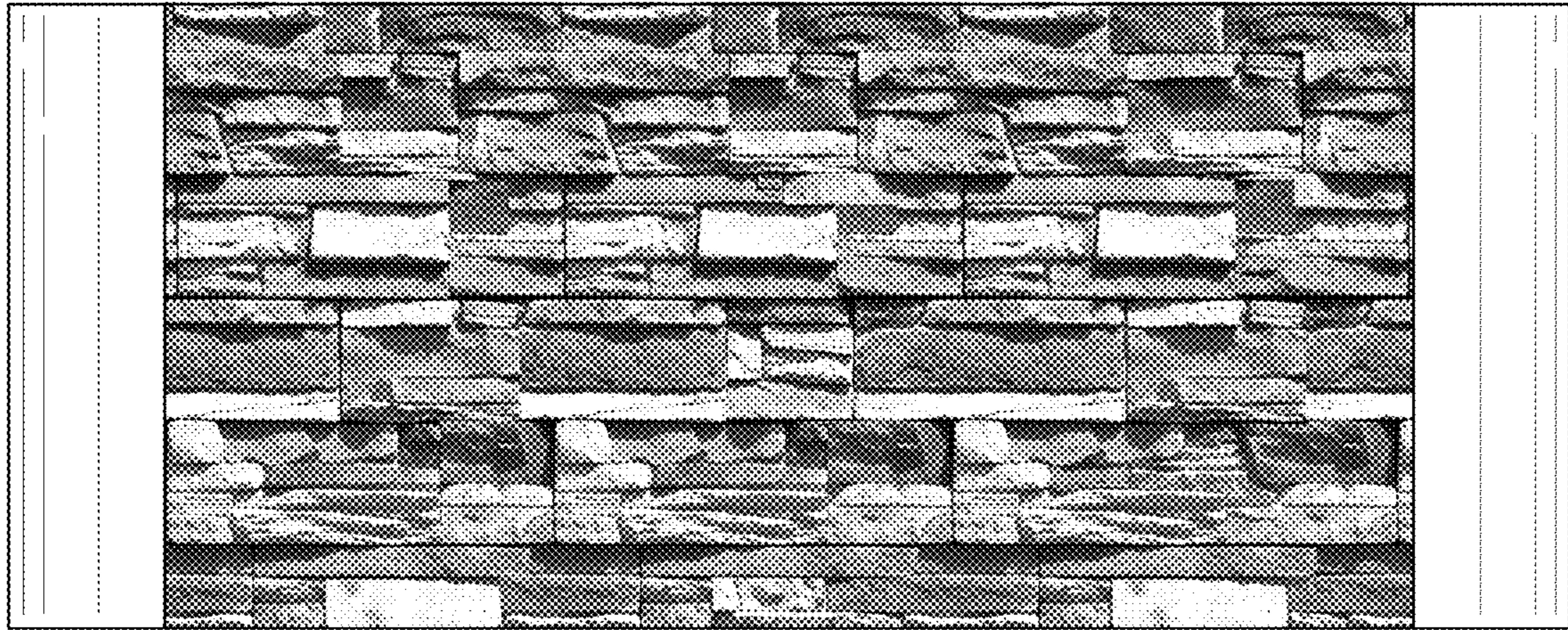

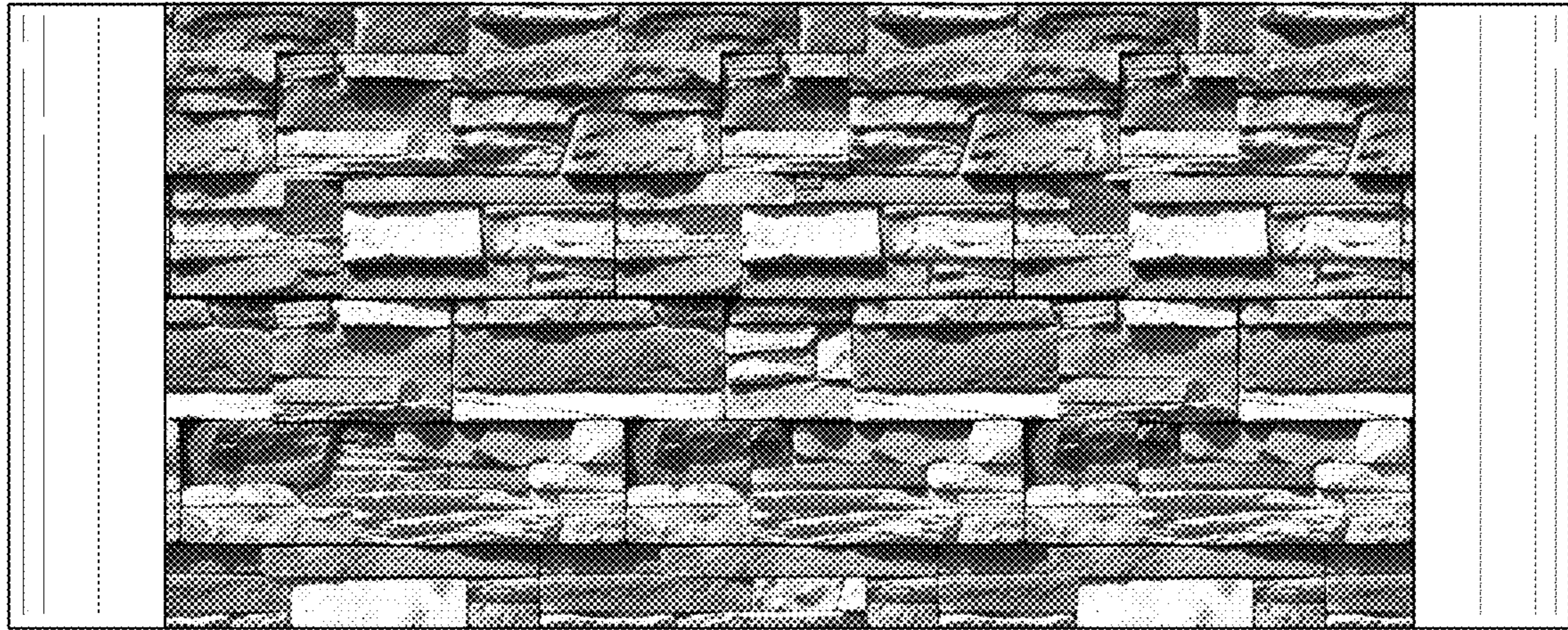

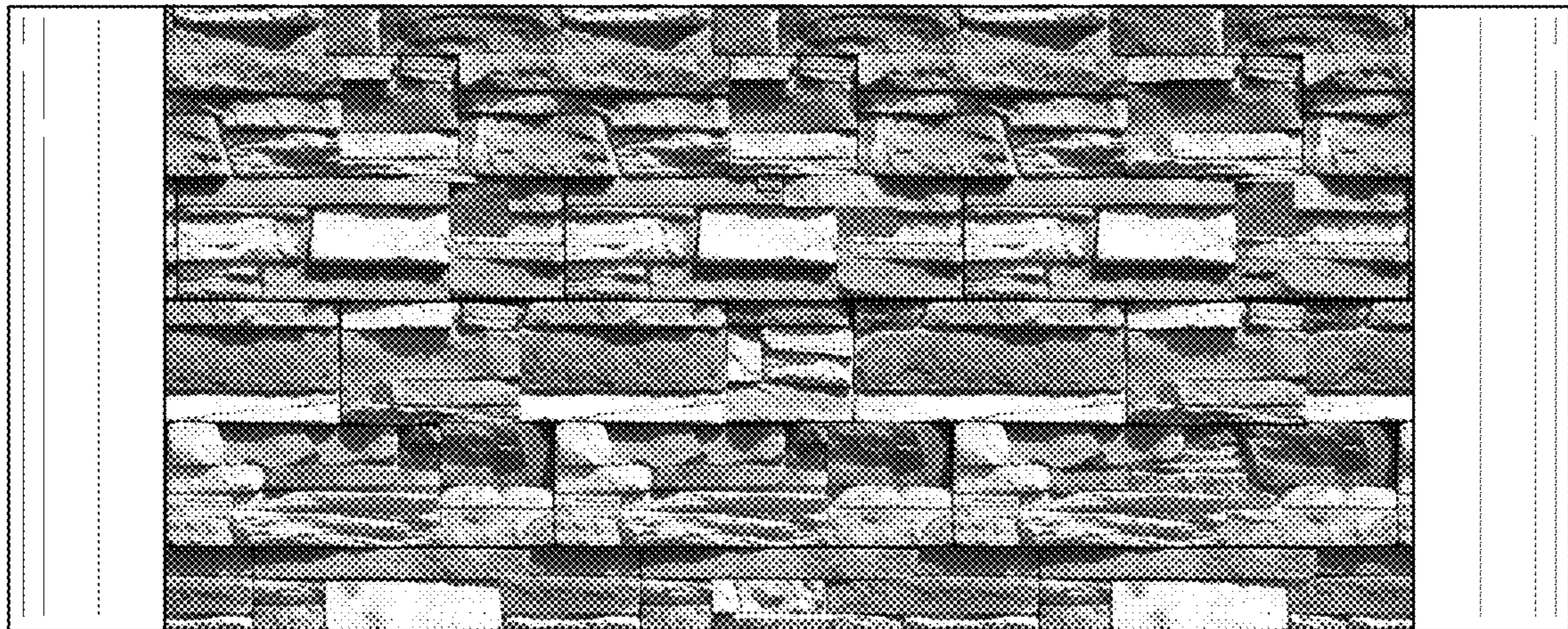

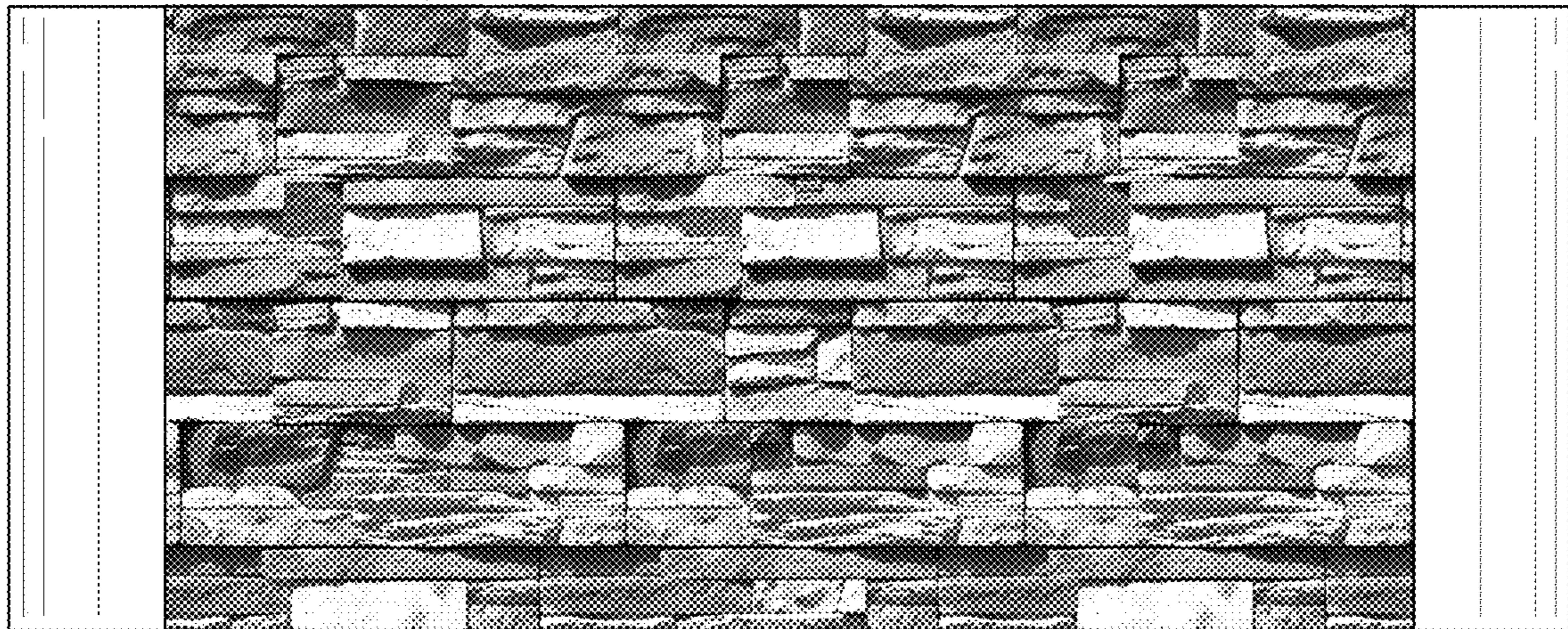

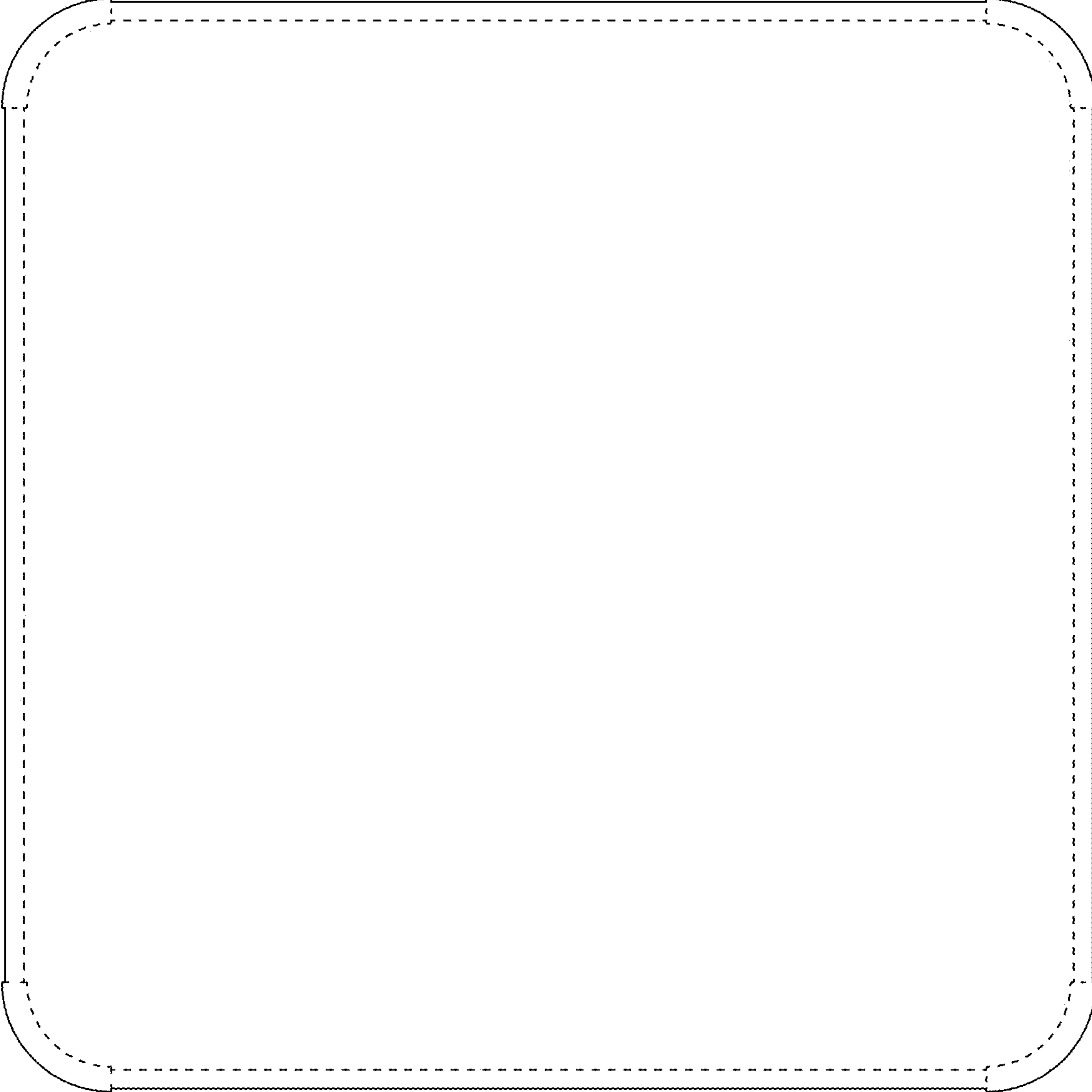

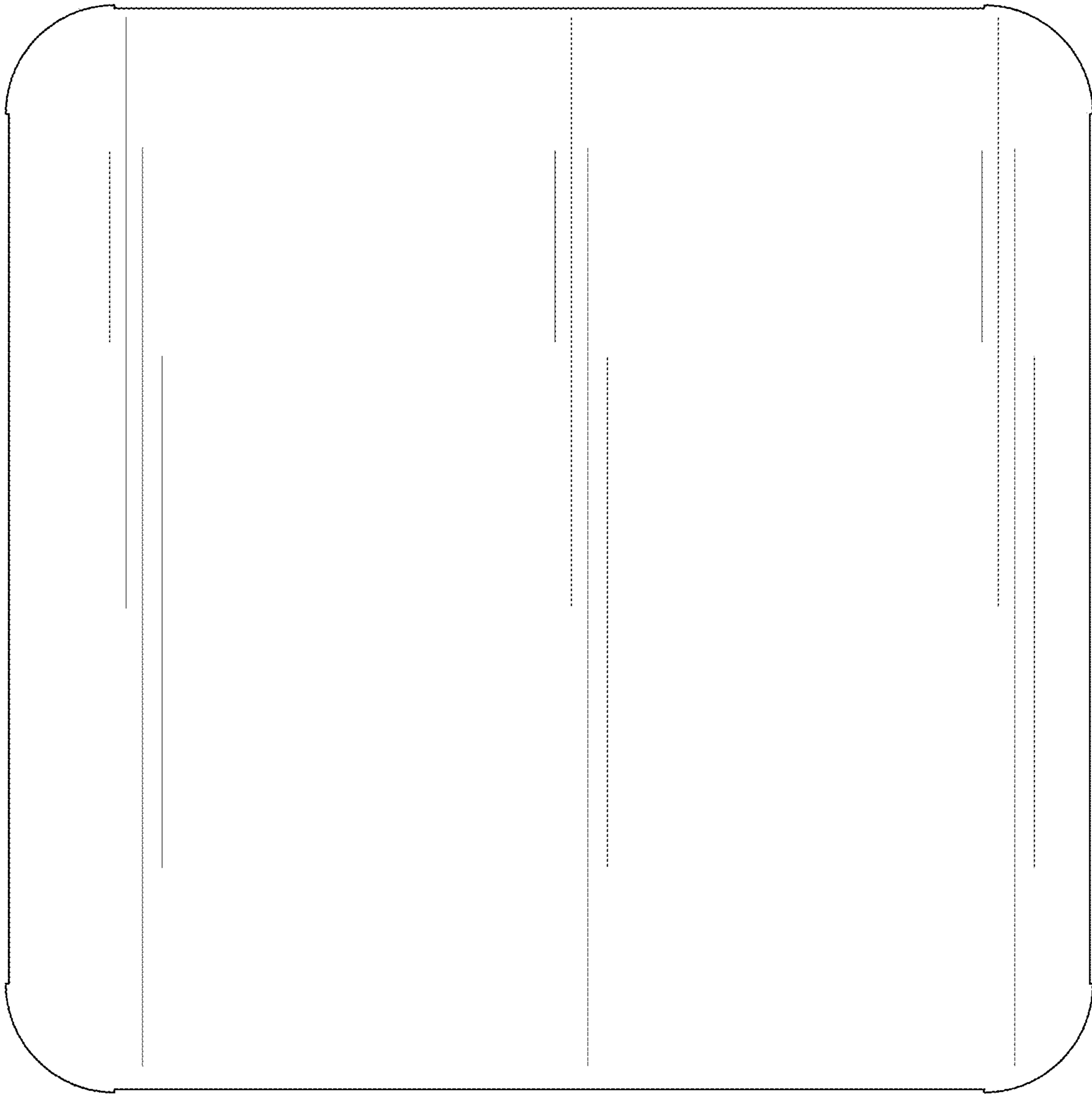
