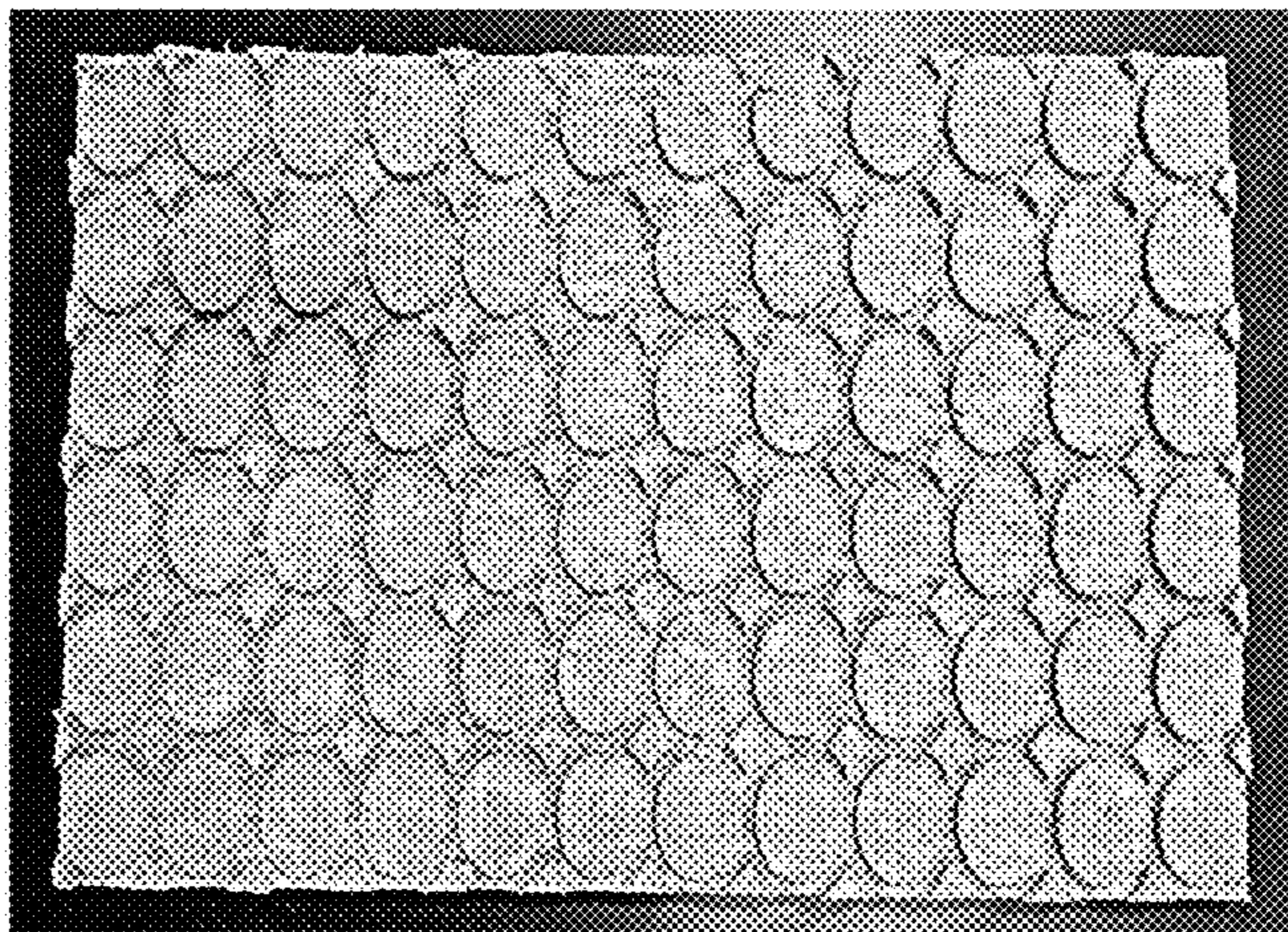
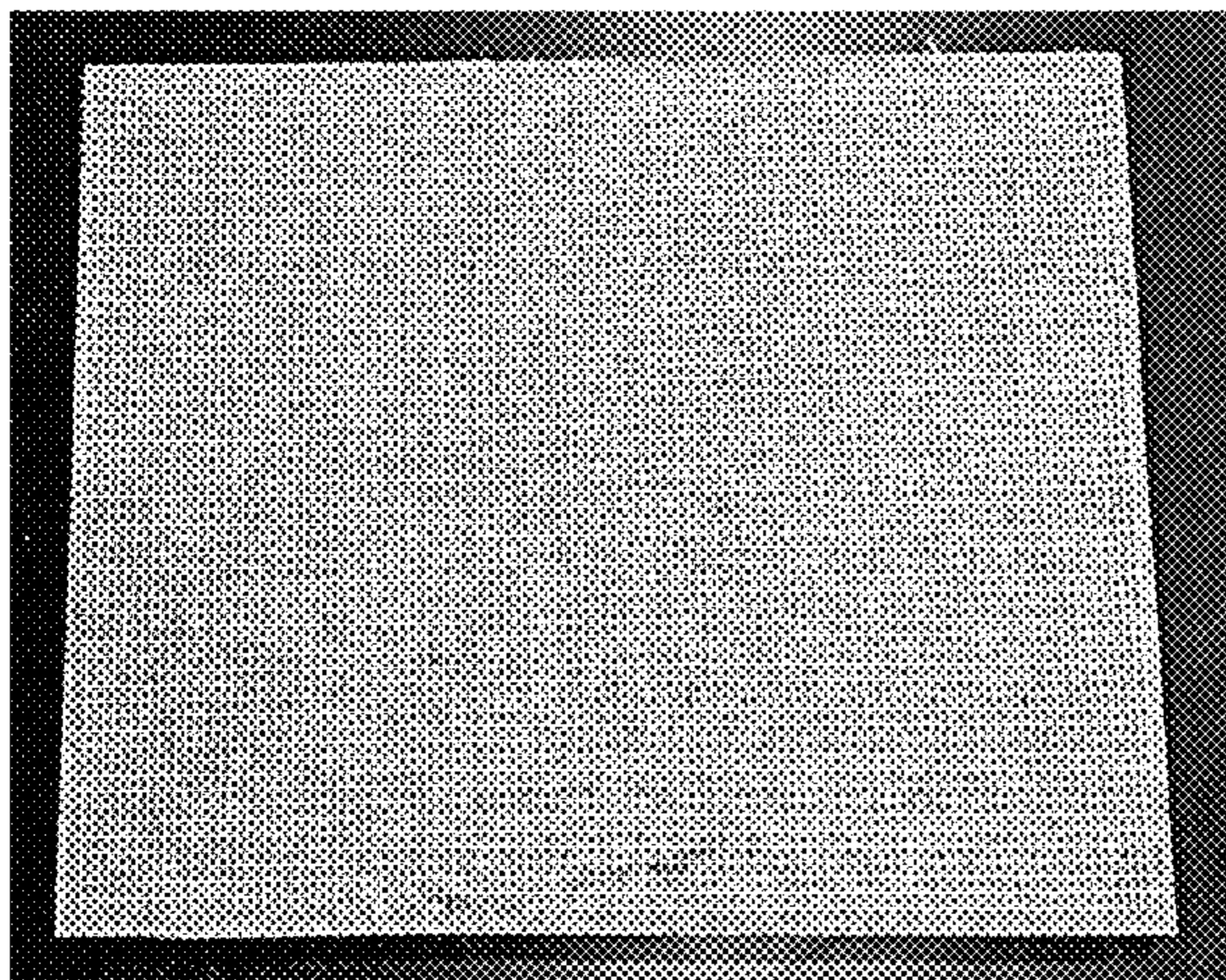
(57) **CLAIM**

The ornamental design for a mineral wool insulation board with reinforcing mesh, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of the mineral wool insulation board with reinforcing mesh design; FIG. 2 is a rear elevational view thereof; FIG. 3 is a bottom and/or top view thereof; FIG. 4 is a left and/or right view thereof; FIG. 5 is a front perspective view thereof; and, FIG. 6 is a rear perspective view thereof.

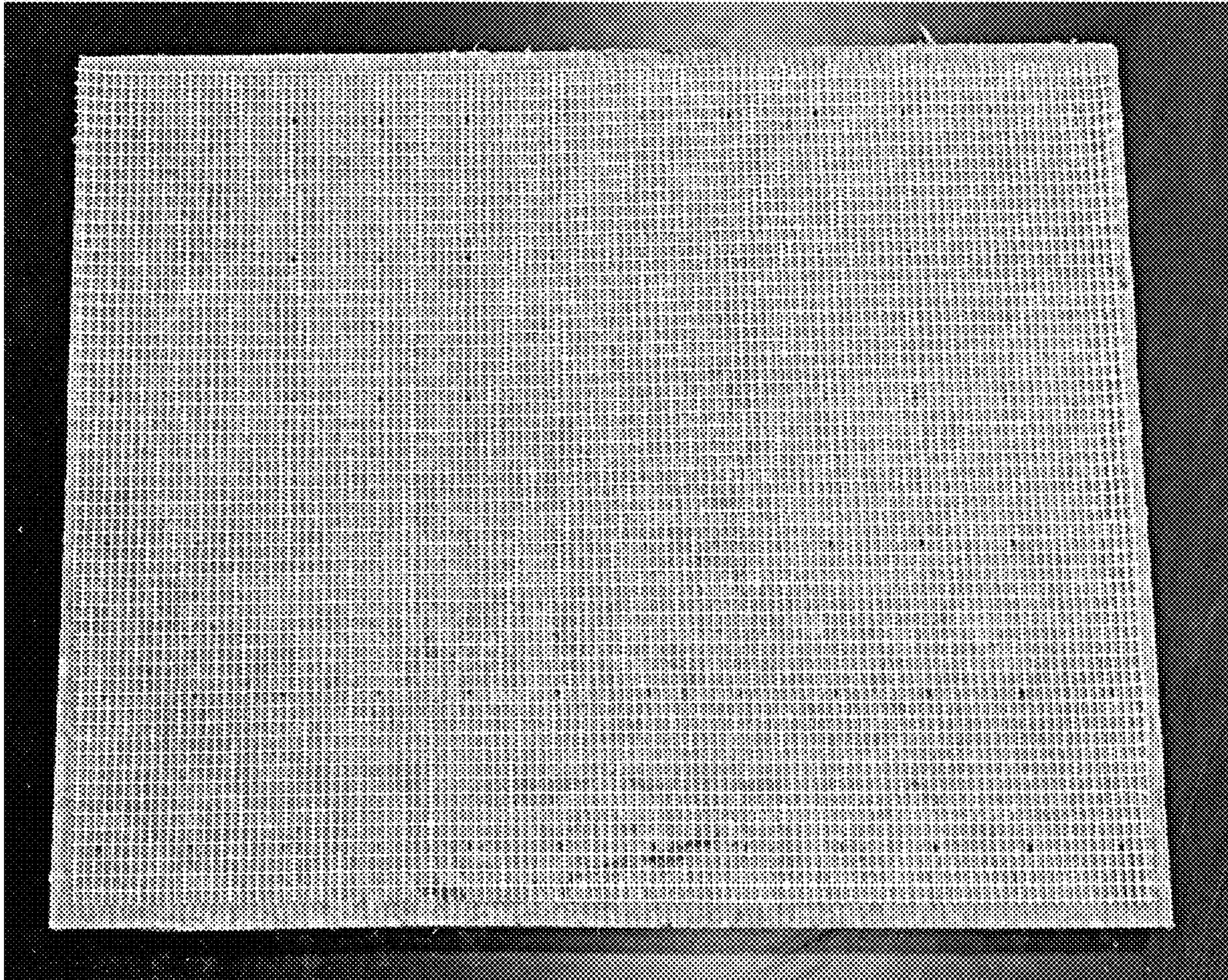

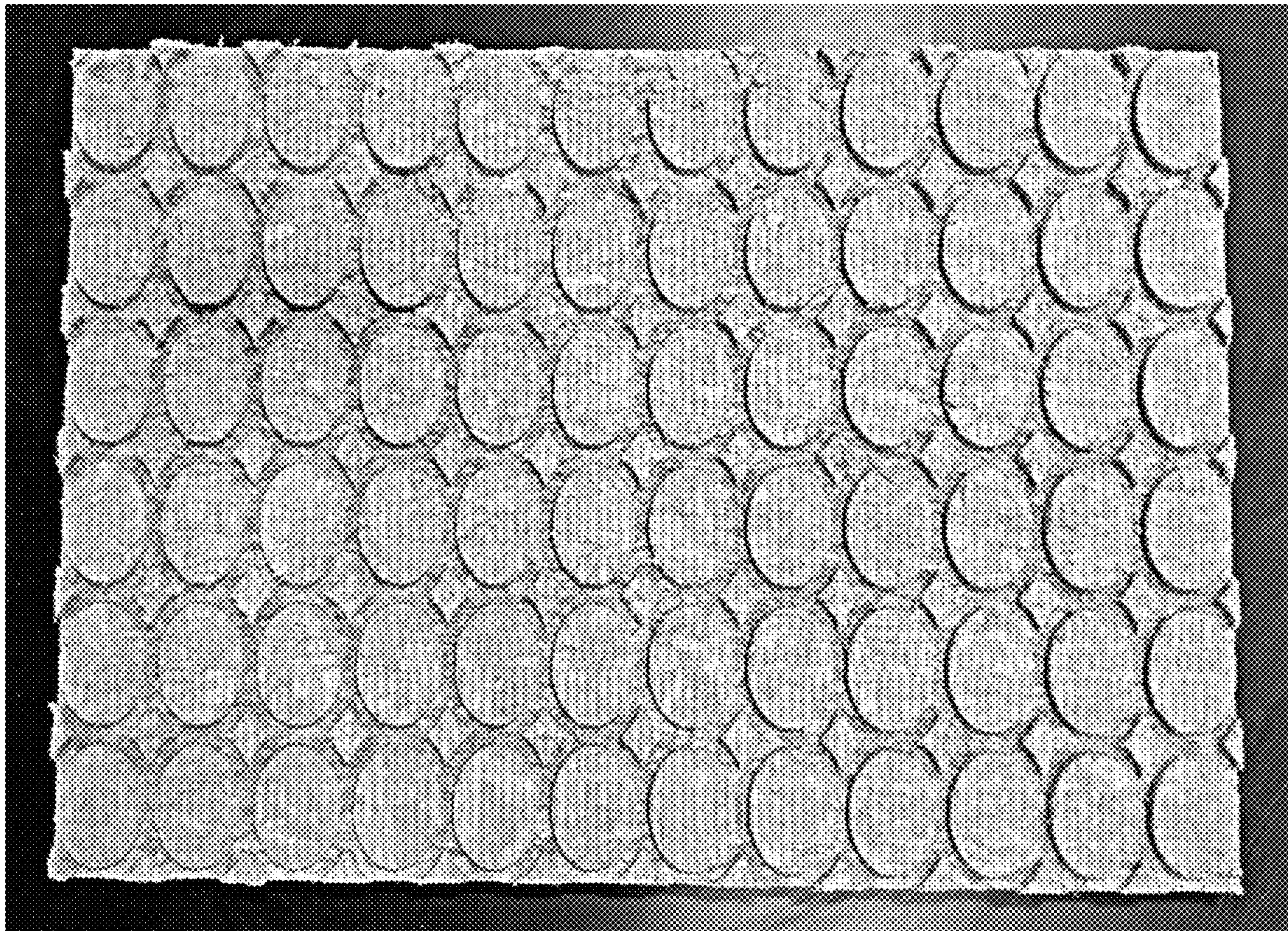

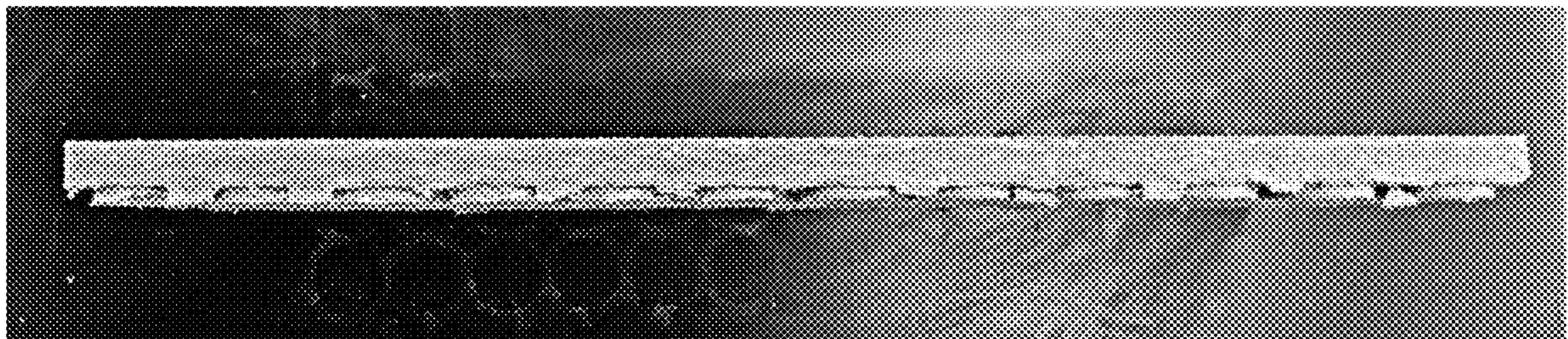

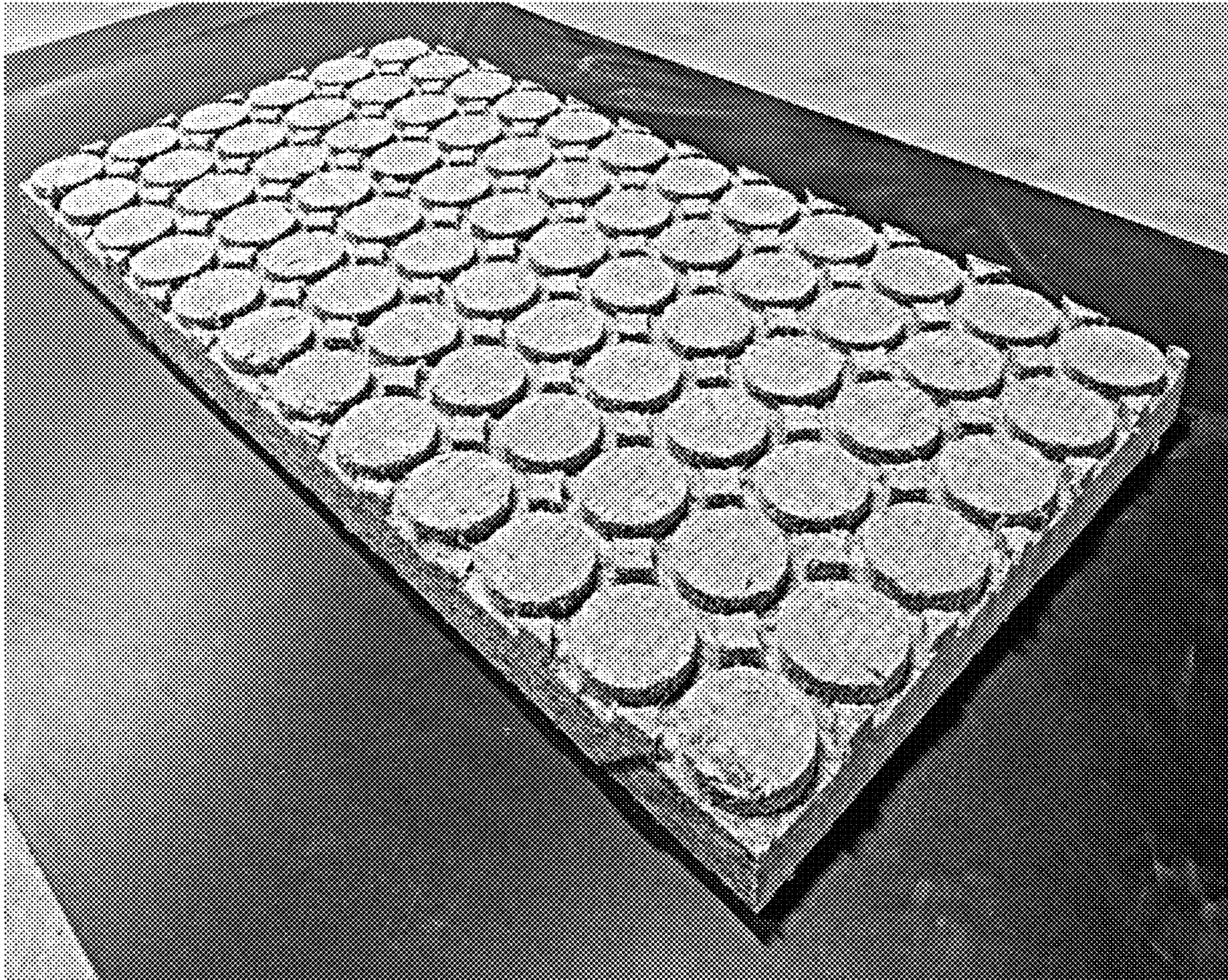
