(57) **CLAIM**

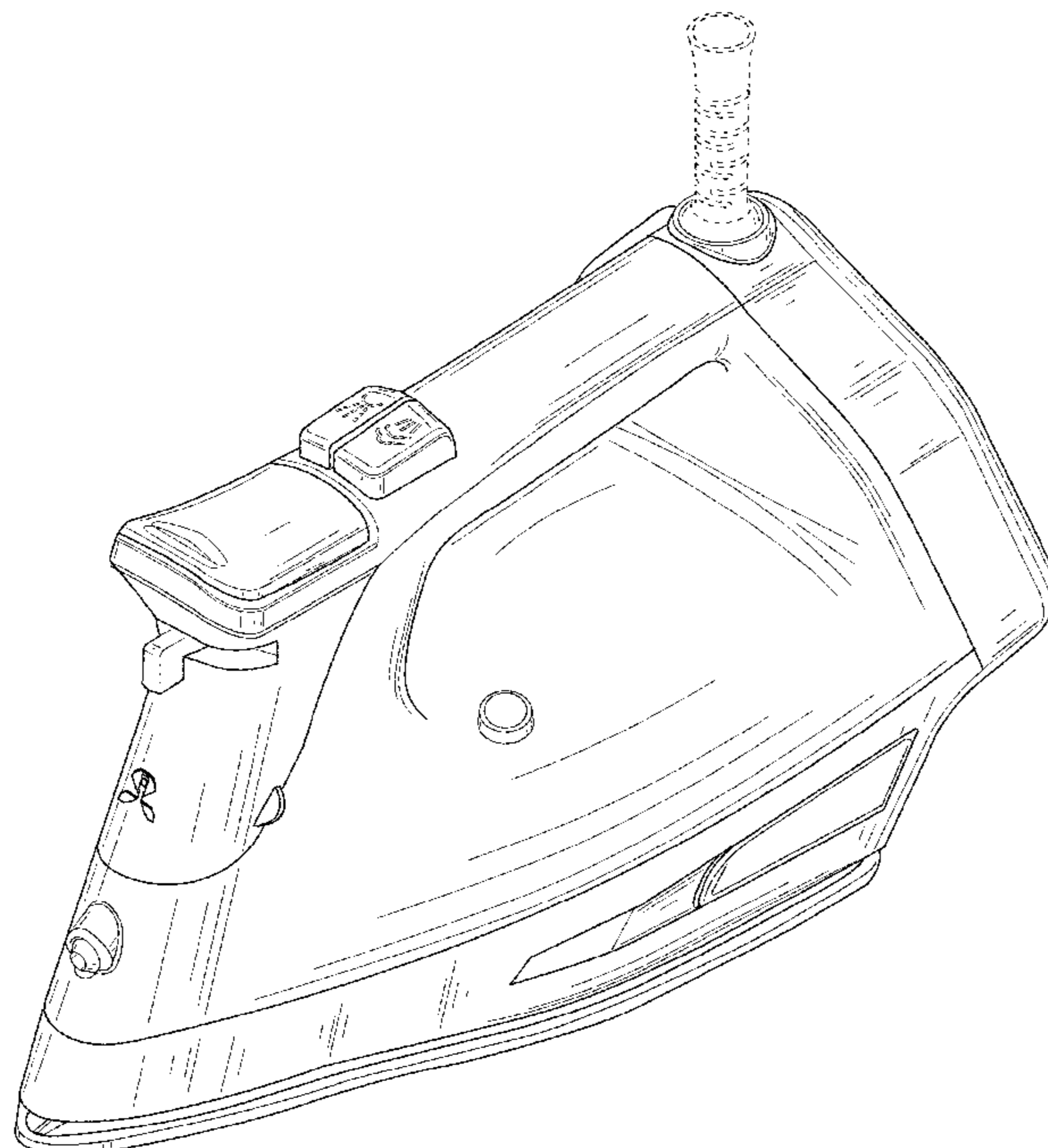
I claim the ornamental design for an iron, as shown and described.

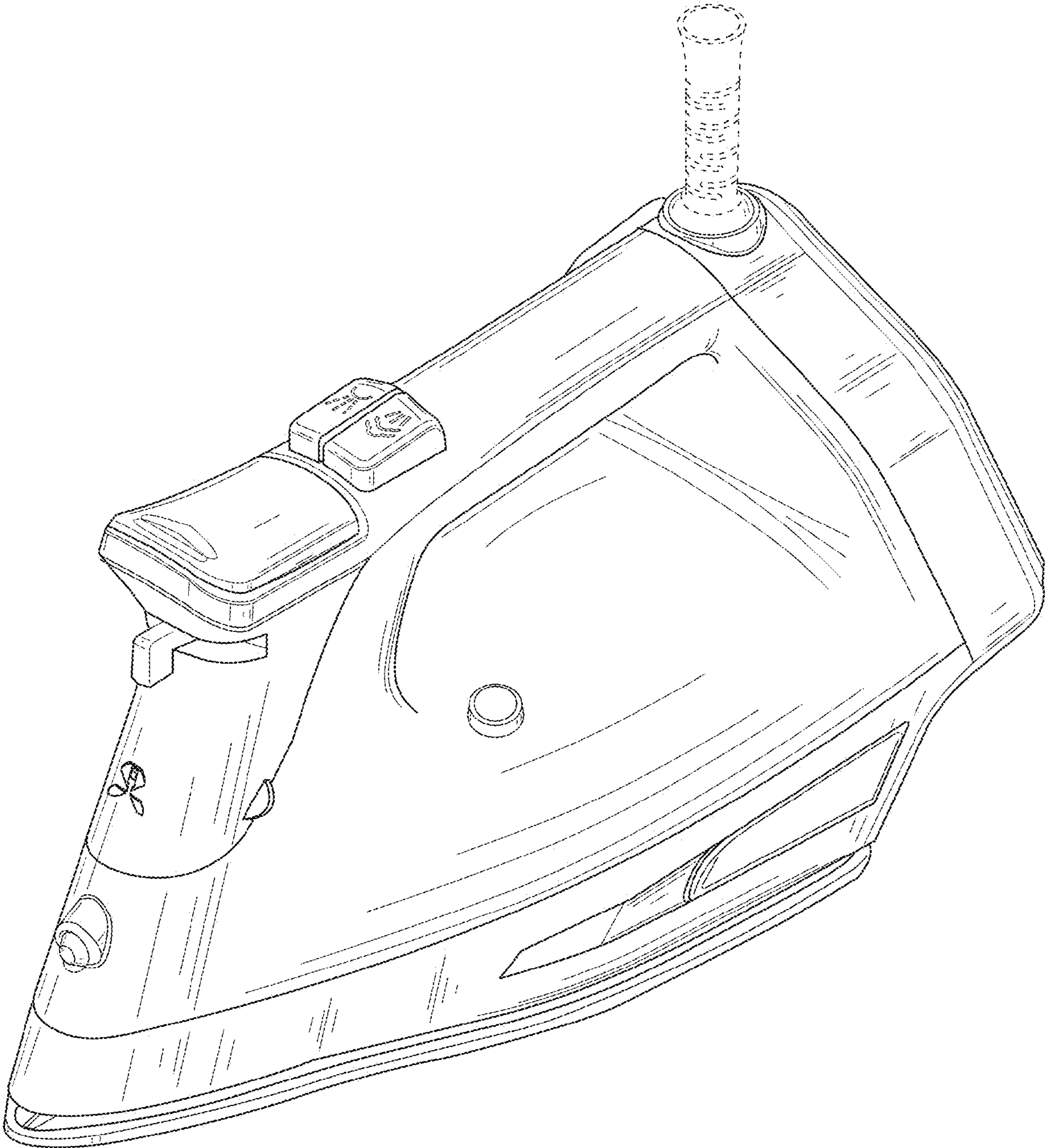

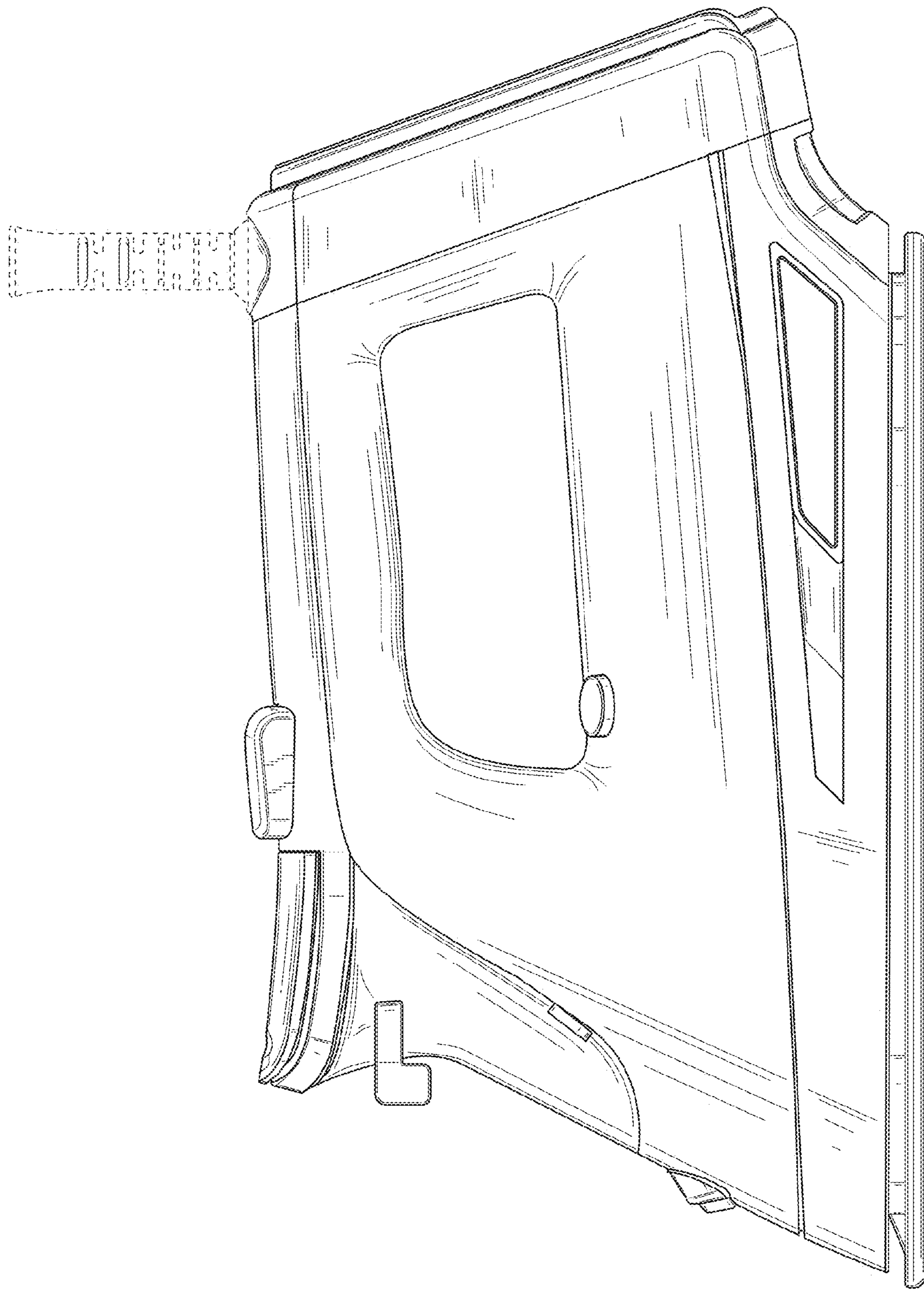

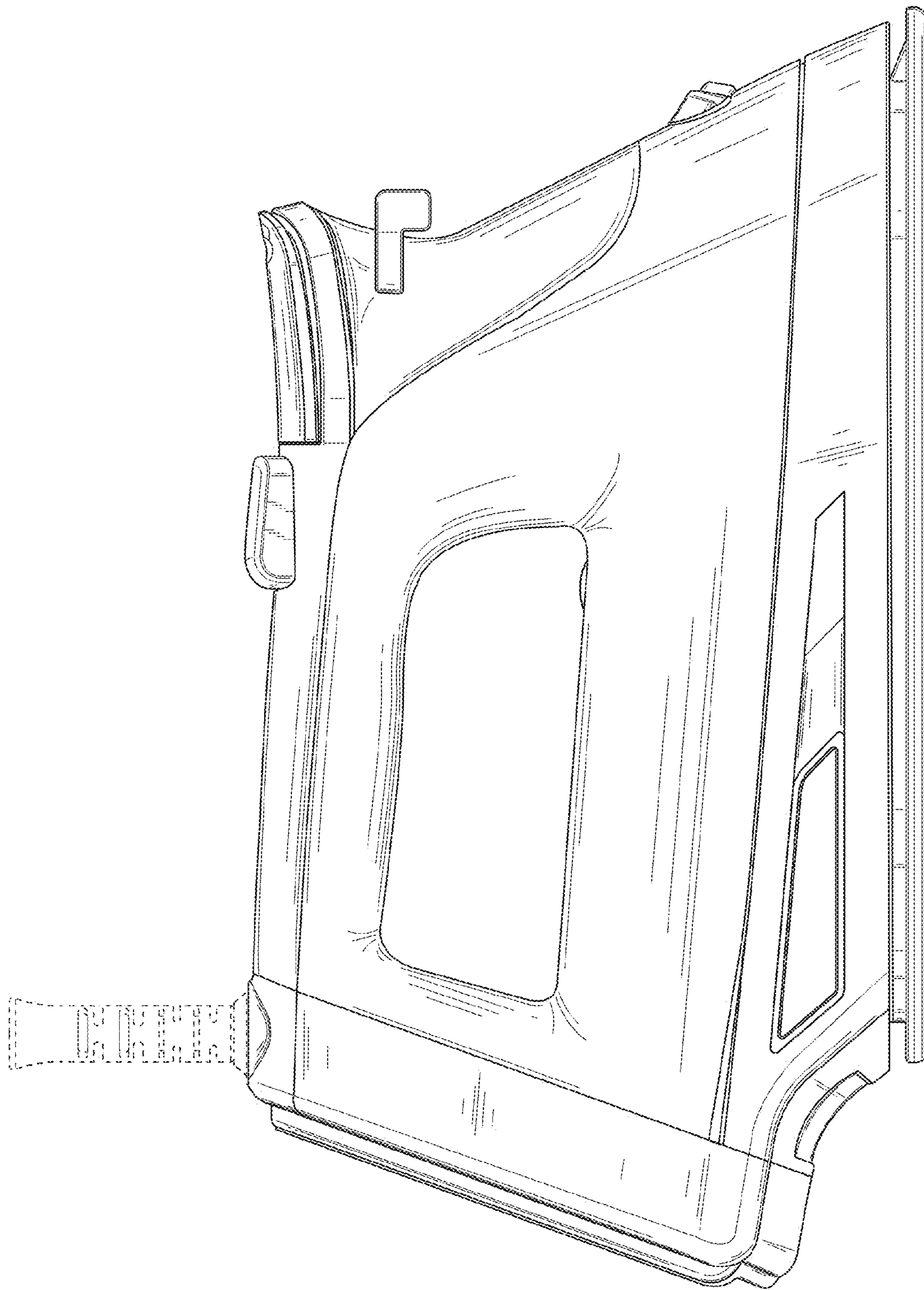

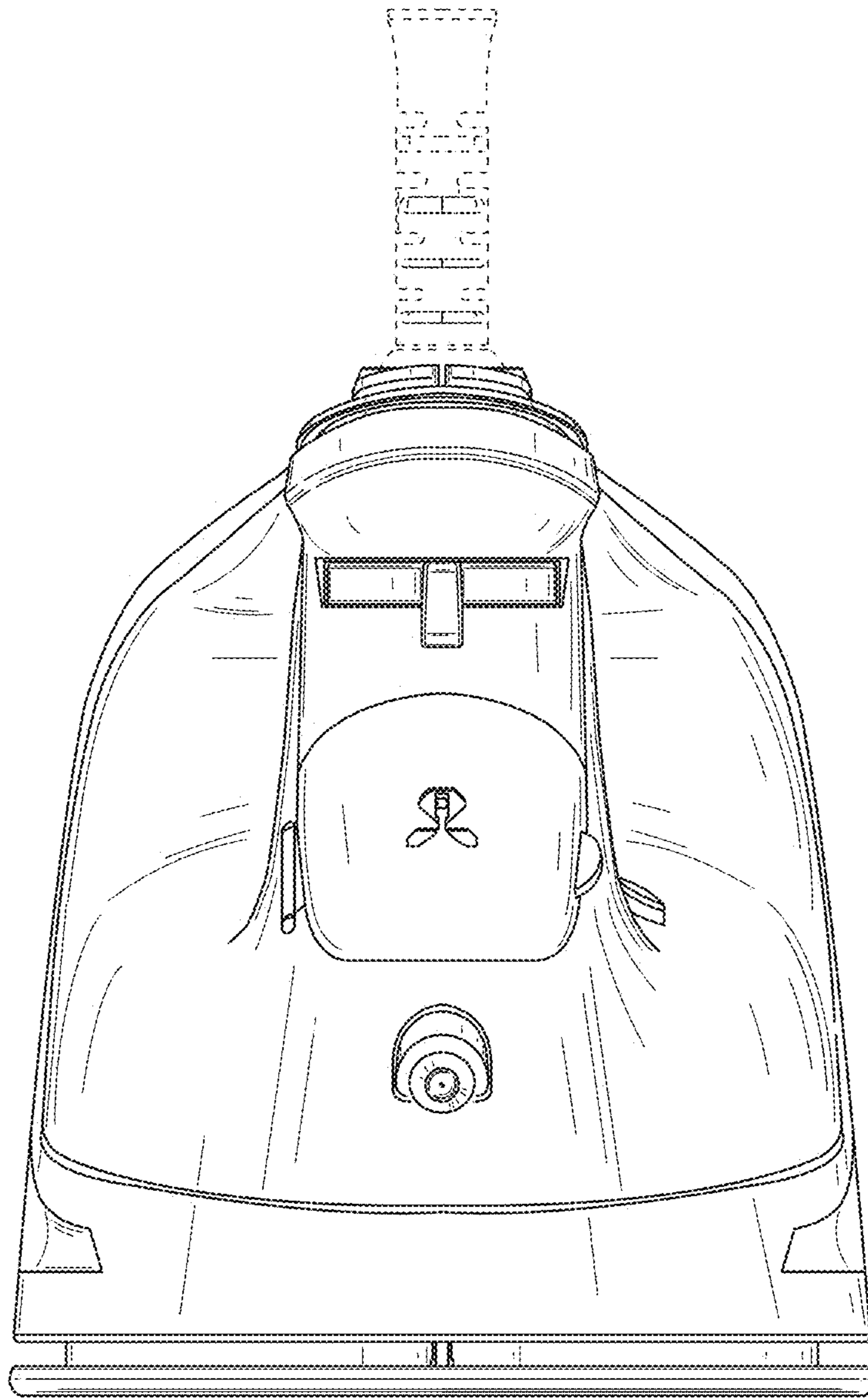

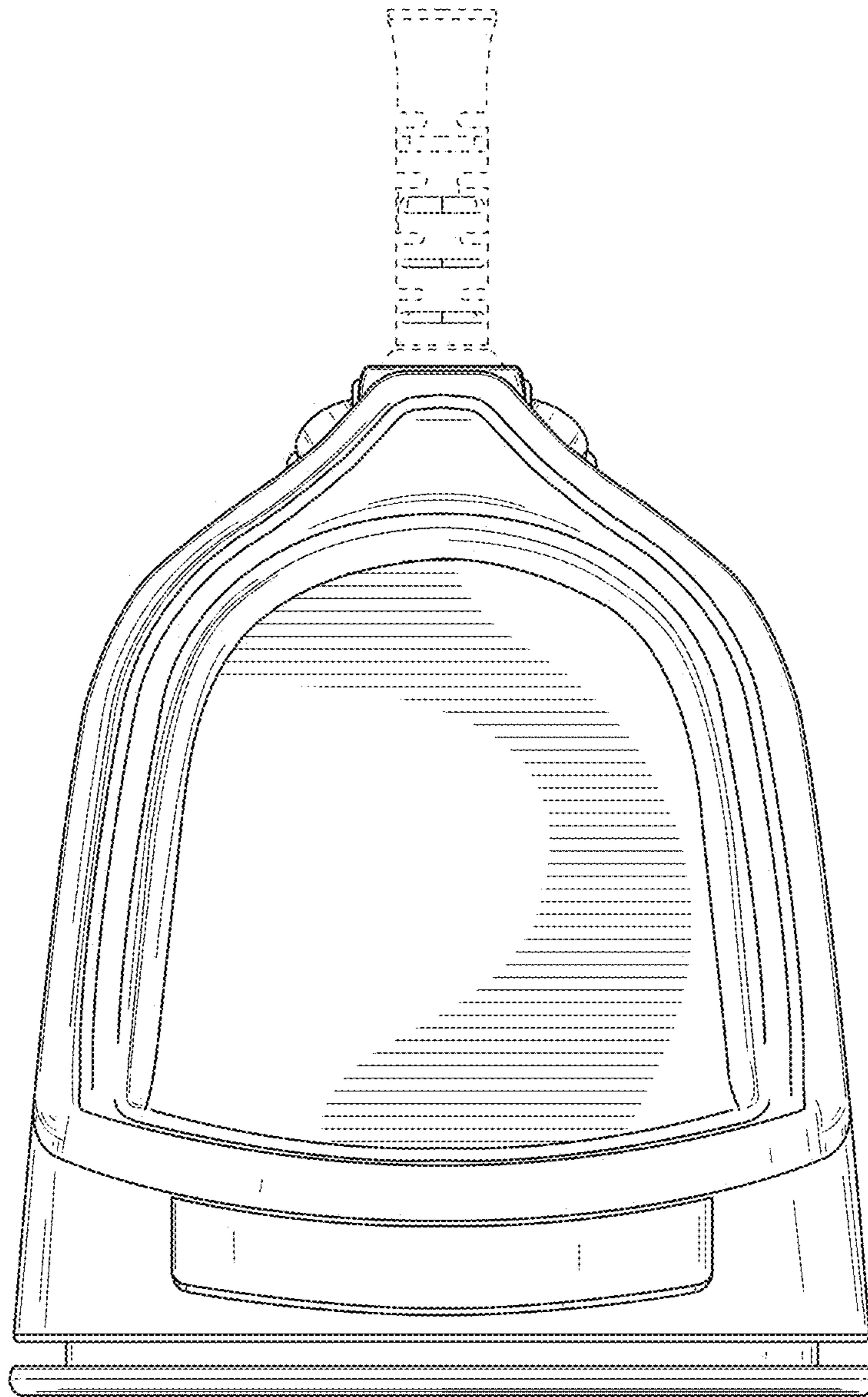

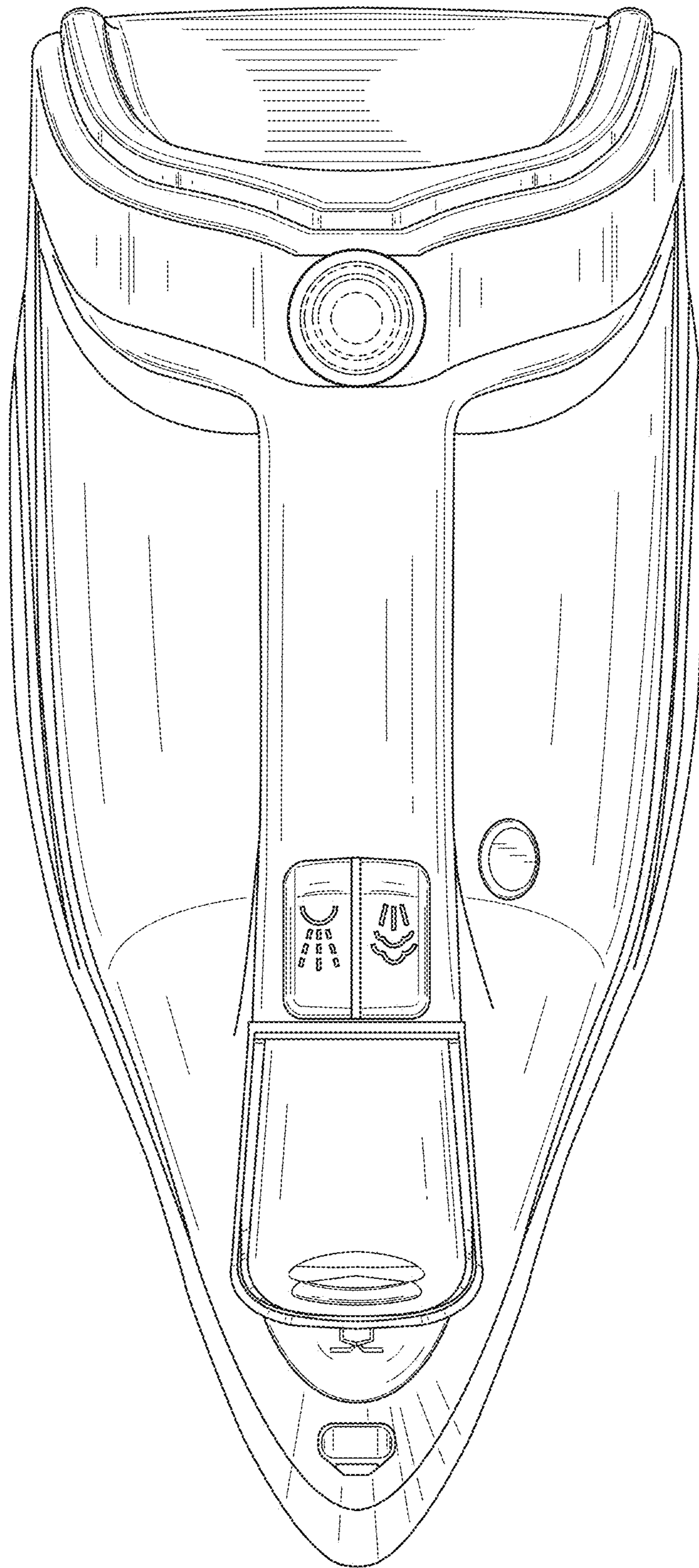

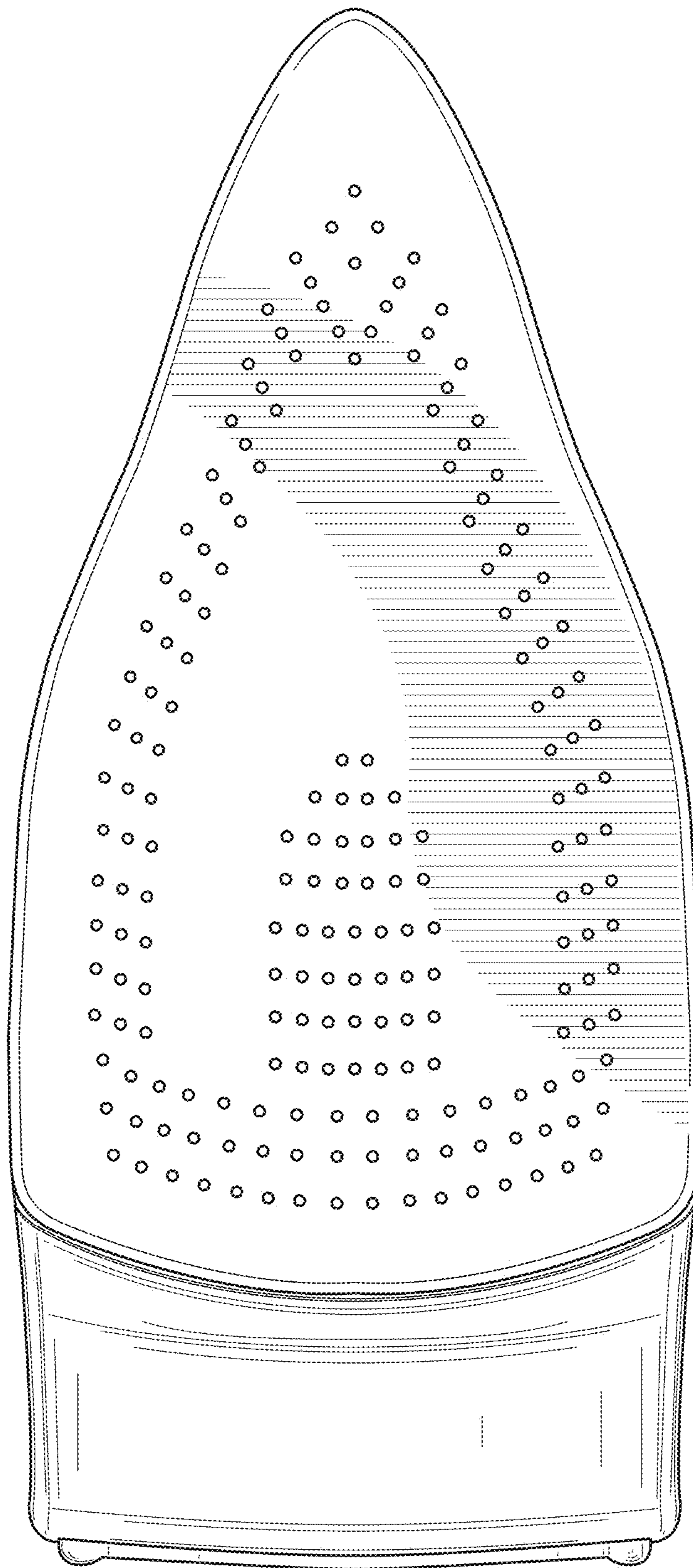
