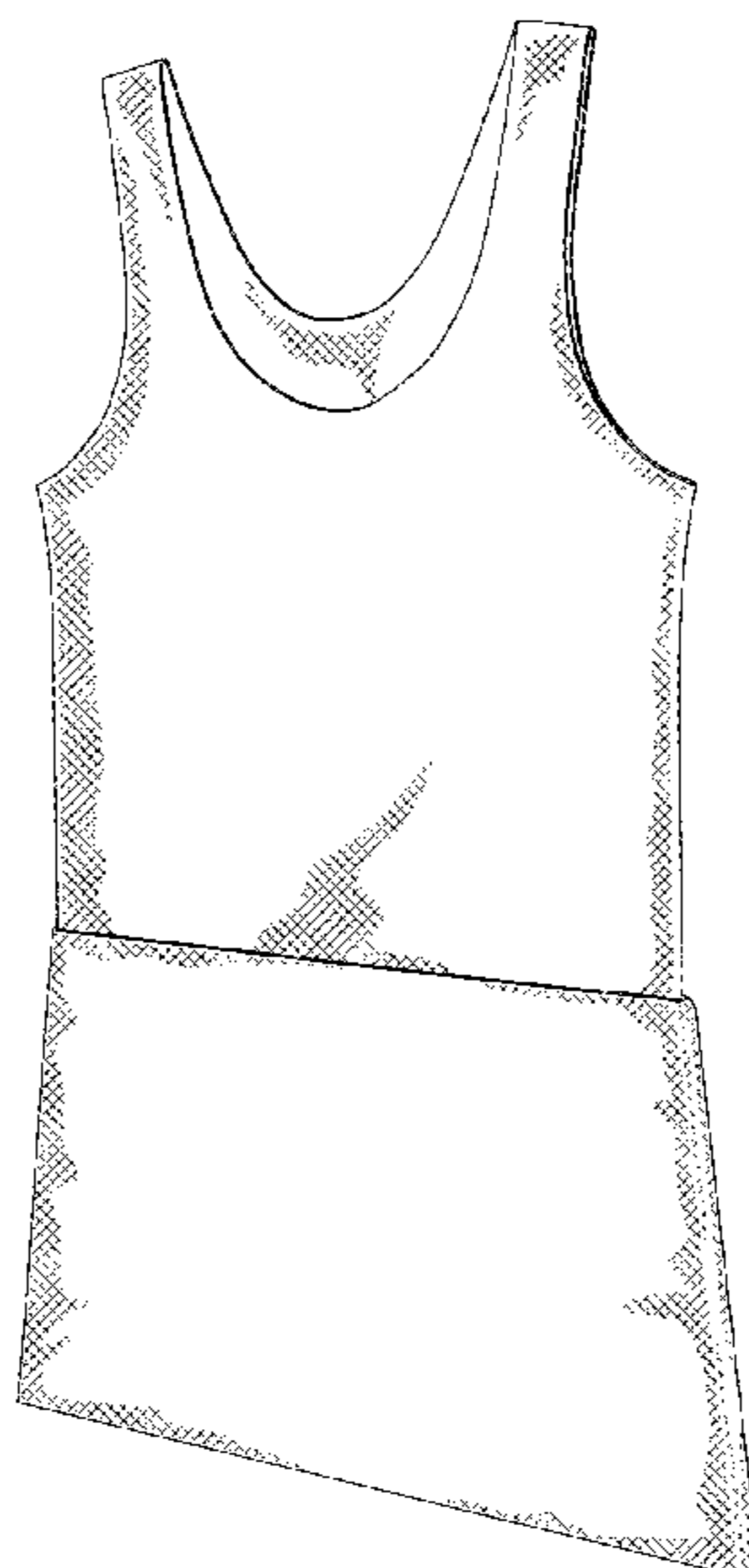
(57) **CLAIM**

The ornamental design for a torso garment, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a torso garment showing my new design.
FIG. 2 is a front elevational view thereof.
FIG. 3 is a rear elevational view thereof.
FIG. 4 is a side elevational view thereof, with the opposite side being a mirror view.
FIG. 5 is a top plan view thereof.
FIG. 6 is a bottom plan view thereof.
FIG. 7 is a sectional taken along line 7-7 of FIG. 2.
FIG. 8 is a front perspective in-use view thereof; and,
FIG. 9 is a rear perspective in-use view thereof.
The broken line showing of a mannequin model in FIGS. 8 and 9 is for purpose of depicting environmental structure and forms no part of the claimed design.

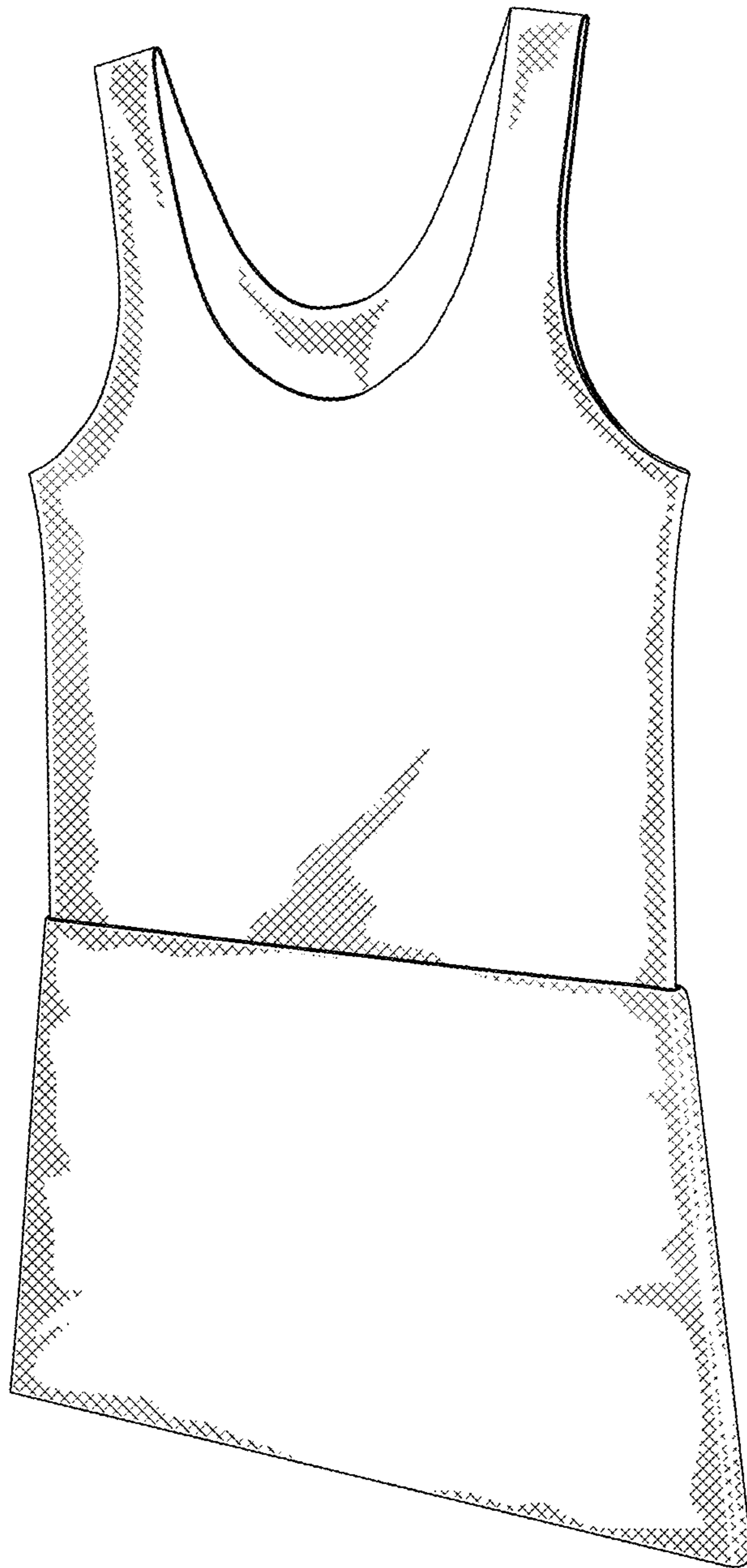

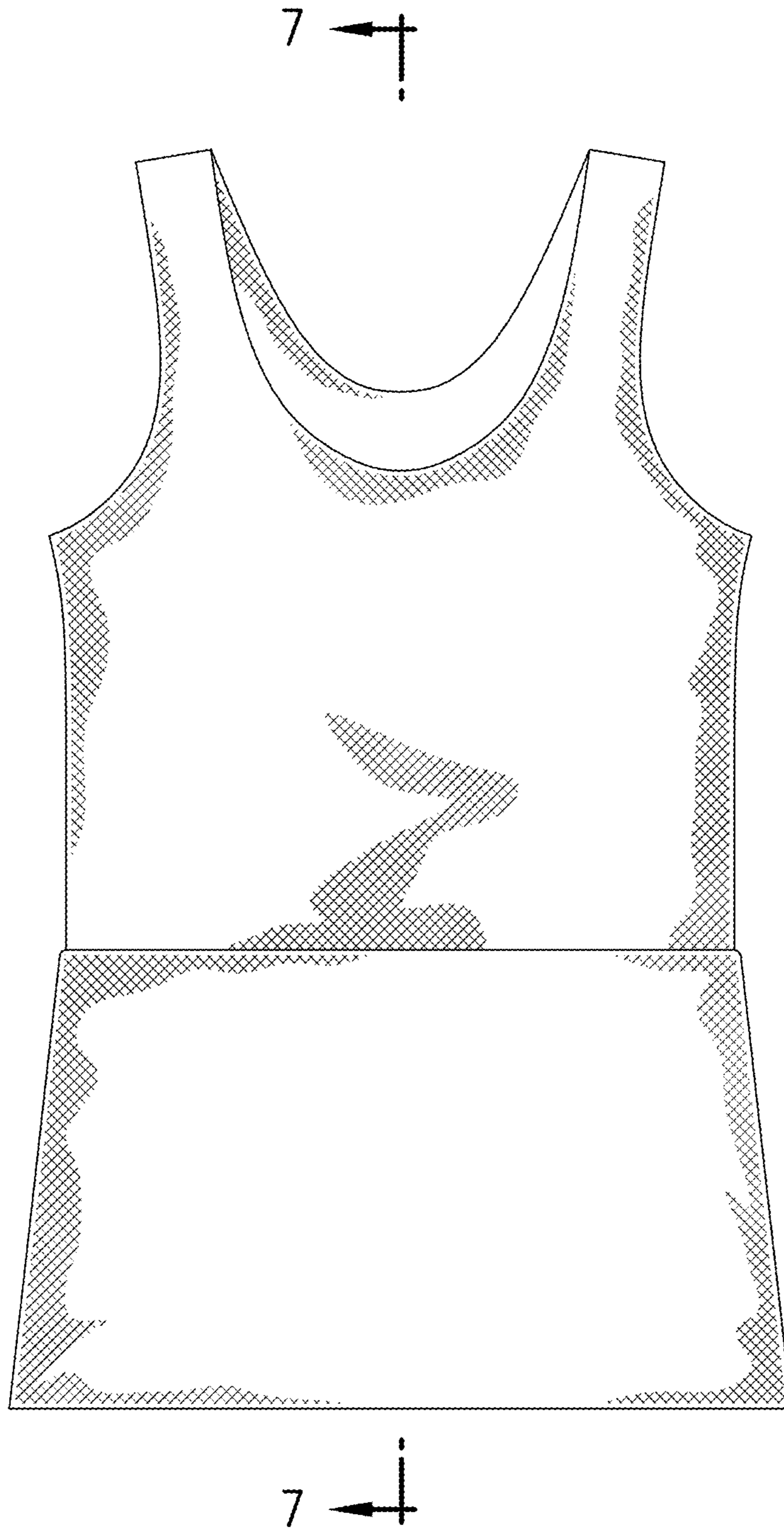

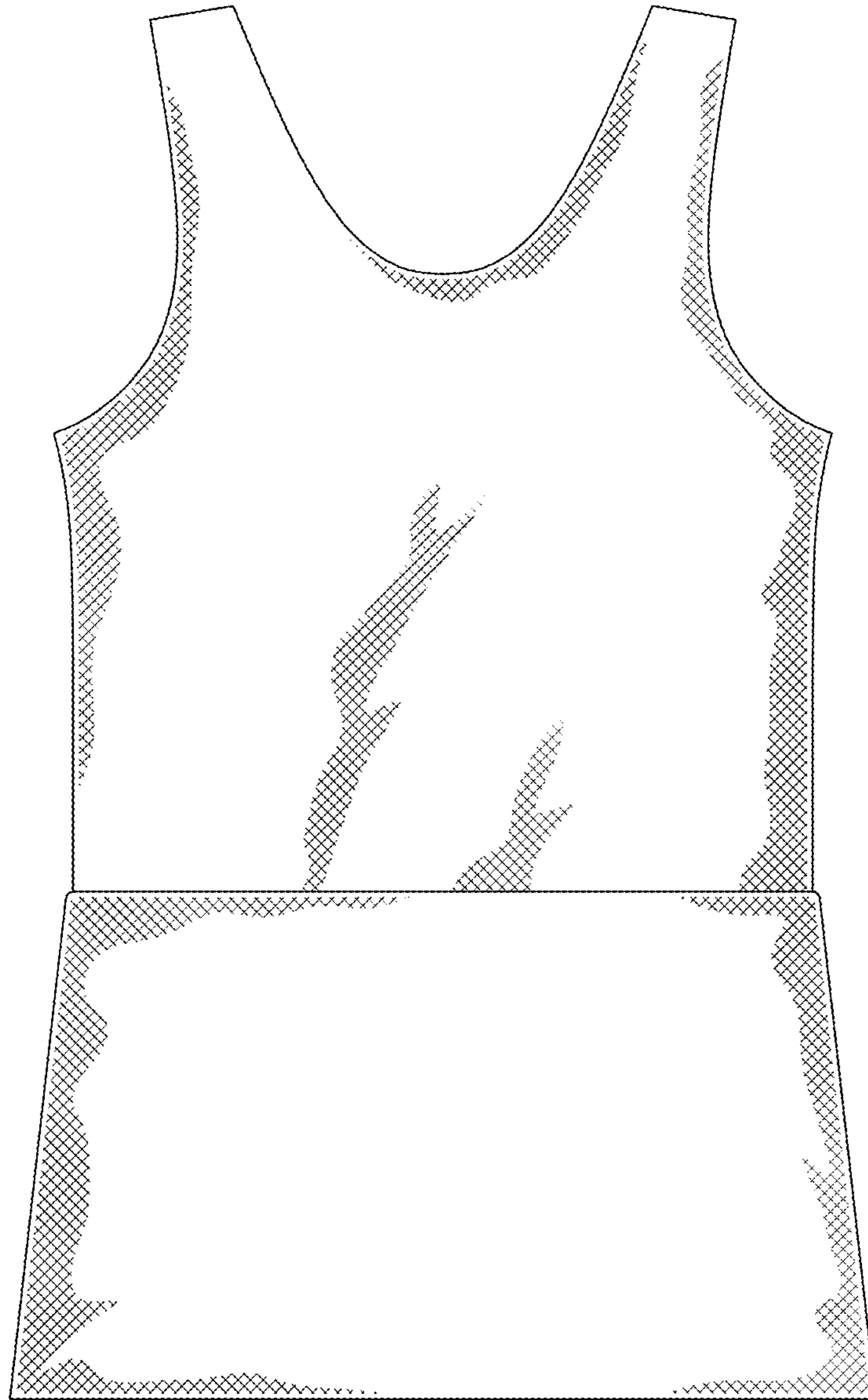

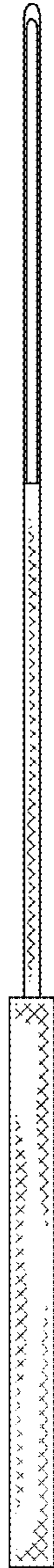

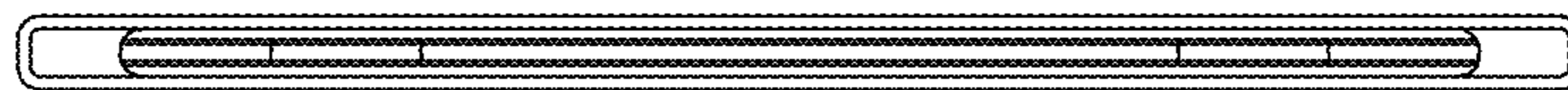

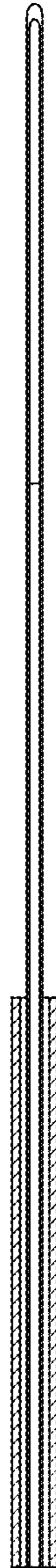

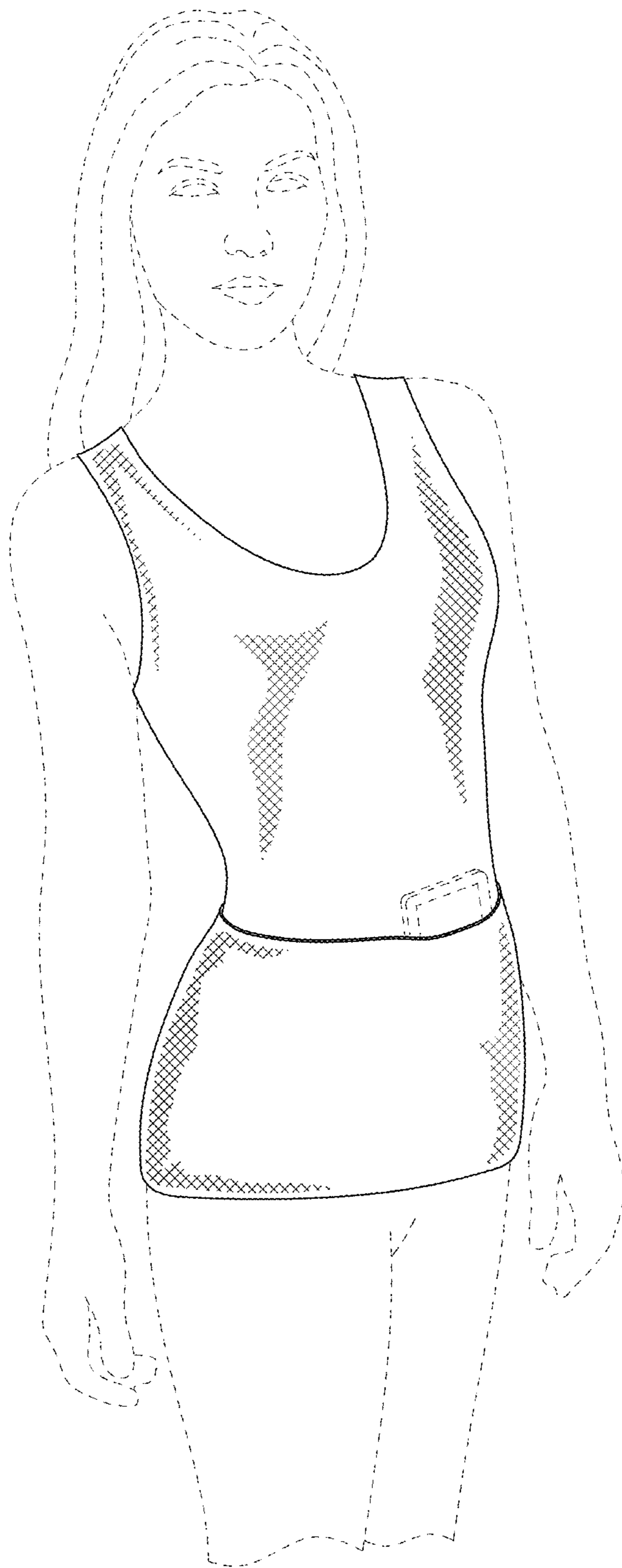

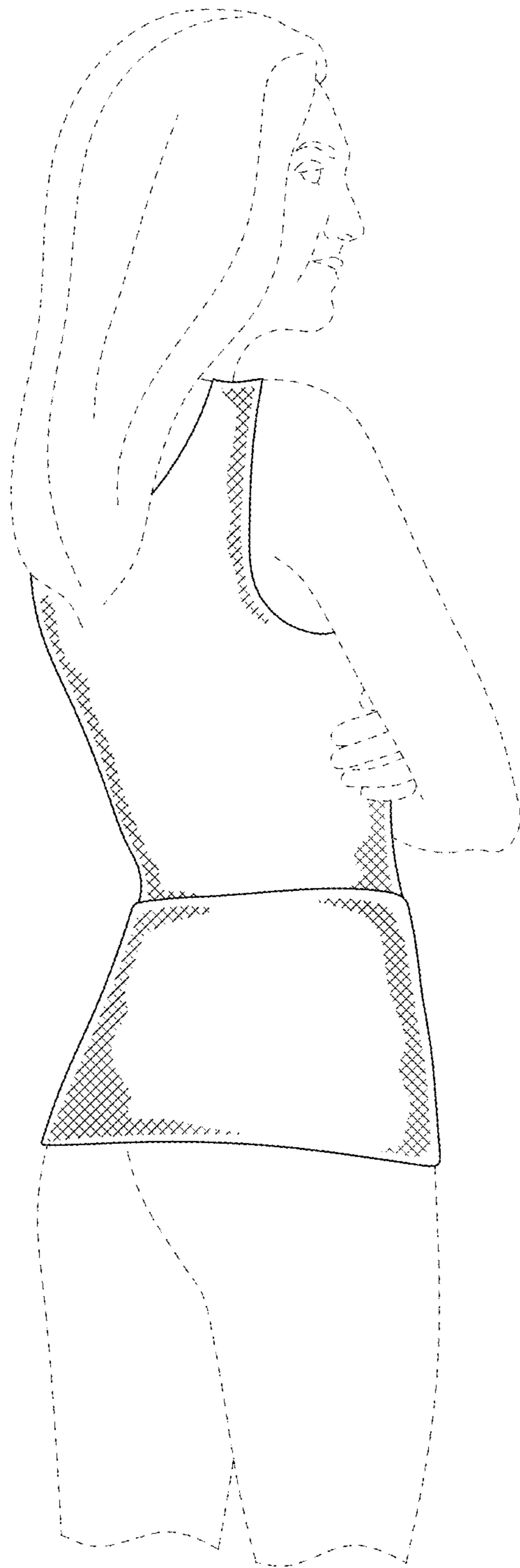
