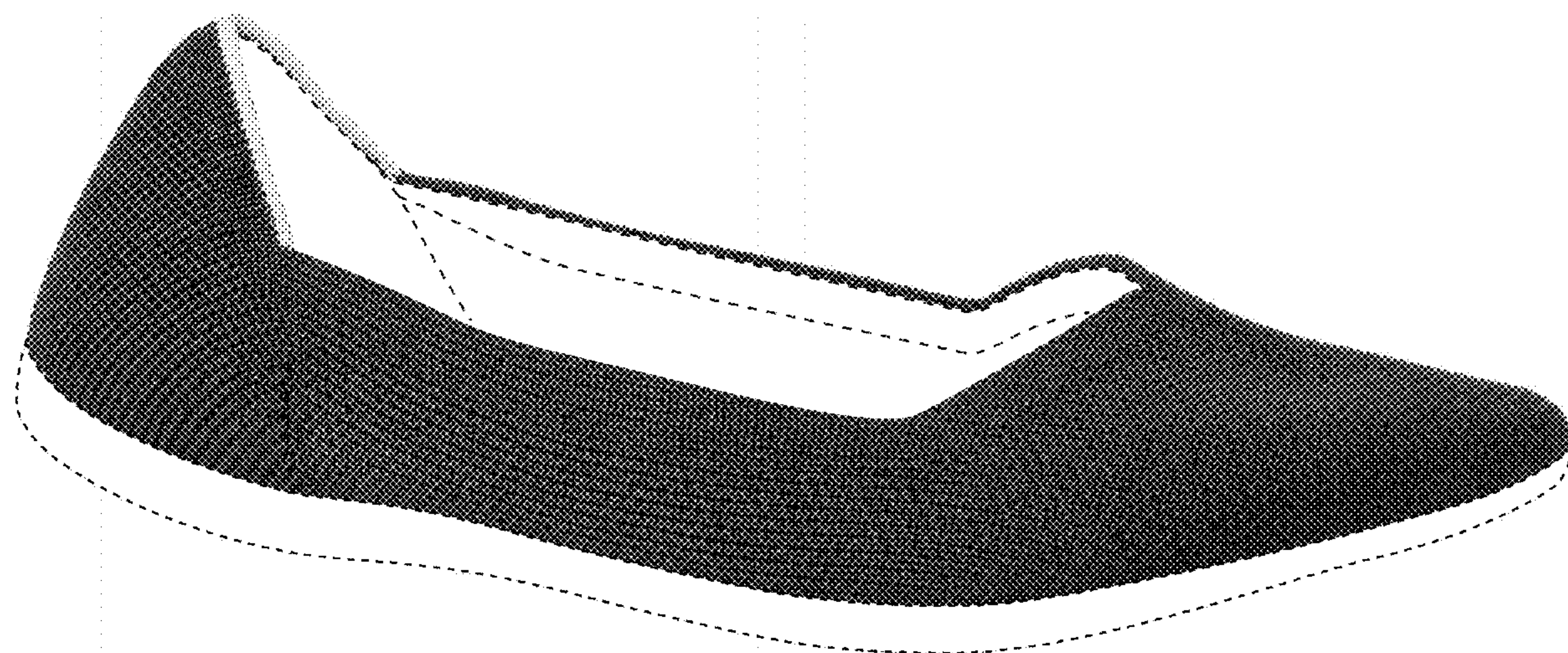
(57) **CLAIM**

The ornamental design for a portion of a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a front left perspective view of a first embodiment of a portion of a shoe showing our new design;

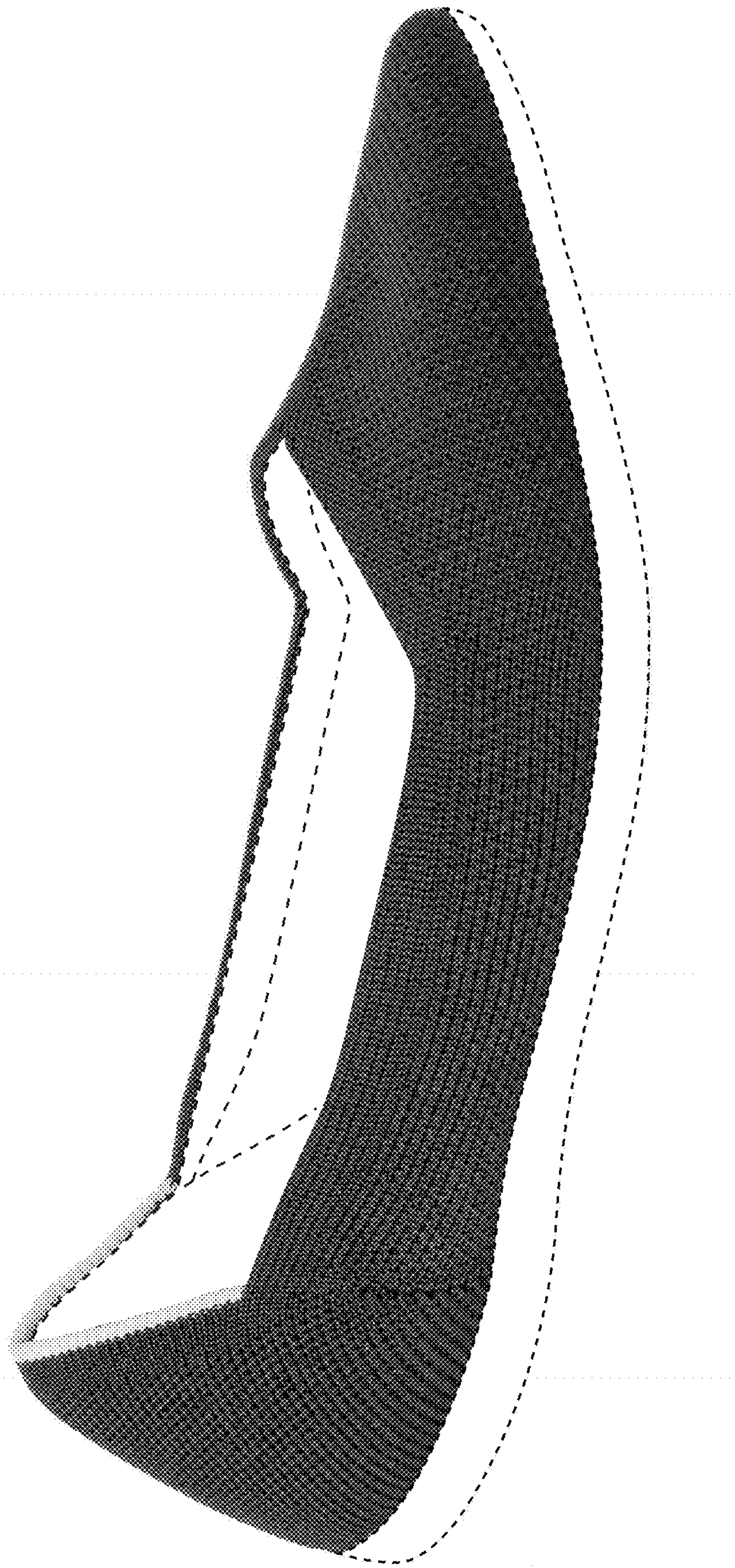

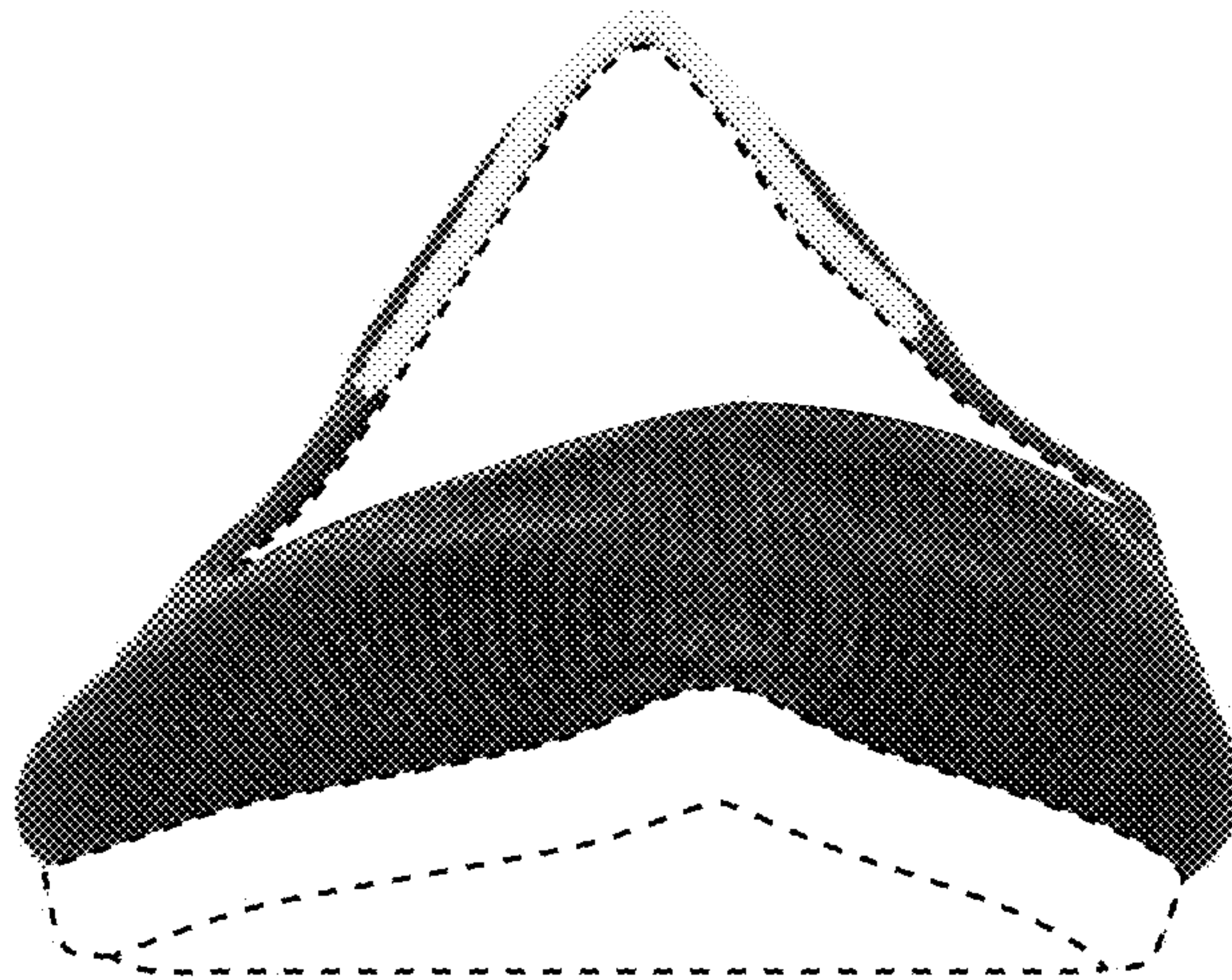

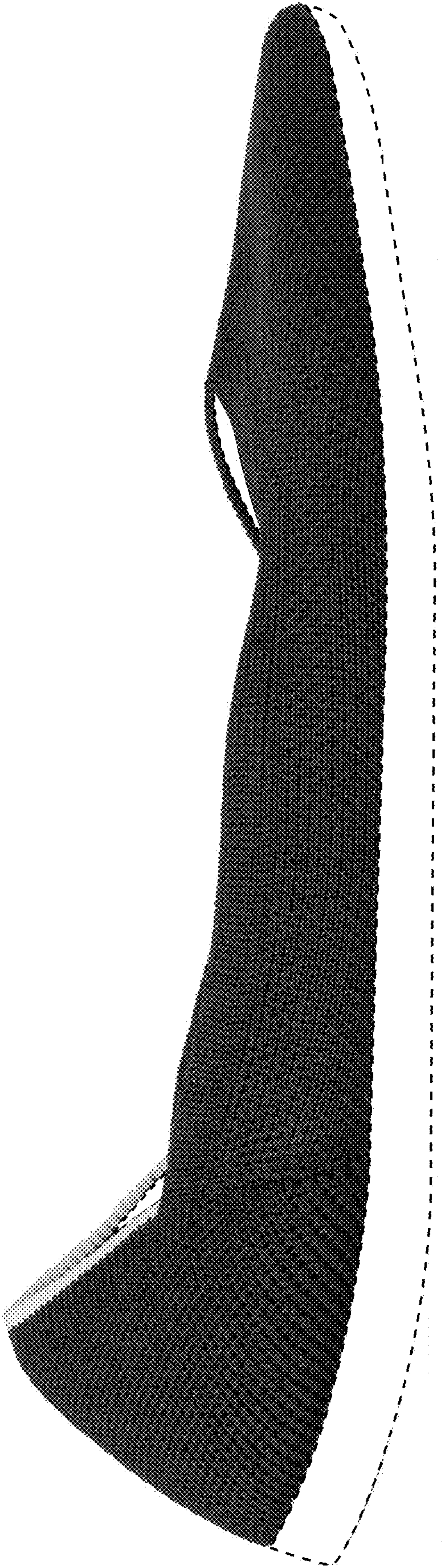

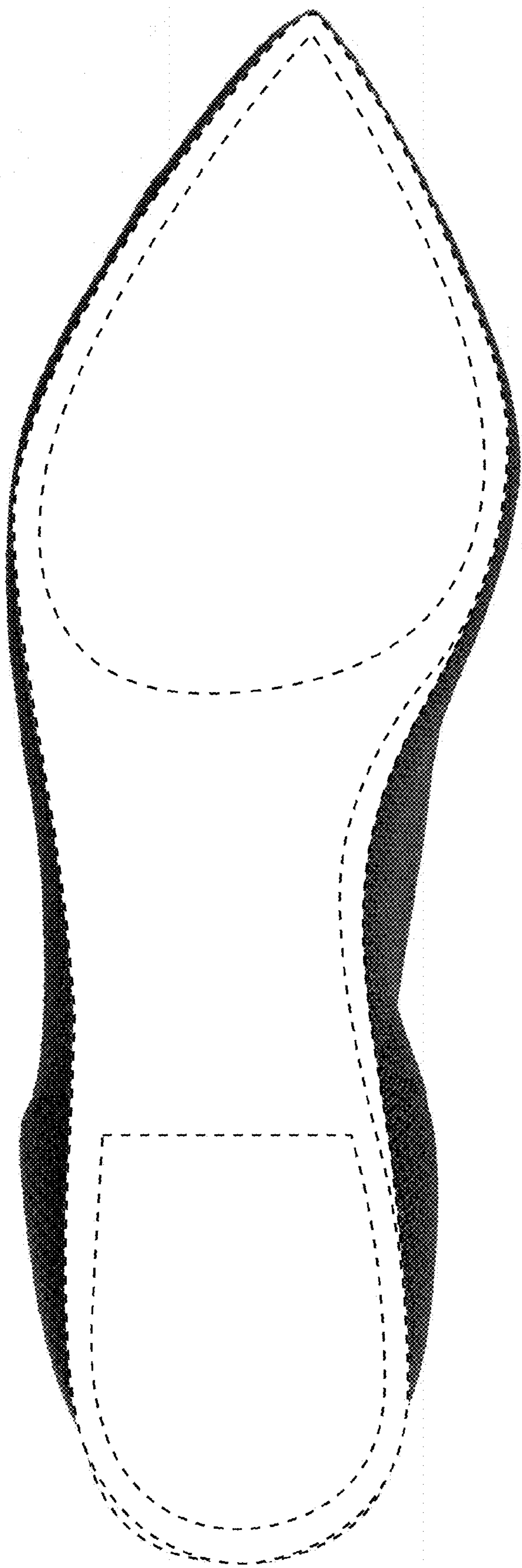

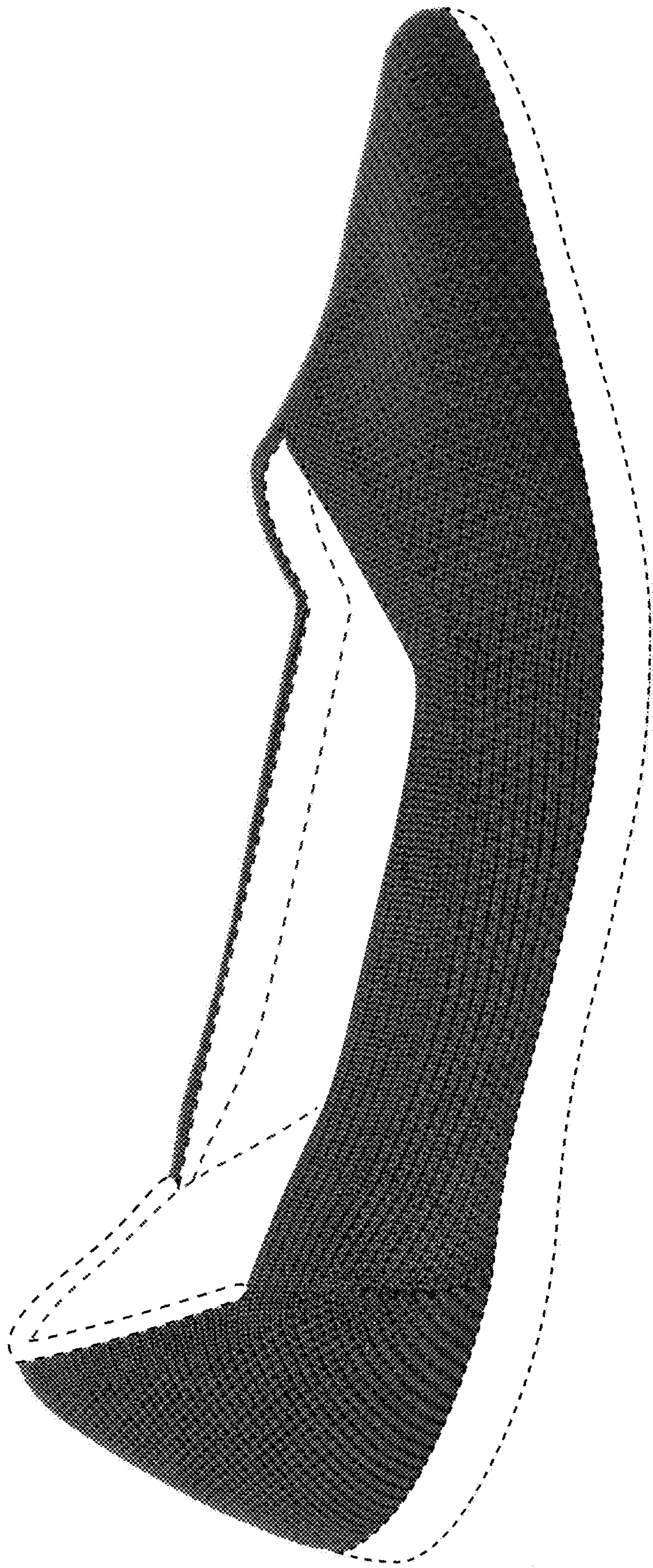

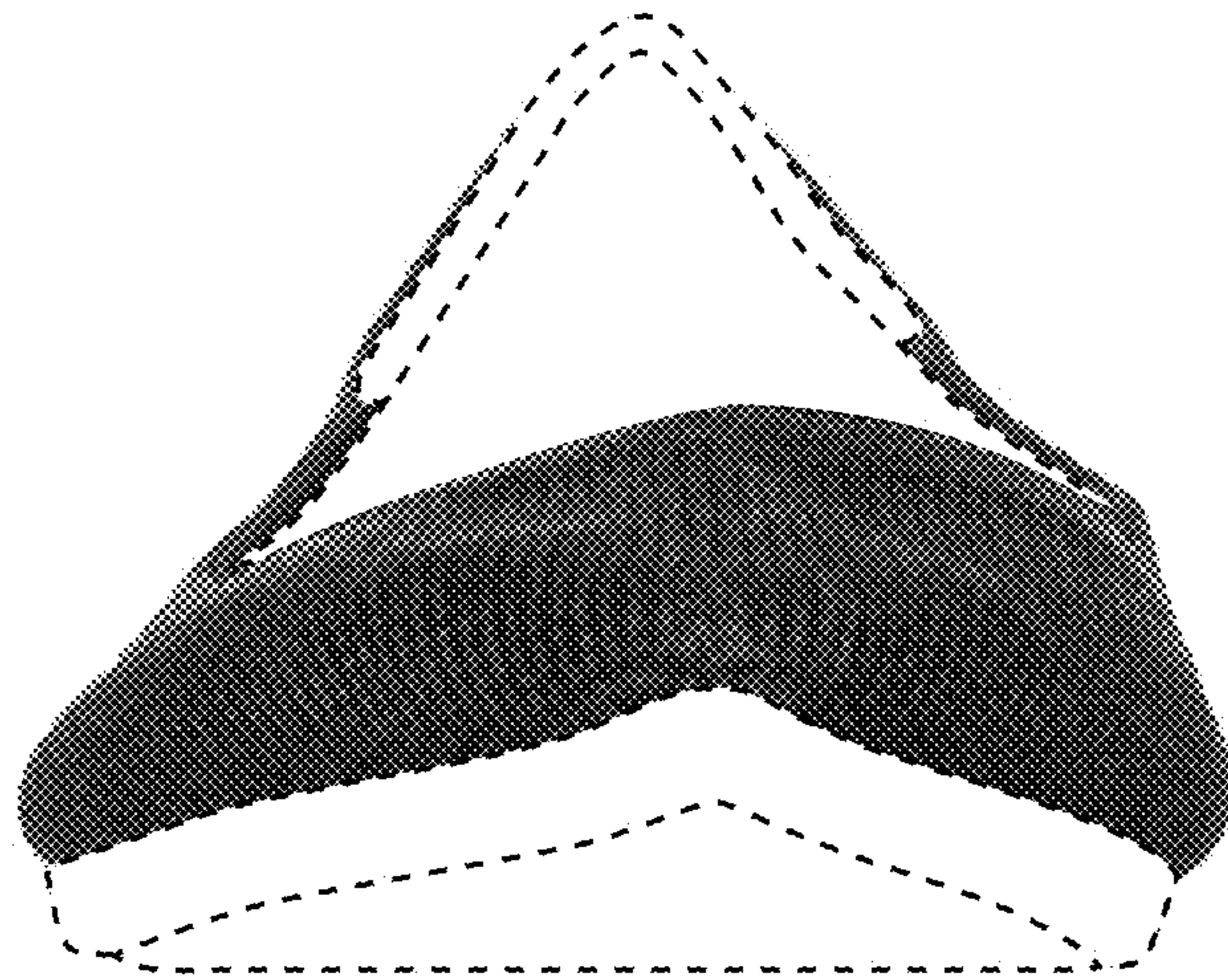

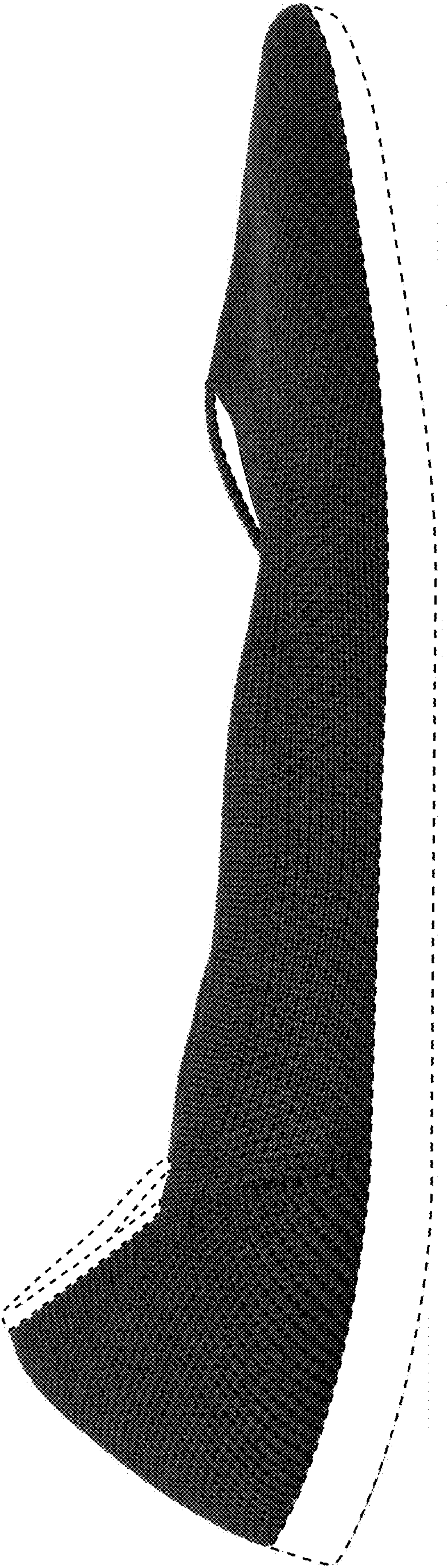

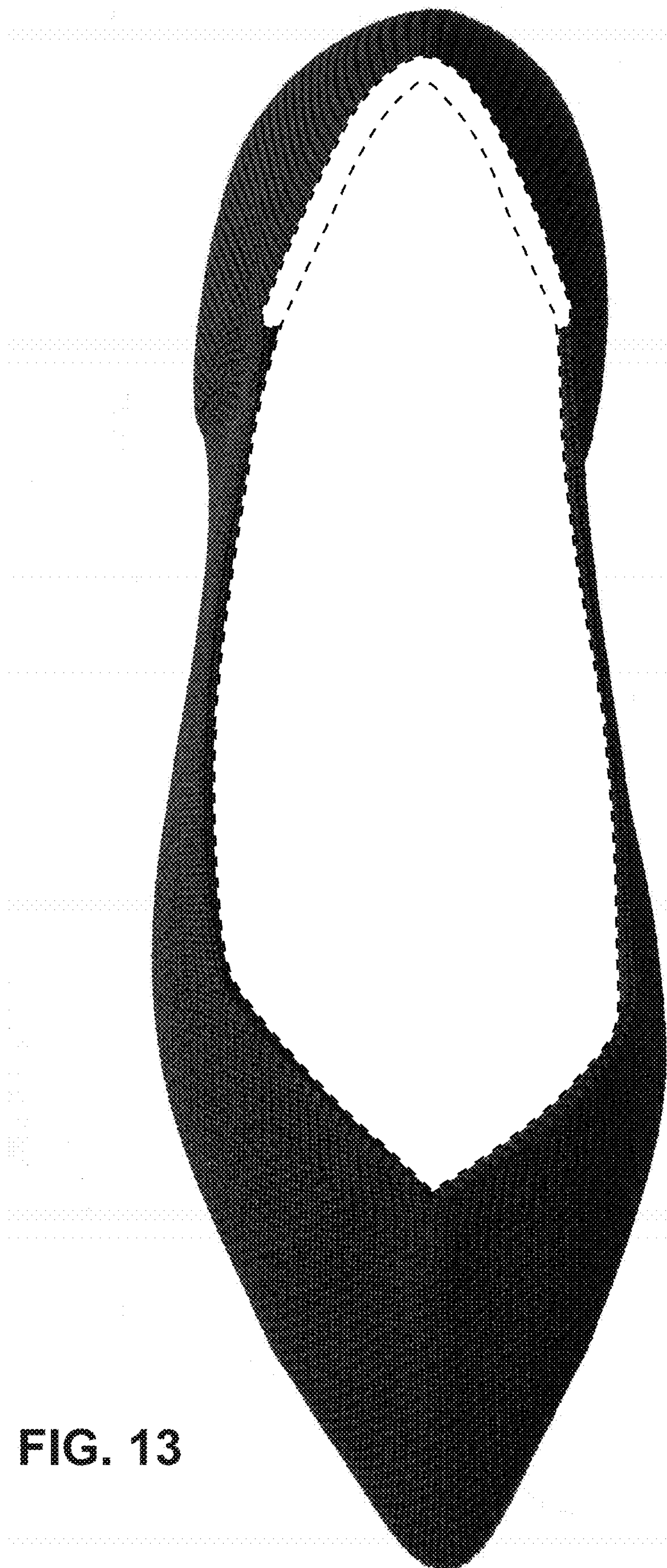

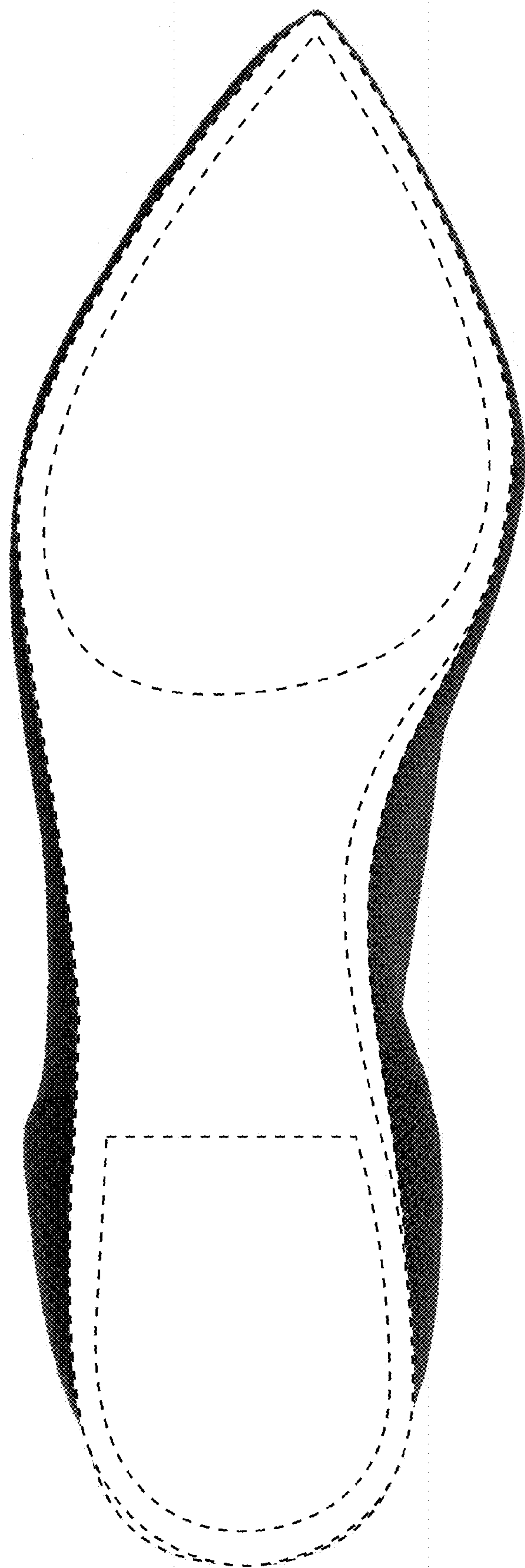
