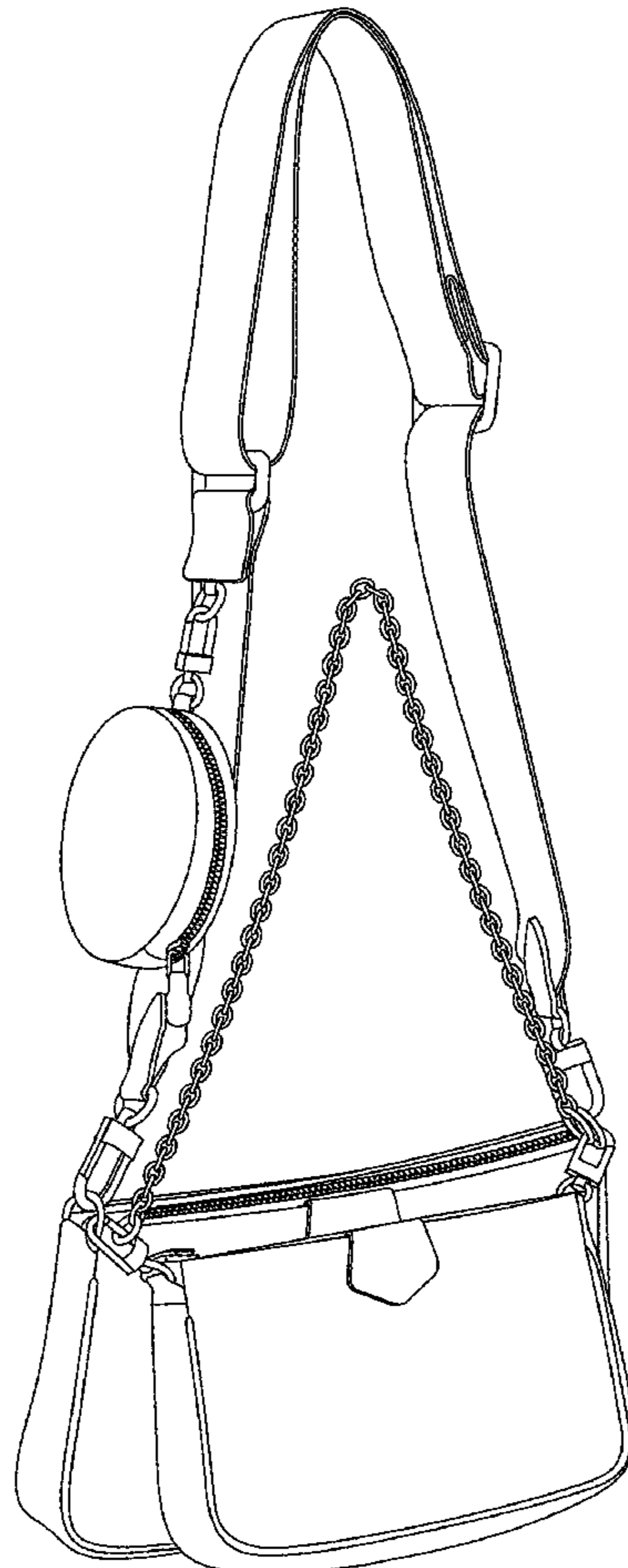
FIG. 1 is a front perspective view of my handbag showing my new design;

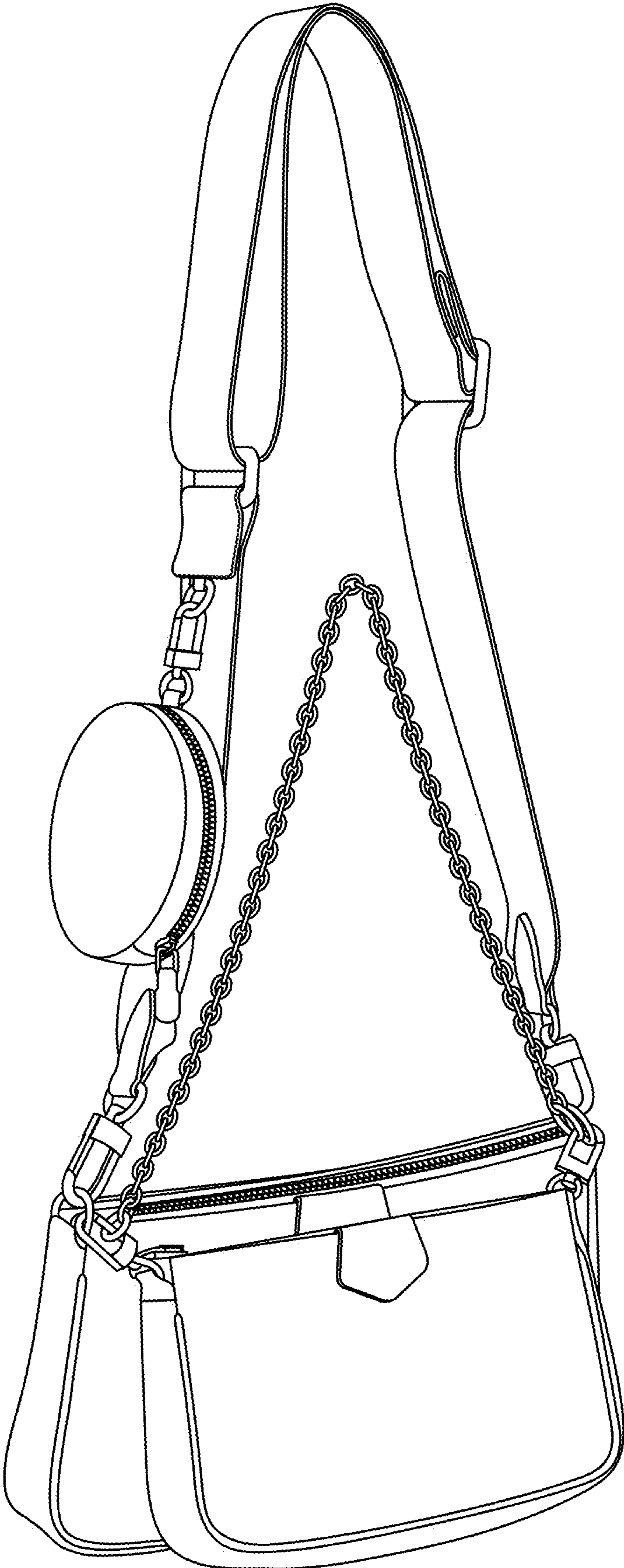

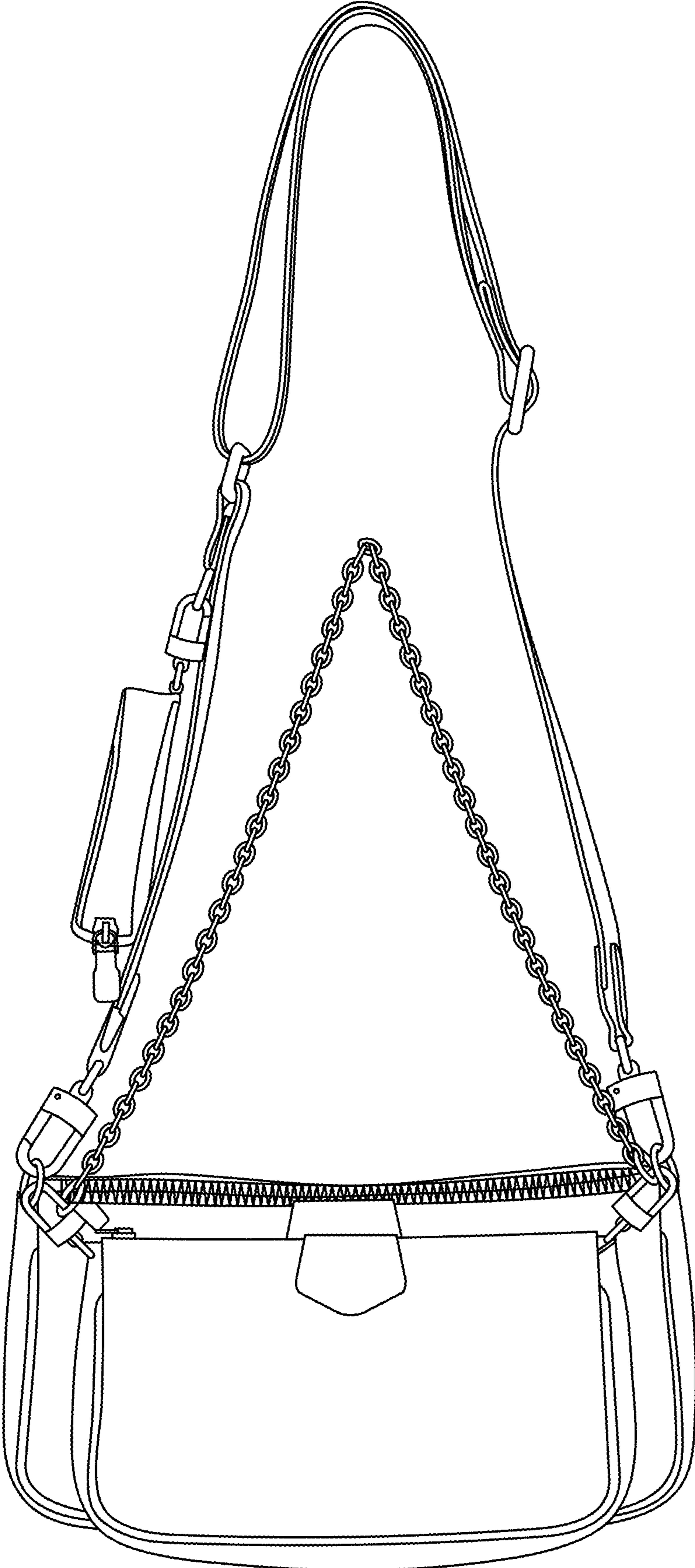

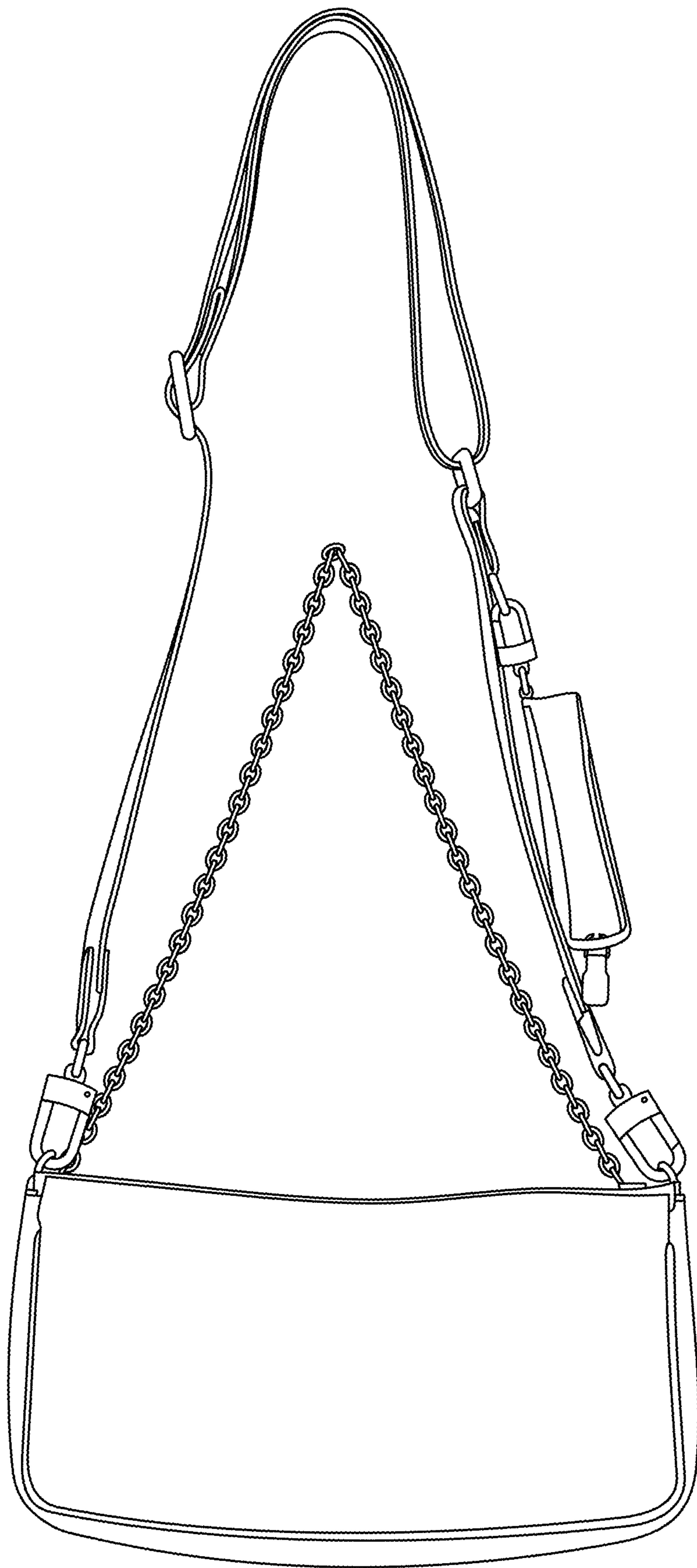

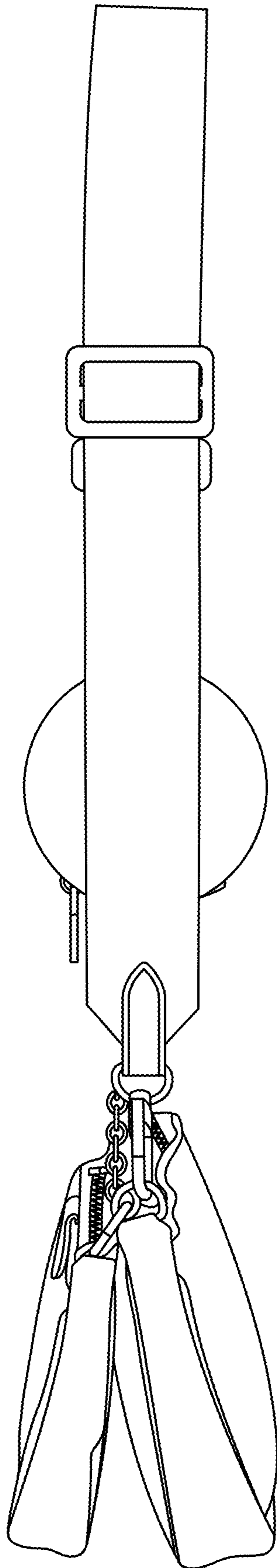

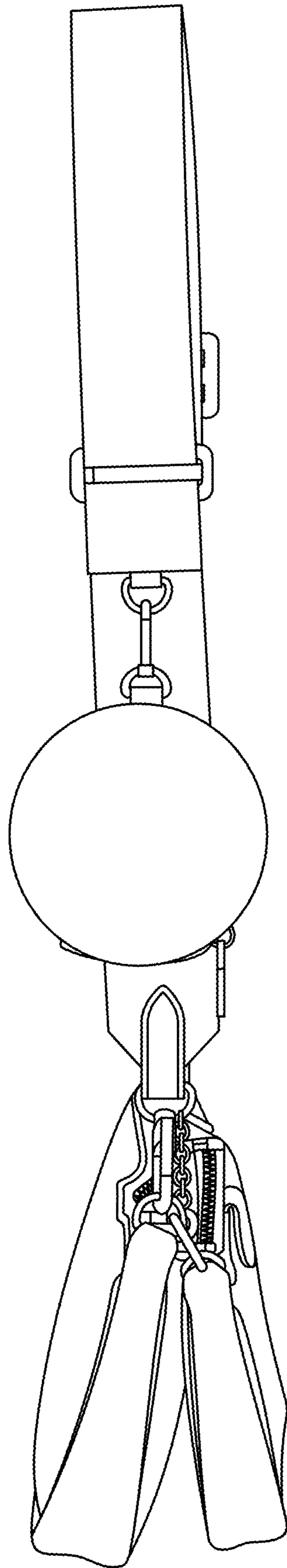

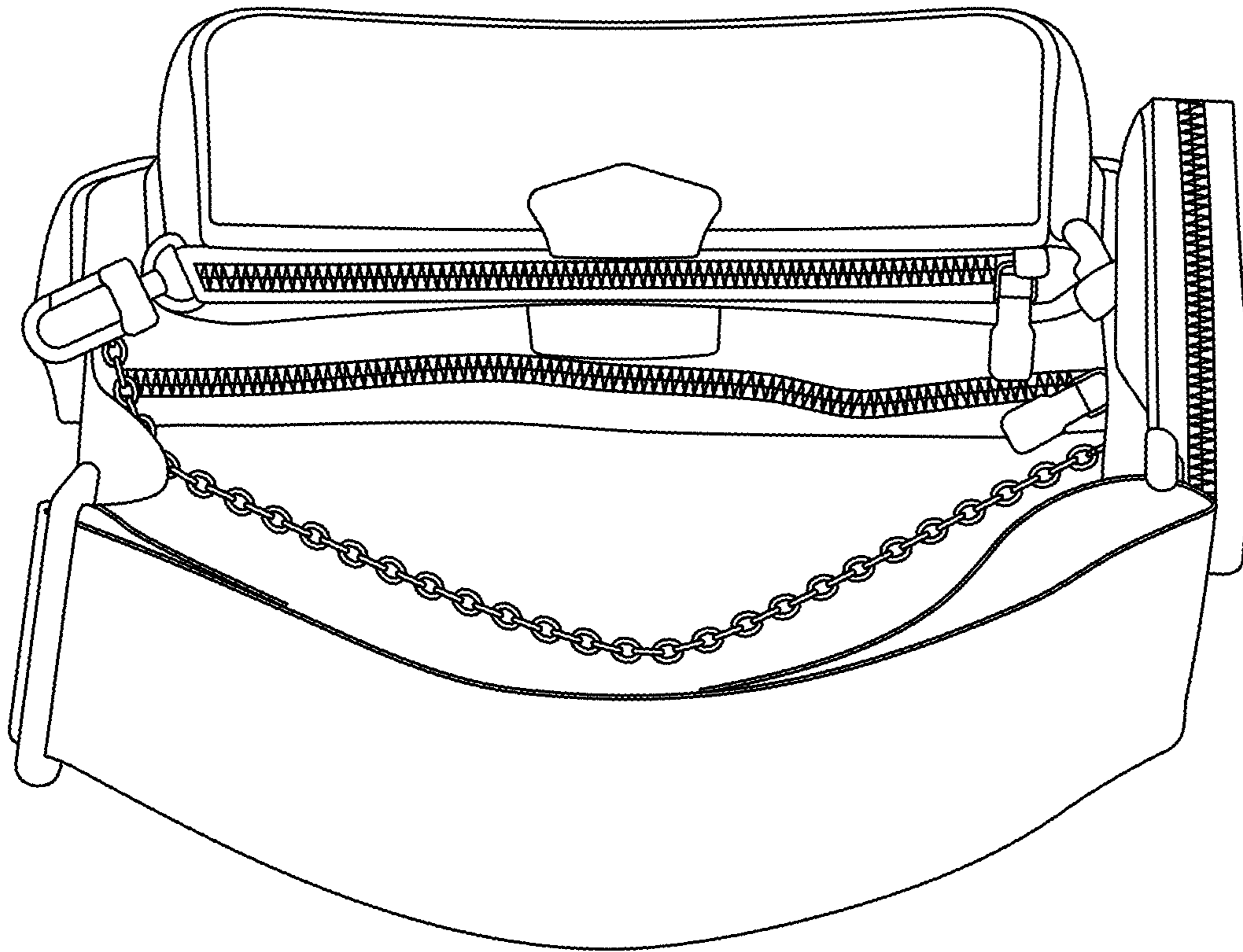

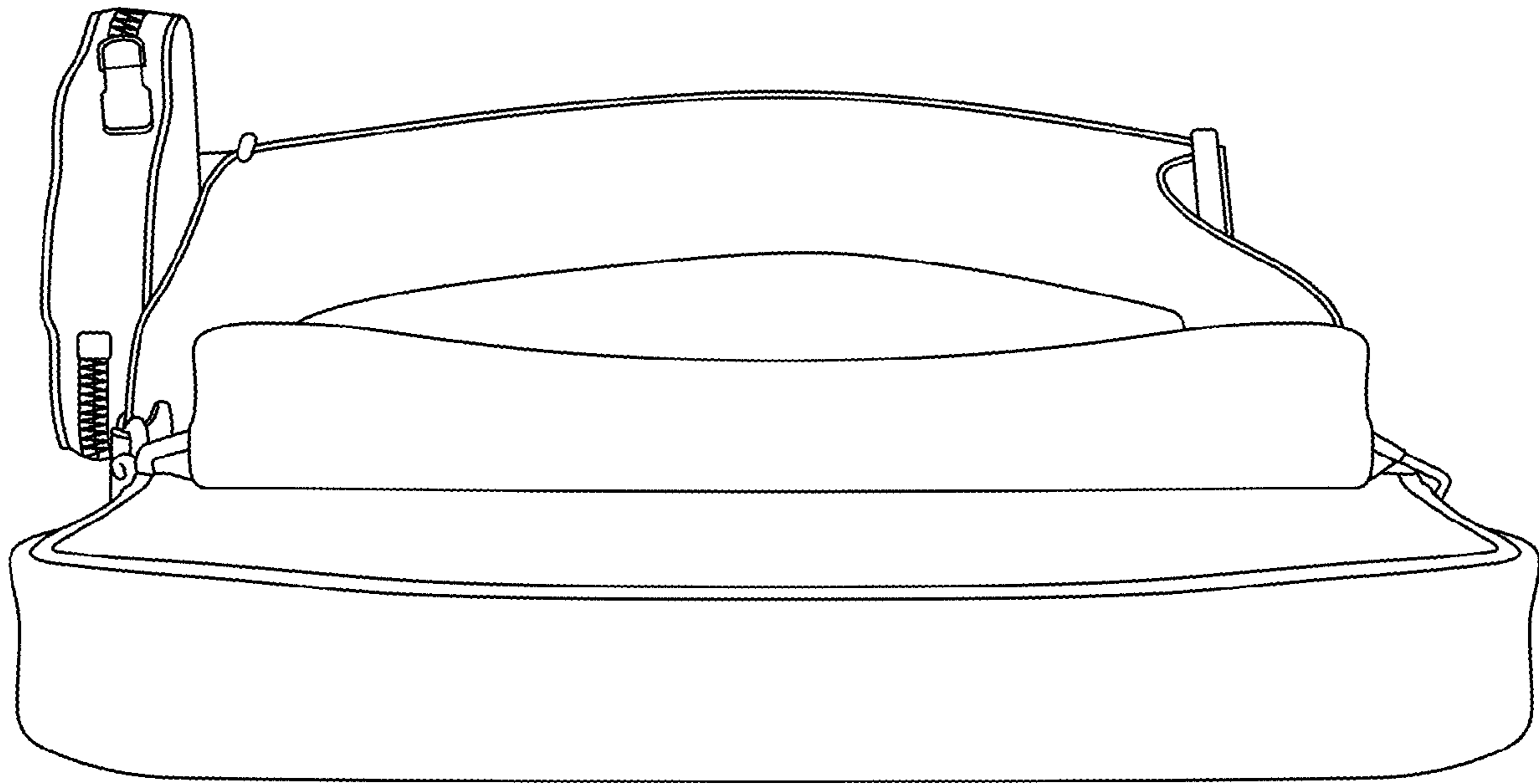
