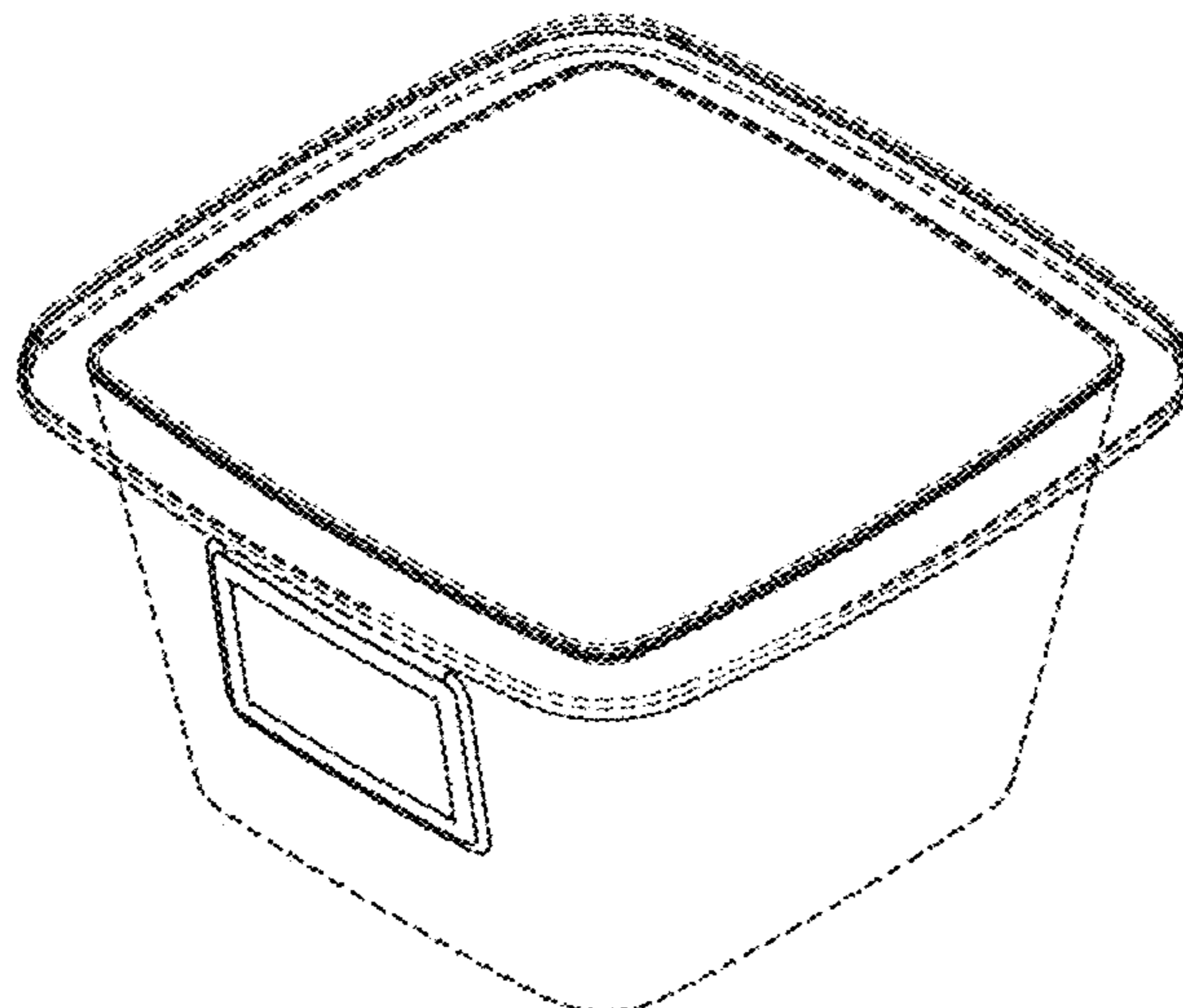
FIG. 2 is a side-on view of my storage container identification apparatus, where the broken lines showing a container and lid are for illustrative purposes only and form no part of the claimed design;

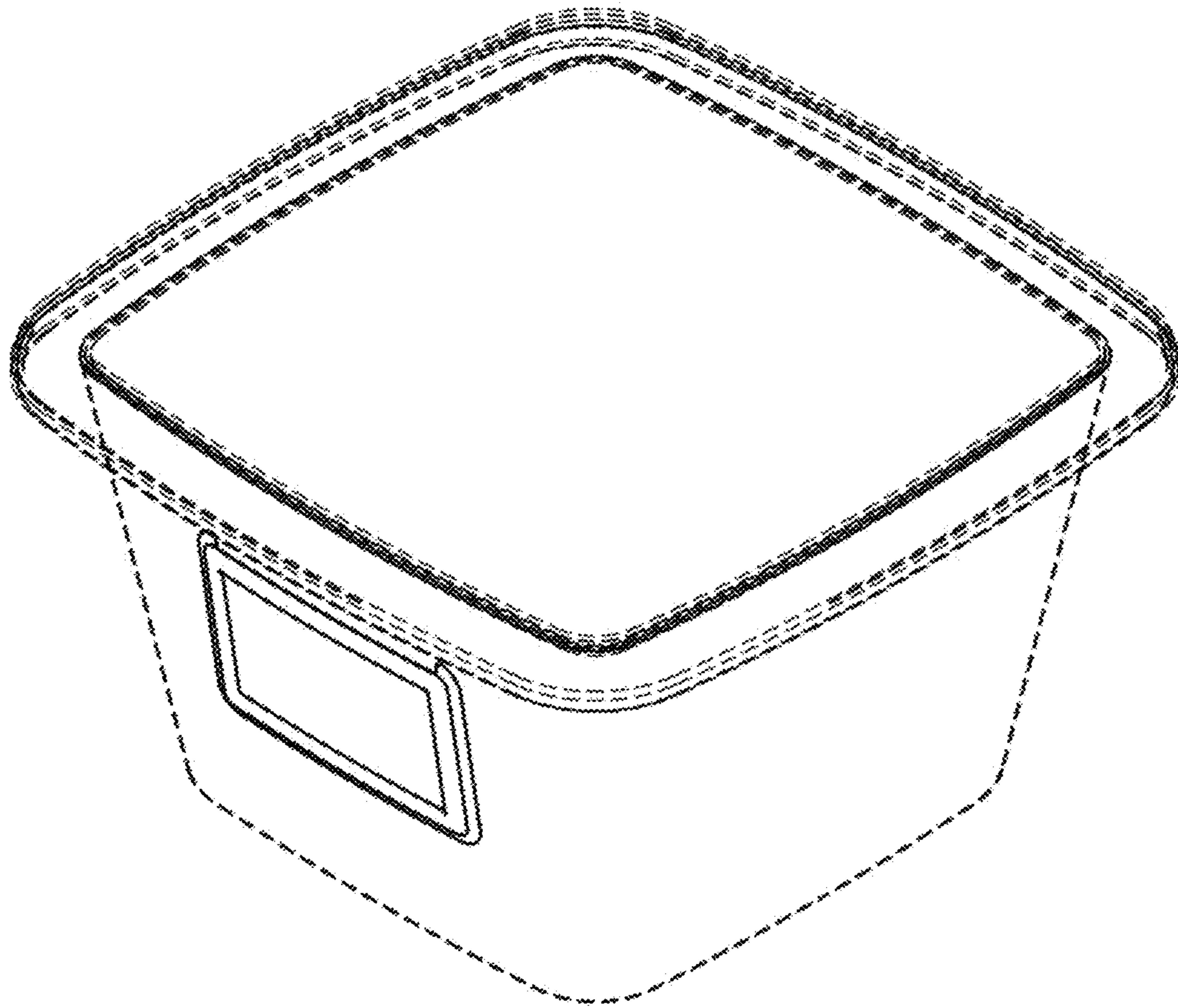

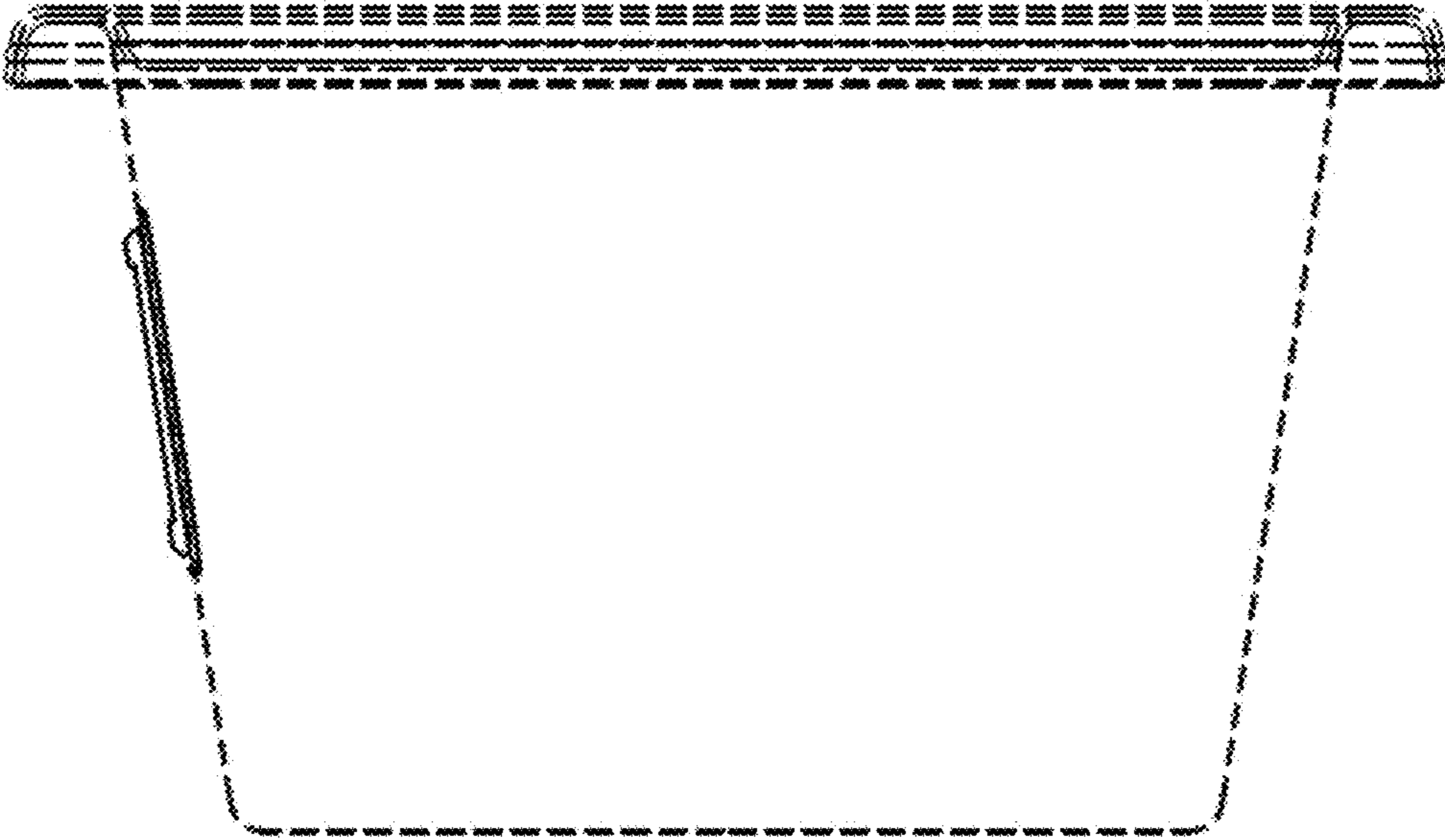

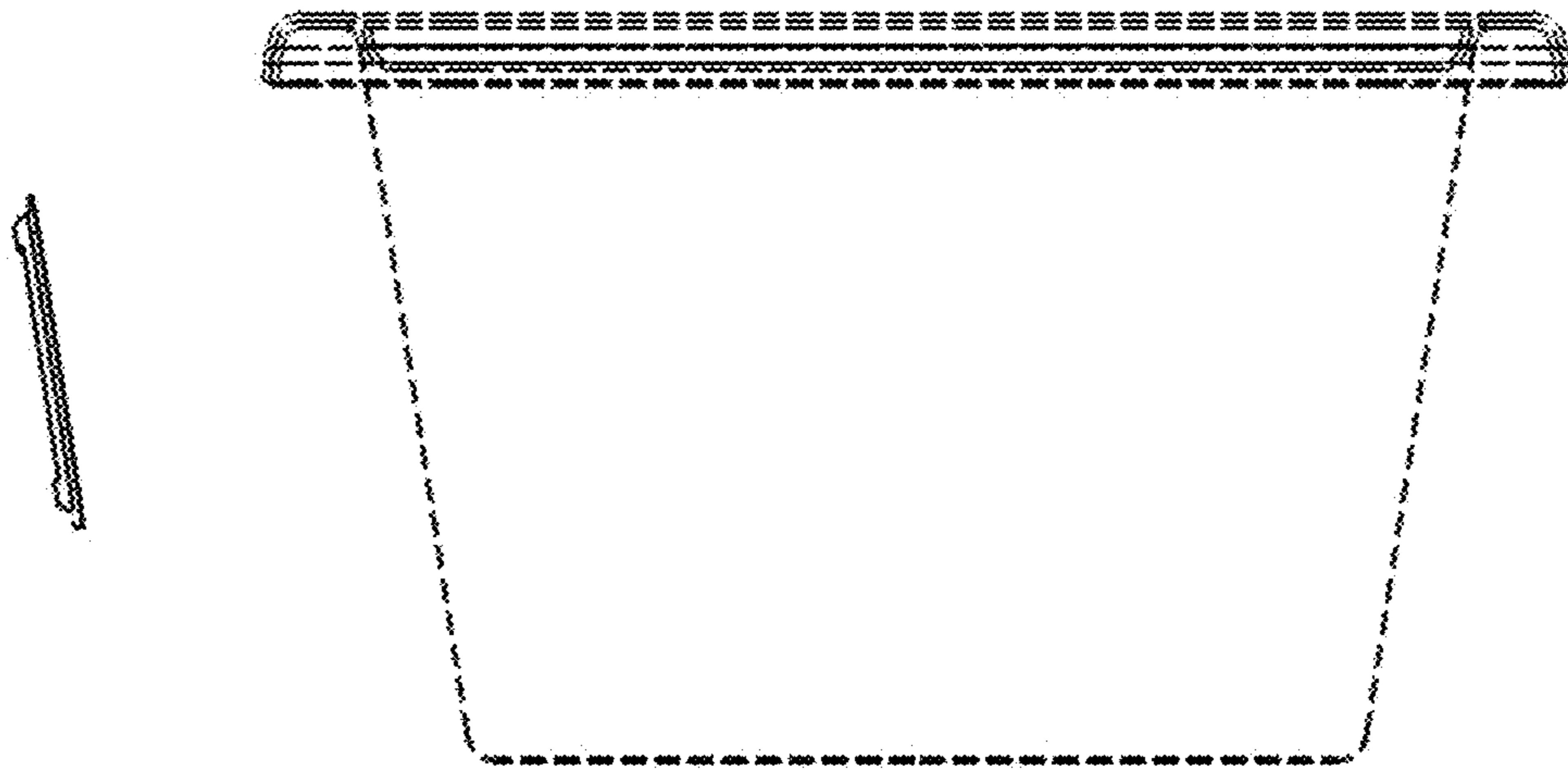

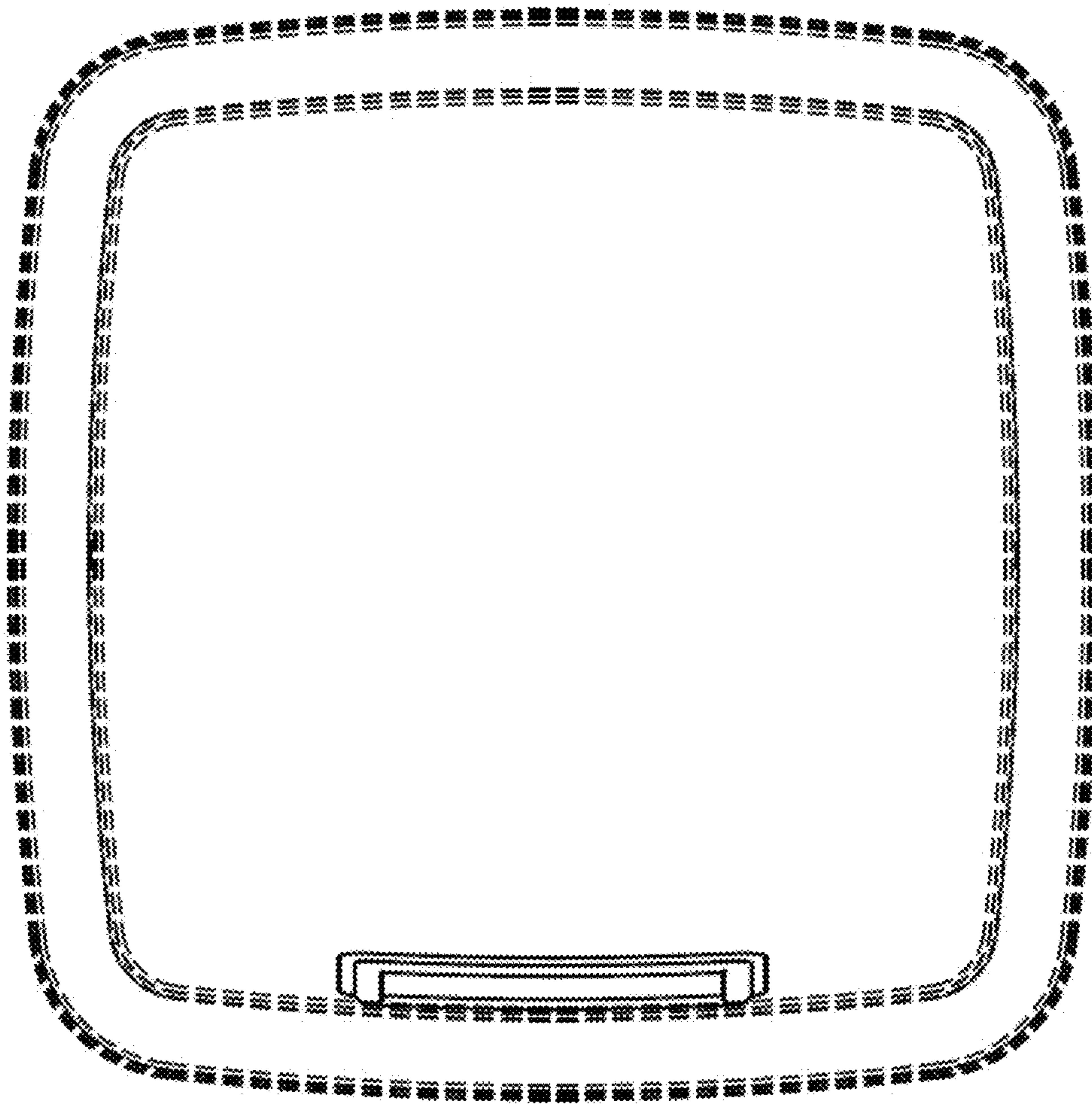

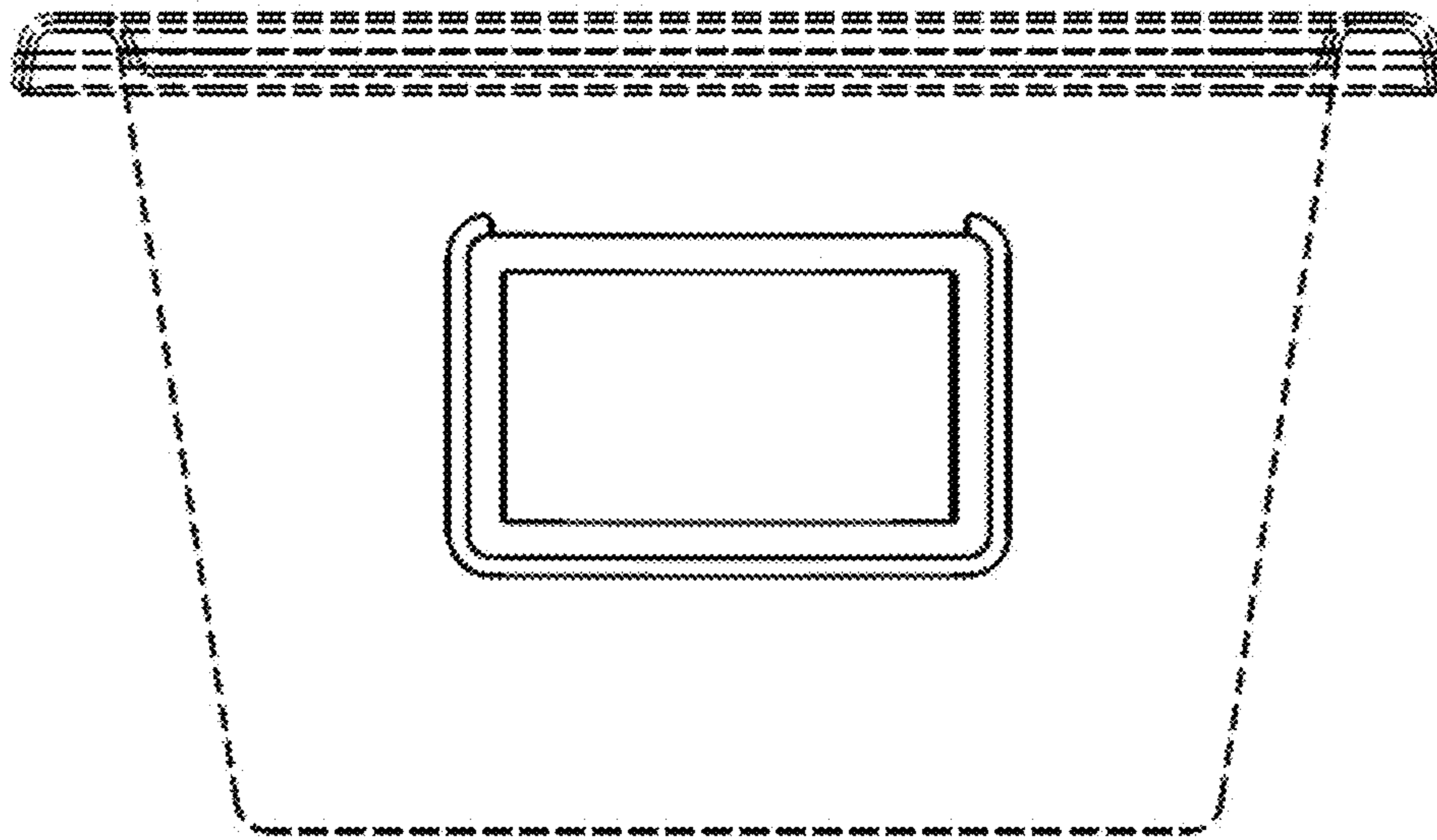
