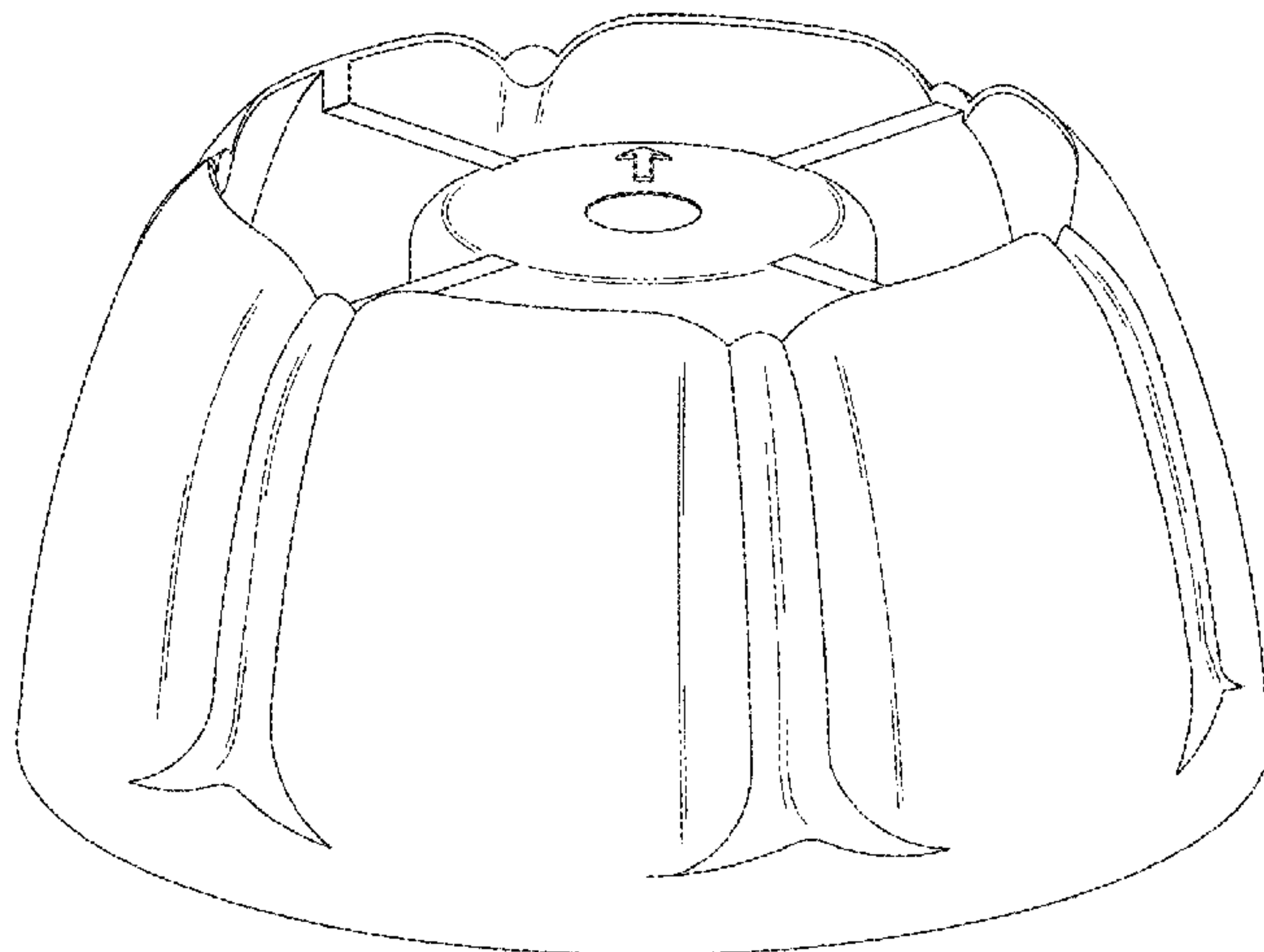
The ornamental design for a cap for packing container, as shown and described.

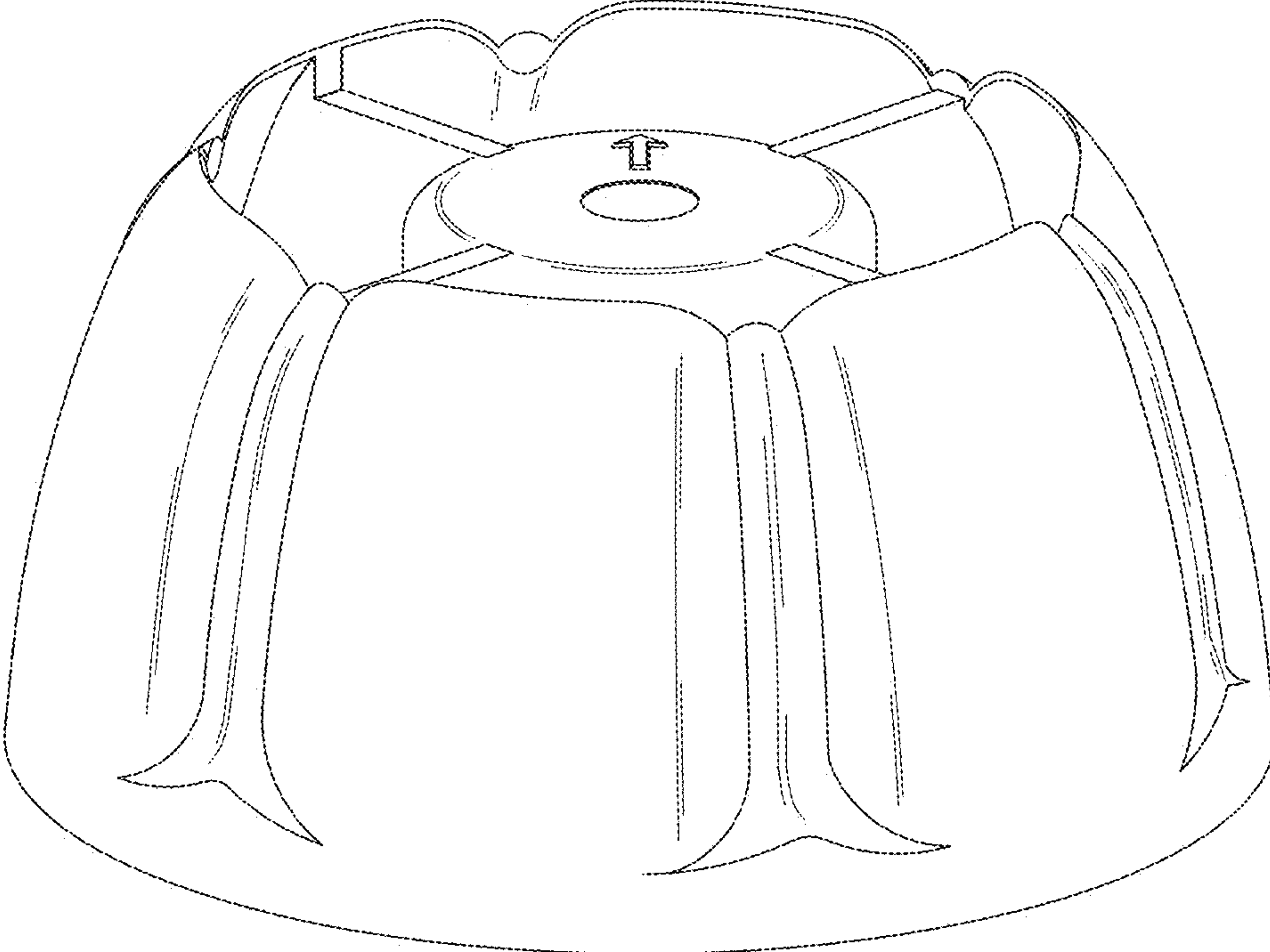

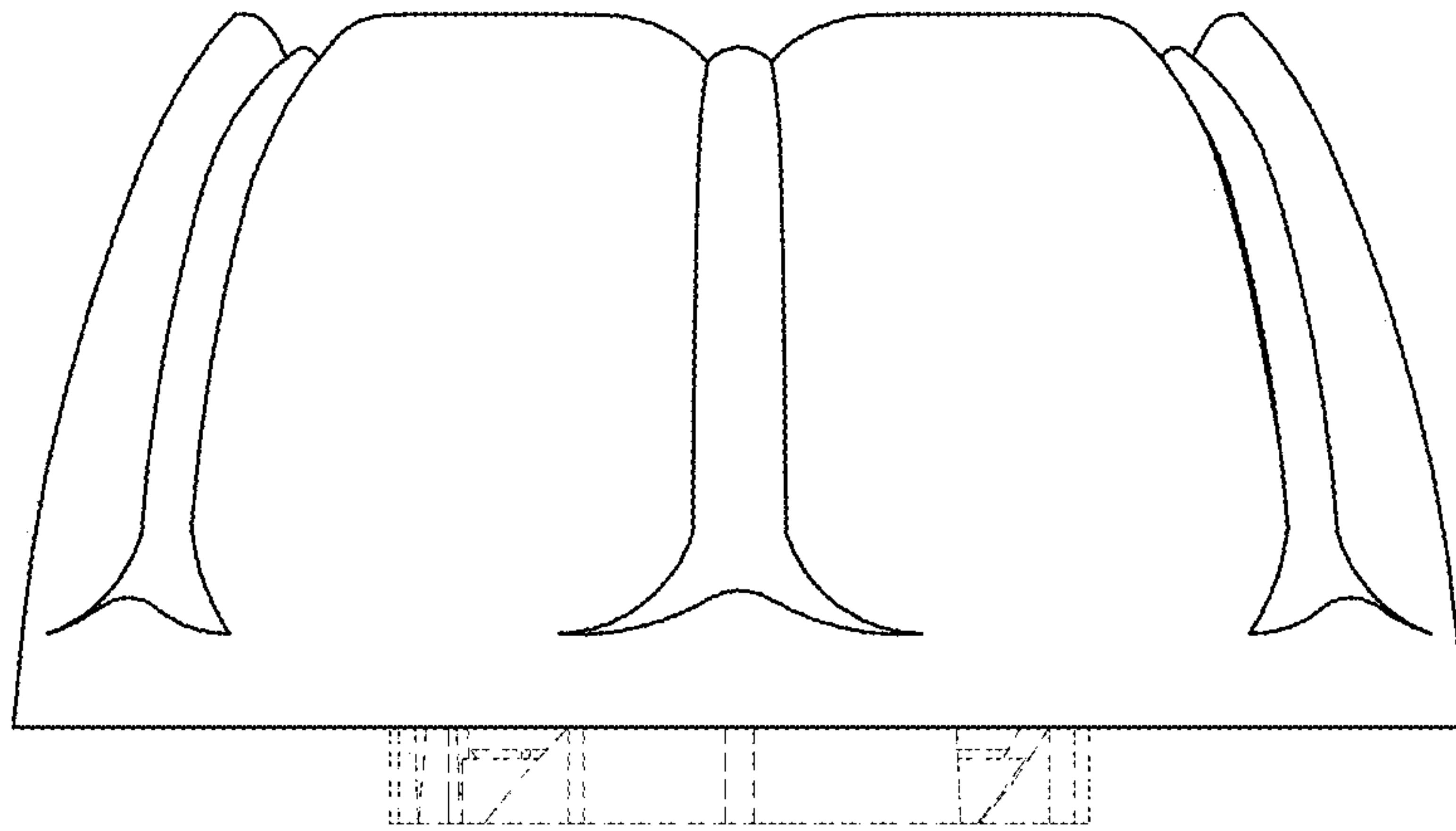

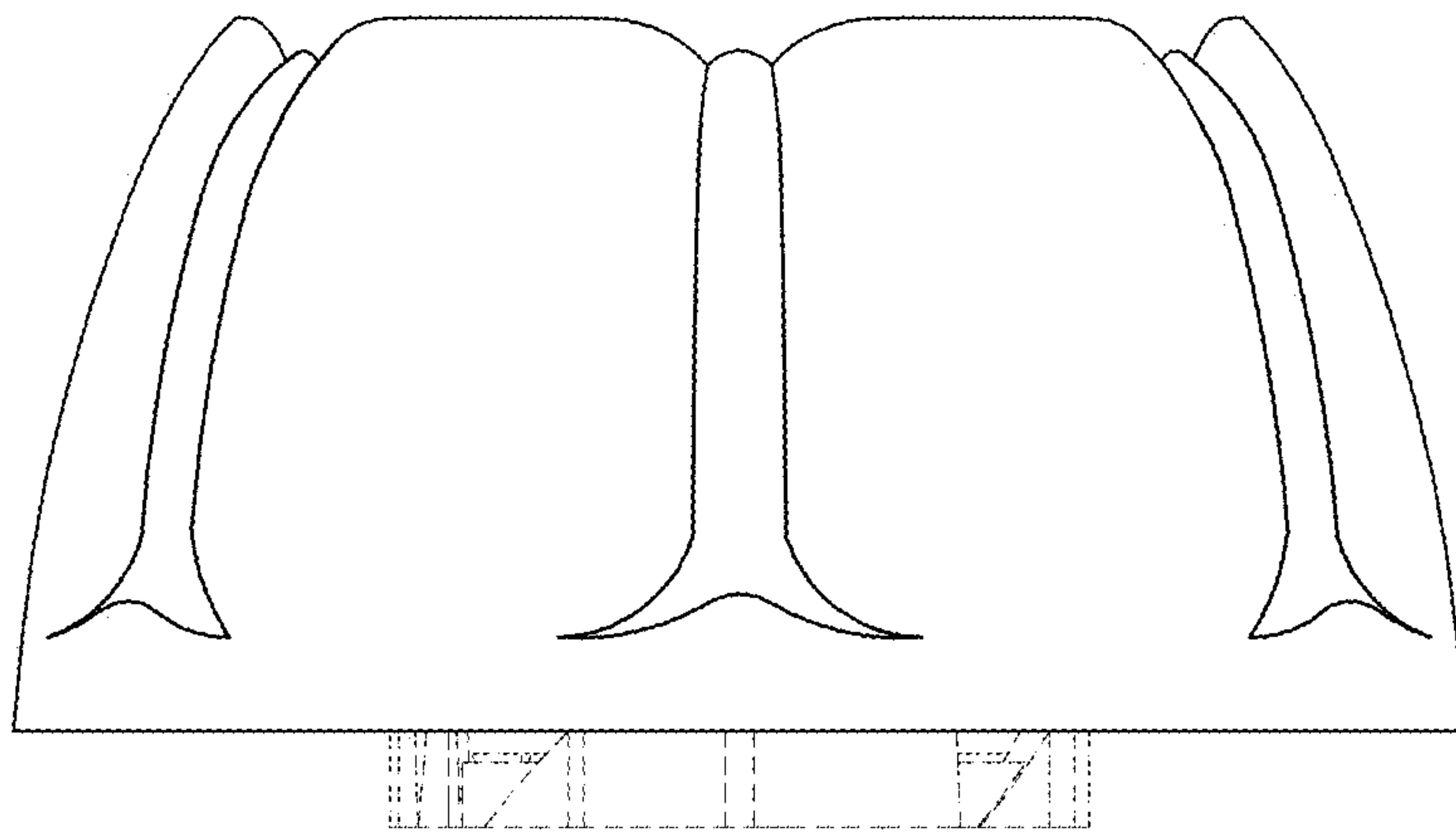

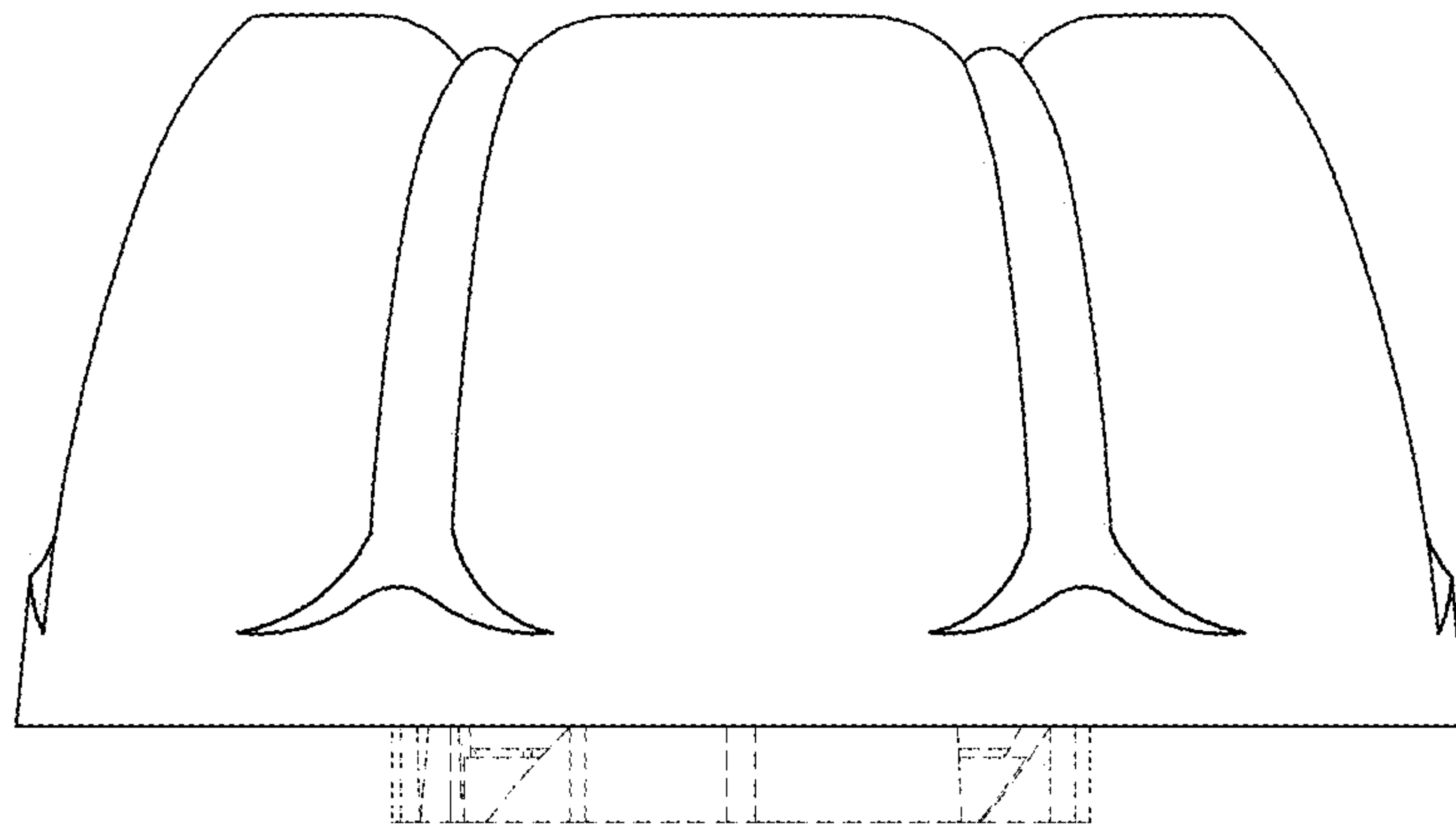

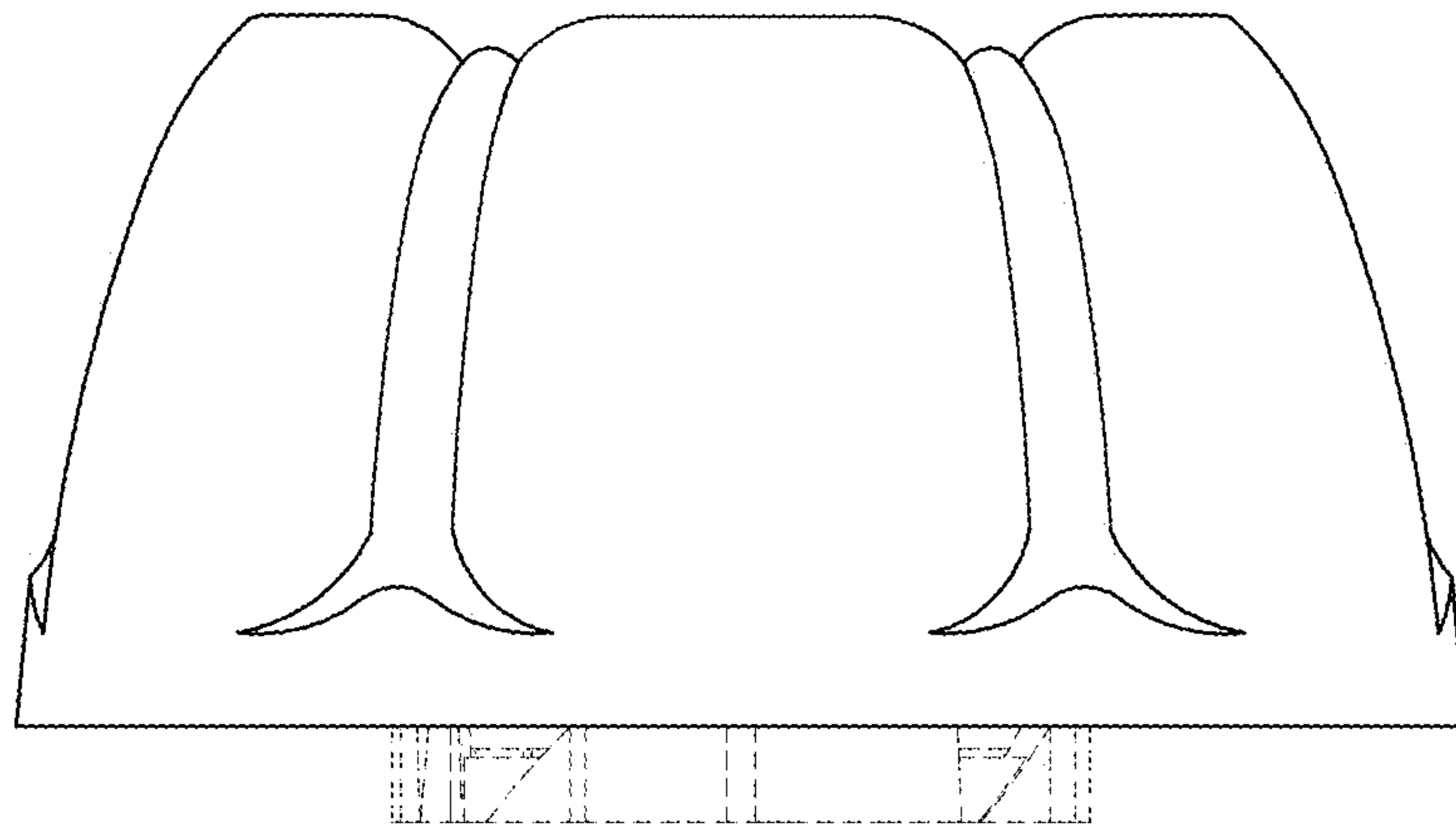

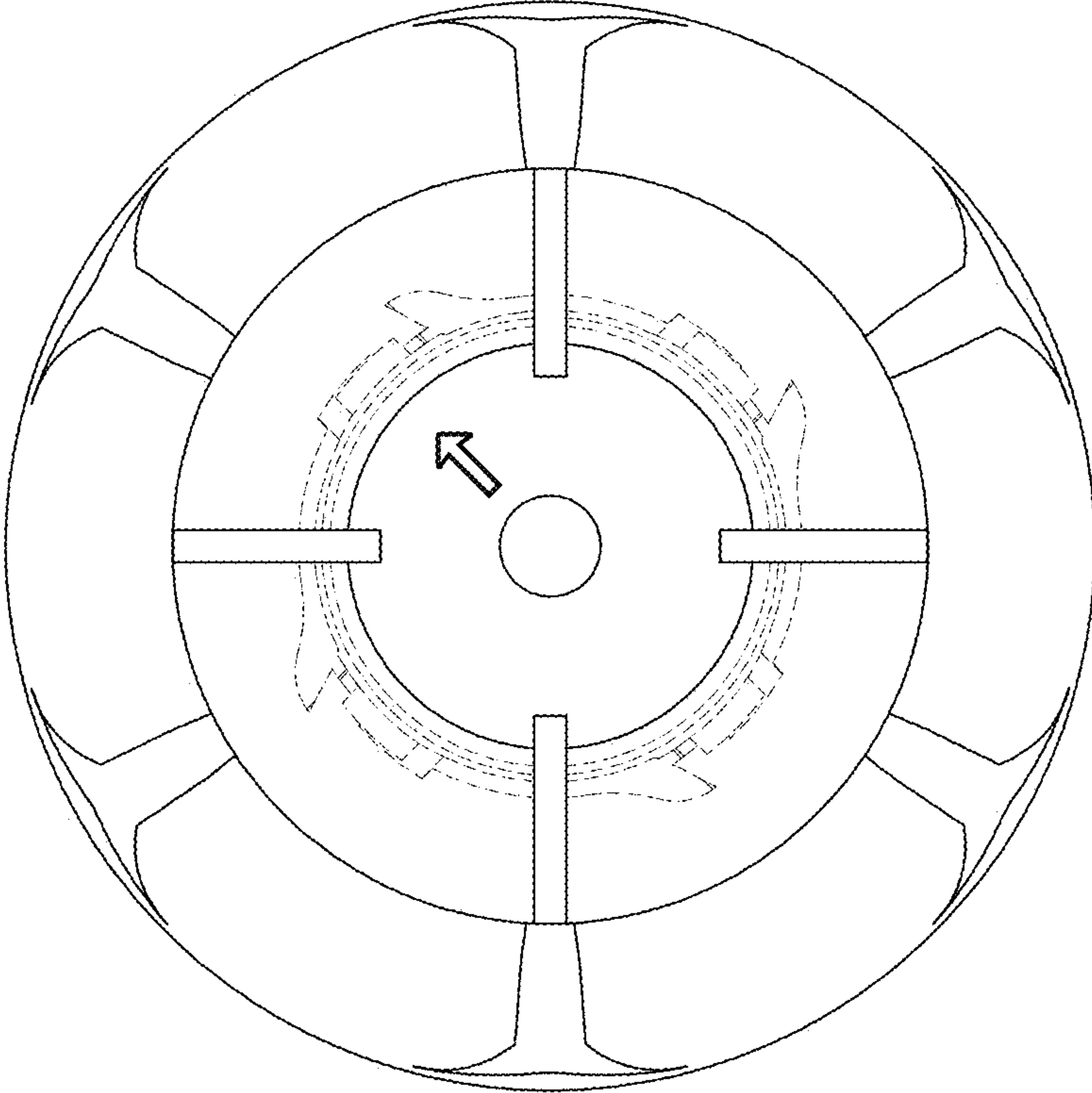

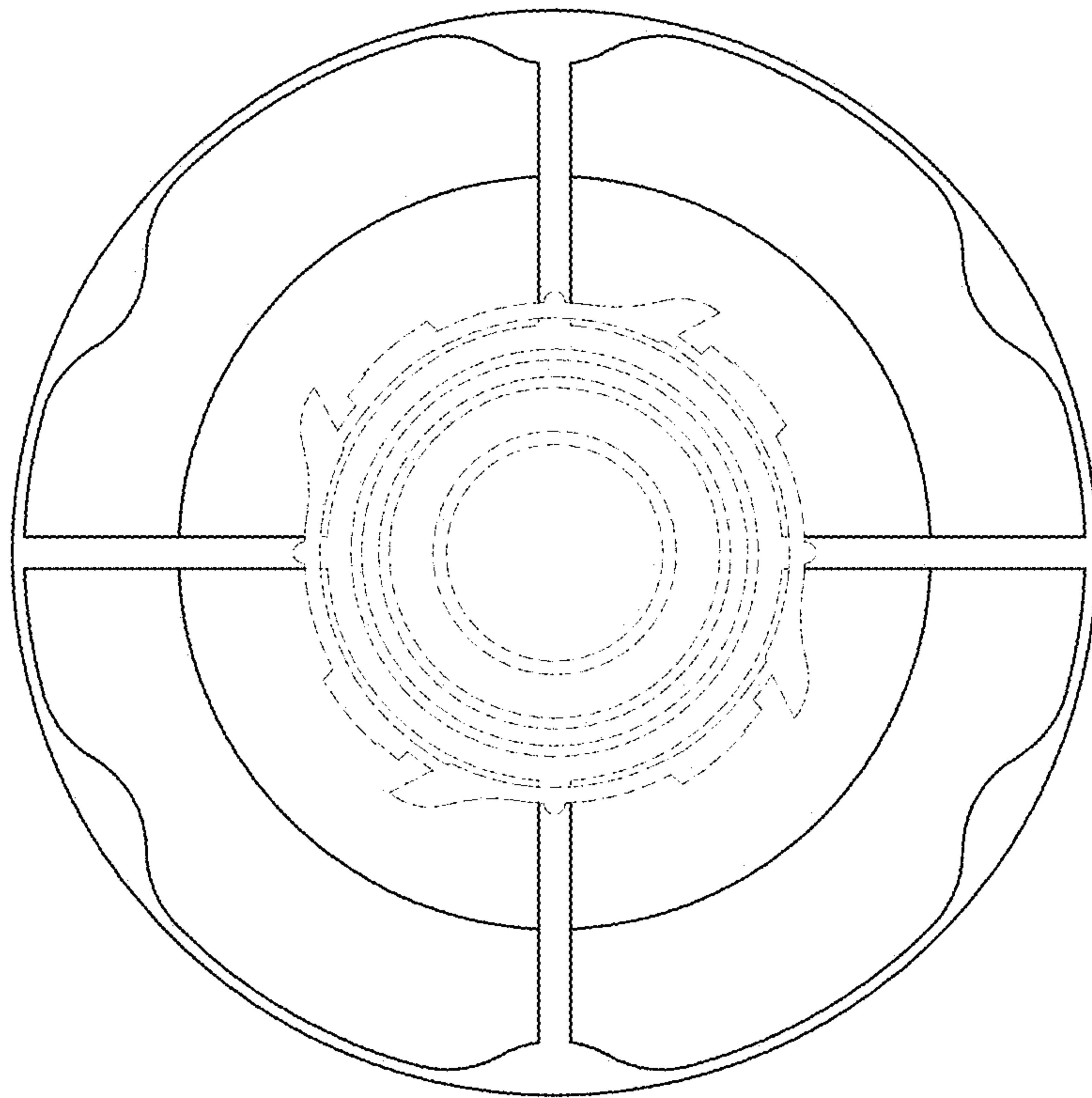
