The ornamental design for a packaging container, as shown and described.

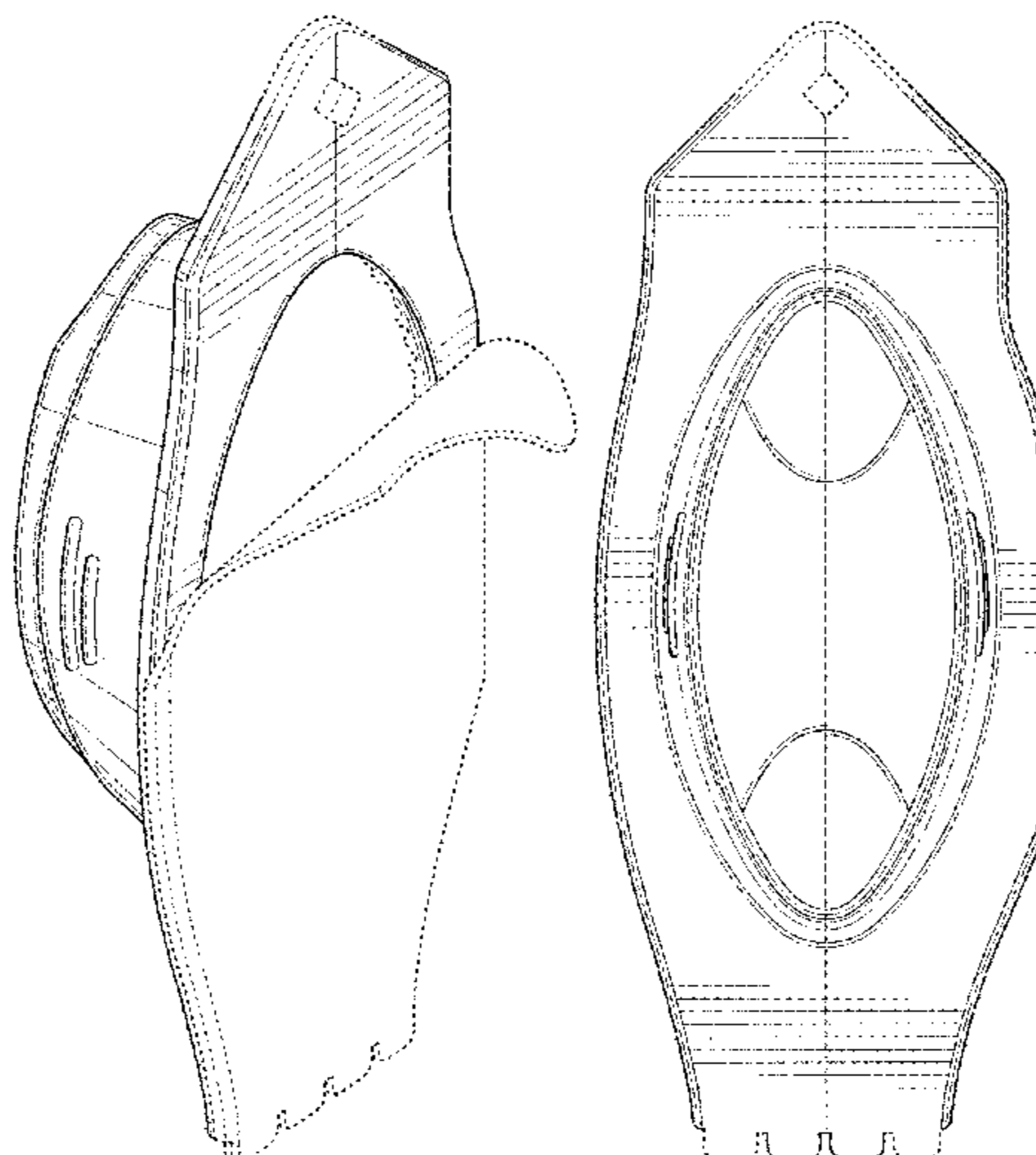
DESCRIPTION

FIG. 1 is an upper perspective view of a packaging container according to our new design, showing an additional packaging container as well as peelable lids for illustrative purposes;

FIG. 2 is a second upper perspective view of the packaging container showing a peelable lid for illustrative purposes; FIG. 3 is a third upper perspective view of the packaging container showing a peelable lid partially peeled away and pet food for illustrative purposes;

FIG. 4 is a top plan view of the packaging container; FIG. 5 is a bottom plan view of the packaging container; FIG. 6 is a left side view of the packaging container; FIG. 7 is a right side view of the packaging container; FIG. 8 is a first end view of the packaging container; and, FIG. 9 is a second end view of the packaging container. The broken lines shown represent portions of the claimed design and illustrative subject matter, all of which form no part of the claimed design.

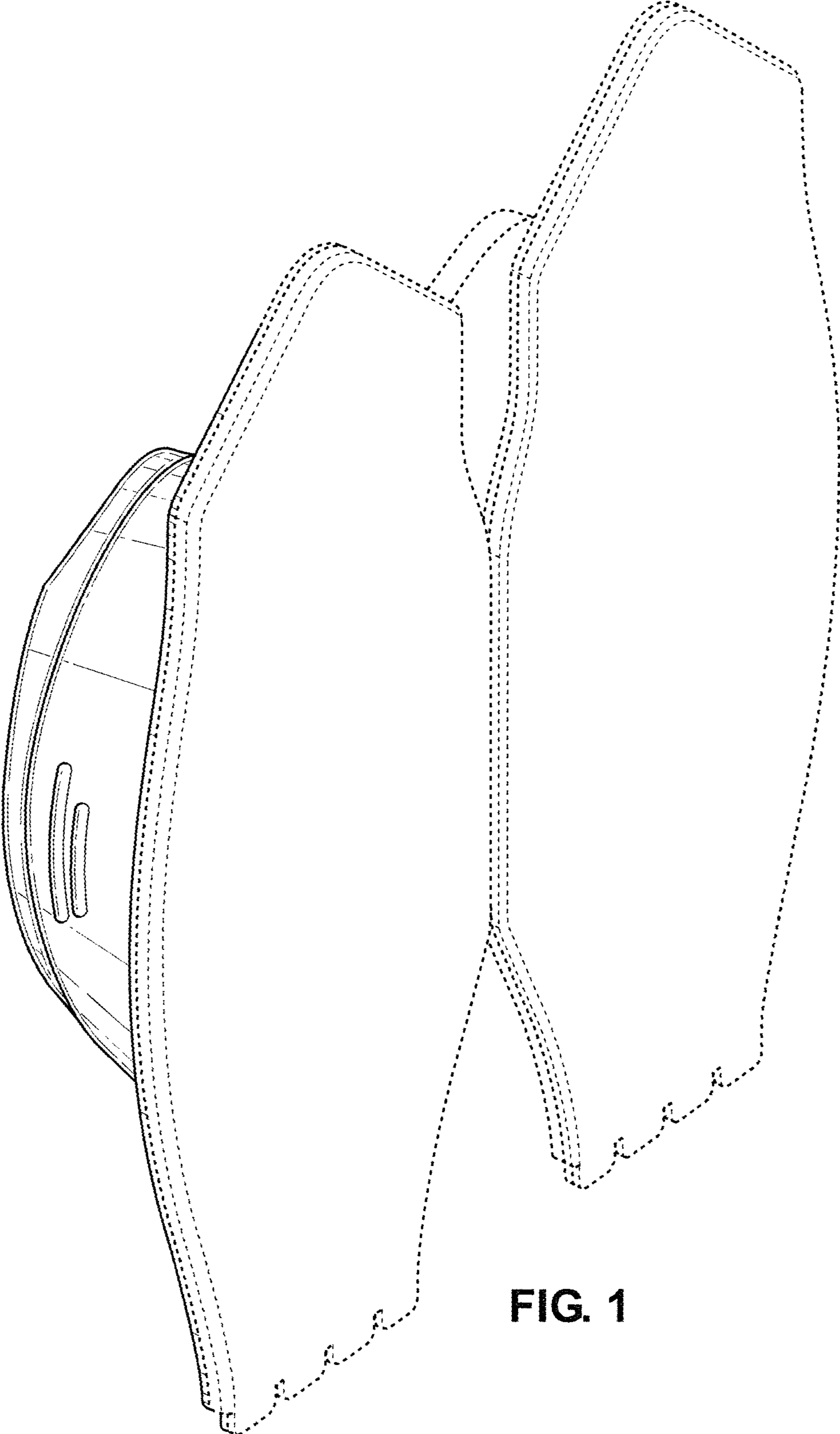

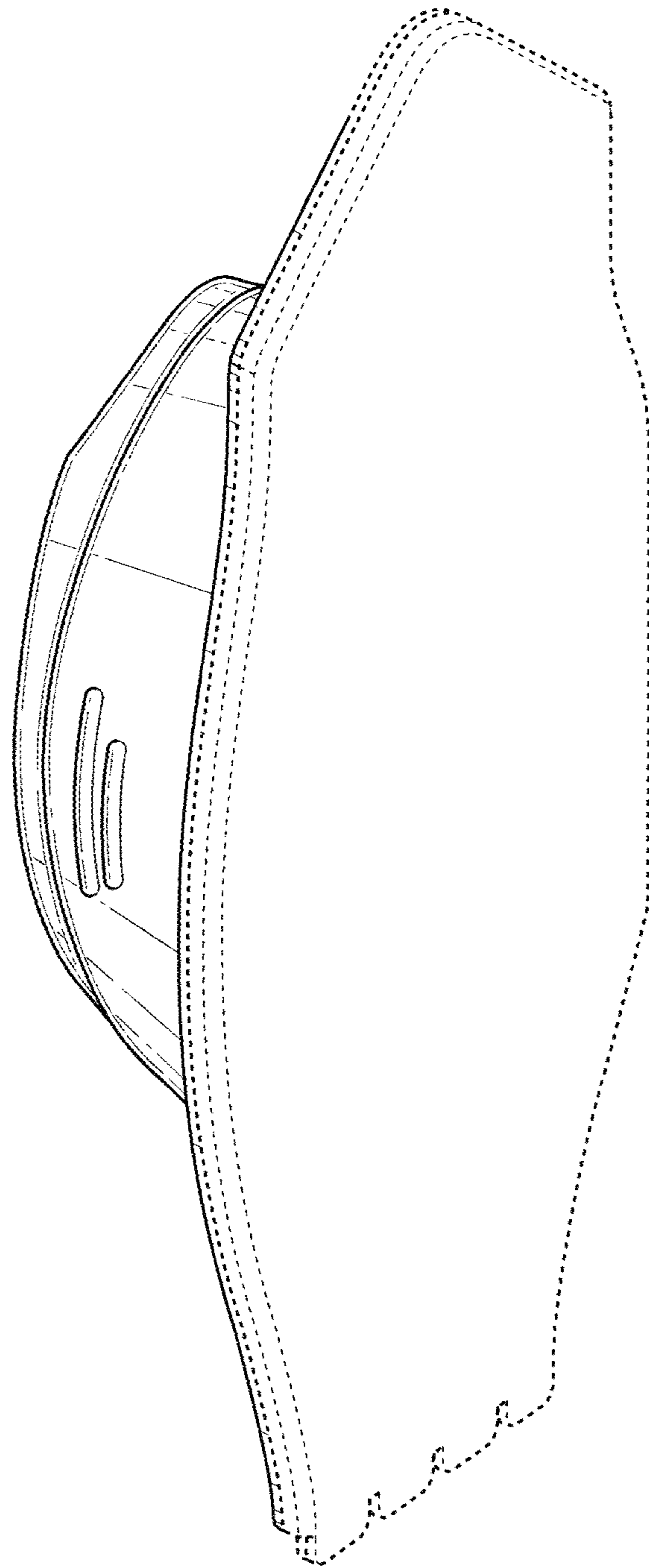

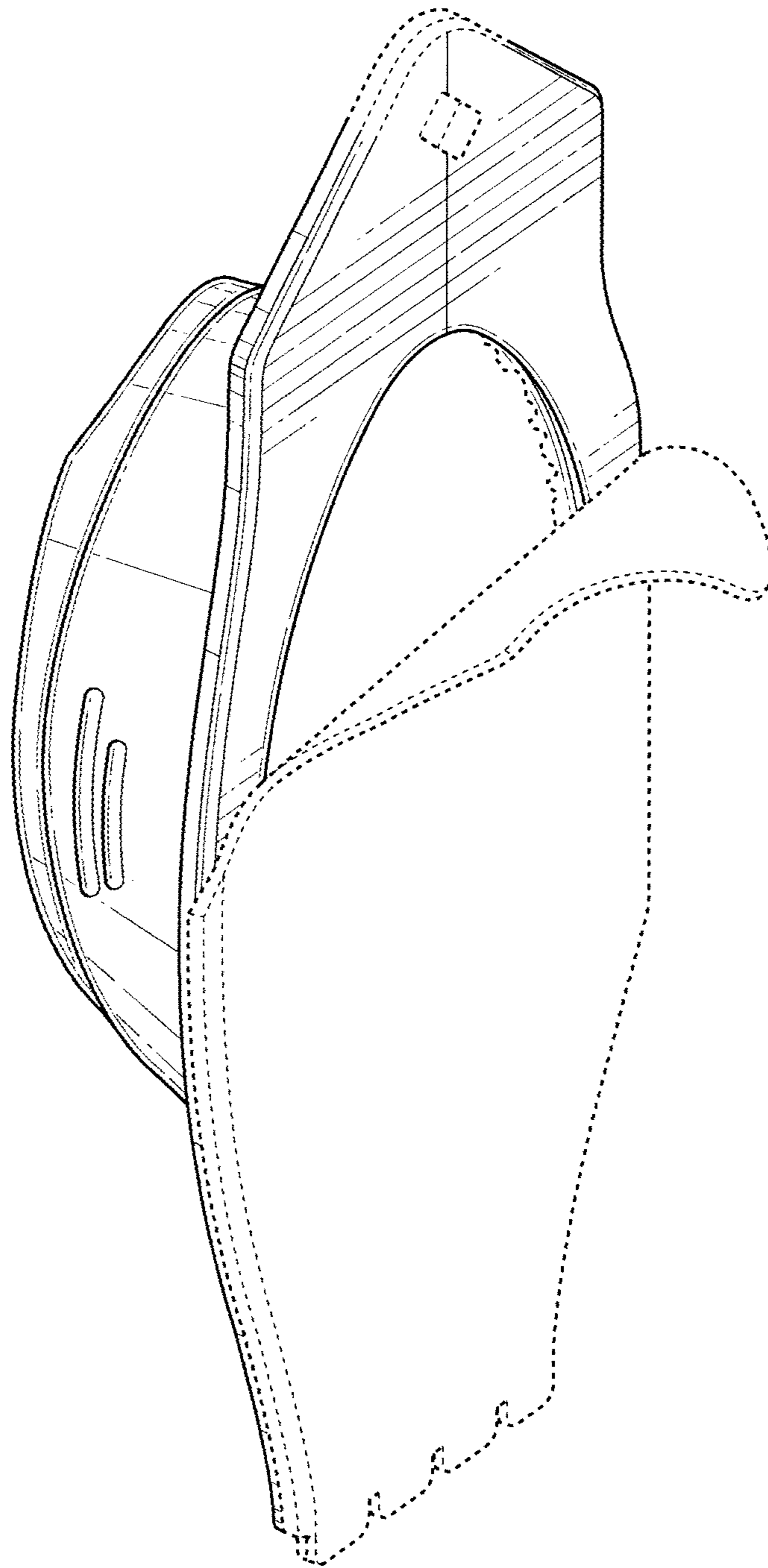

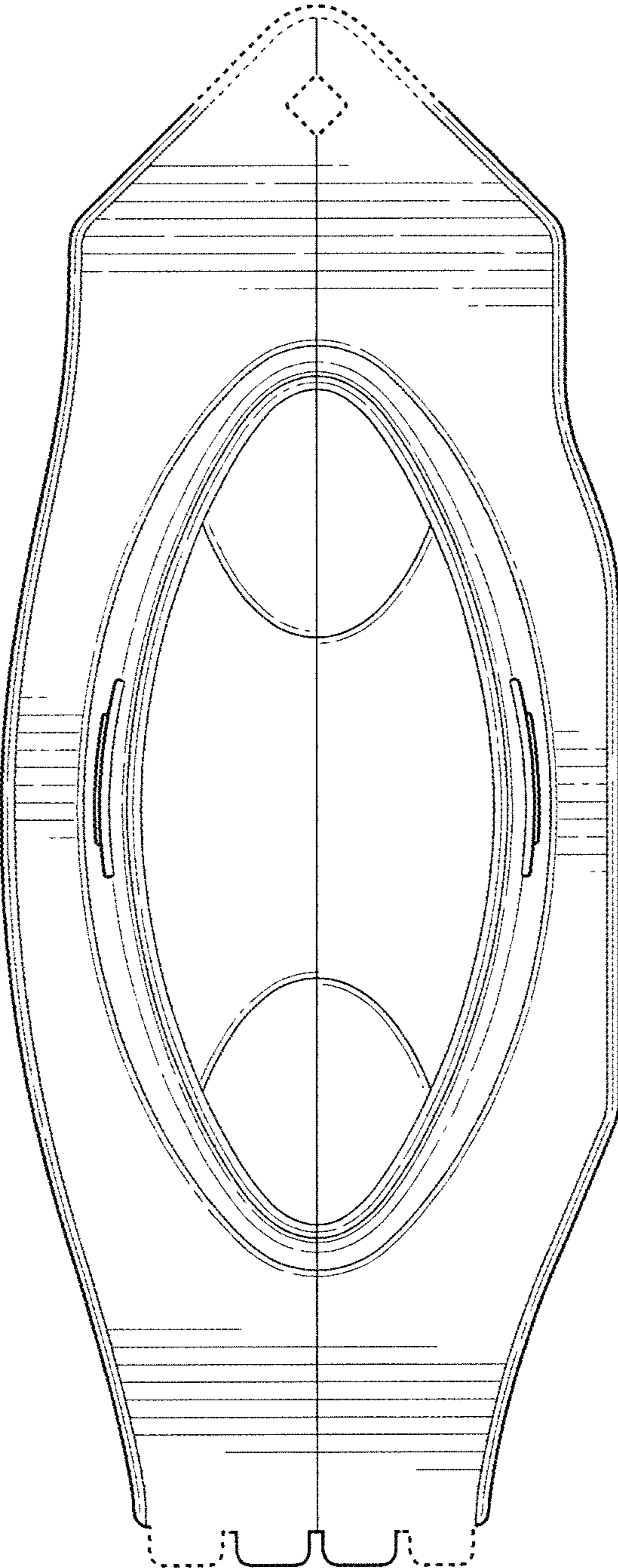

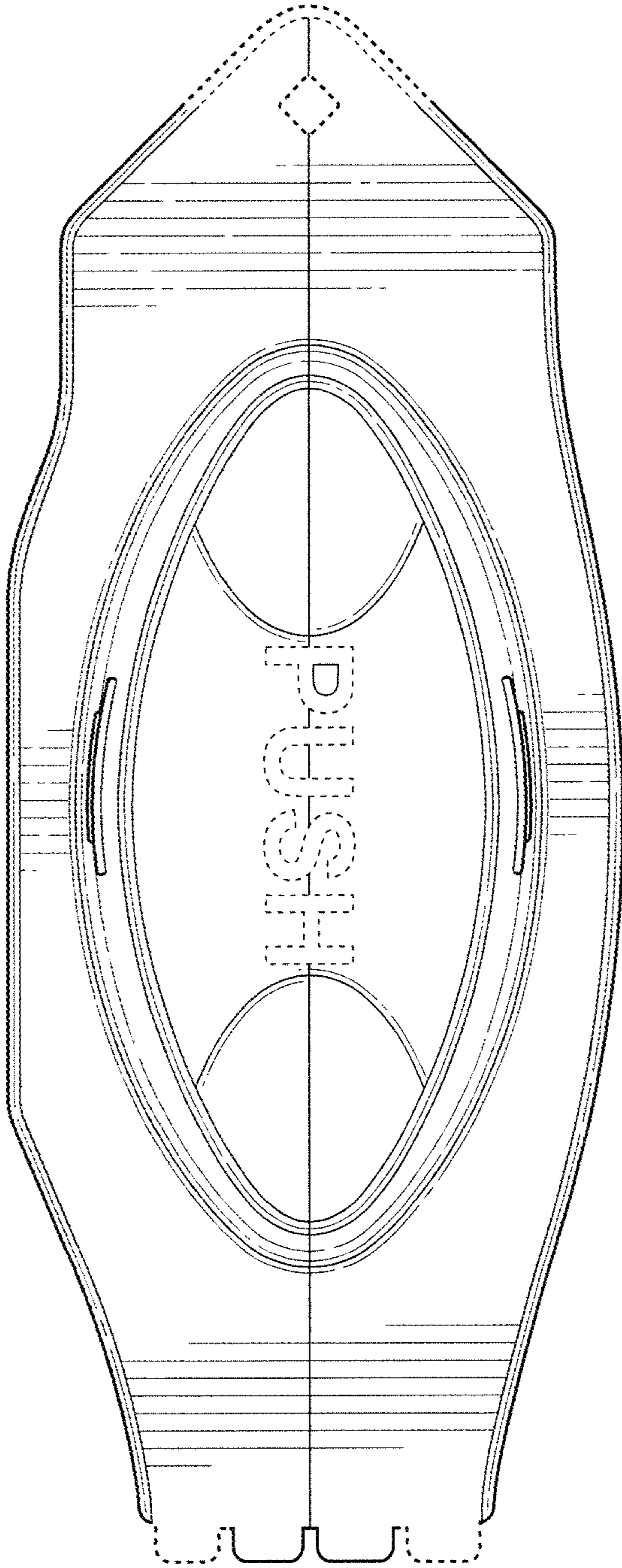

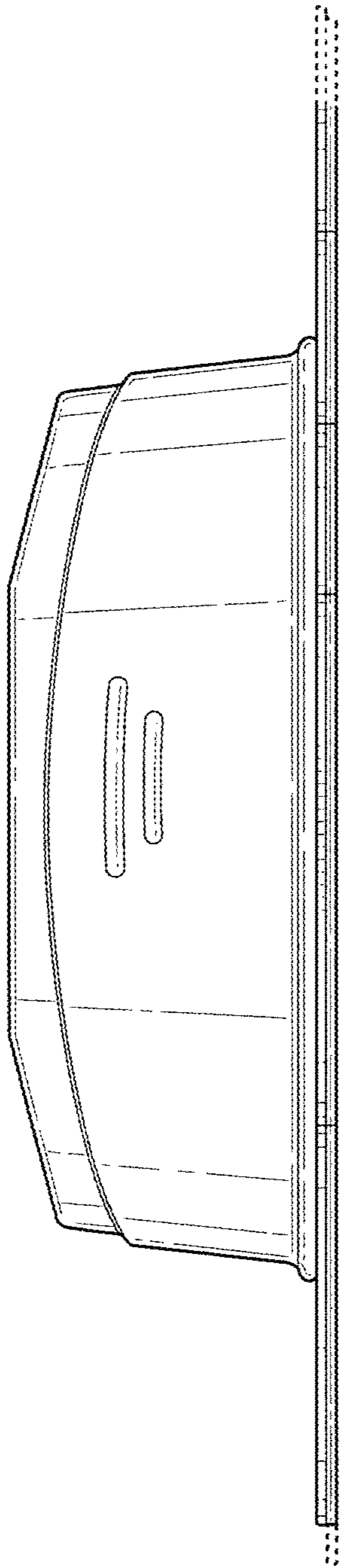

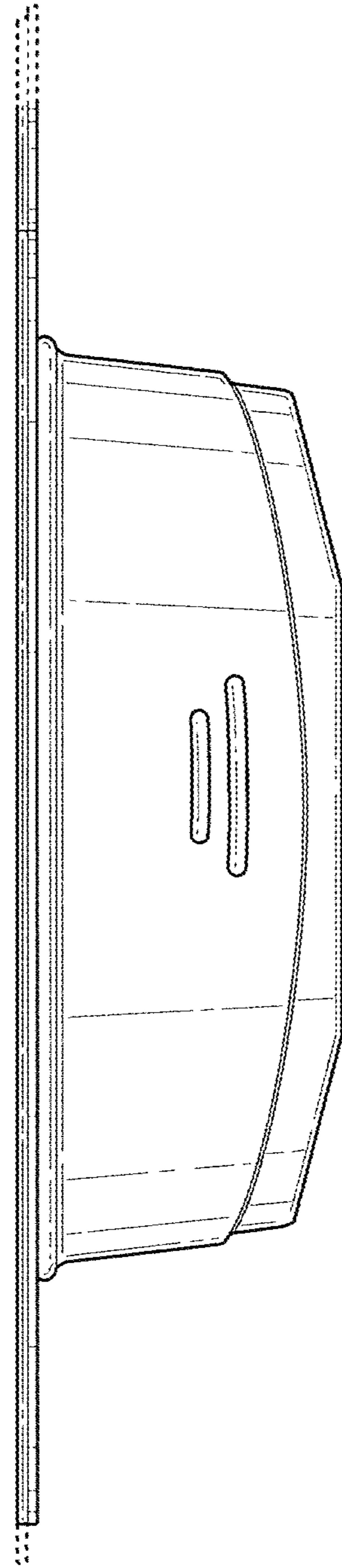

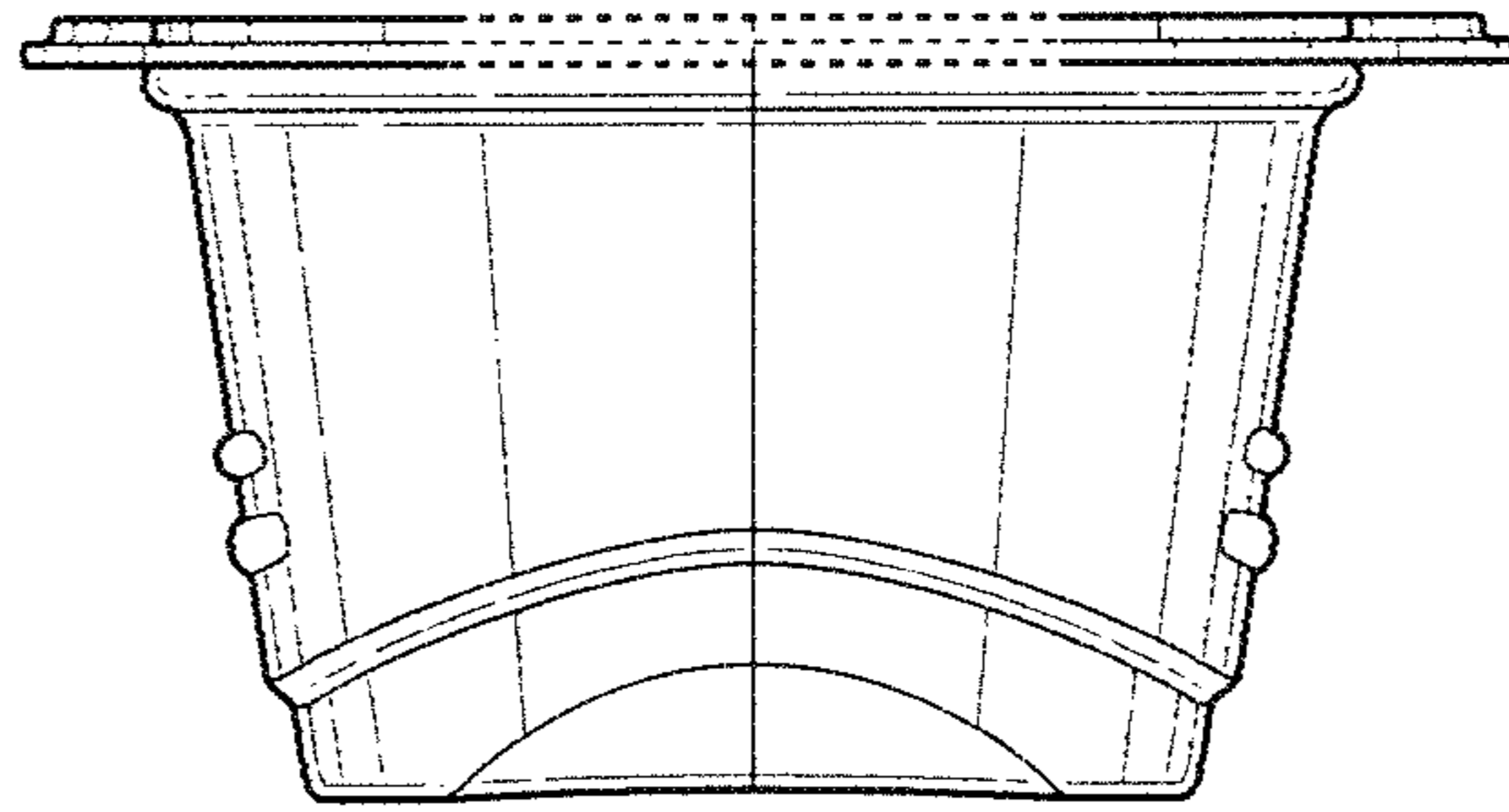

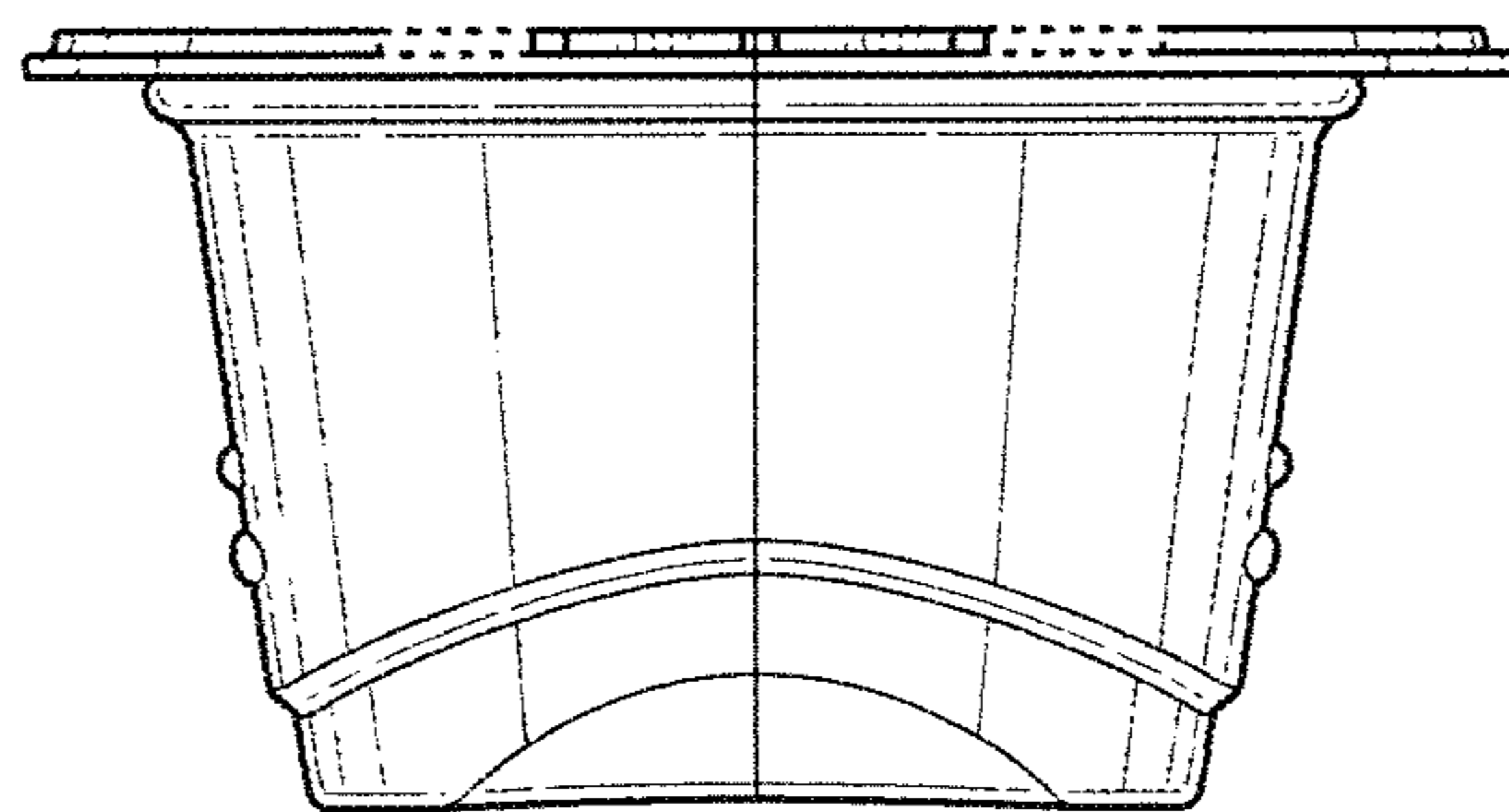
