(57) **CLAIM**

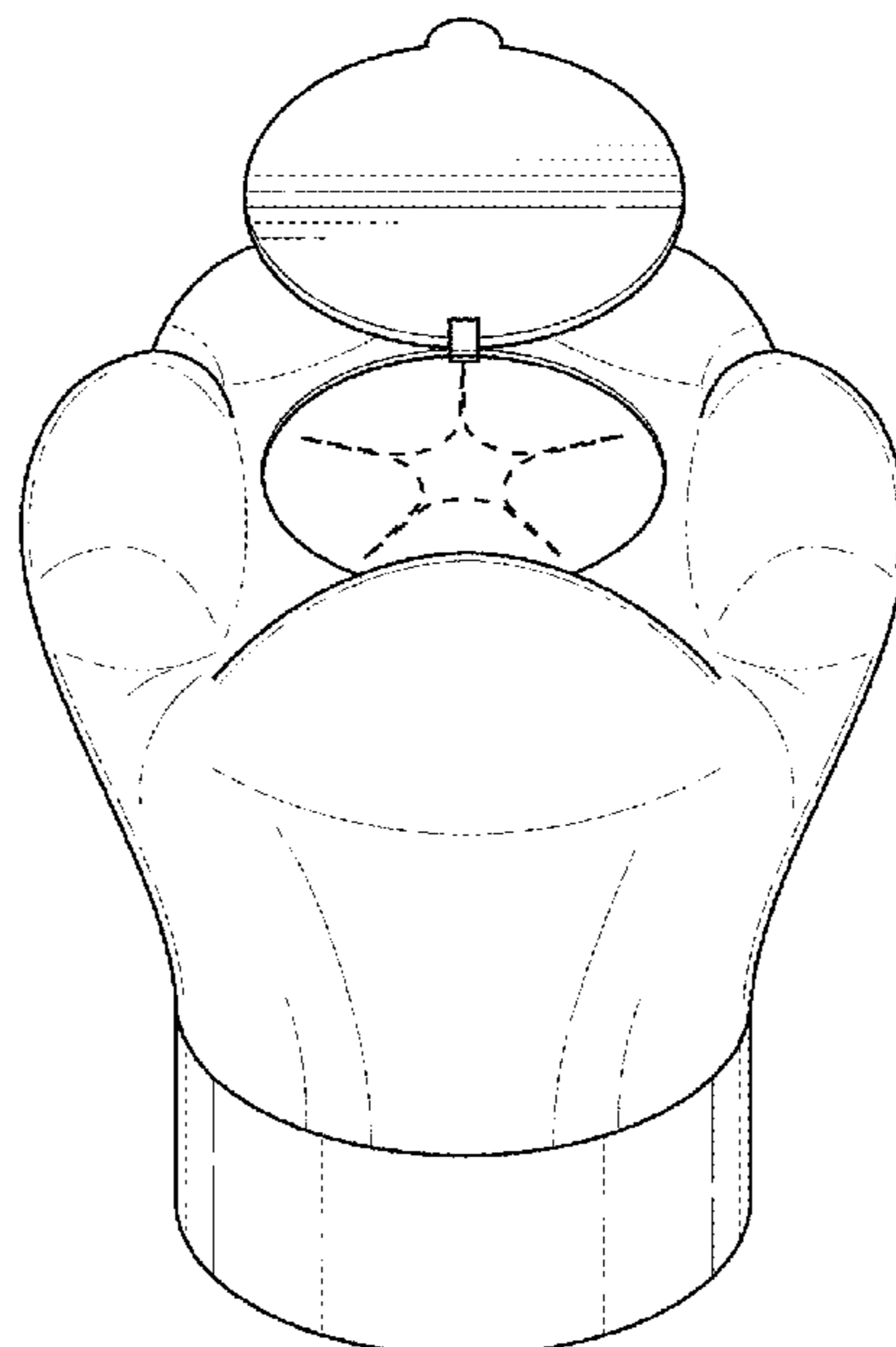
The ornamental design for a baking wipe container, as shown and described.

DESCRIPTION

FIG. 1 shows a perspective view of a baking wipe container. FIG. 2 shows a front view of the baking wipe container. FIG. 3 shows a rear view of the baking wipe container. FIG. 4 shows a right side view of the baking wipe container. FIG. 5 shows a left side view of the baking wipe container. FIG. 6 shows a top plan view of the baking container; and, FIG. 7 shows a bottom plan view of the baking wipe container.
The shade lines in the Figures show contour and not surface ornamentation.

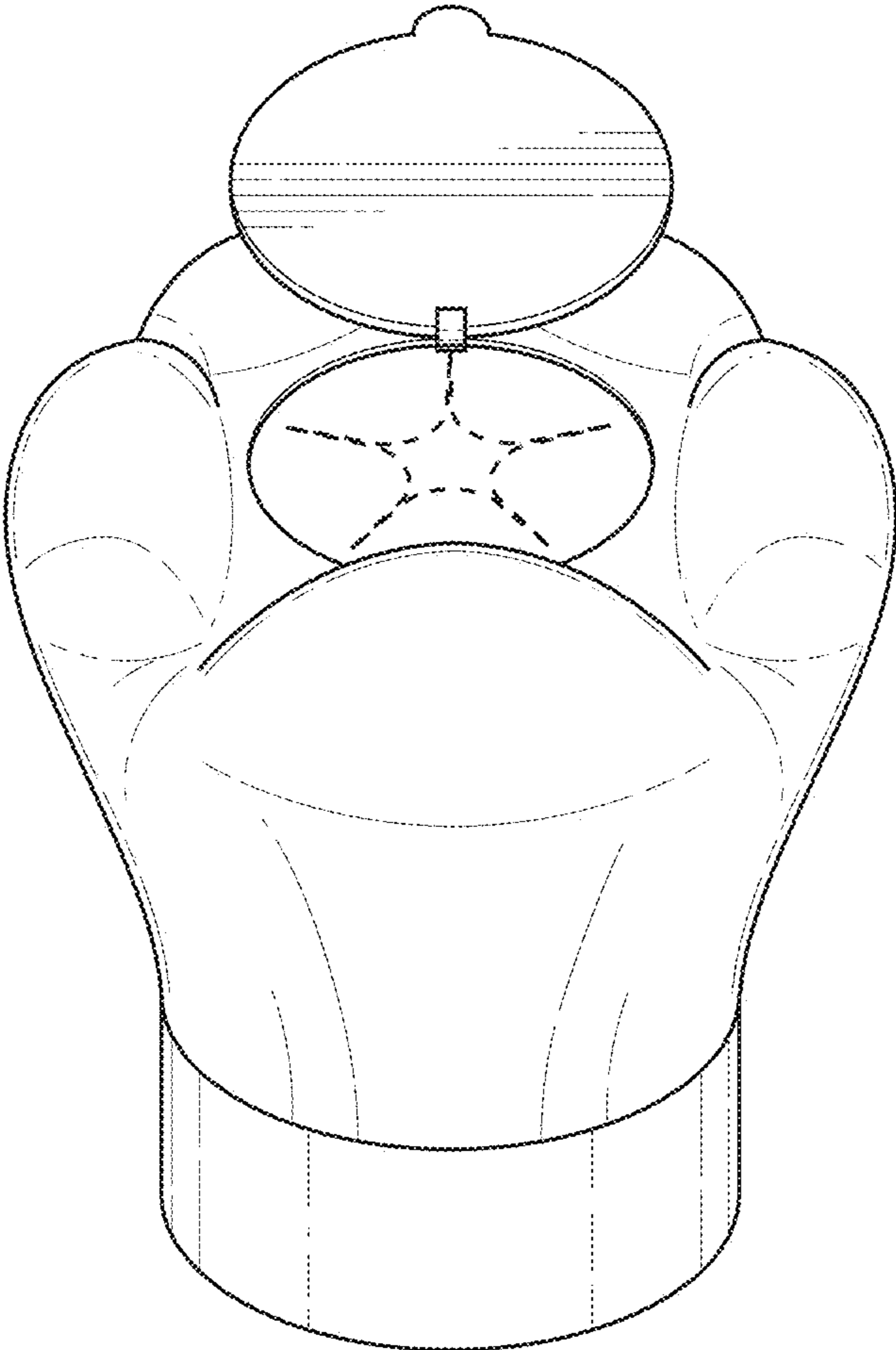

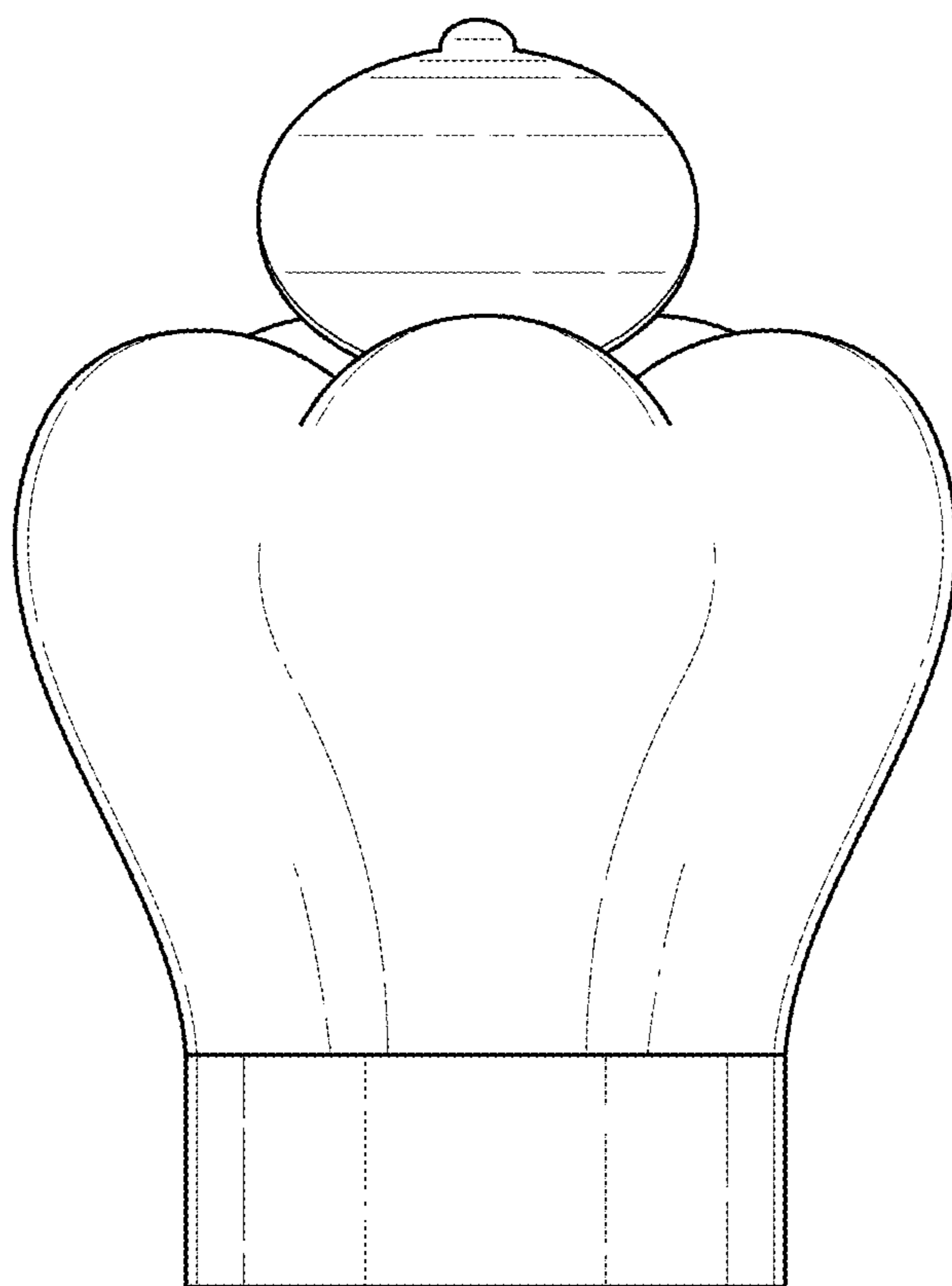

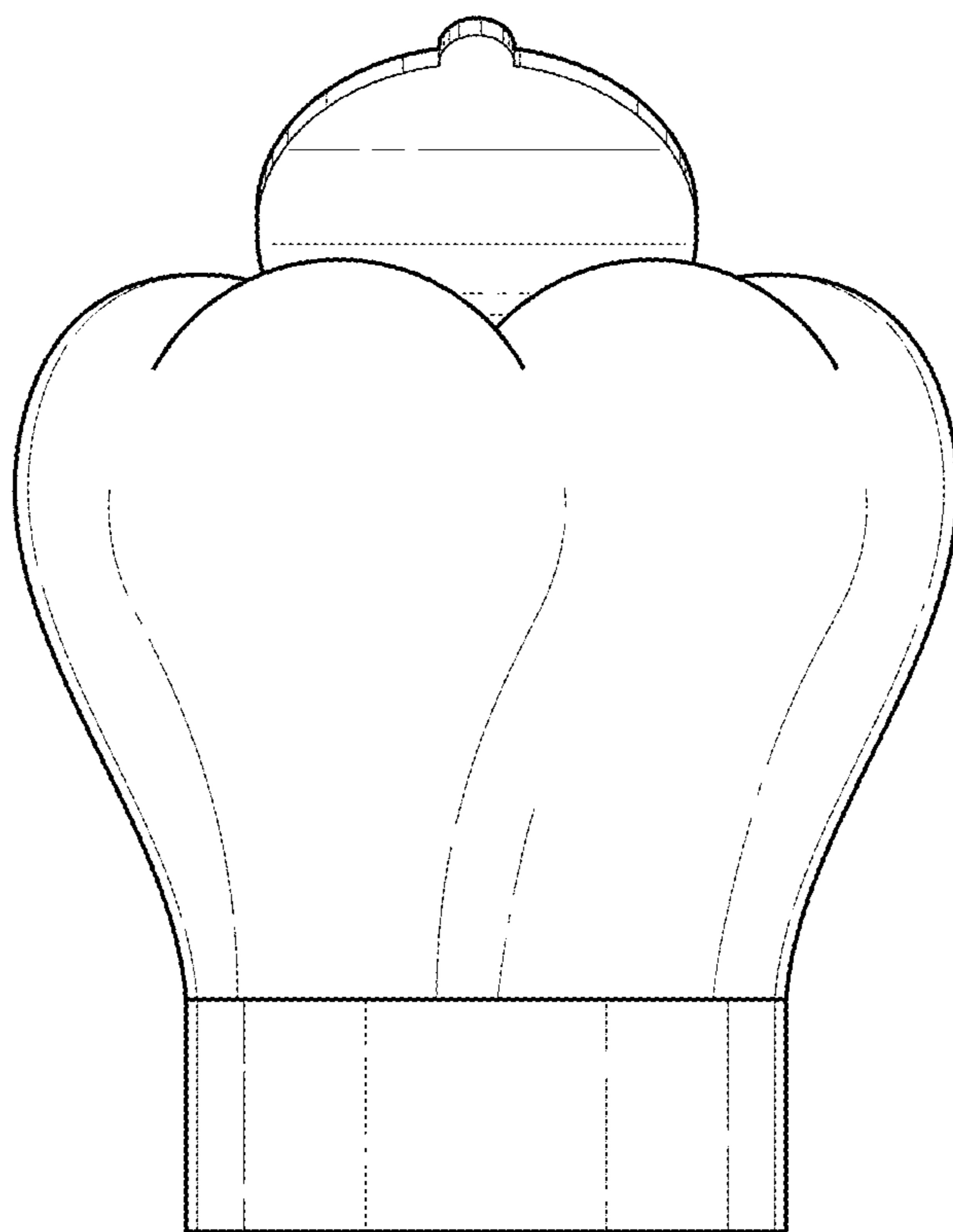

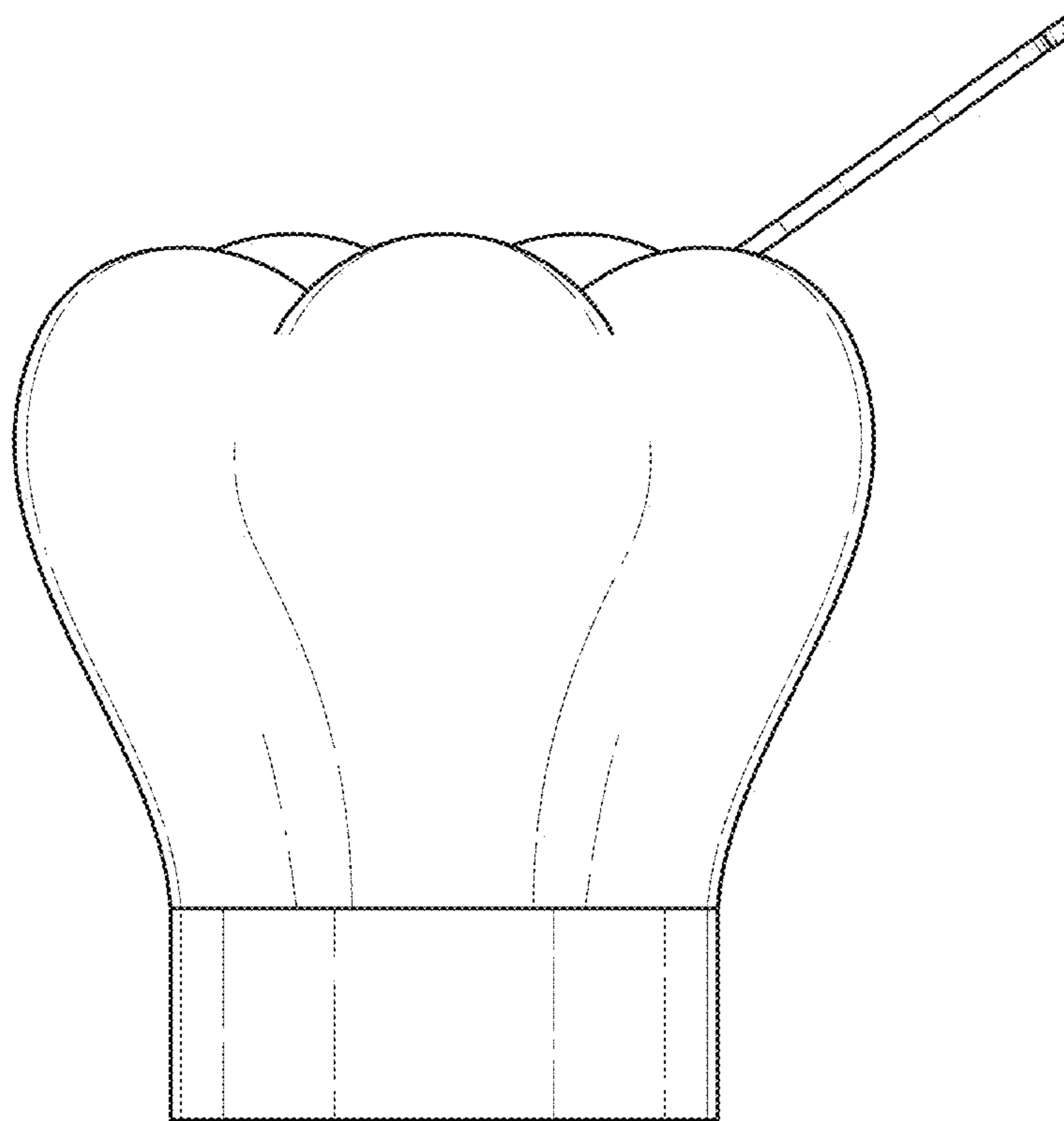

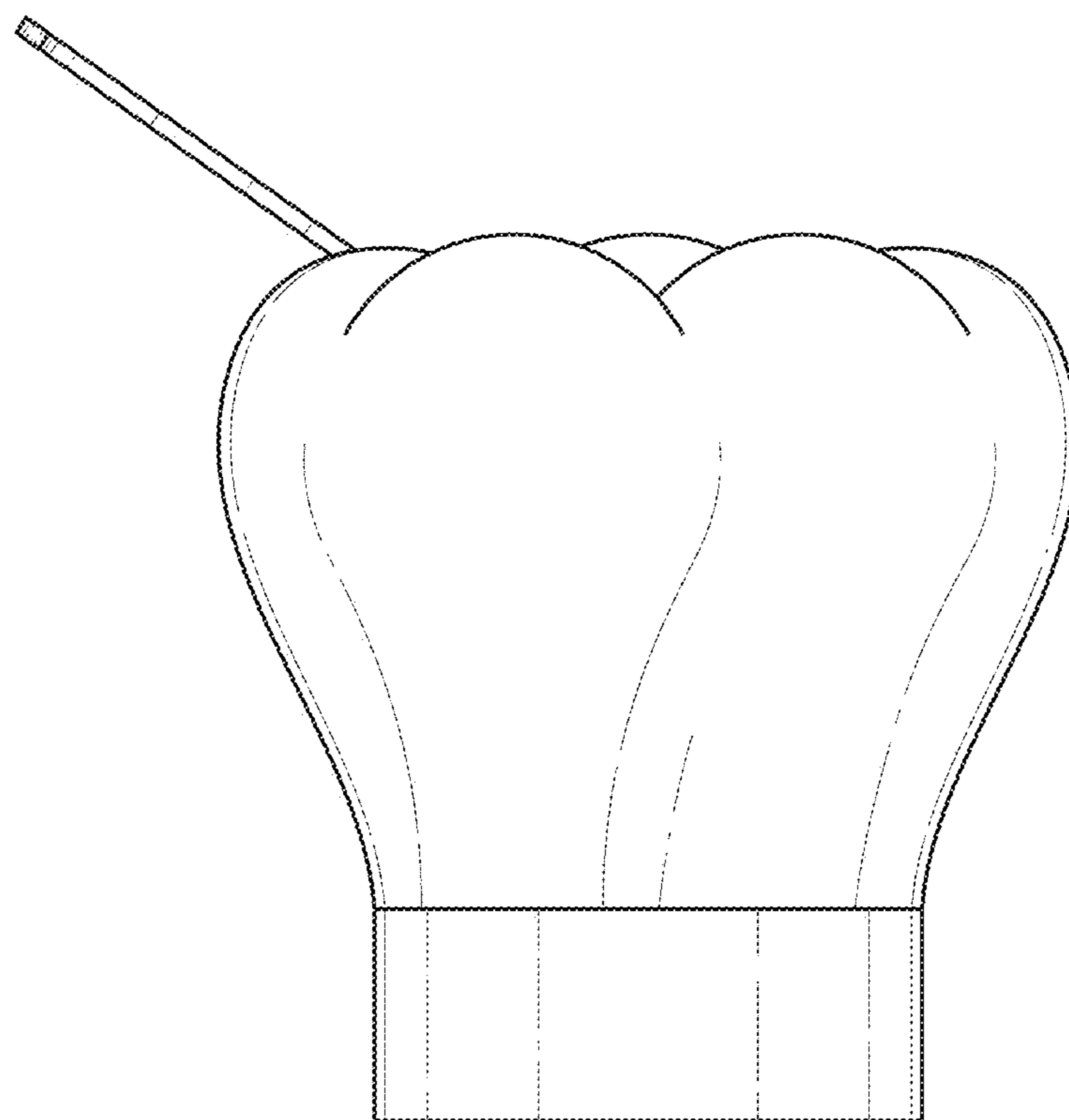

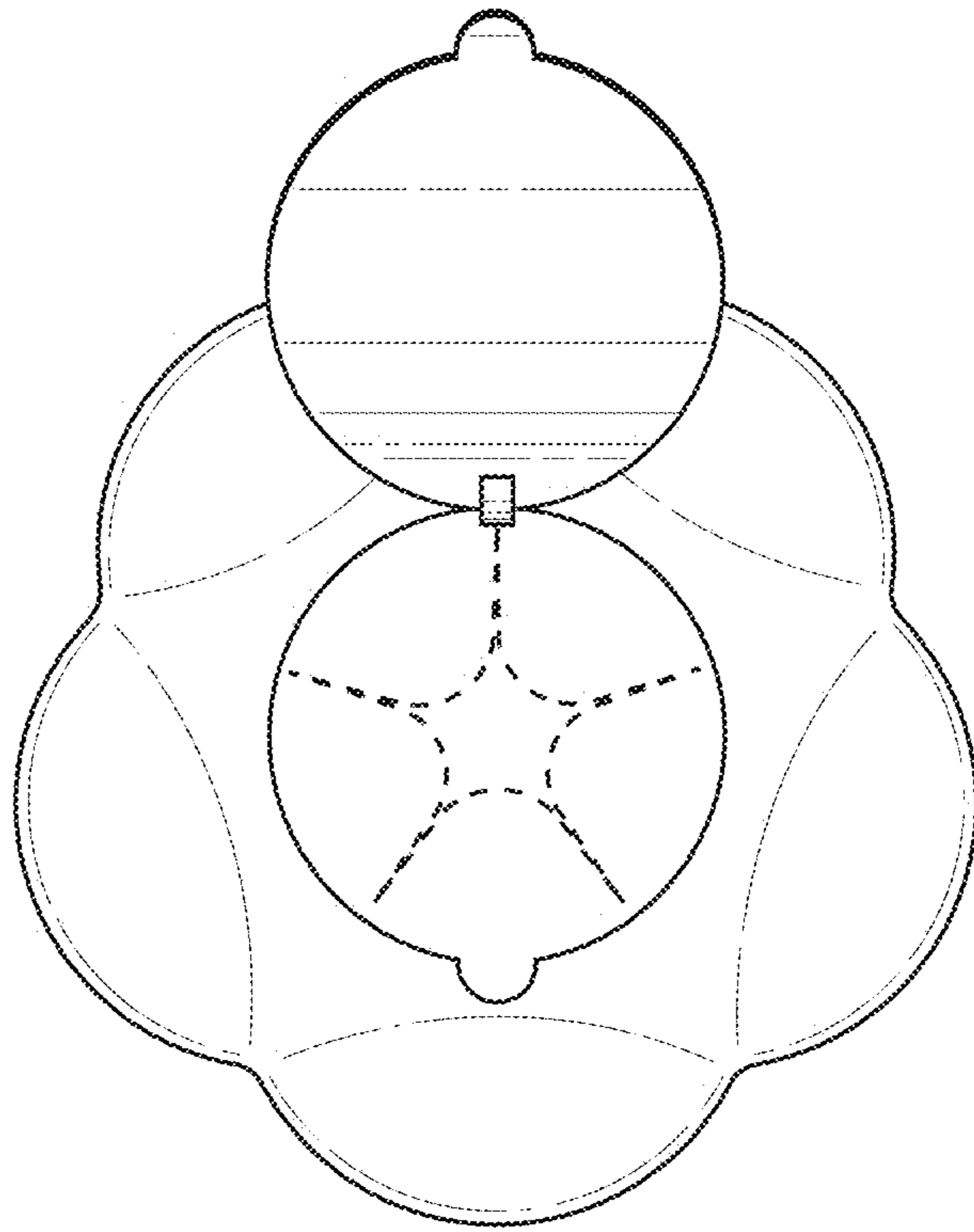

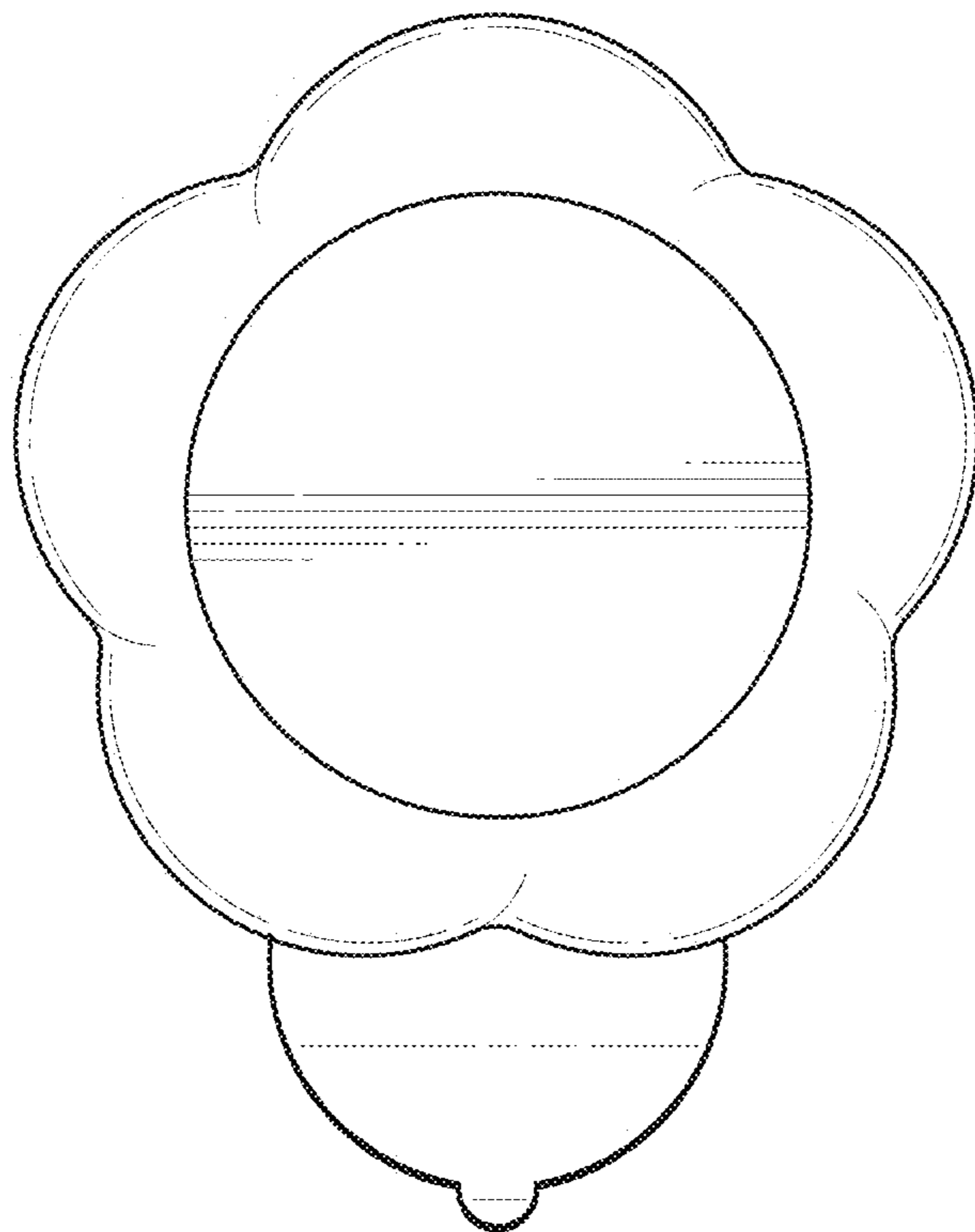
