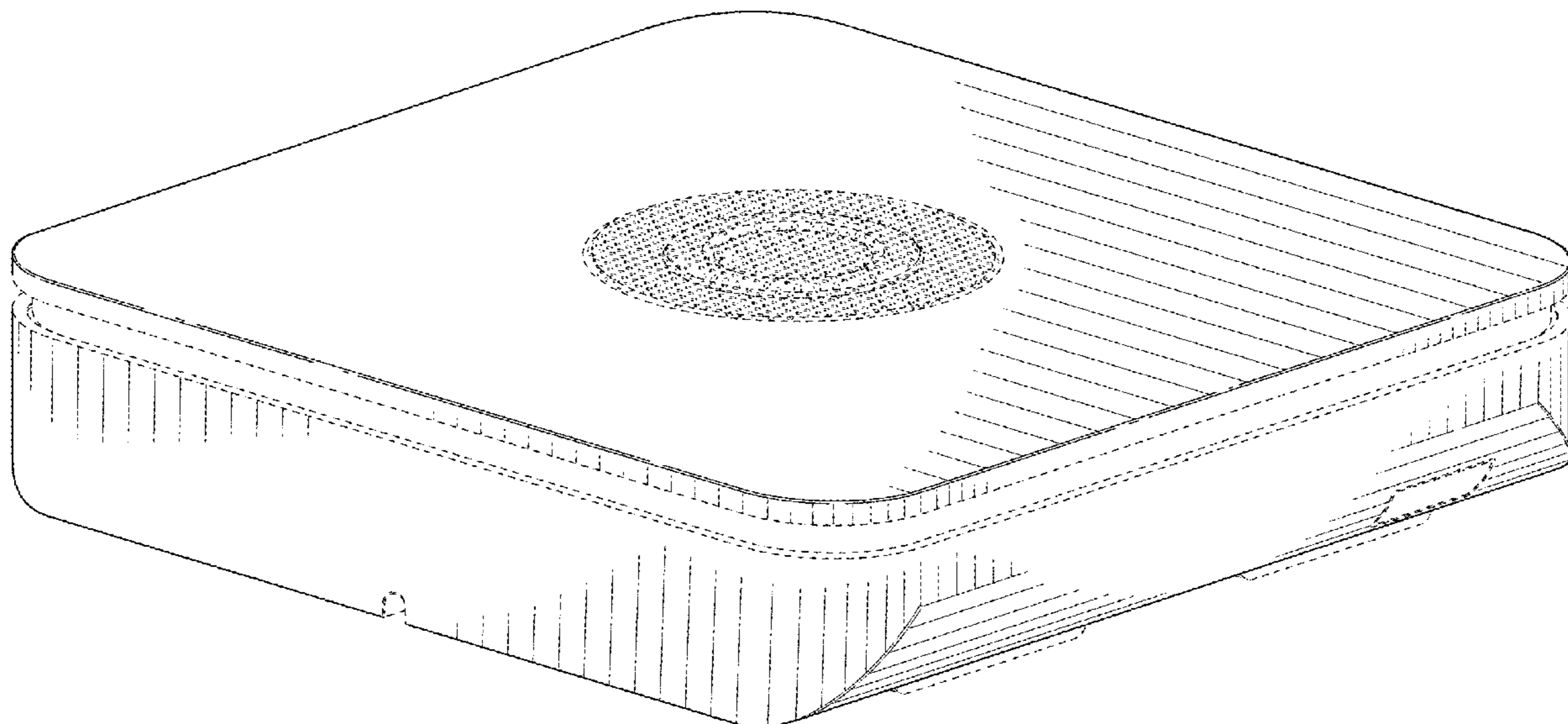
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of the hub according to the
present design;
FIG. 2 is a front elevational view of the hub of FIG. 1;
FIG. 3 is a rear elevational view of the hub of FIG. 1;
FIG. 4 is a left-side elevational view of the hub of FIG. 1;
FIG. 5 is a right-side elevational view of the hub of FIG. 1;
FIG. 6 is a top plan view of the hub of FIG. 1; and,
FIG. 7 is a bottom plan view of the hub of FIG. 1.

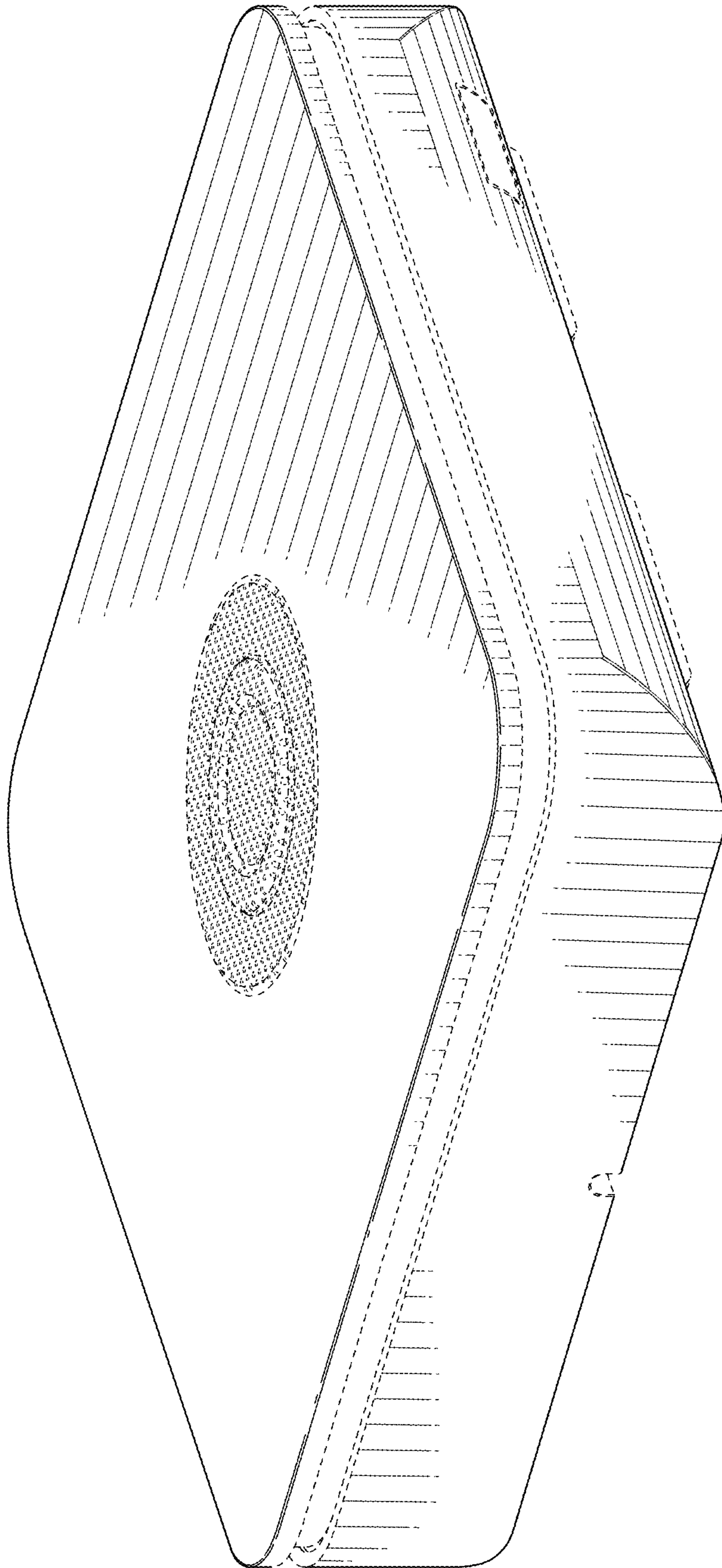

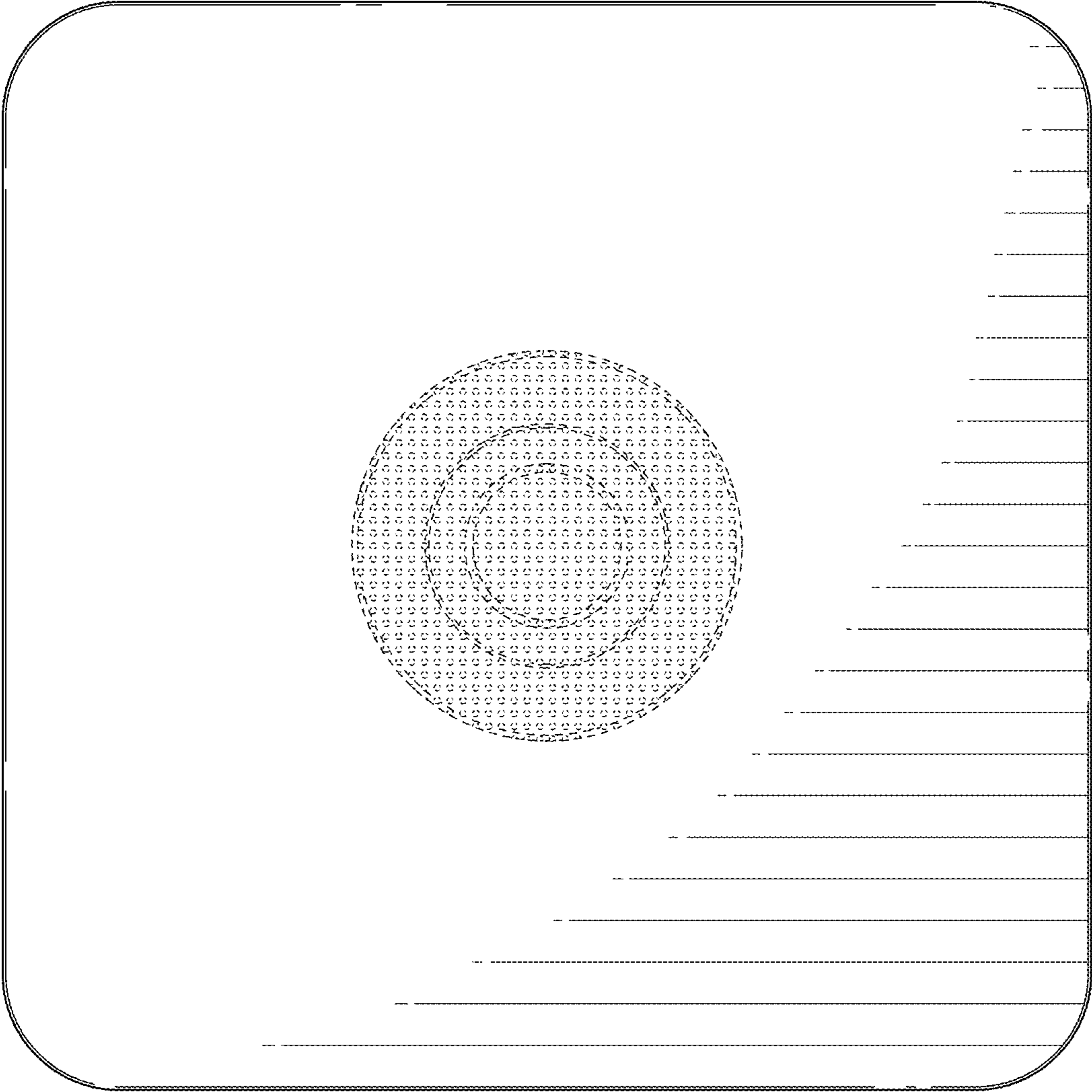

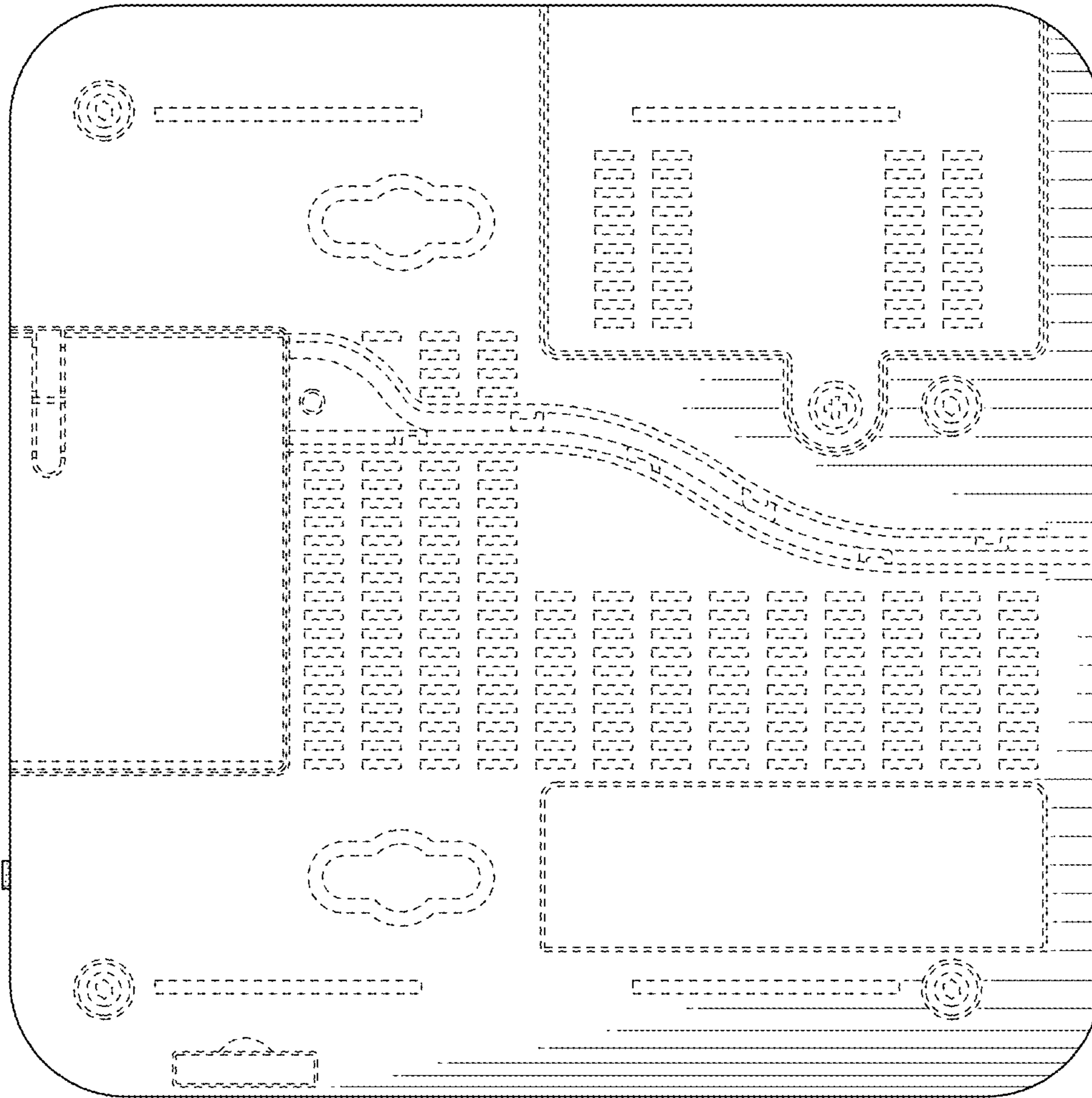

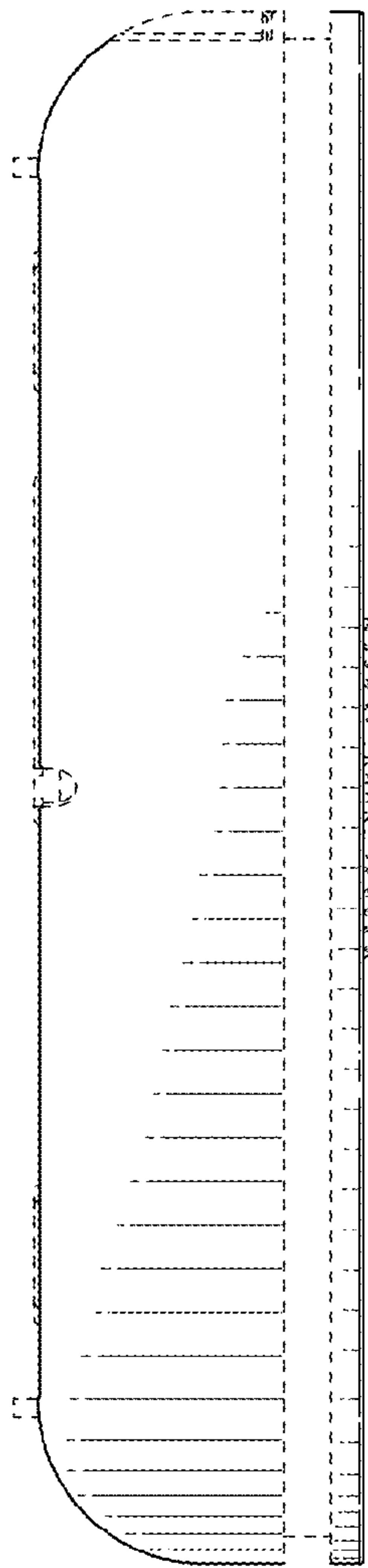

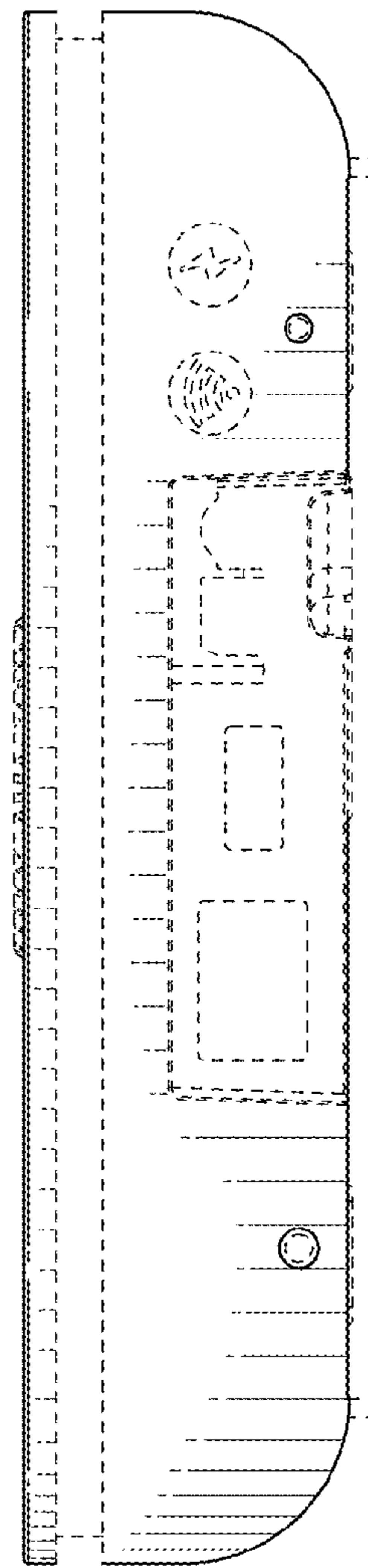

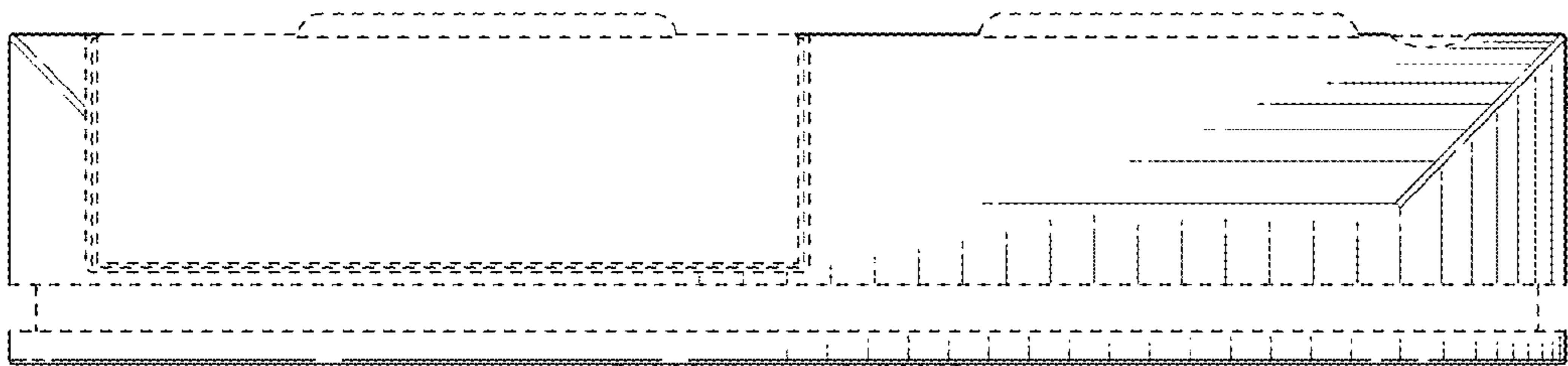

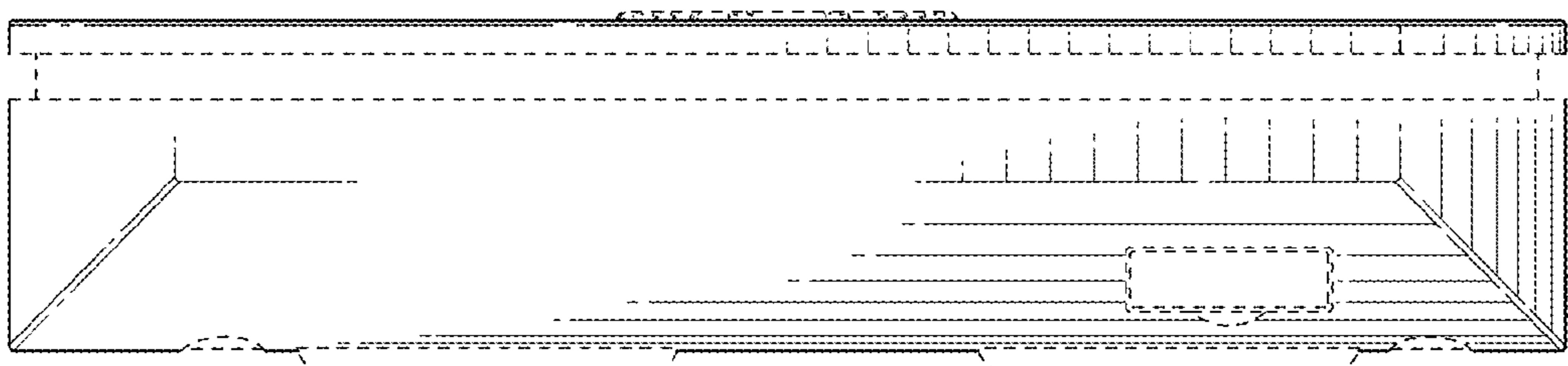
