(57) **CLAIM**

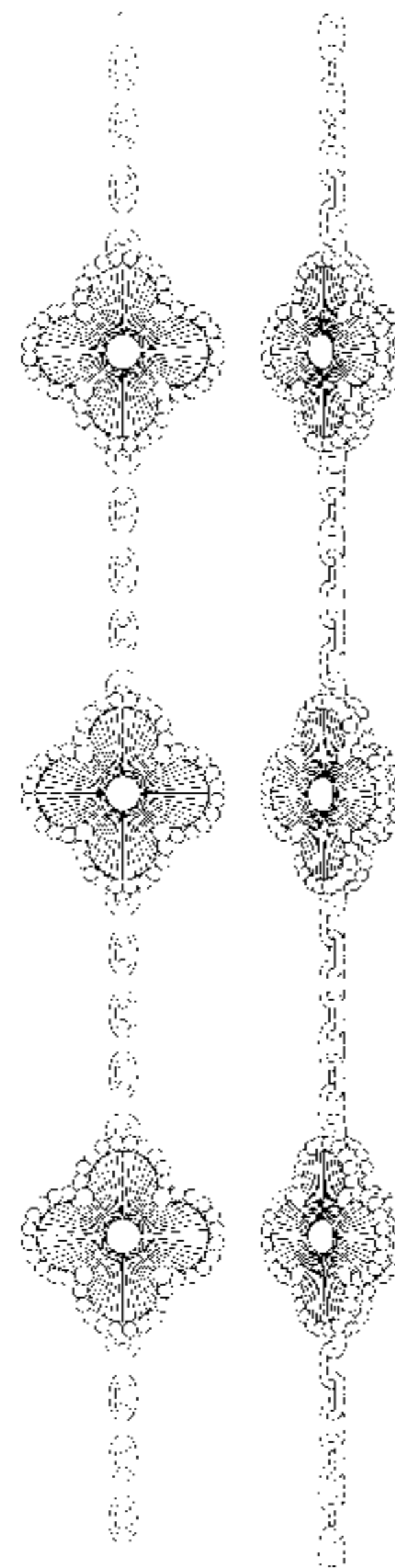
The ornamental design for an article of jewelry, as shown

**DESCRIPTION**

FIG. 1 is a front elevational view of an article of jewelry  
showing my new design;

FIG. 5 is a left side elevational view thereof;

FIG. 9 is an enlarged, front elevational view of one of the  
decorative elements.

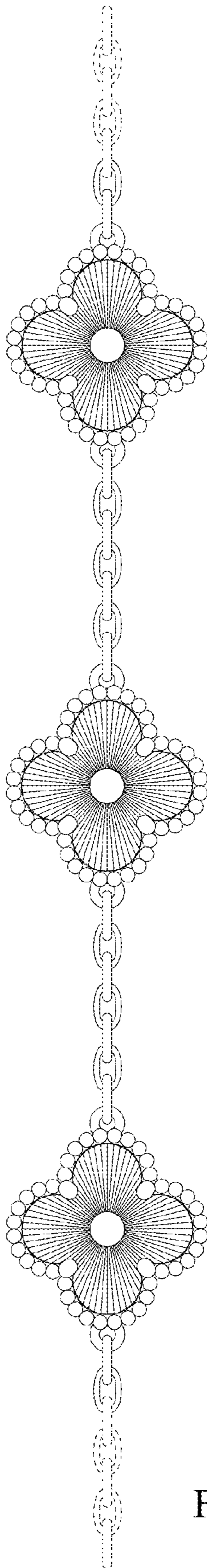

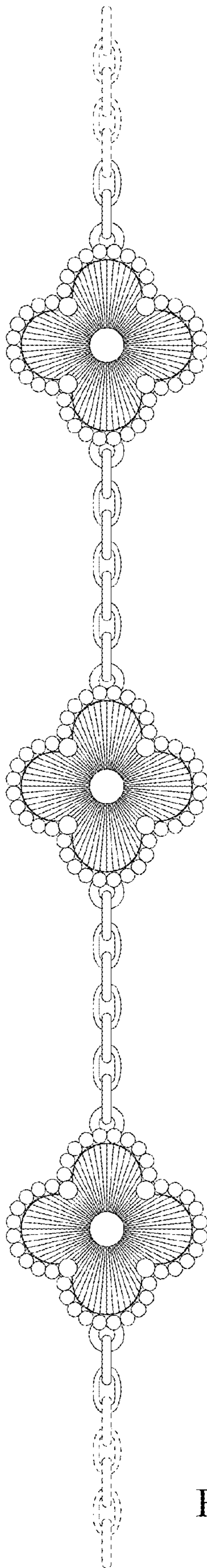

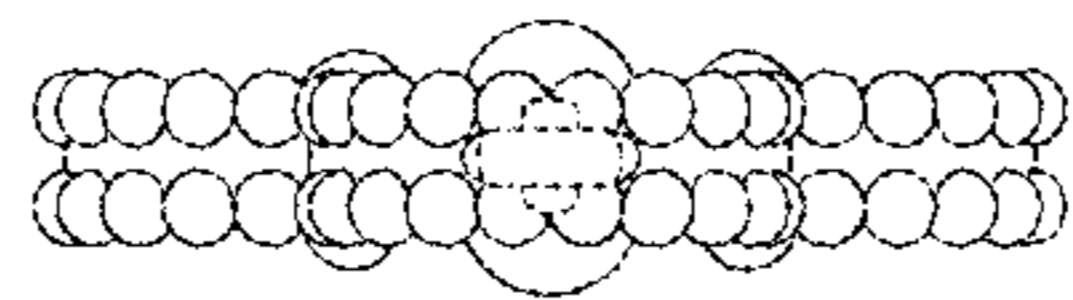

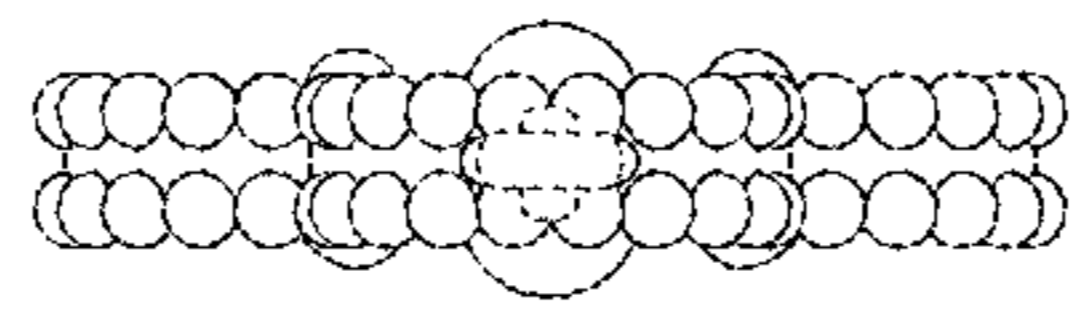

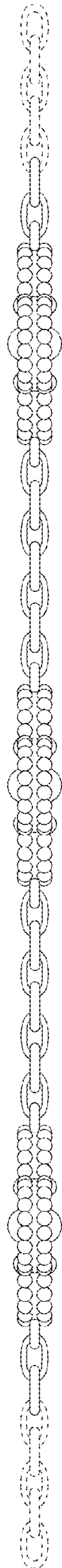

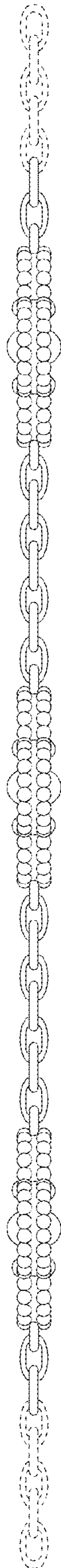

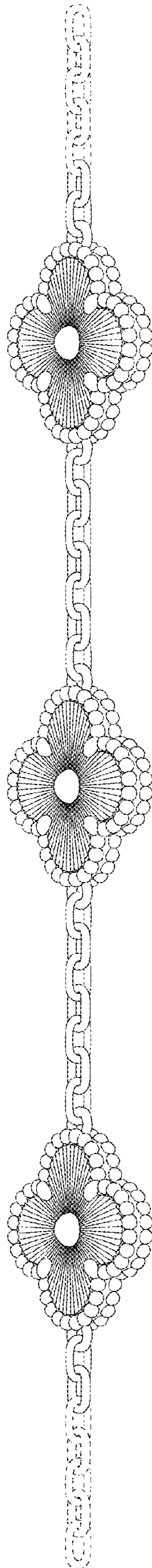

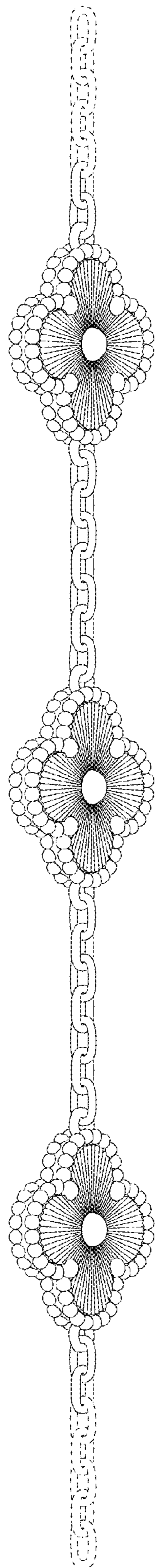

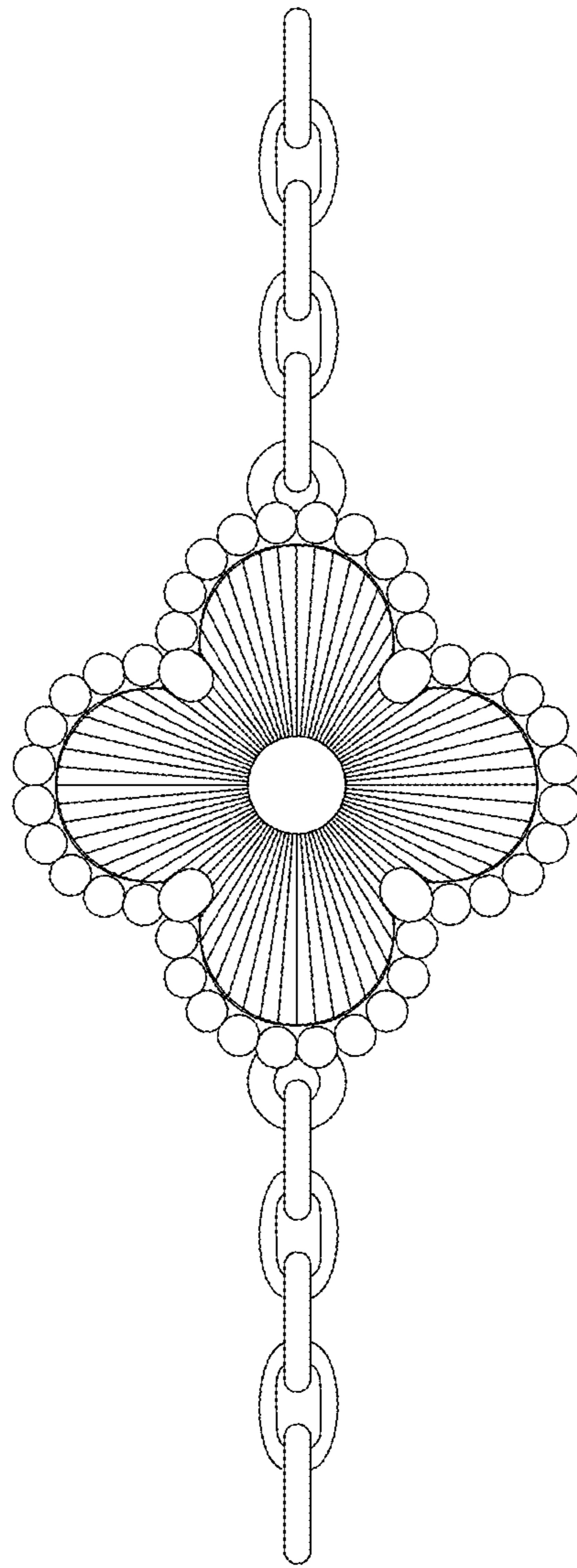
