DESCRIPTION

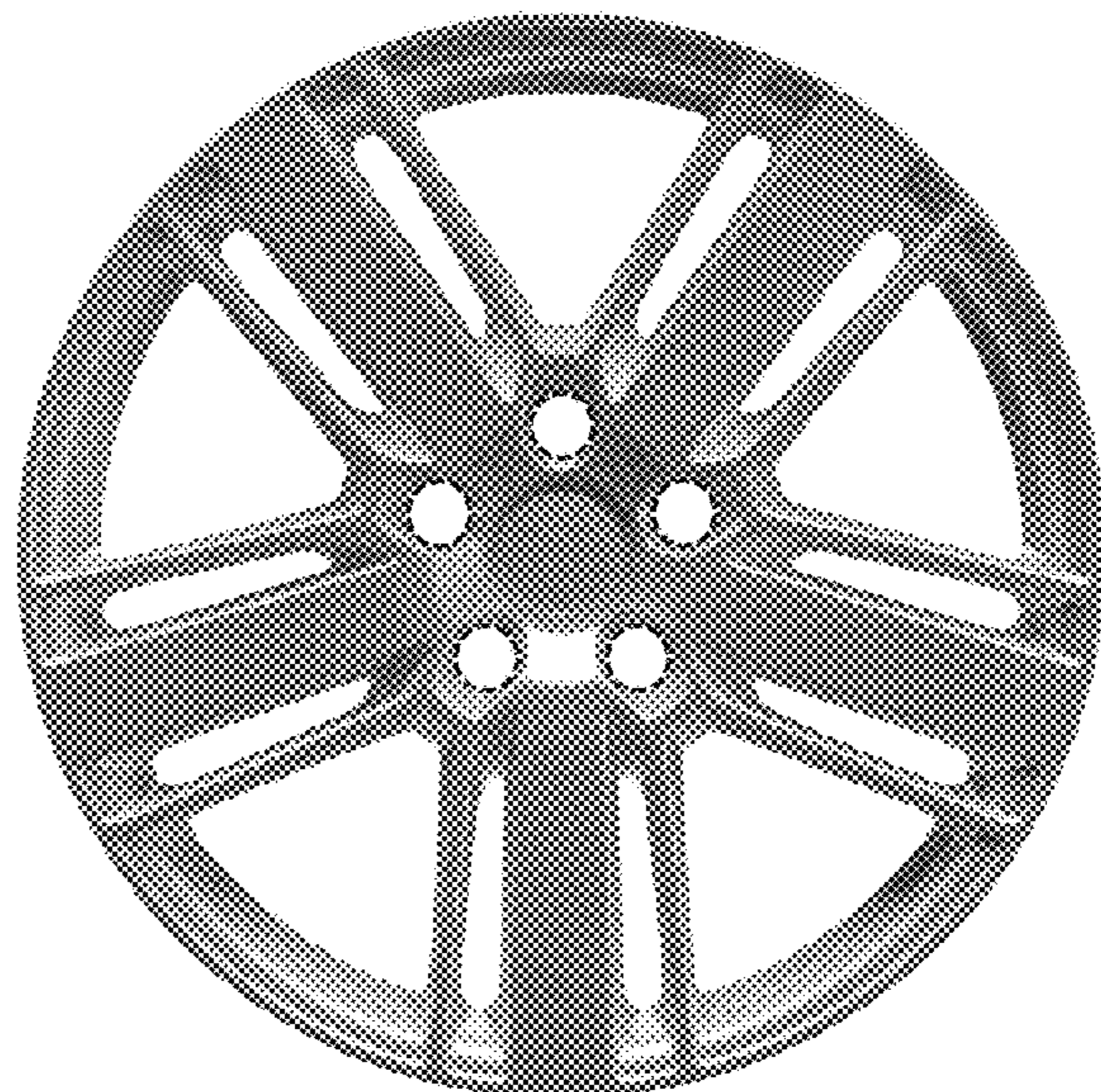
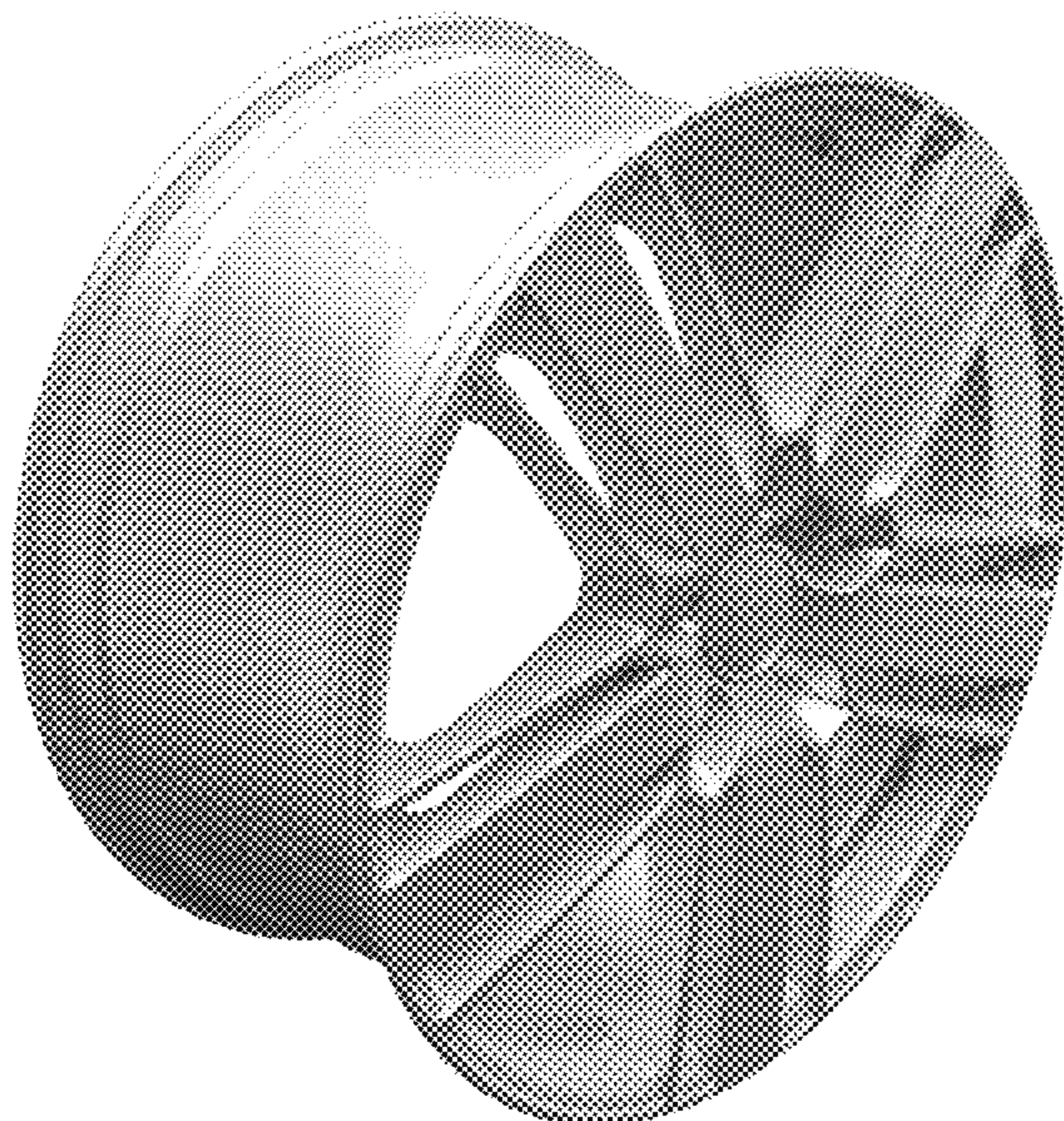
FIG. 1 is a front perspective view of a wheel for motor vehicle;

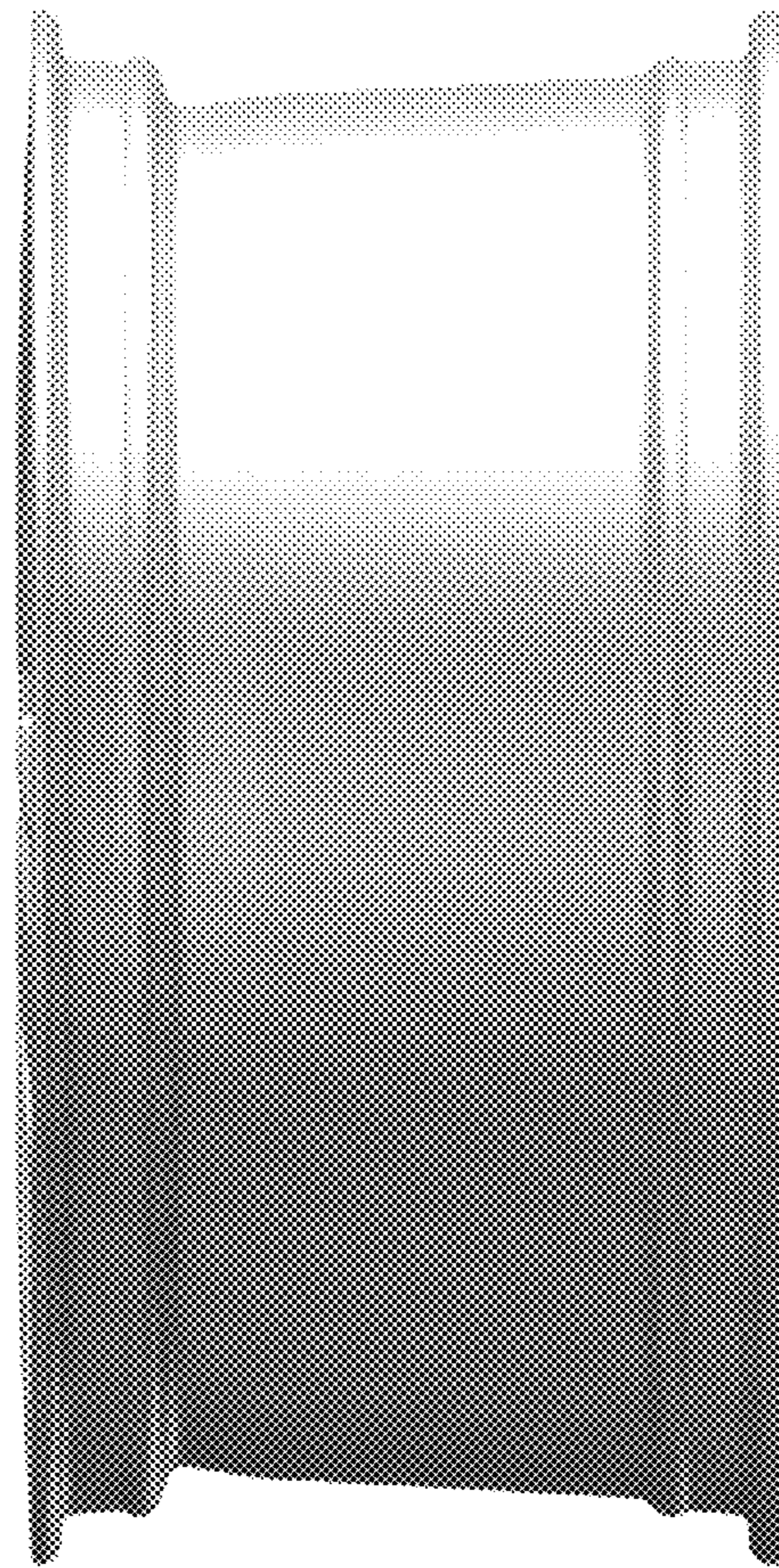
