FIG. 6 is a left-side view thereof.

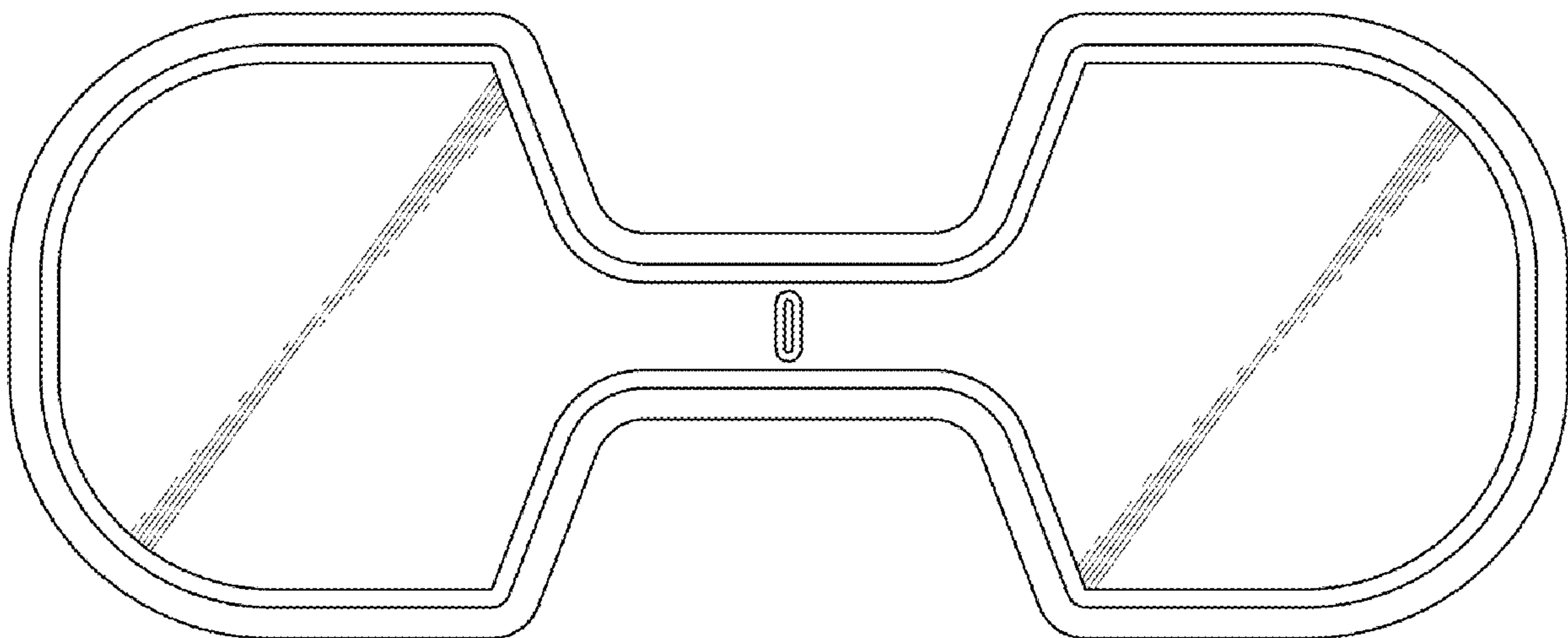
FIG. 7 is a right-side view thereof; and,

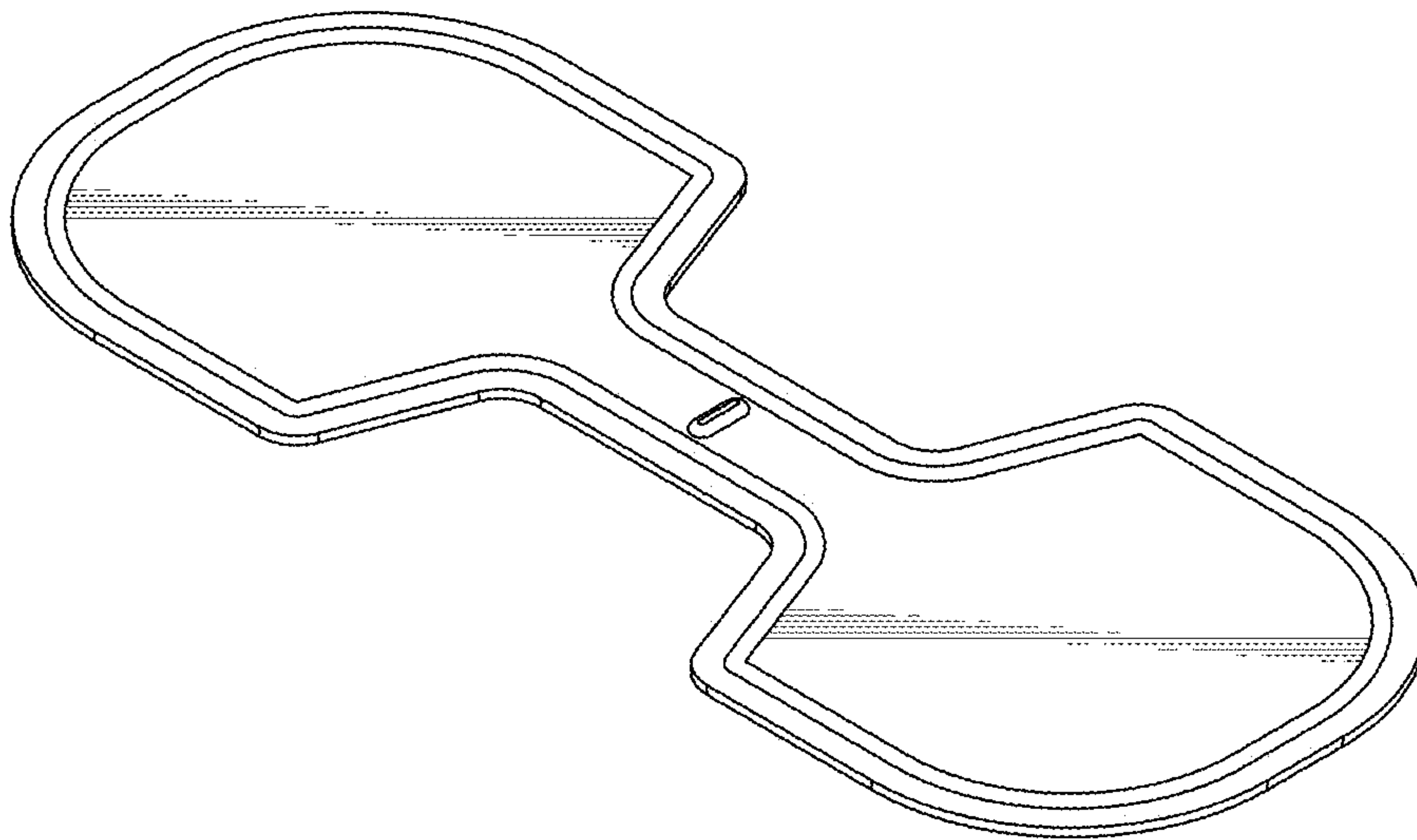

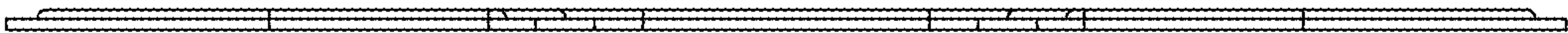

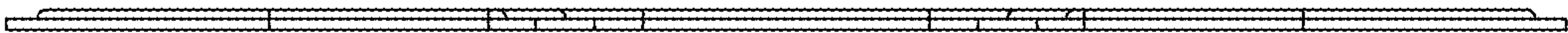

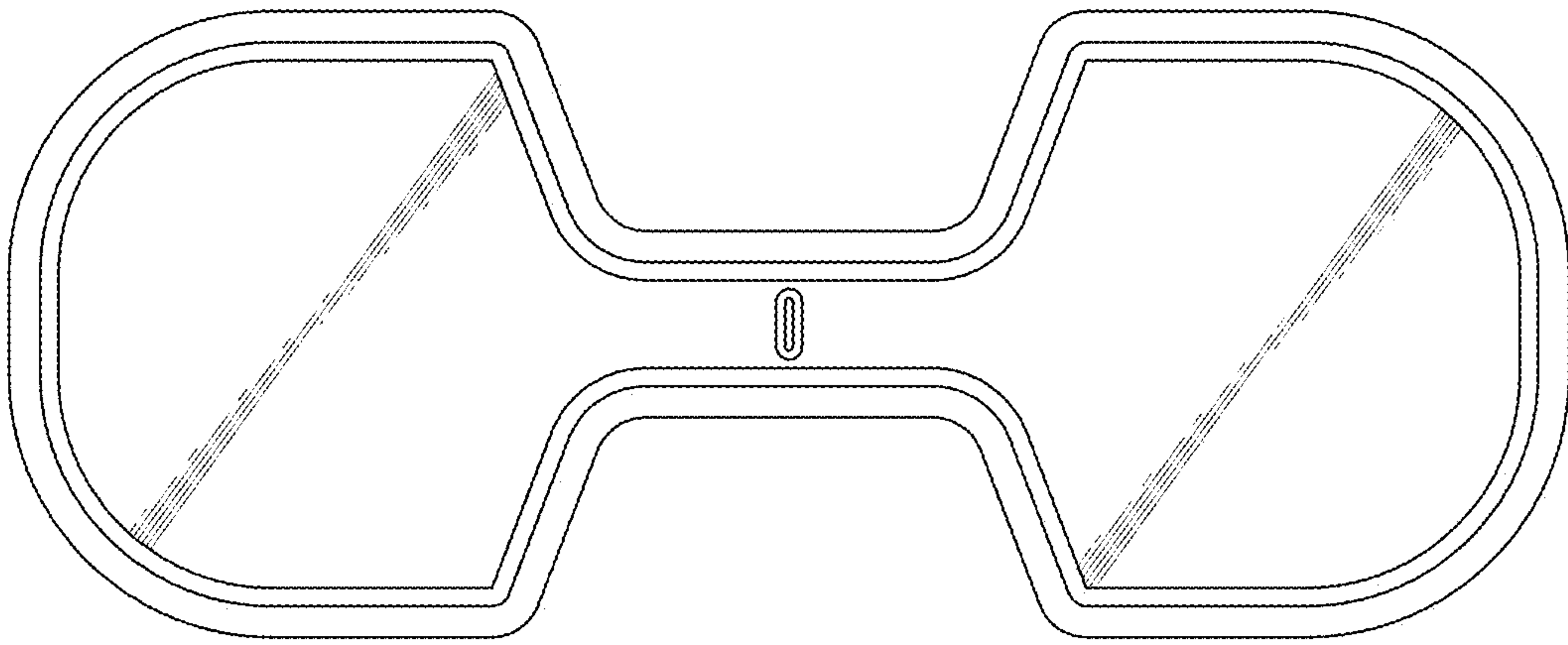

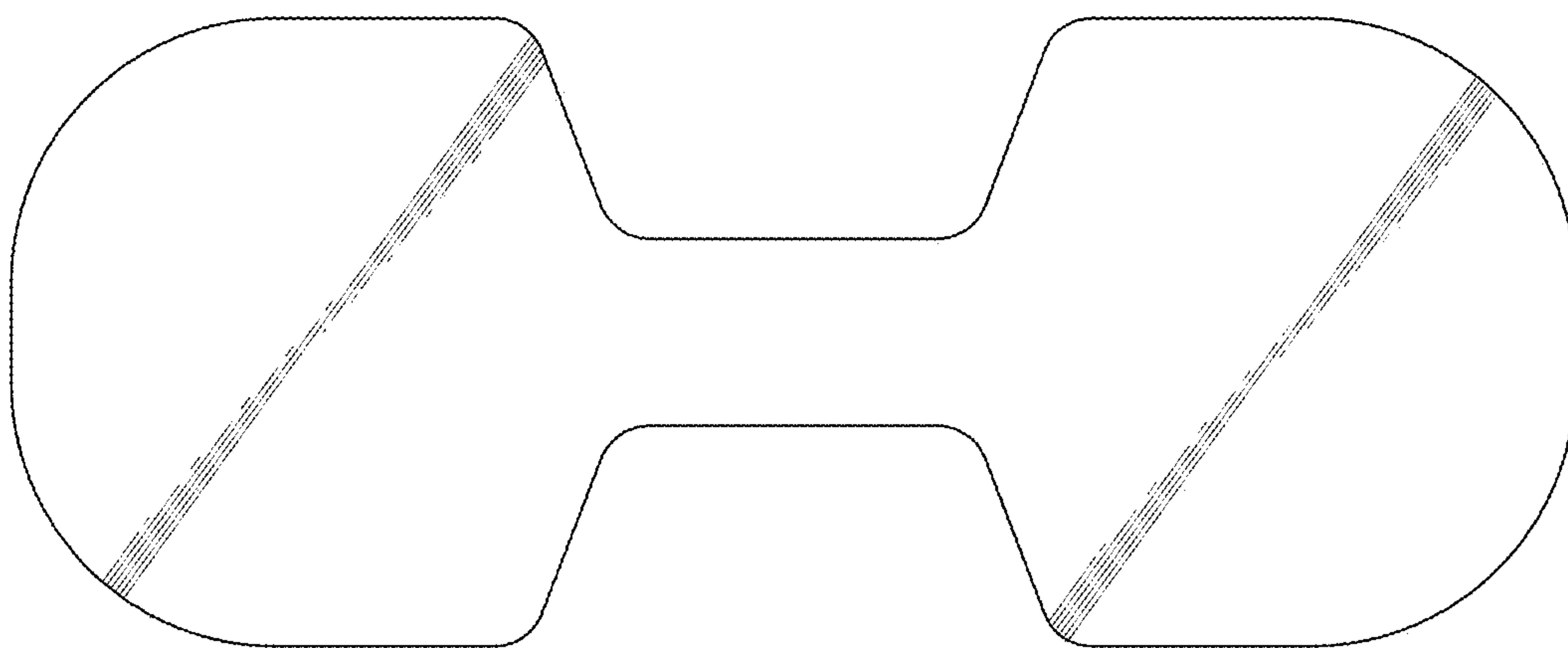

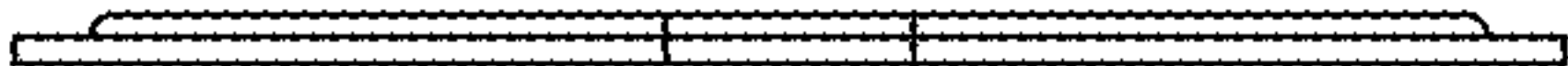

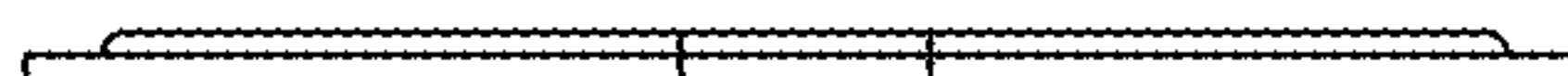

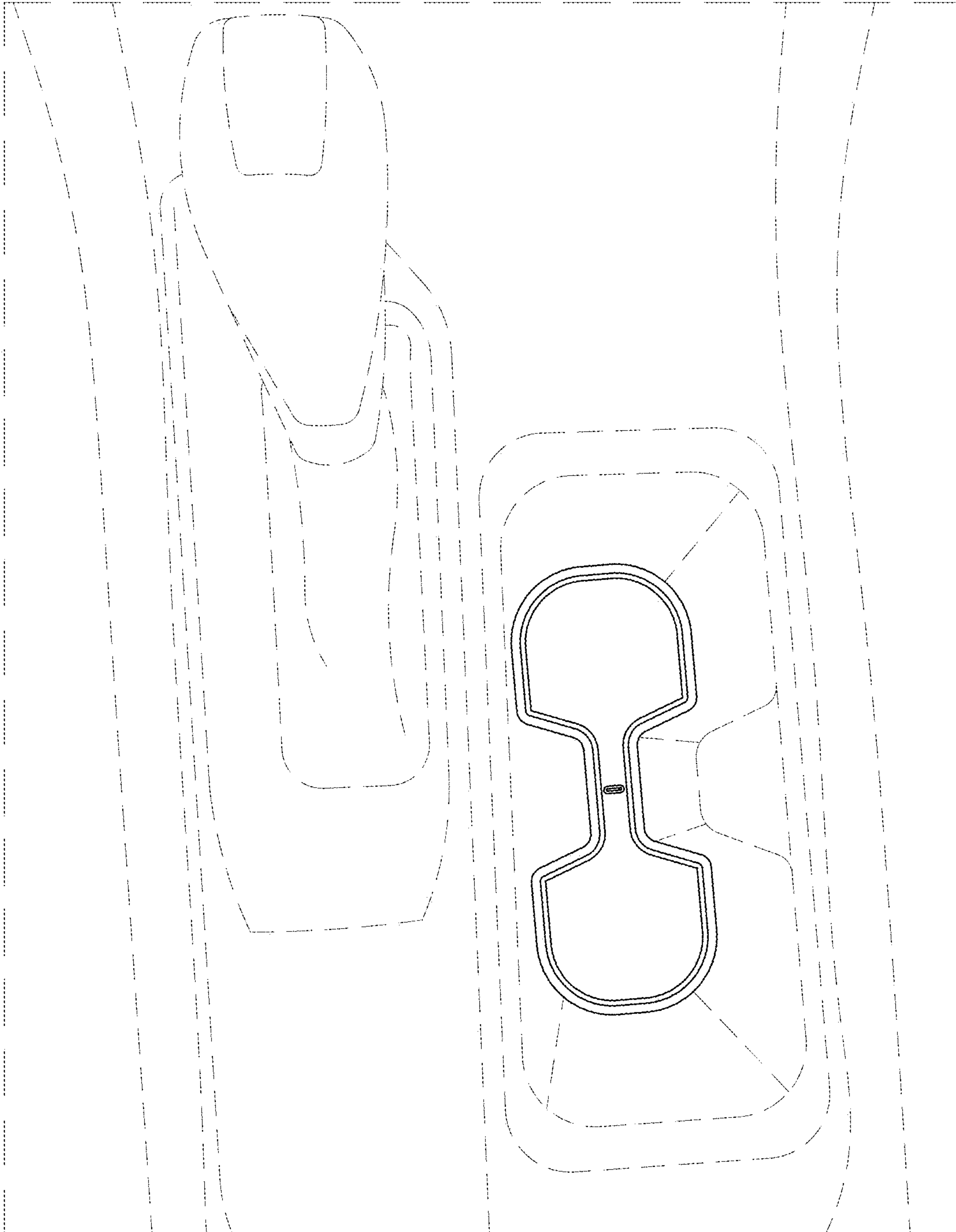
