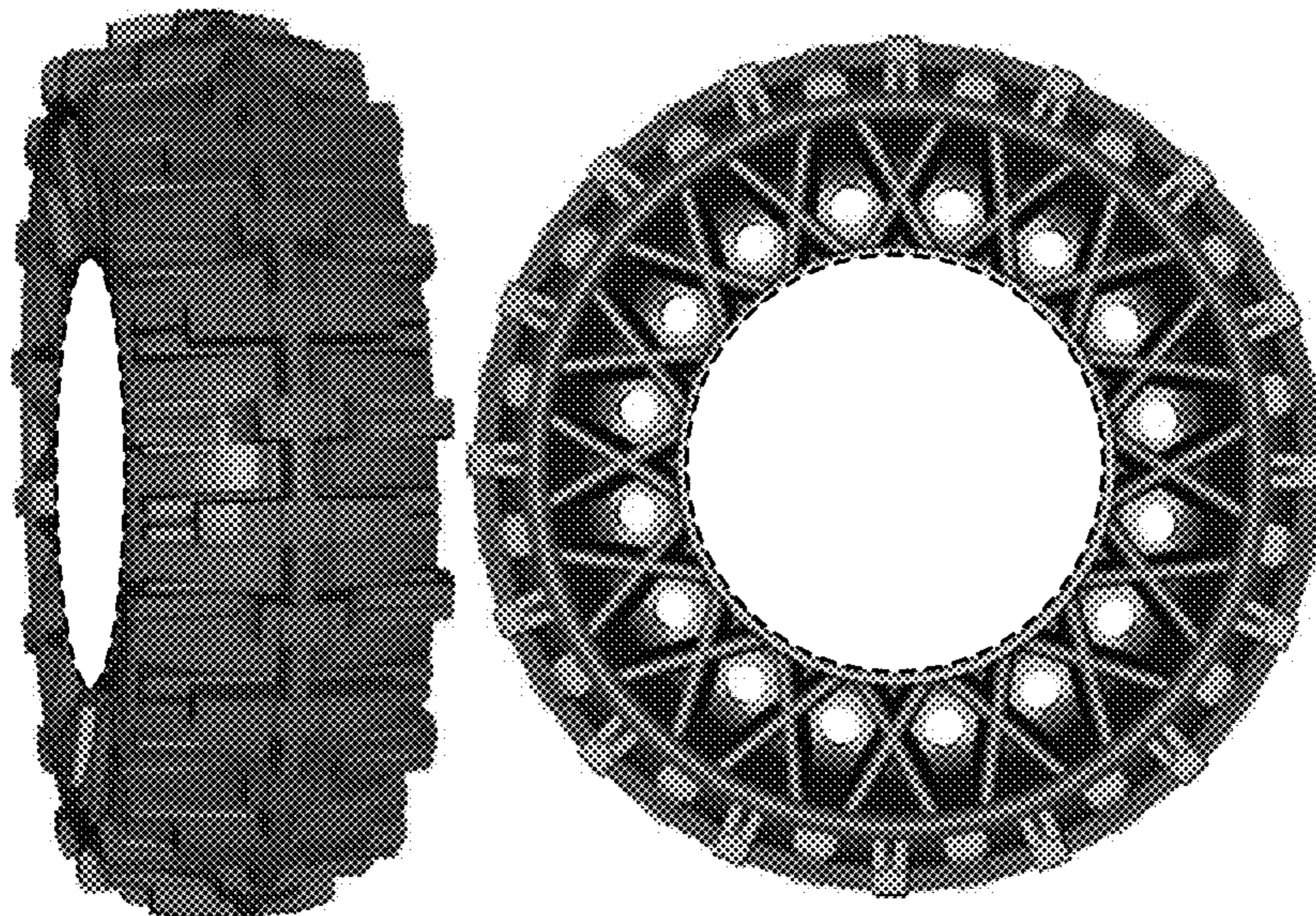
(57) **CLAIM**

The ornamental design for an airless tire, as shown and described.

DESCRIPTION

FIG. 1 is a side perspective view of an airless tire showing my new design, it being understood that the pattern repeats uniformly throughout the circumference of the tread;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a right side view, thereof;
FIG. 4 is a right side front perspective view thereof;
FIG. 5 is a right side front perspective view thereof;
FIG. 6 is a right side bottom perspective view thereof;
FIG. 7 is a left side view thereof;
FIG. 8 is a left side front perspective view thereof; and,
FIG. 9 is a left side front perspective view thereof.
The broken lines in the drawings represent the claim boundaries.

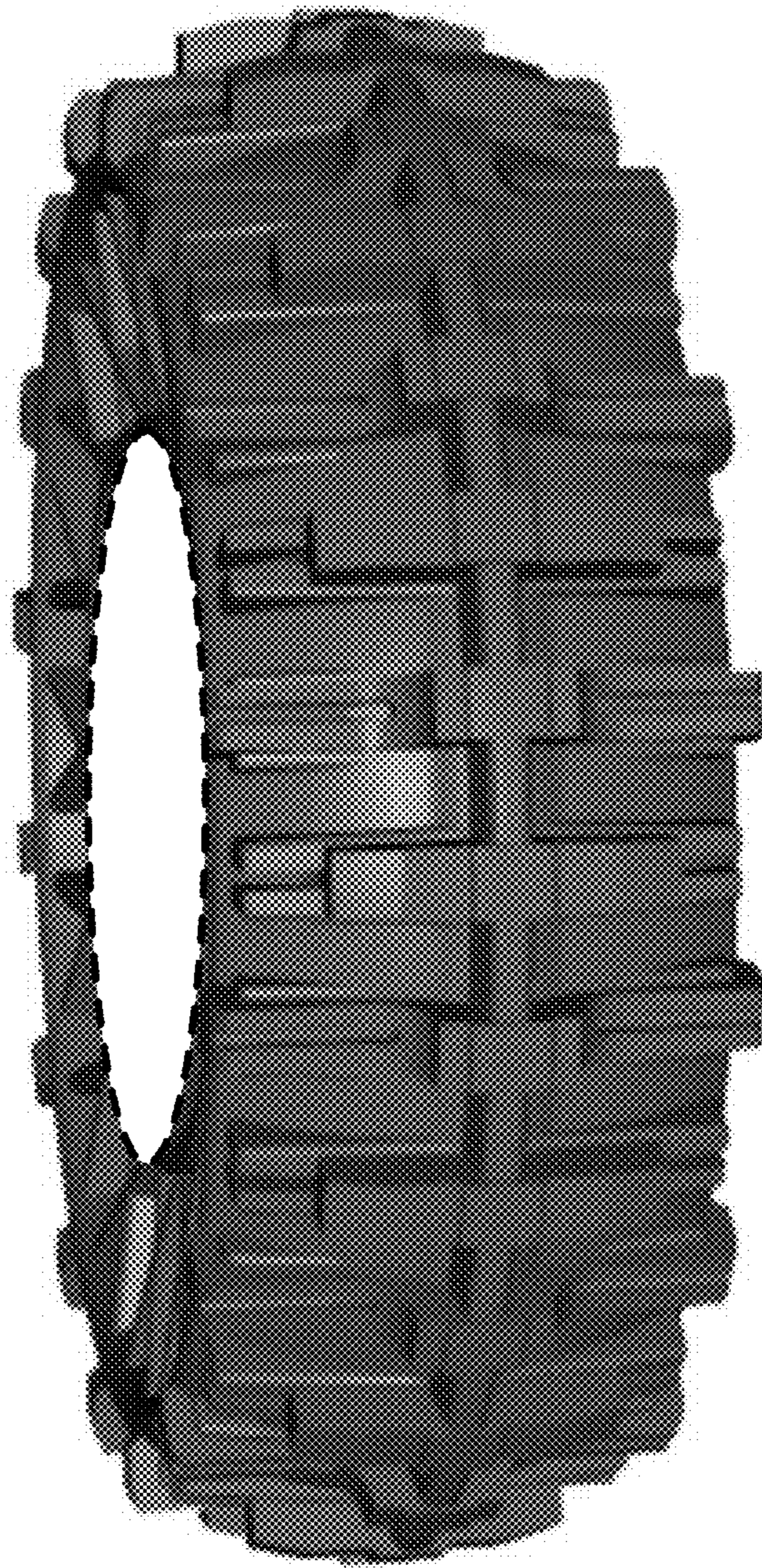

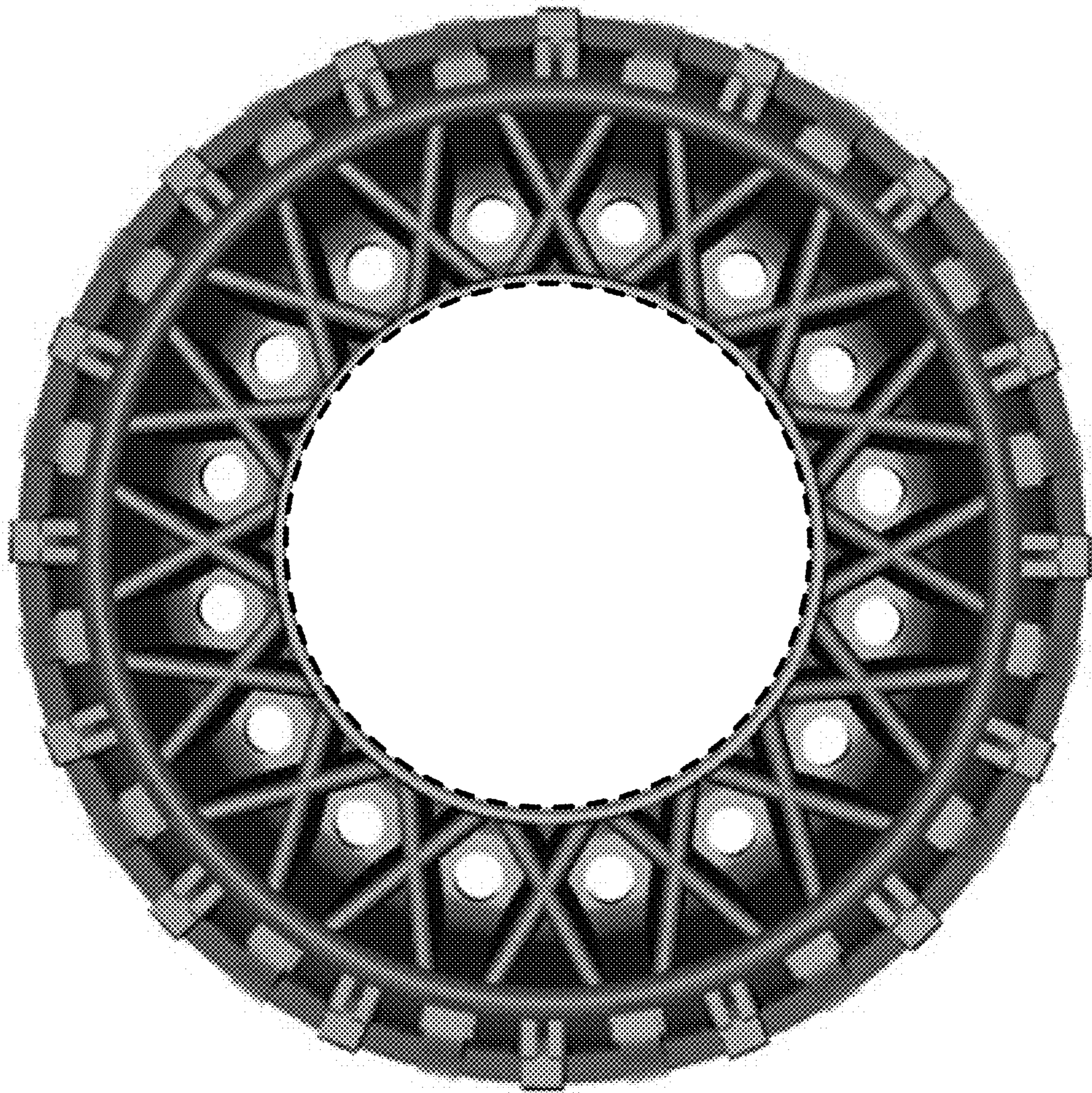

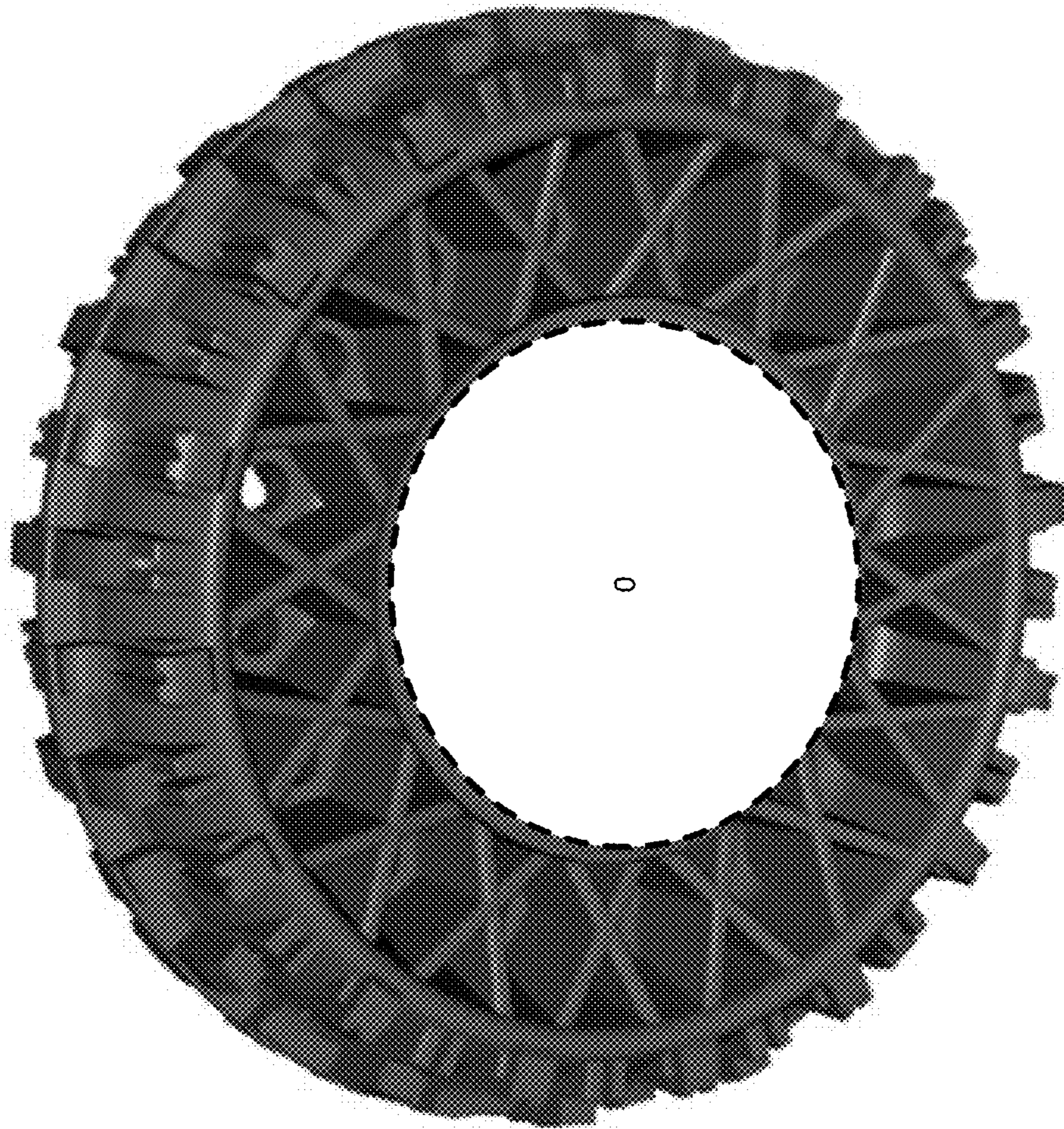

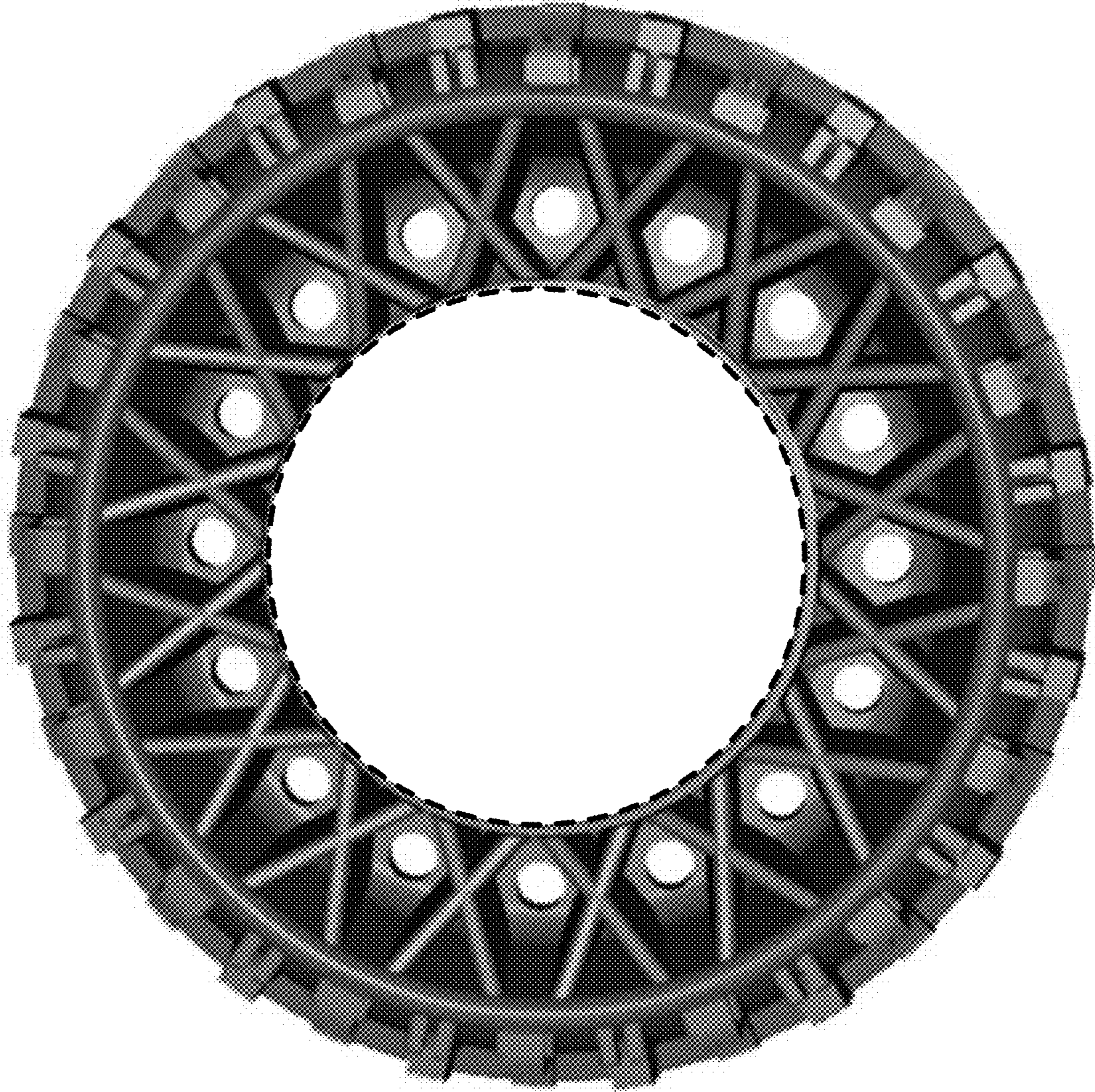

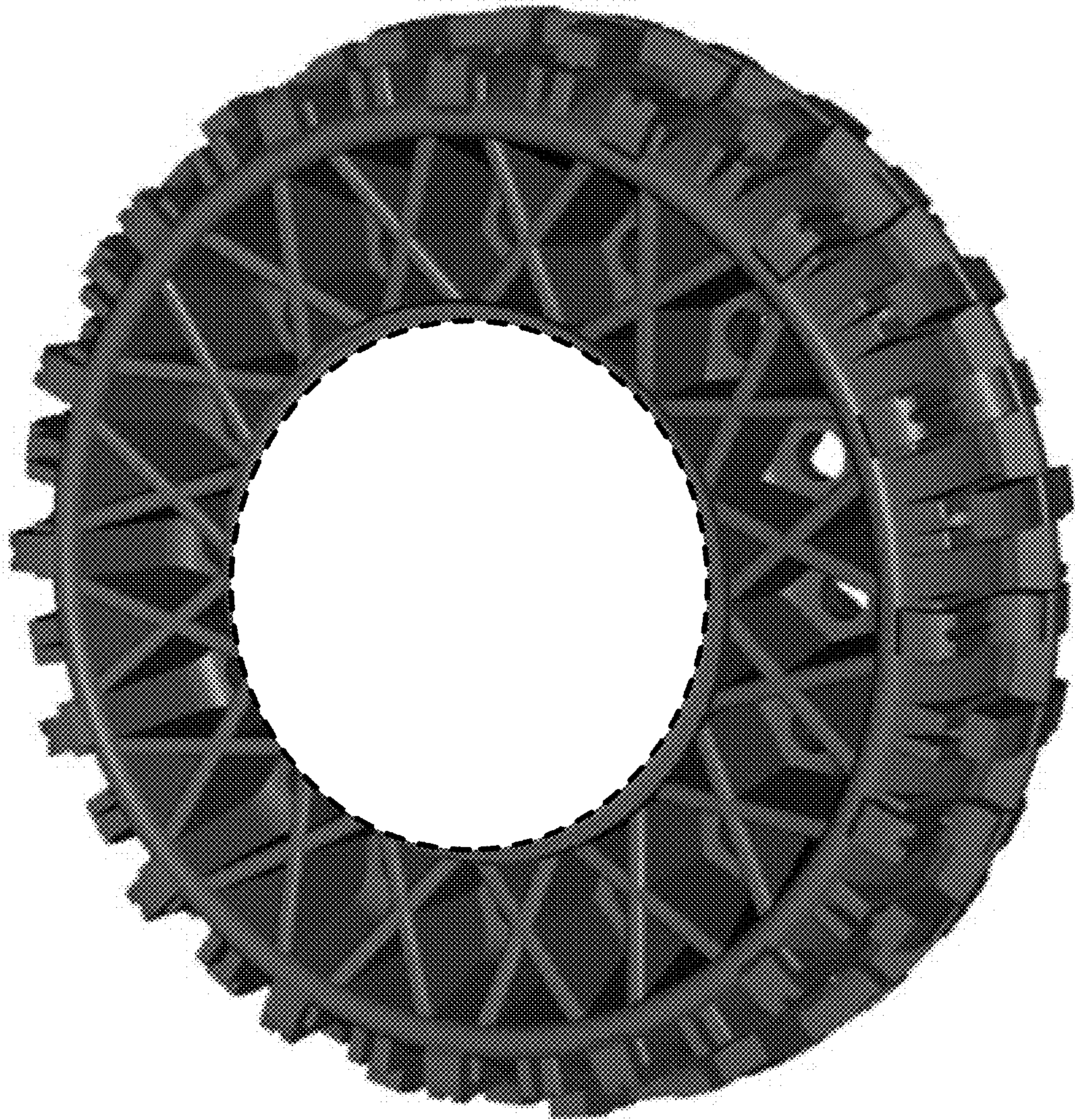
