(57) **CLAIM**

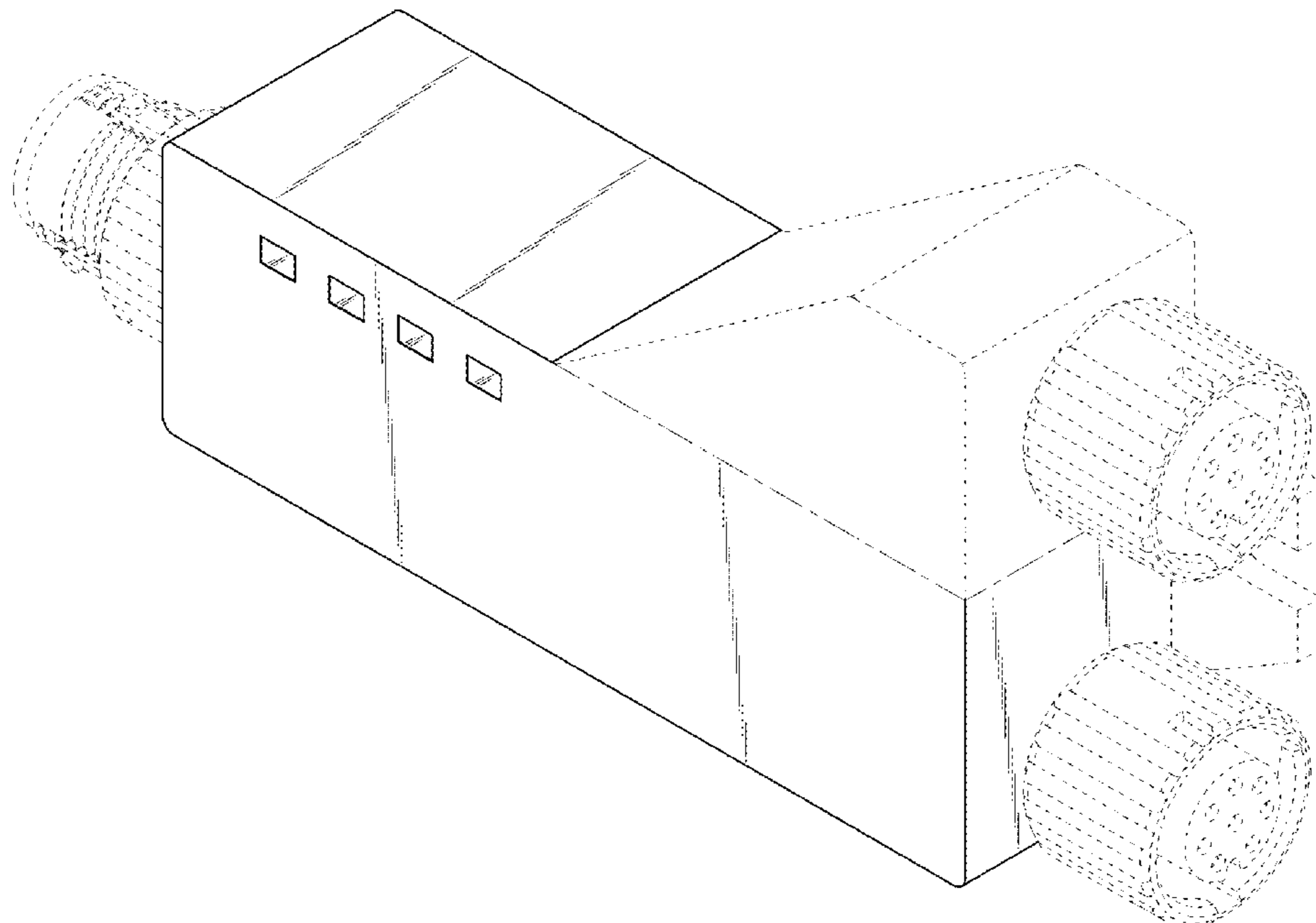
The ornamental design for a signal transfer connector, as shown and described.

DESCRIPTION

FIG. 1 is a front, top, and right side perspective view of a signal transfer connector showing my new design;
FIG. 2 is a rear, top, and right side perspective view thereof;
FIG. 3 front view thereof;
FIG. 4 is a rear view thereof;
FIG. 5 is a left side view thereof;
FIG. 6 is a right side view thereof;
FIG. 7 is a top view thereof; and,
FIG. 8 is a bottom view thereof.

The equal-length broken lines in the drawings depict portions of the signal transfer connector that form no part of the claimed design. The dash-dot-dash lines define the boundaries of the claim.

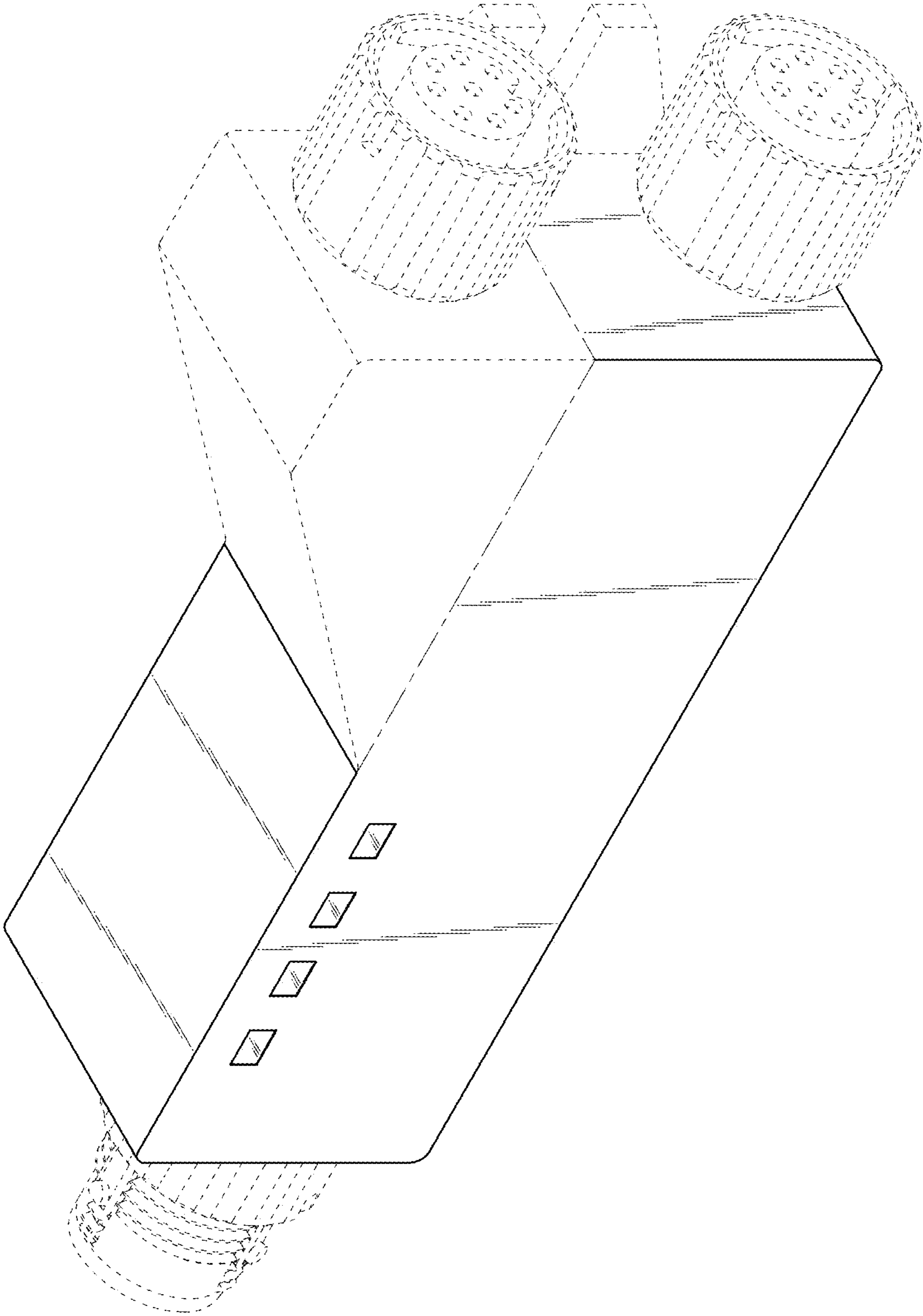

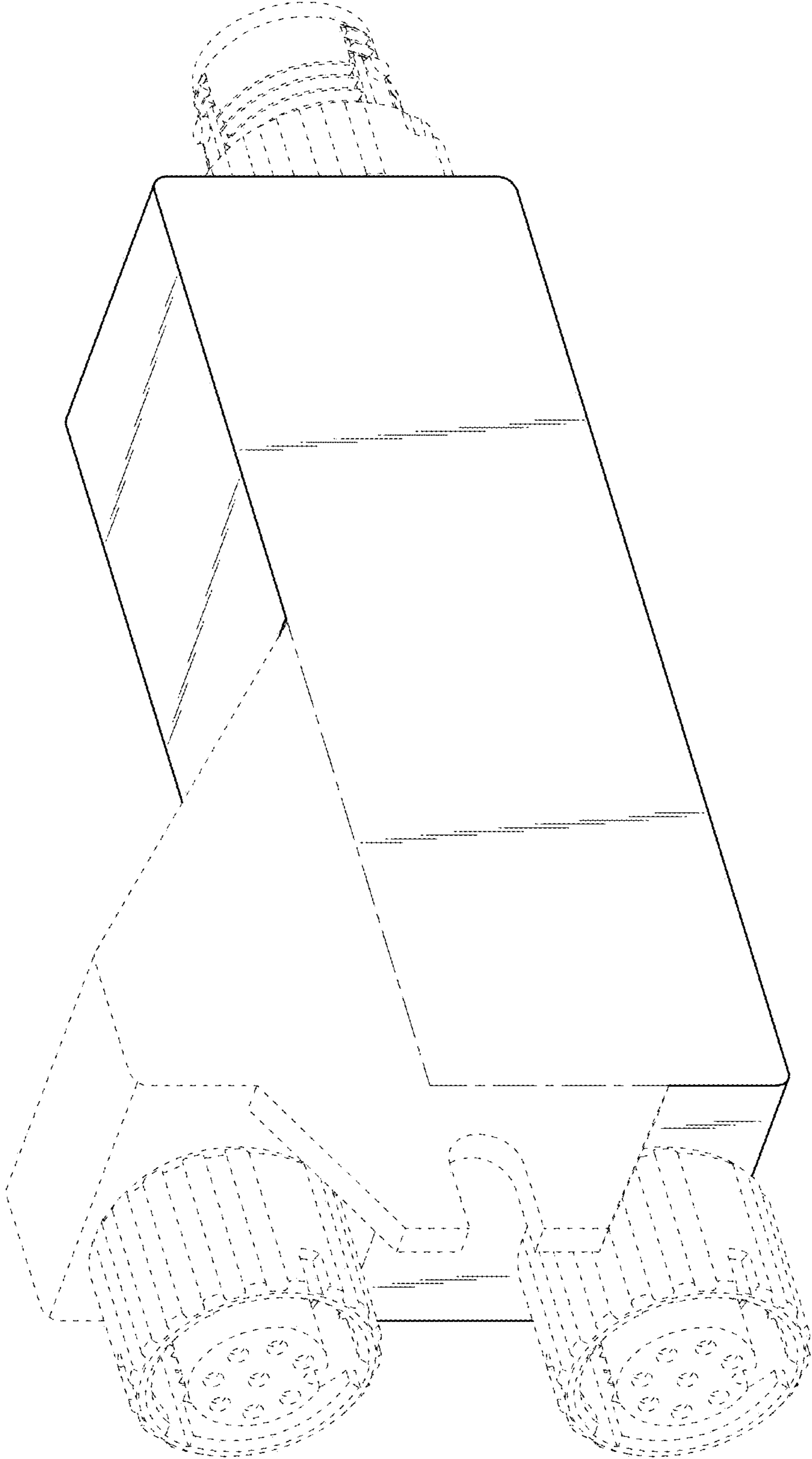

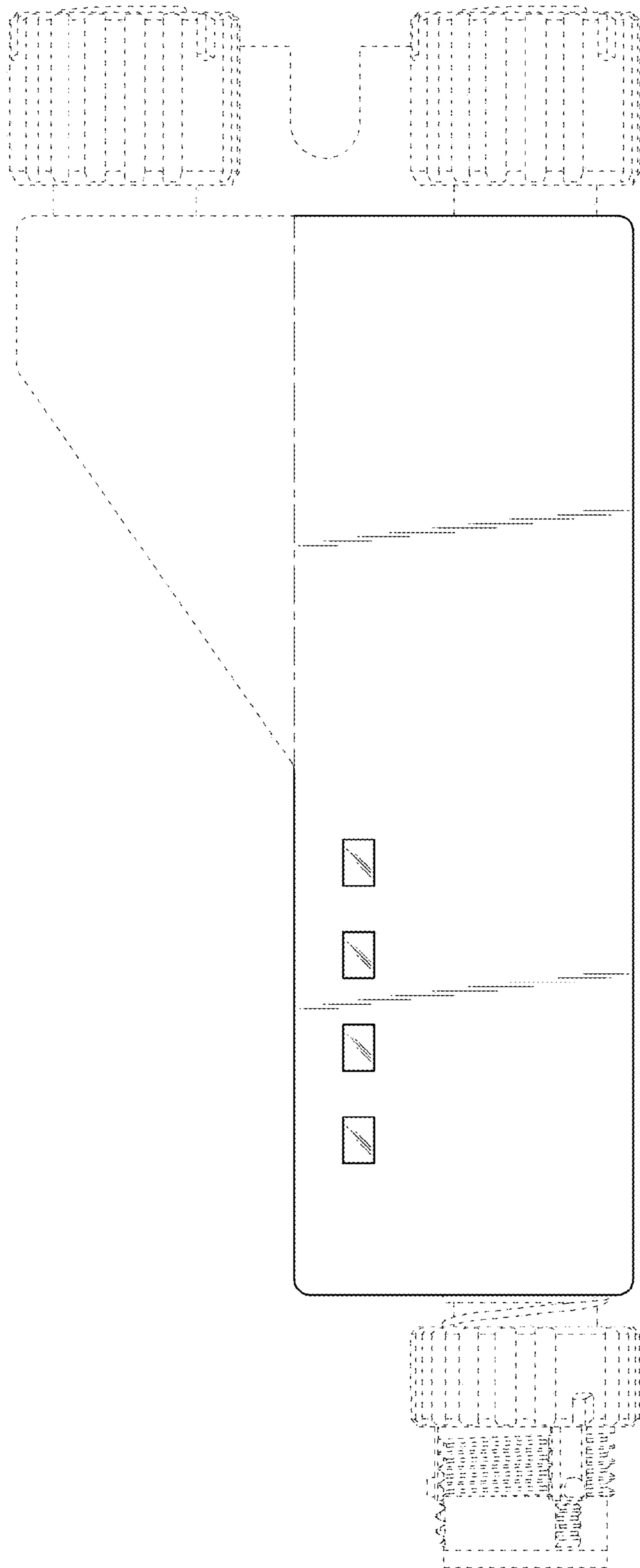
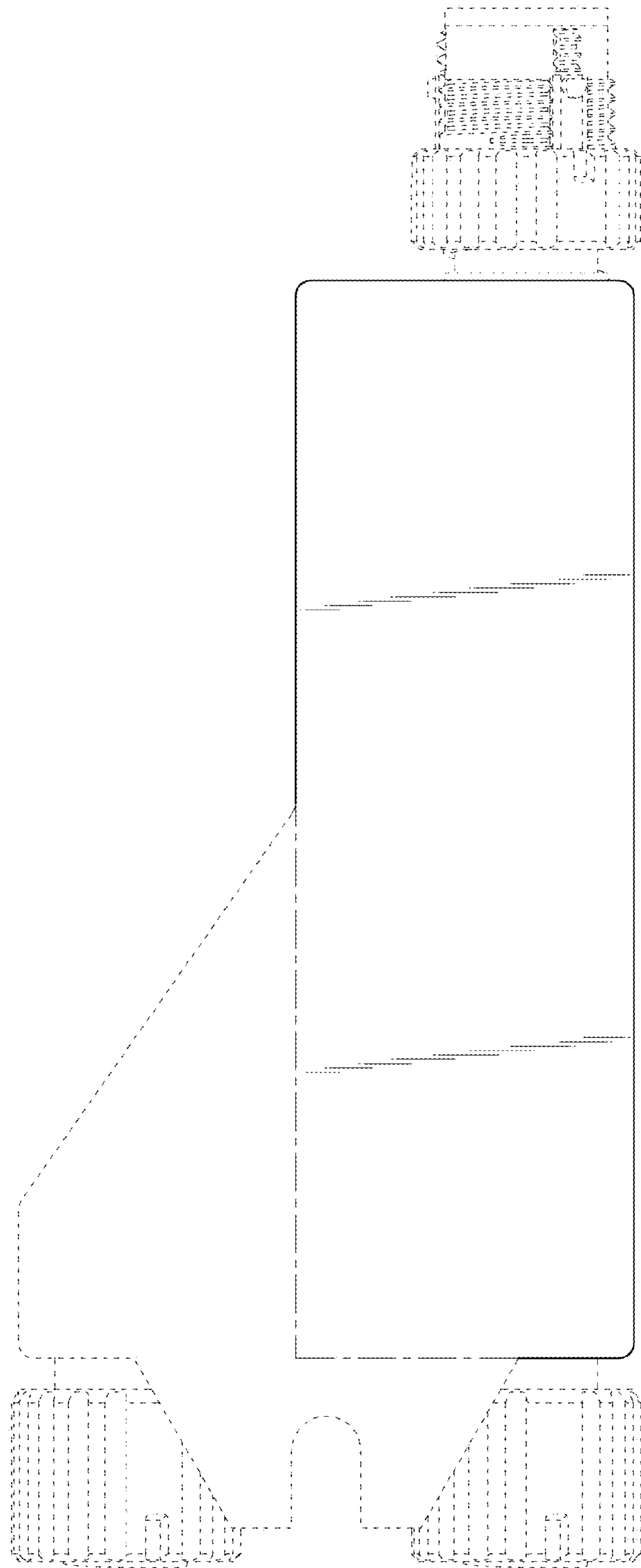

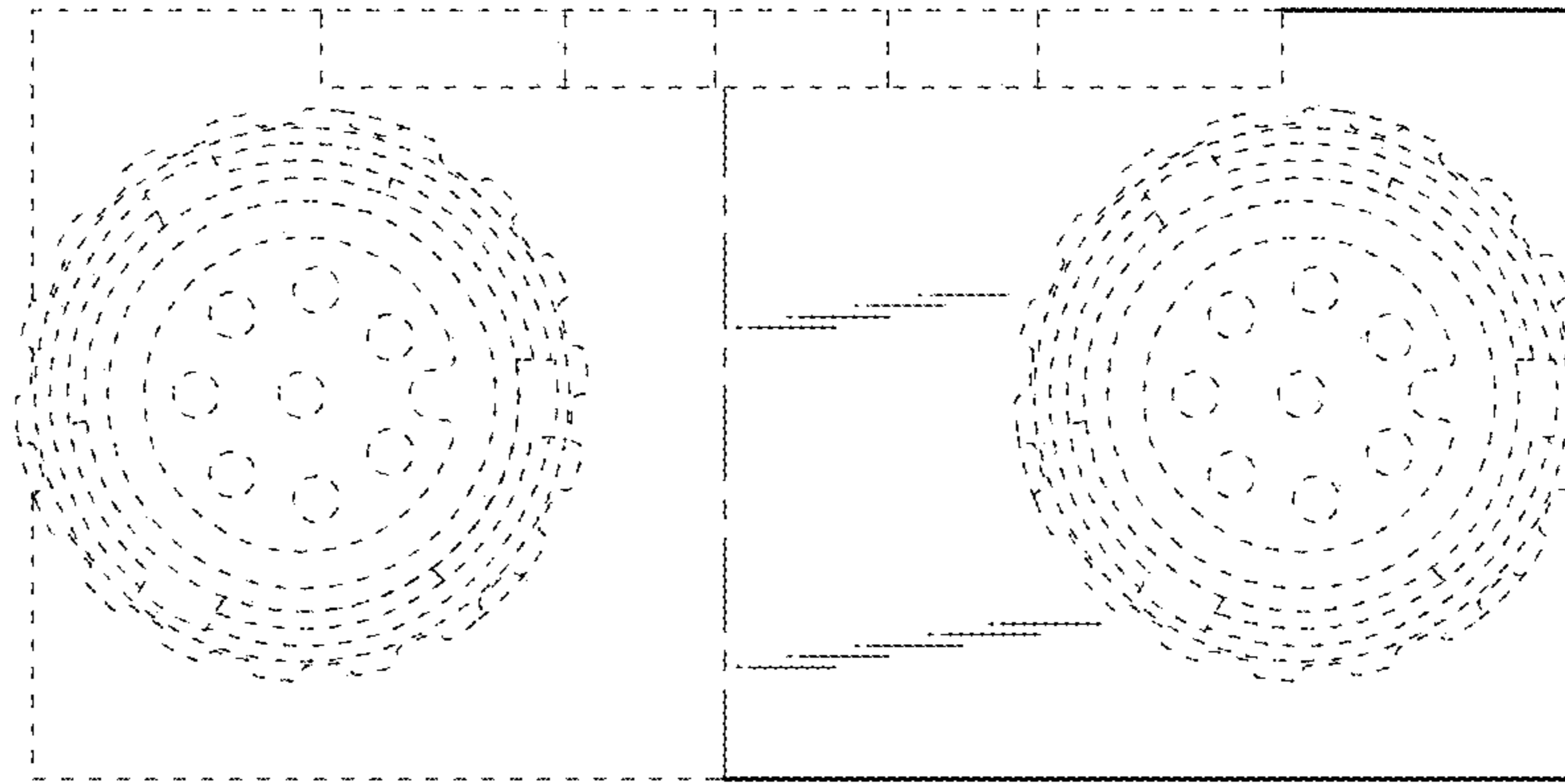

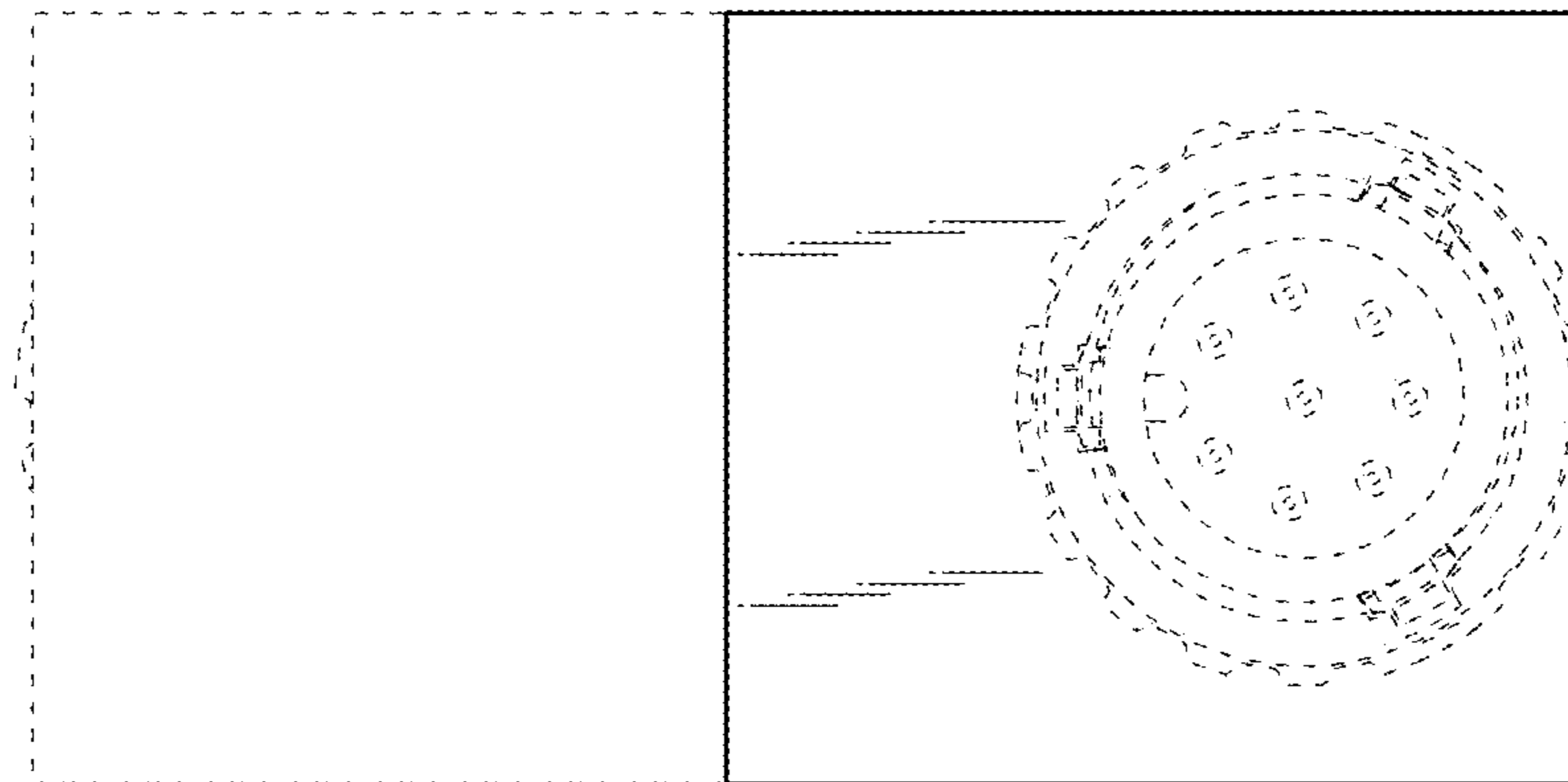

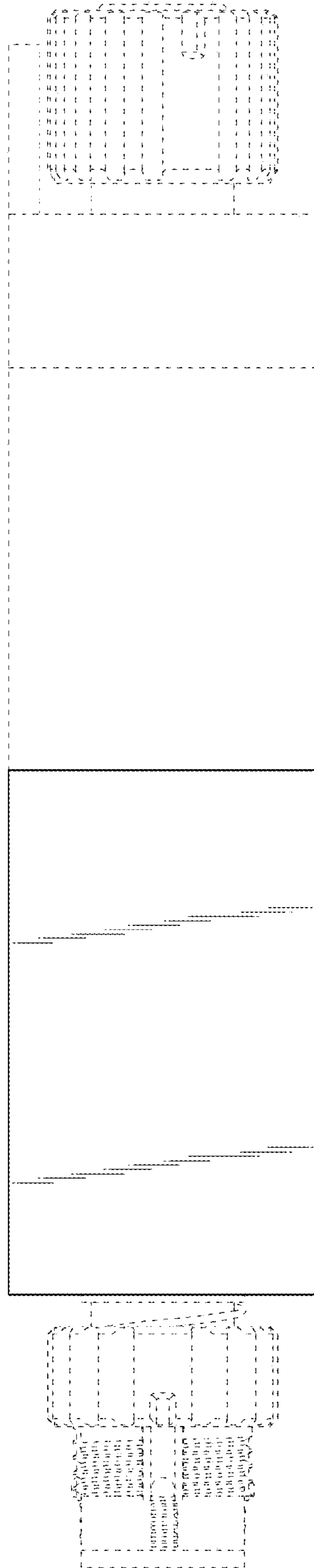
