**DESCRIPTION**

FIG. 1 is a front, top and right side perspective view of an electrical connector cover showing our new design;

FIG. 2 is a rear, bottom and left side perspective view thereof;

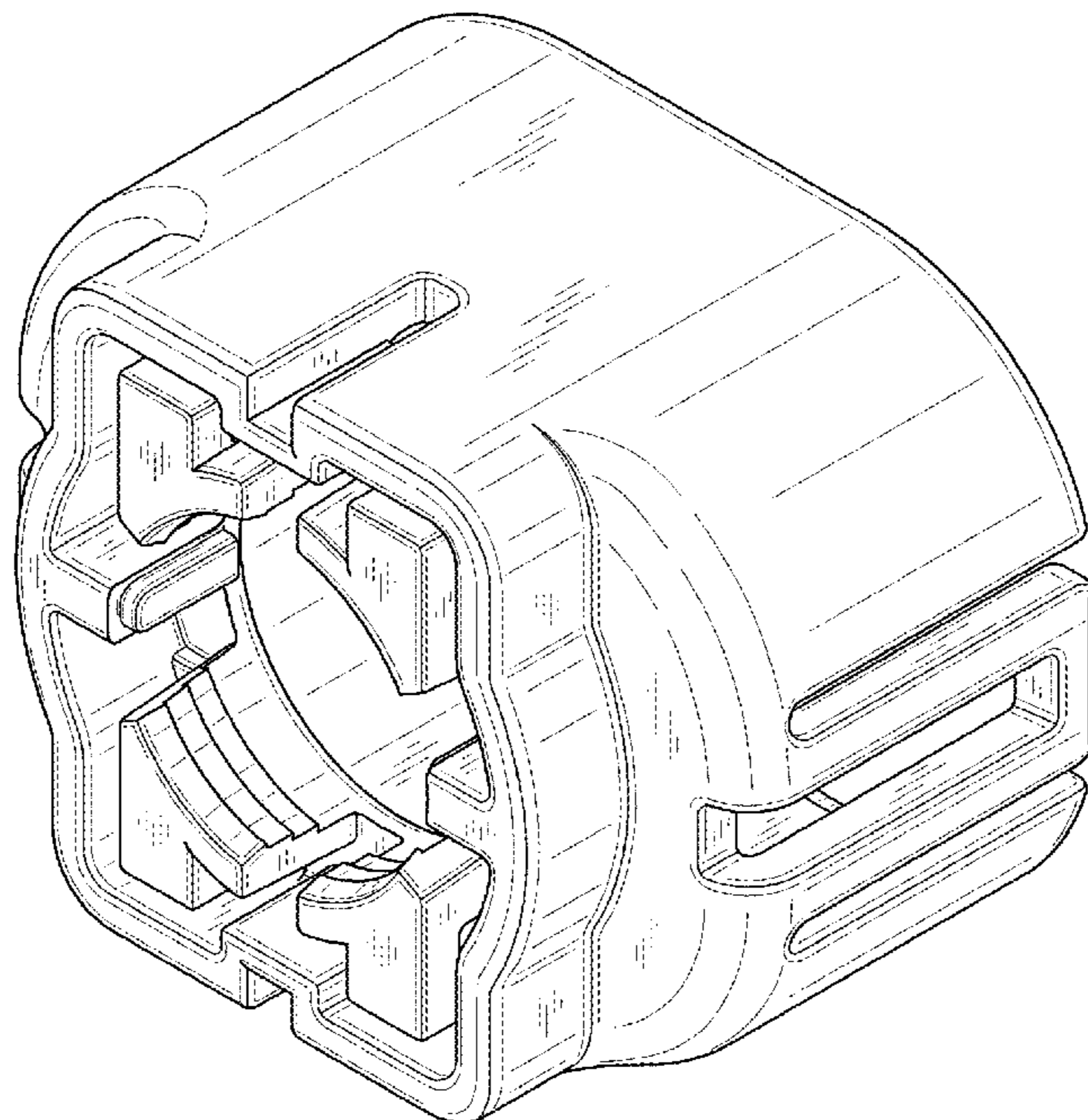
FIG. 3 is a front view thereof;

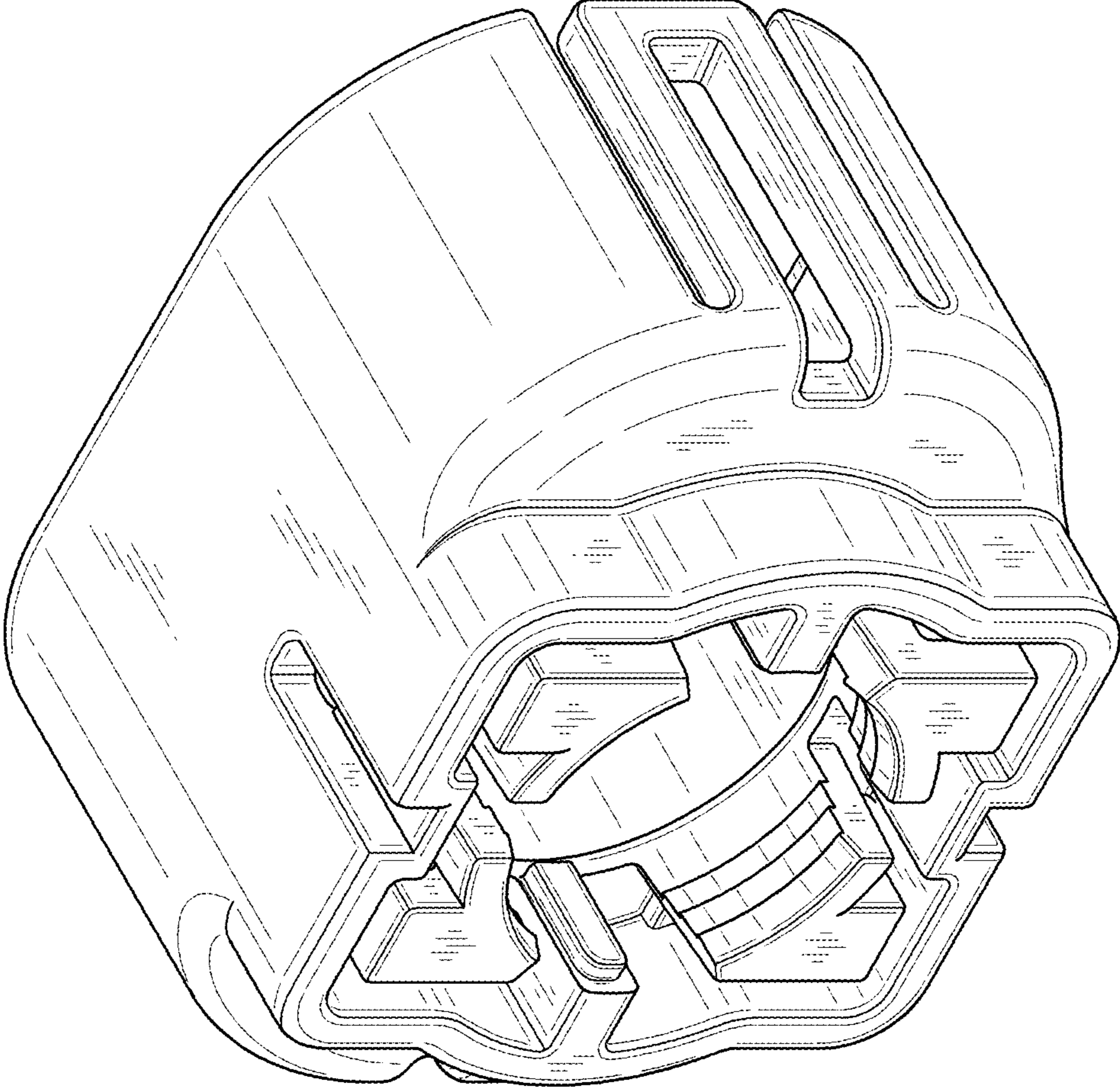

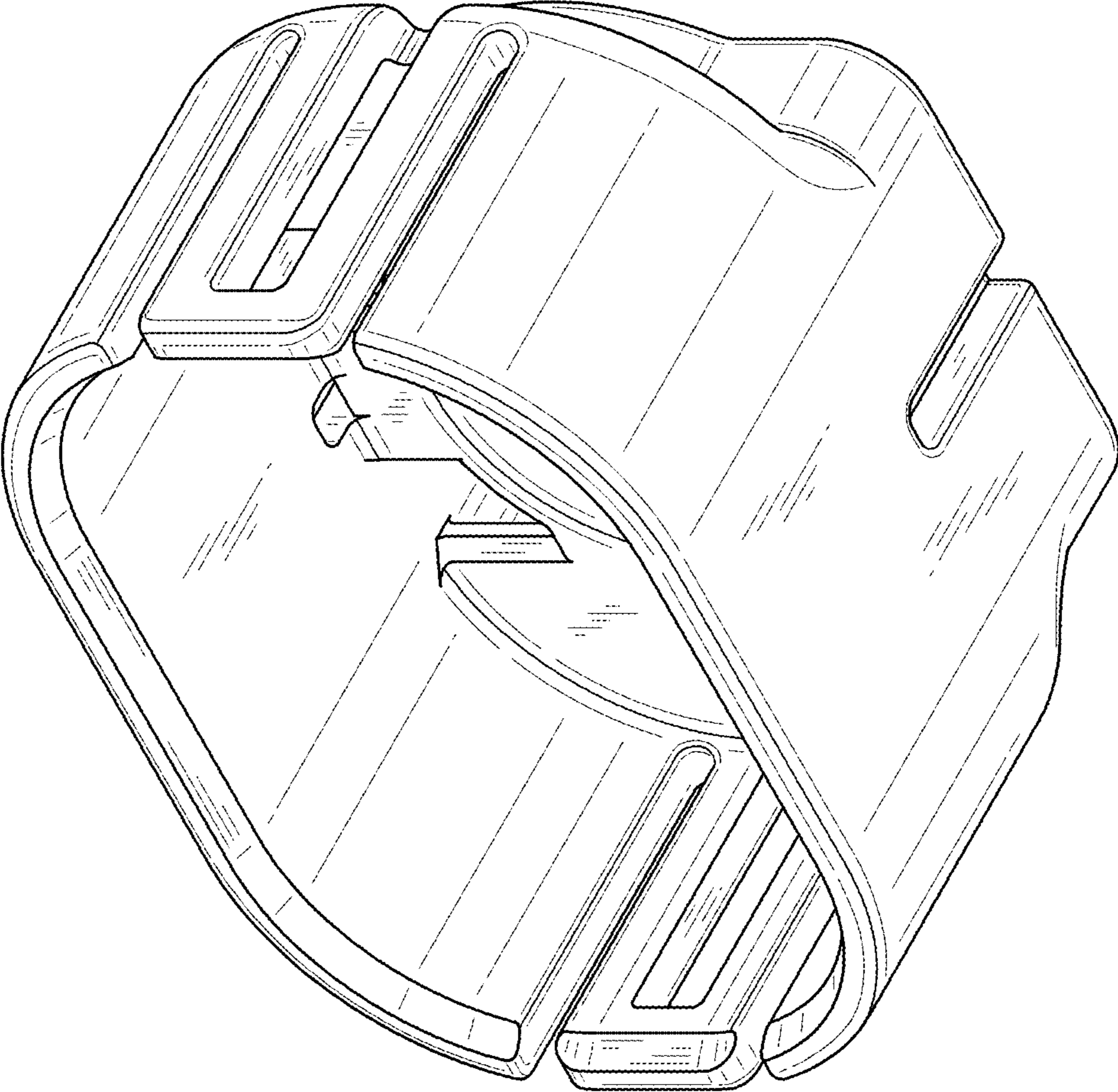

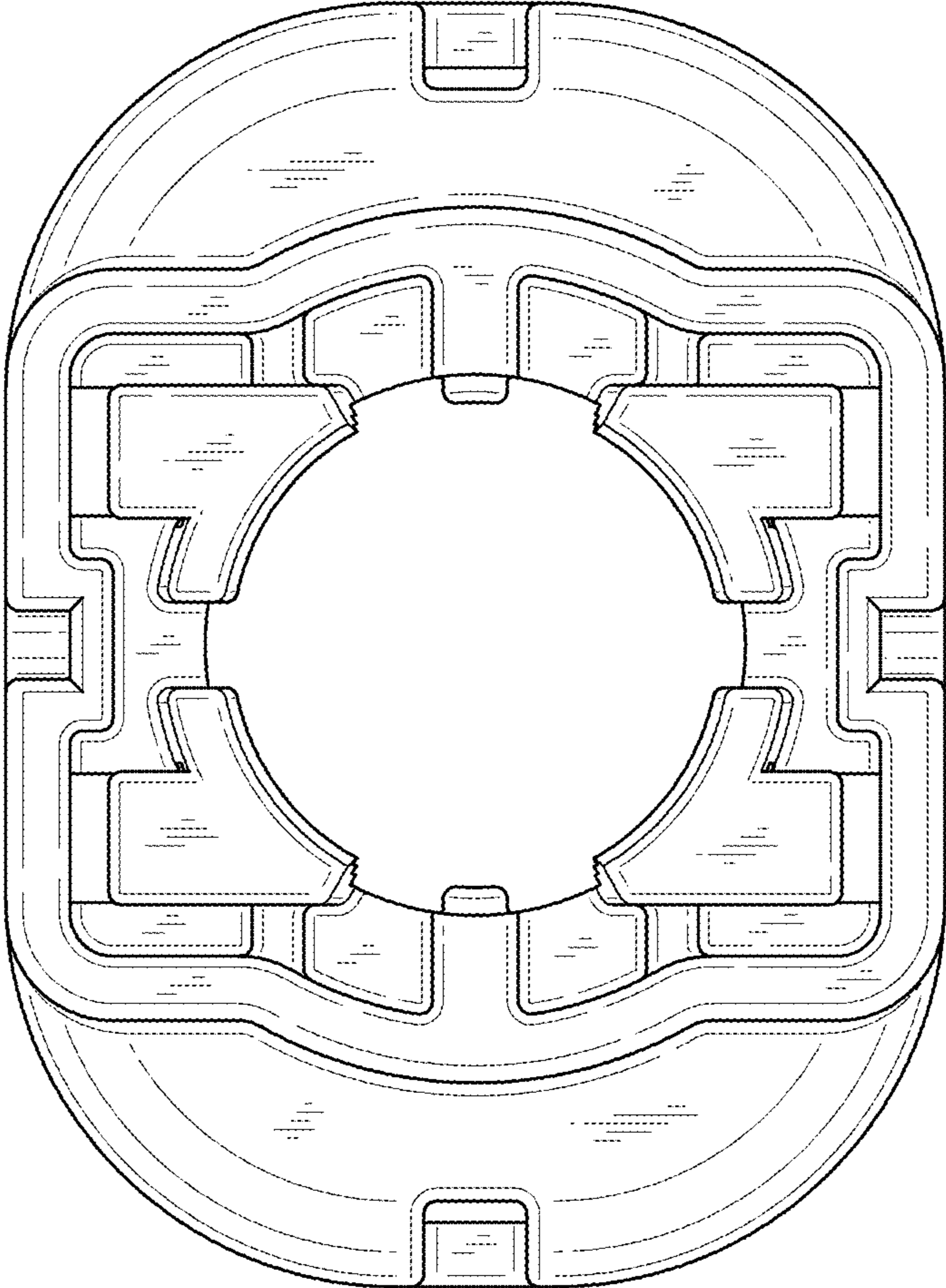

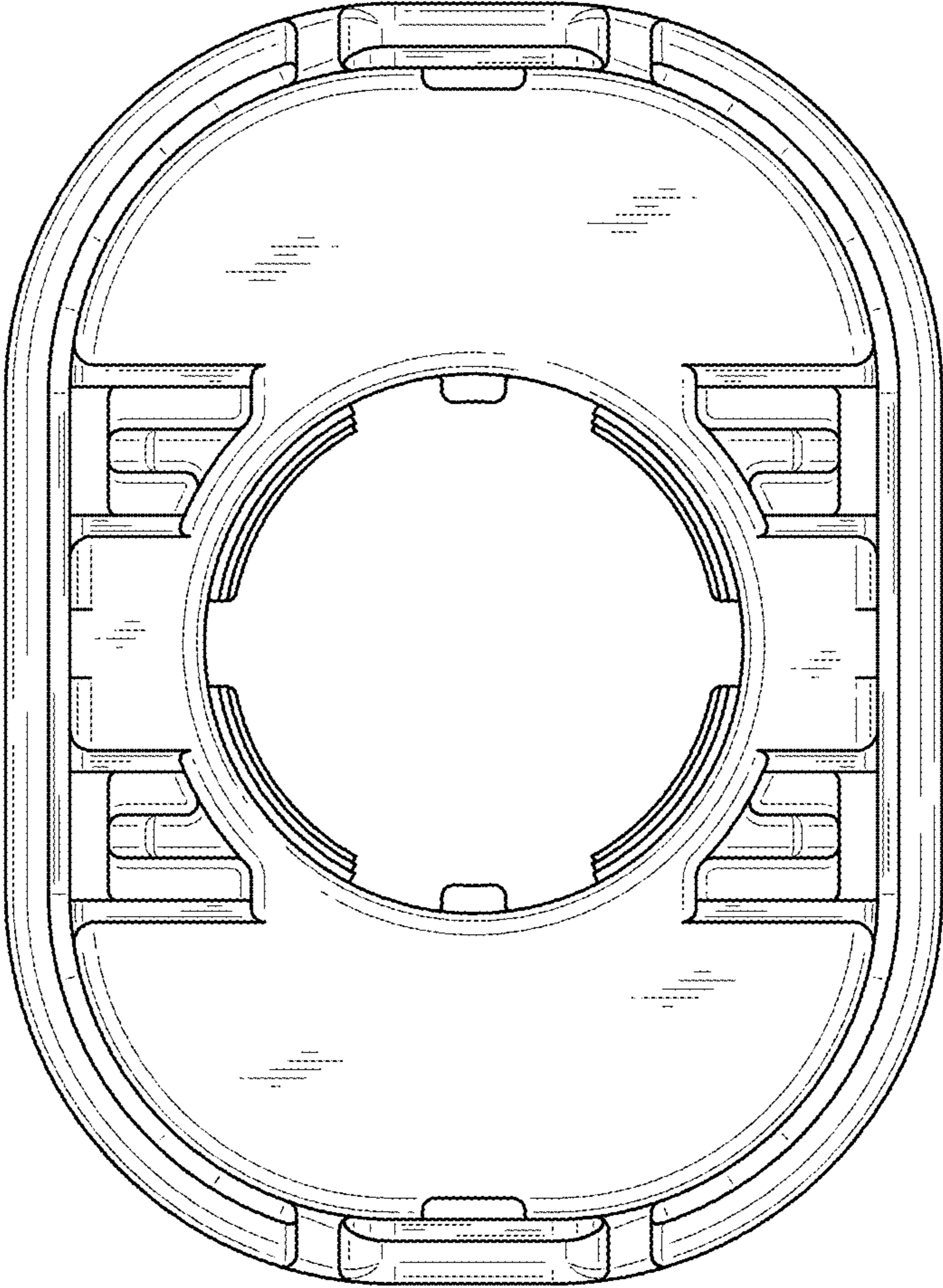

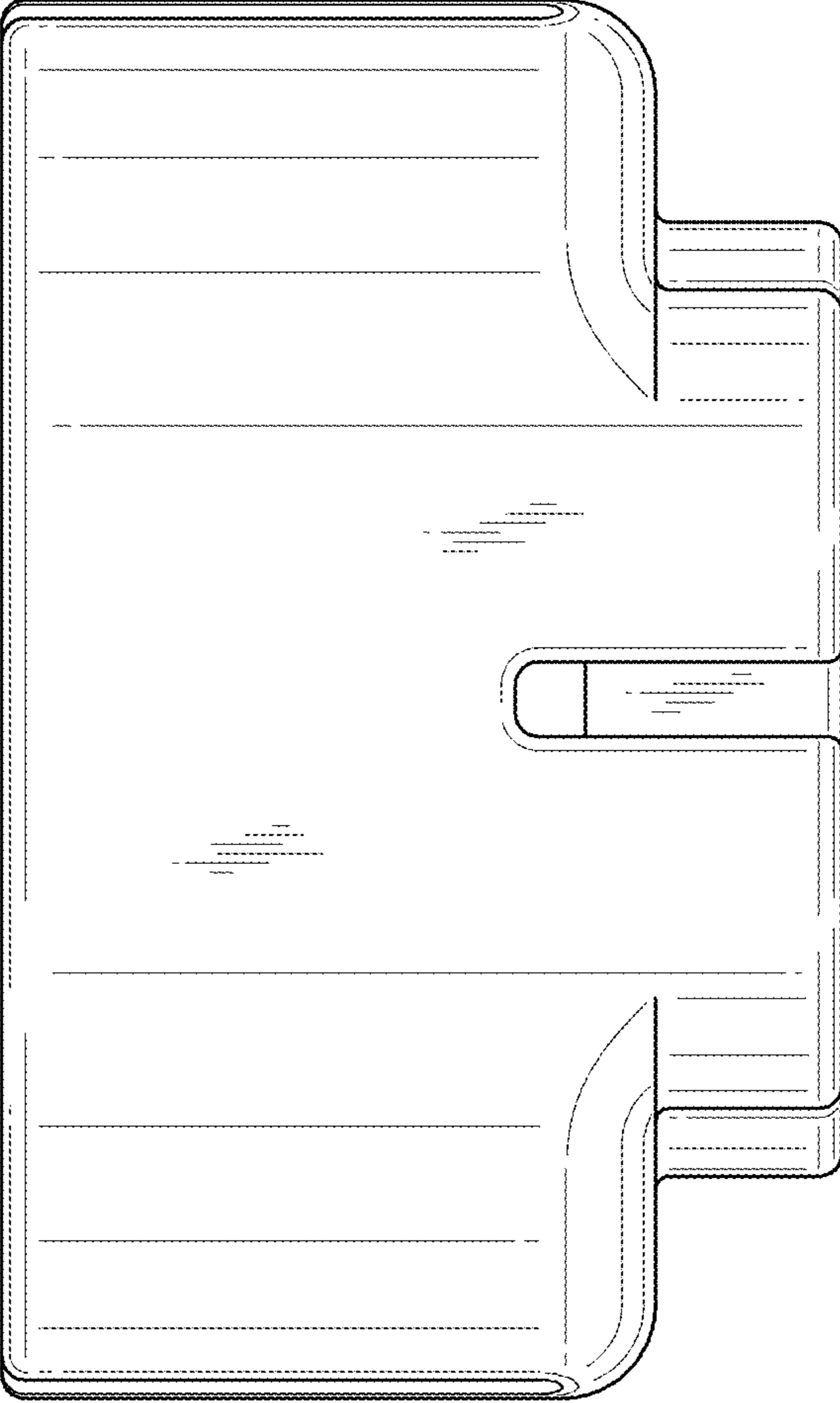

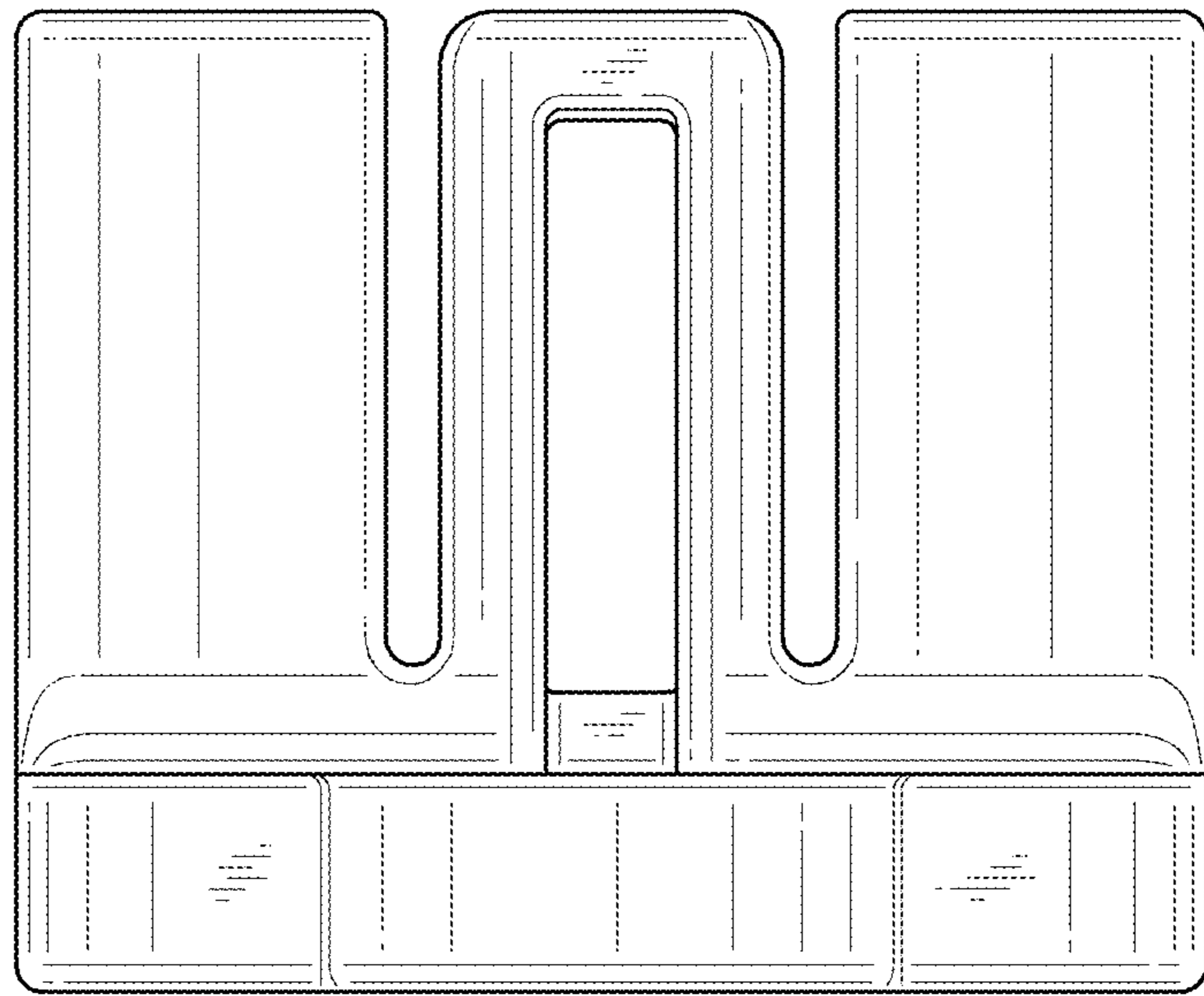
