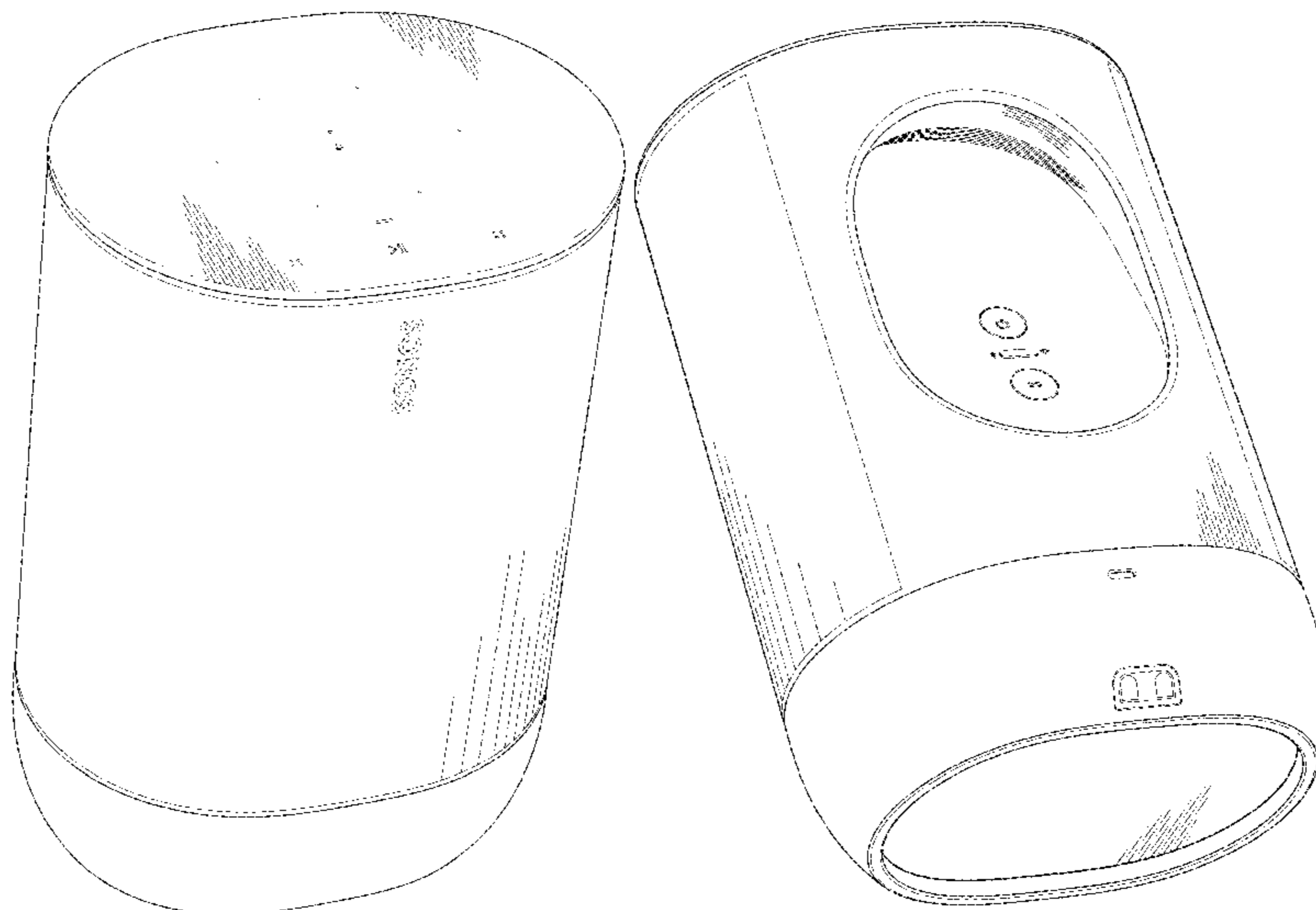
(57) **CLAIM**

The ornamental design for a media player device, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a media player device. FIG. 2 is rear elevation view thereof. FIG. 3 is a left side view thereof. FIG. 4 is a right side view thereof. FIG. 5 is a top plan view thereof. FIG. 6 is a bottom plan view thereof. FIG. 7 is a perspective view thereof; and, FIG. 8 is a second perspective view thereof. 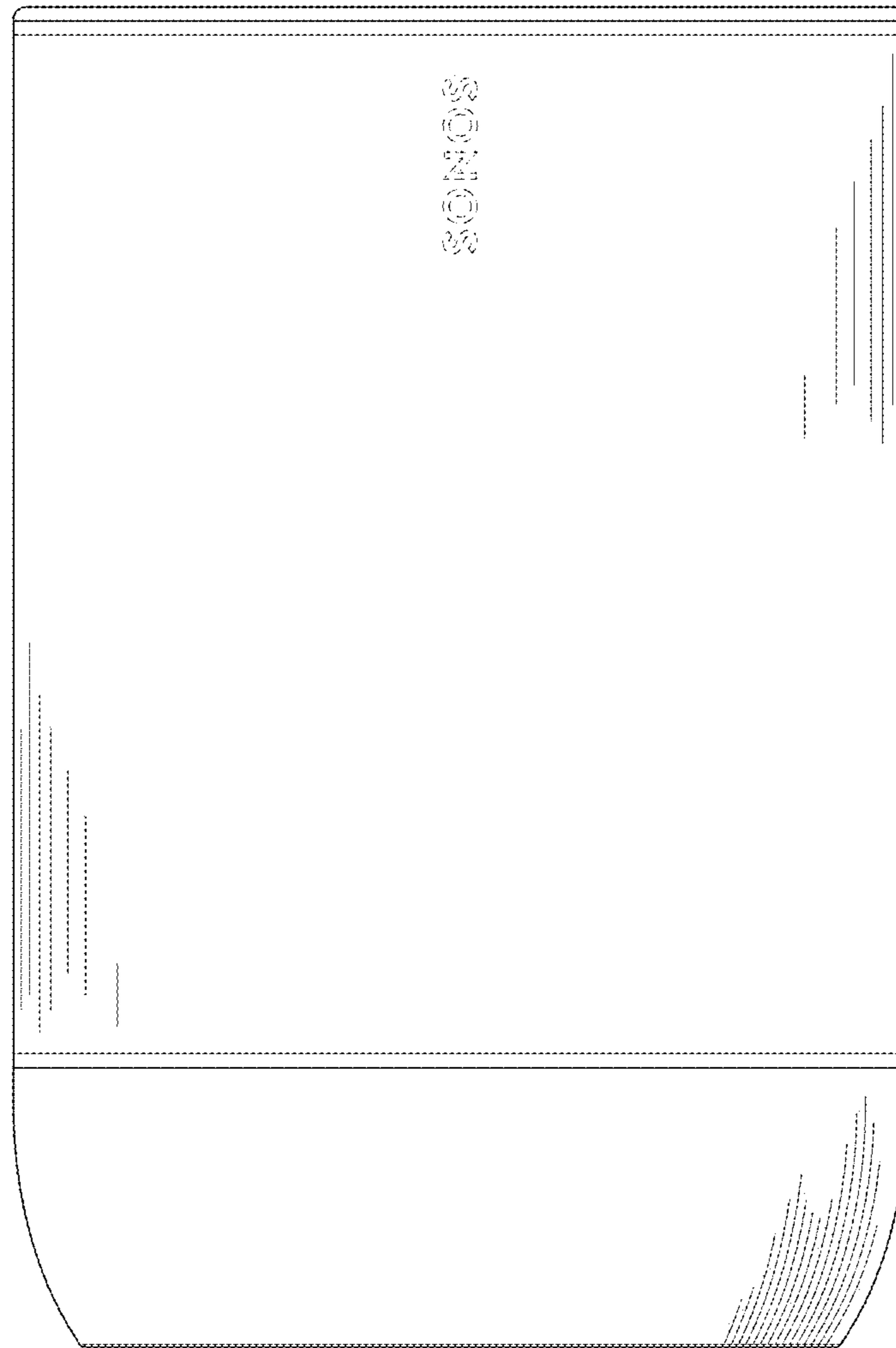

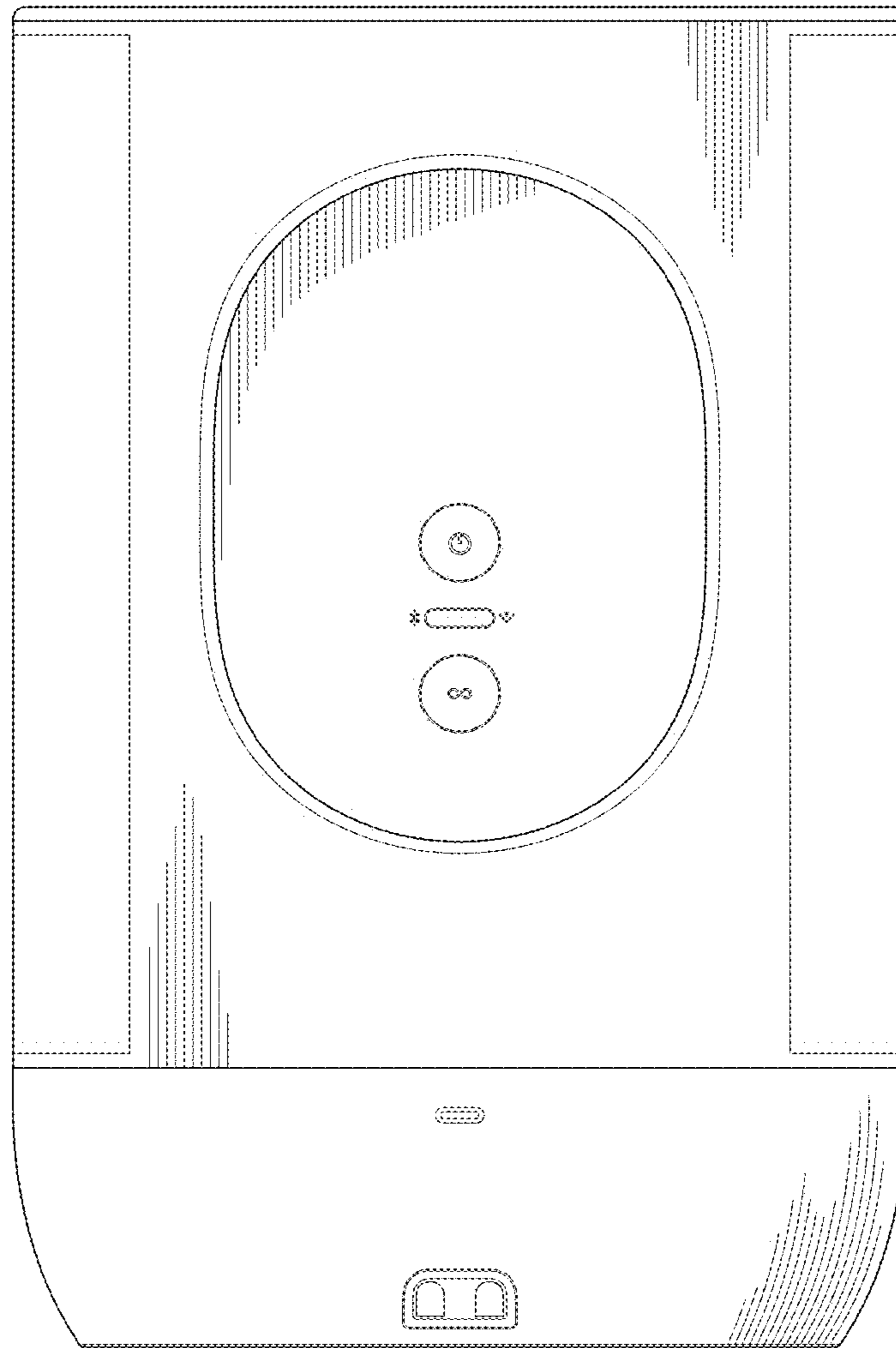

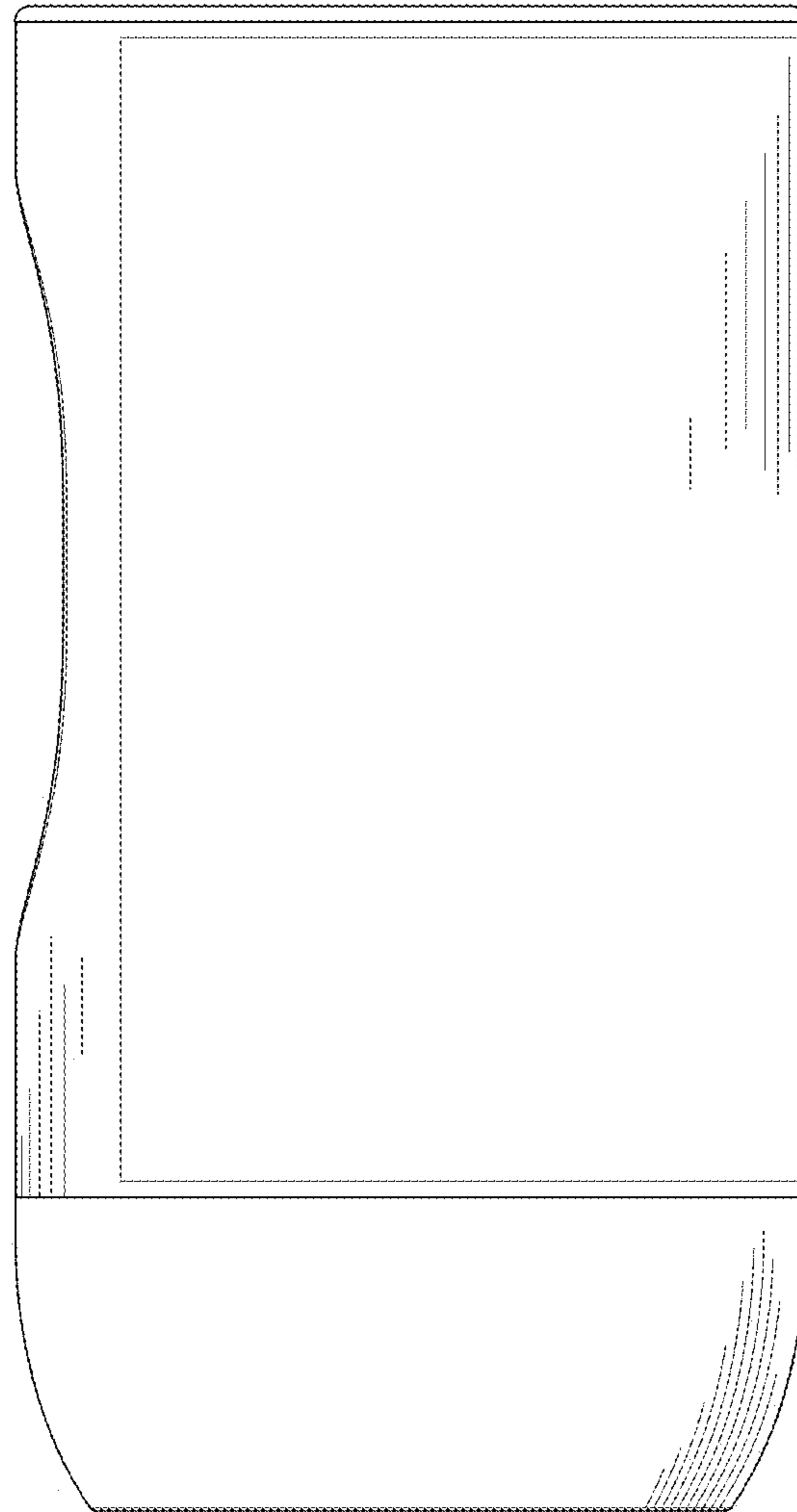

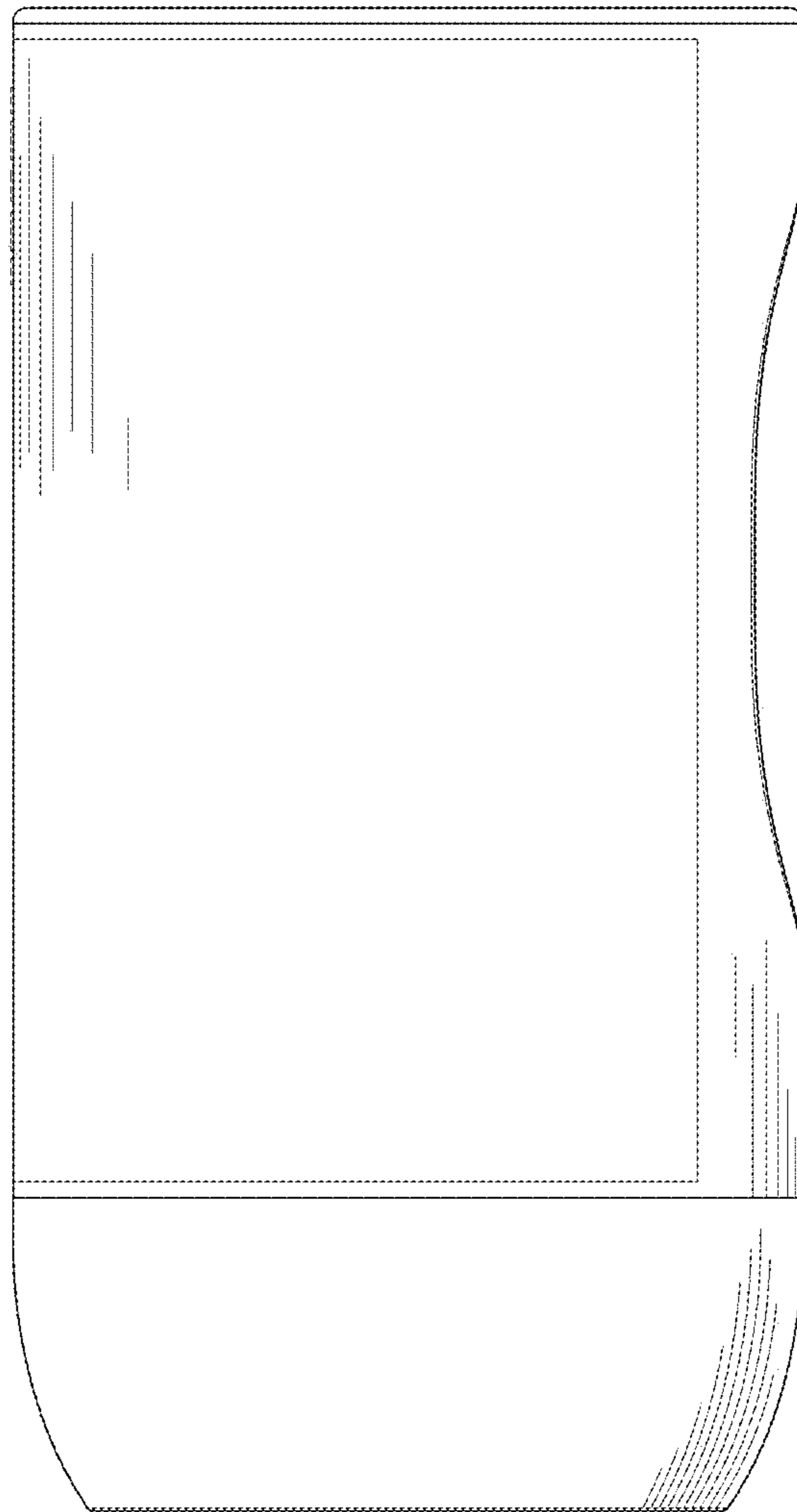

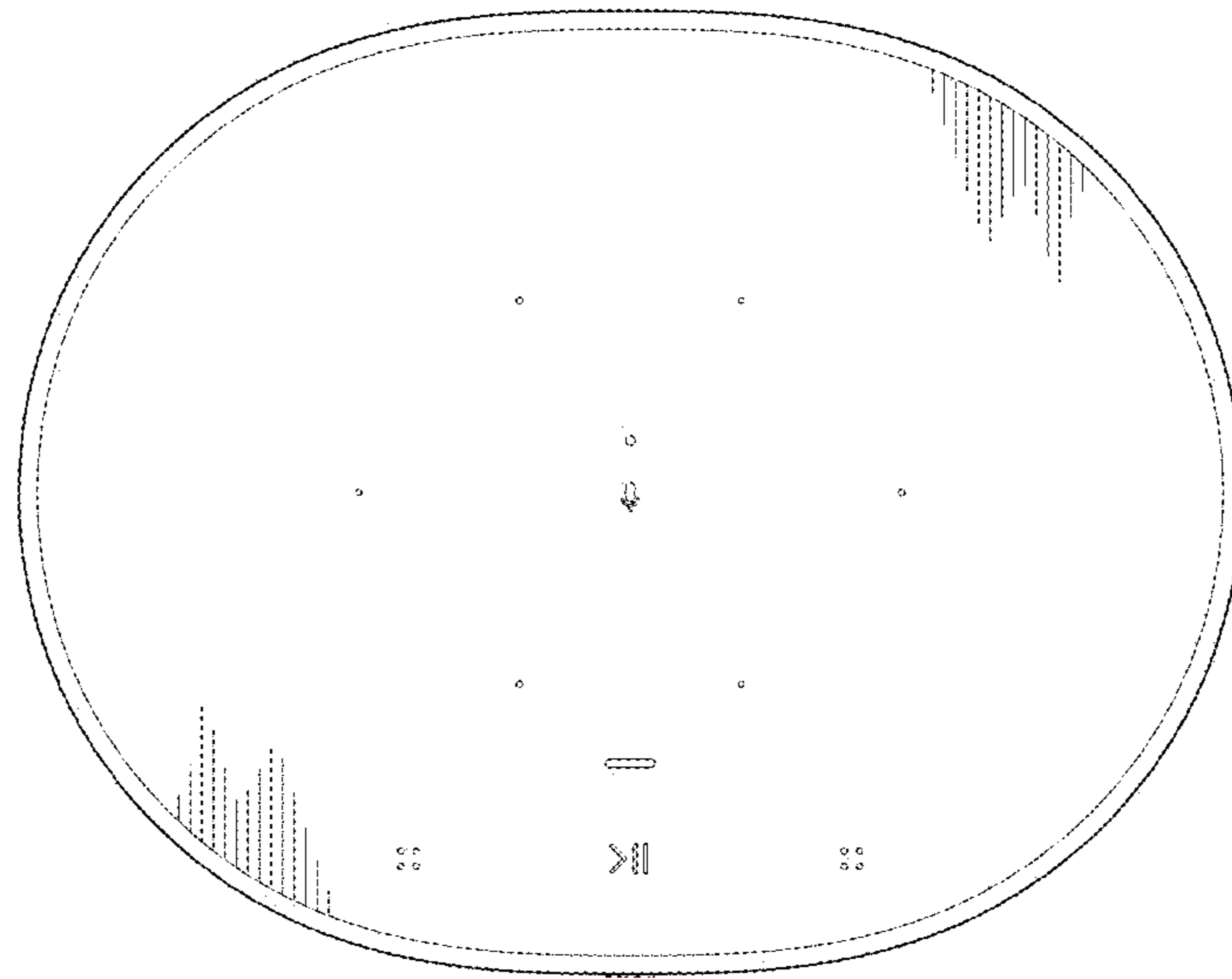

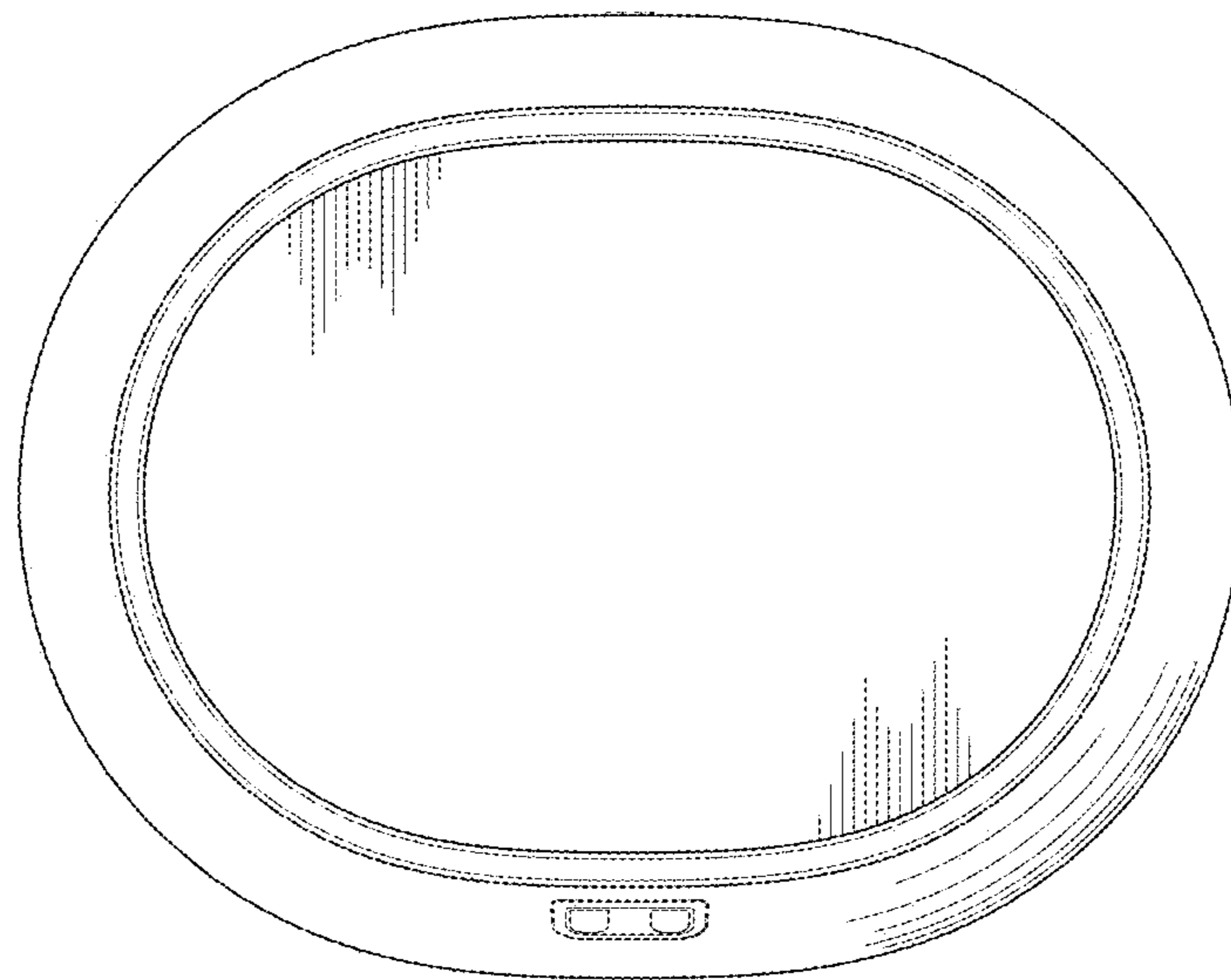

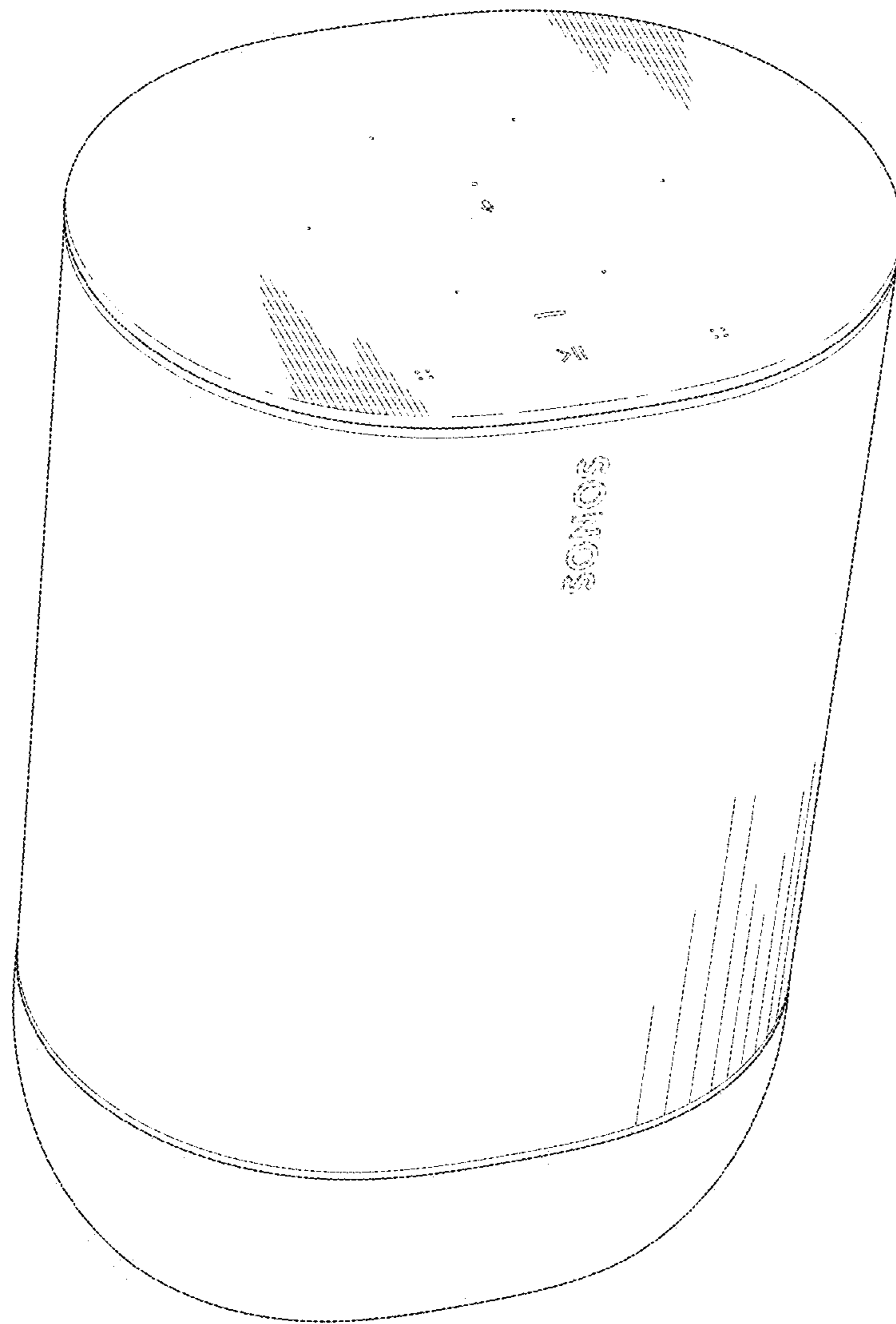

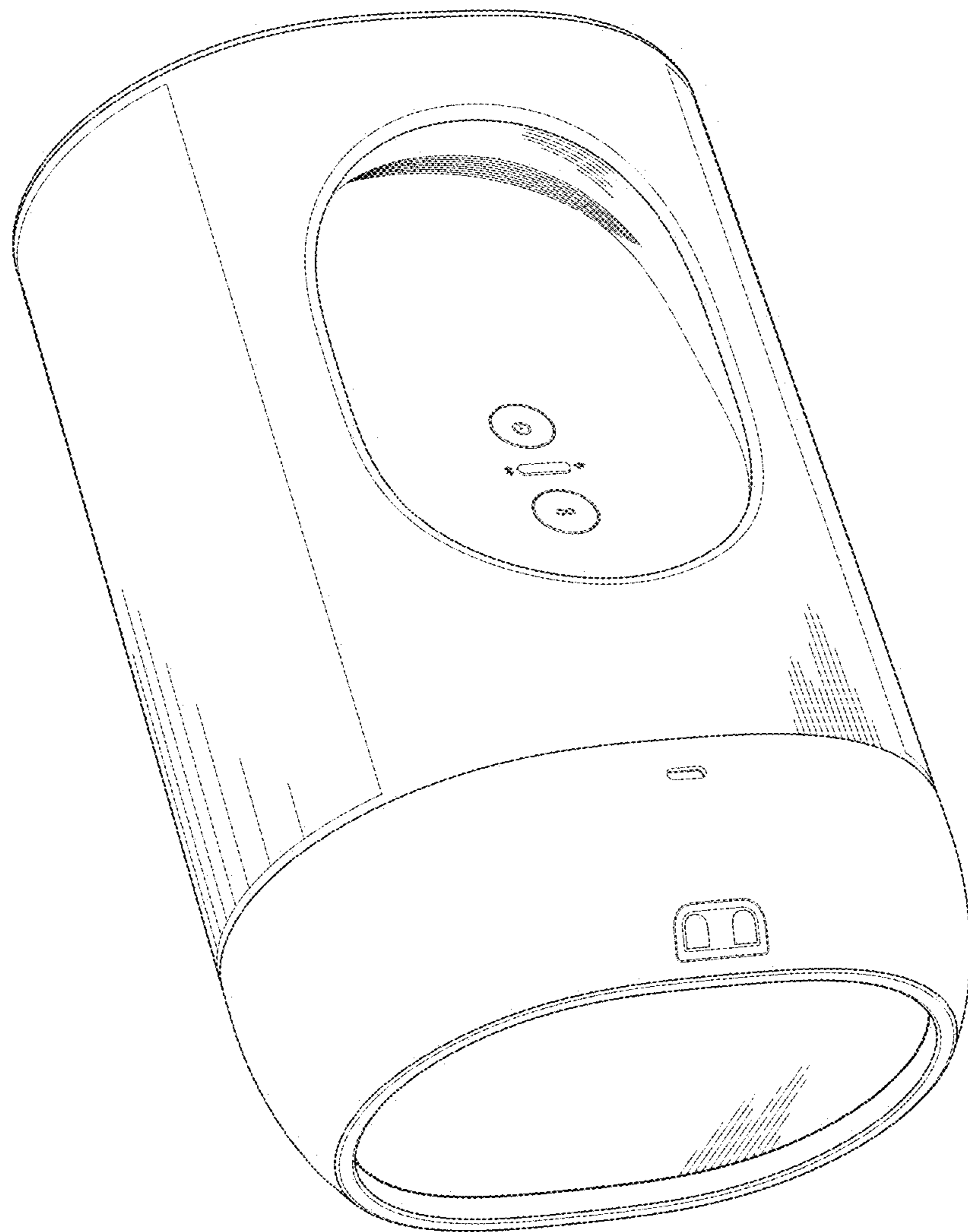
