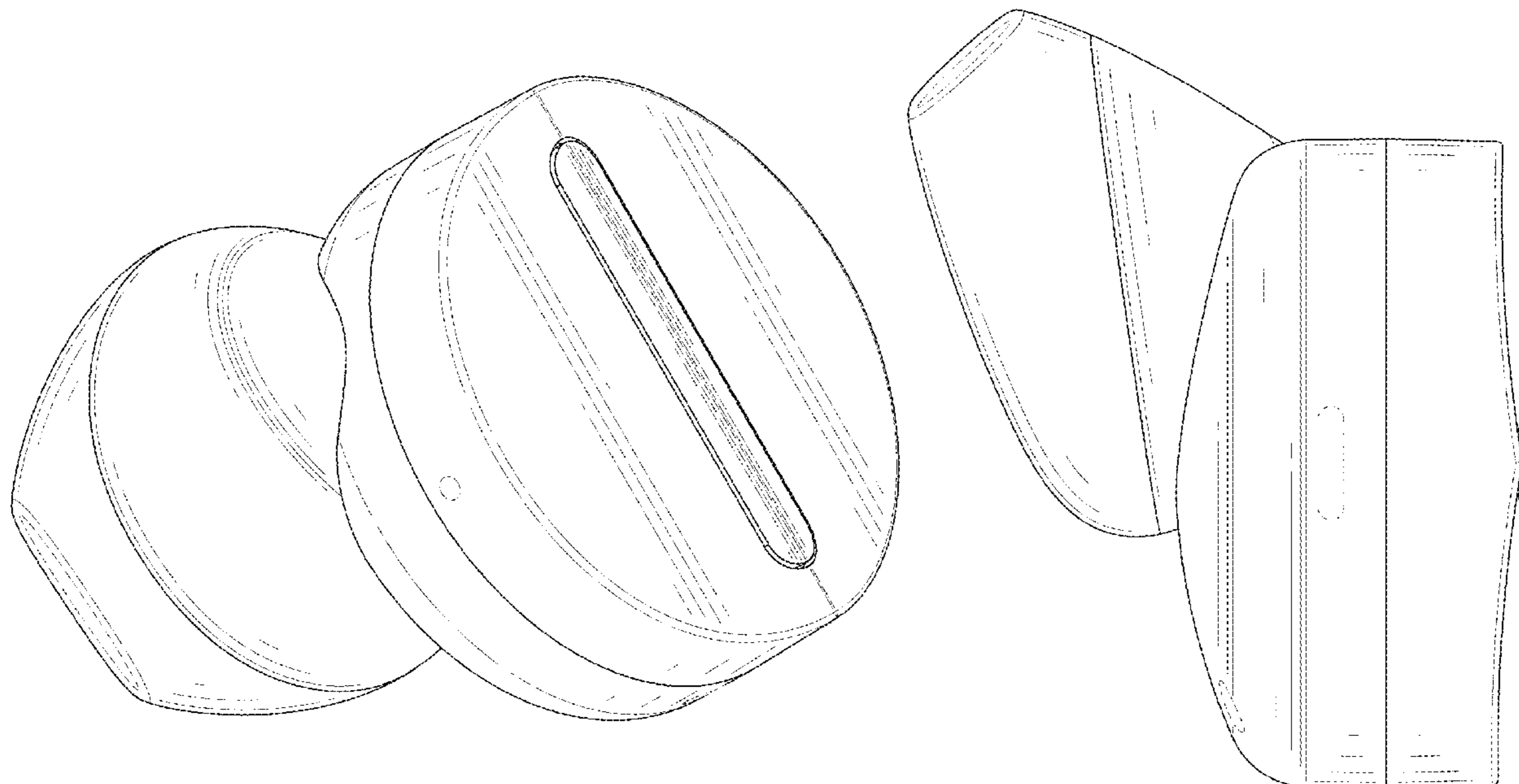
(57) **CLAIM**

The ornamental design for an earphone, as shown and described.

**DESCRIPTION**

FIG. 1 is a rear, top perspective view of an earphone;  
FIG. 2 is a bottom, left side, front perspective view thereof;  
FIG. 3 is a rear, right side perspective view thereof;  
FIG. 4 is a front, top perspective view thereof;  
FIG. 5 is a rear elevation view thereof;  
FIG. 6 is a front elevation view thereof;

FIG. 9 is a top plan view thereof; and,  
FIG. 10 is a bottom plan view thereof.

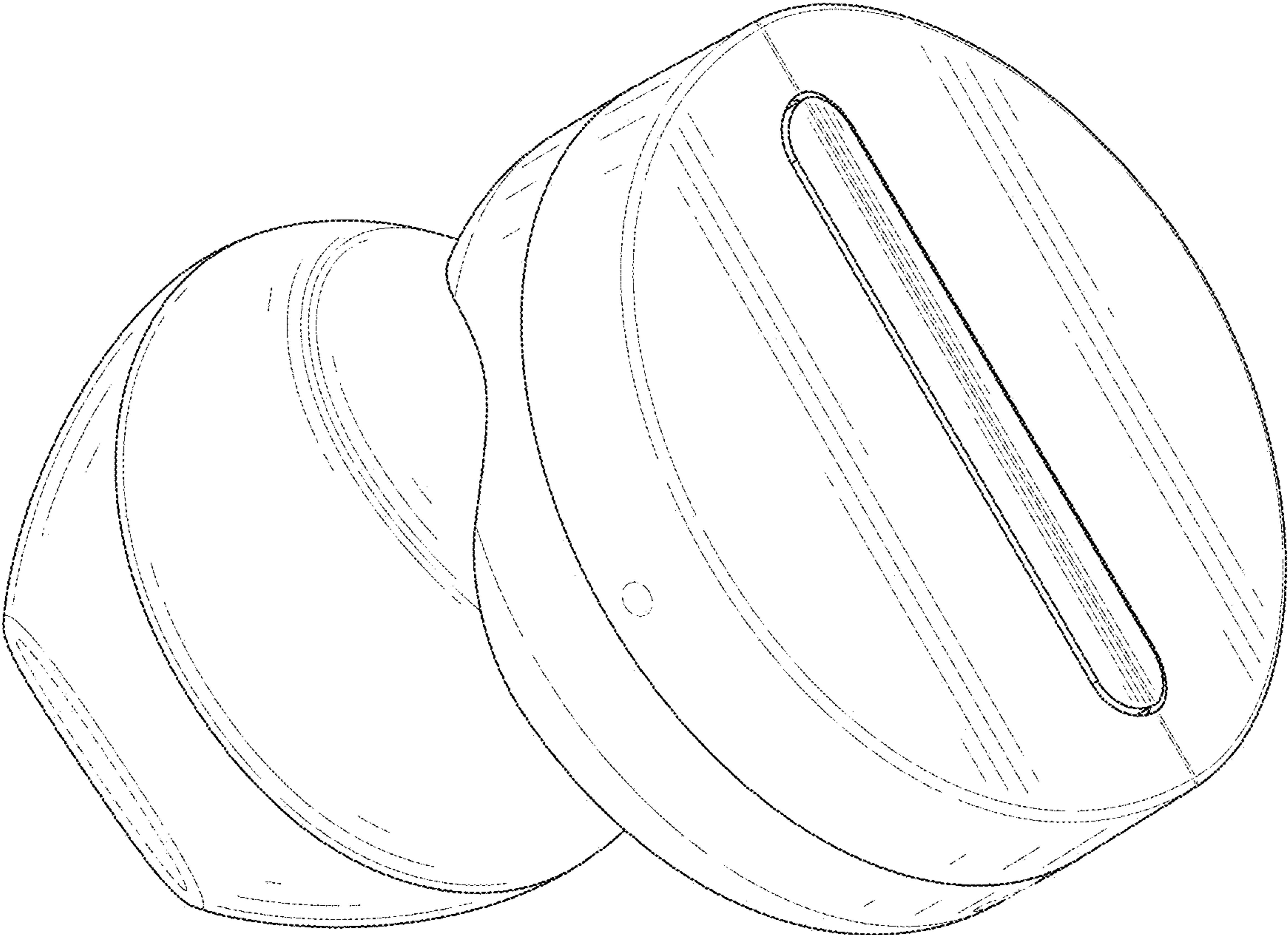

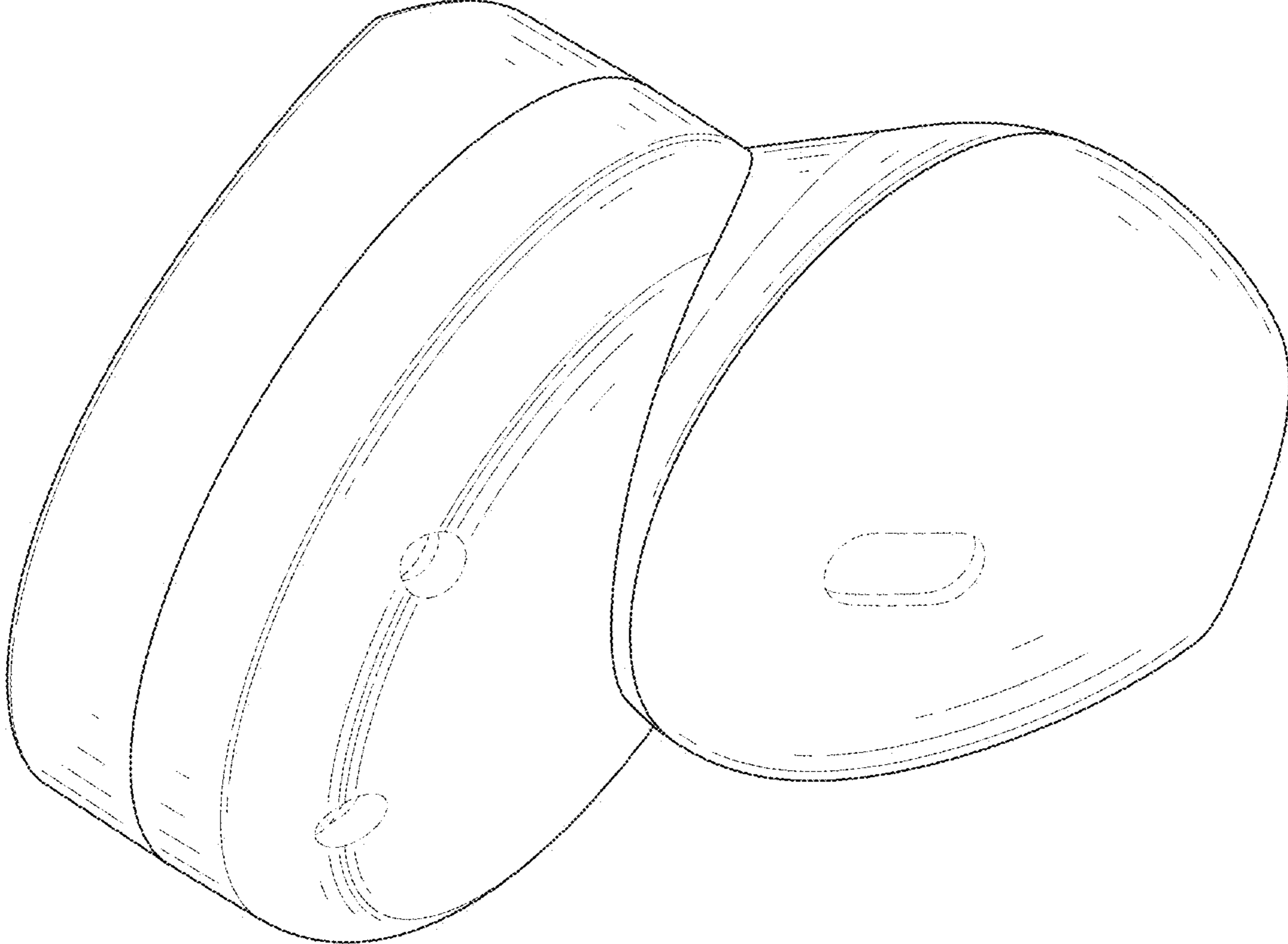

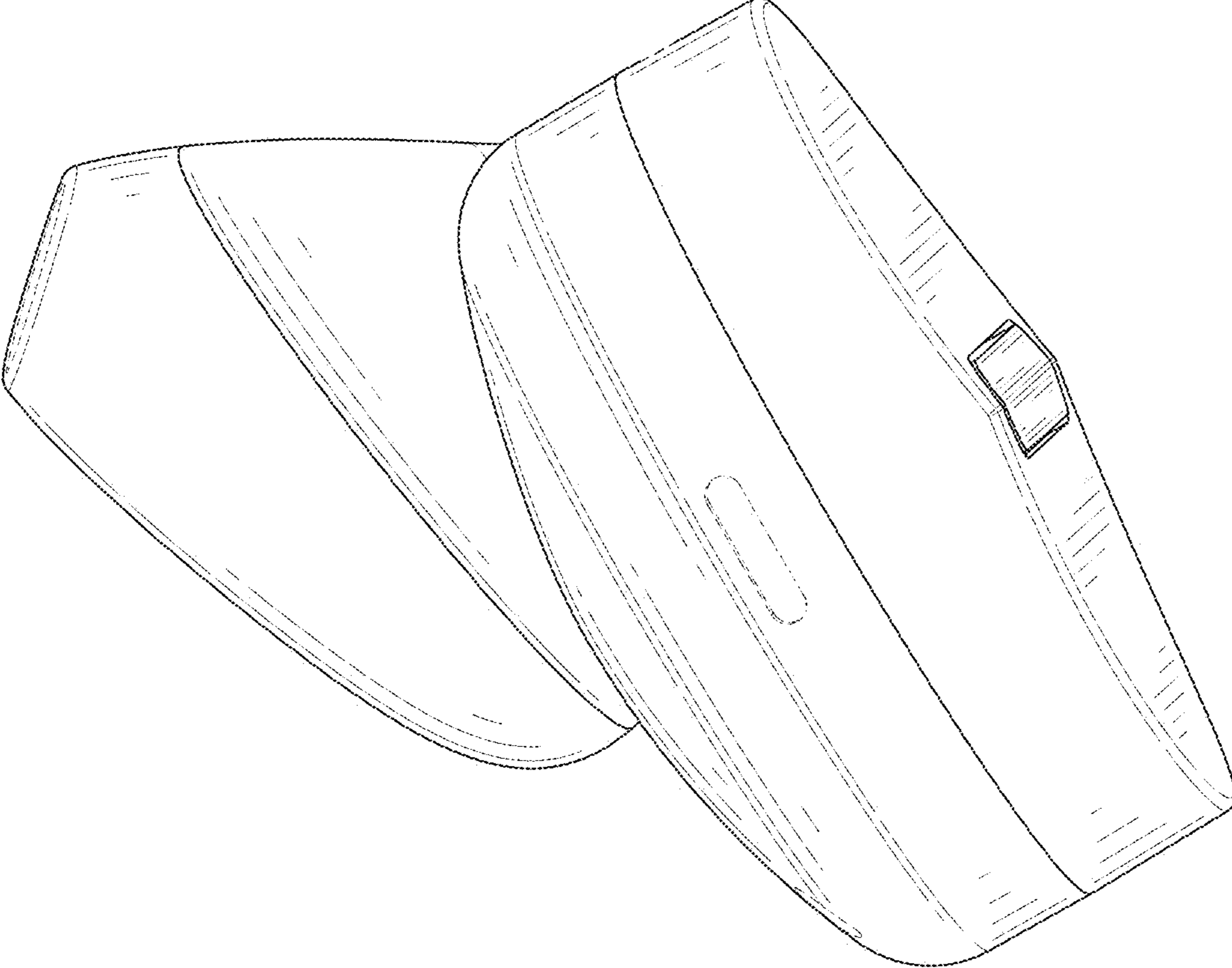

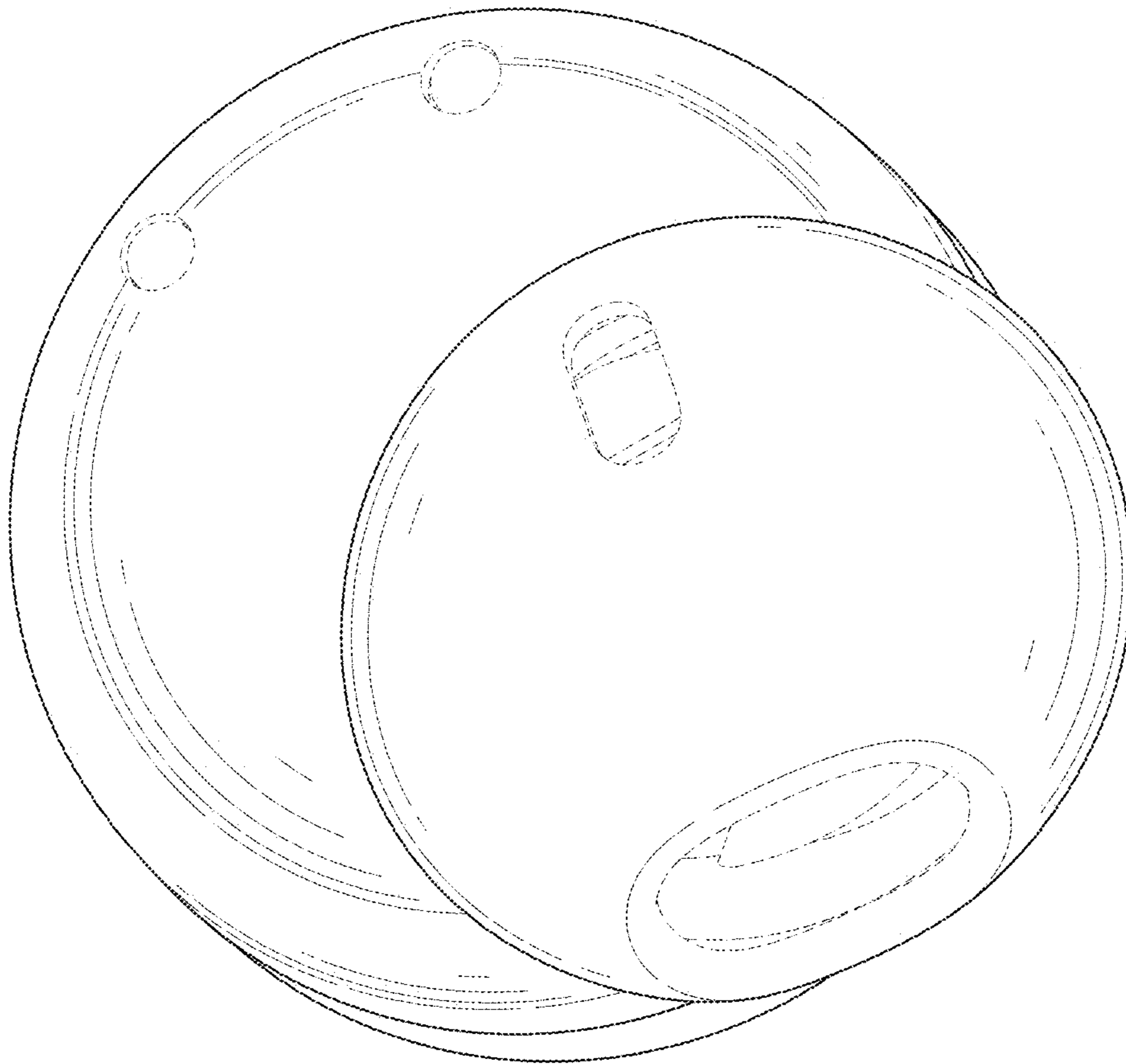

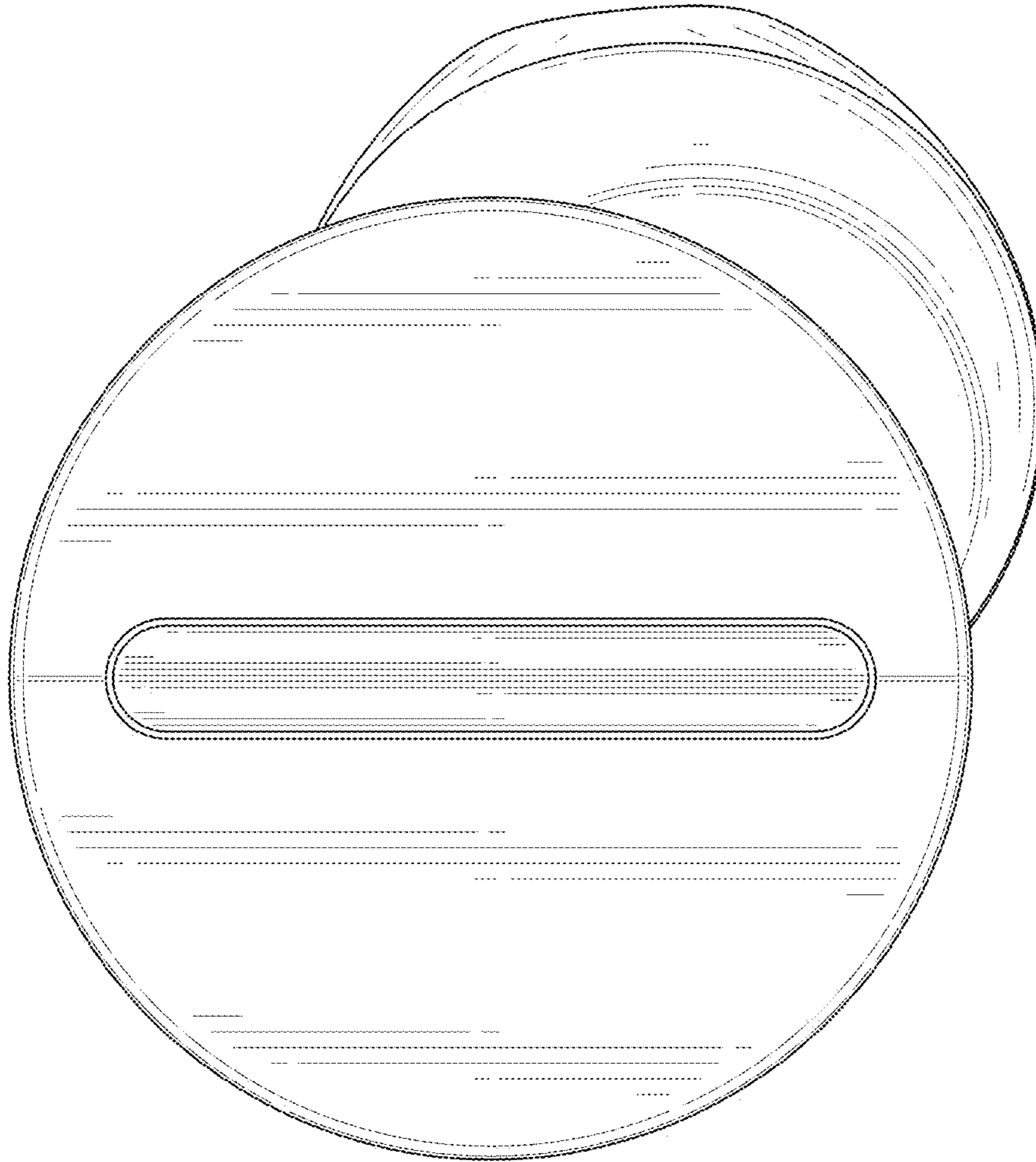

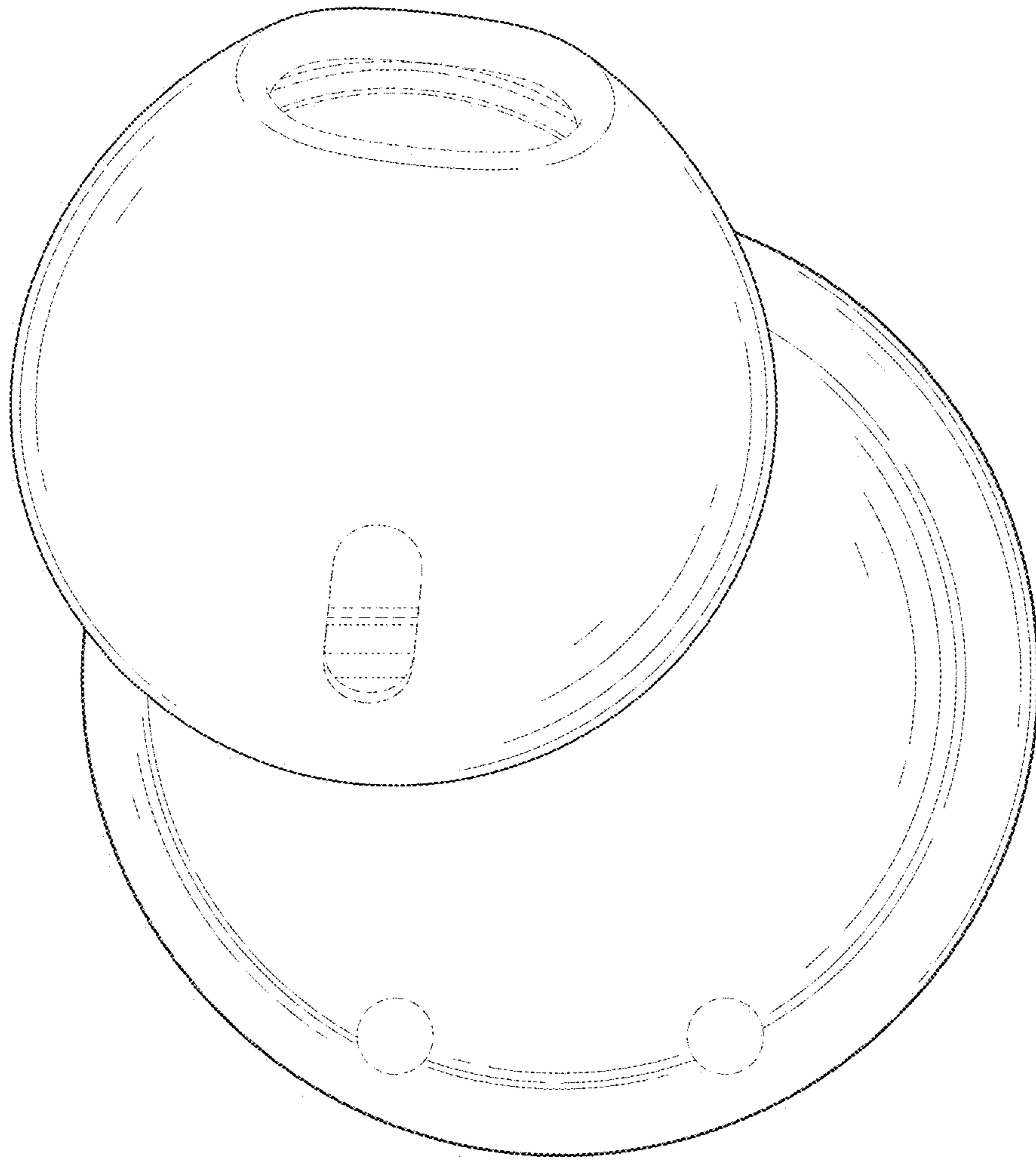

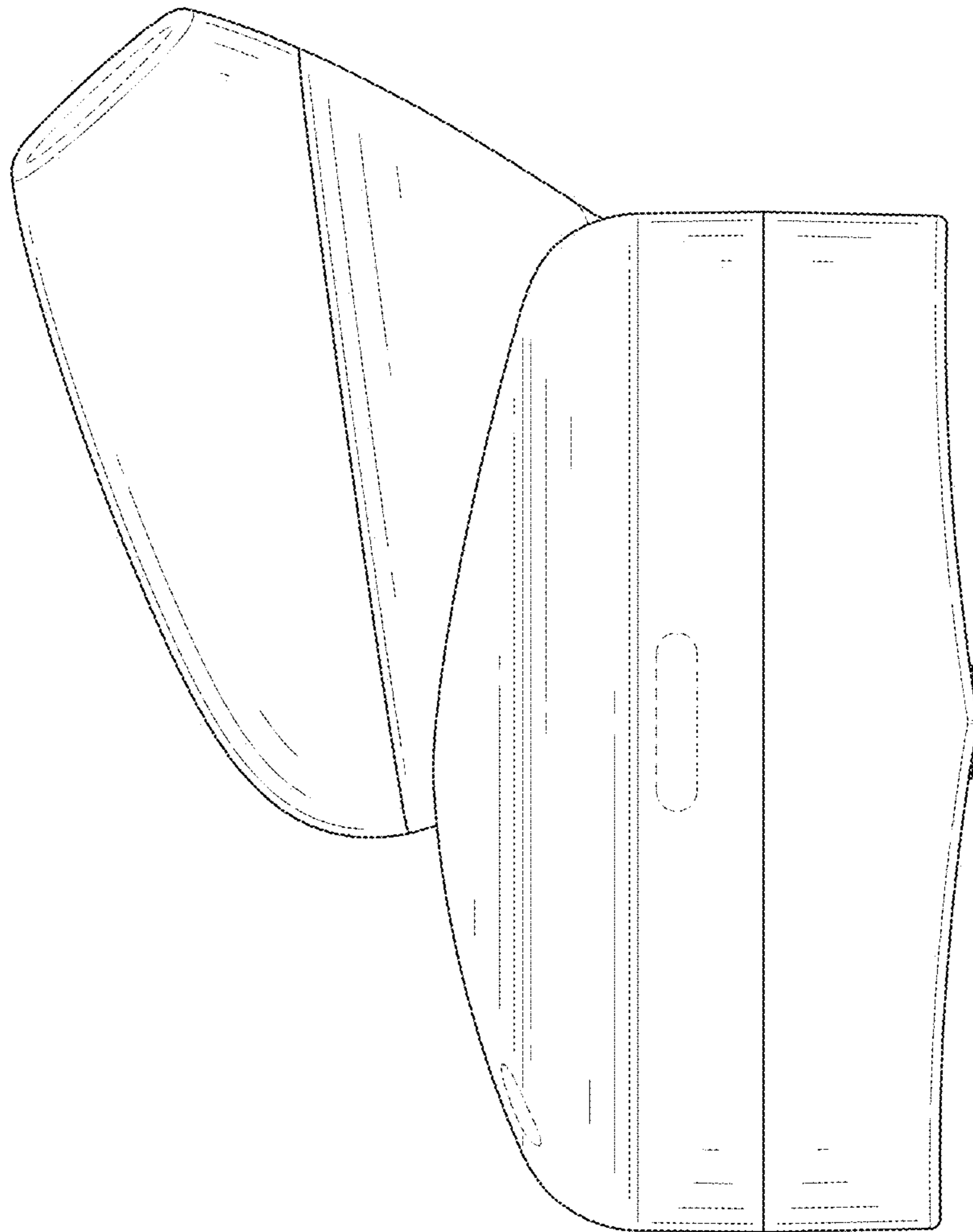

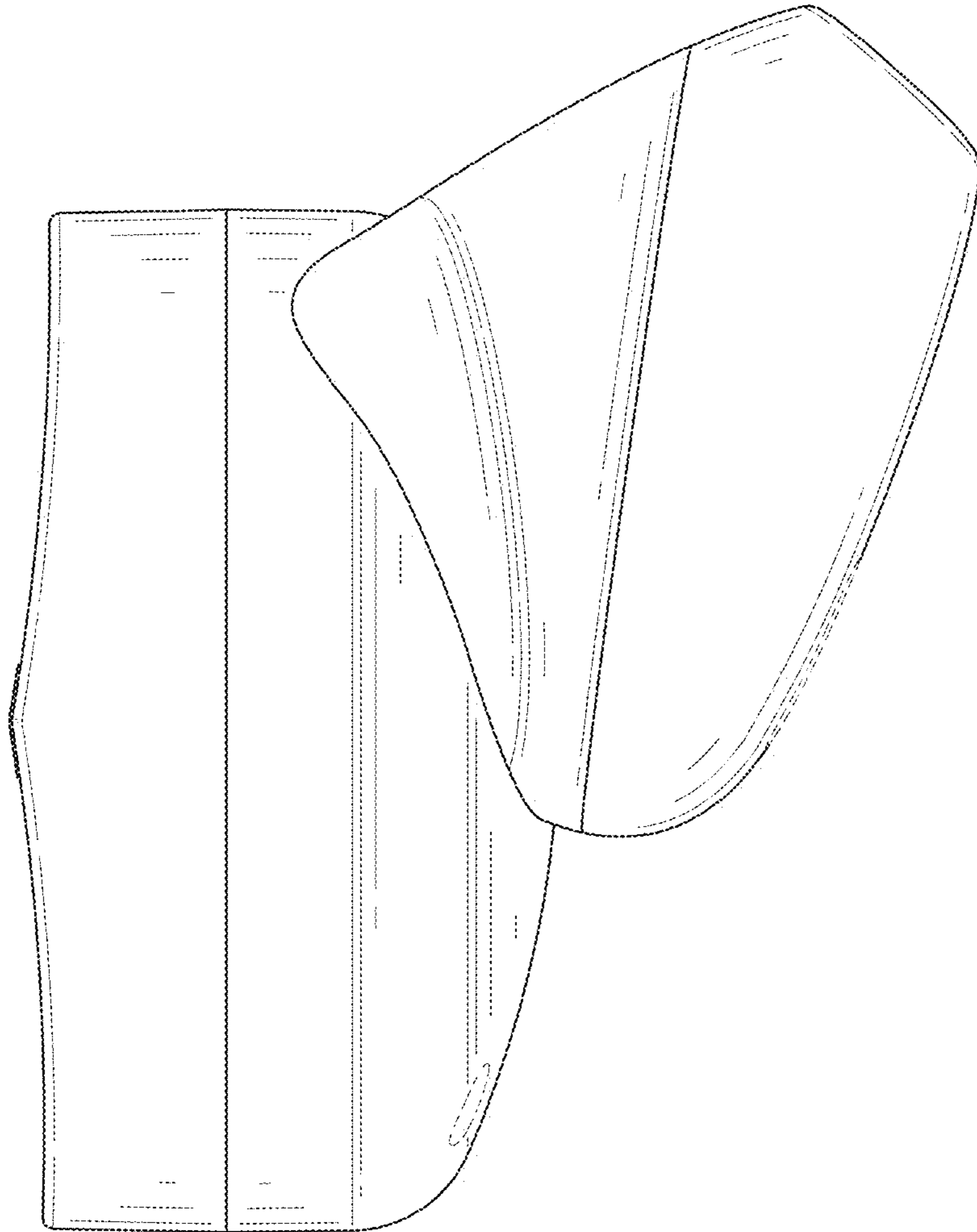

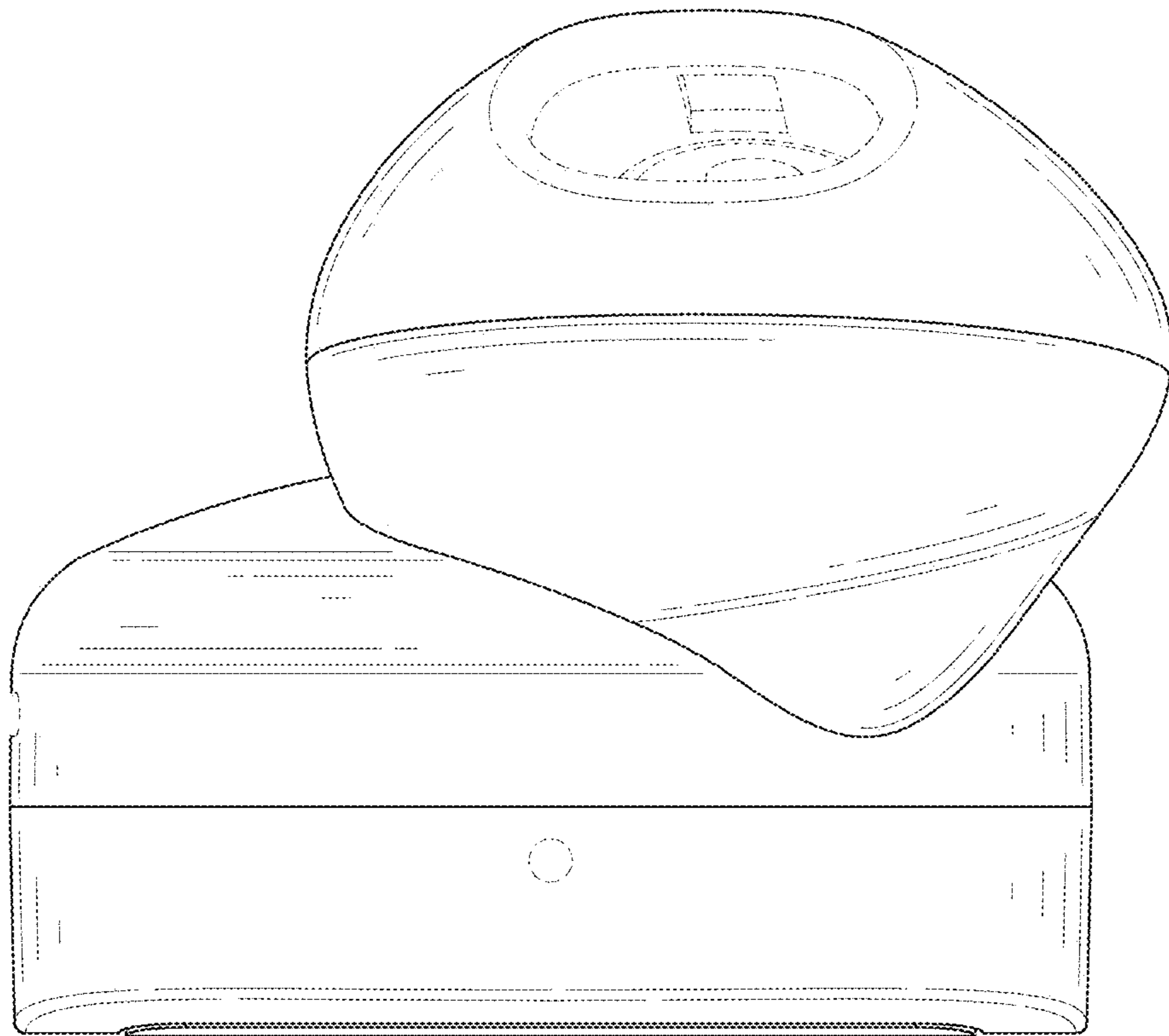

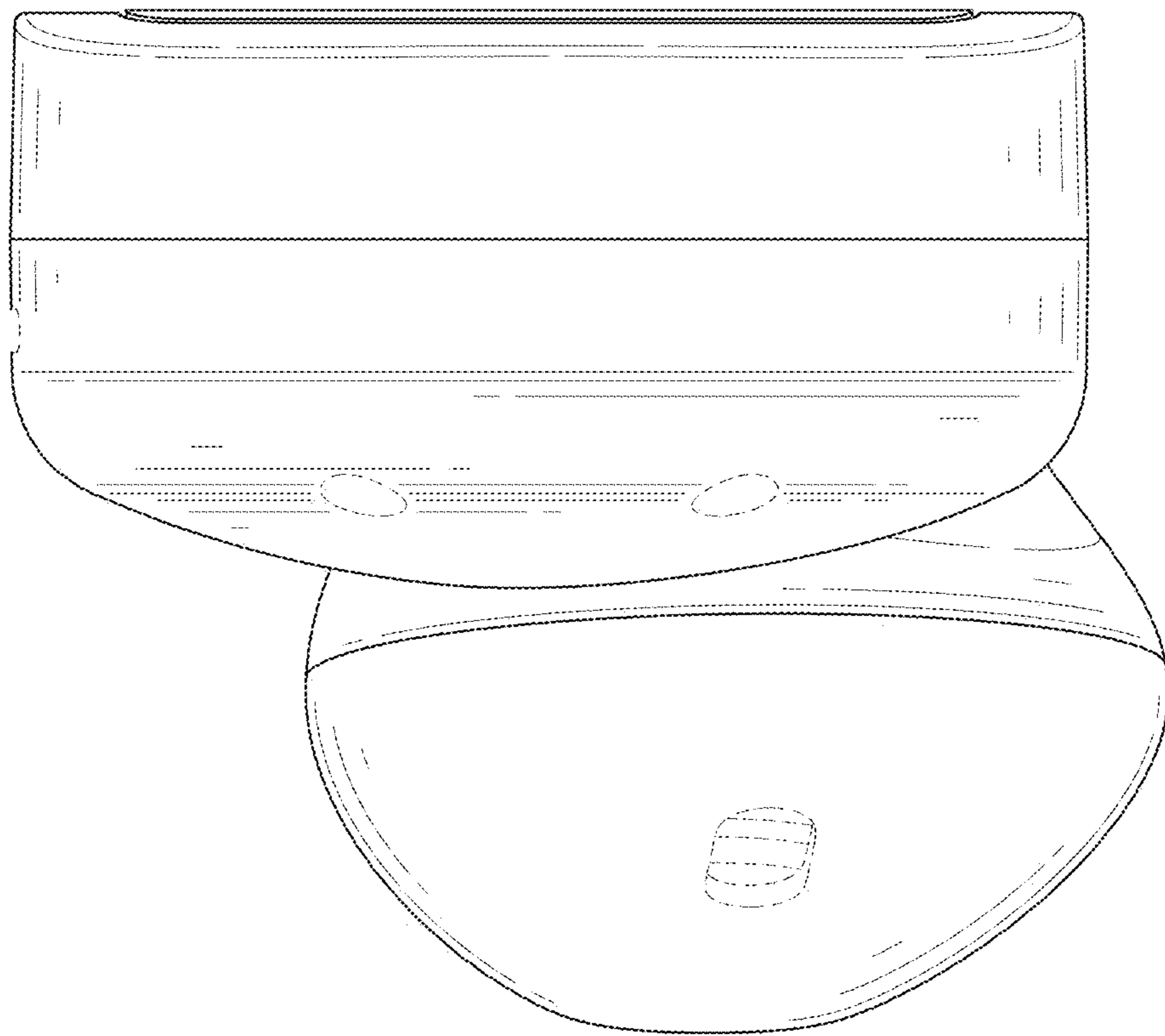
