(57) **CLAIM**

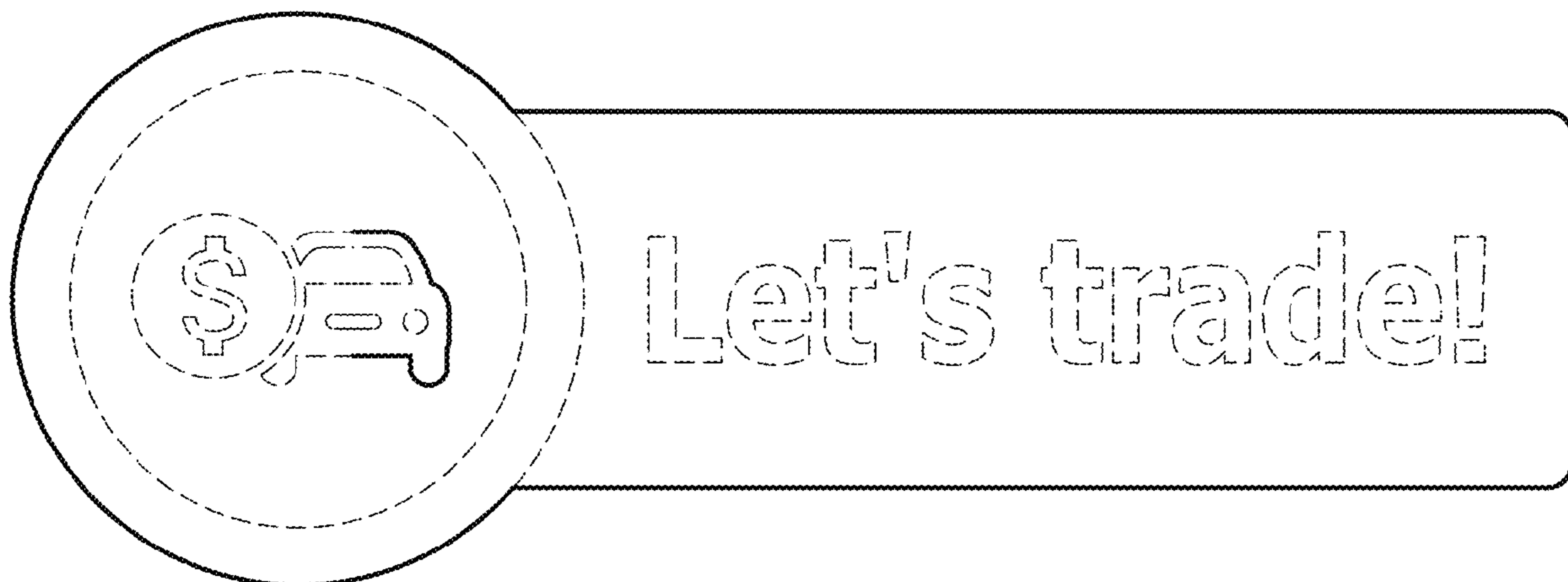
The ornamental design for a display screen or portion thereof with icon, as shown and described.

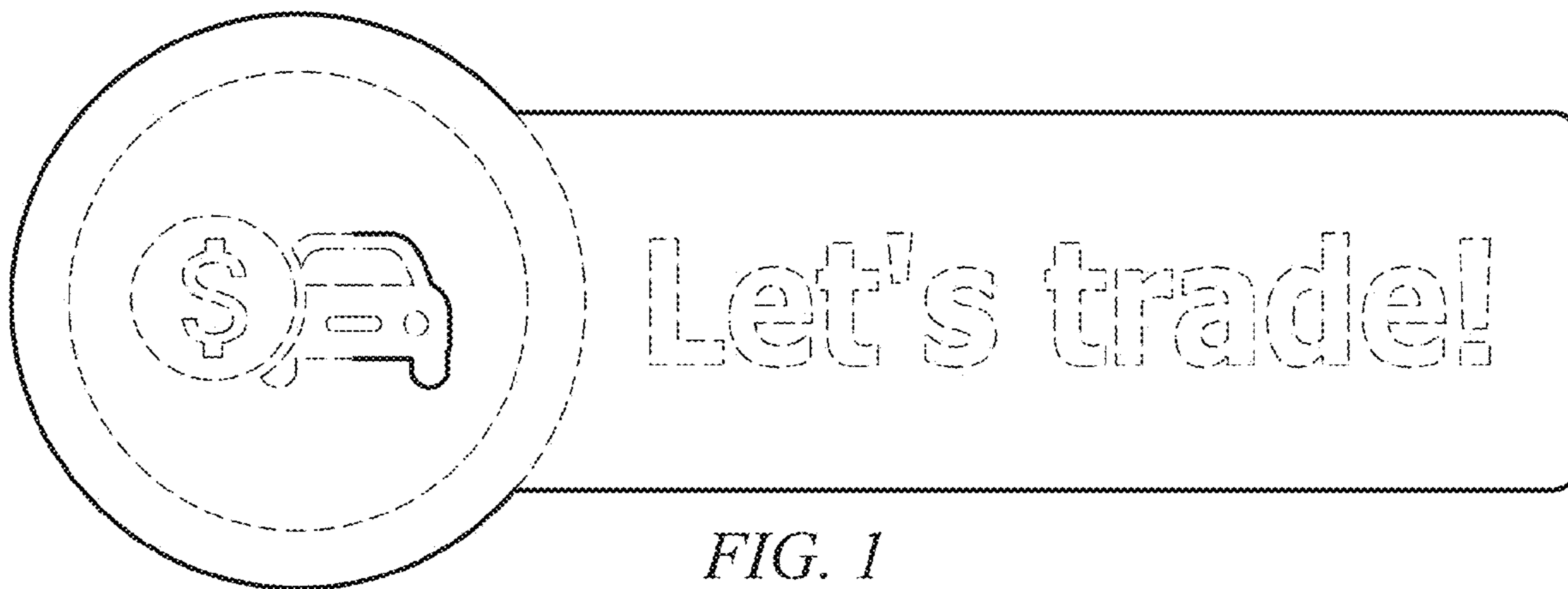

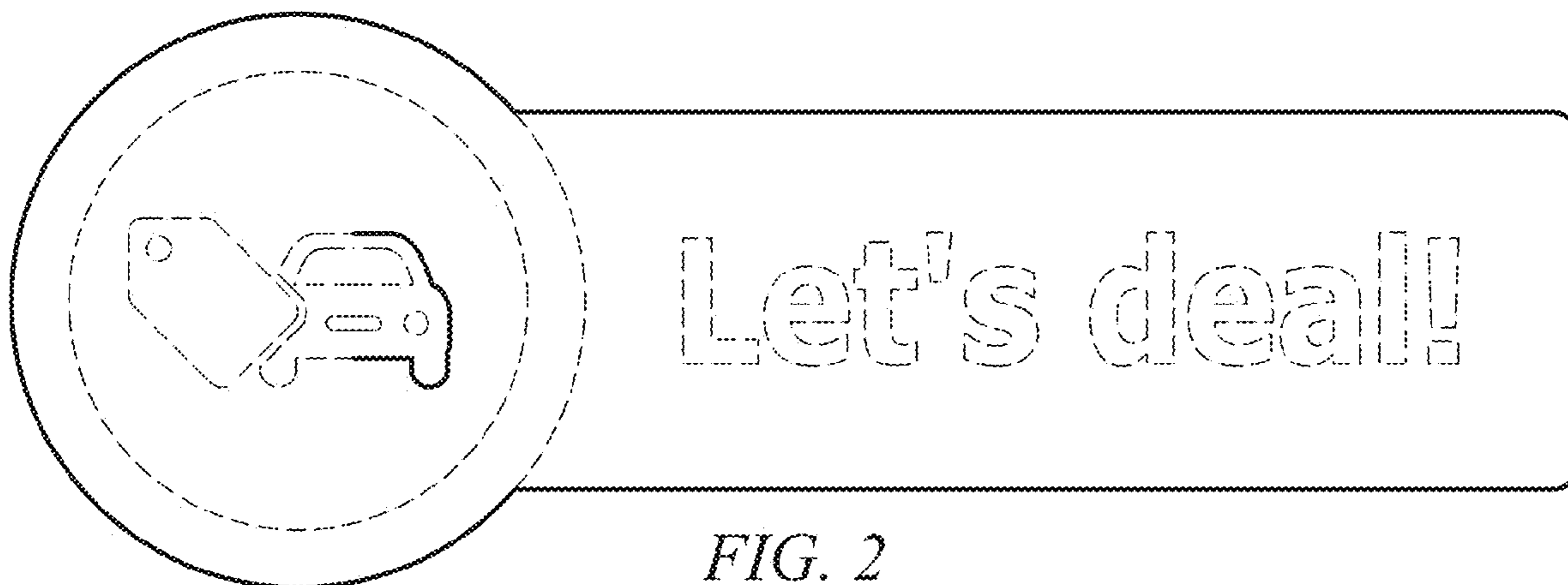

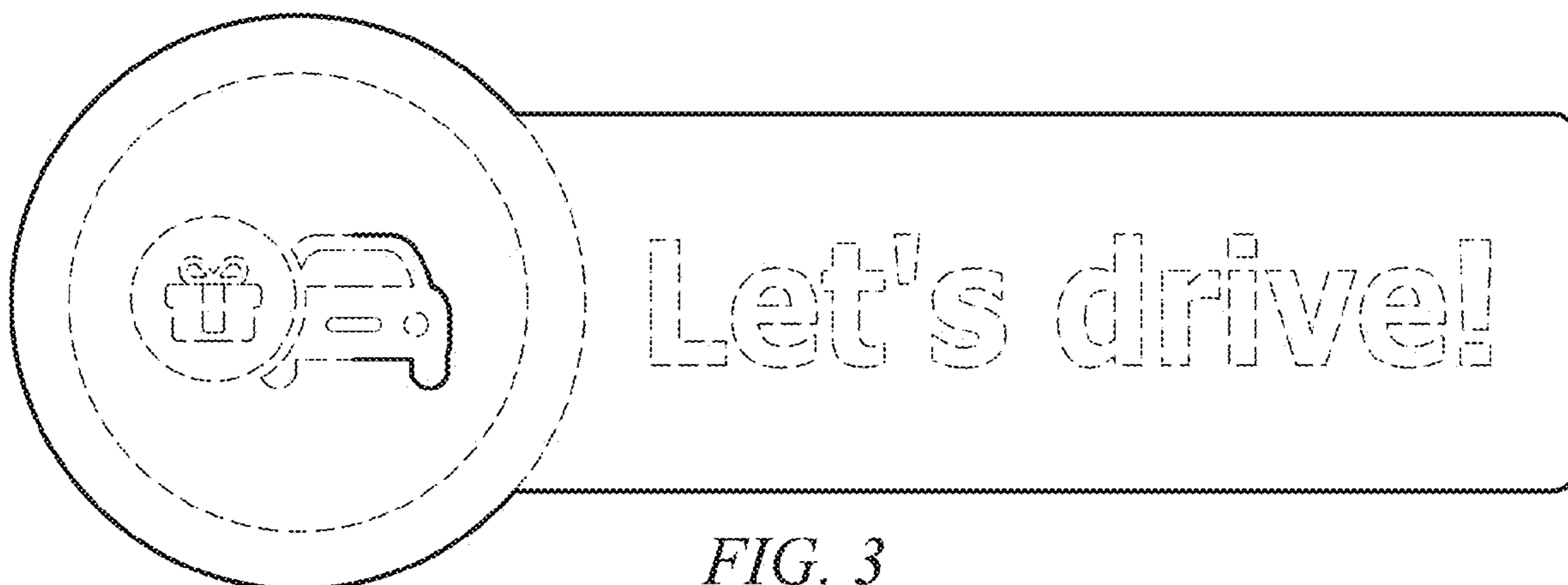

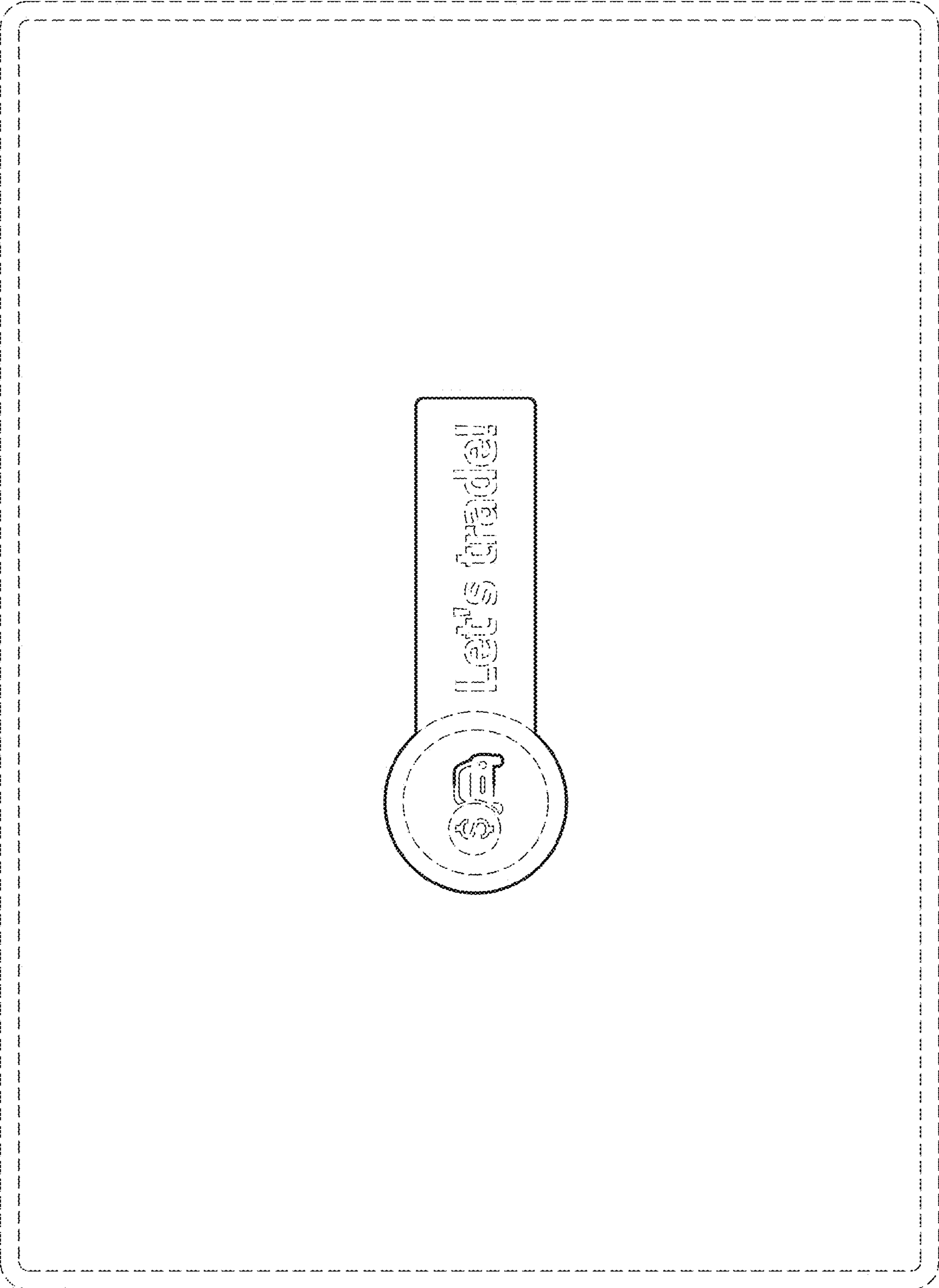
