The ornamental design for a weighted sleep mask, as shown and described.

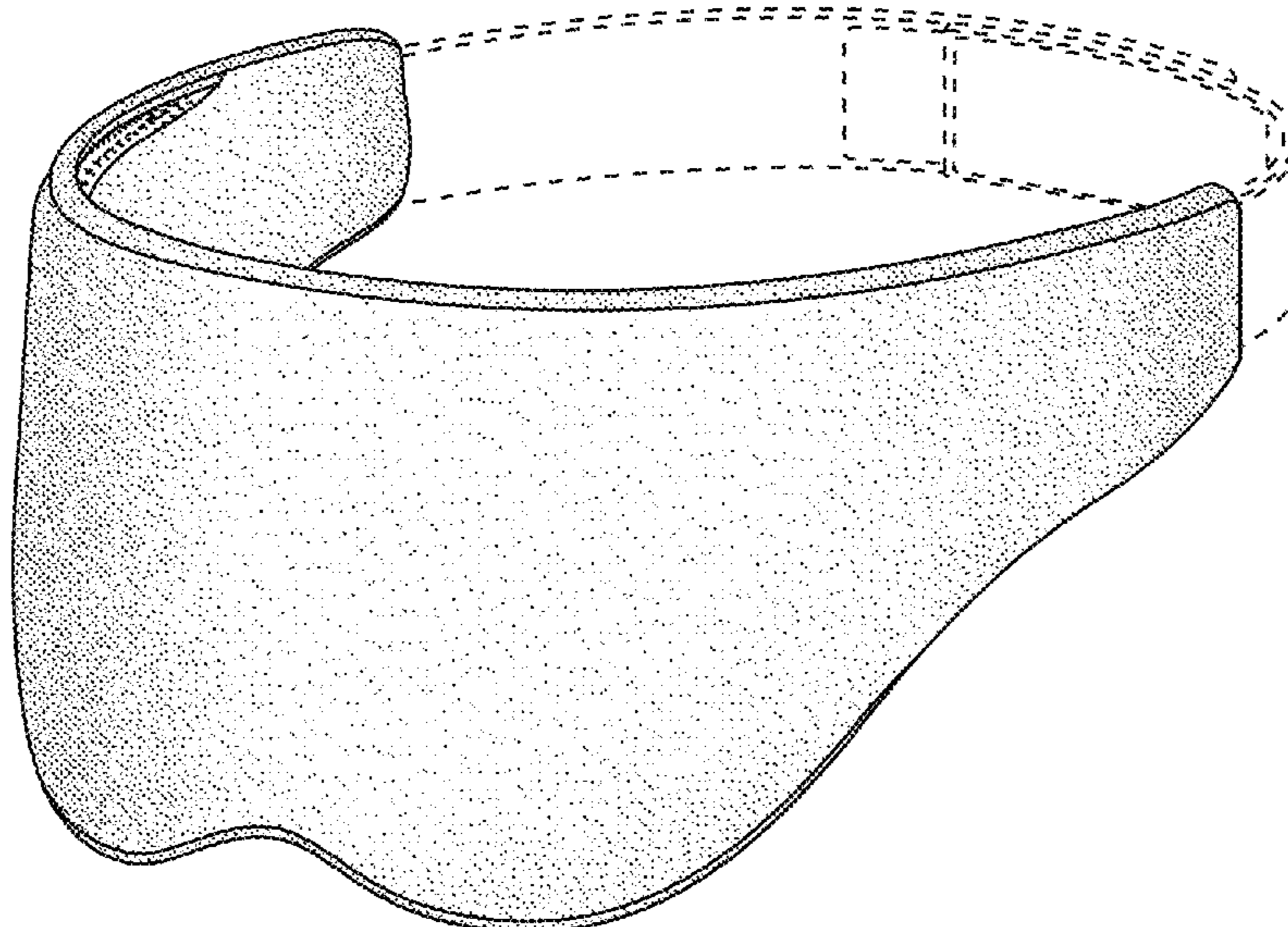
DESCRIPTION

This application incorporates by reference for all purposes the full disclosures of co-pending U.S. patent application Ser. No. 16/290,781, filed concurrently herewith, entitled "Weighted Sleep Mask".

FIG. 1 is a perspective view of a weighted sleep mask; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a left elevational view thereof; FIG. 5 is a right elevational view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; and, FIG. 8 is another perspective view thereof, shown in a position of use.

The dashed broken lines illustrate portions of the weighted sleep mask, the thick closely spaced broken lines showing a zipper illustrate portions of the weighted sleep mask, and the broken lines showing of a human figure in FIG. 8 illustrate the environment. None of these broken lines described form any part of the claimed design.

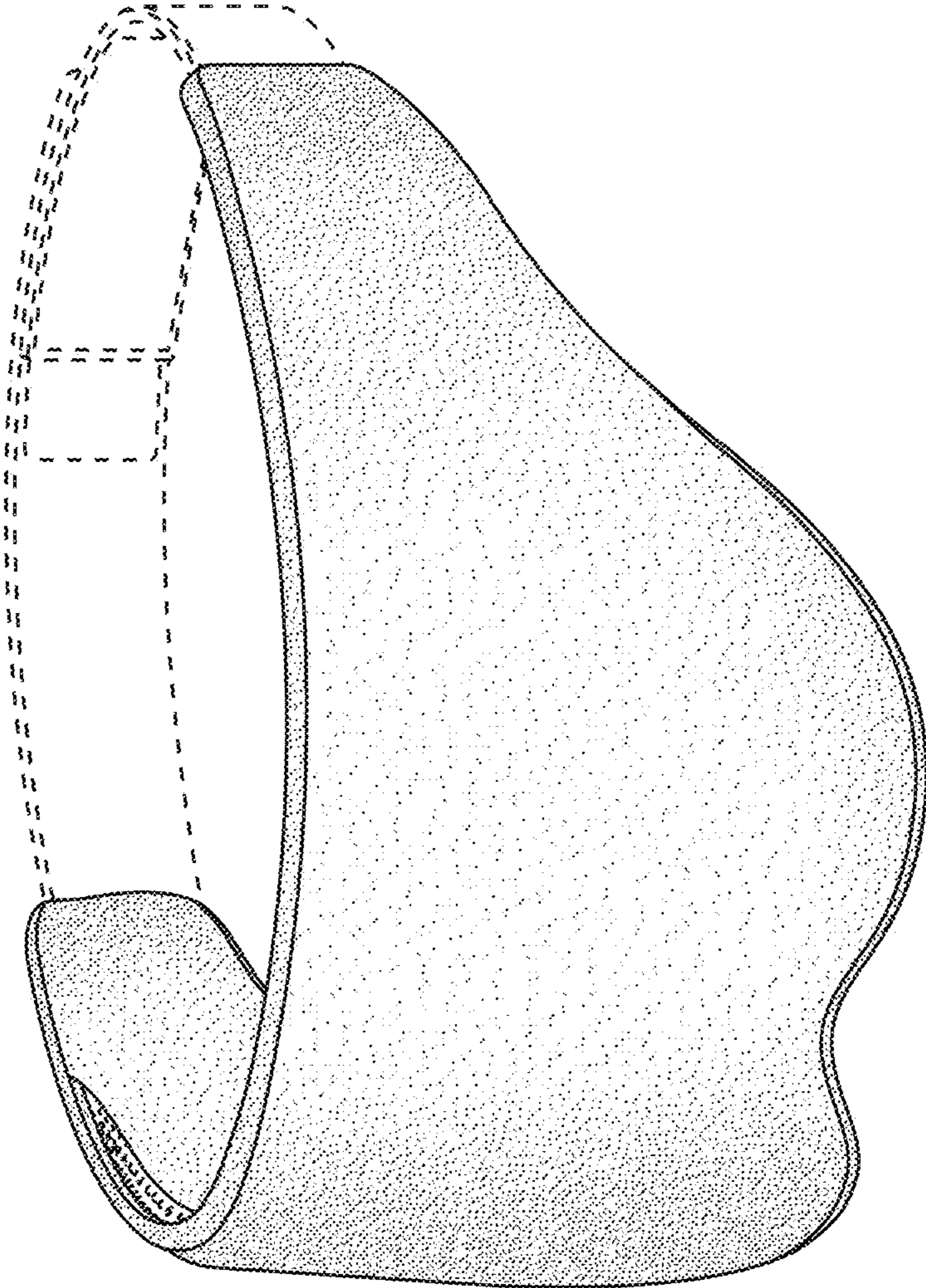

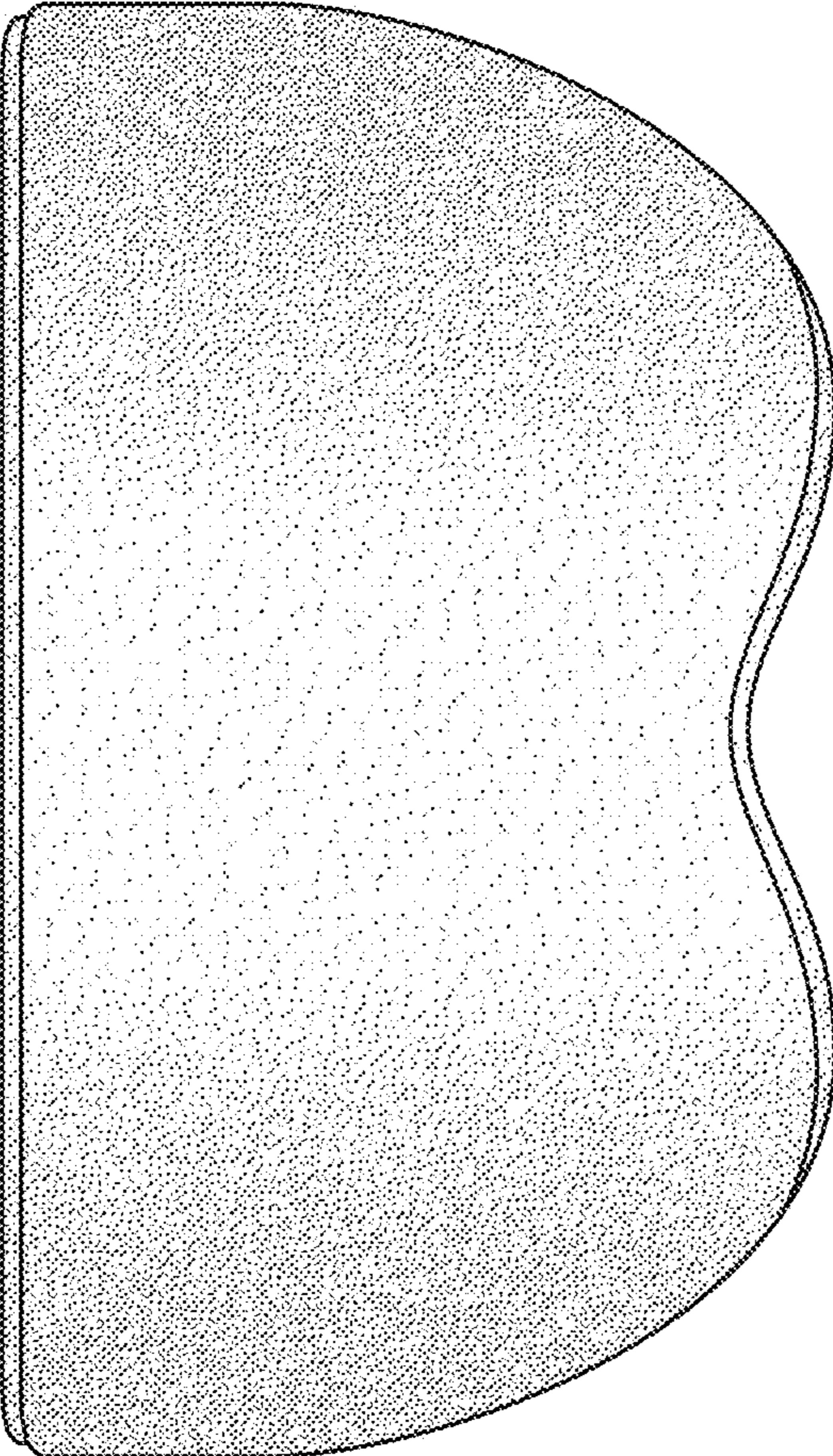

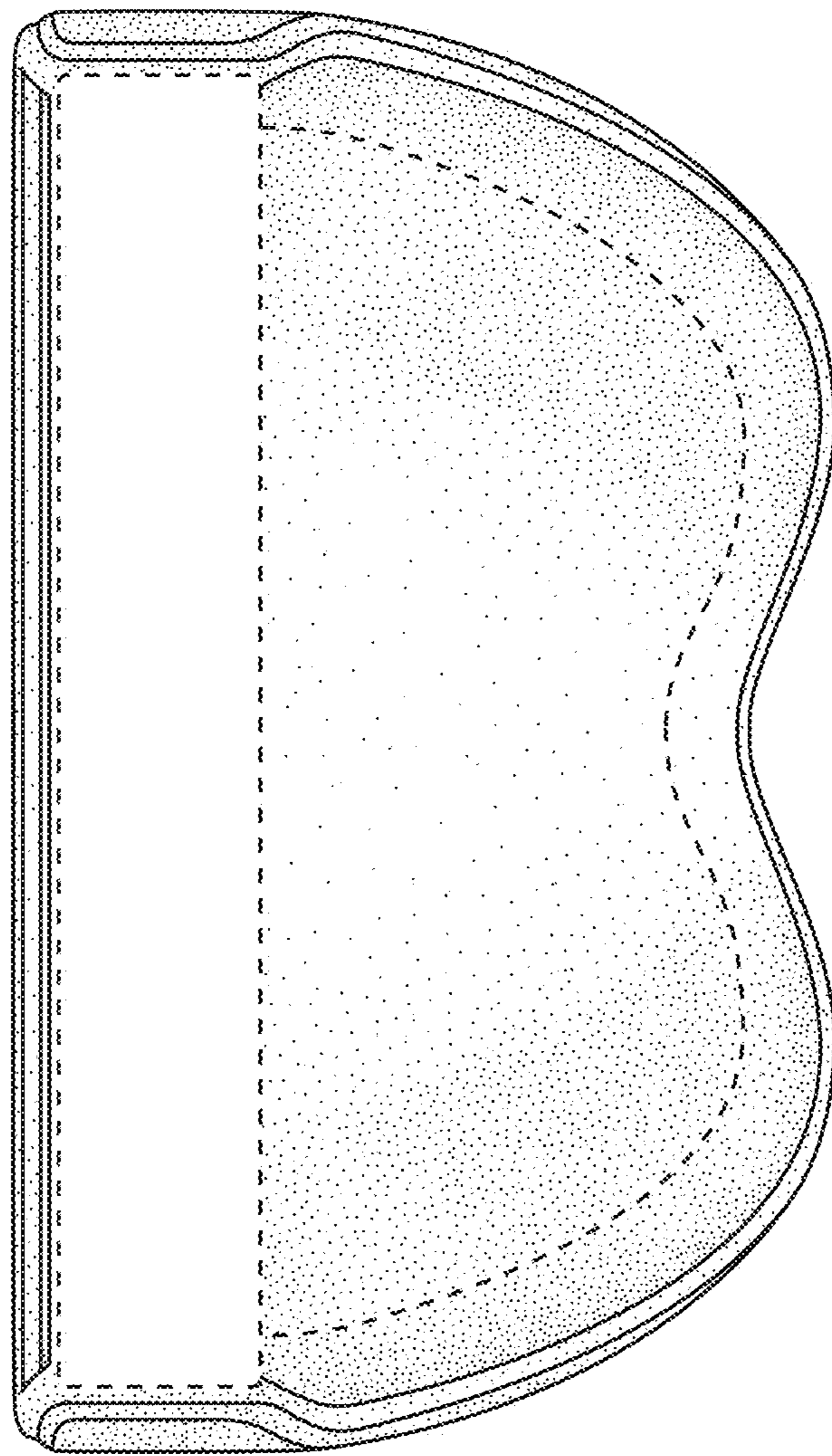

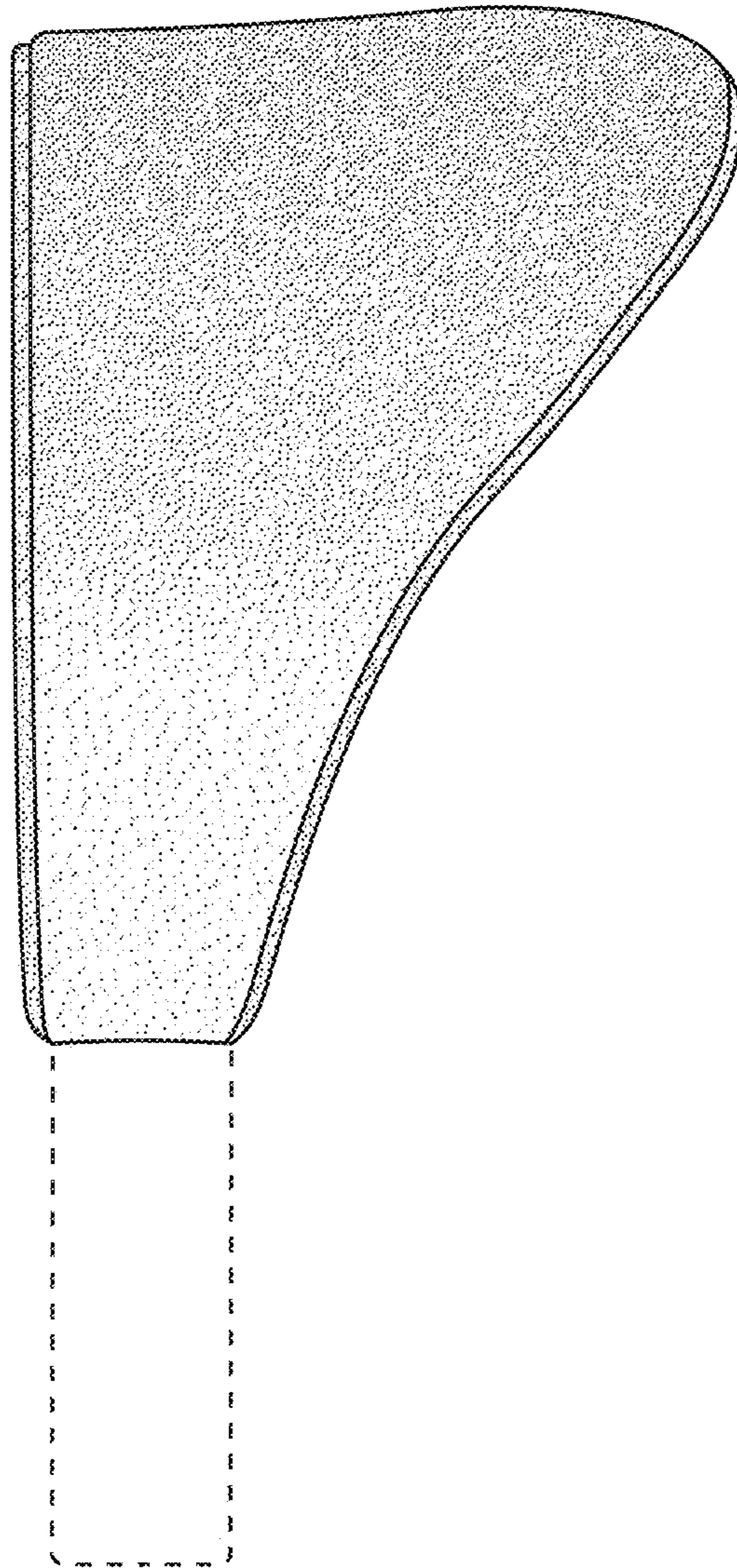

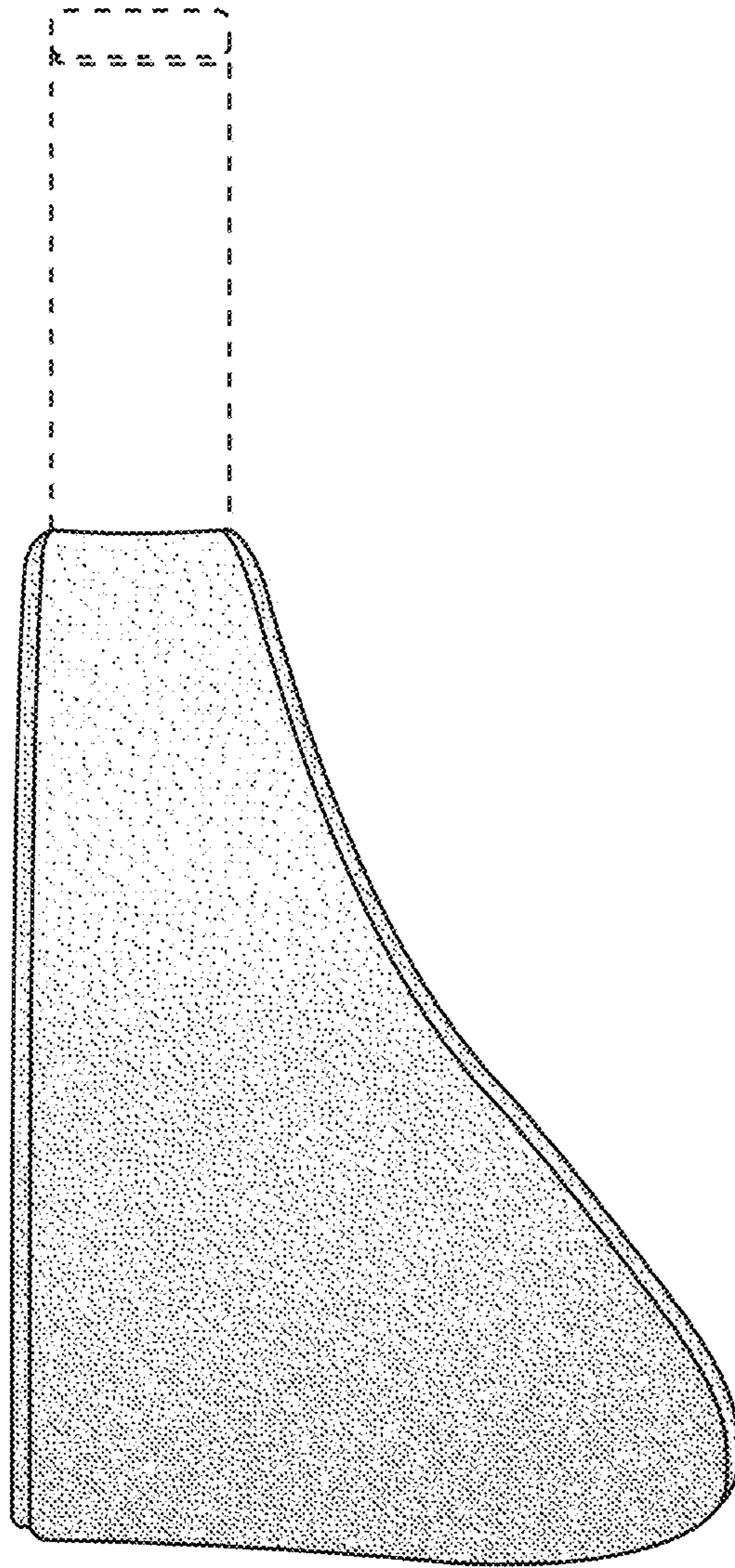

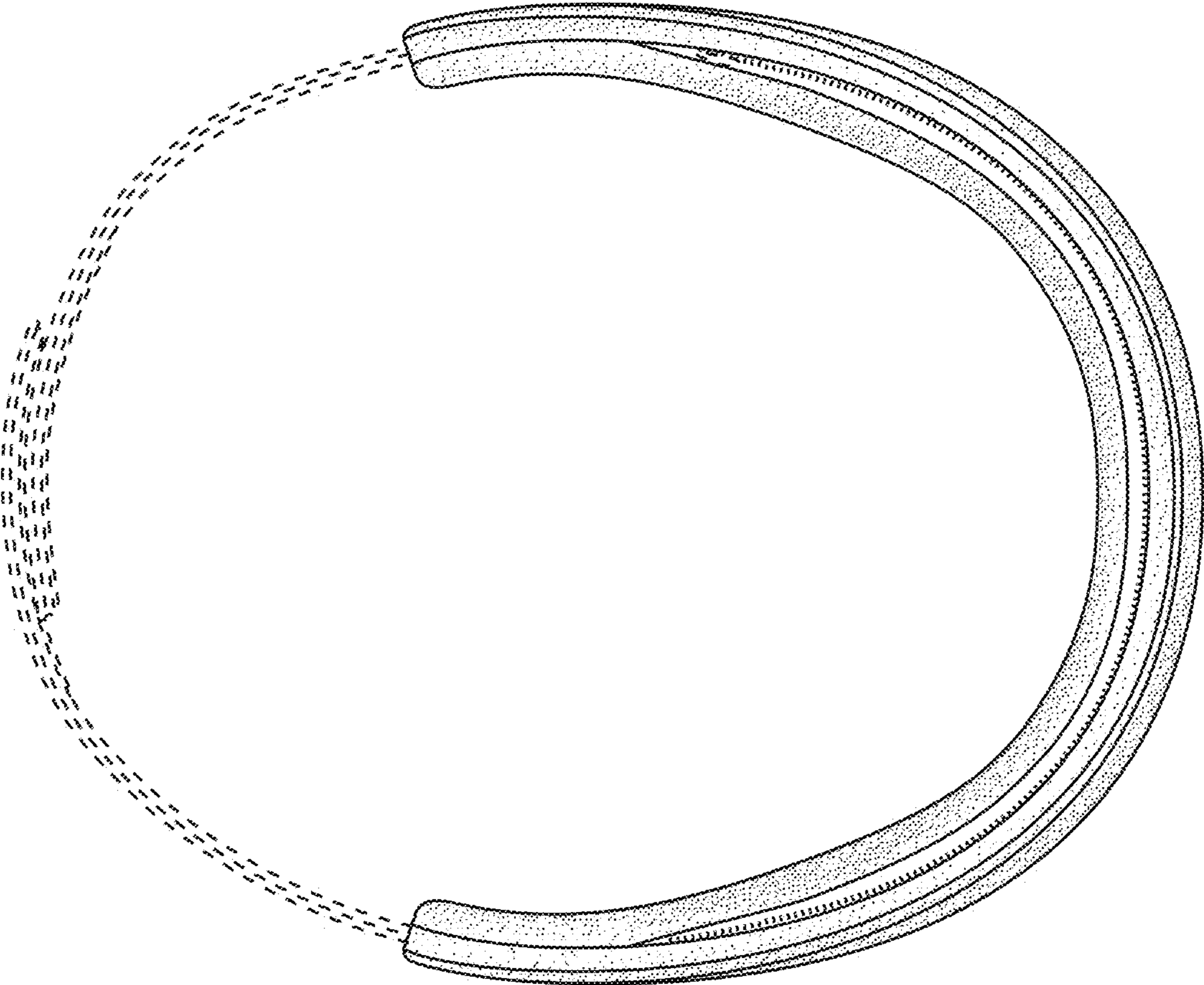

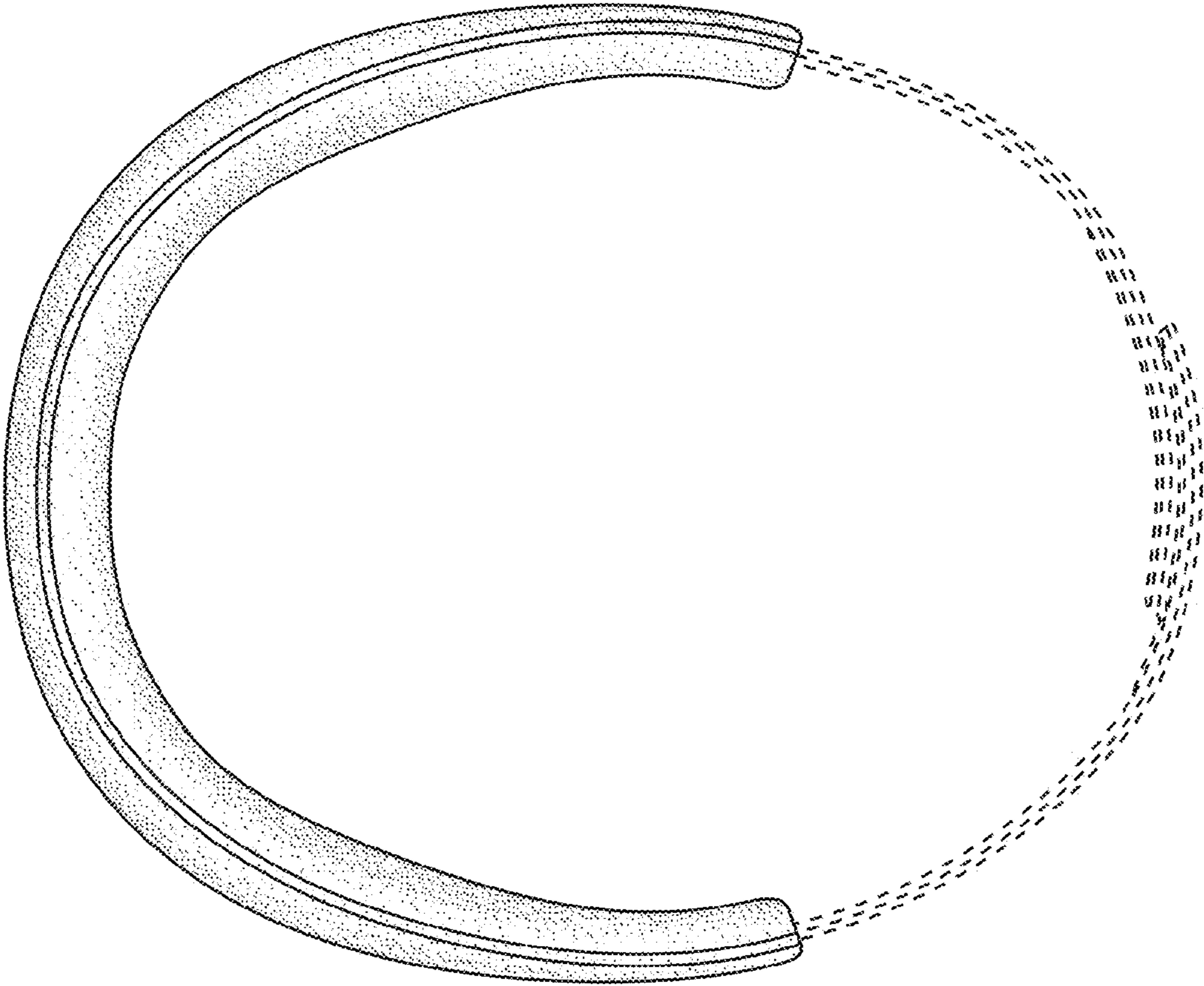

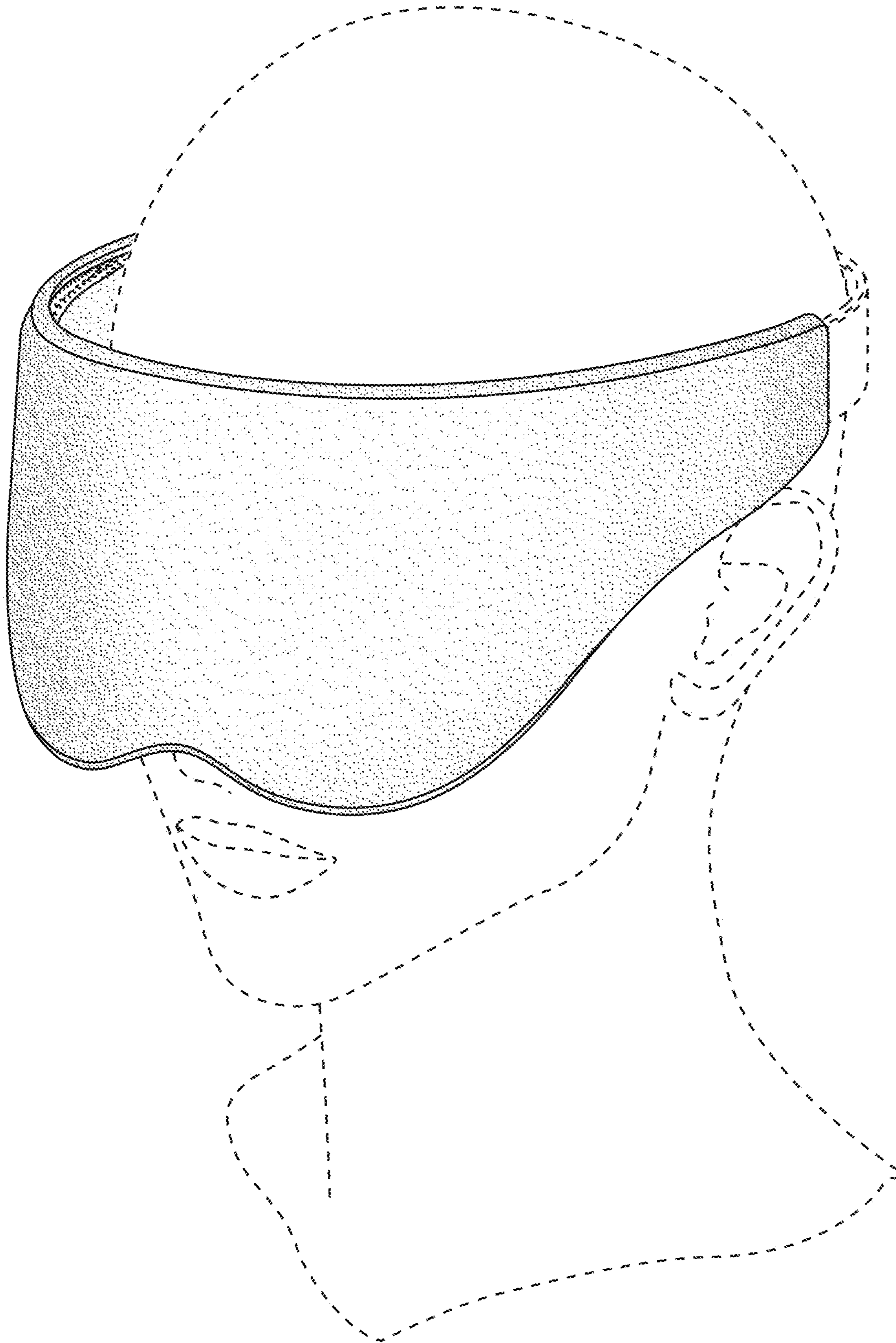
