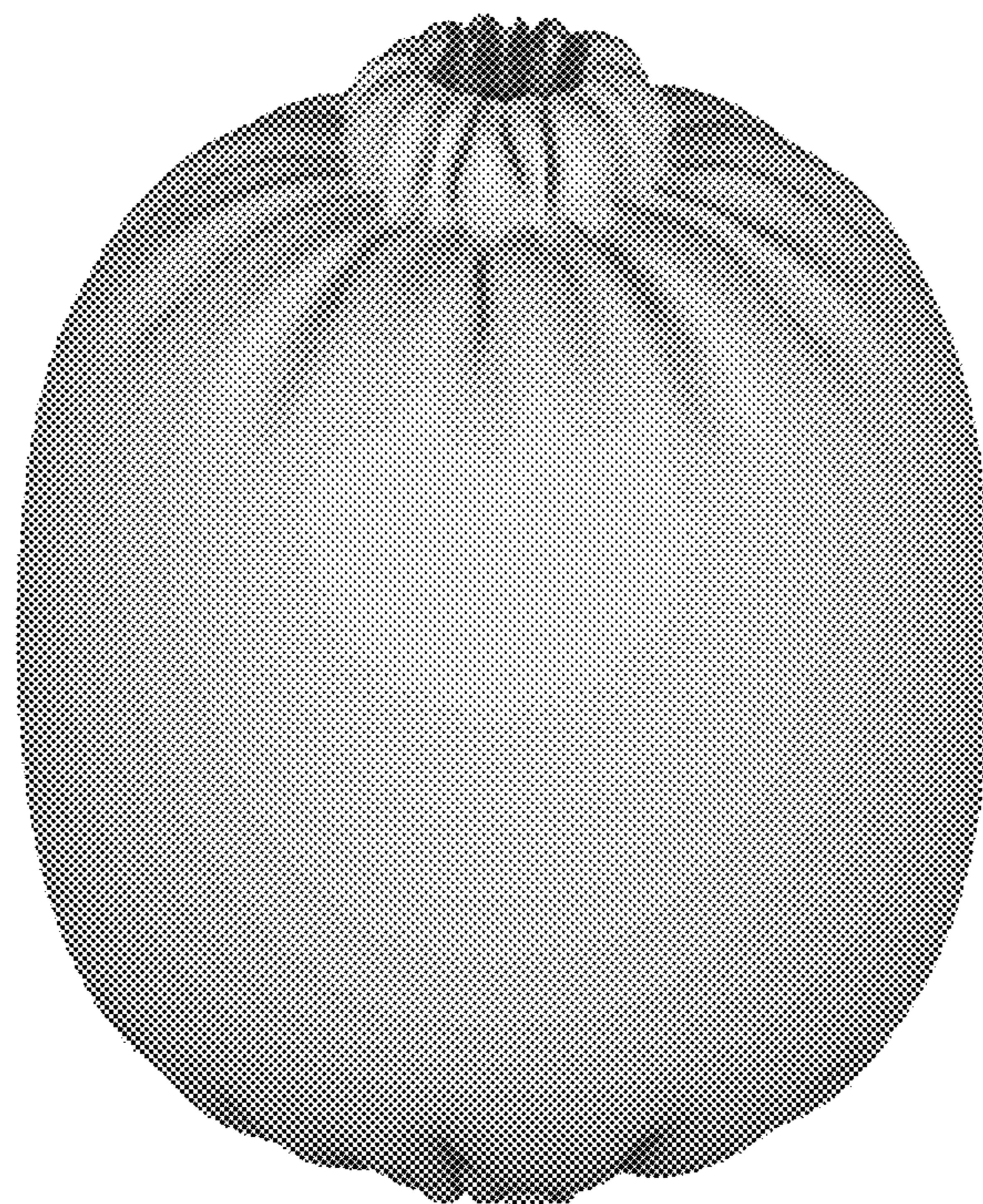
FIG. 1 is a perspective view of a hydrant drain bag;

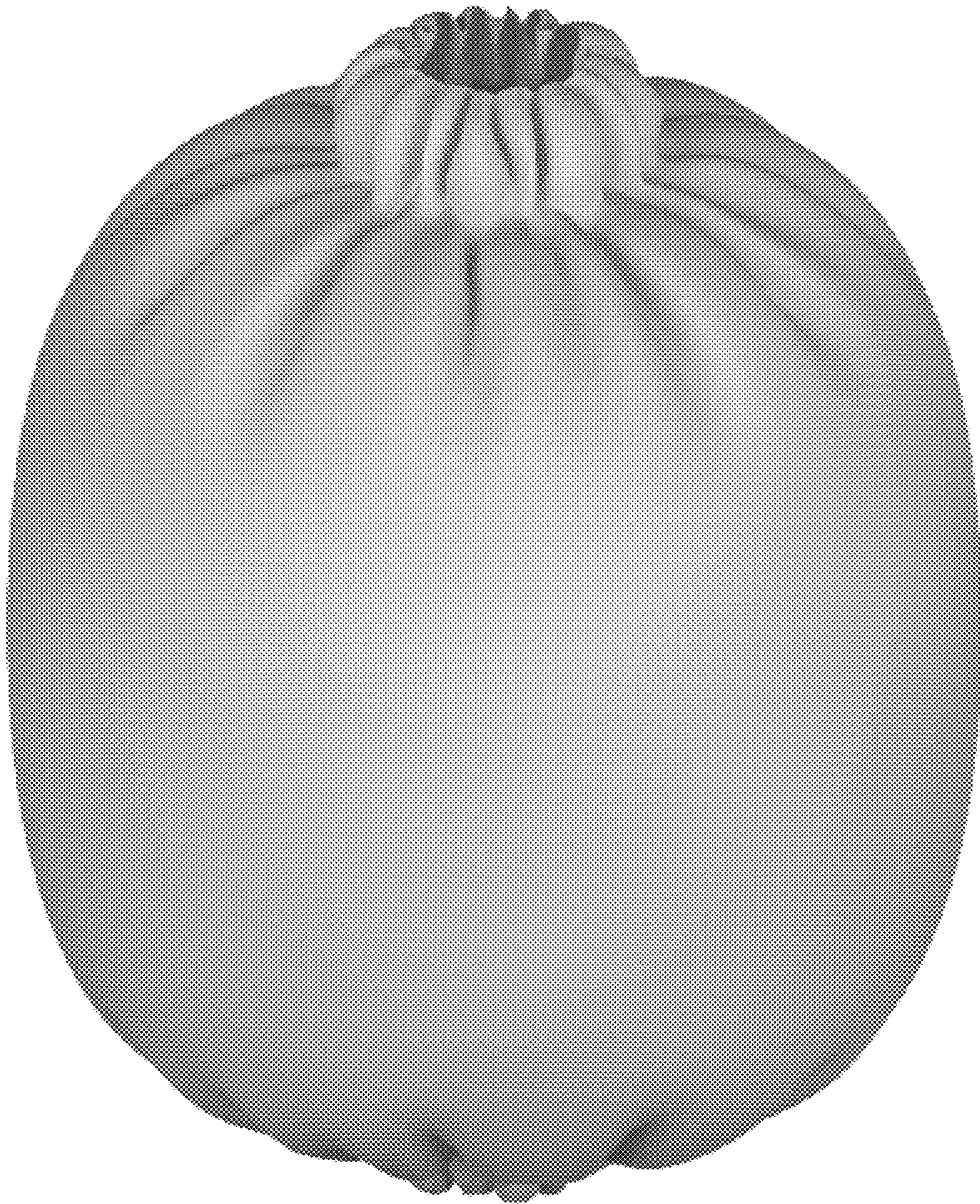

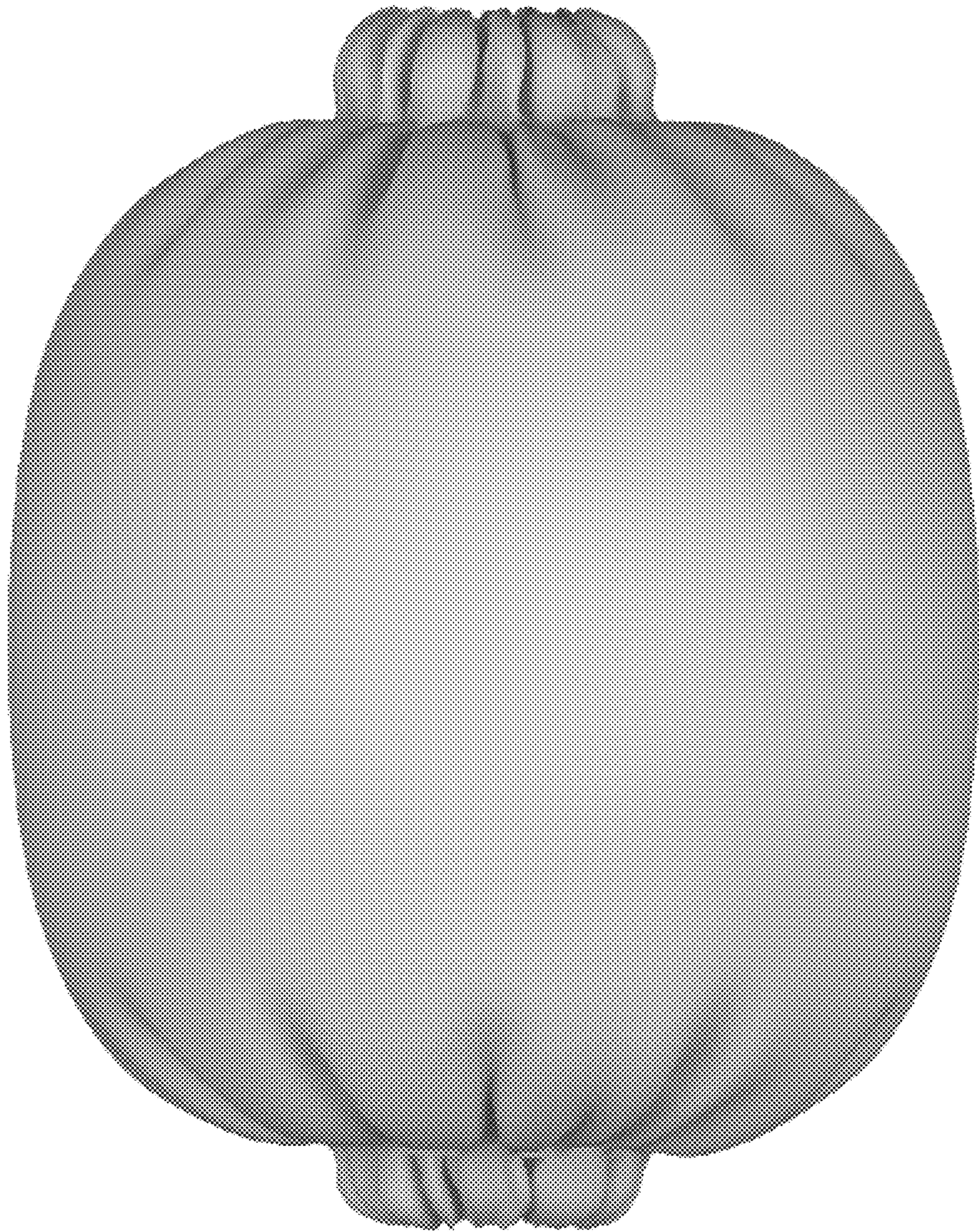

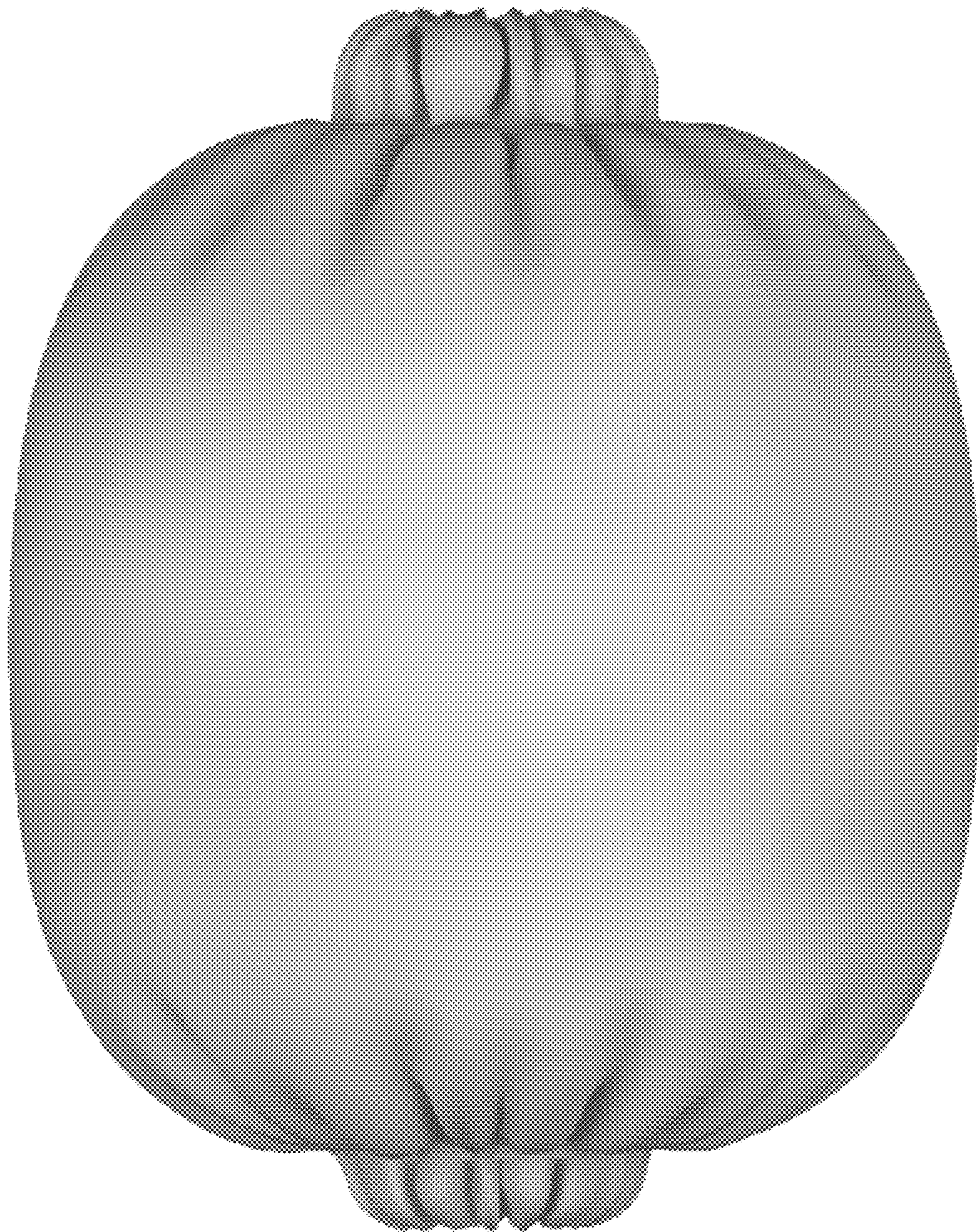

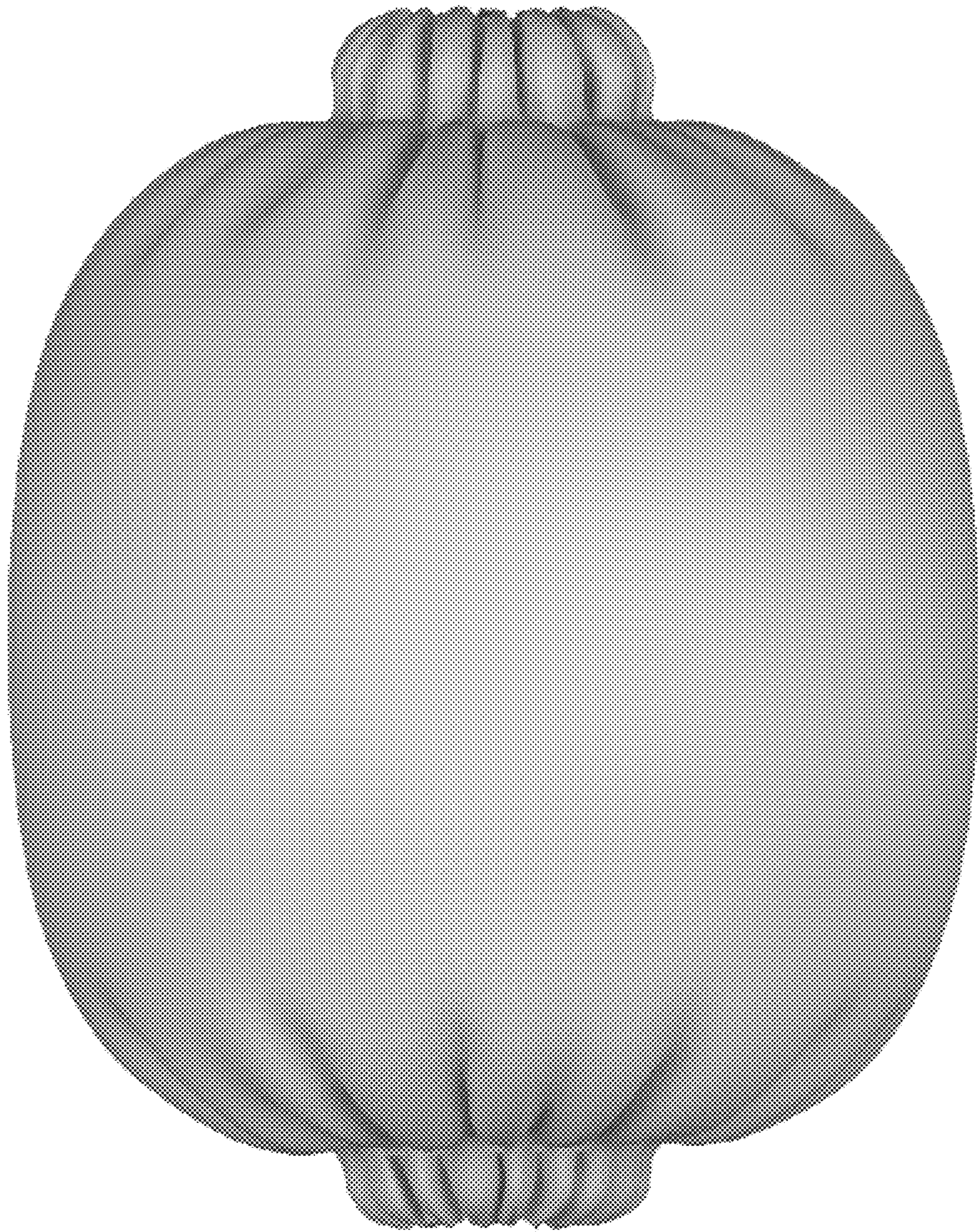

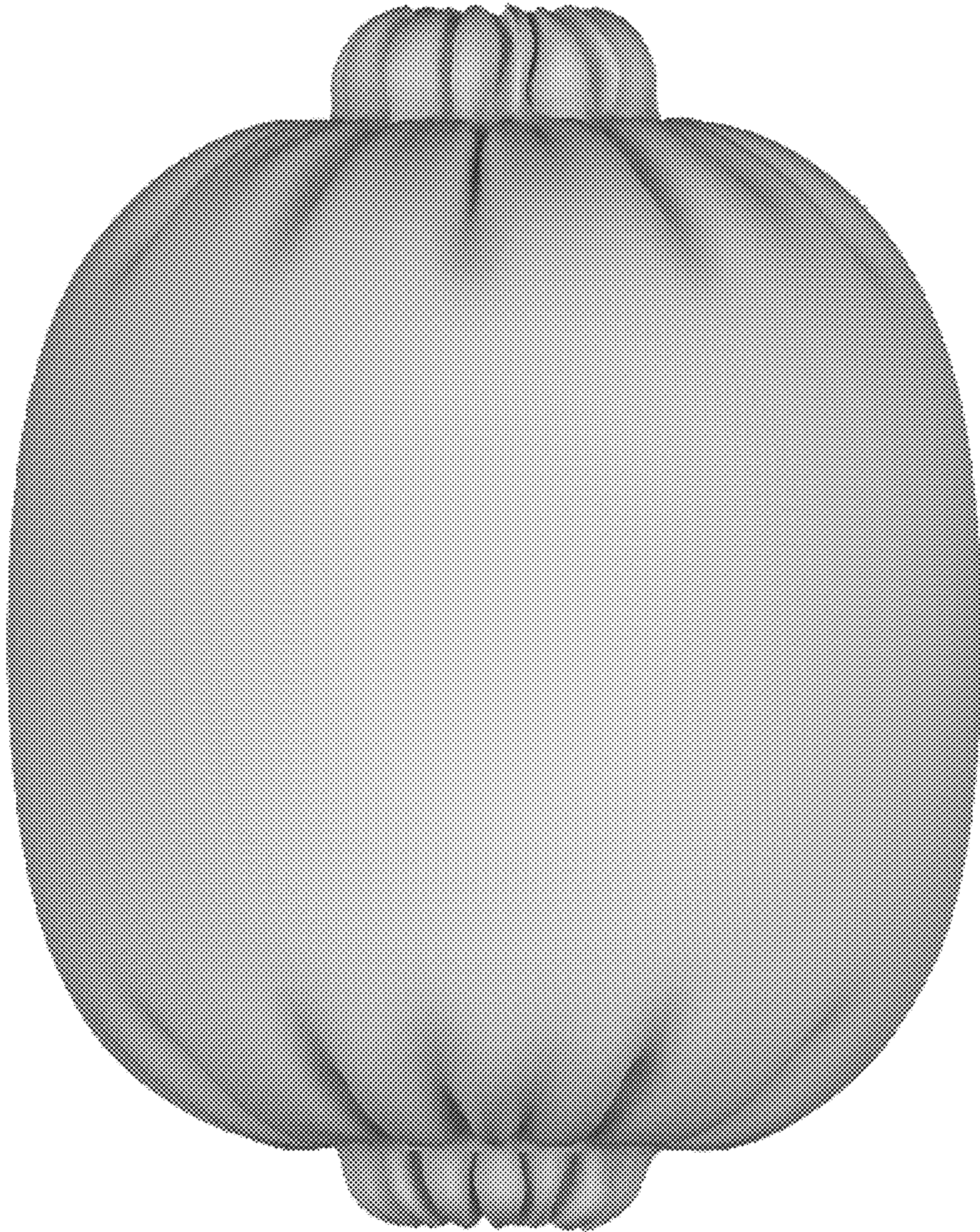

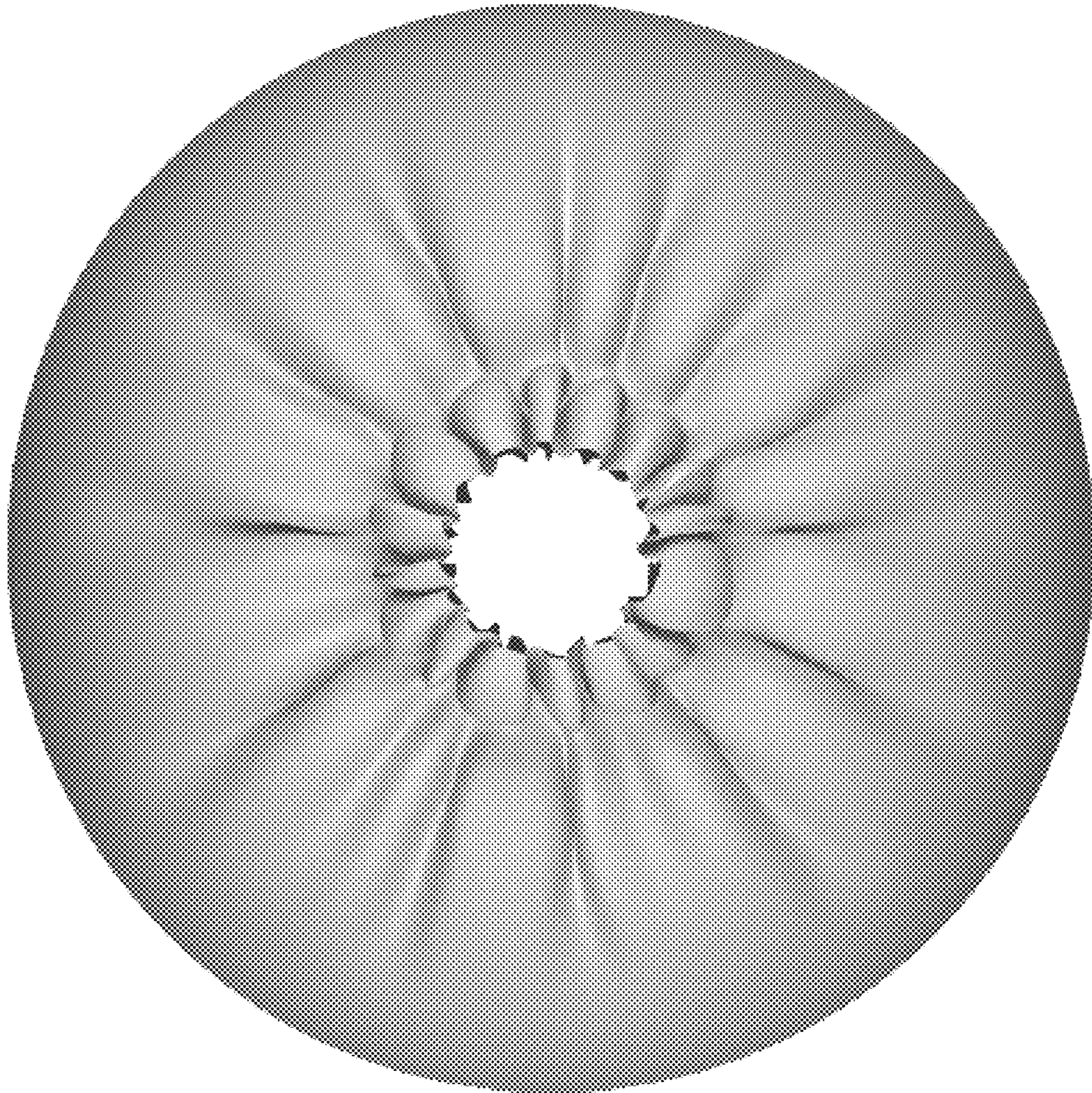

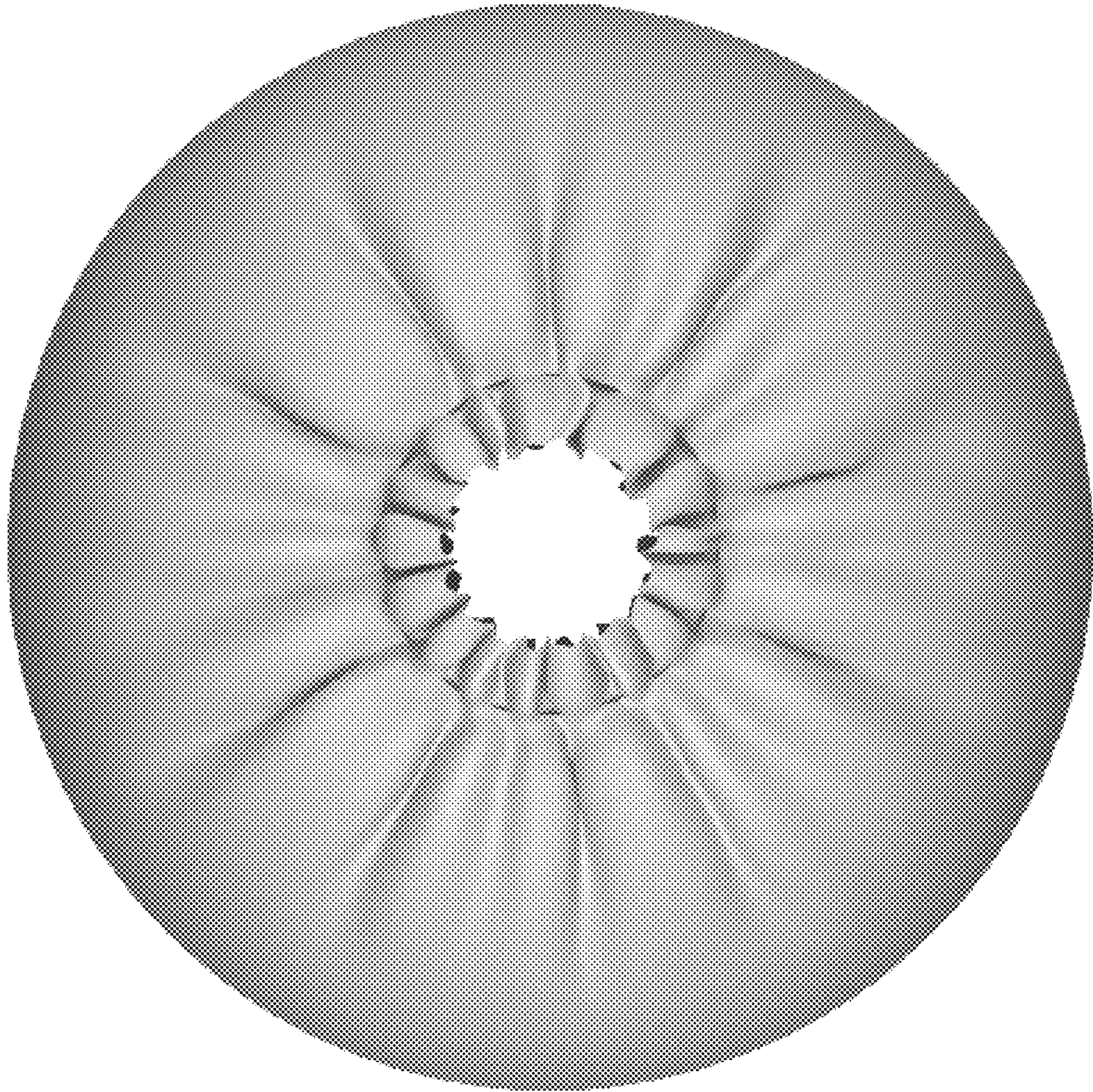

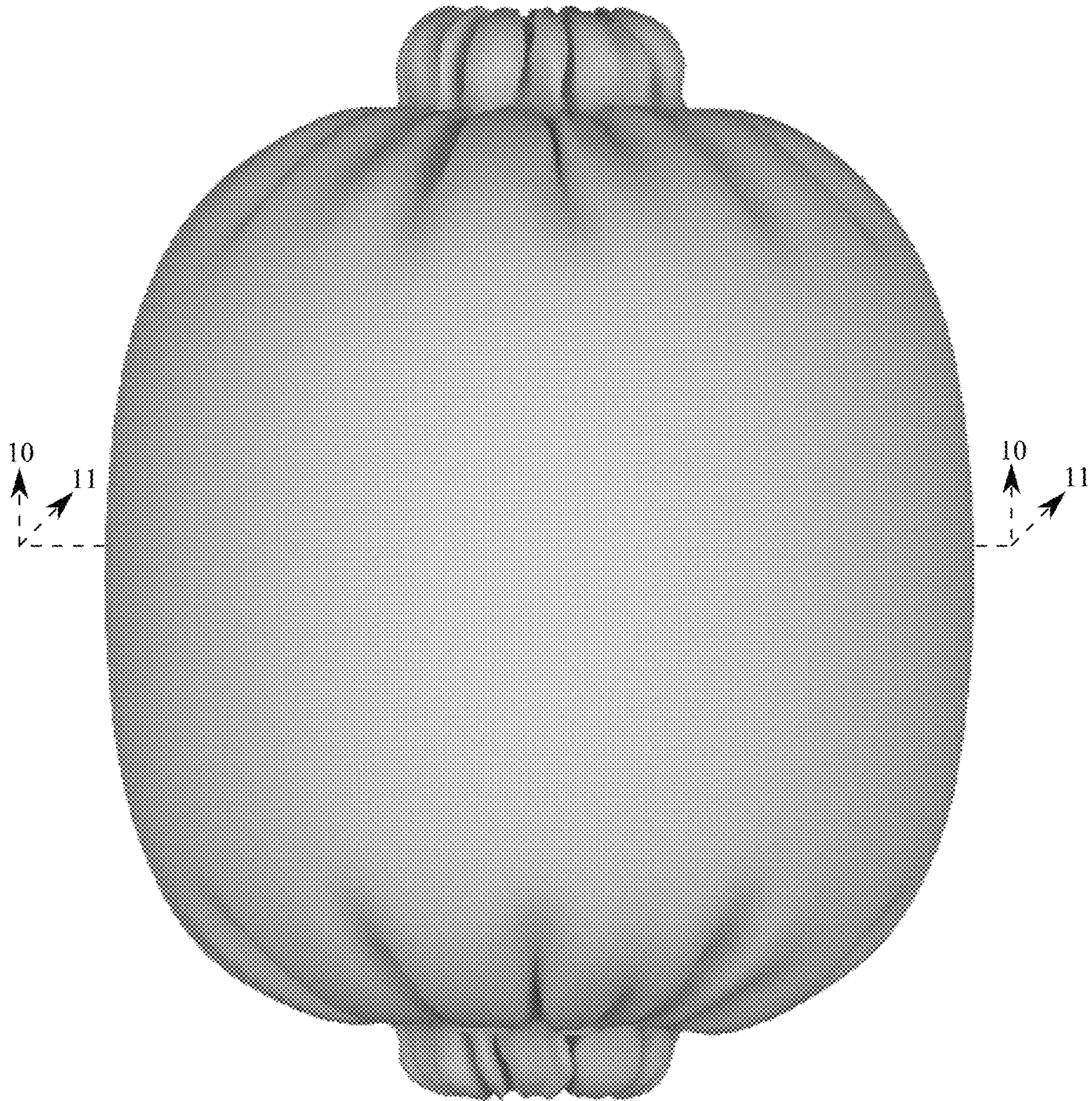

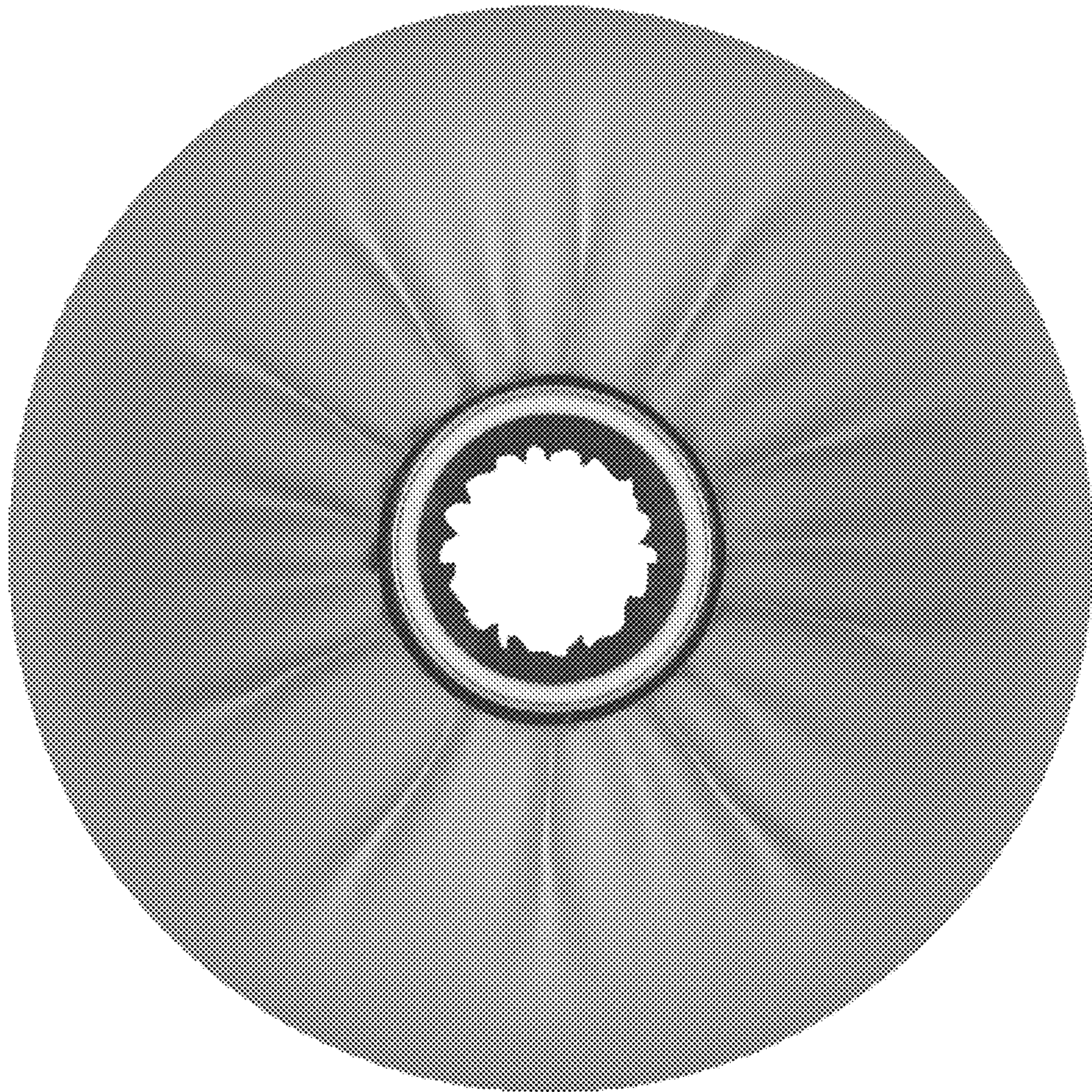

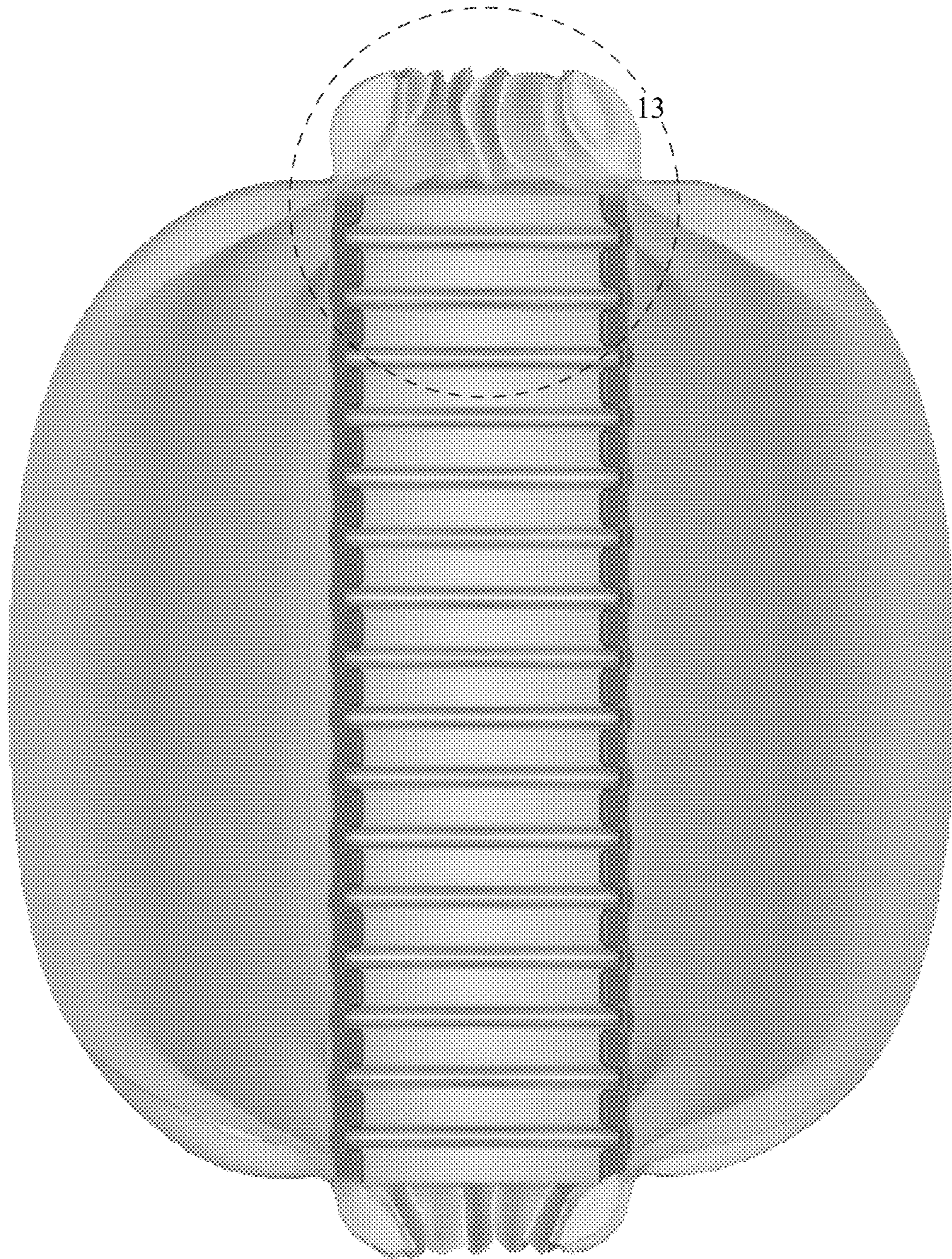

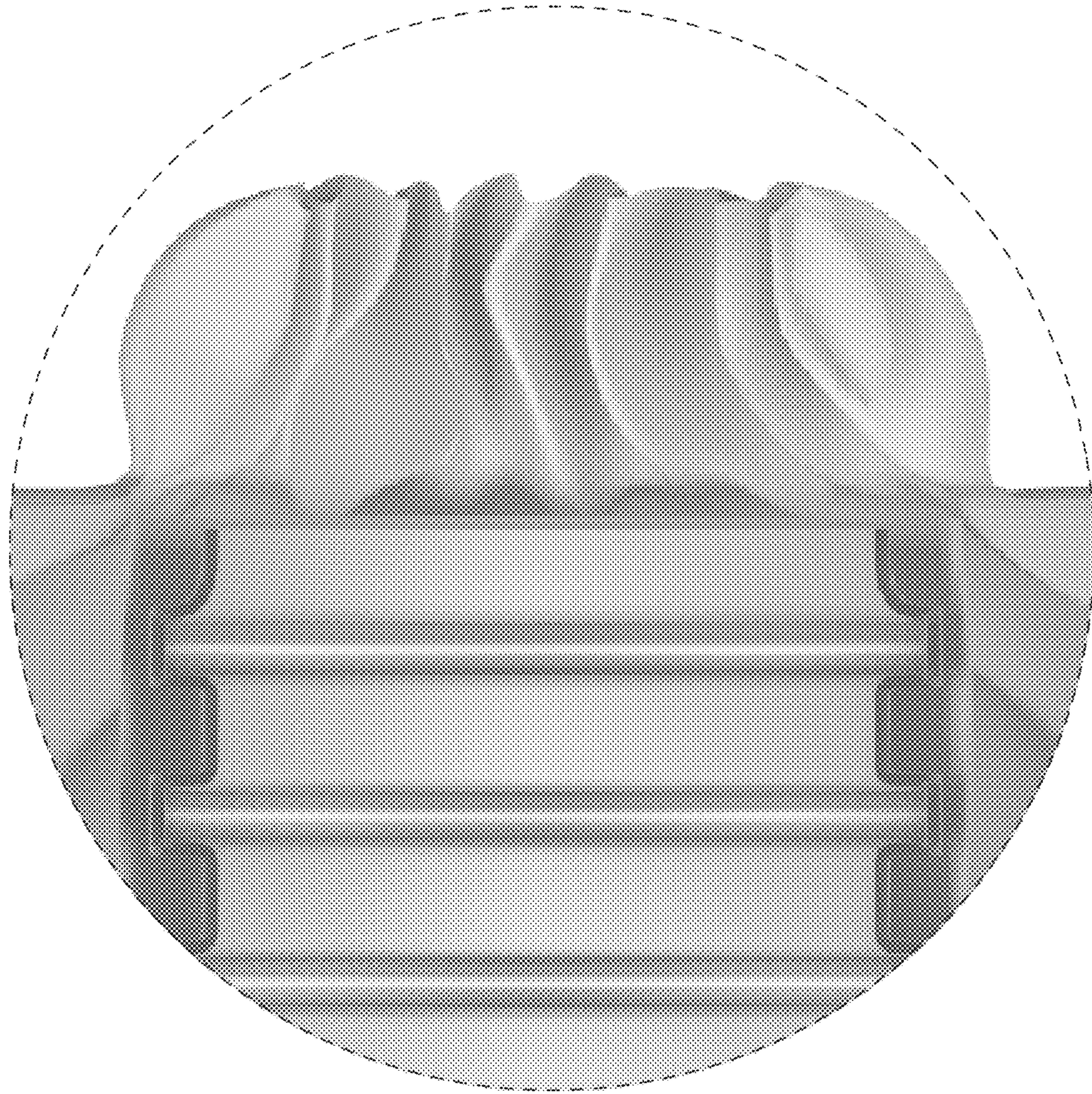
