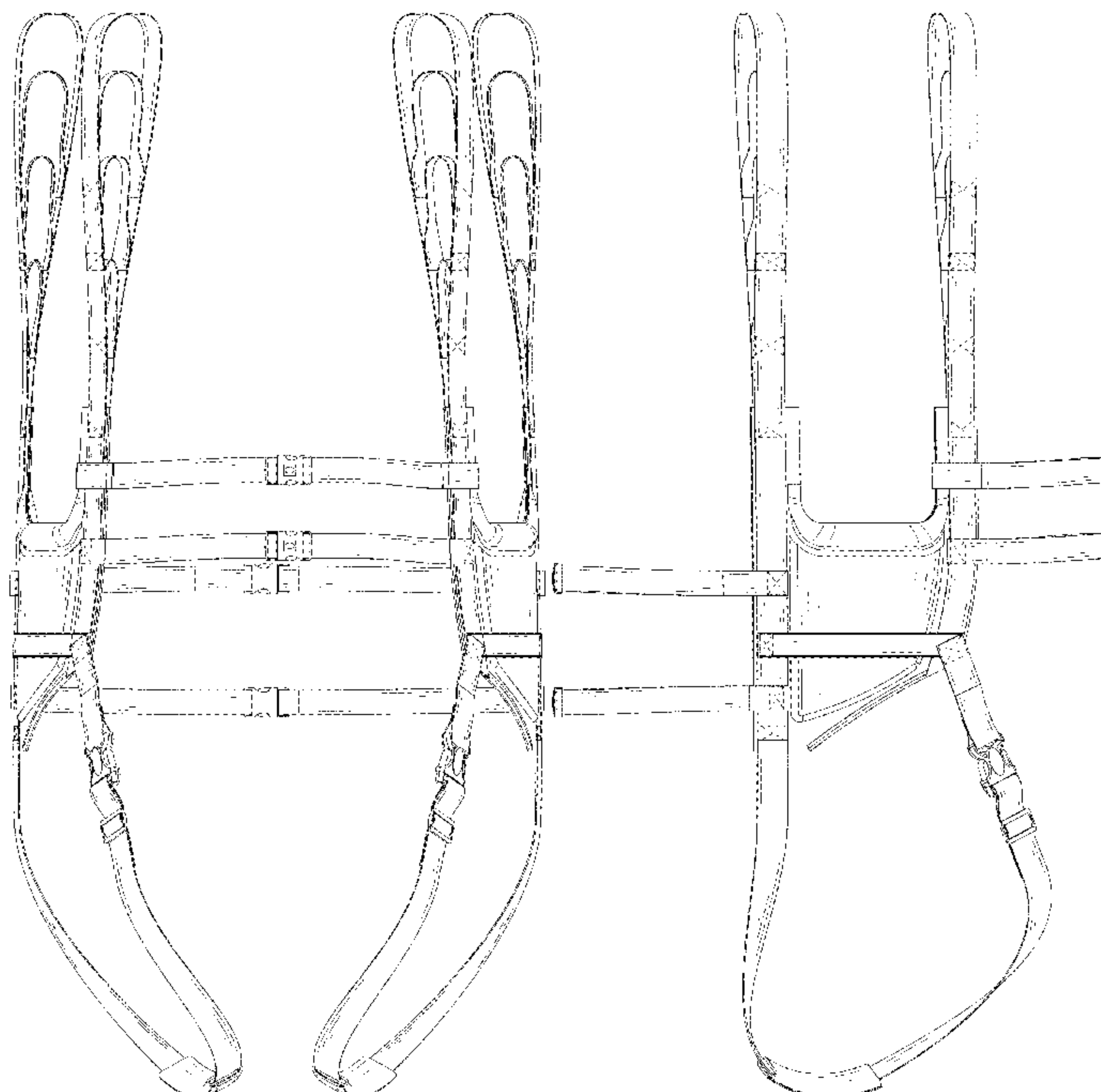
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a lifting sling showing my new design;
FIG. 2 is another perspective view thereof;

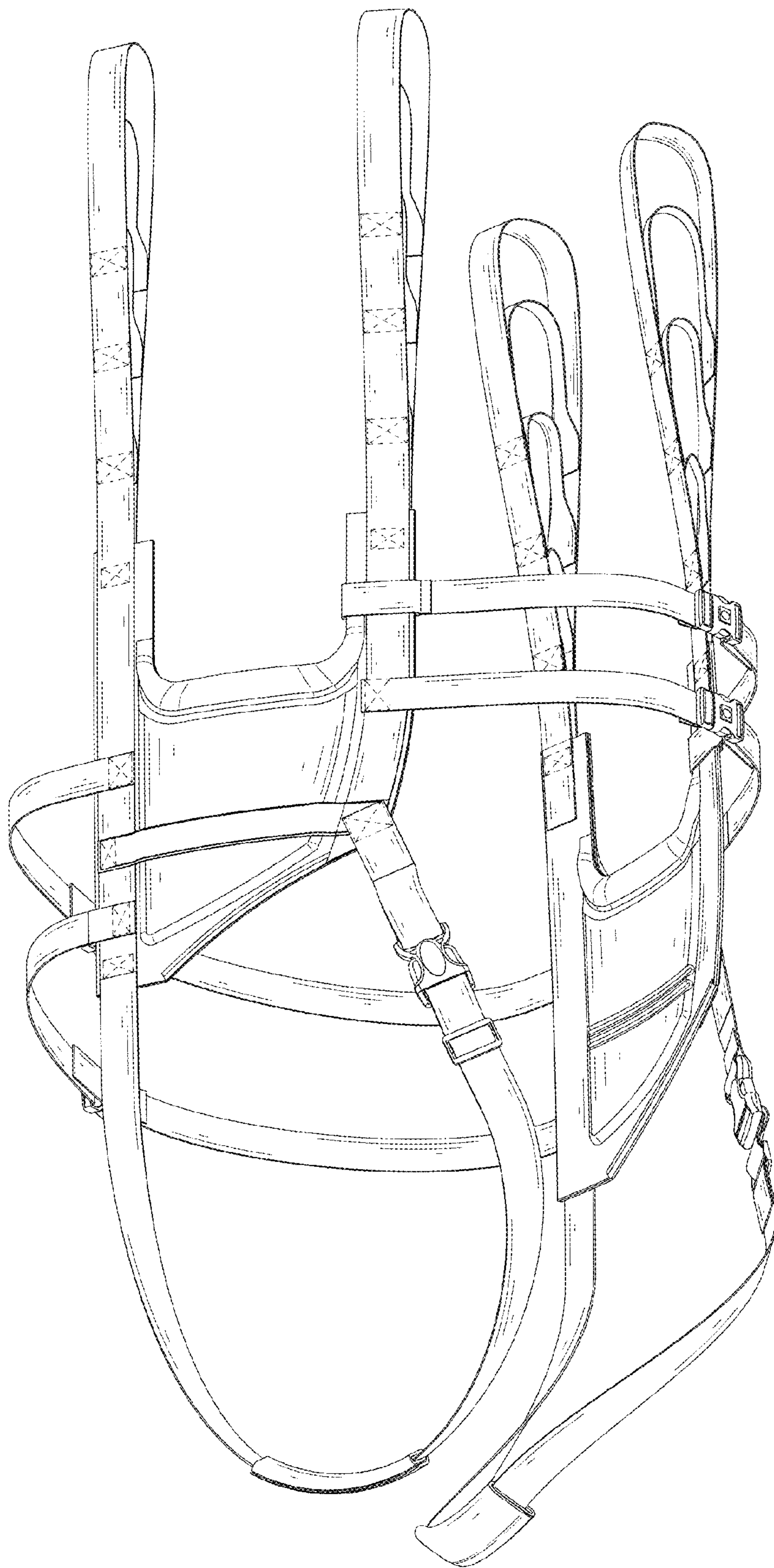

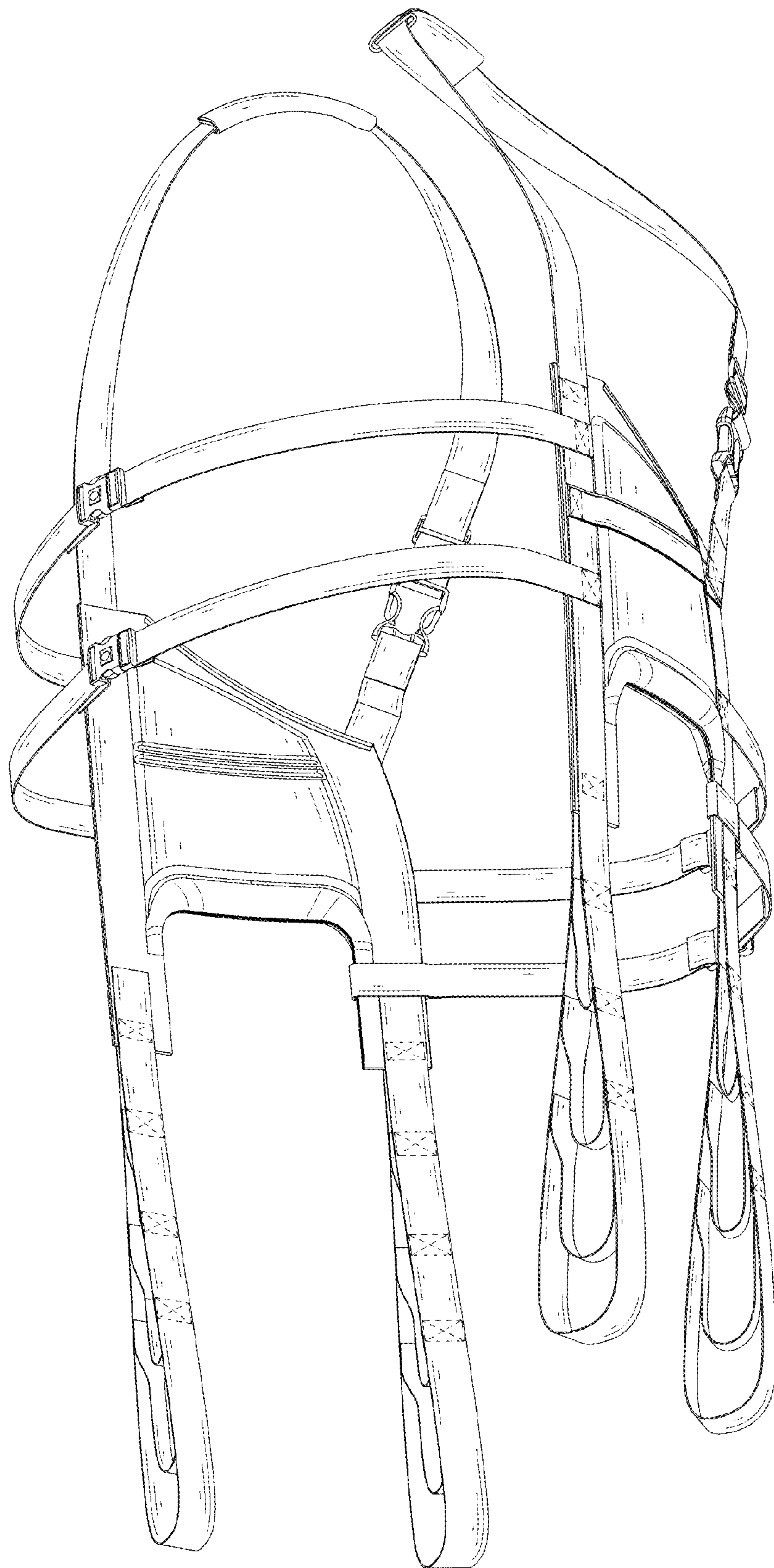

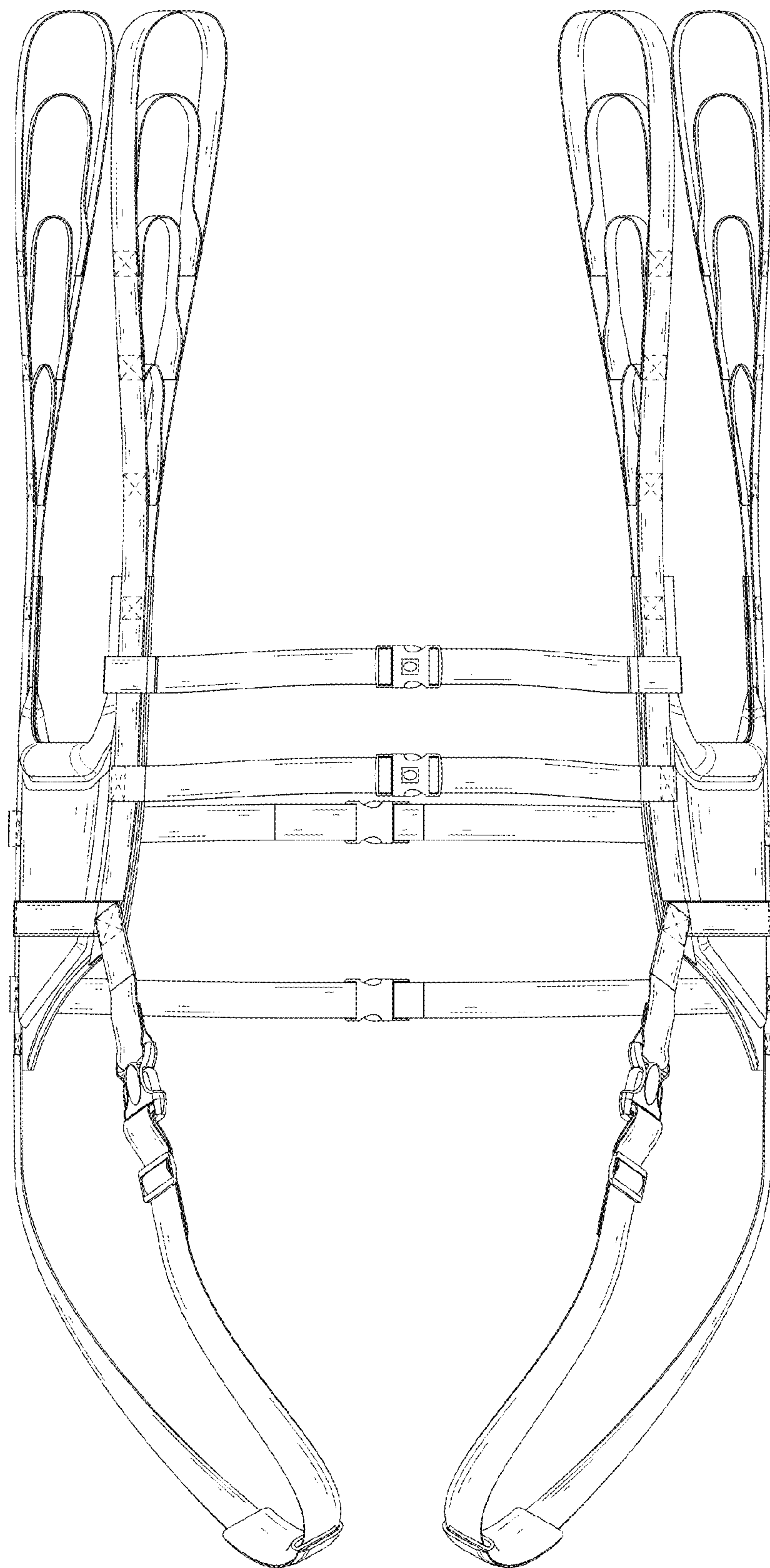

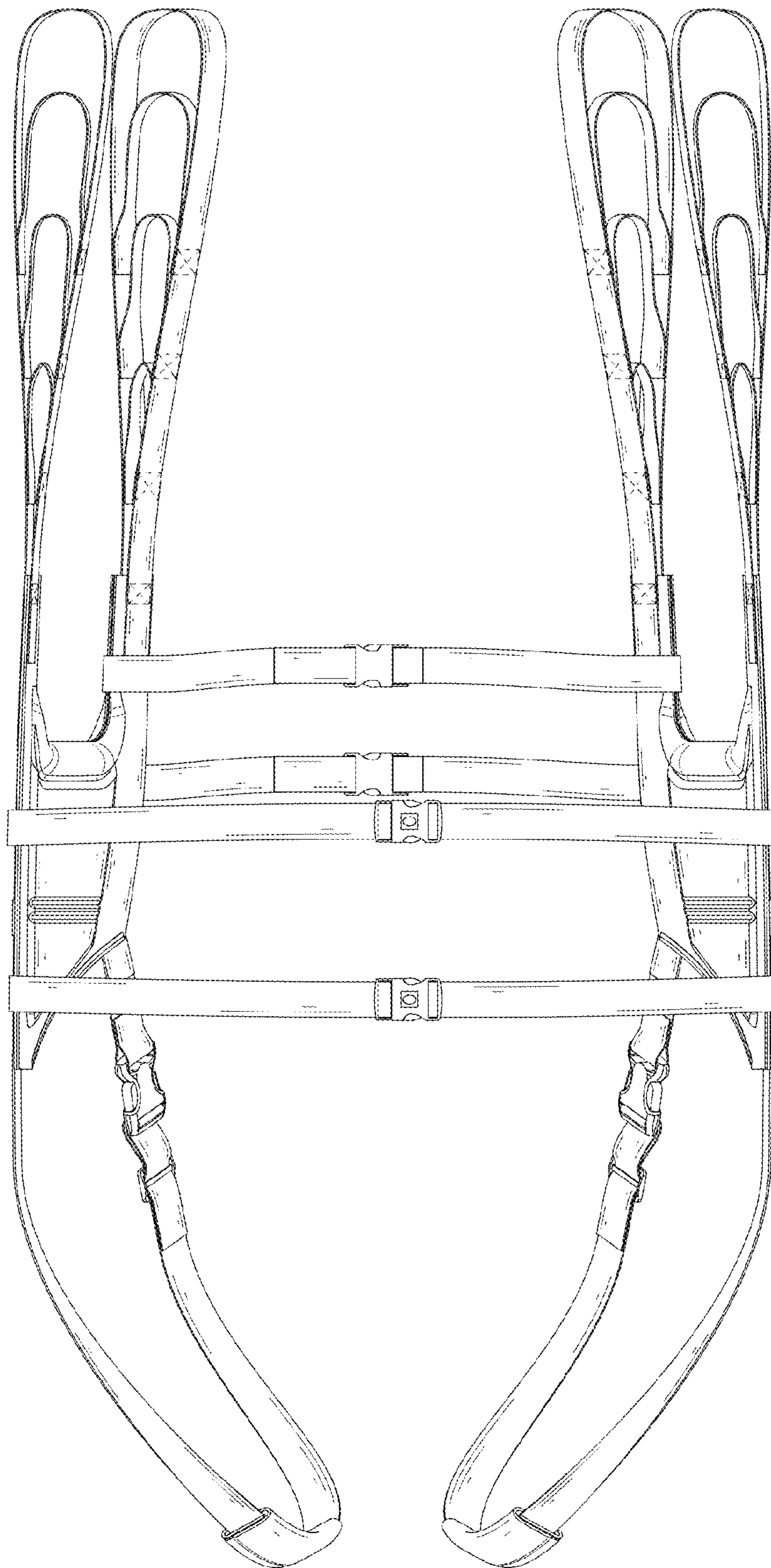

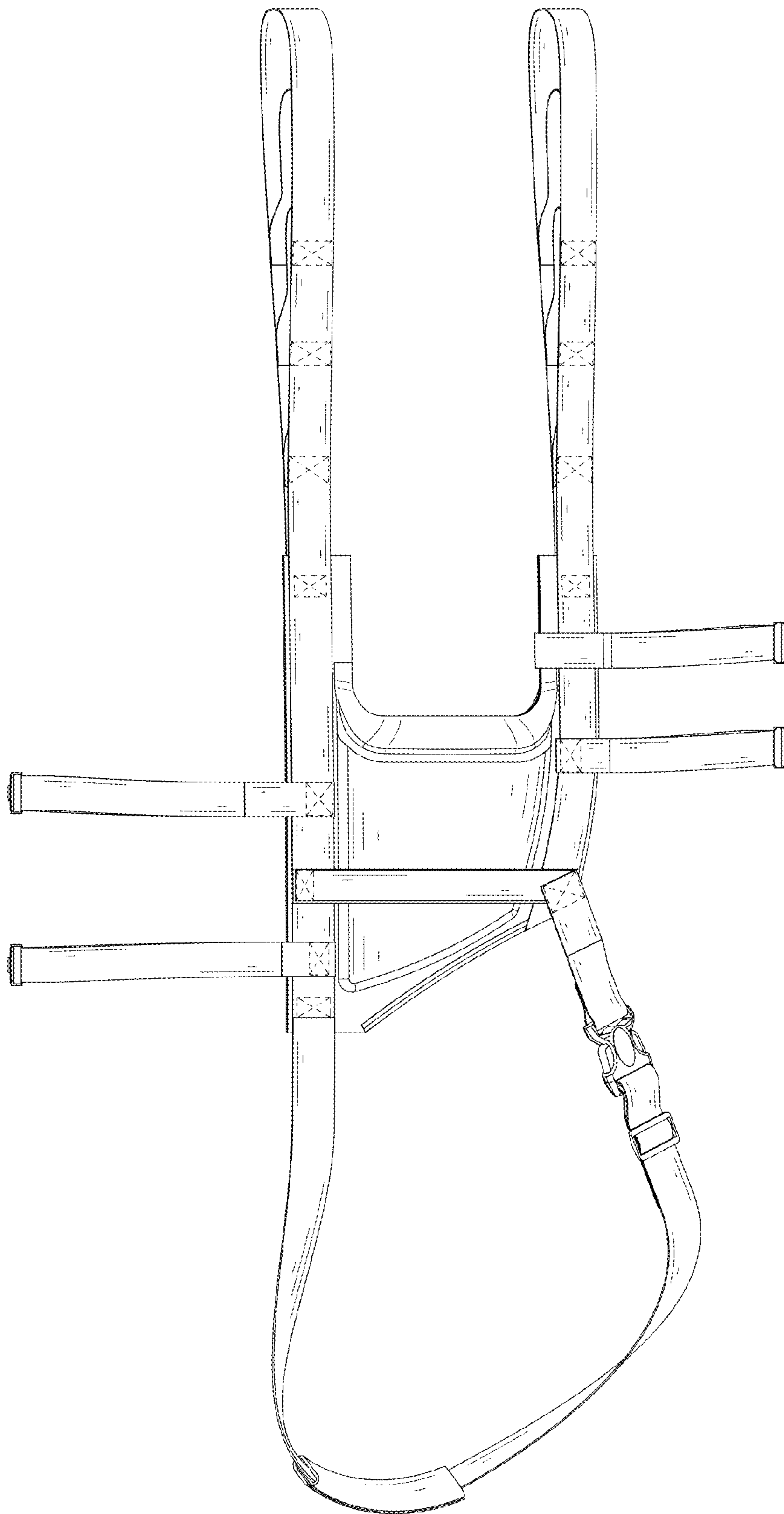

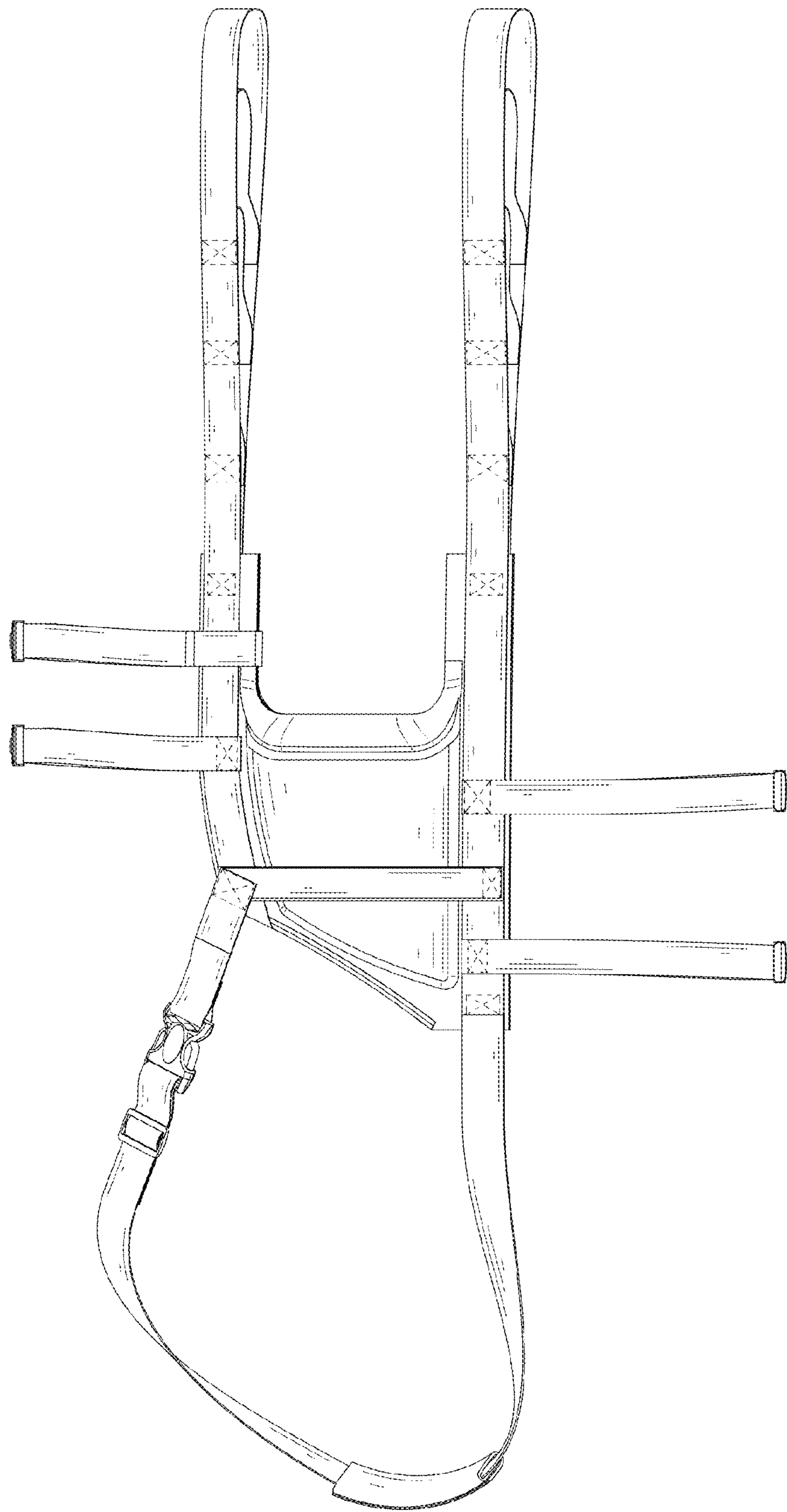

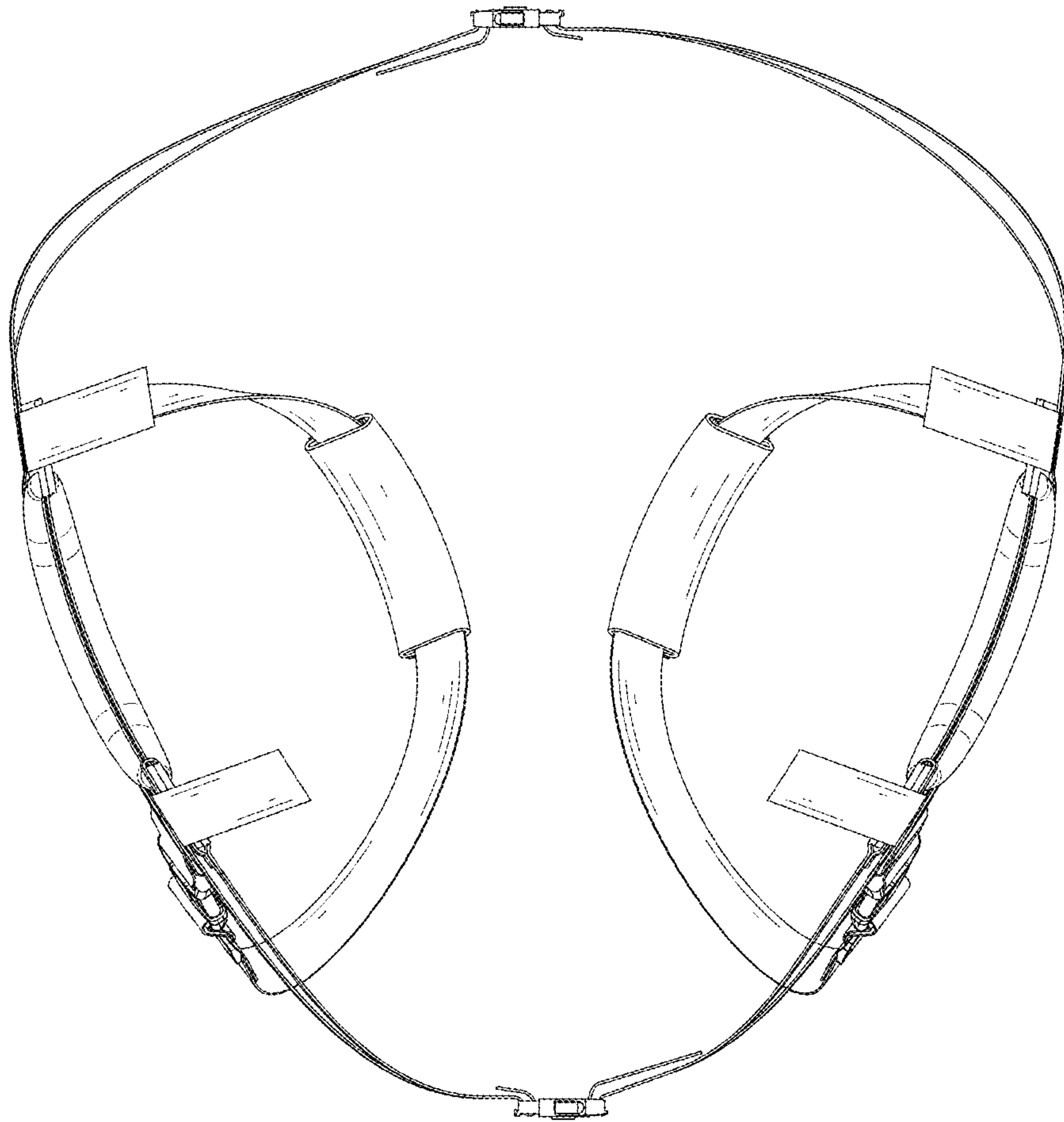

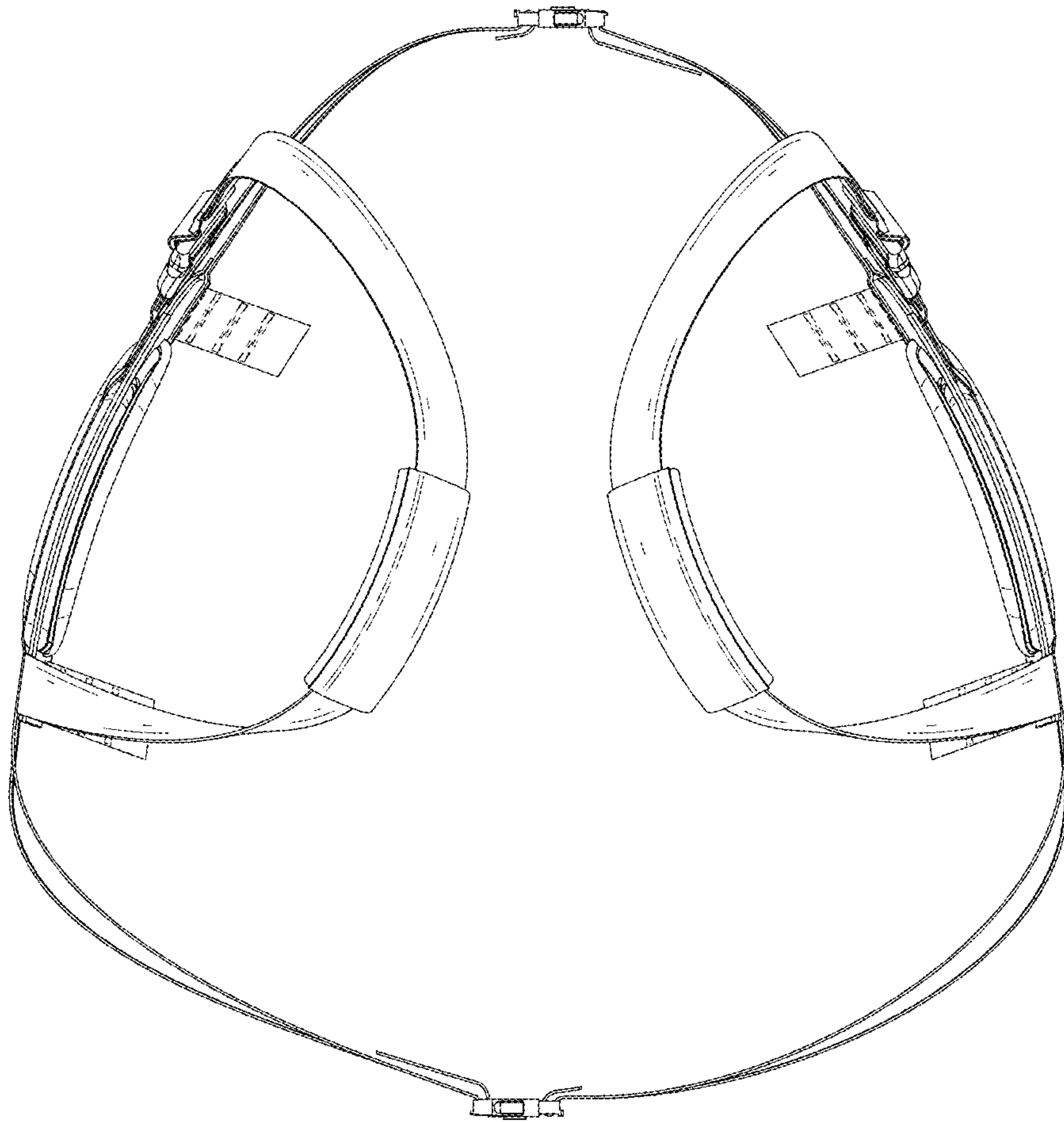
