(57) **CLAIM**

The ornamental design for a retail fixture, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of the retail fixture in accordance with a first embodiment of the invention.

FIG. 2 is a rear elevational view of the retail fixture in accordance with the first embodiment of the invention.

FIG. 3 is a top plan view of the retail fixture in accordance with the first embodiment of the invention.

FIG. 4 is a bottom plan view of the retail fixture in accordance with the first embodiment of the invention.

FIG. 5 is a first side elevational view of the retail fixture in accordance with the first embodiment of the invention.

FIG. 6 is a second side elevational view of the retail fixture in accordance with the first embodiment of the invention.

FIG. 8 is a rear elevational view of the retail fixture in accordance with the second embodiment of the invention.


FIG. 9 is a top plan view of the retail fixture in accordance with the second embodiment of the invention.






















