FIG. 8 is a first cross sectional view of the motorcycle headlight shown in FIG. 2; and,

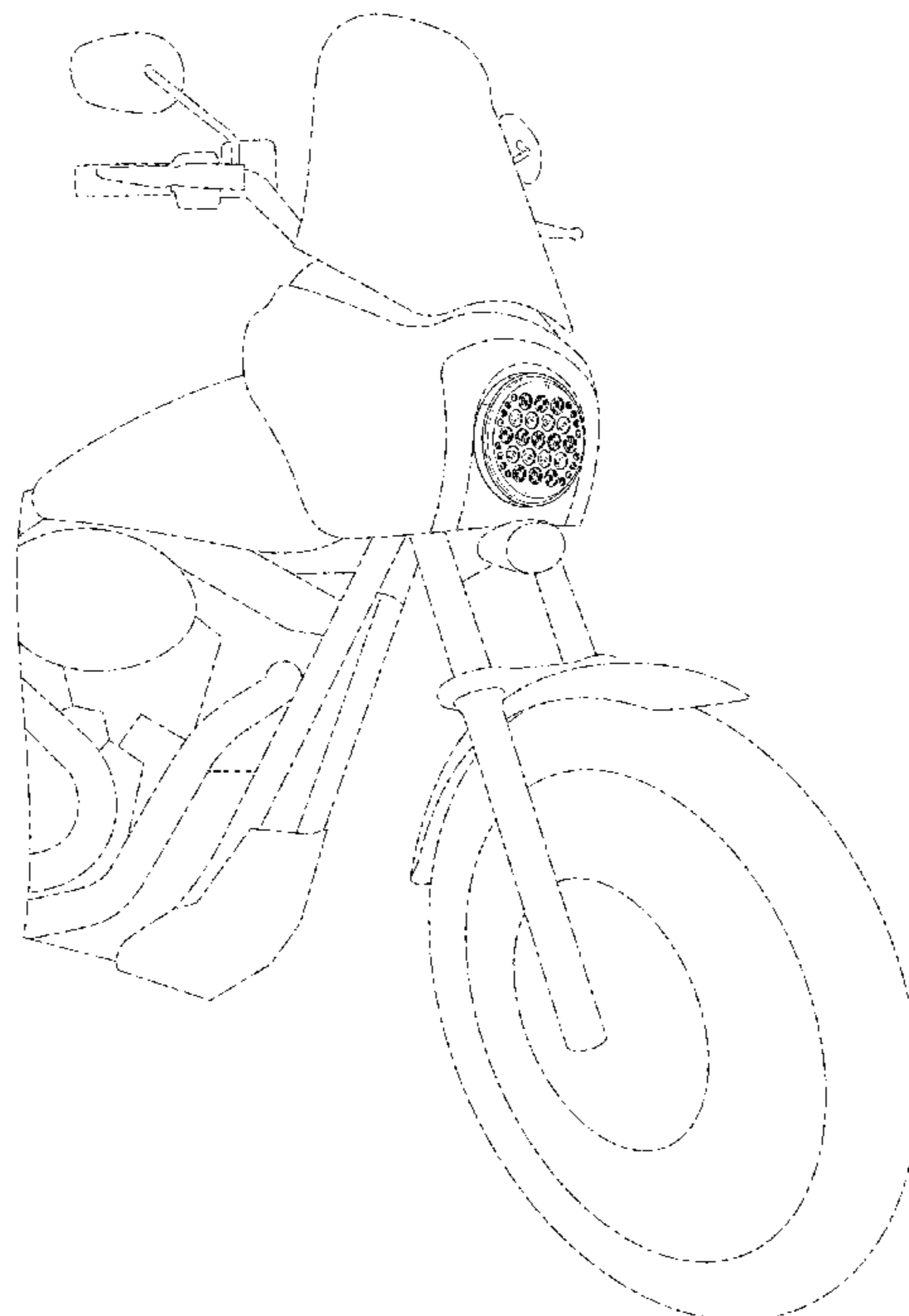
FIG. 9 is a second cross sectional view of the motorcycle headlight shown in FIG. 2.

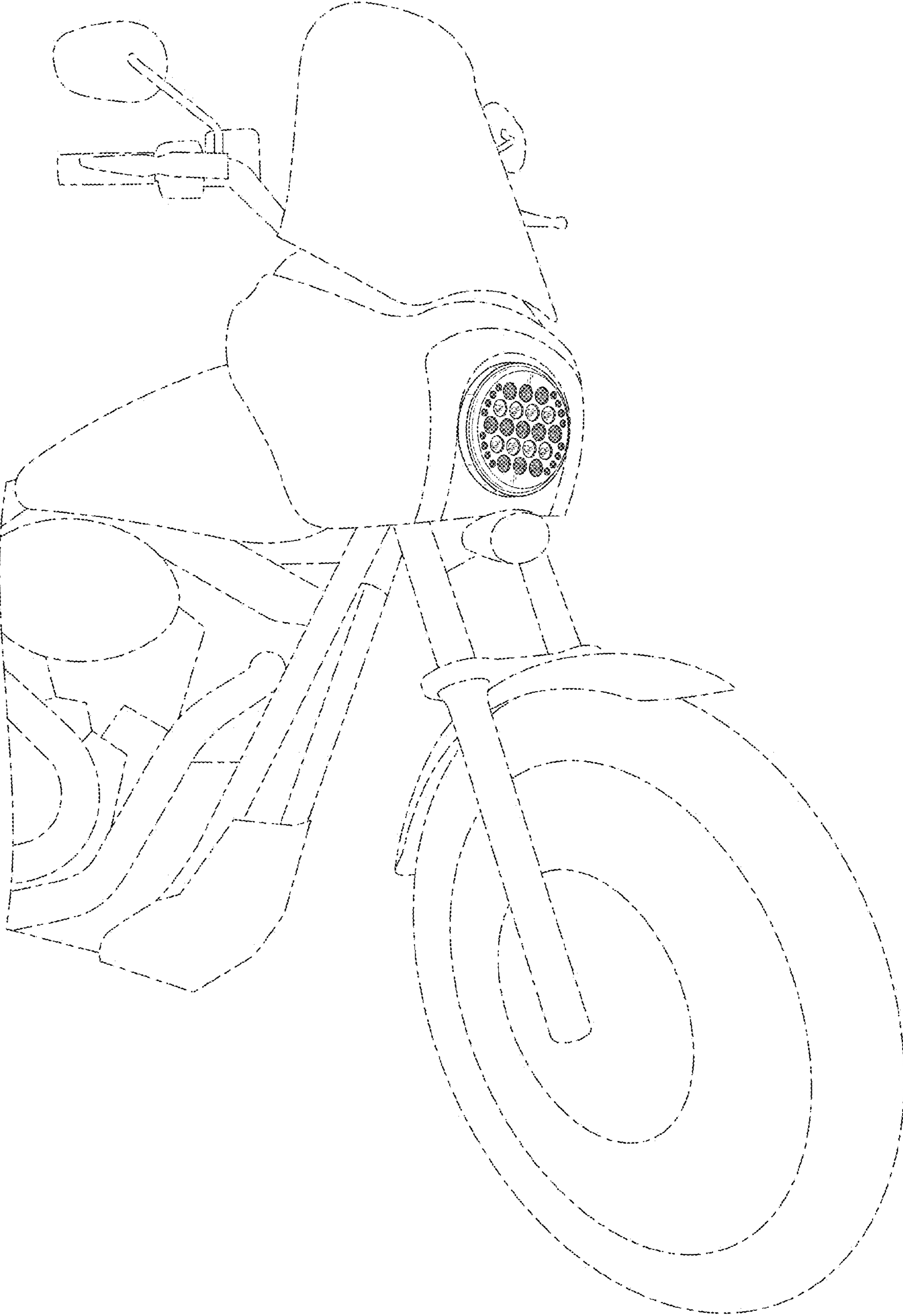

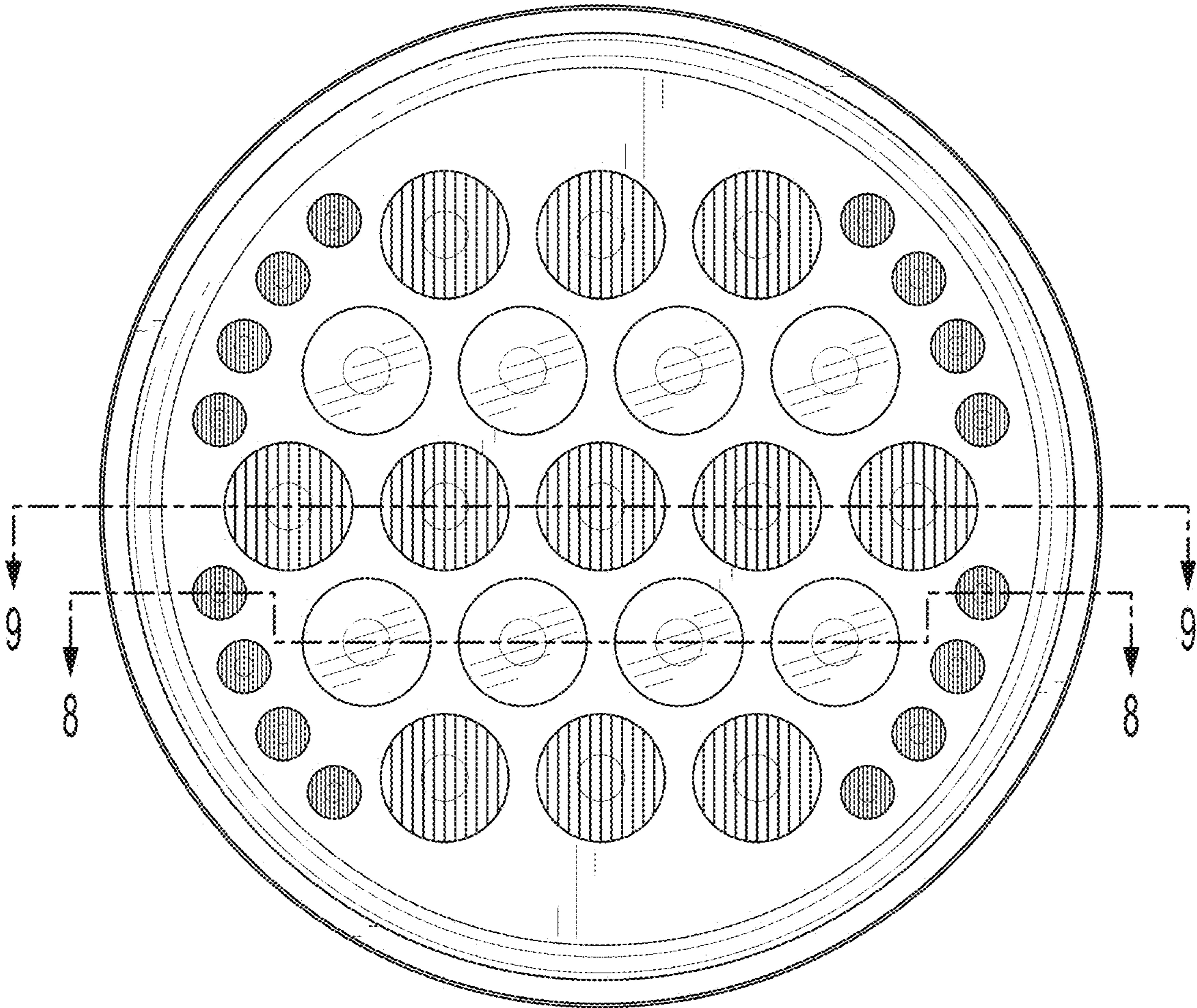

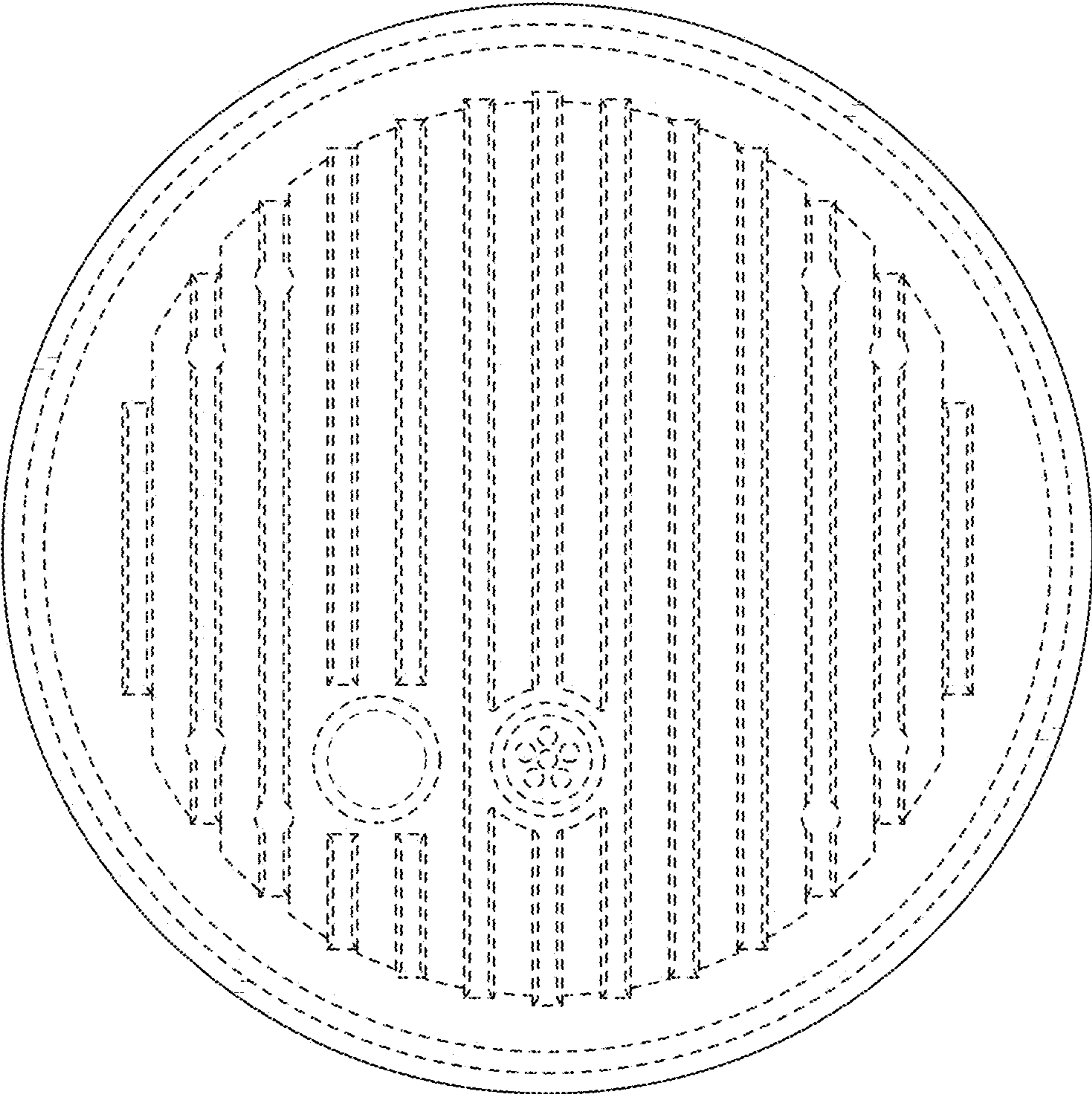

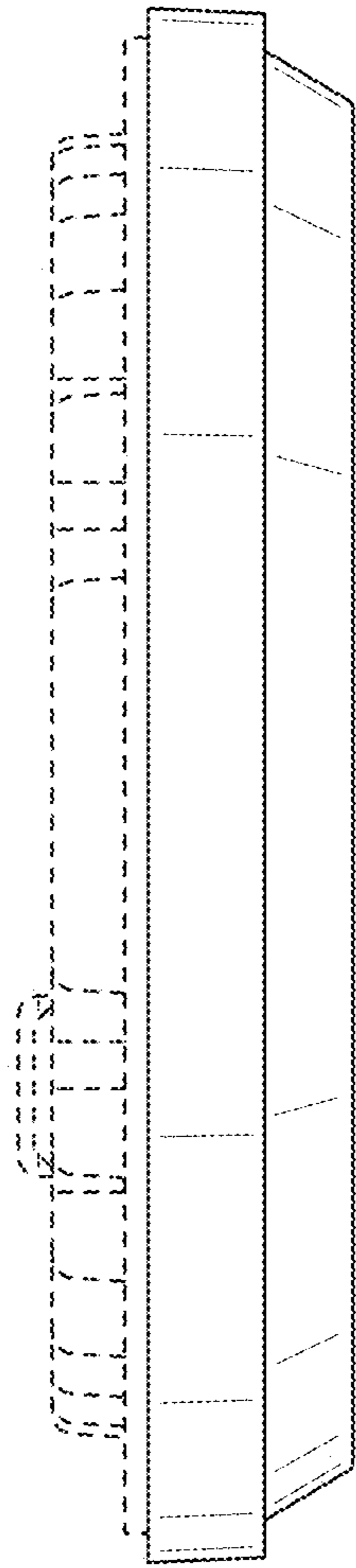

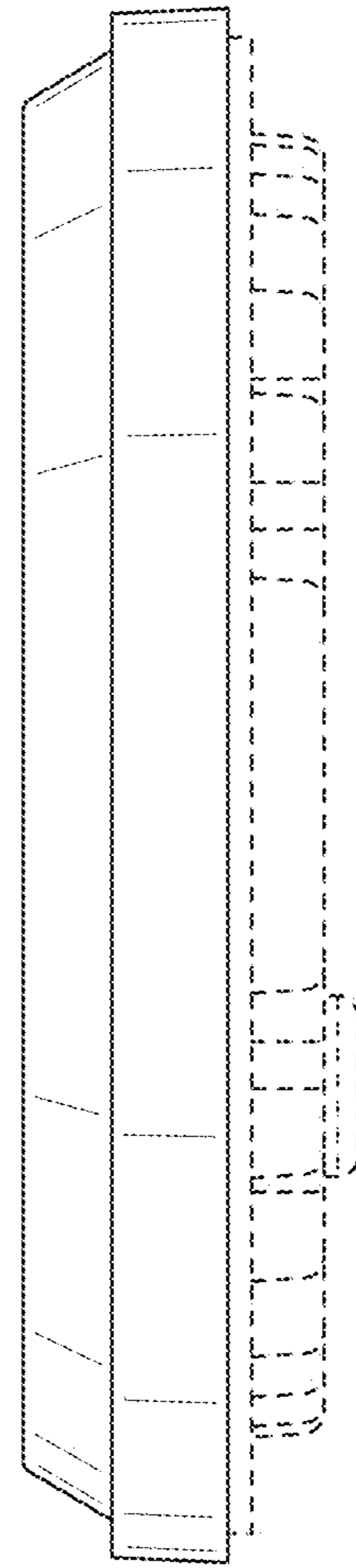

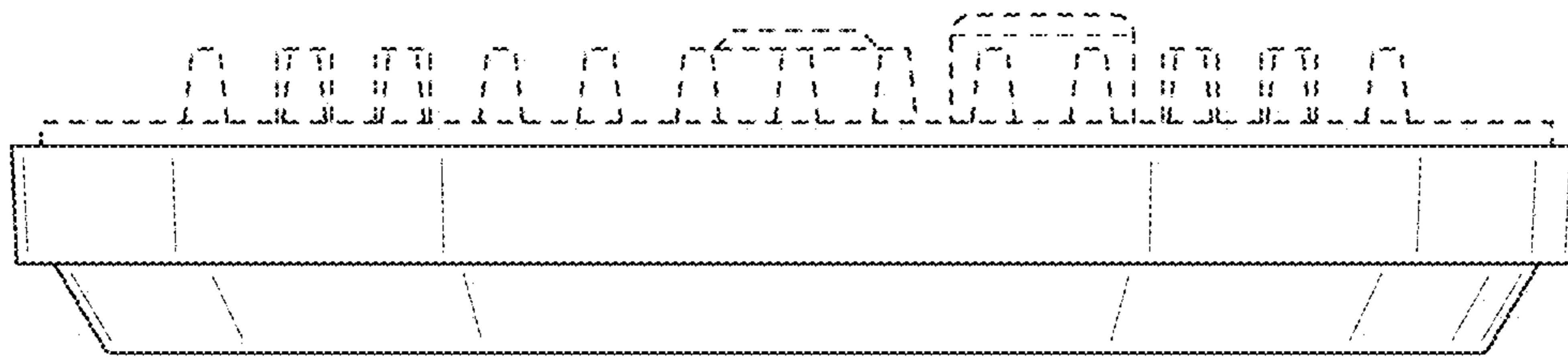

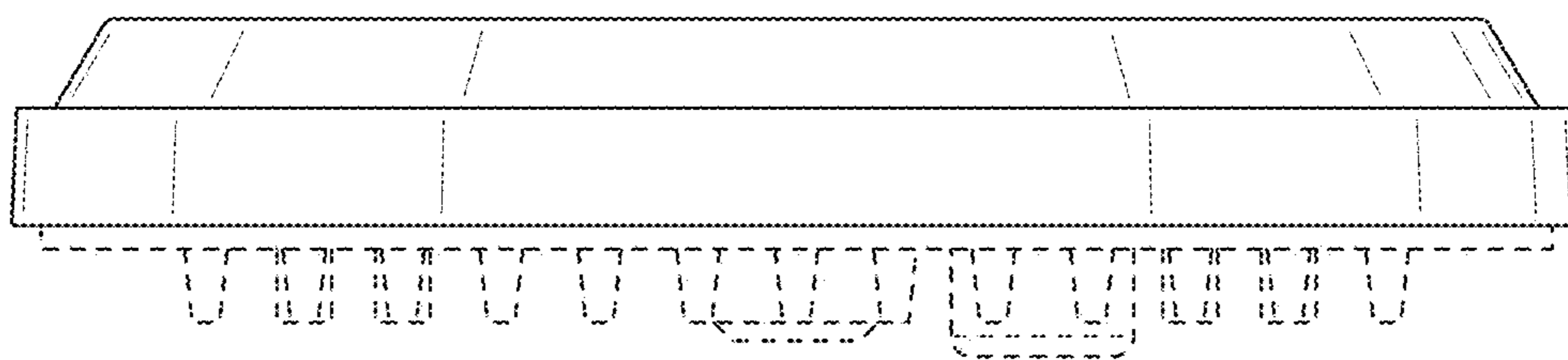

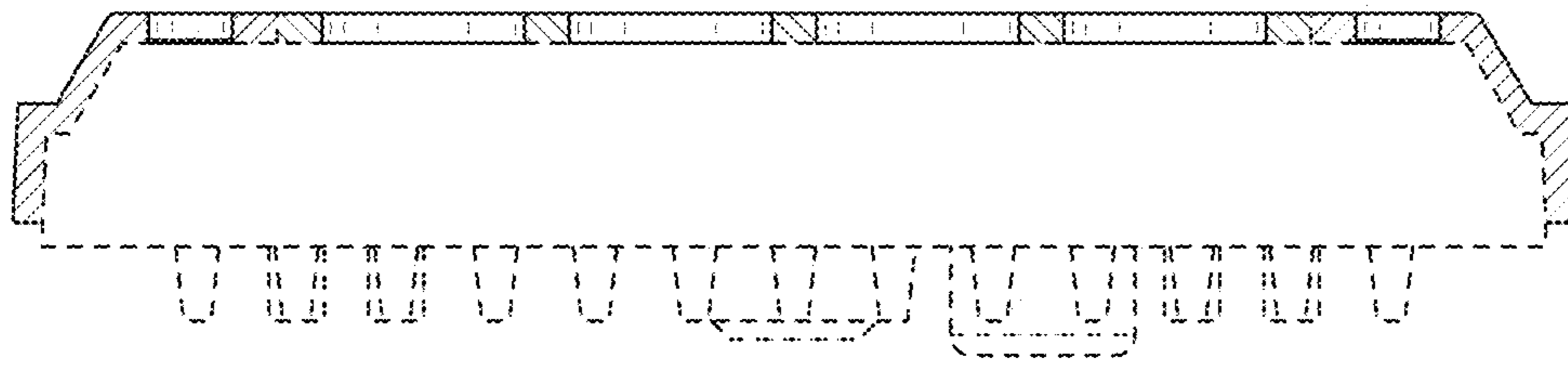

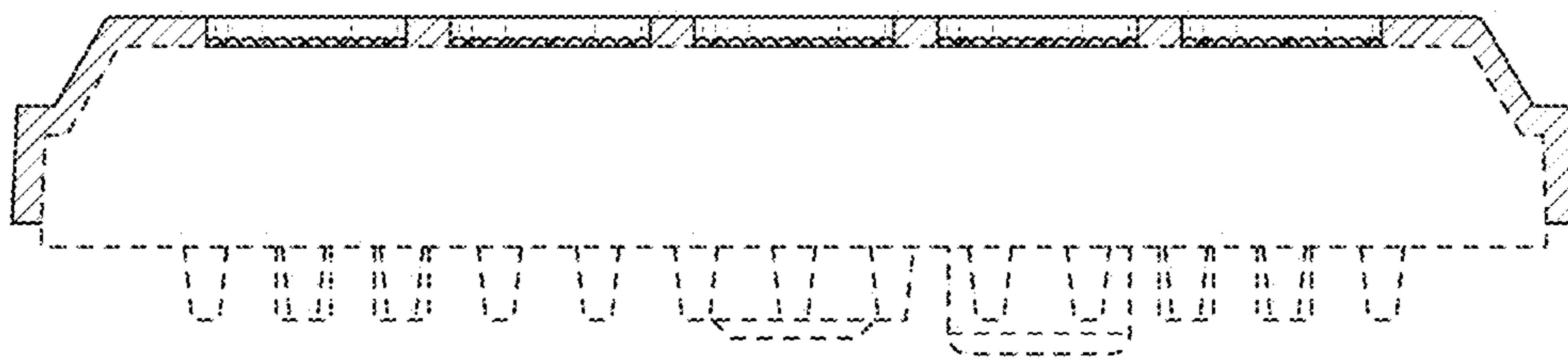
