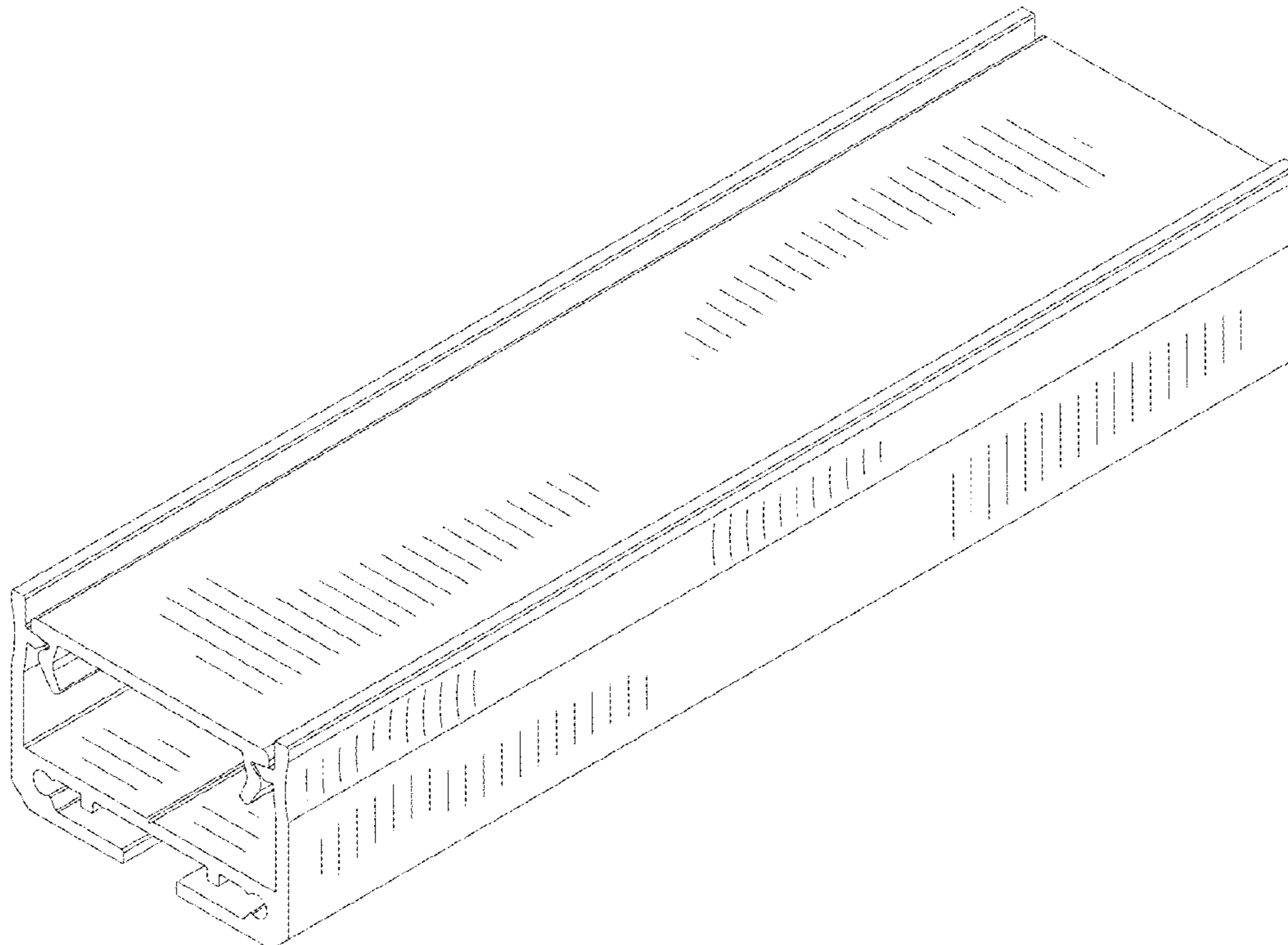
(57) **CLAIM**

The ornamental design for a housing for a LED-based lighting apparatus as shown and described.

DESCRIPTION

FIG. 1 is a front, a left side perspective view of a housing for a LED-based lighting apparatus showing my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a bottom plan view thereof; and, FIG. 5 is a right side elevational view thereof, the left side being a mirror image.

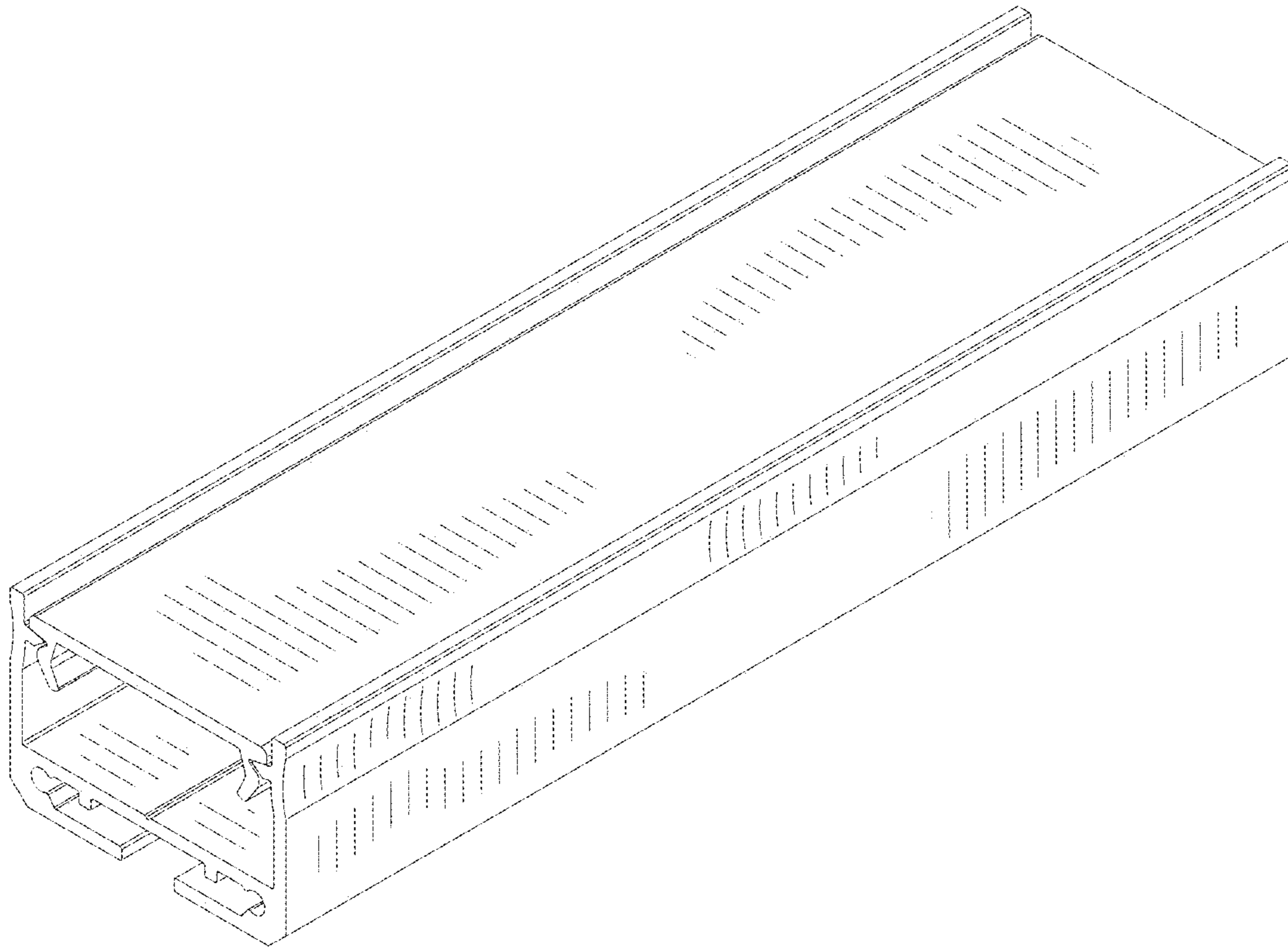

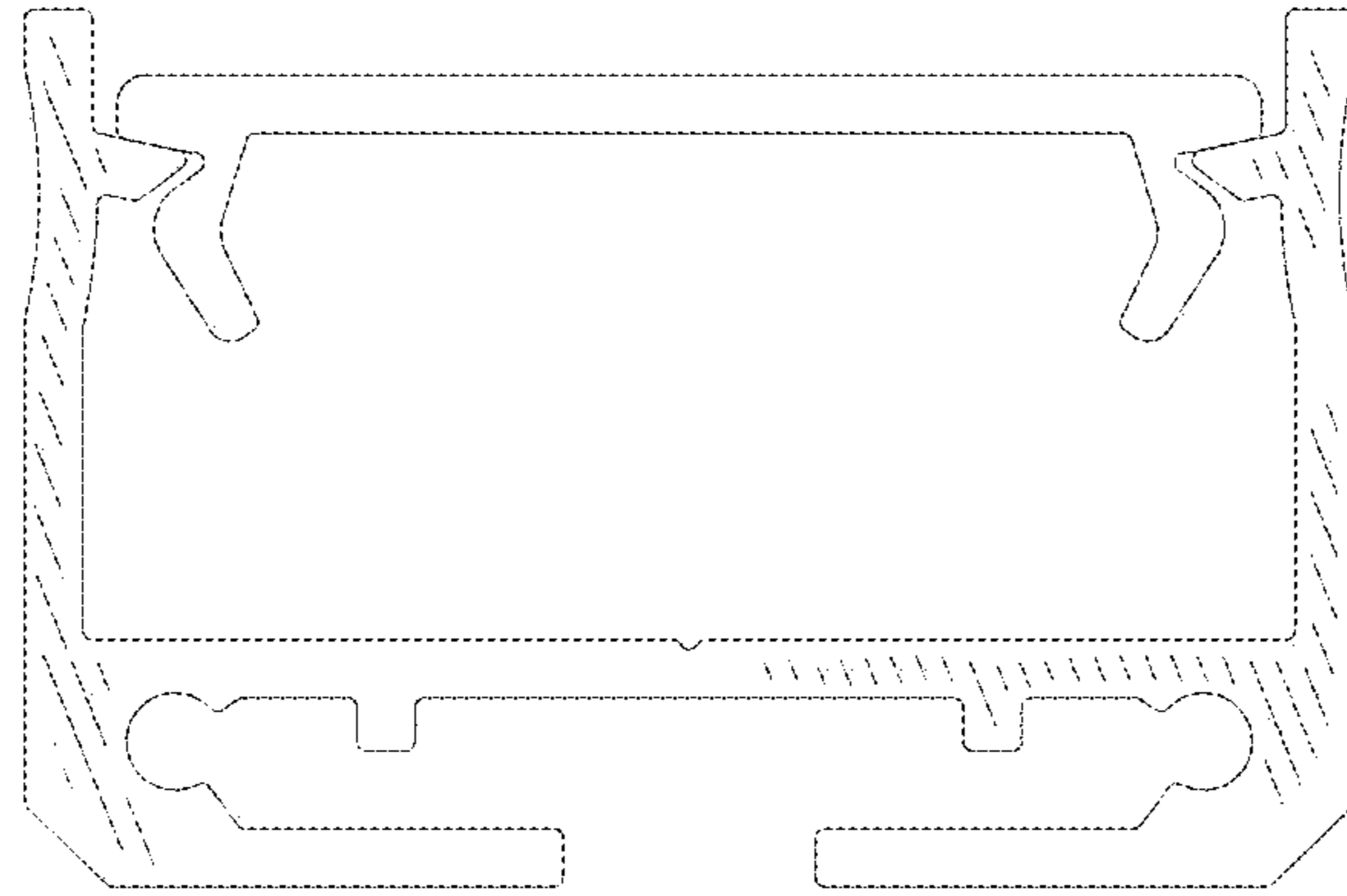

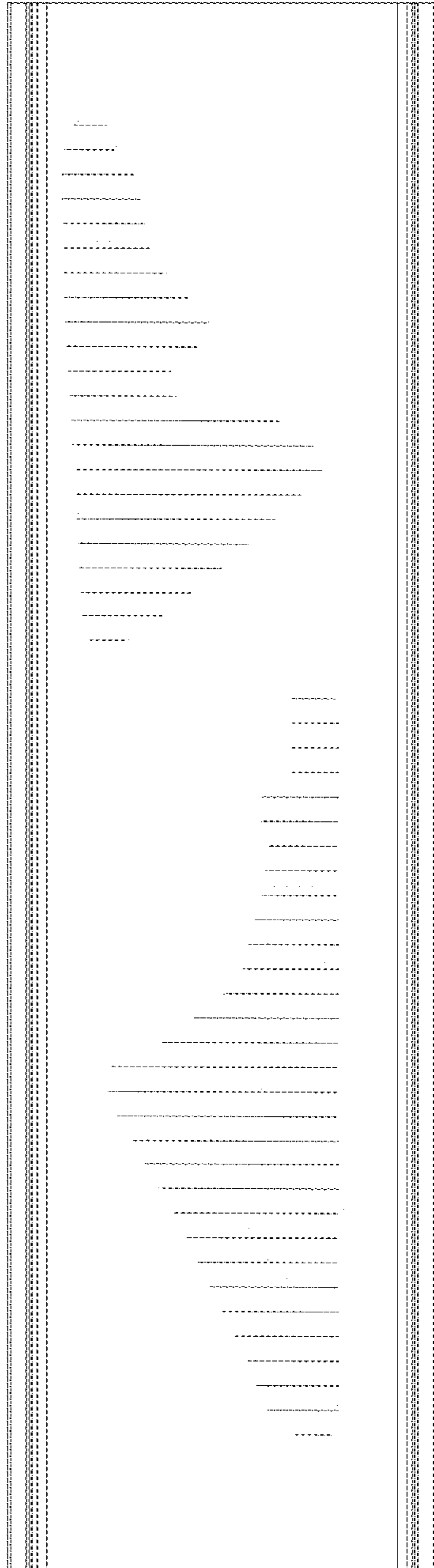

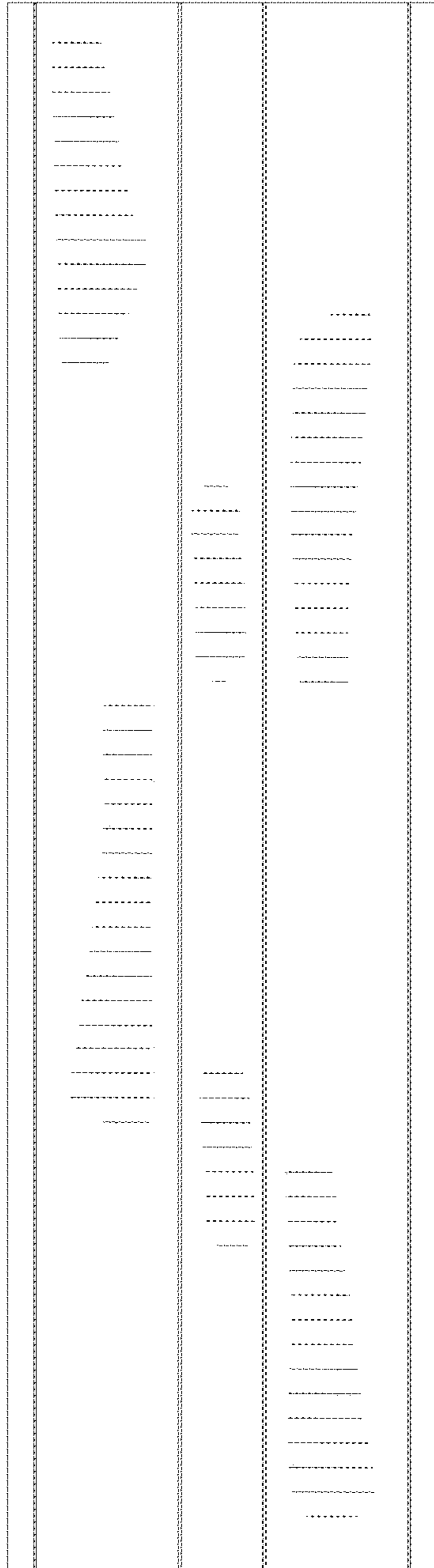

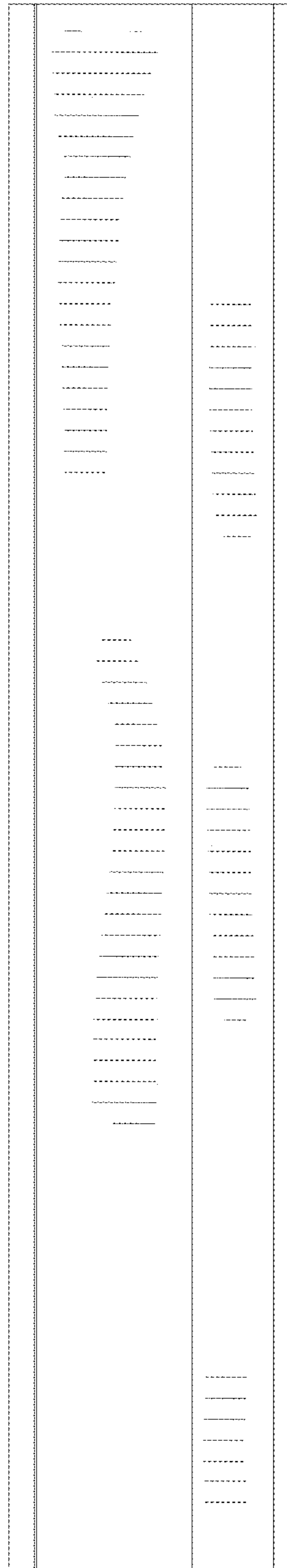
