The ornamental design for a lipstick casing, as shown and described.

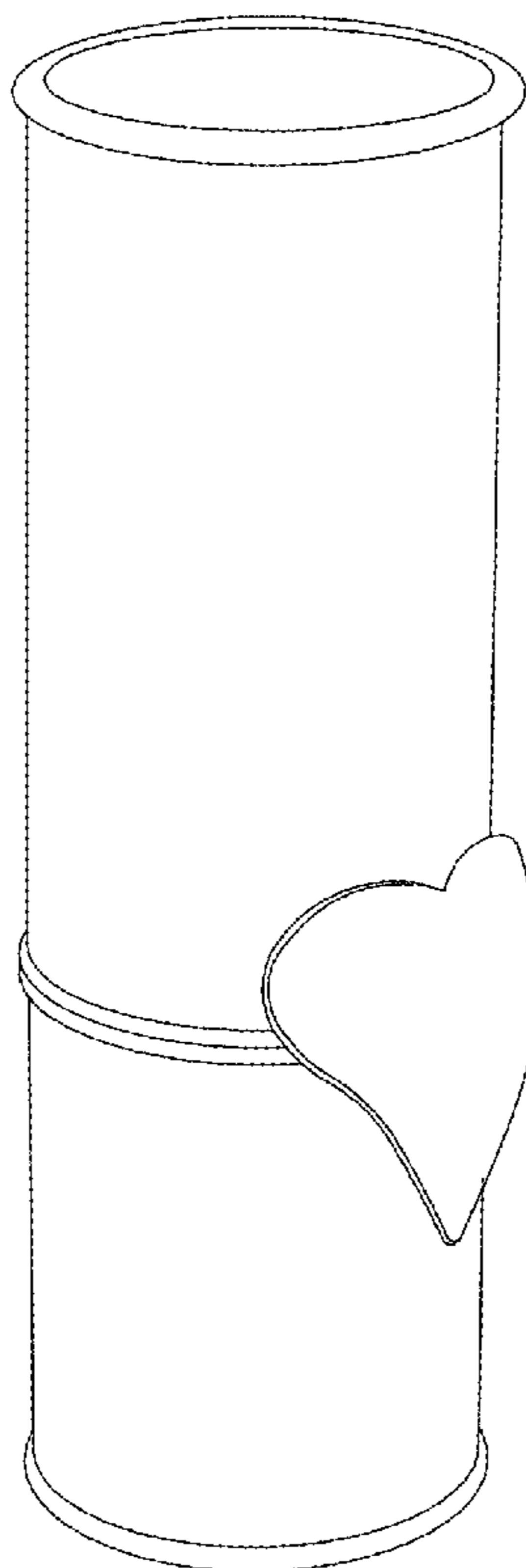
DESCRIPTION

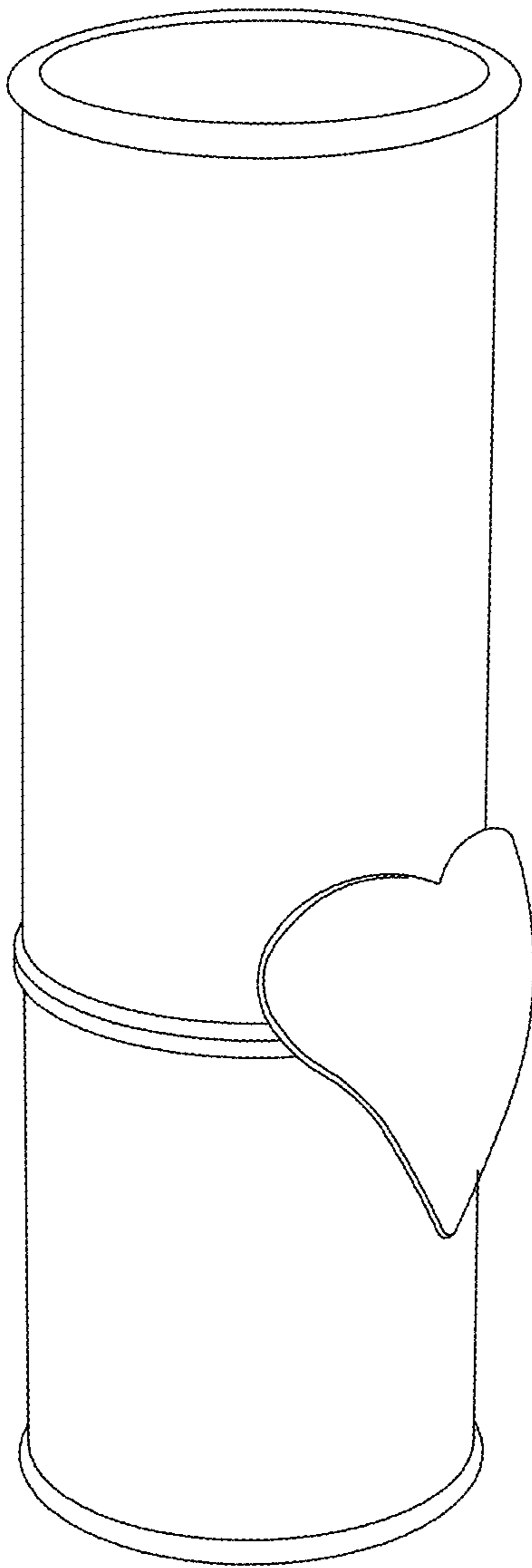

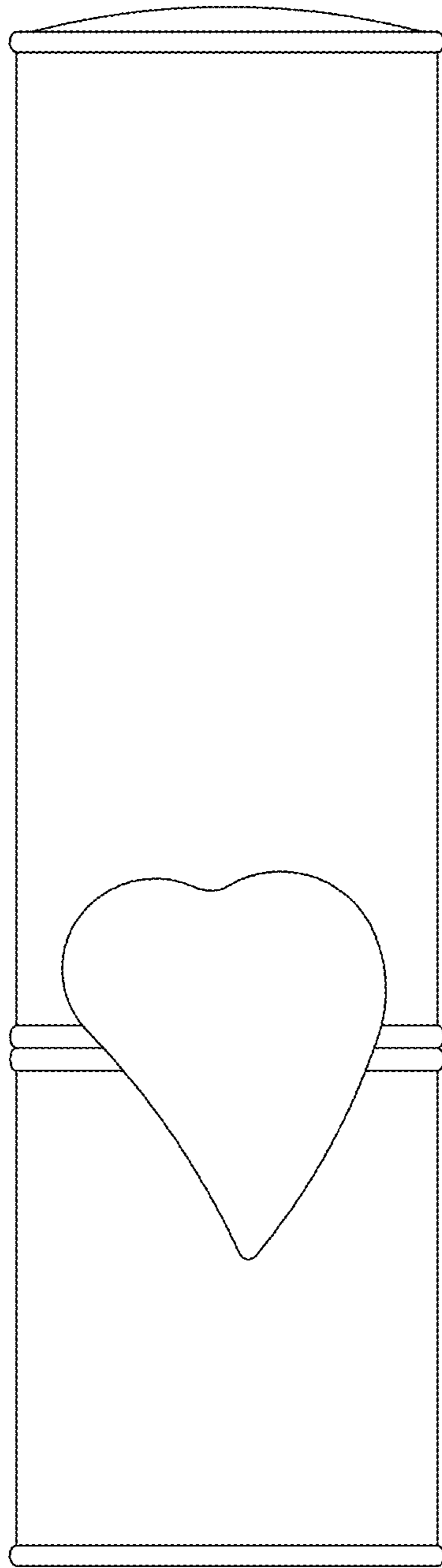

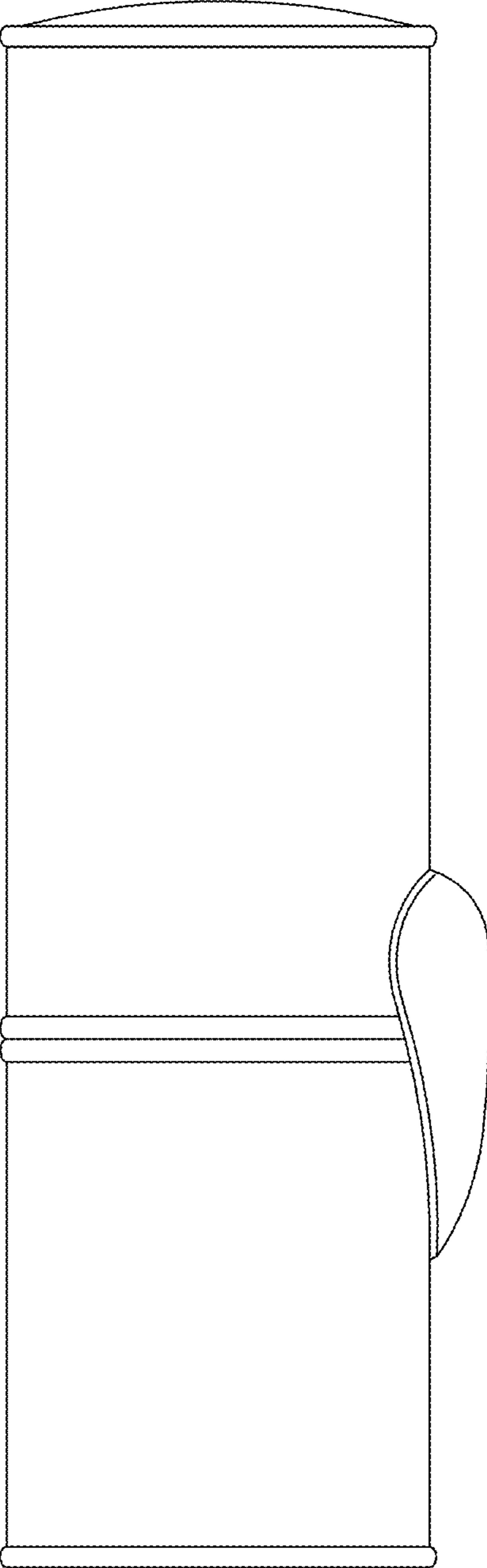

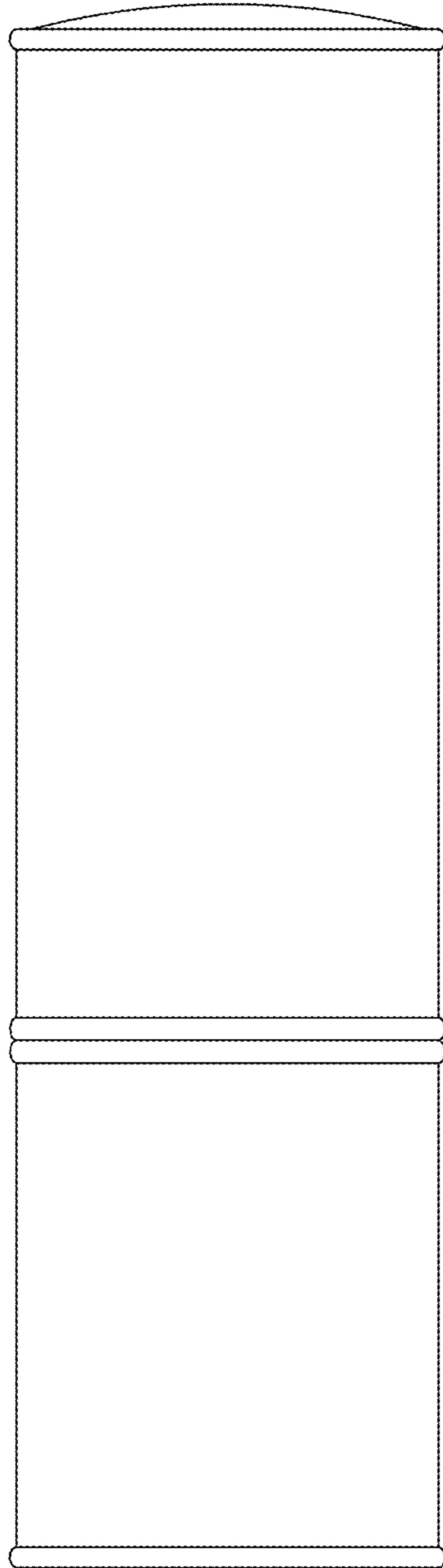

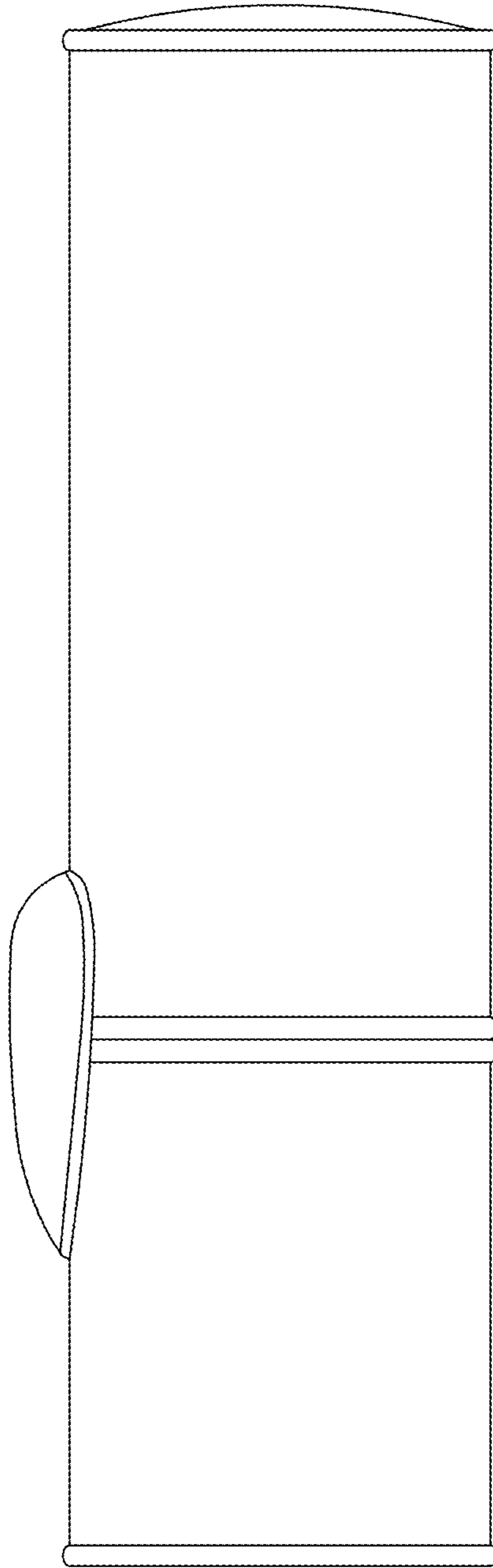

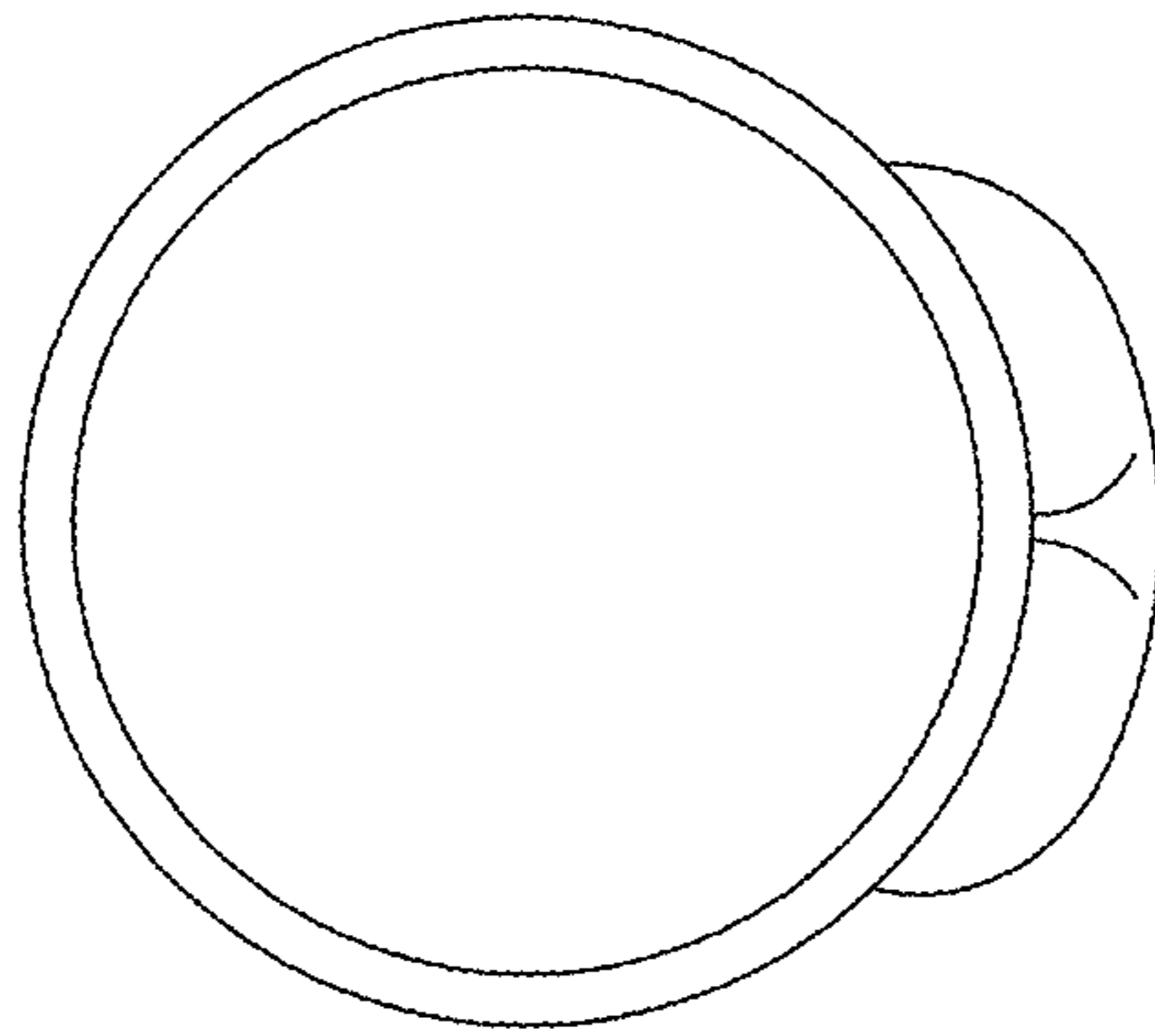

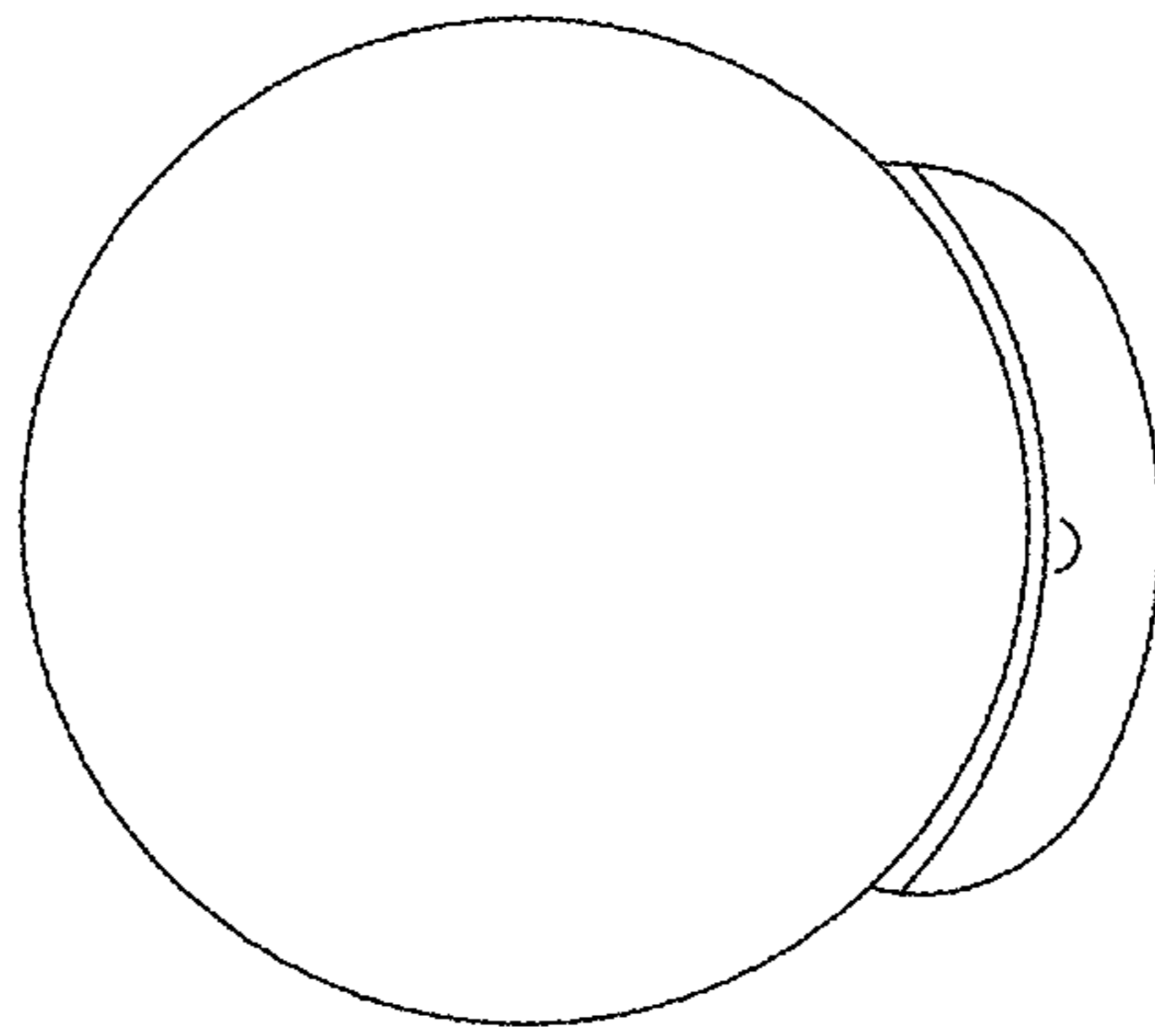

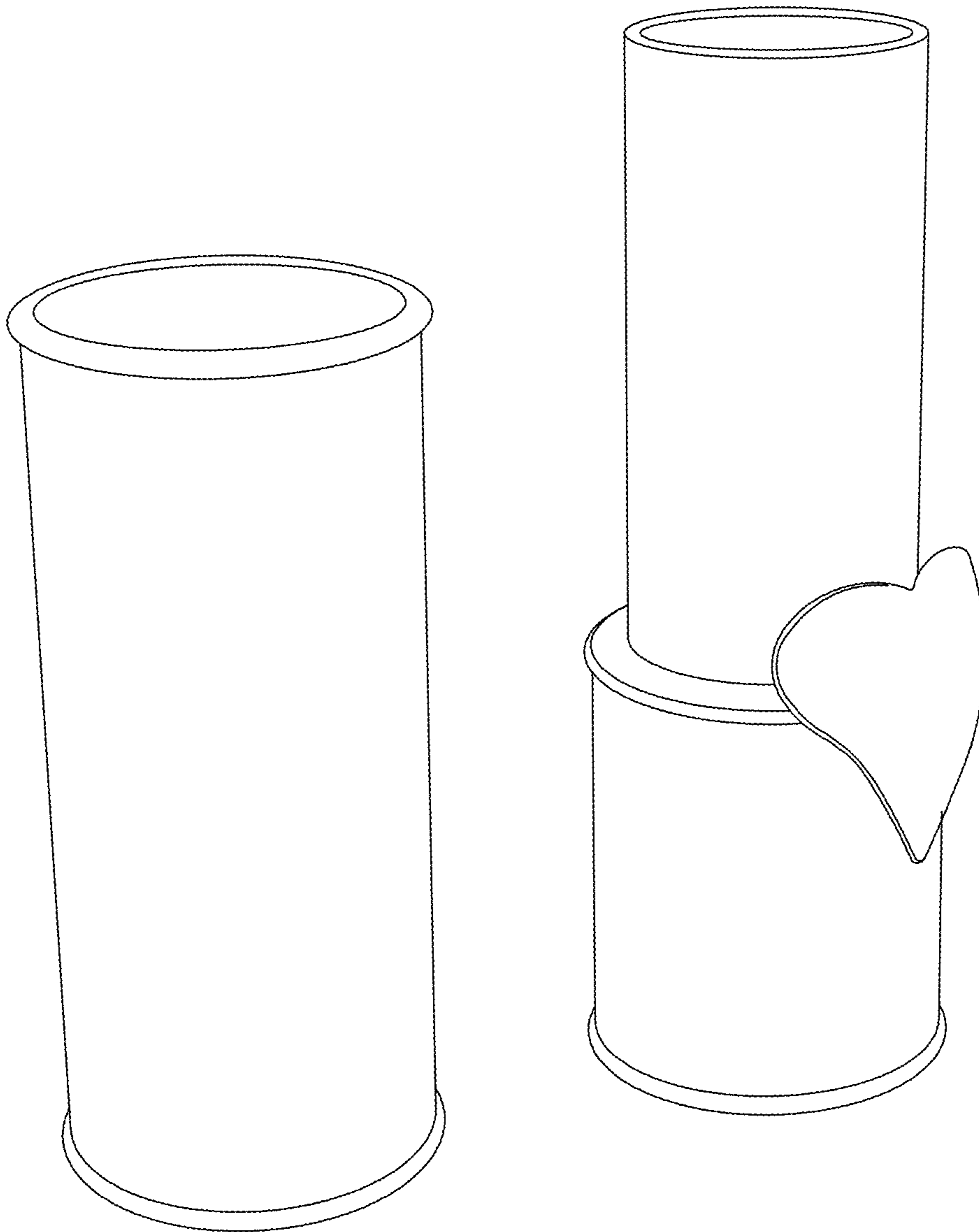
