DESCRIPTION

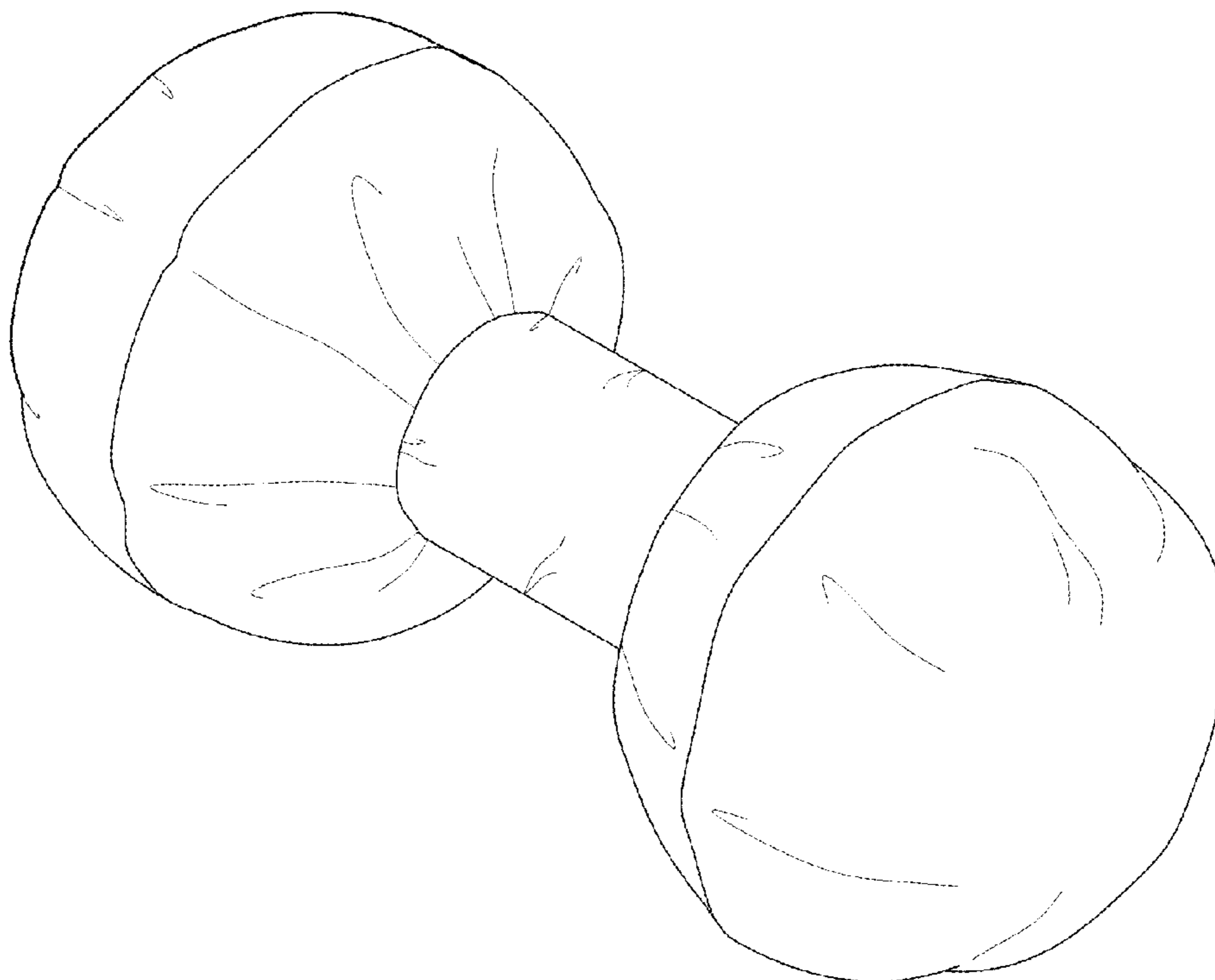

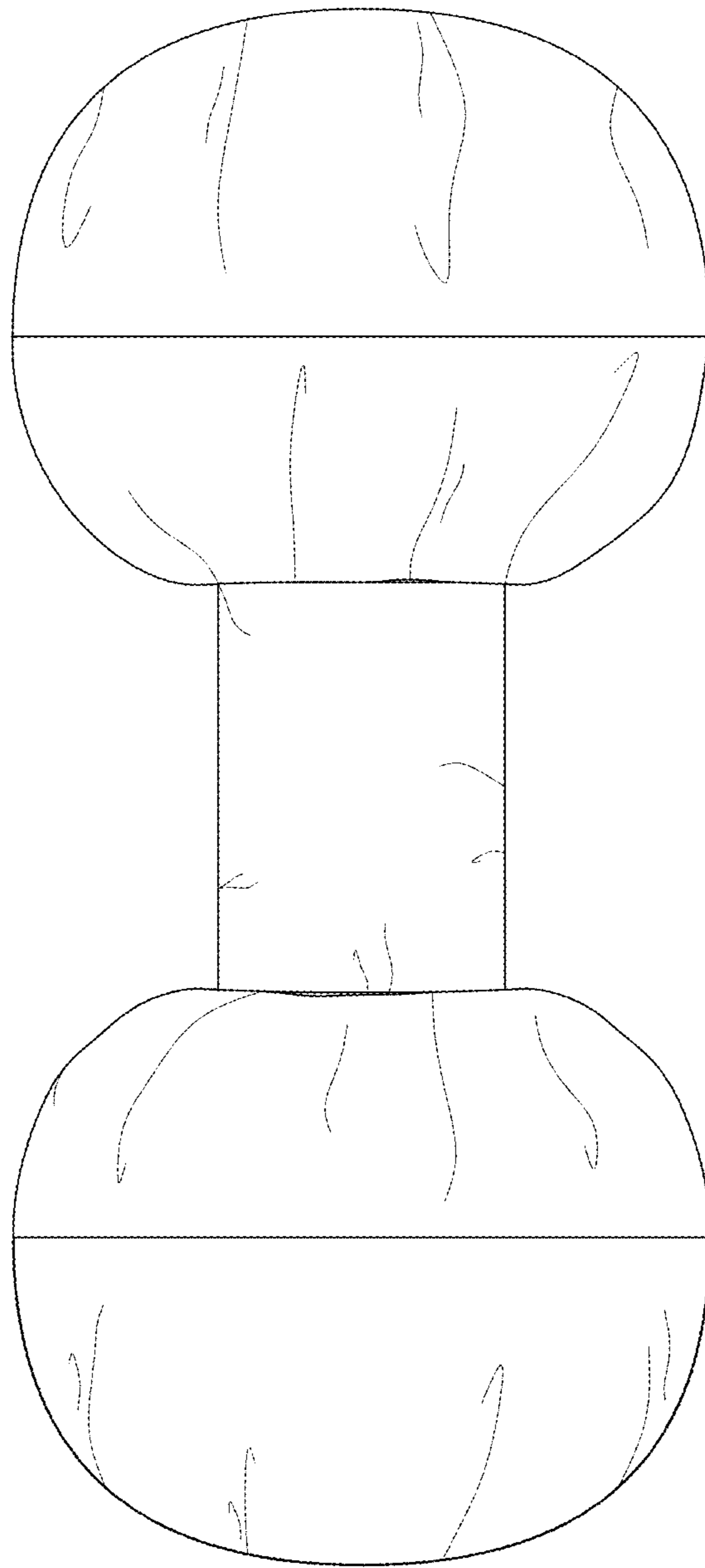

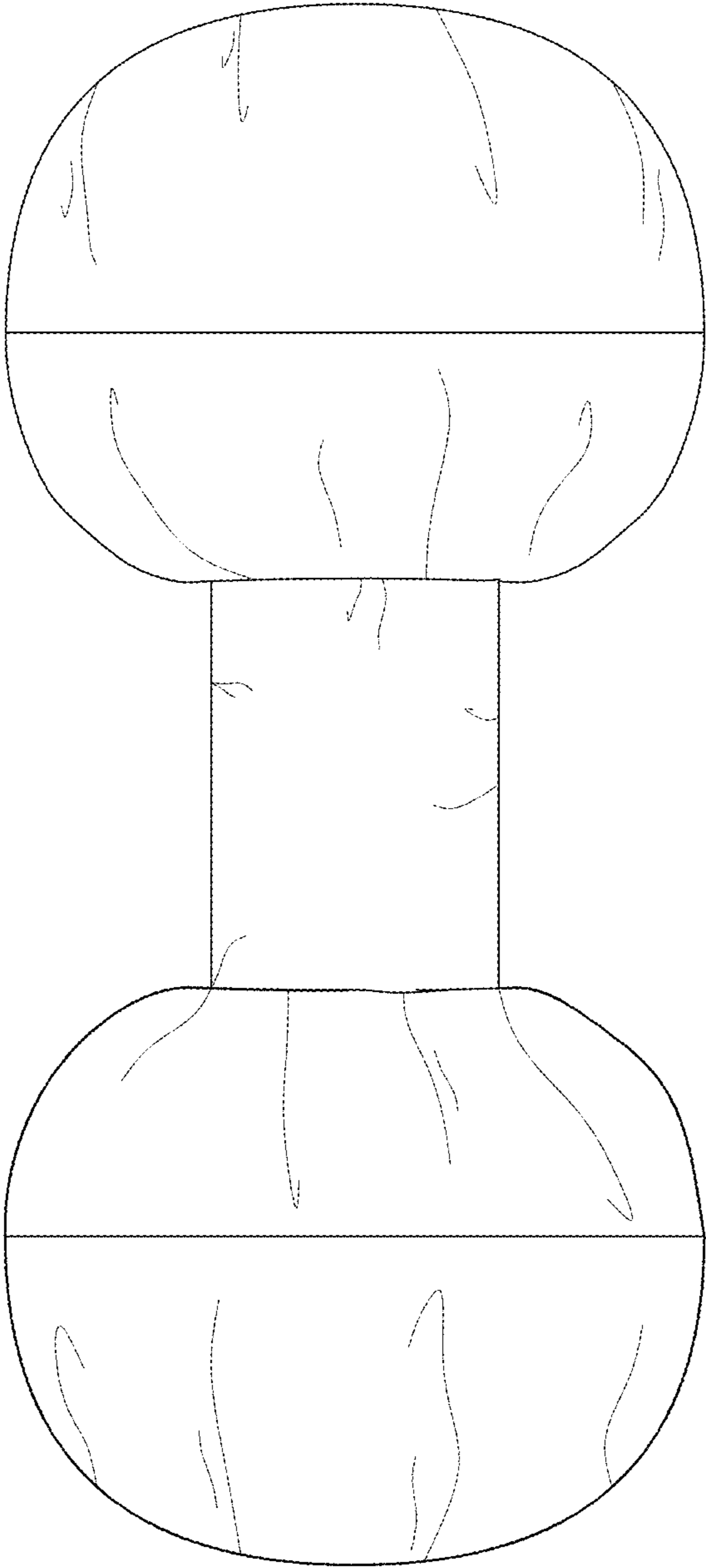

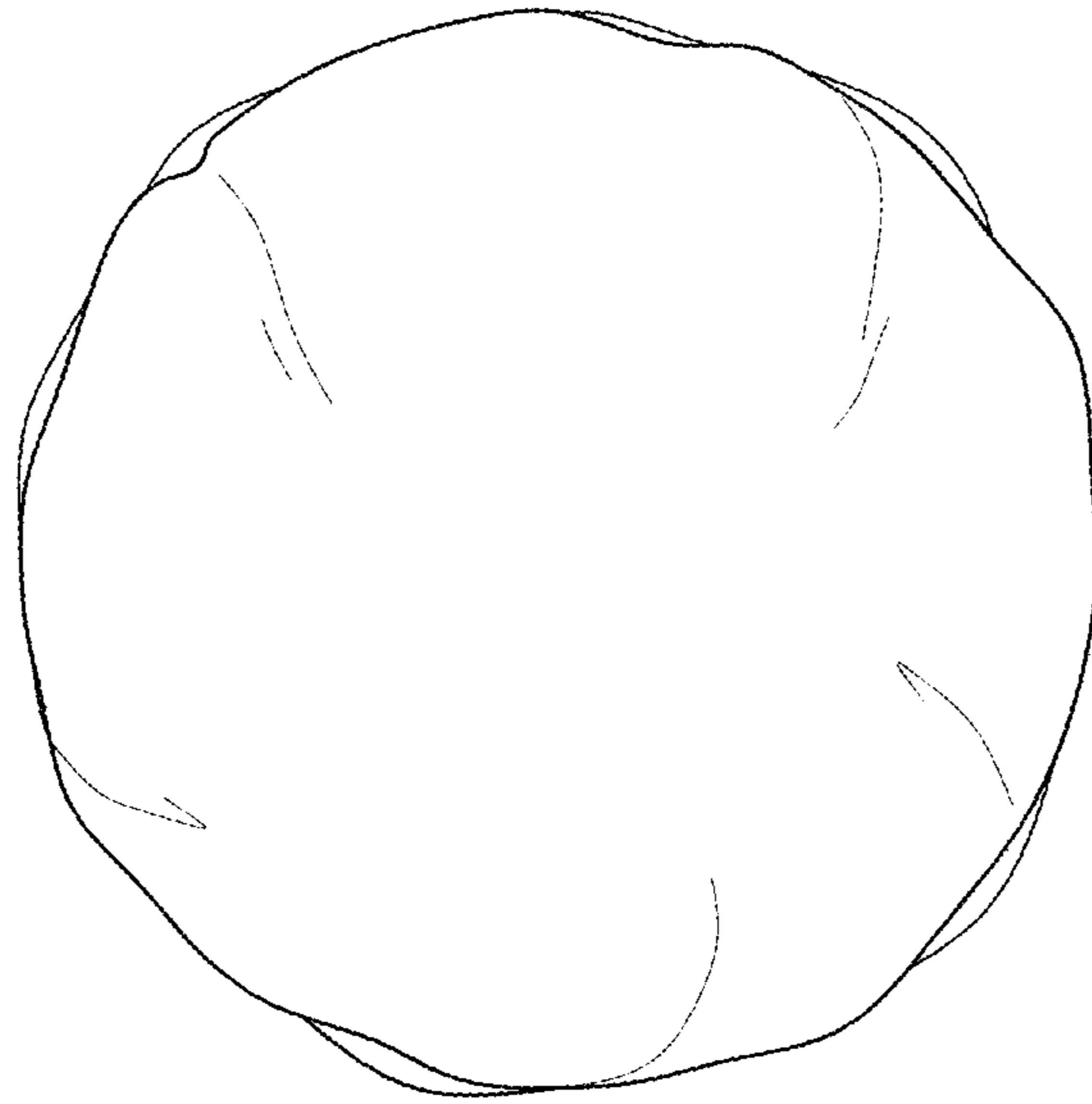

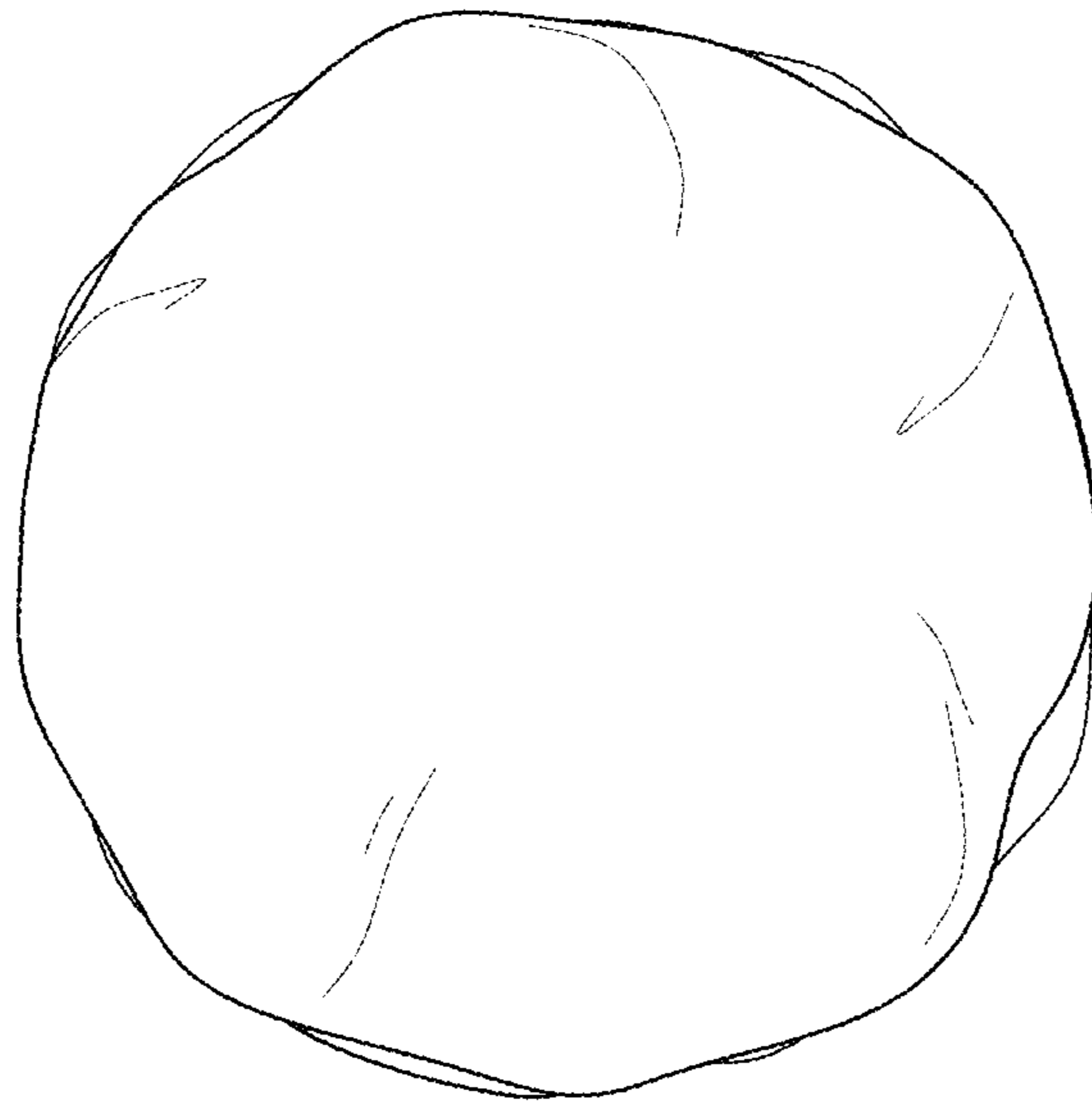

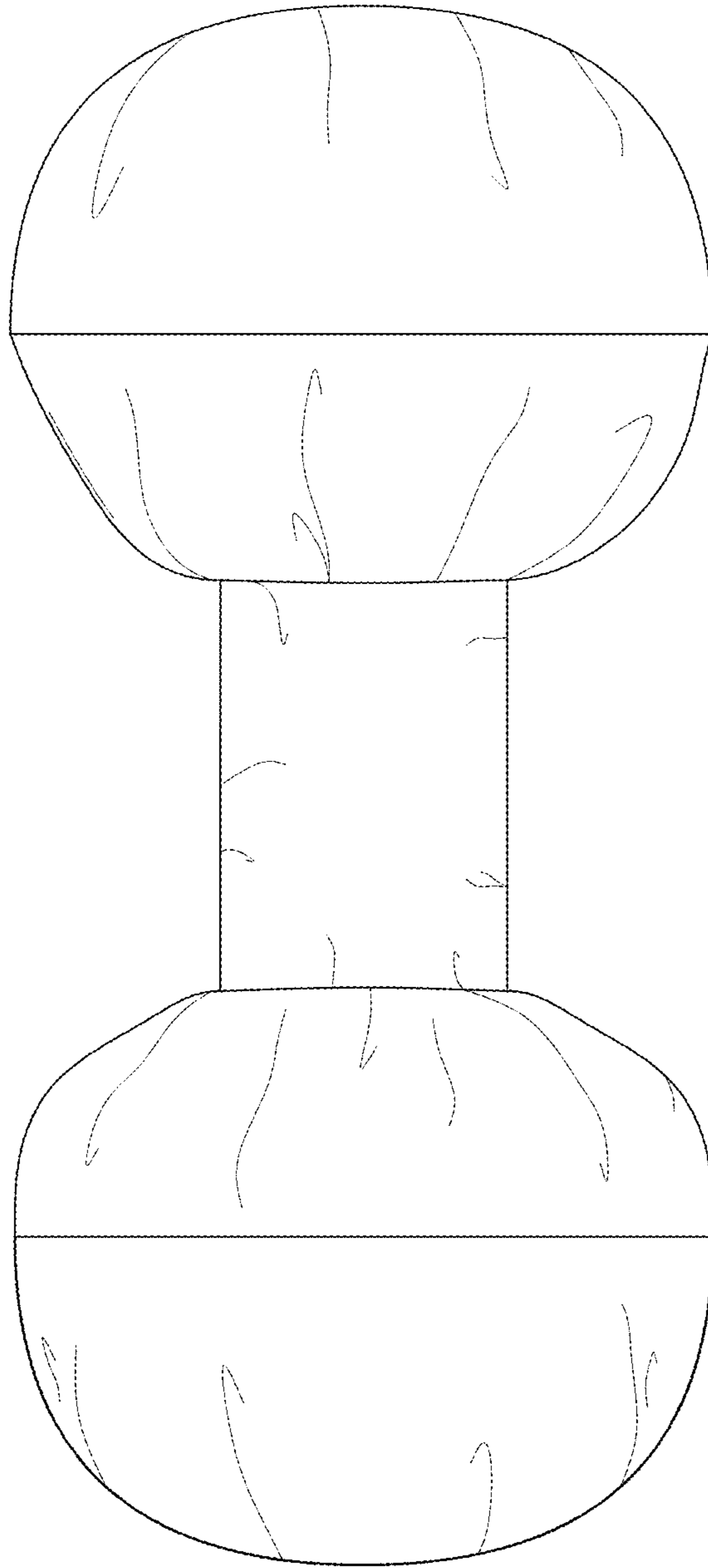

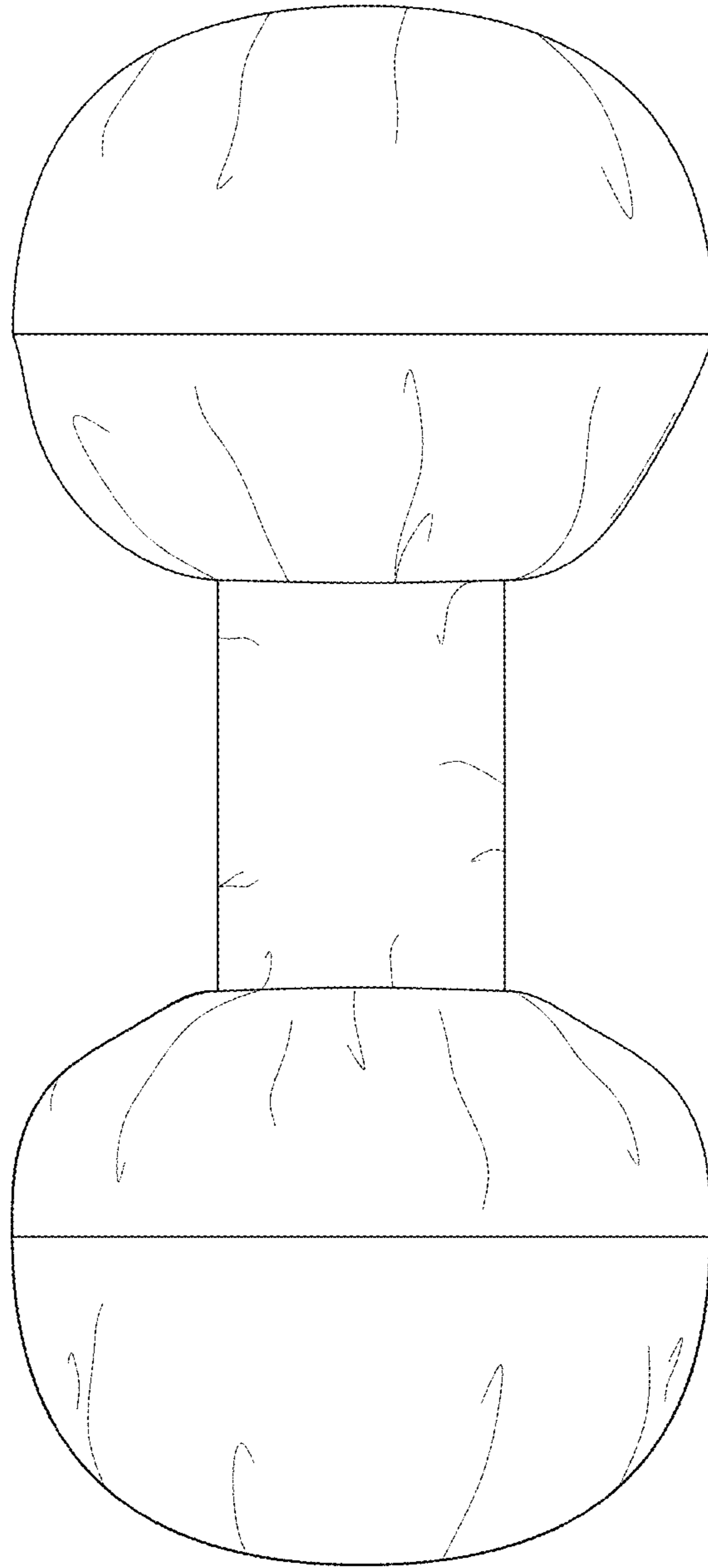

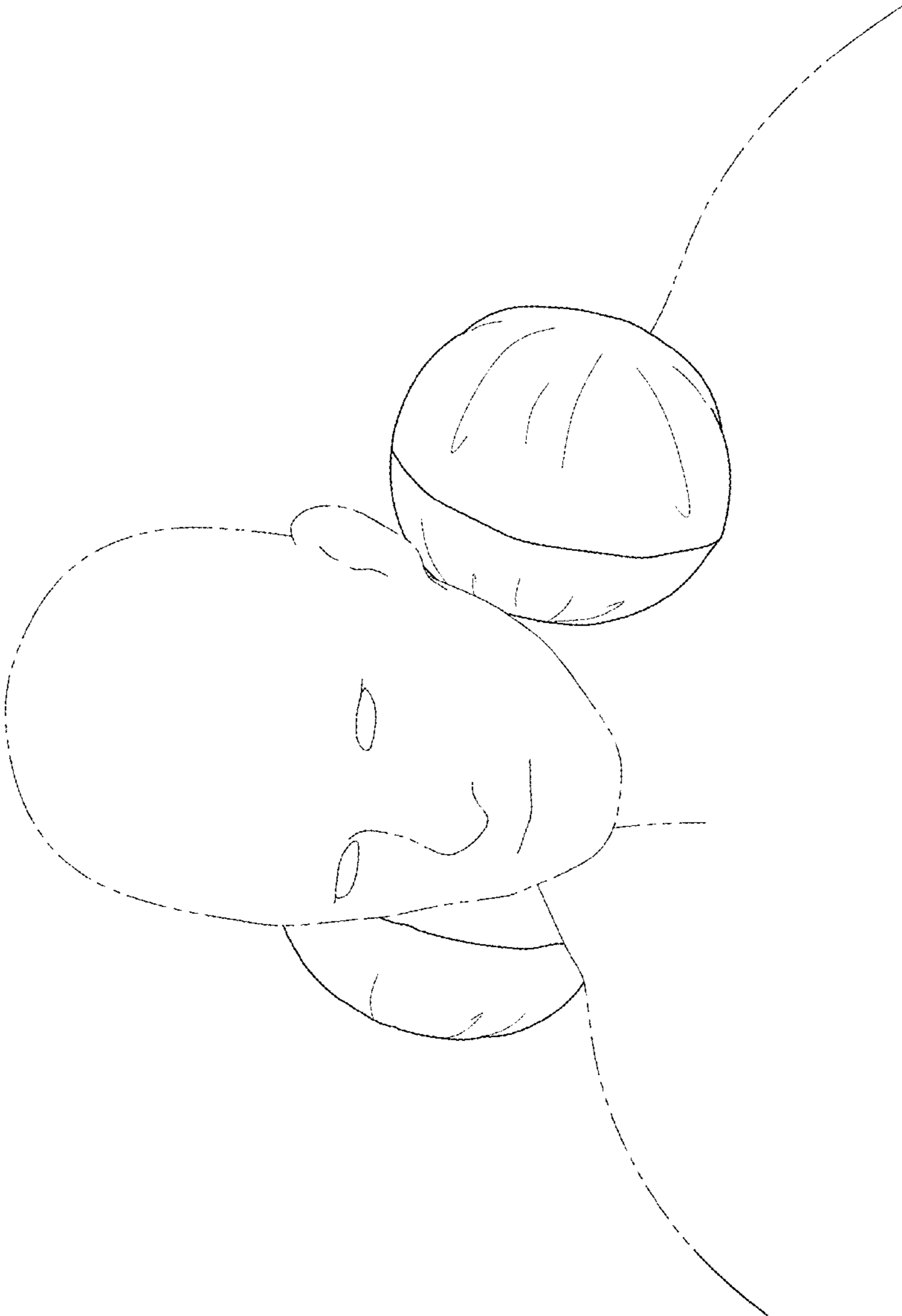

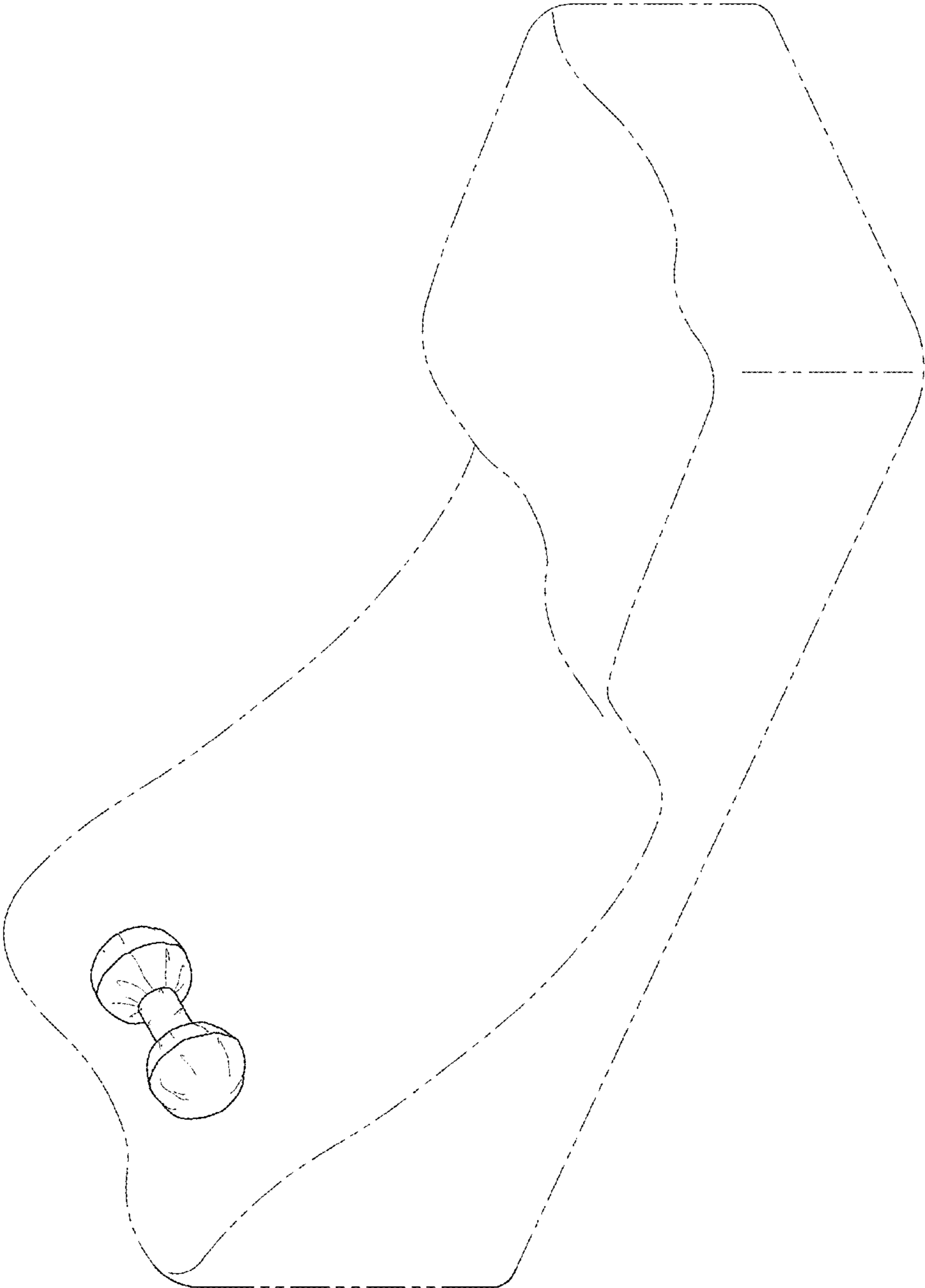
