The ornamental design for a packaging box, as shown and described.

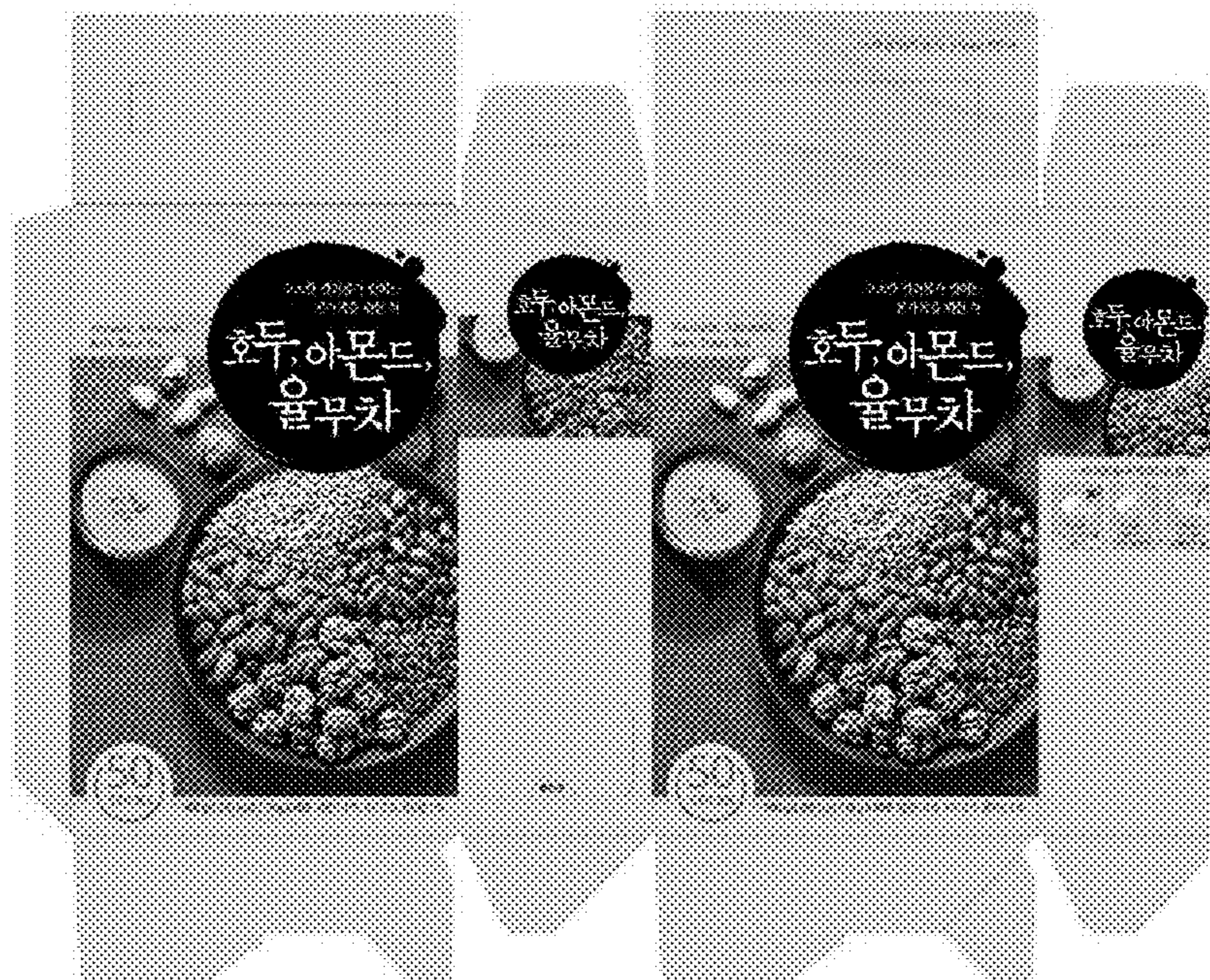
