FIG. 3 is a top front right perspective view of a hygiene product packaging including ornament, in accordance with another embodiment of the present invention.

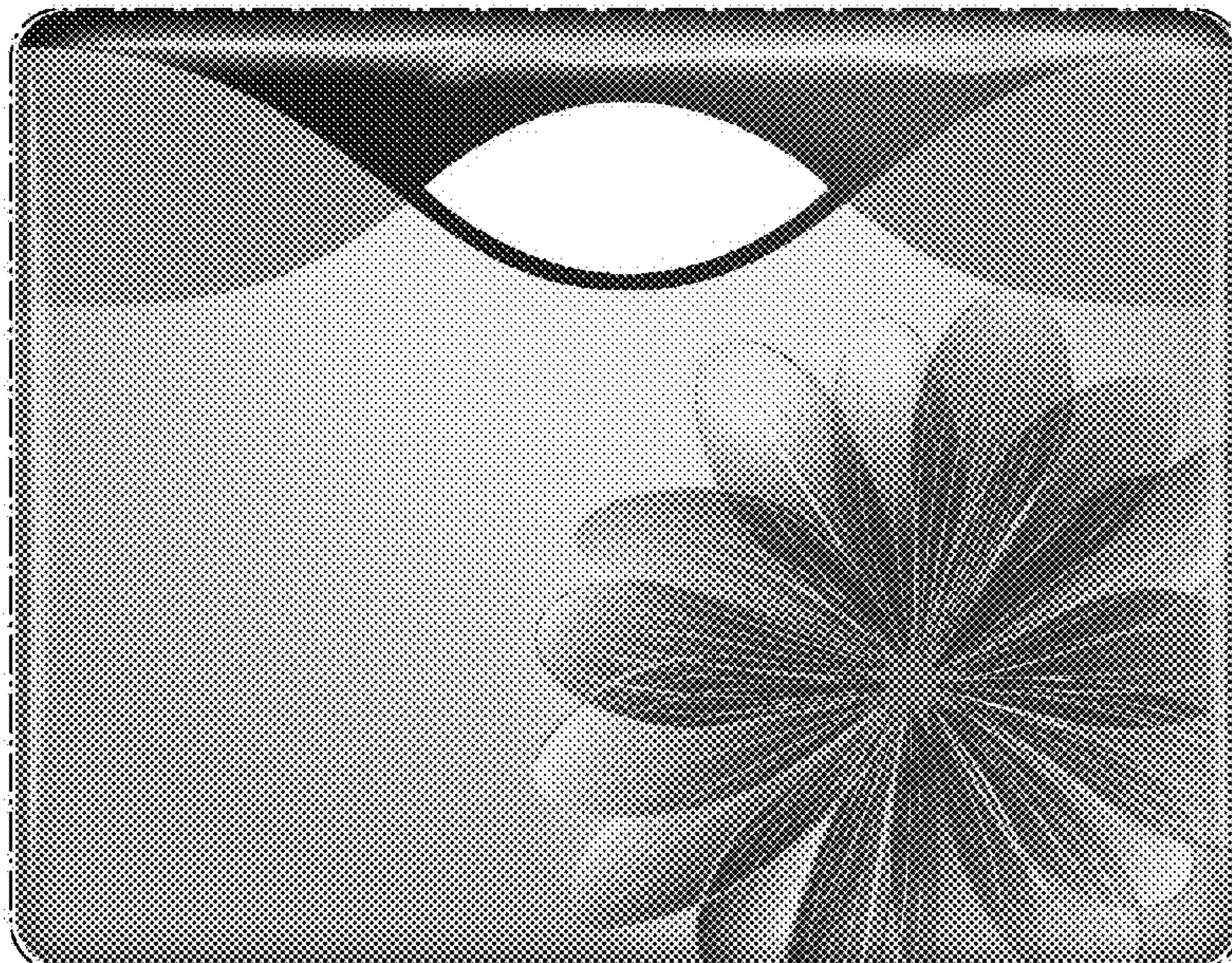
FIG. 4 is a front view thereof.

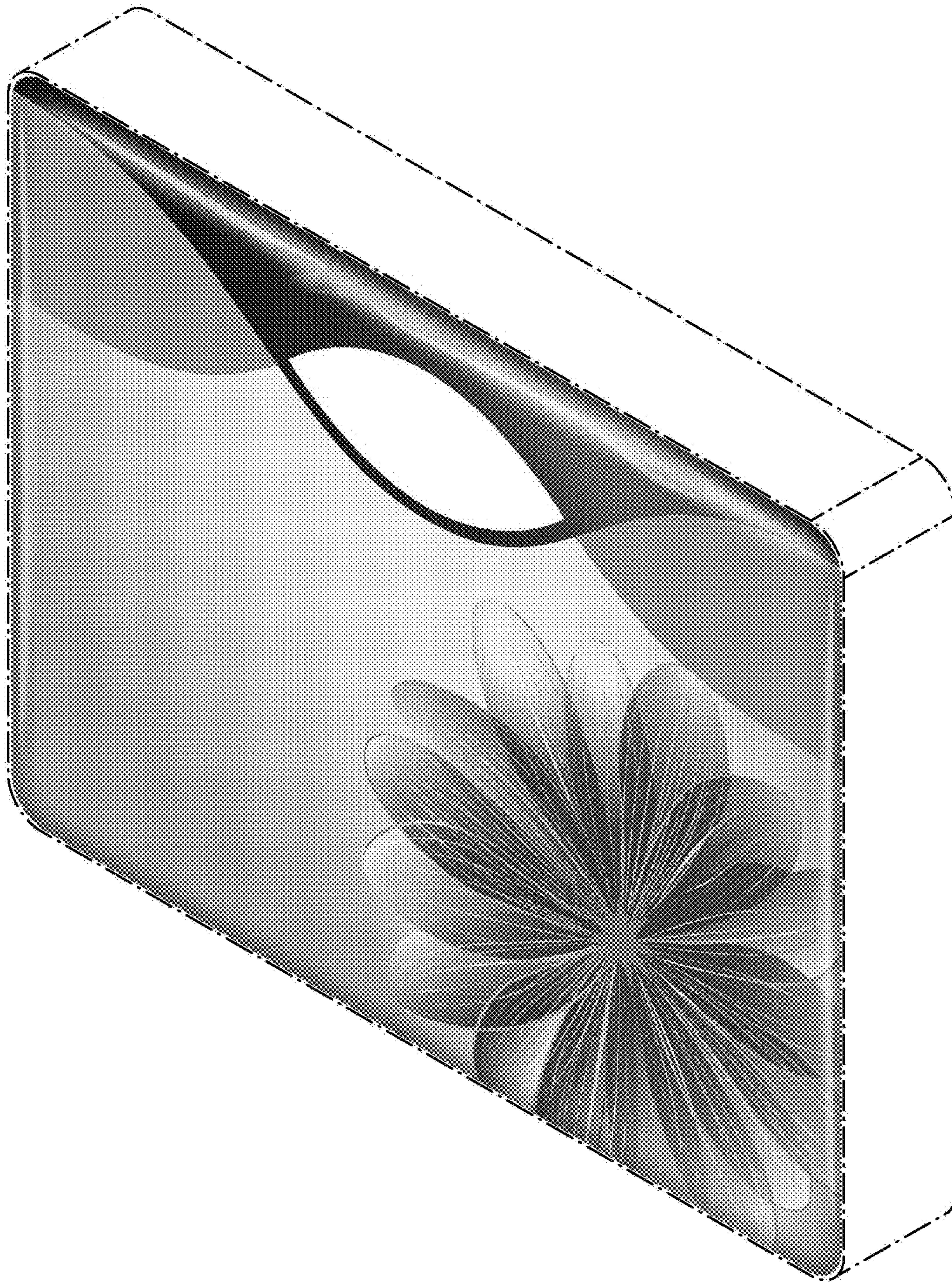

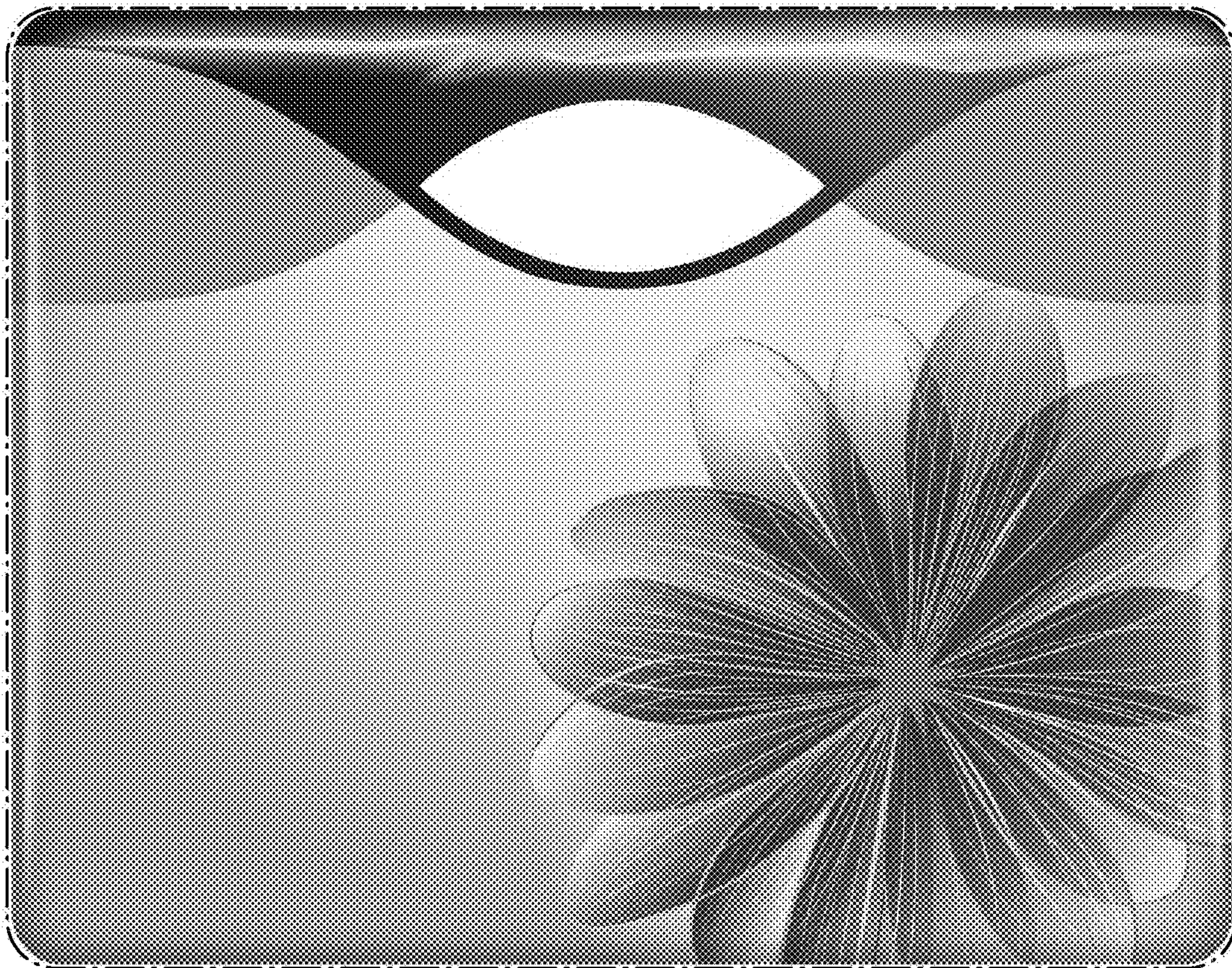

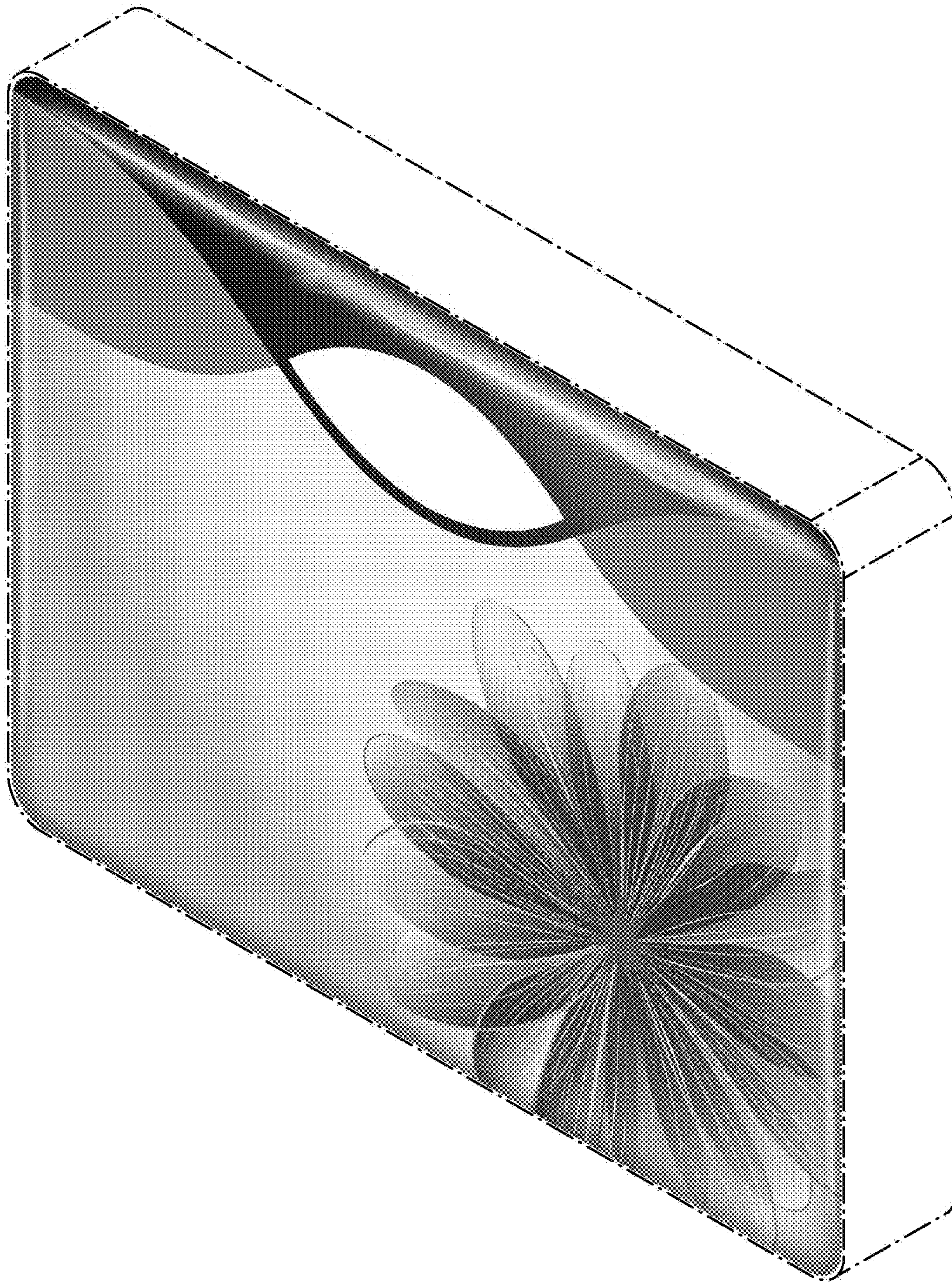

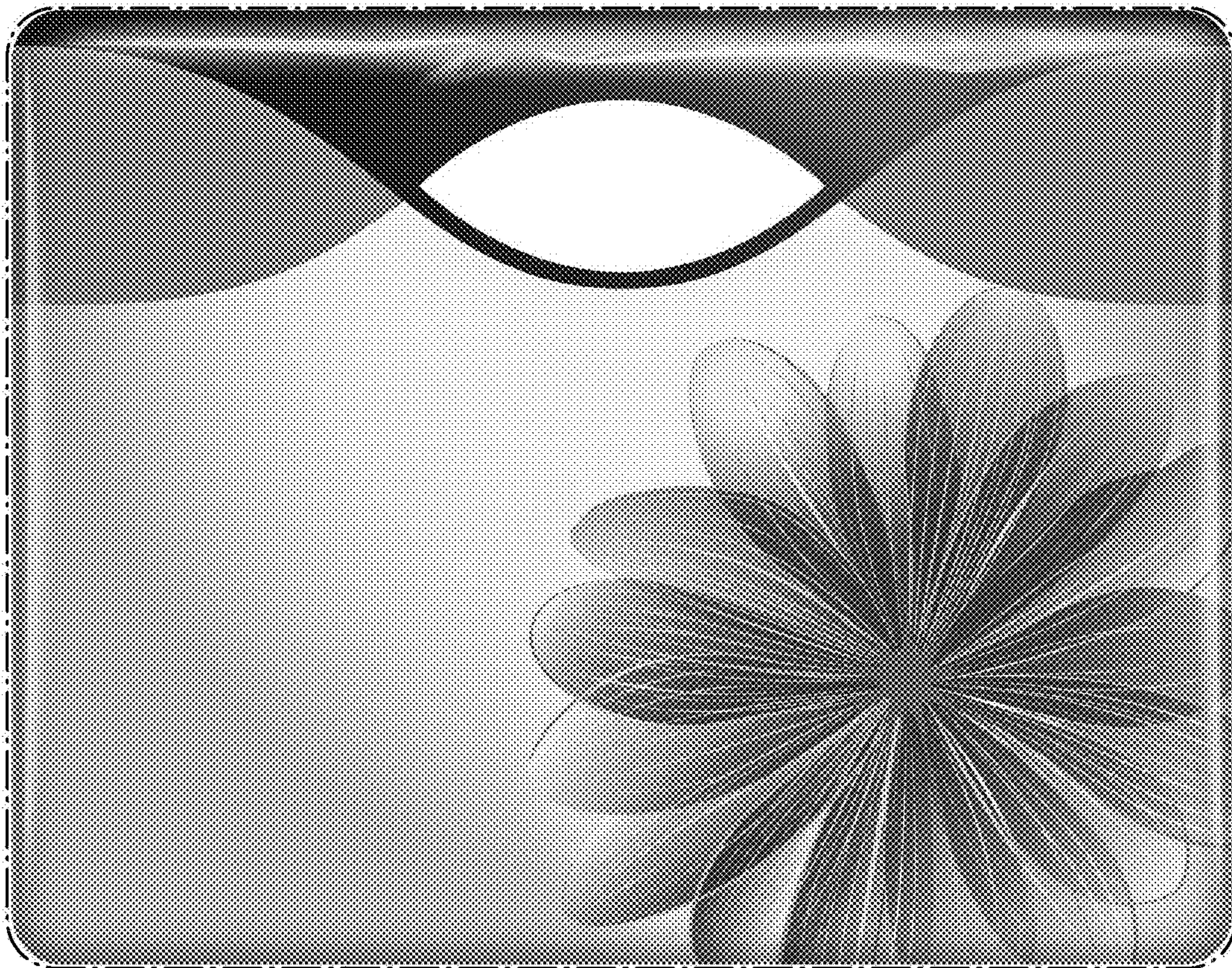

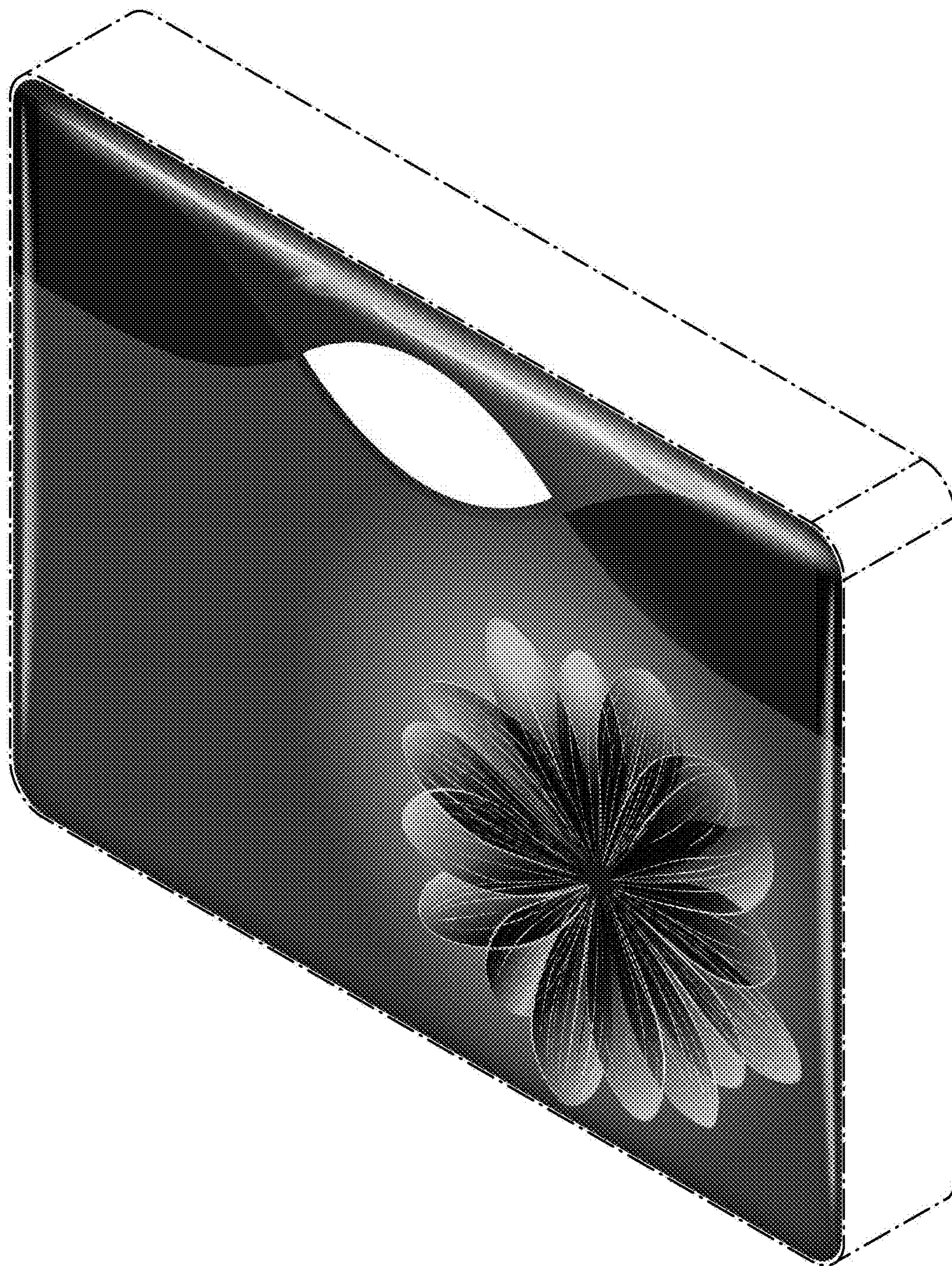

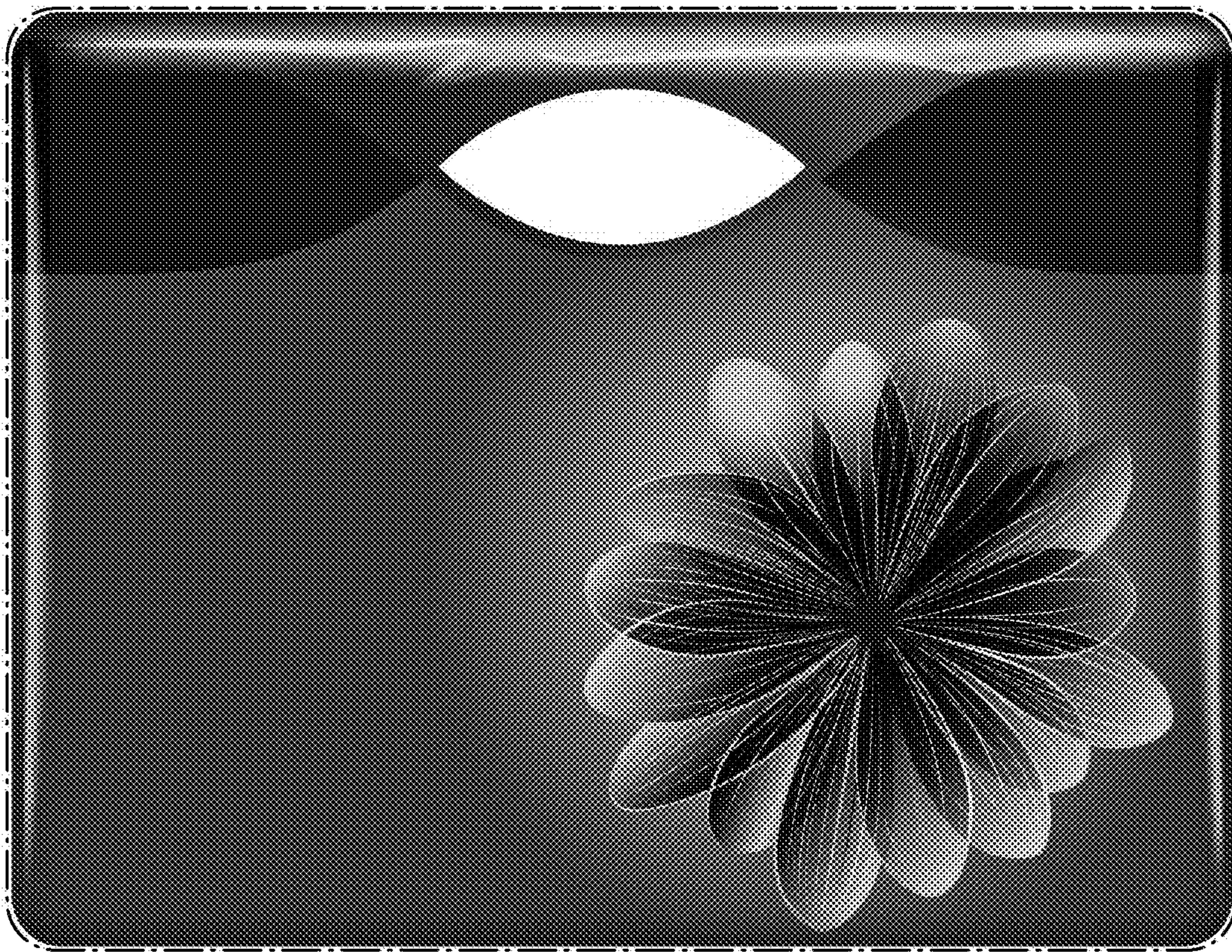
