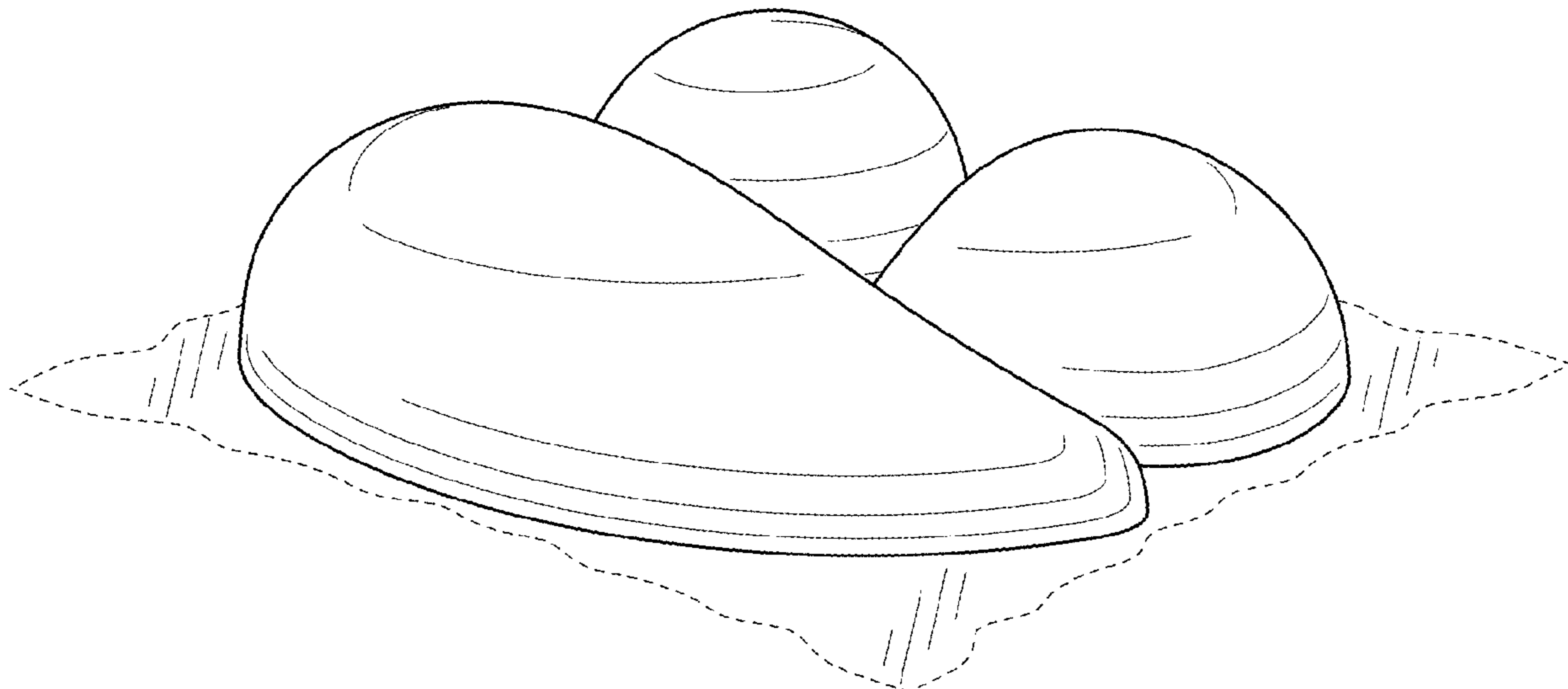
(57) **CLAIM**

The ornamental design for a pouch and cleaning composition, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, right perspective view of a pouch and cleaning composition showing our new design;
FIG. 2 is a right side view thereof;
FIG. 3 is a left side view thereof;
FIG. 4 is a rear view thereof;
FIG. 5 is a front view thereof;
FIG. 6 is a top view thereof; and,
FIG. 7 is a bottom view thereof.

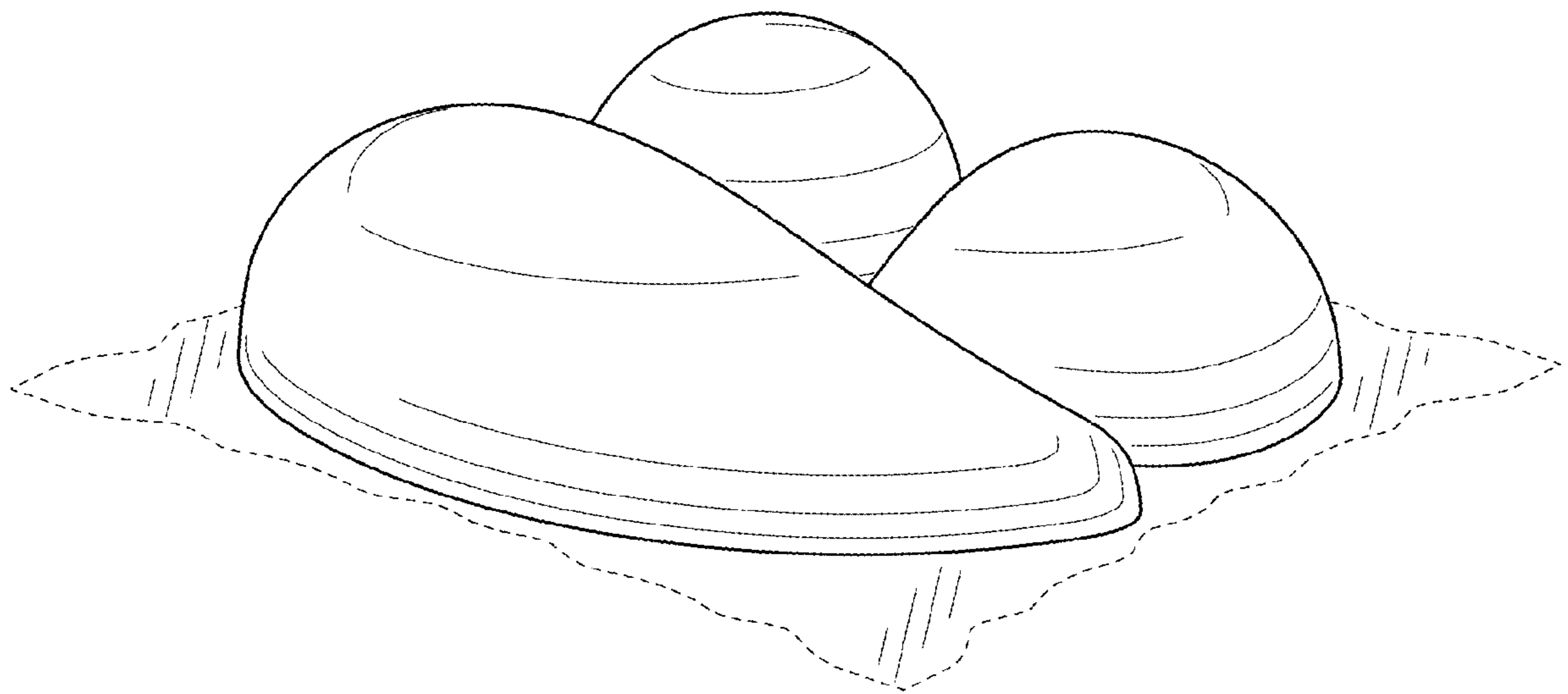

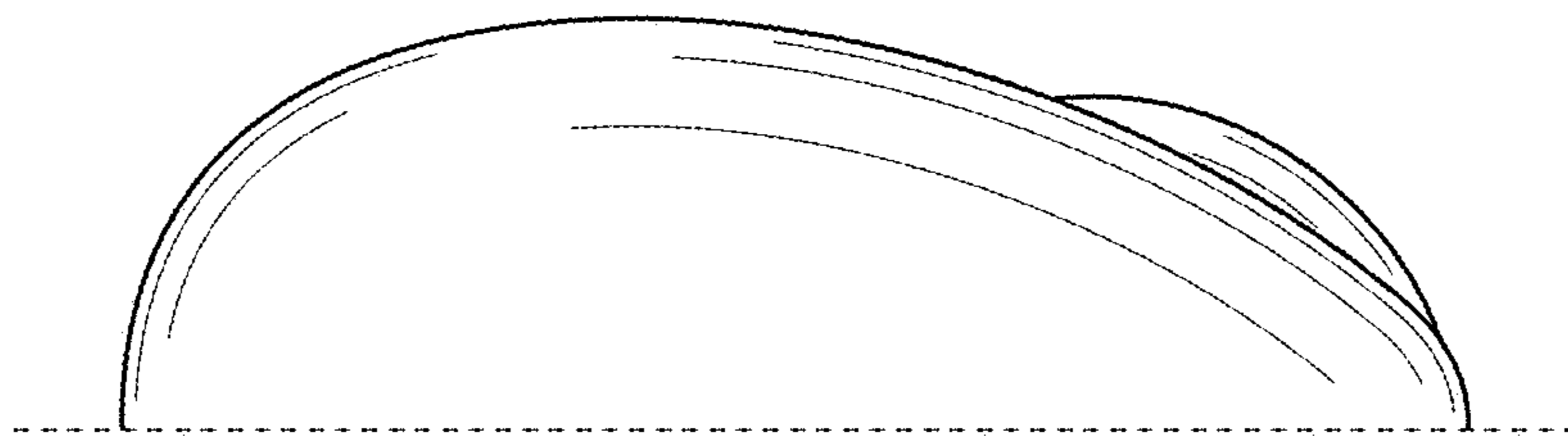

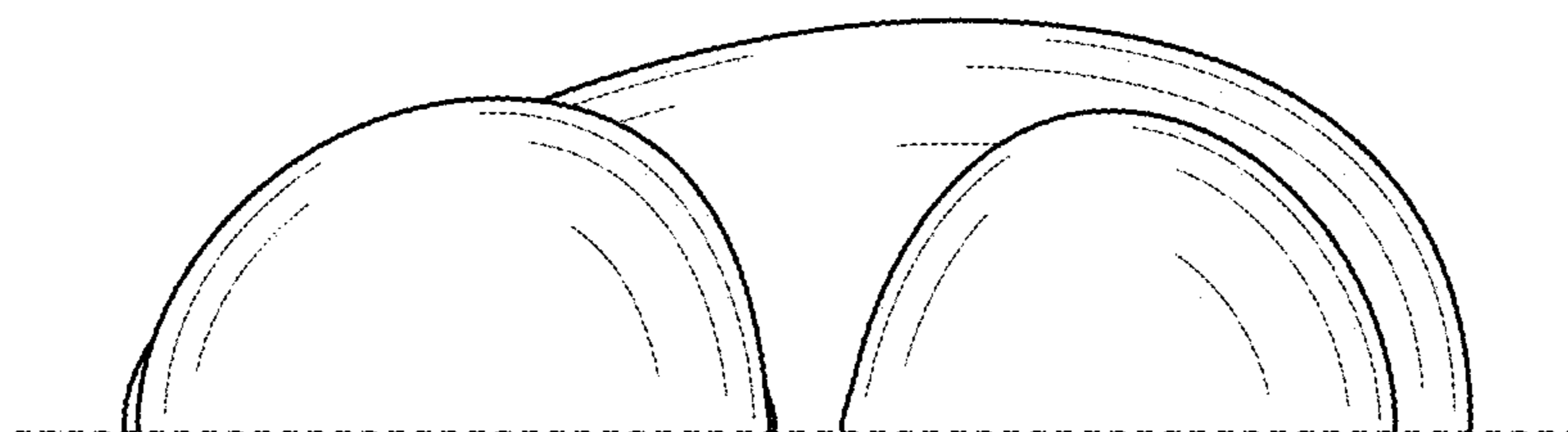

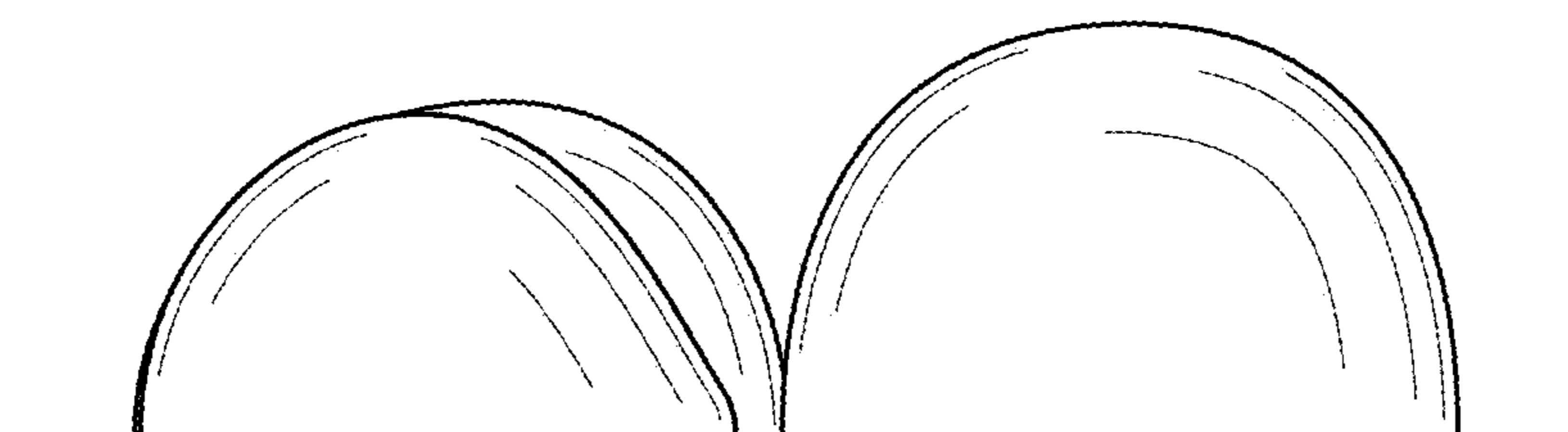

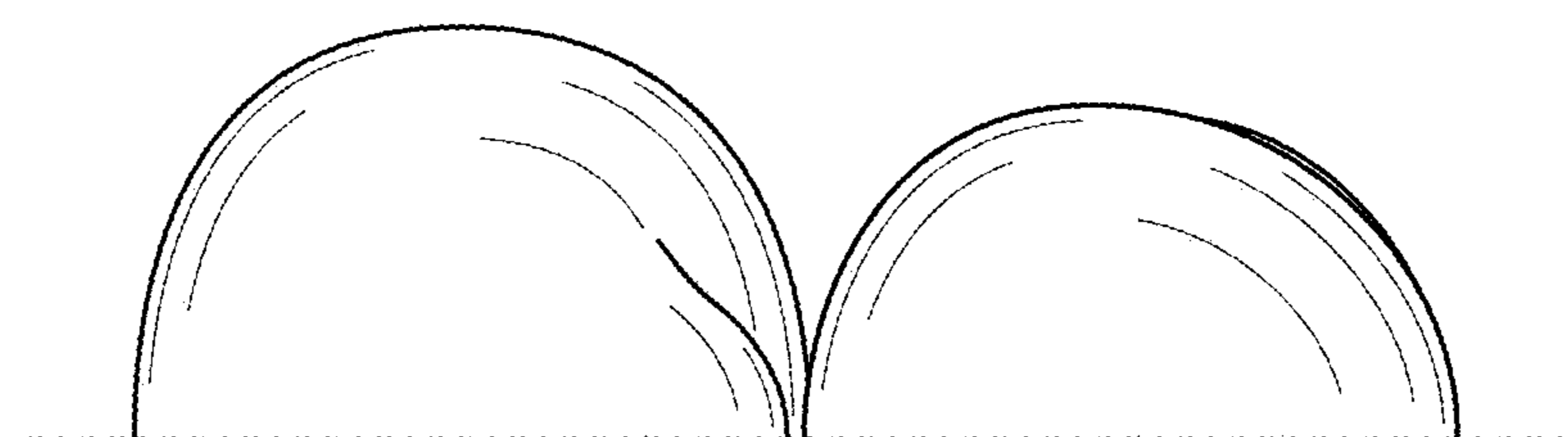

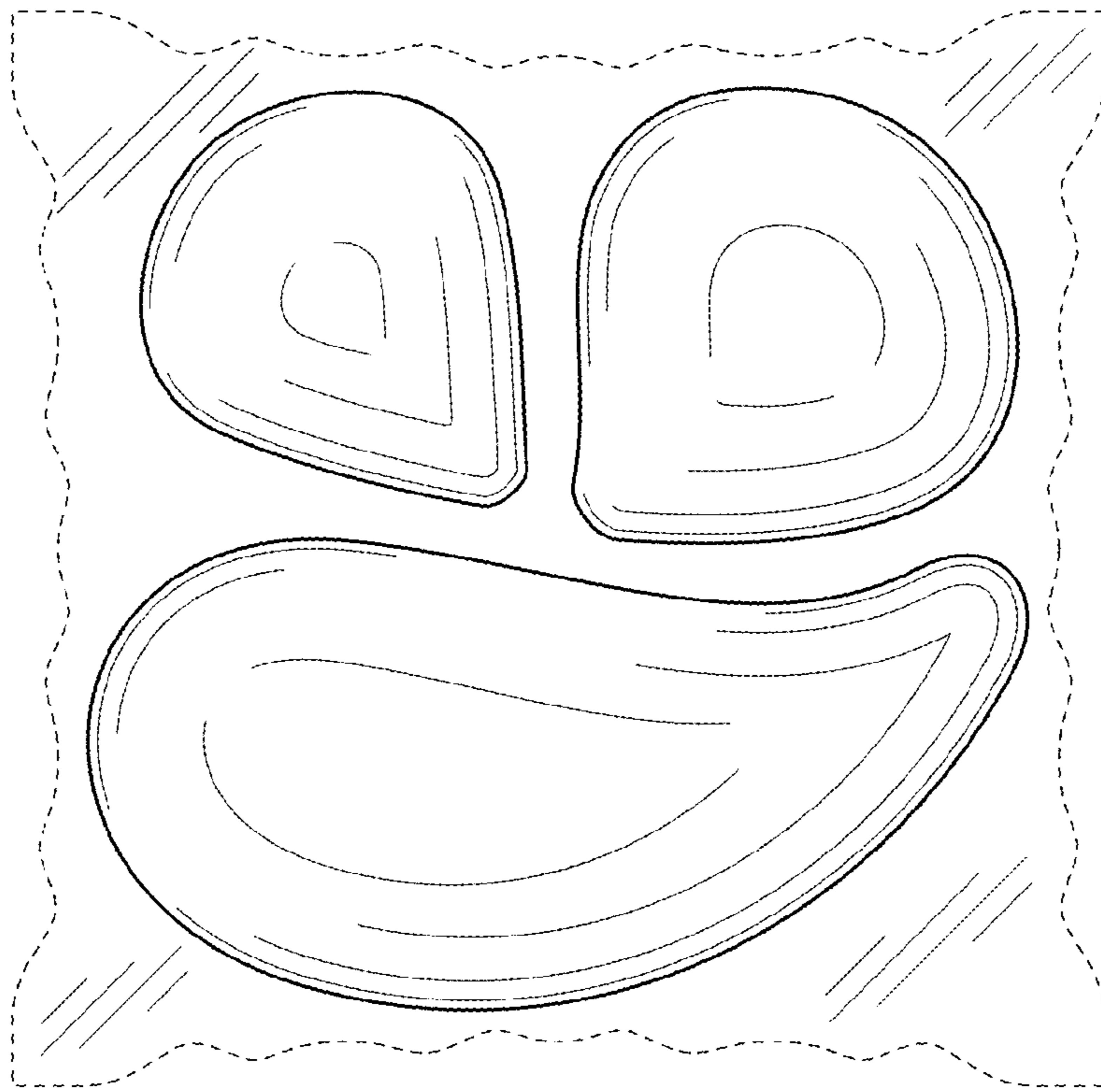

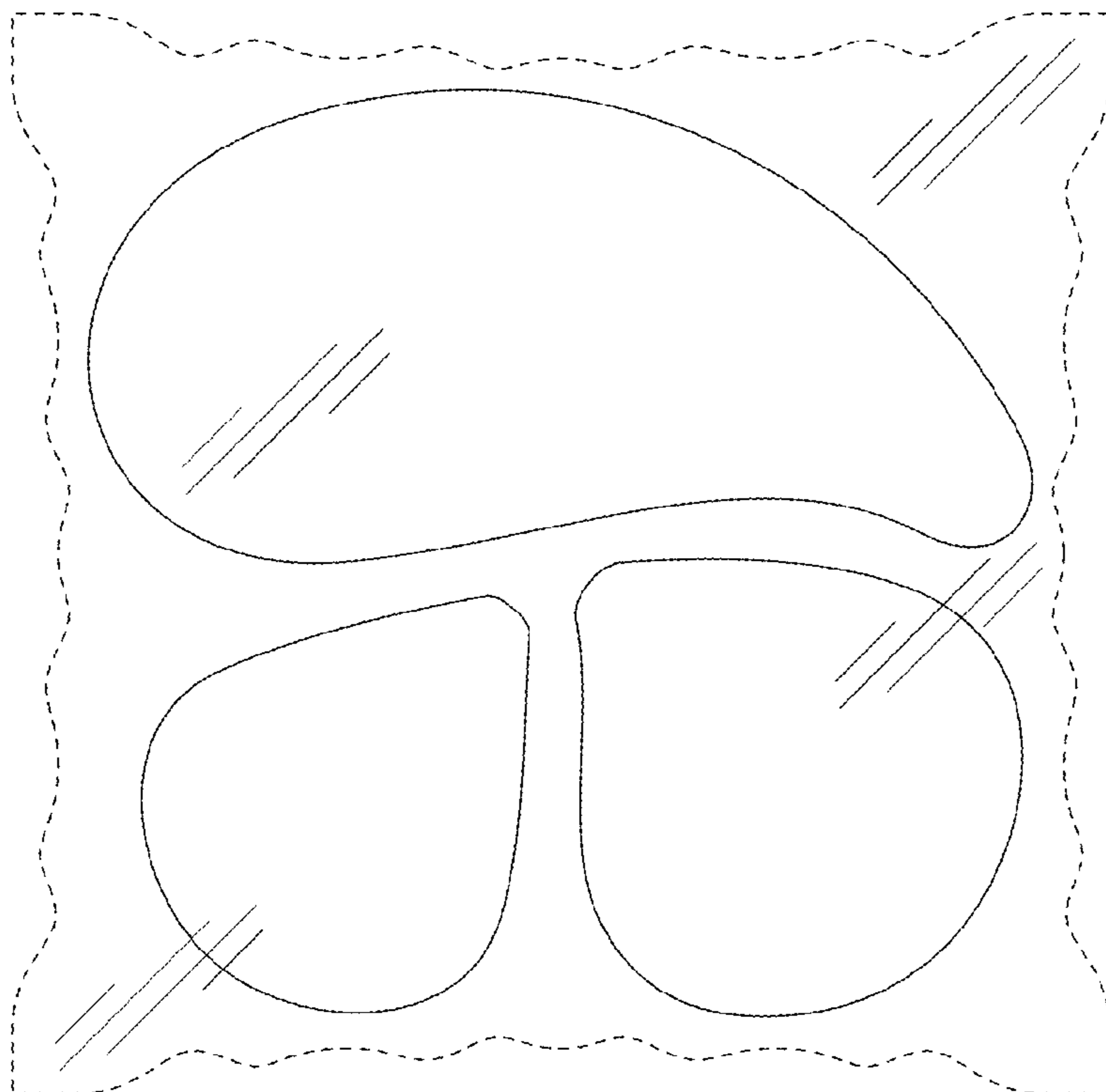
