(57) **CLAIM**

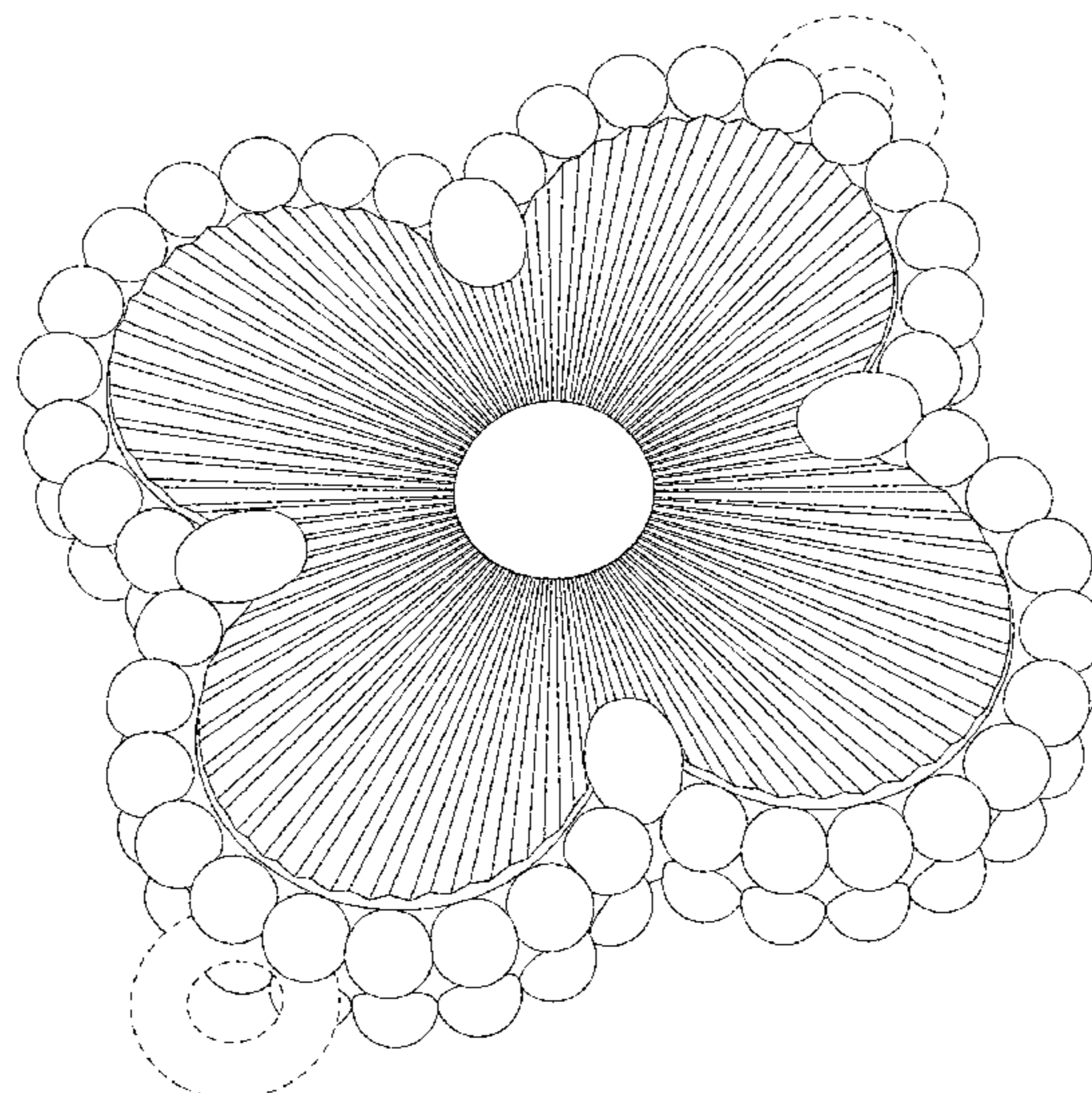
The ornamental design for a decorative element for jewelry,

**DESCRIPTION**

FIG. 1 is a front elevational view of a decorative element for  
jewelry showing my new design;

FIG. 5 is a left side elevational view thereof;

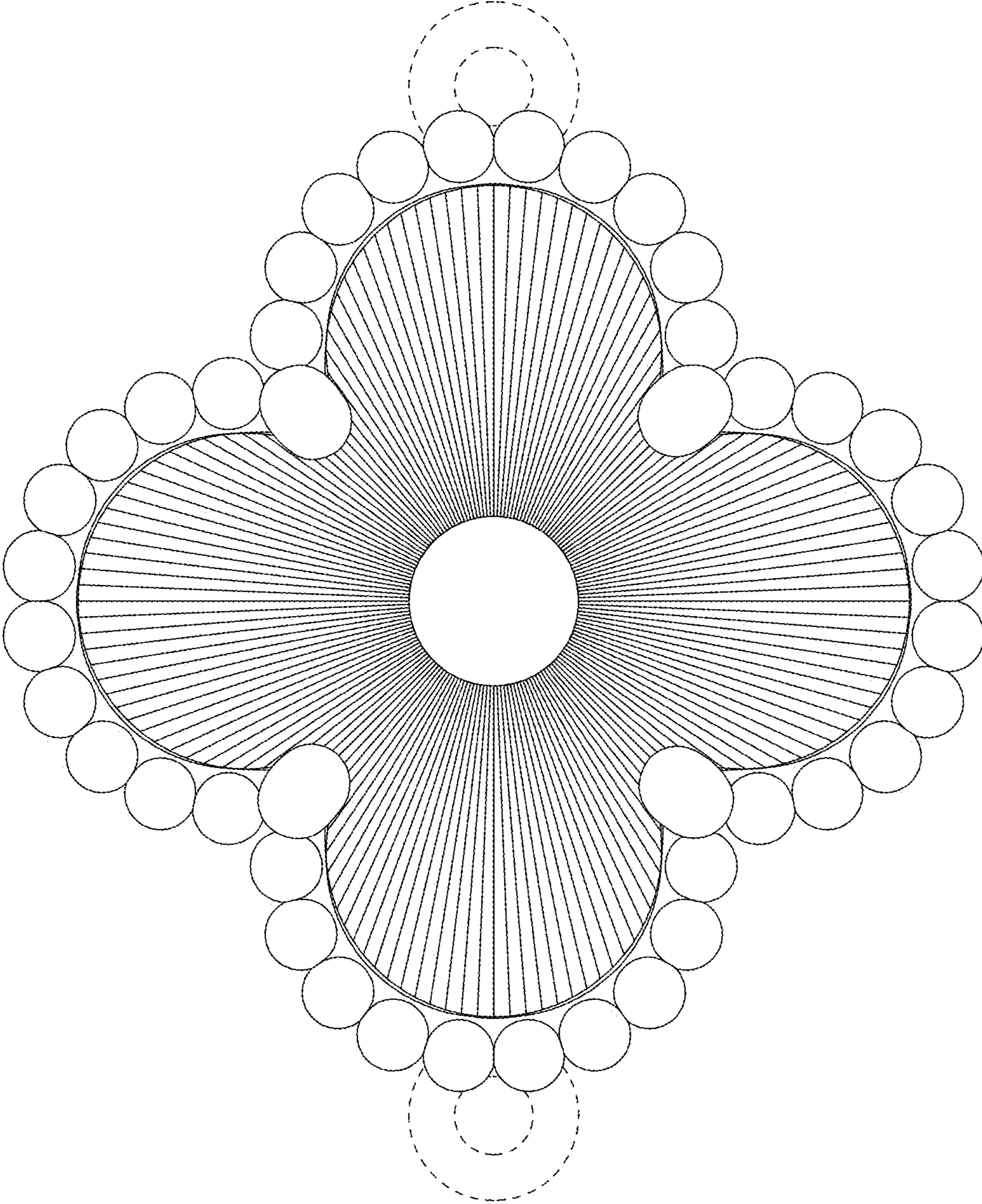

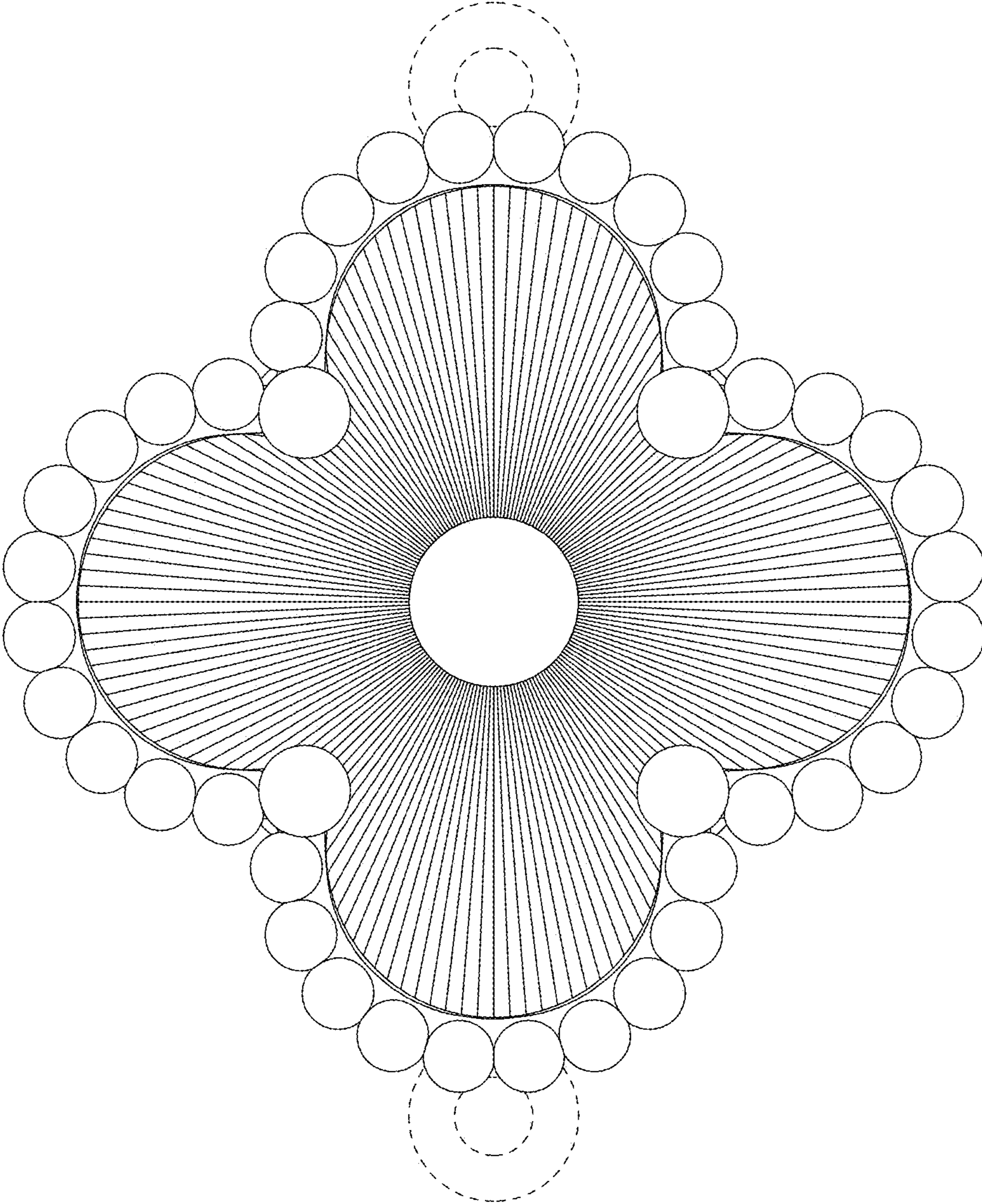

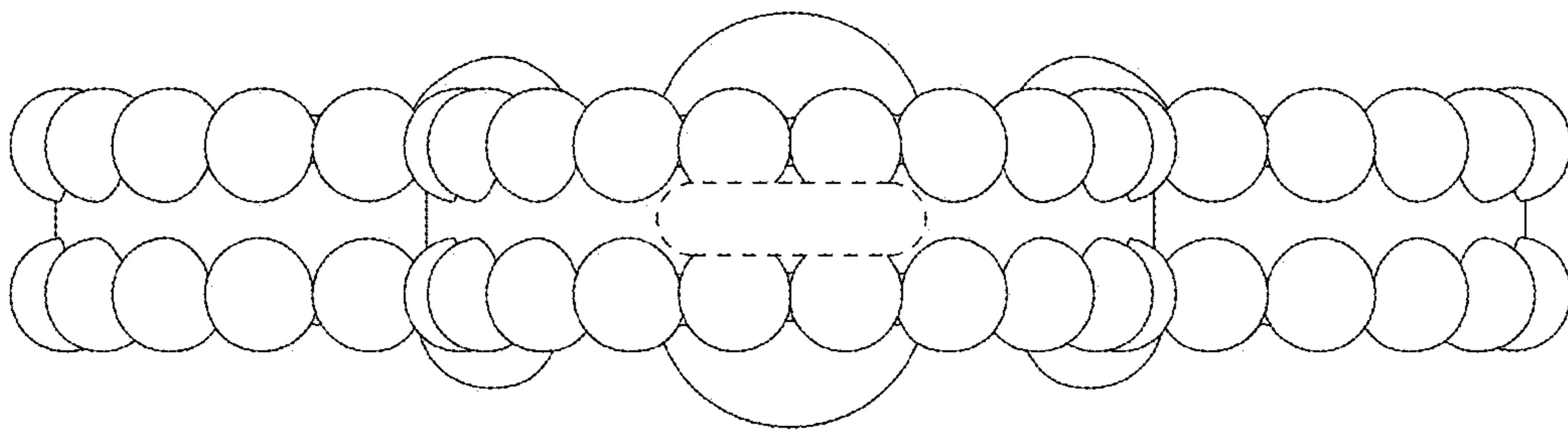

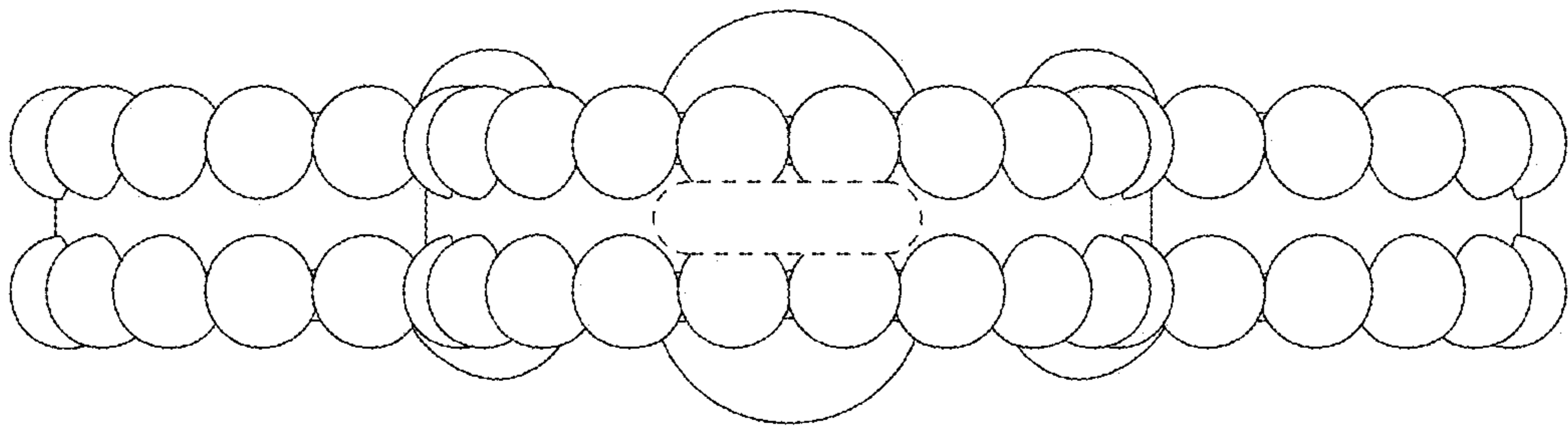

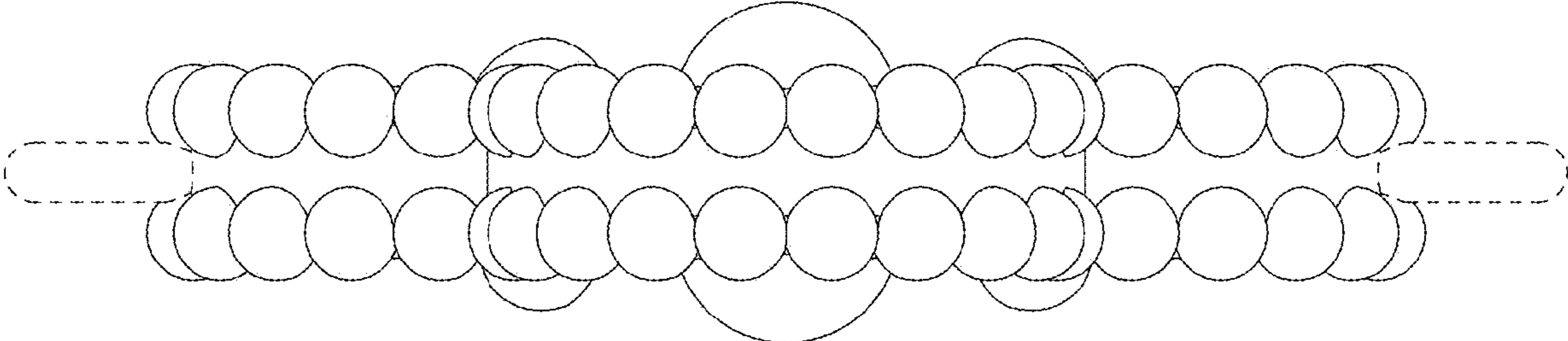

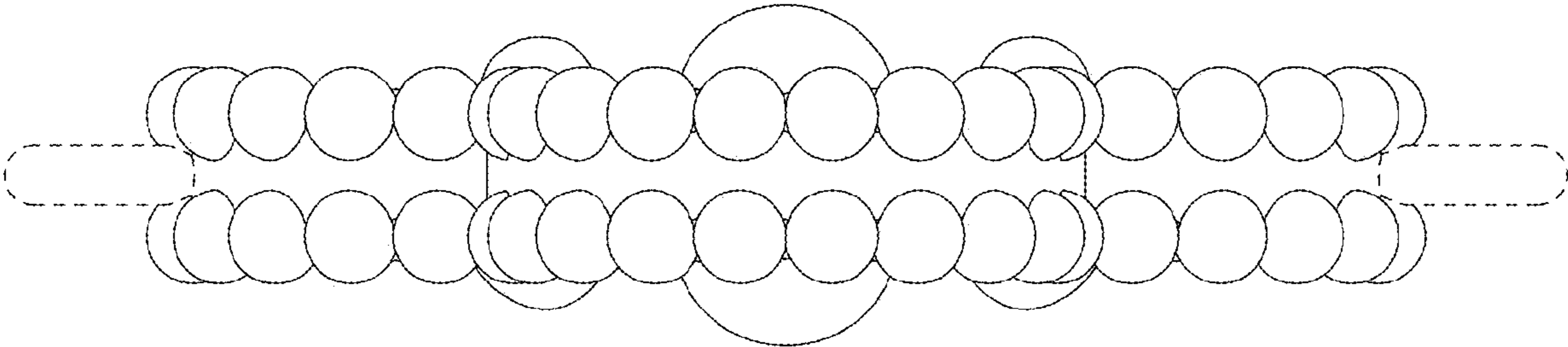

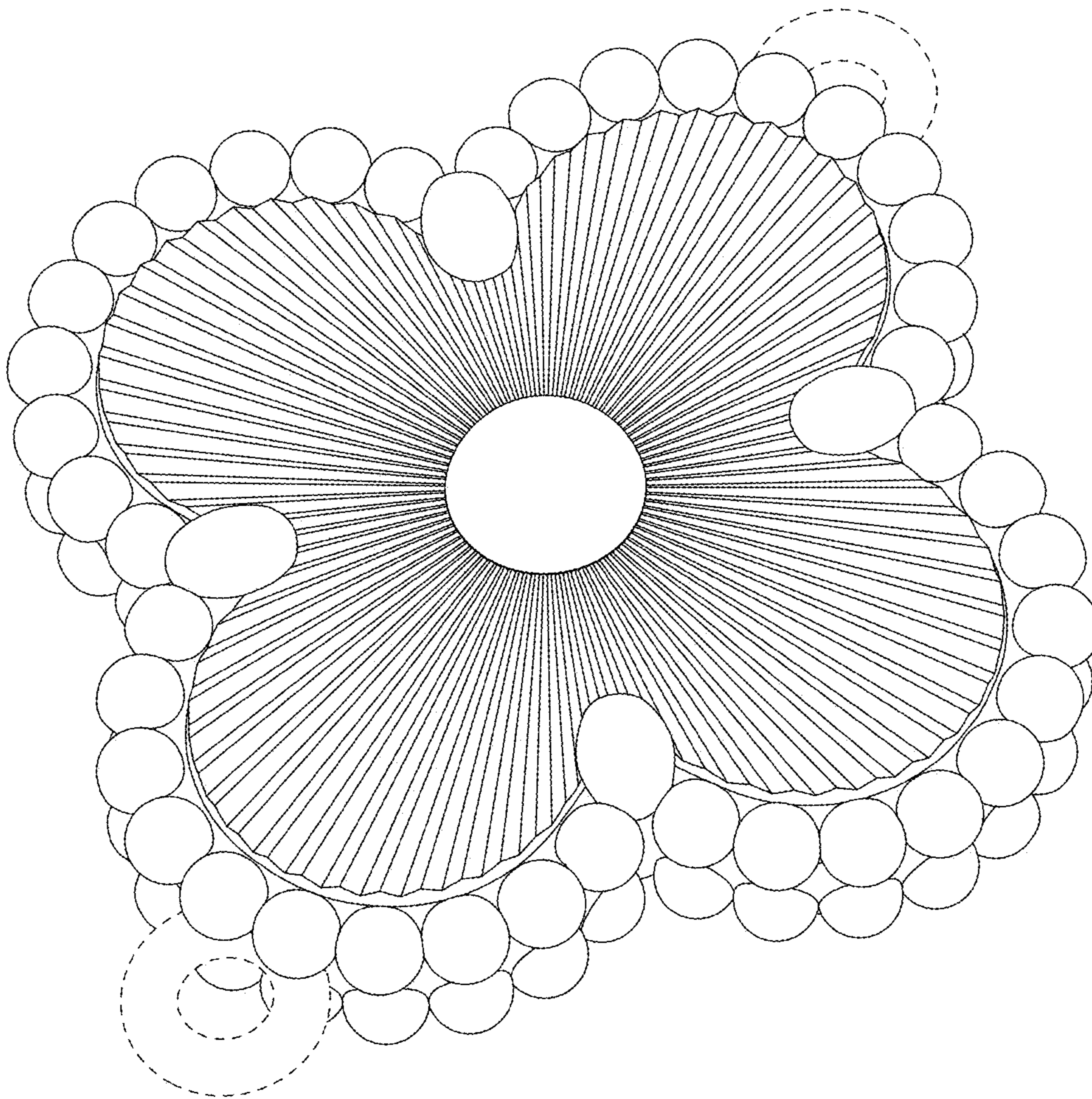

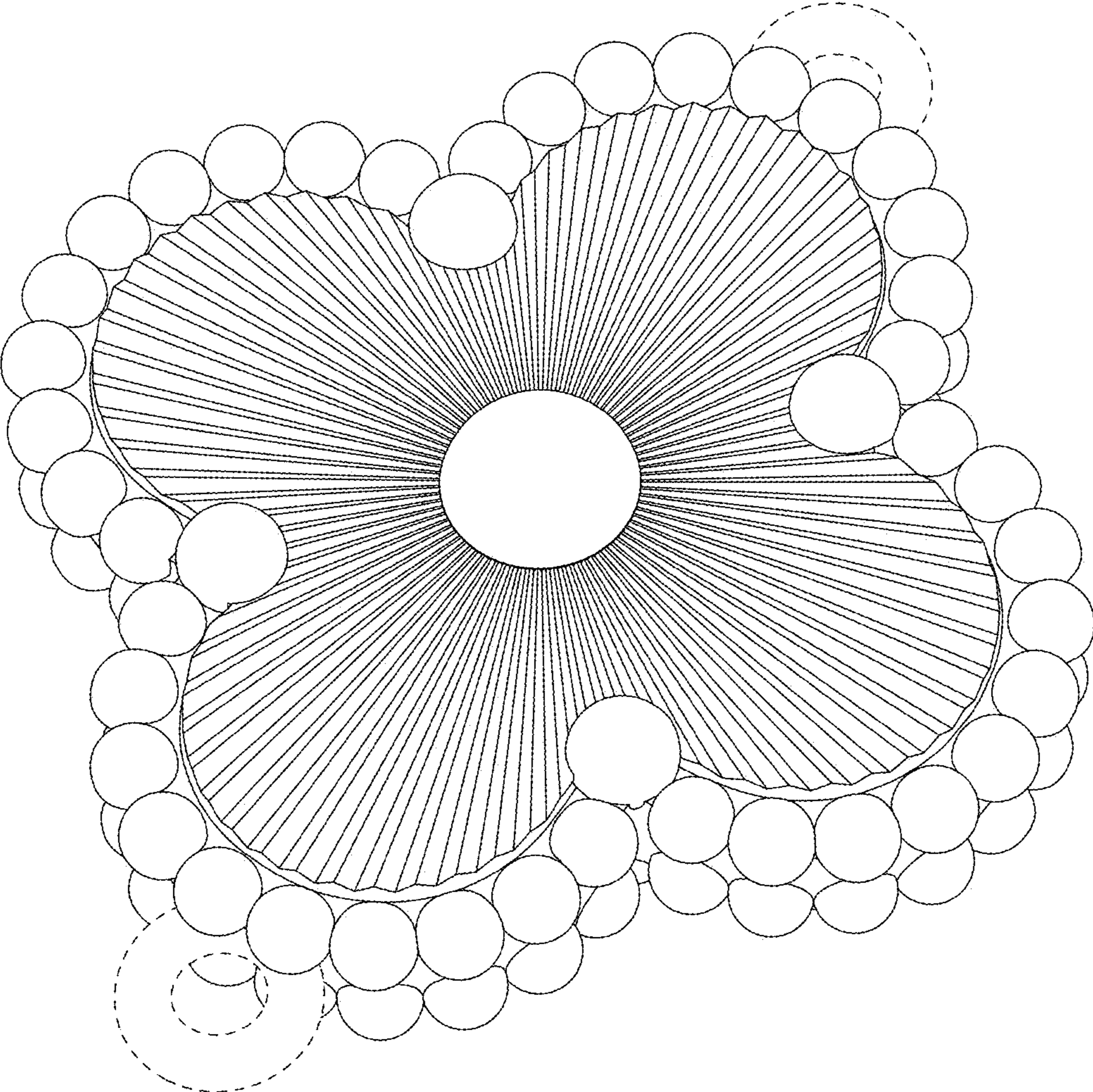
