(57) **CLAIM**

The ornamental design for an edge flap for a wind turbine blade, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of an edge flap for a wind turbine blade showing our new design; FIG. 2 is a rear elevational view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a bottom plan view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a left side elevational view thereof; and, FIG. 7 is rear, left side perspective view thereof. The broken lines shown represent the portions of the edge flap for a wind turbine blade that form no part of the claimed design.

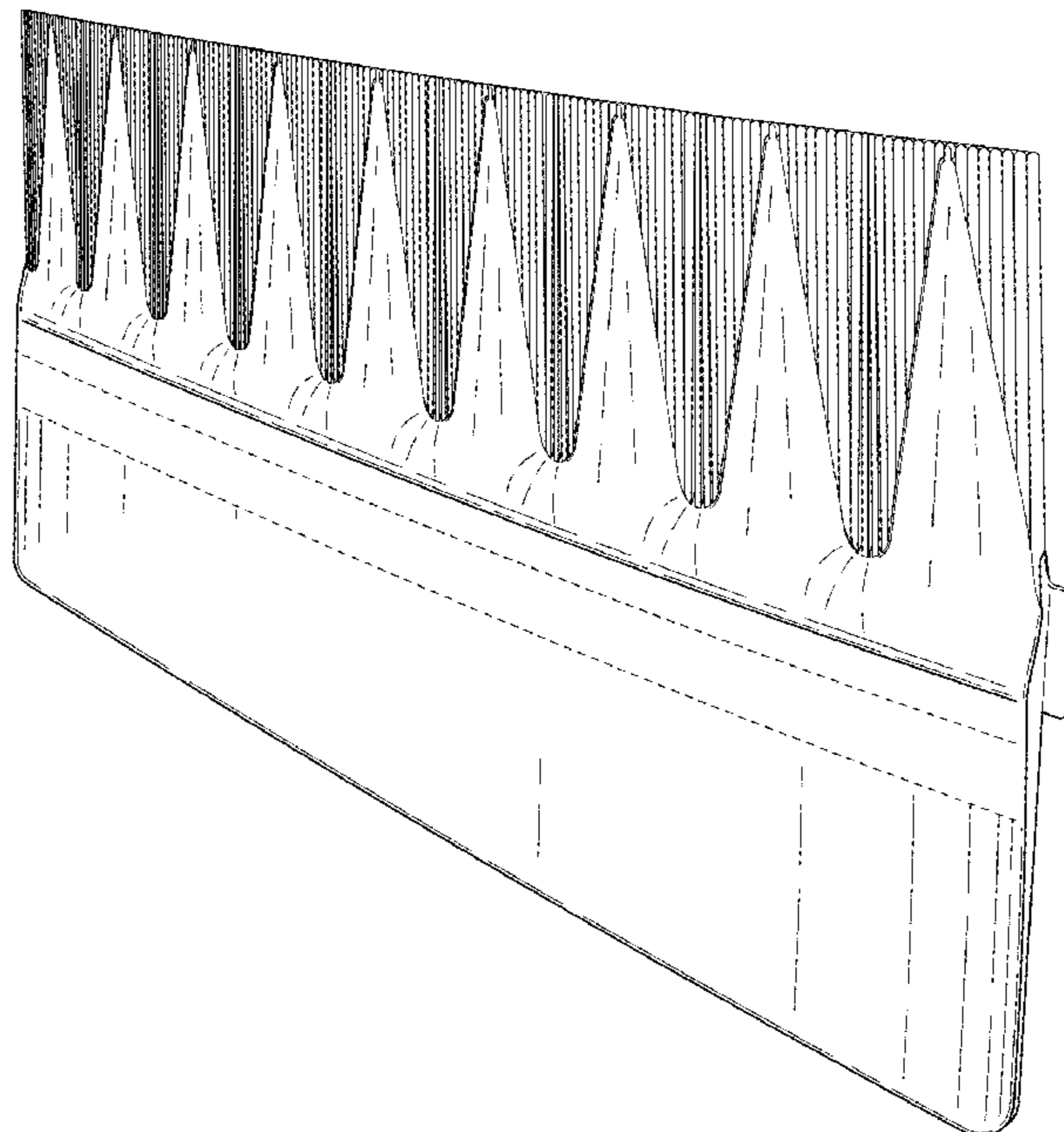

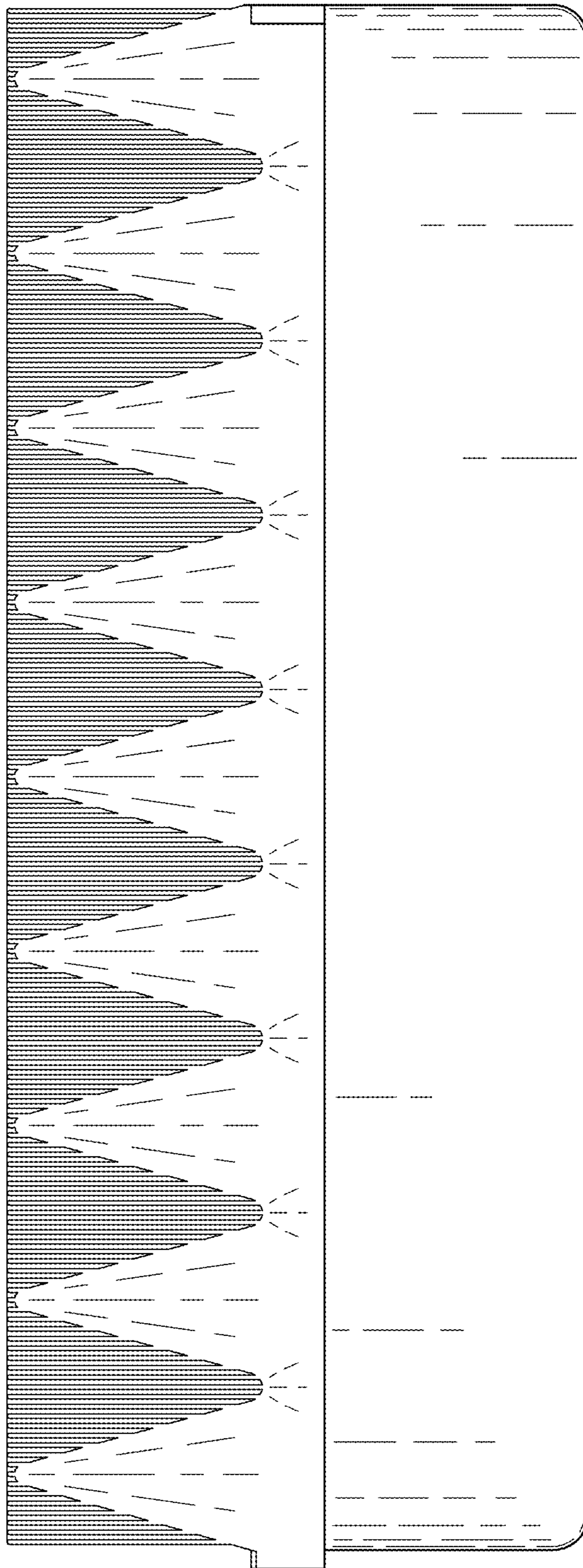

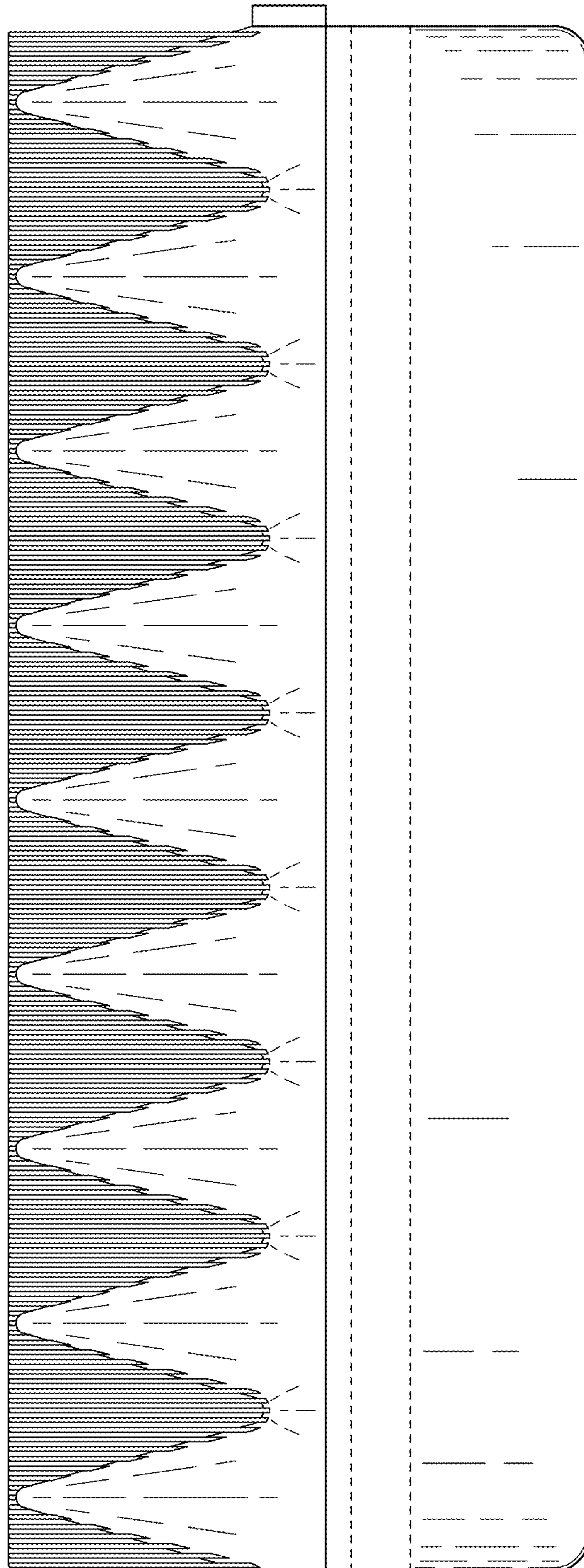

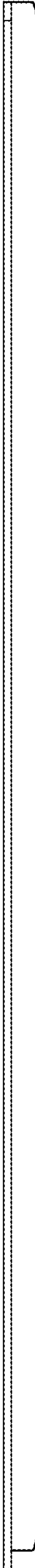

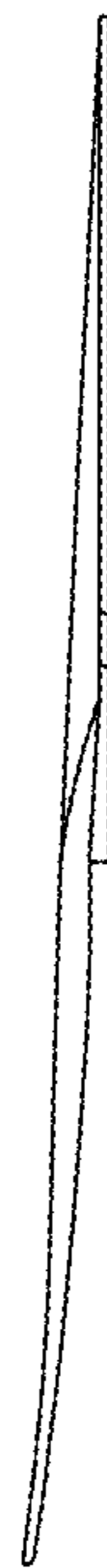
