FIG. 5 is a left side view of the laminating cartridge of FIG. 1.

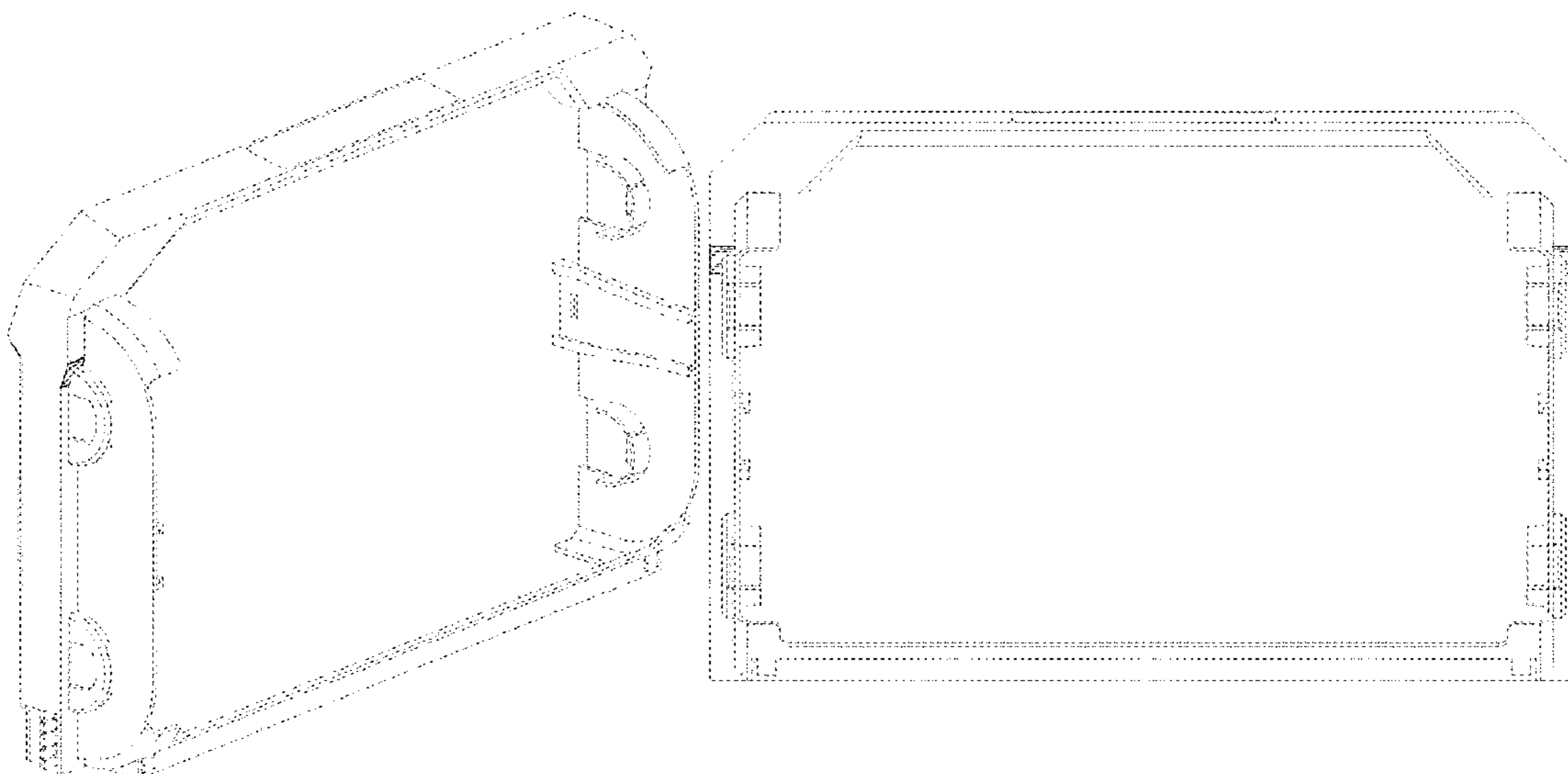
FIG. 6 is a top view of the laminating cartridge of FIG. 1;

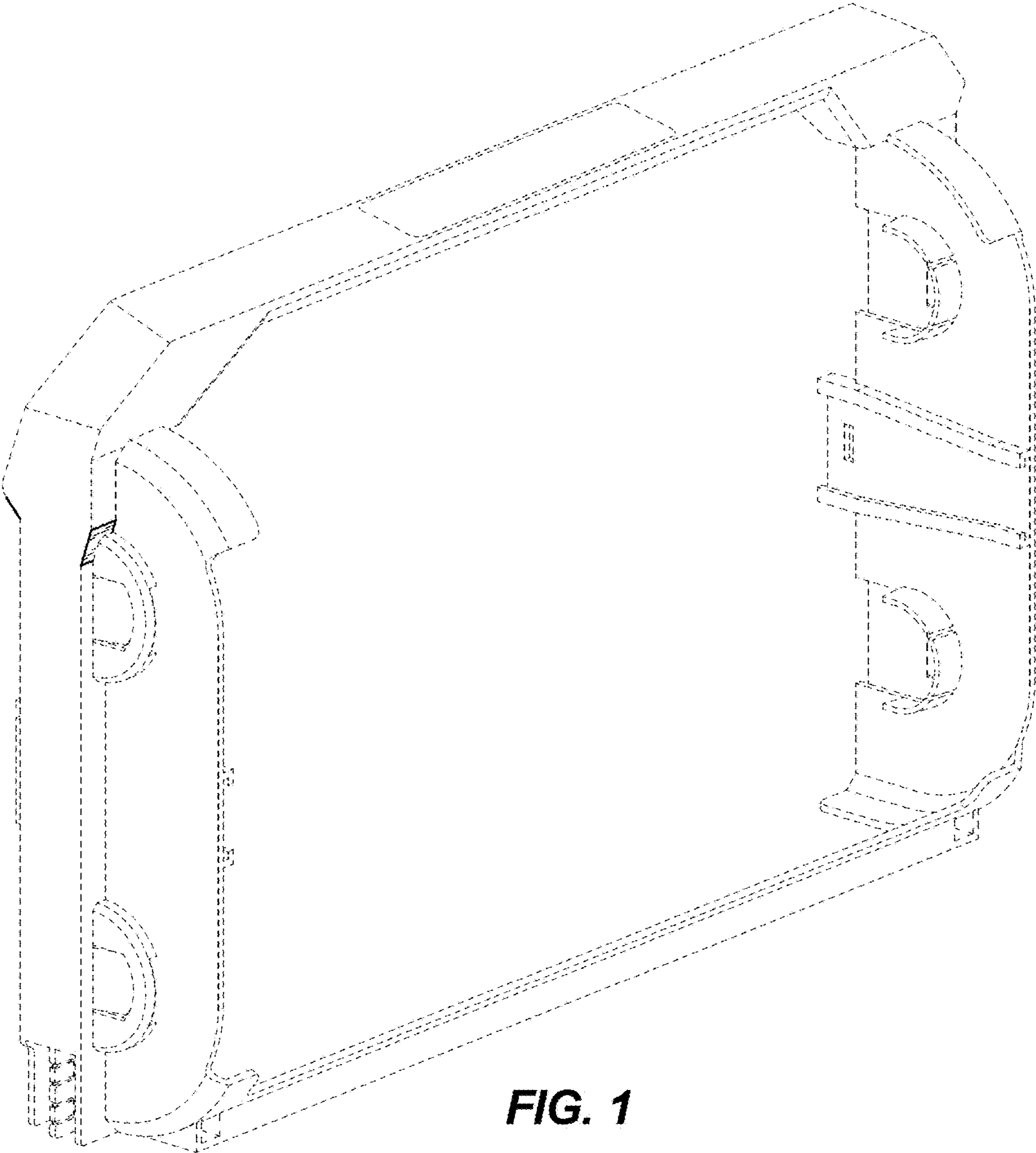

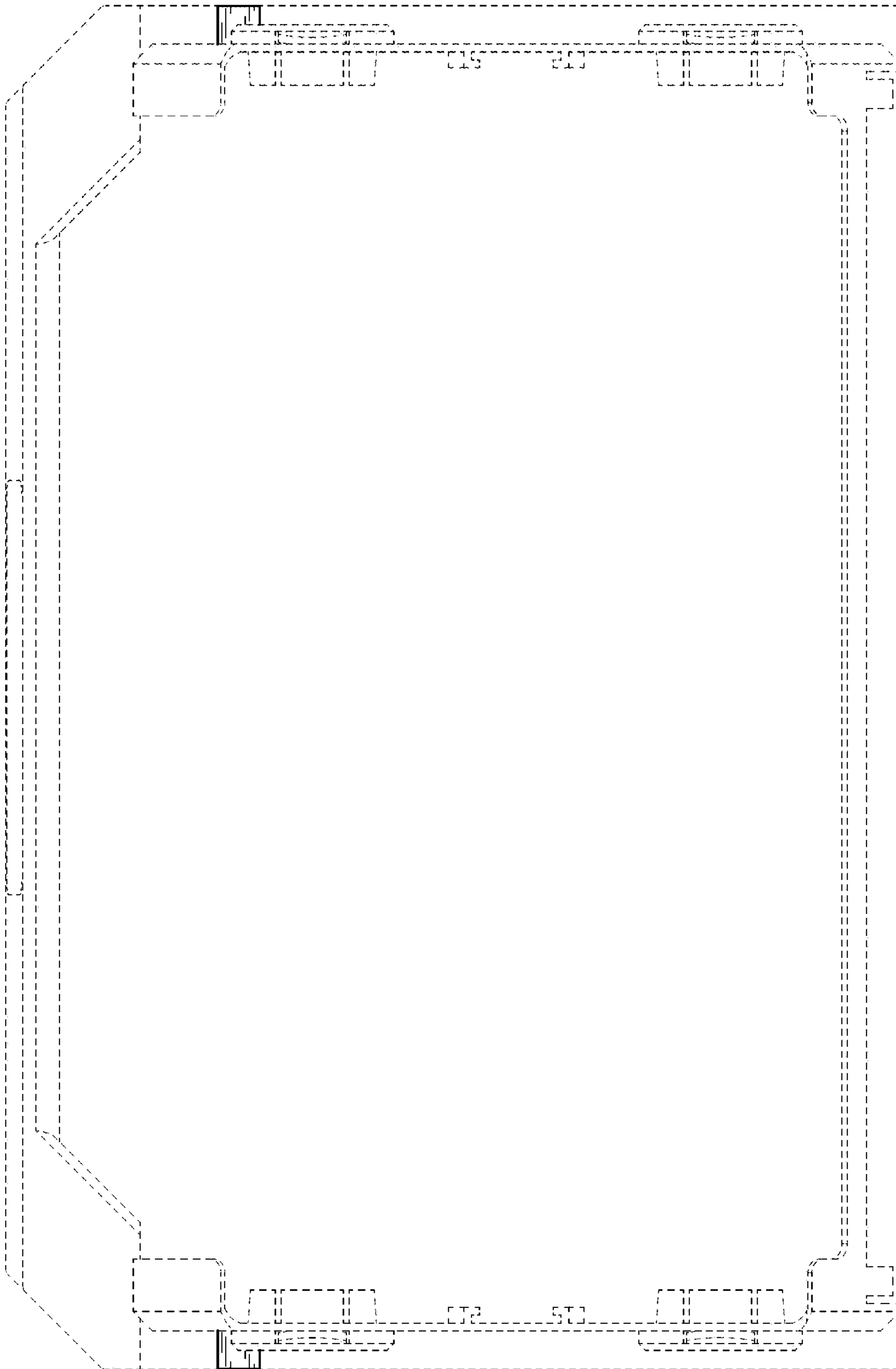

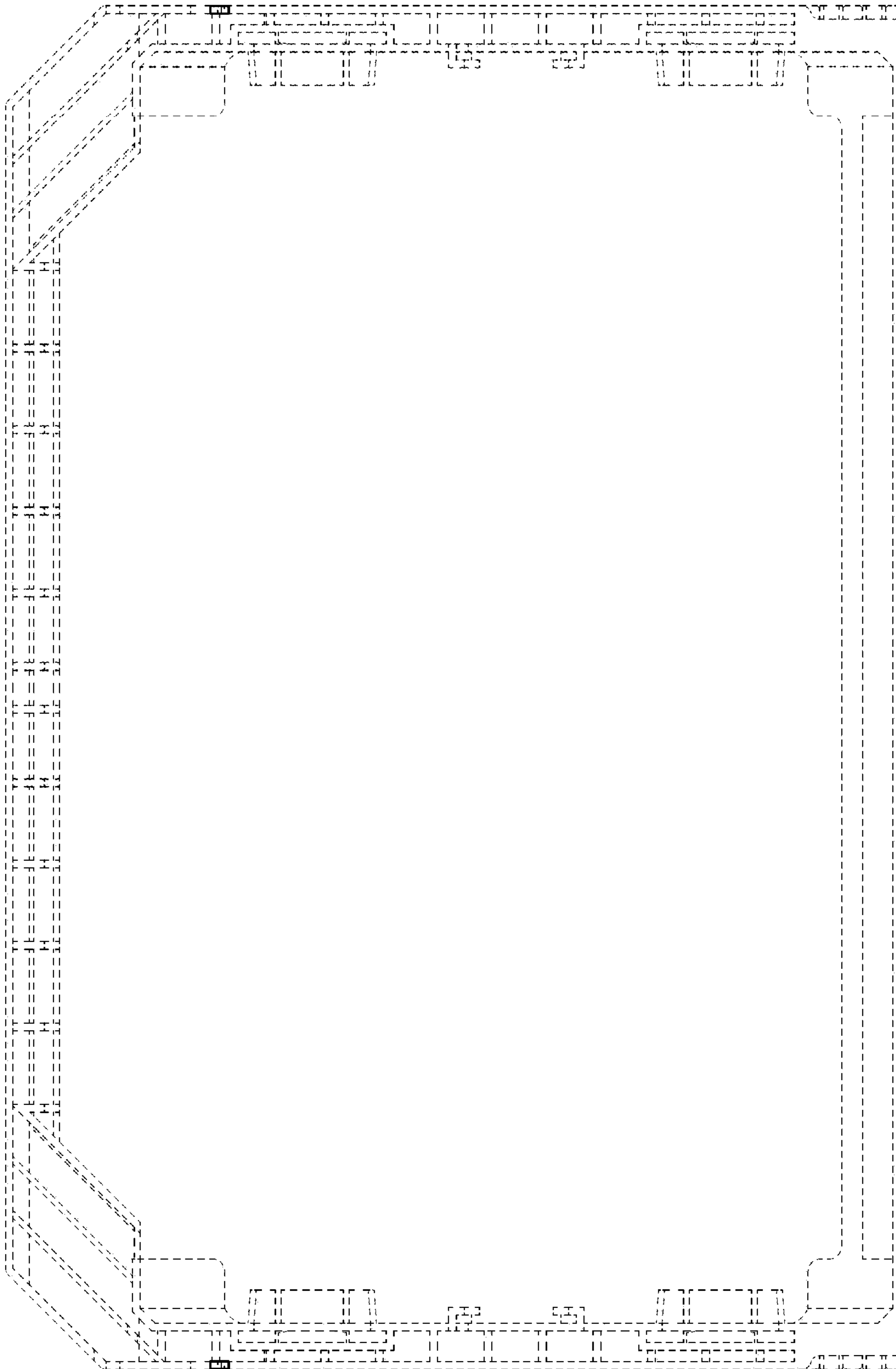

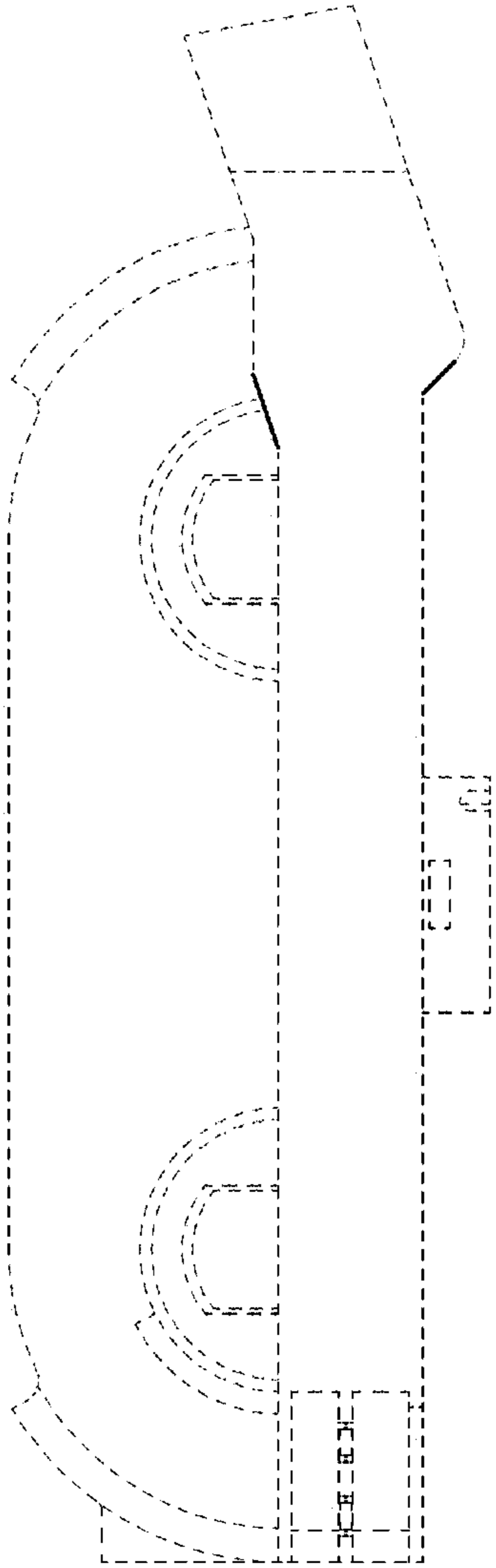

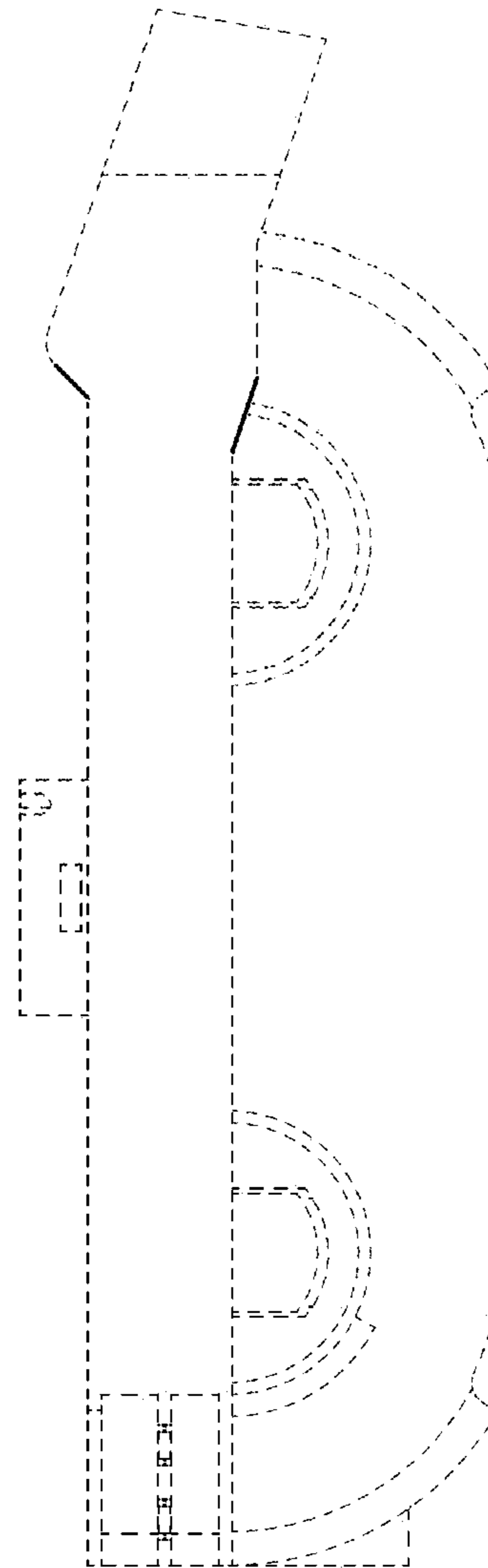

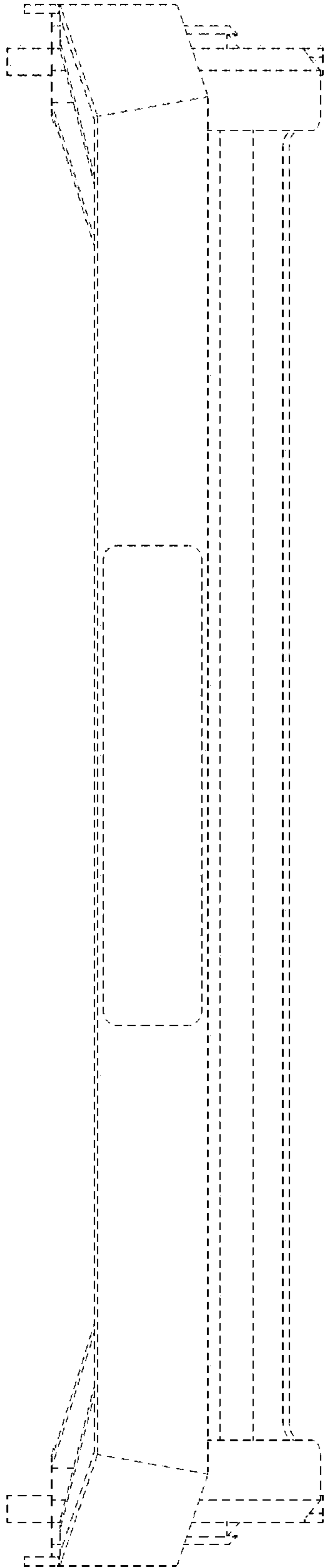

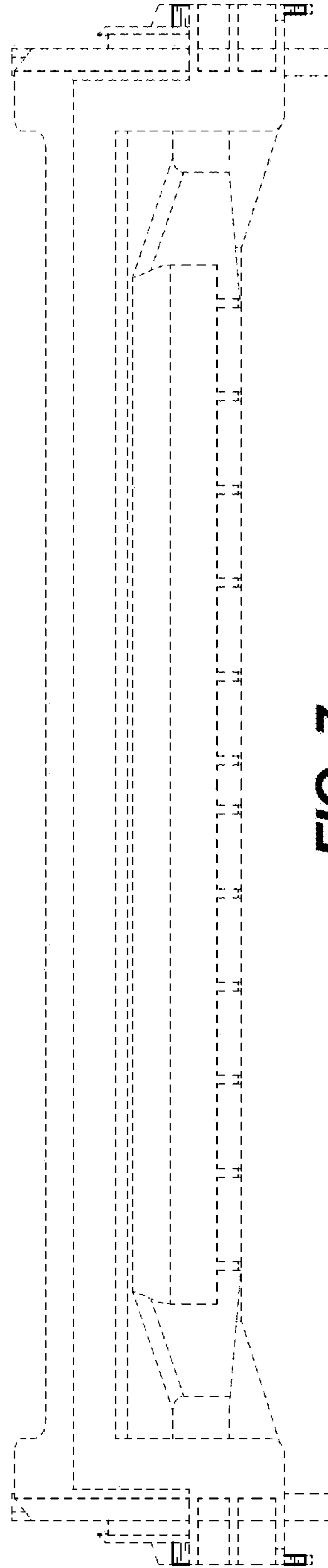
