**DESCRIPTION**

The broken lines in the figures are shown for the purpose of illustrating portions of the goggles that form no part of the claimed design.

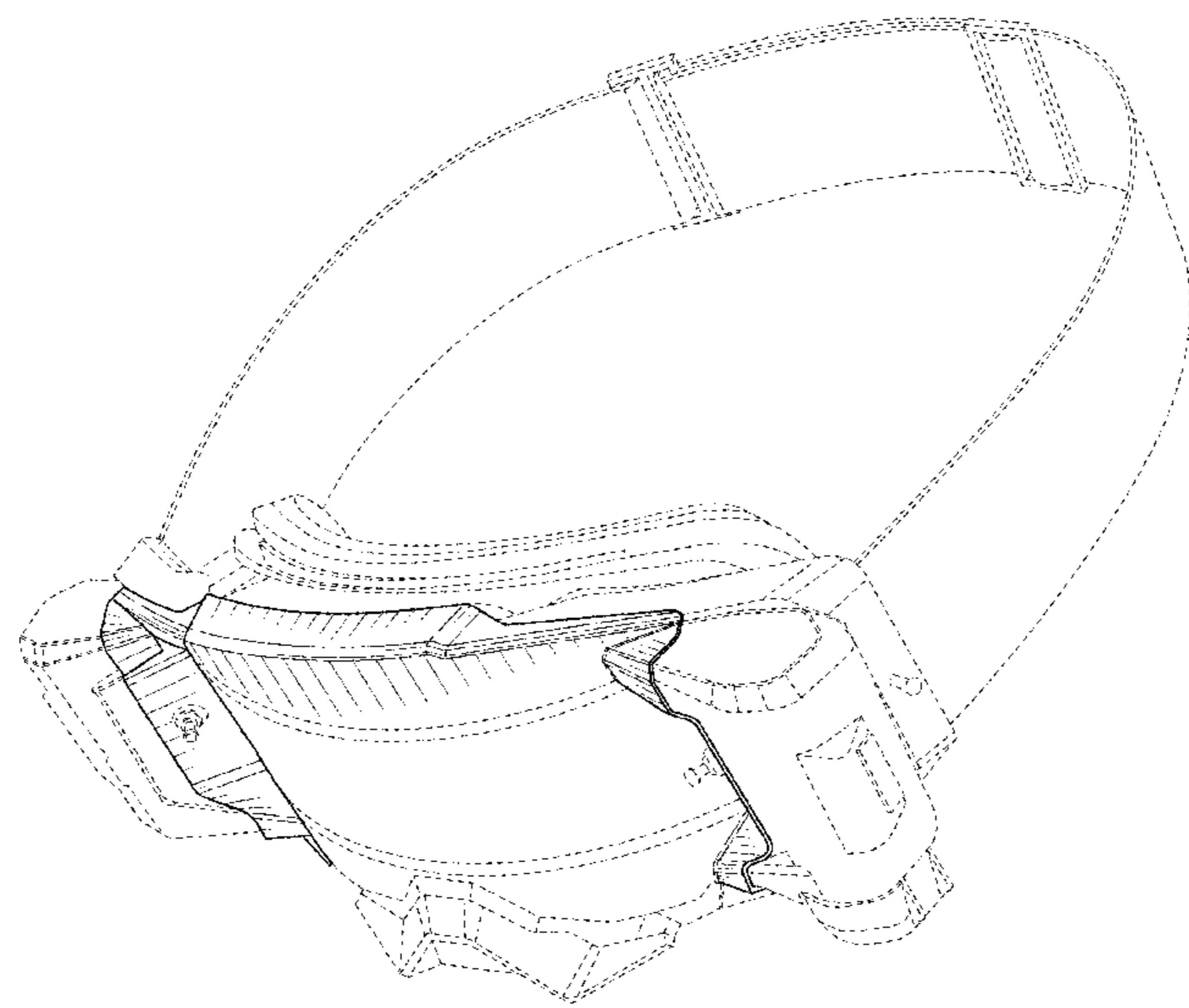

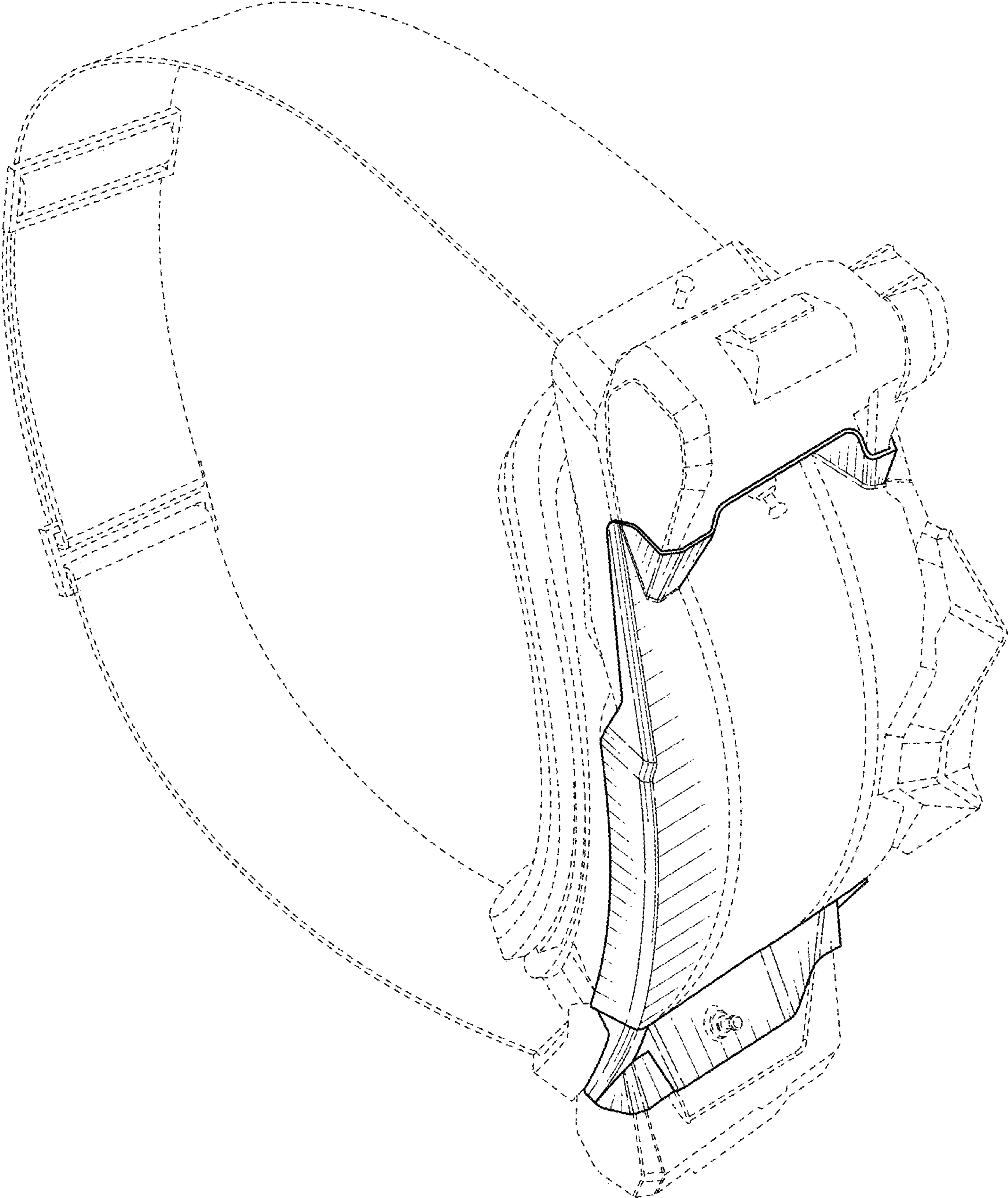

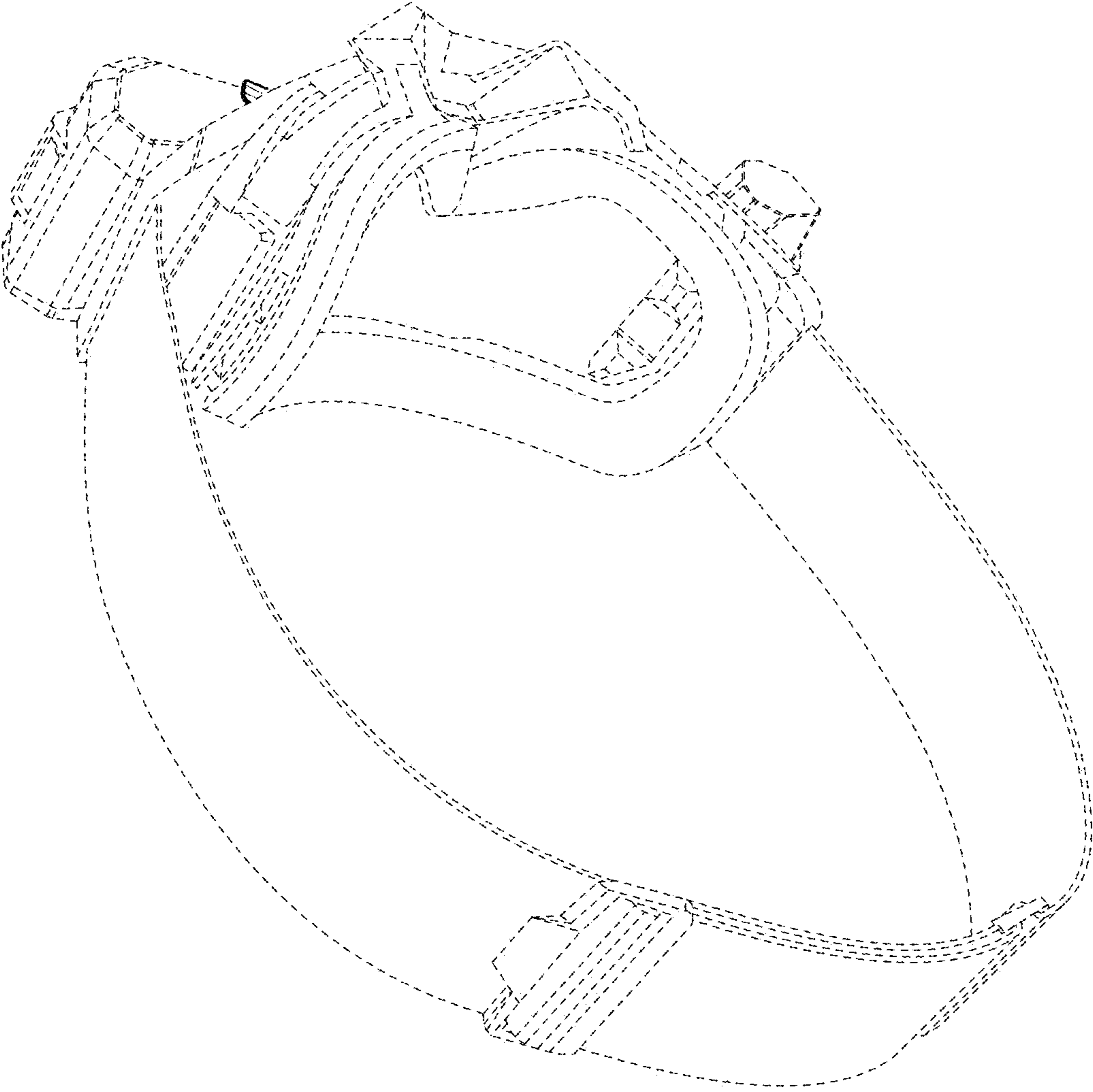

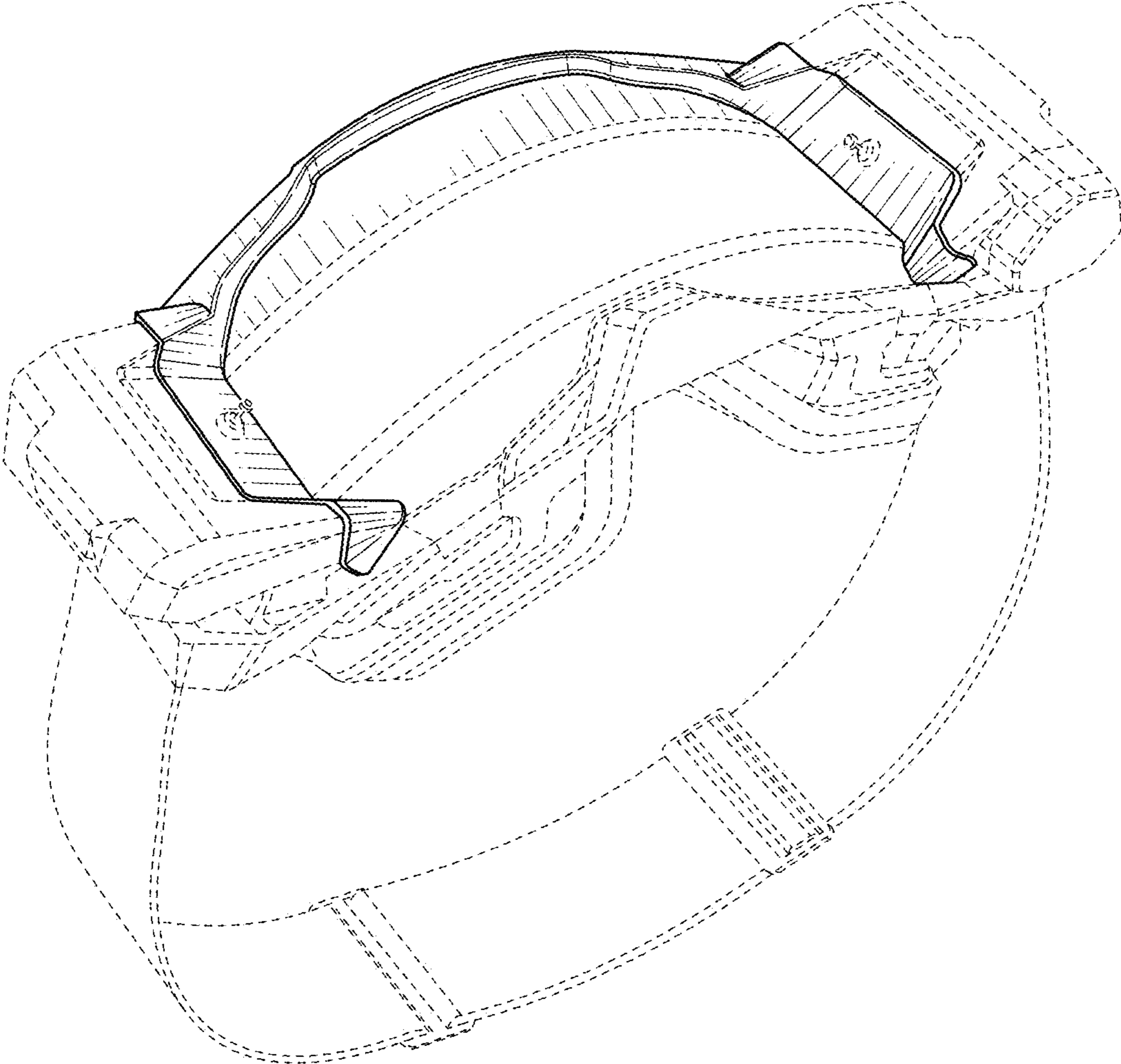

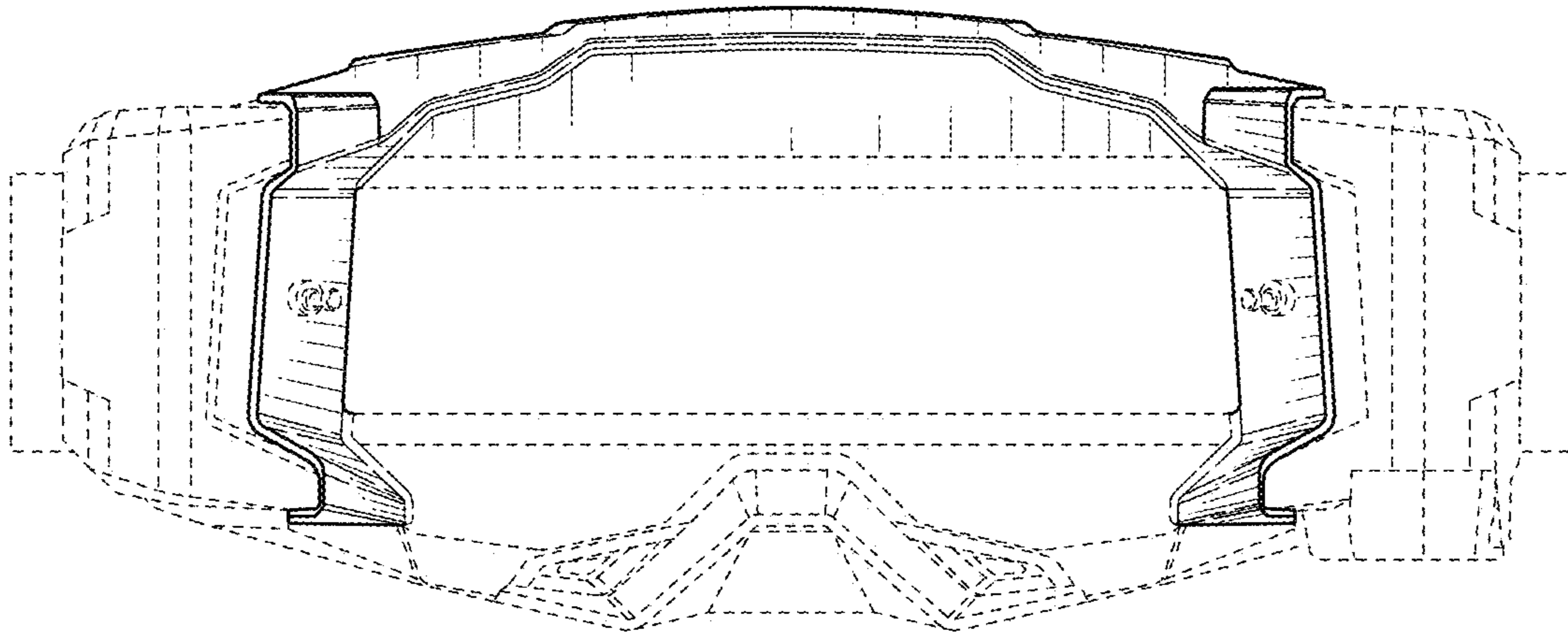

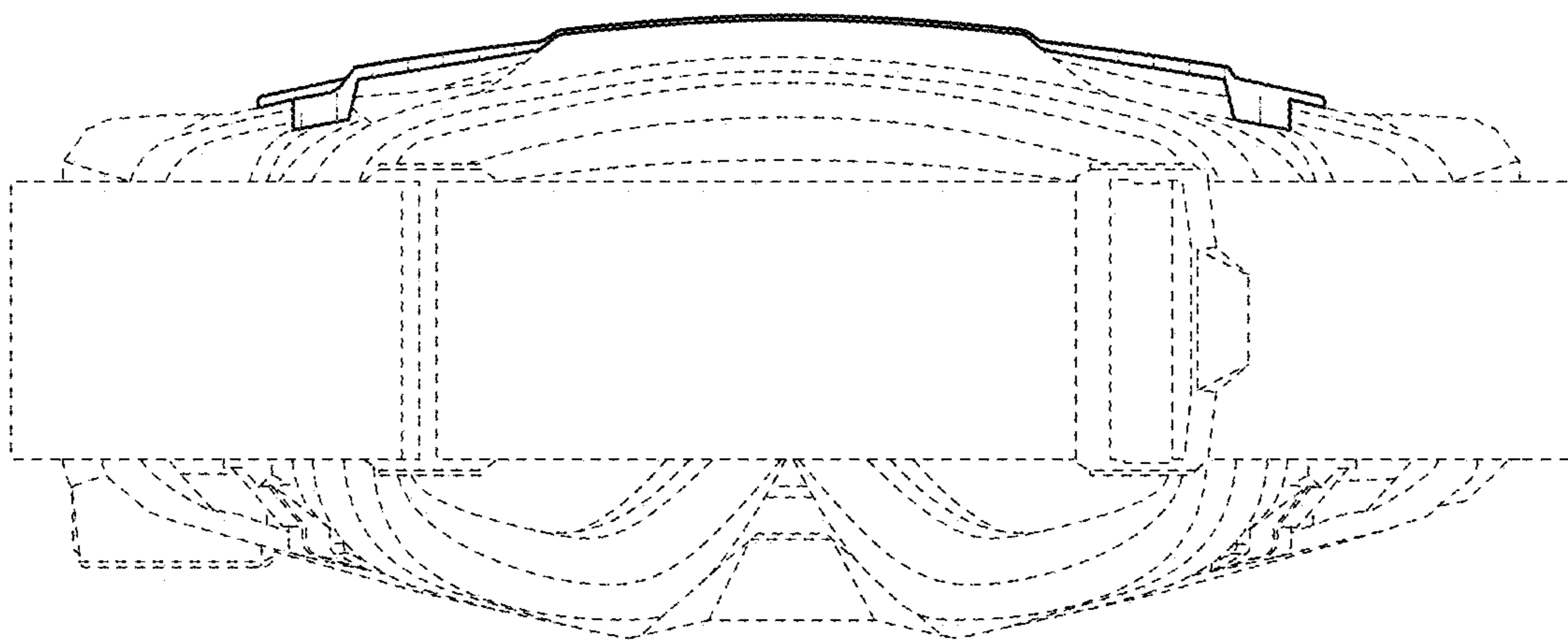

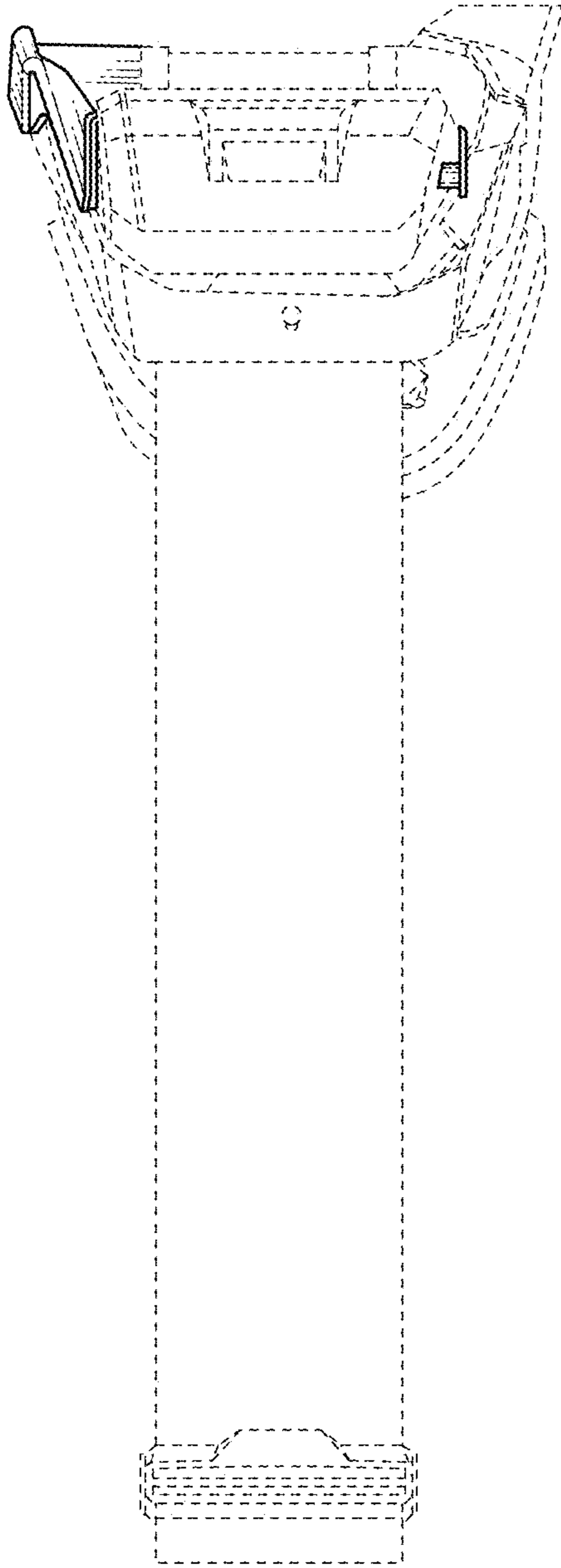

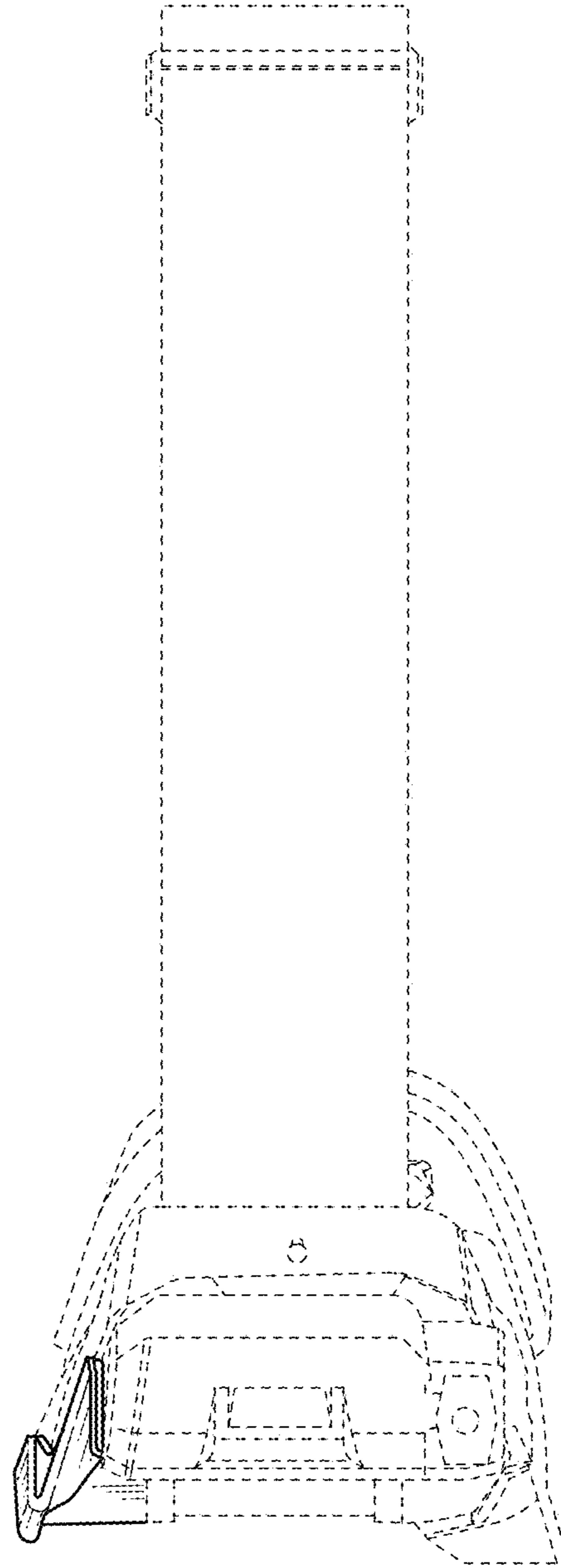

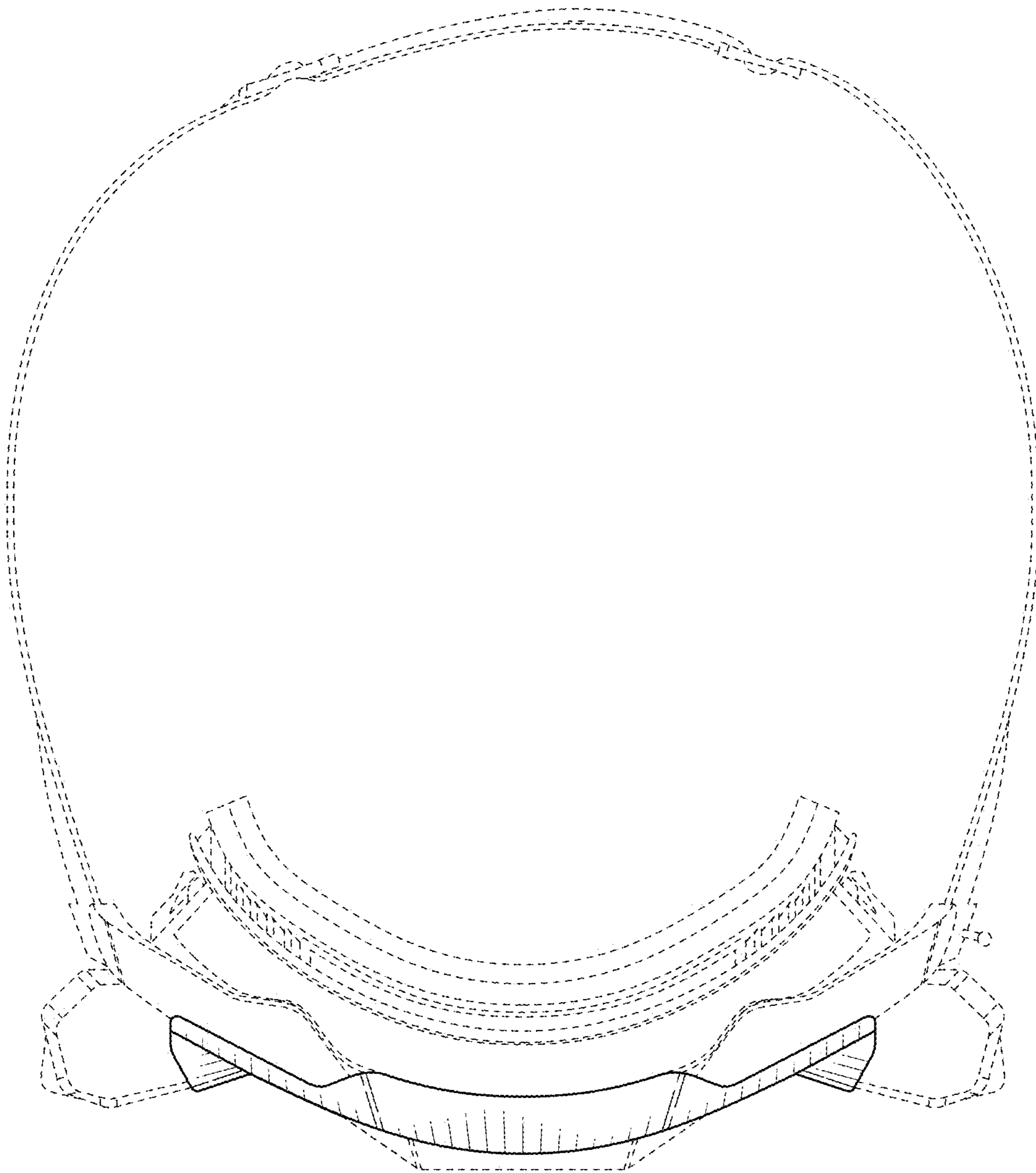

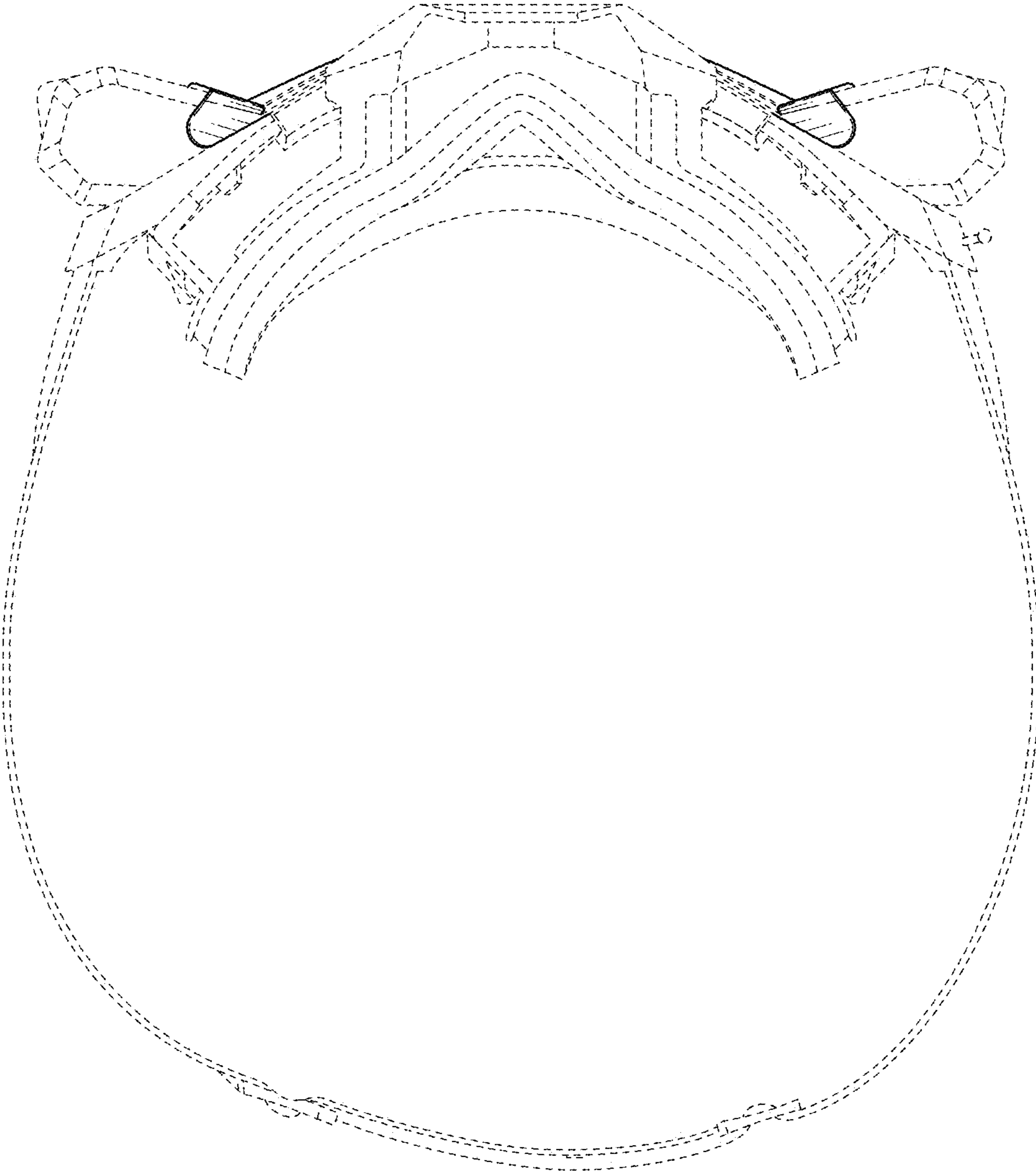
