The ornamental design for a golf club head, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, heel-side, perspective view of the golf club head;

FIG. 2 is a top plan view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a toe-side elevational view thereof;

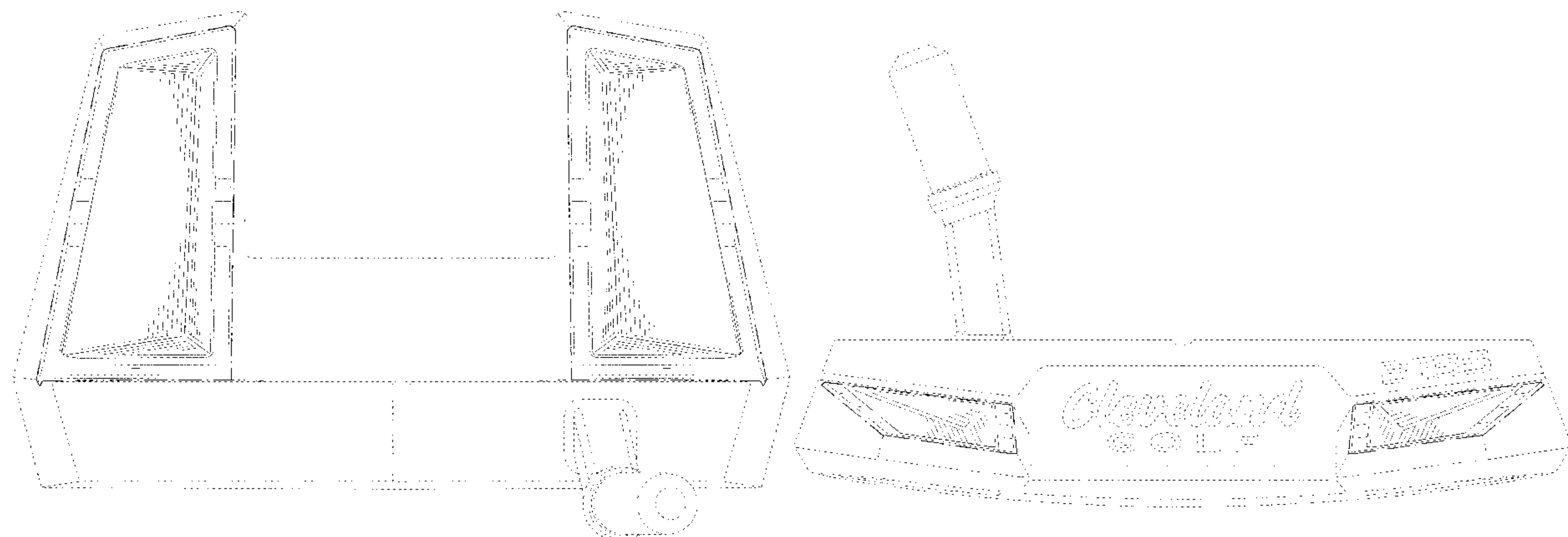
FIG. 5 is a heel-side elevational view thereof;

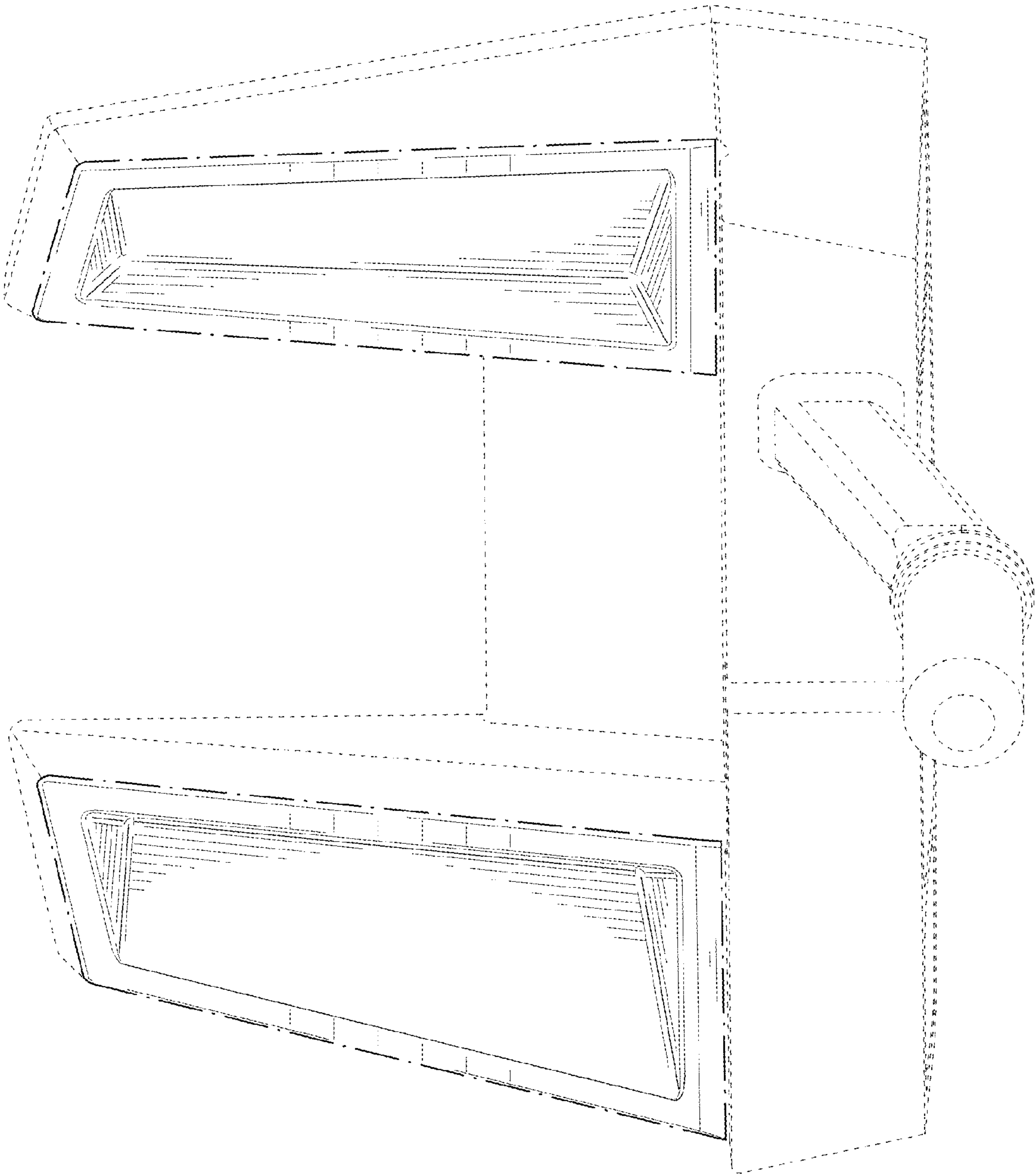

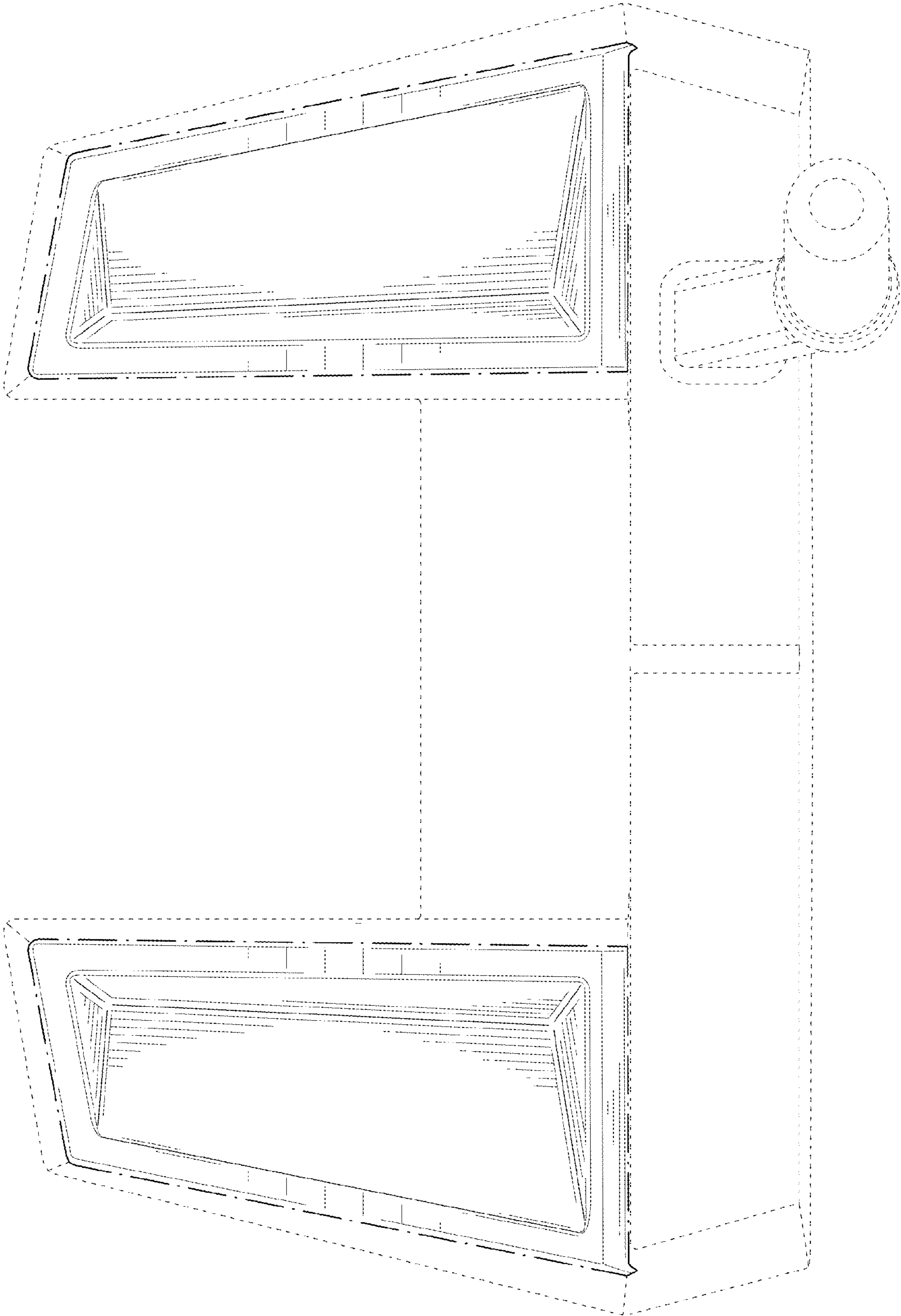

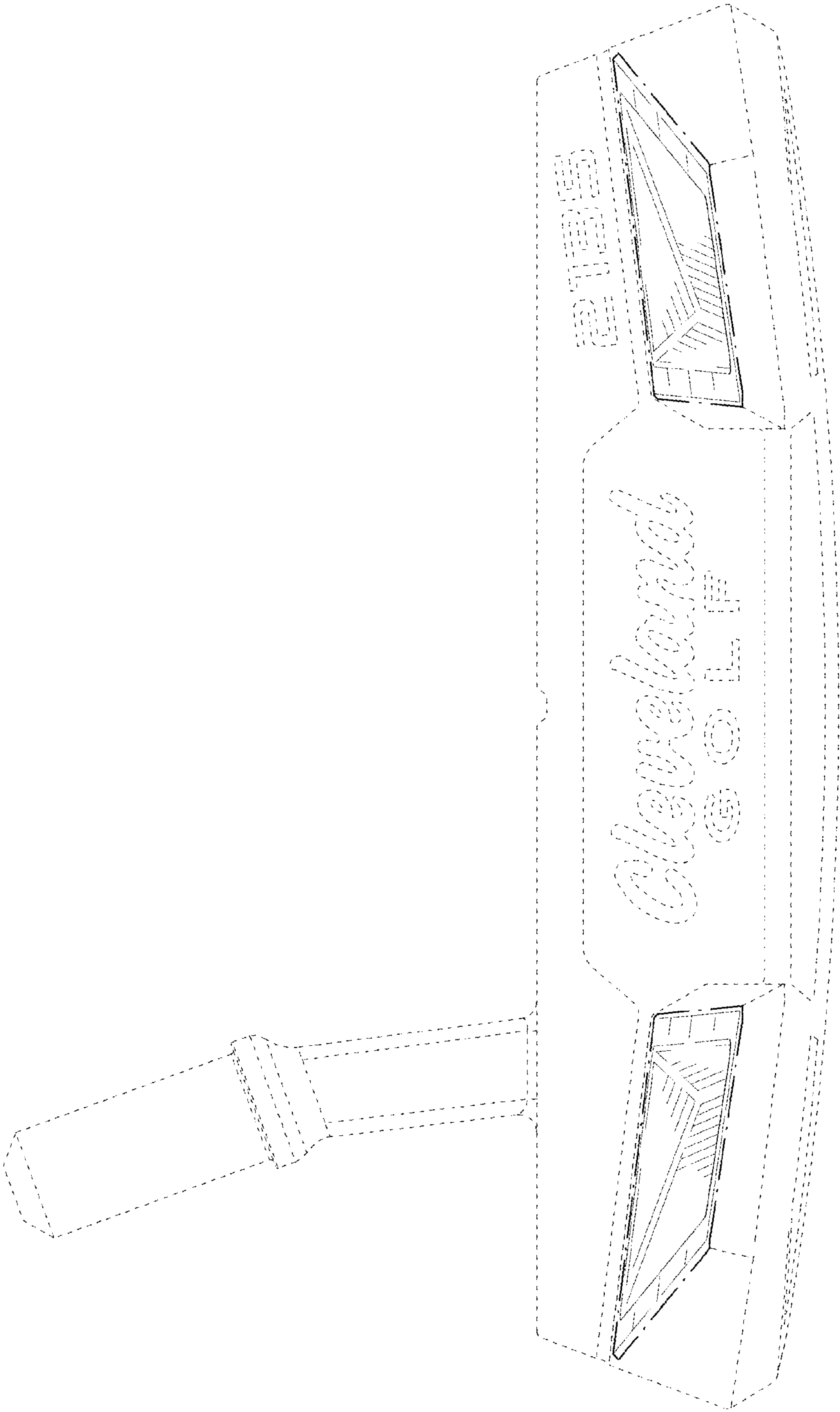

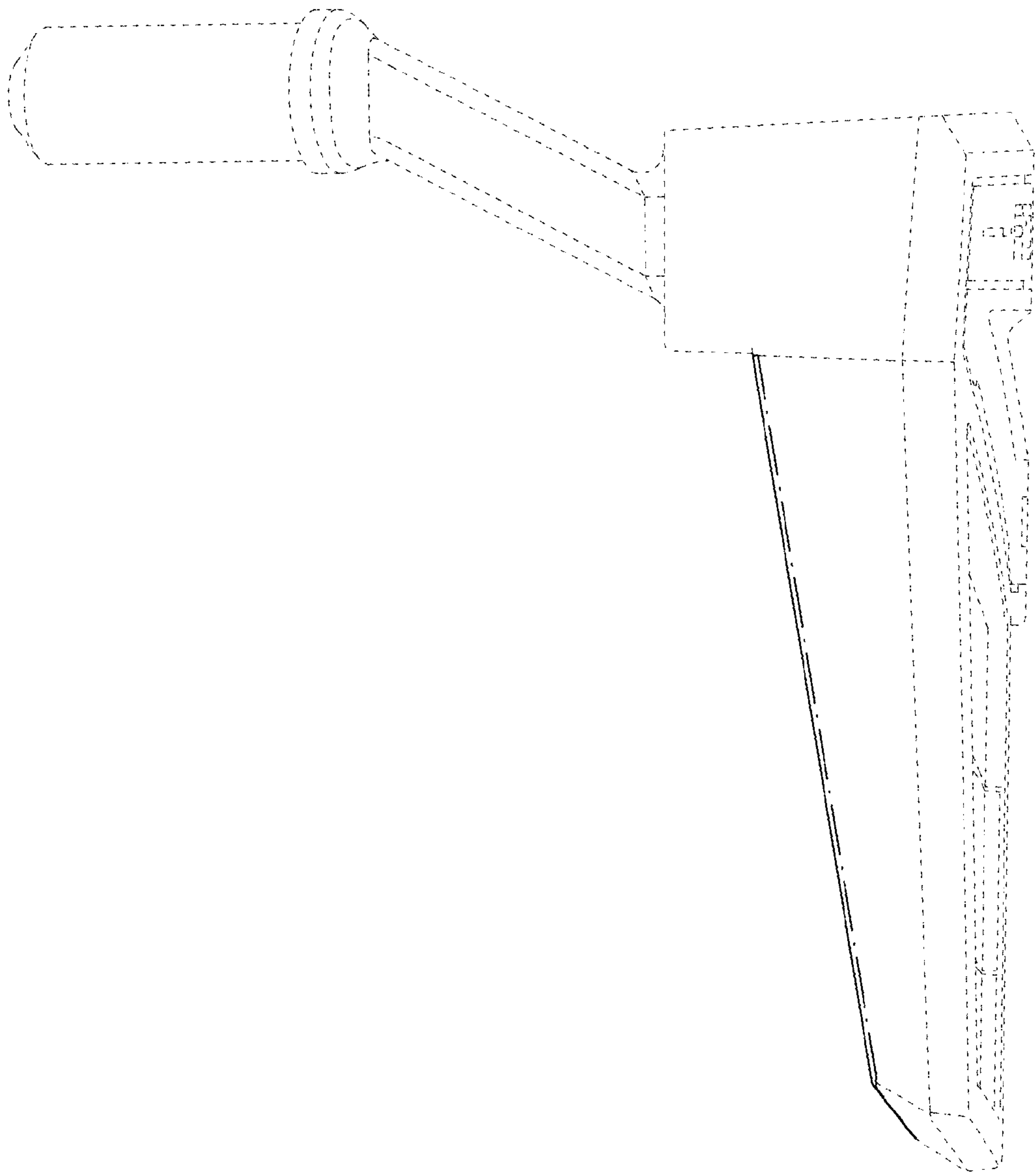

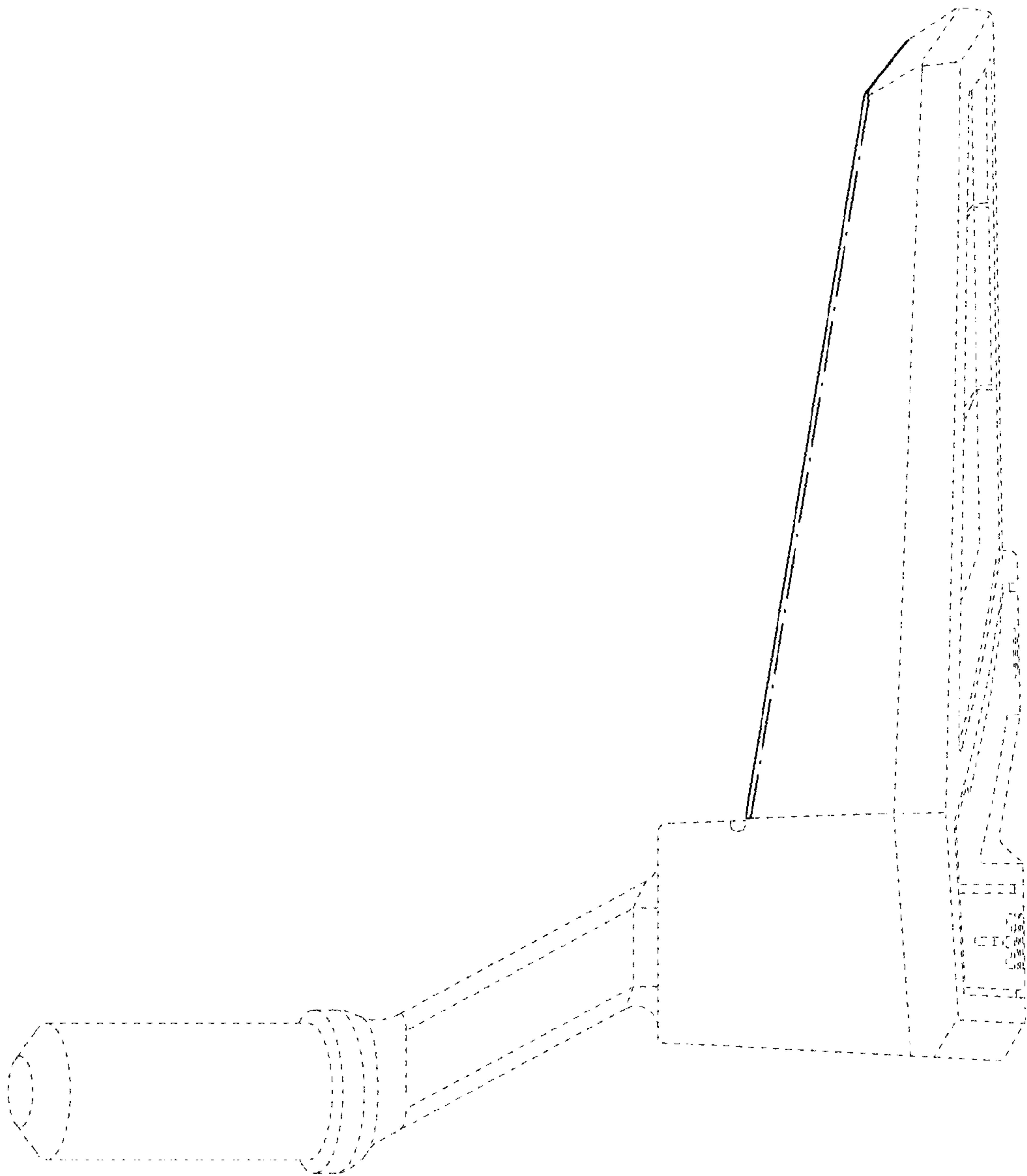

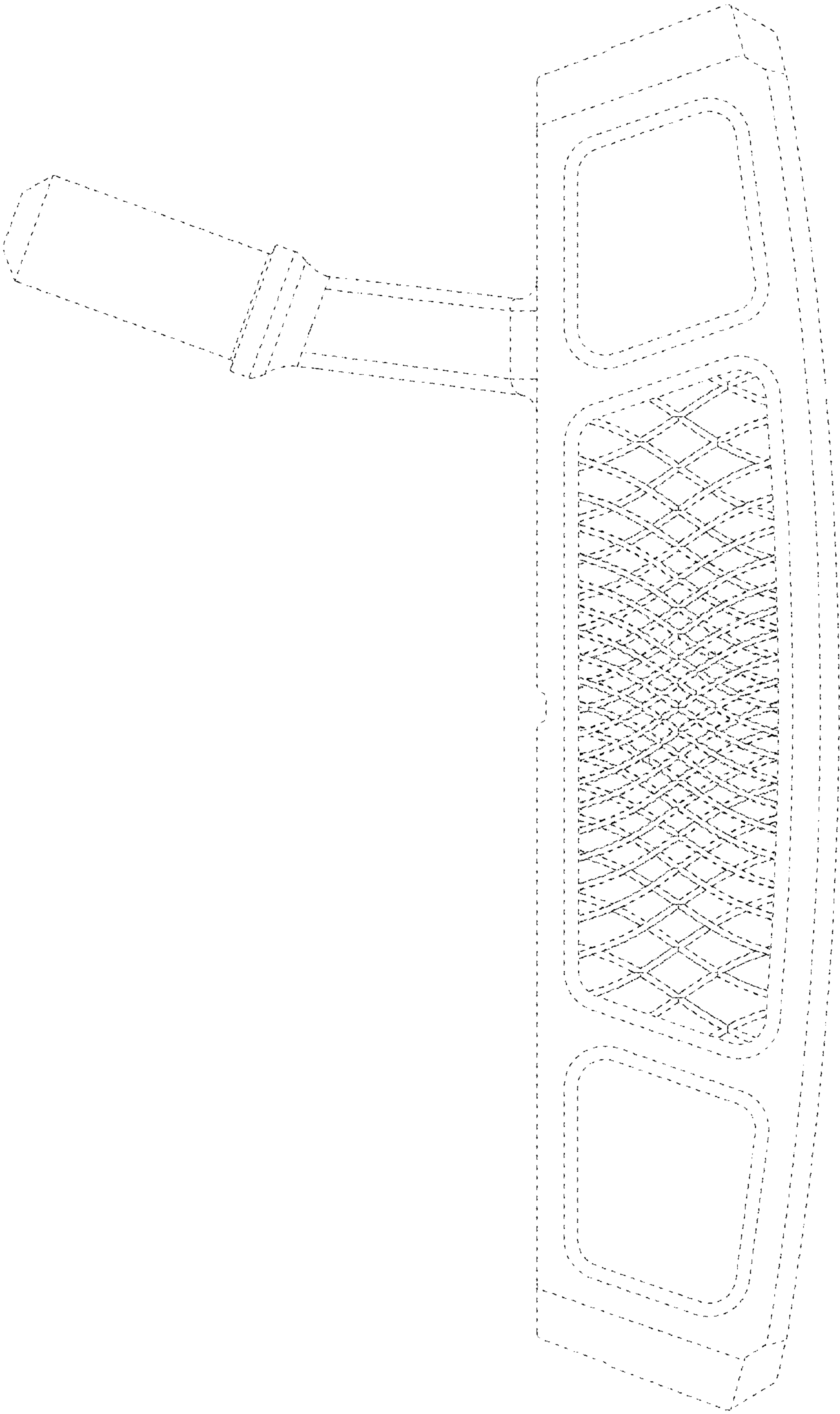

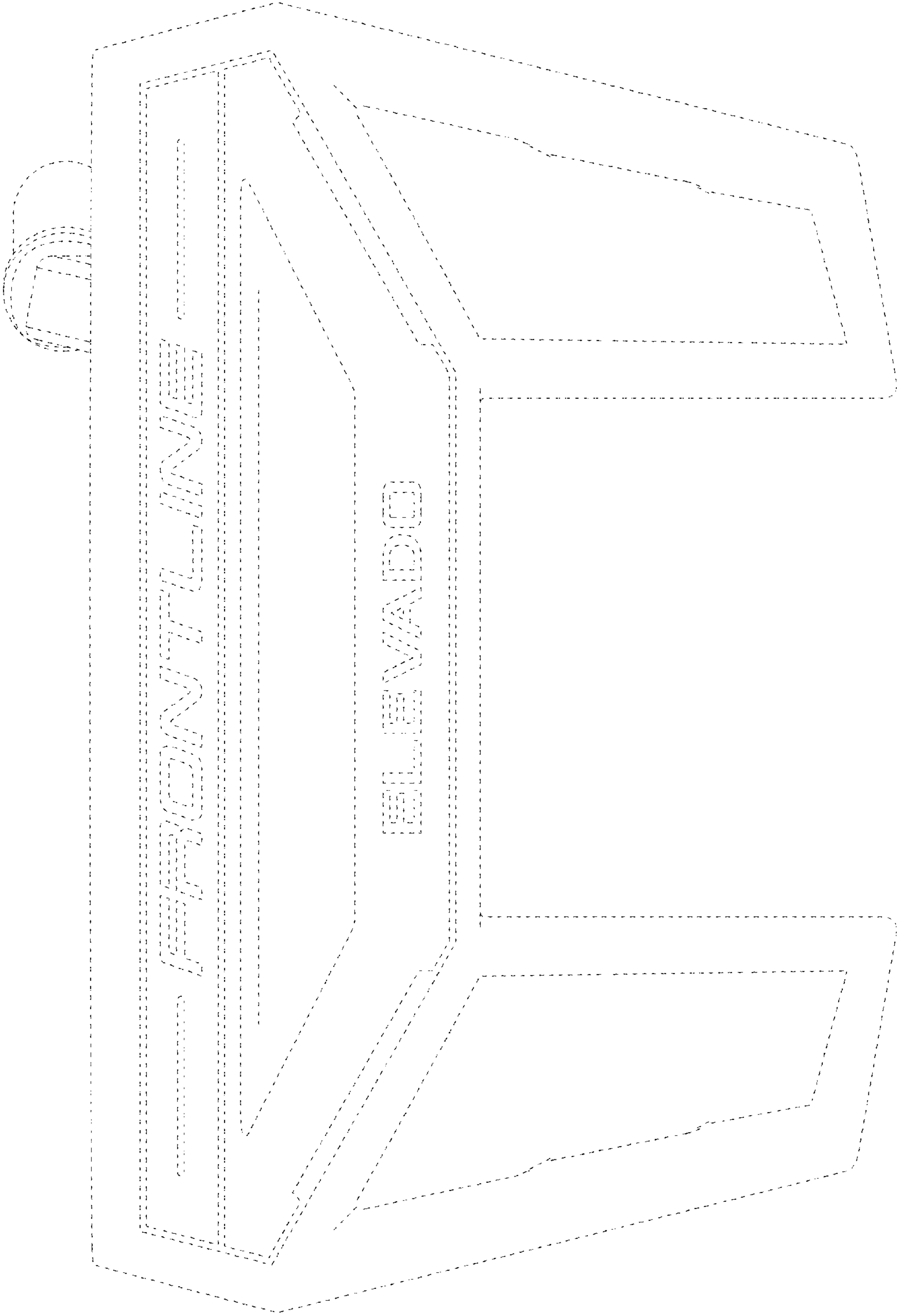
