(57) **CLAIM**

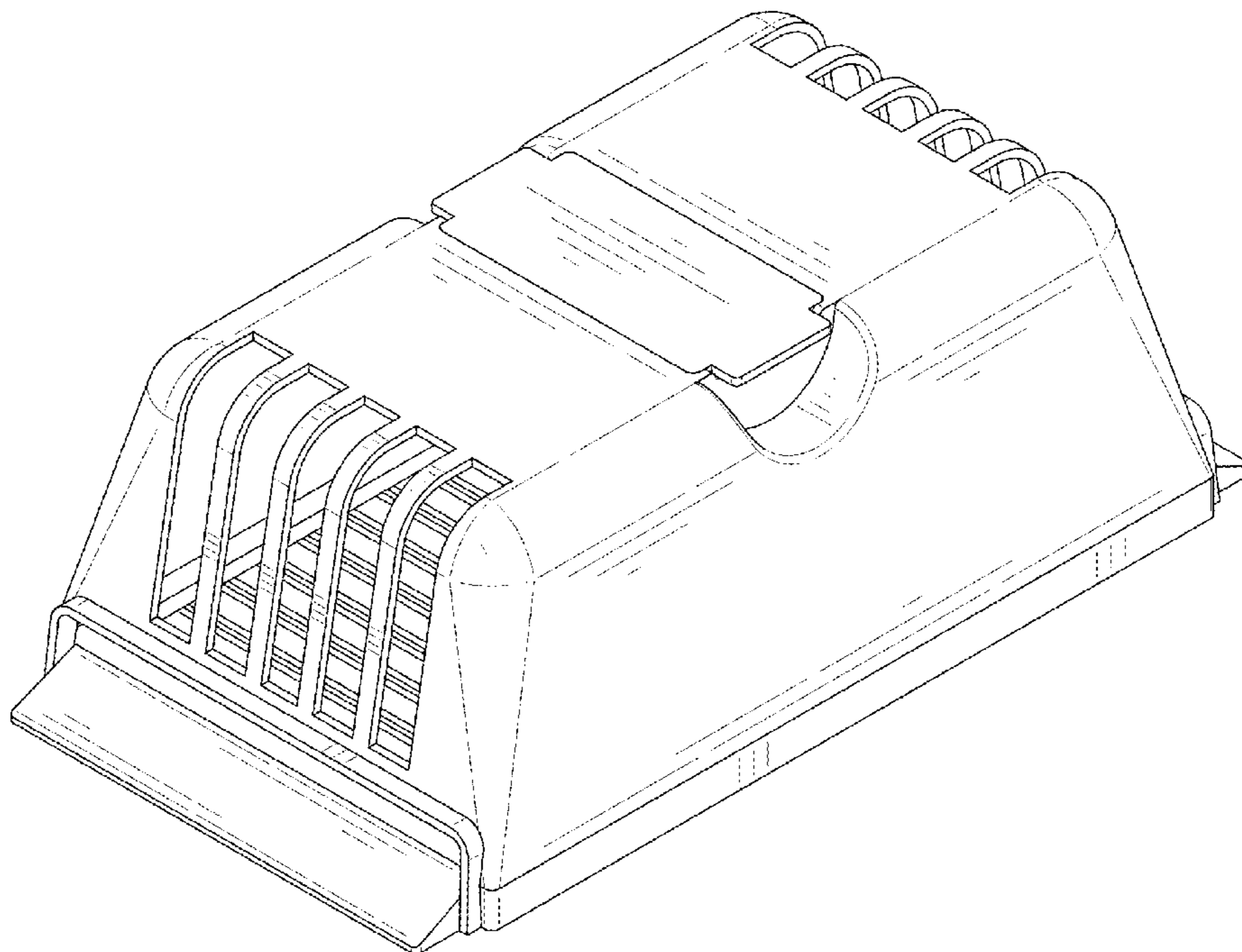
The ornamental design for an electronic cockroach killer, as shown and described.

DESCRIPTION

FIG. 1 is a first perspective view of an electronic cockroach killer showing my new design;

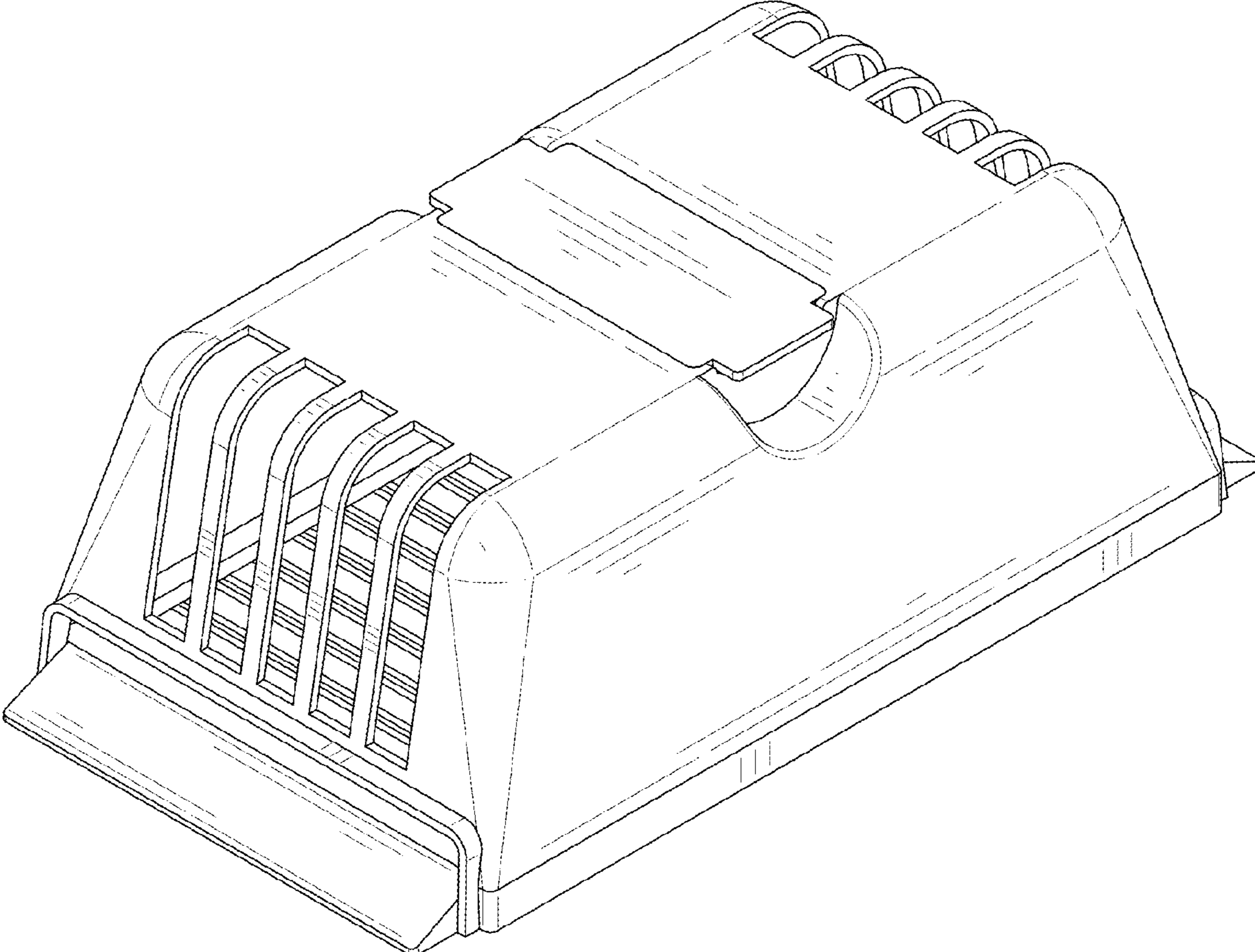

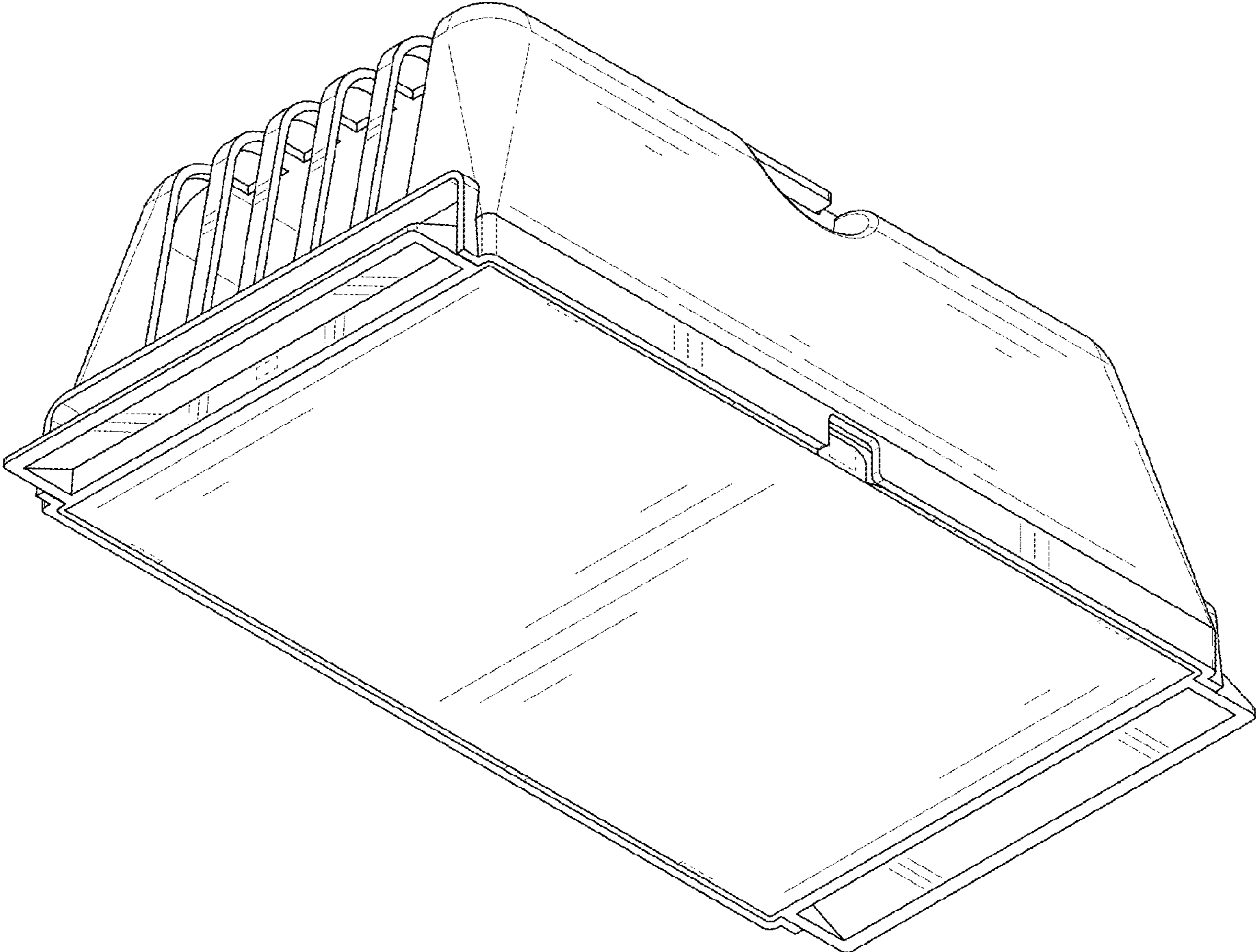

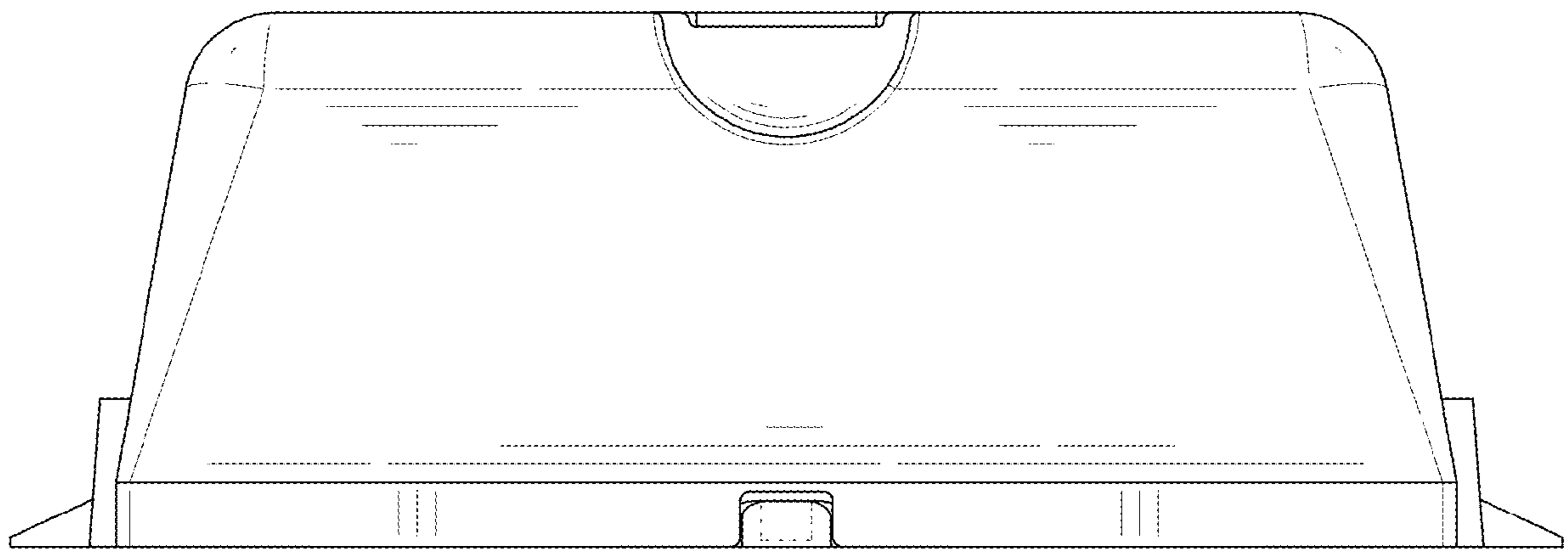

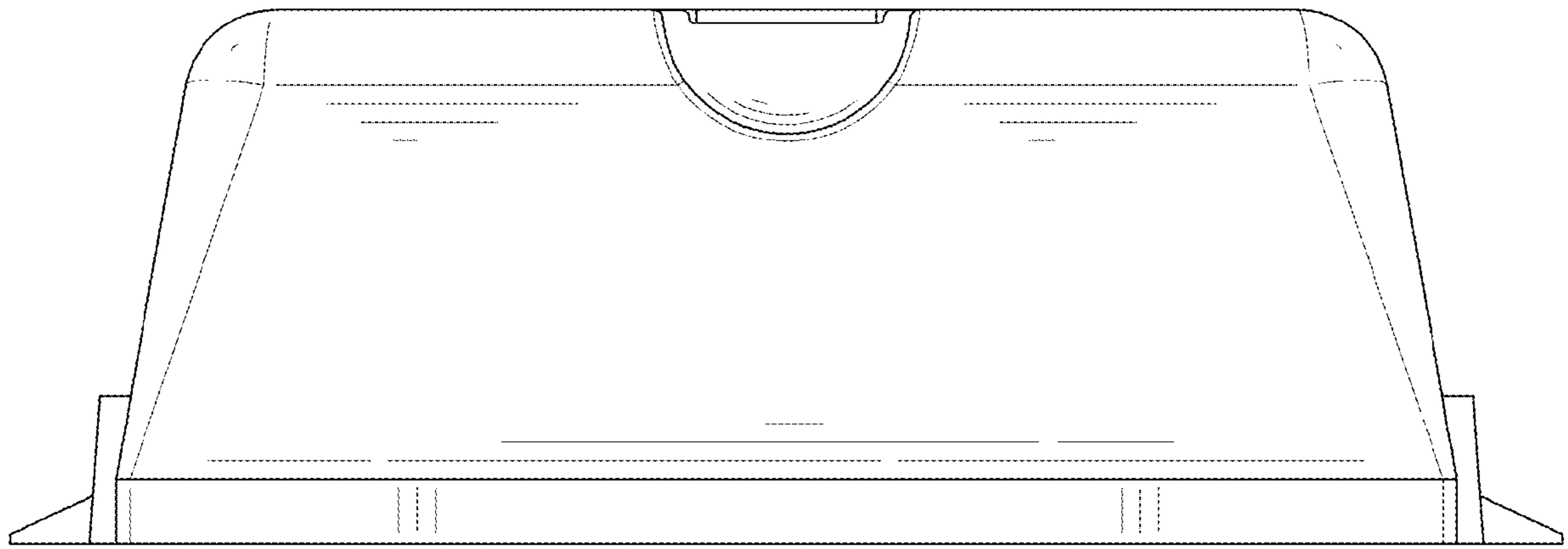

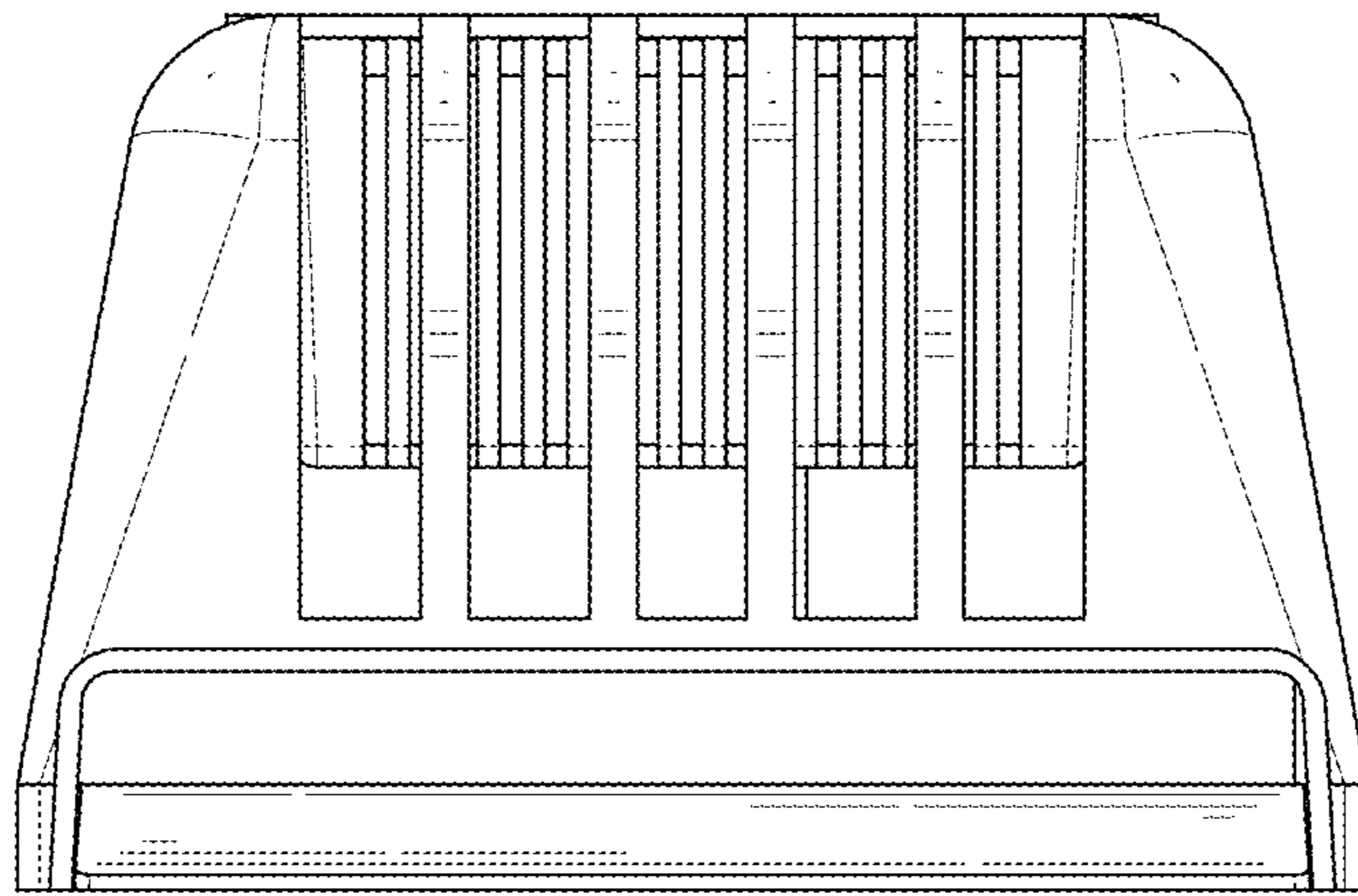

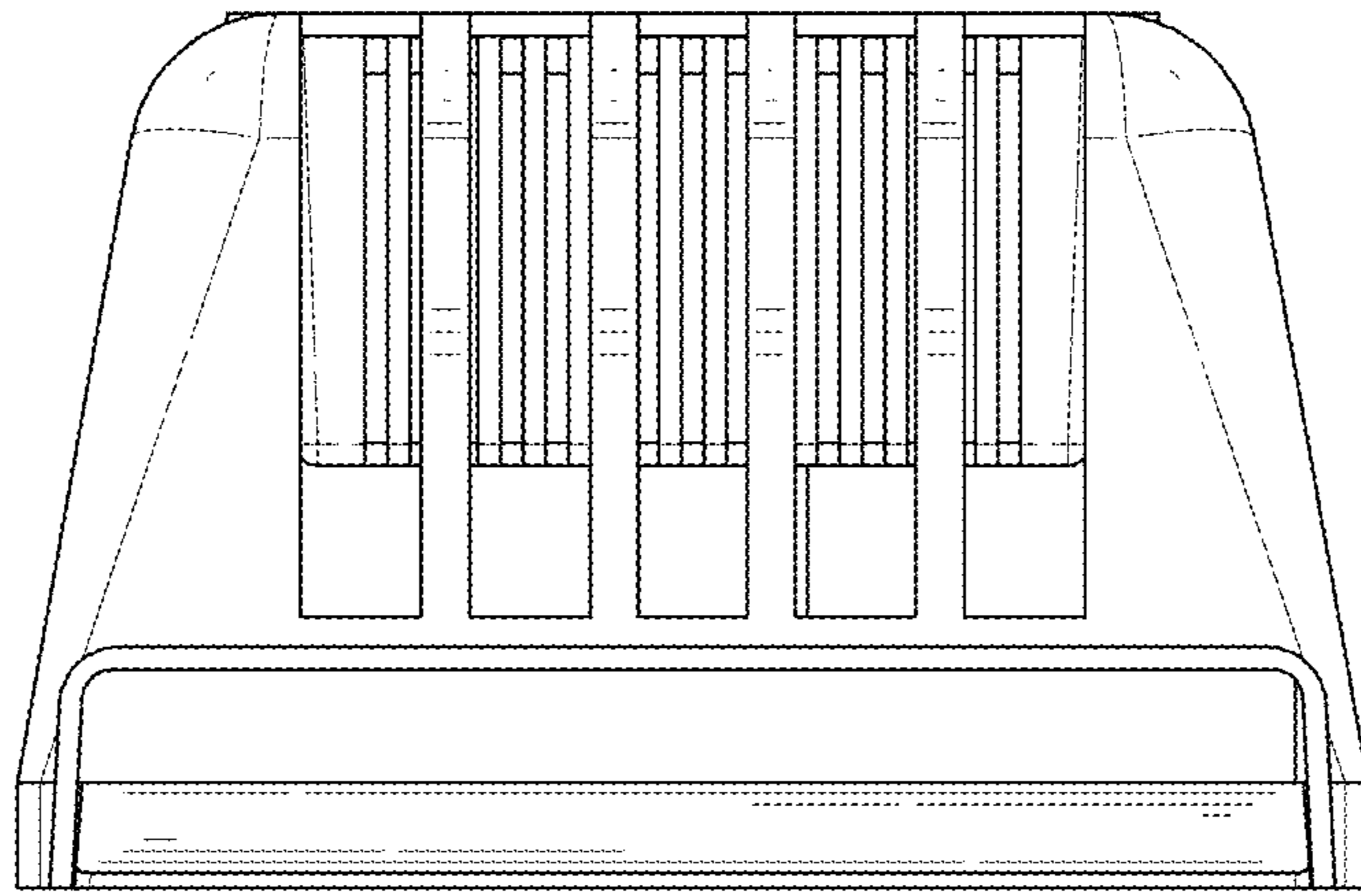

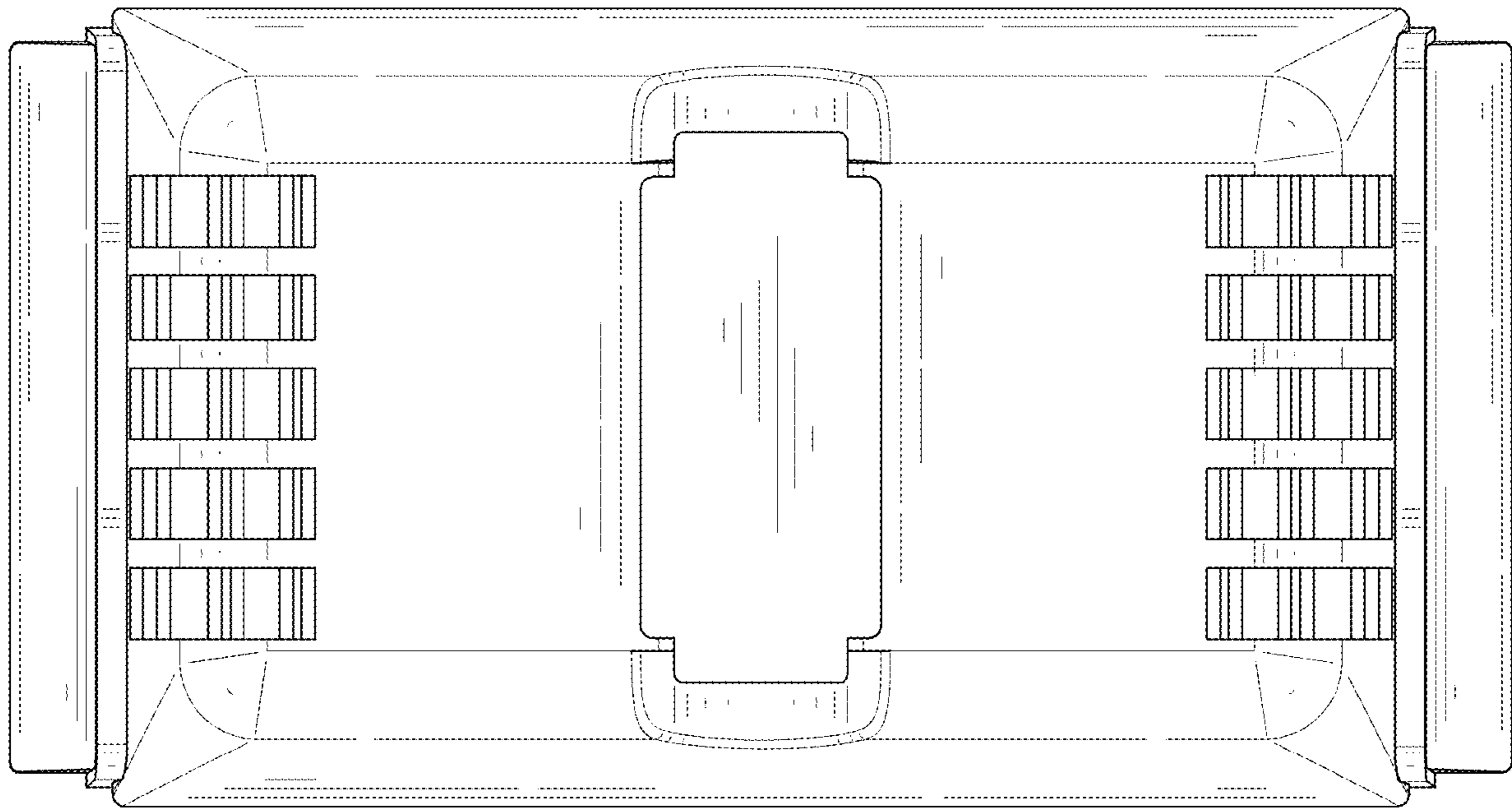

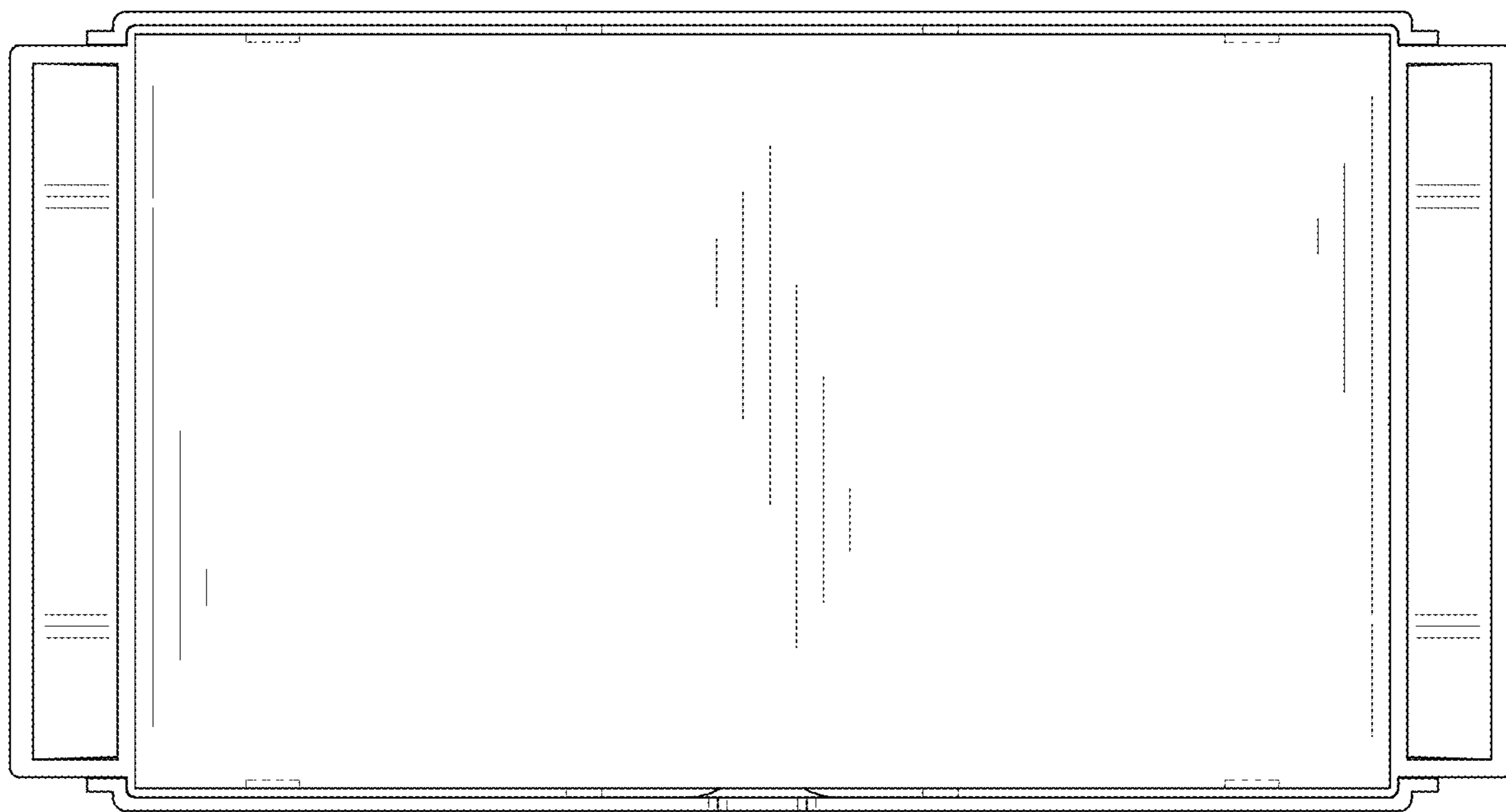
