**DESCRIPTION**

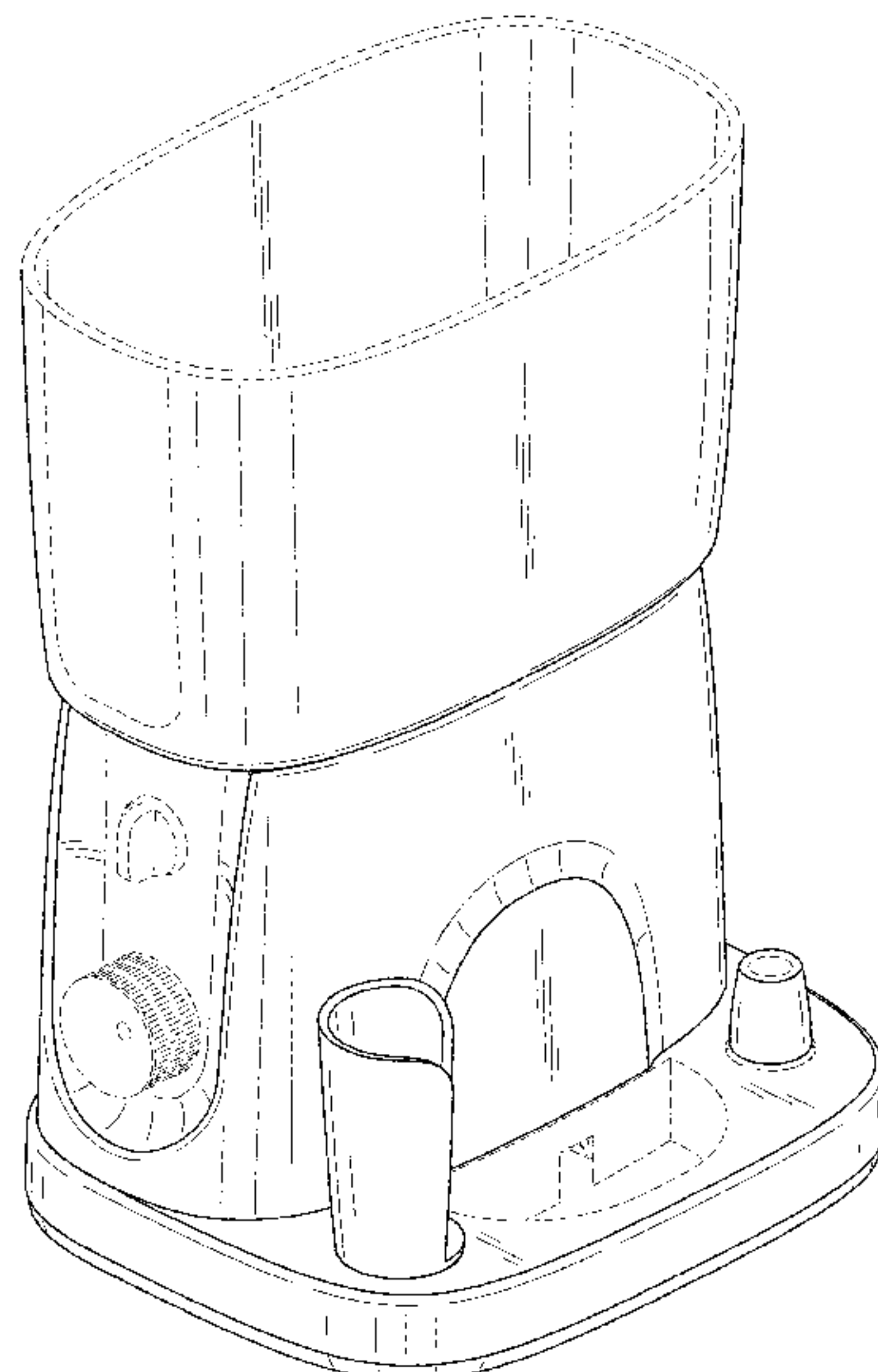
FIG. 1 is a front isometric view of an oral irrigator.

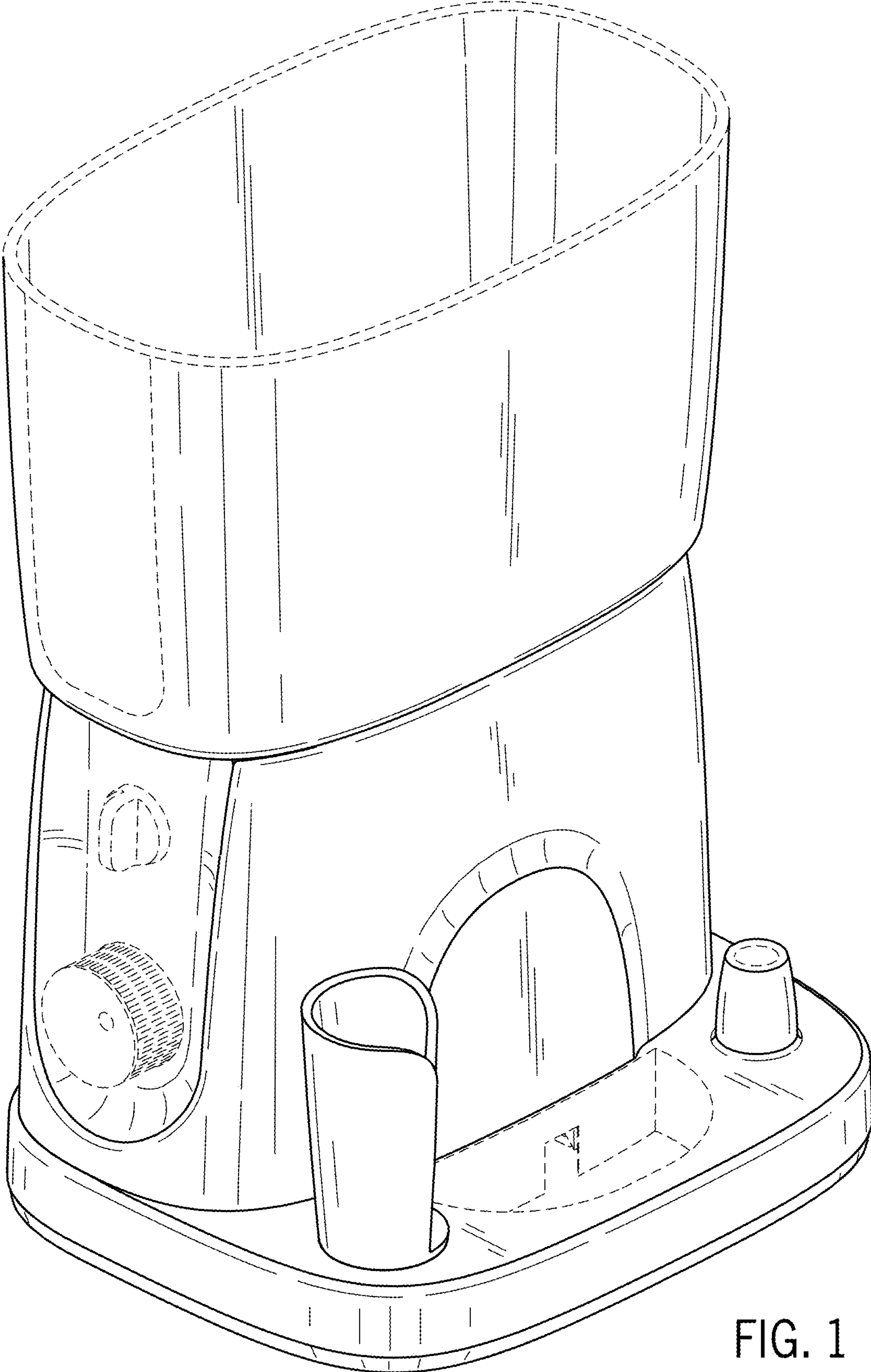

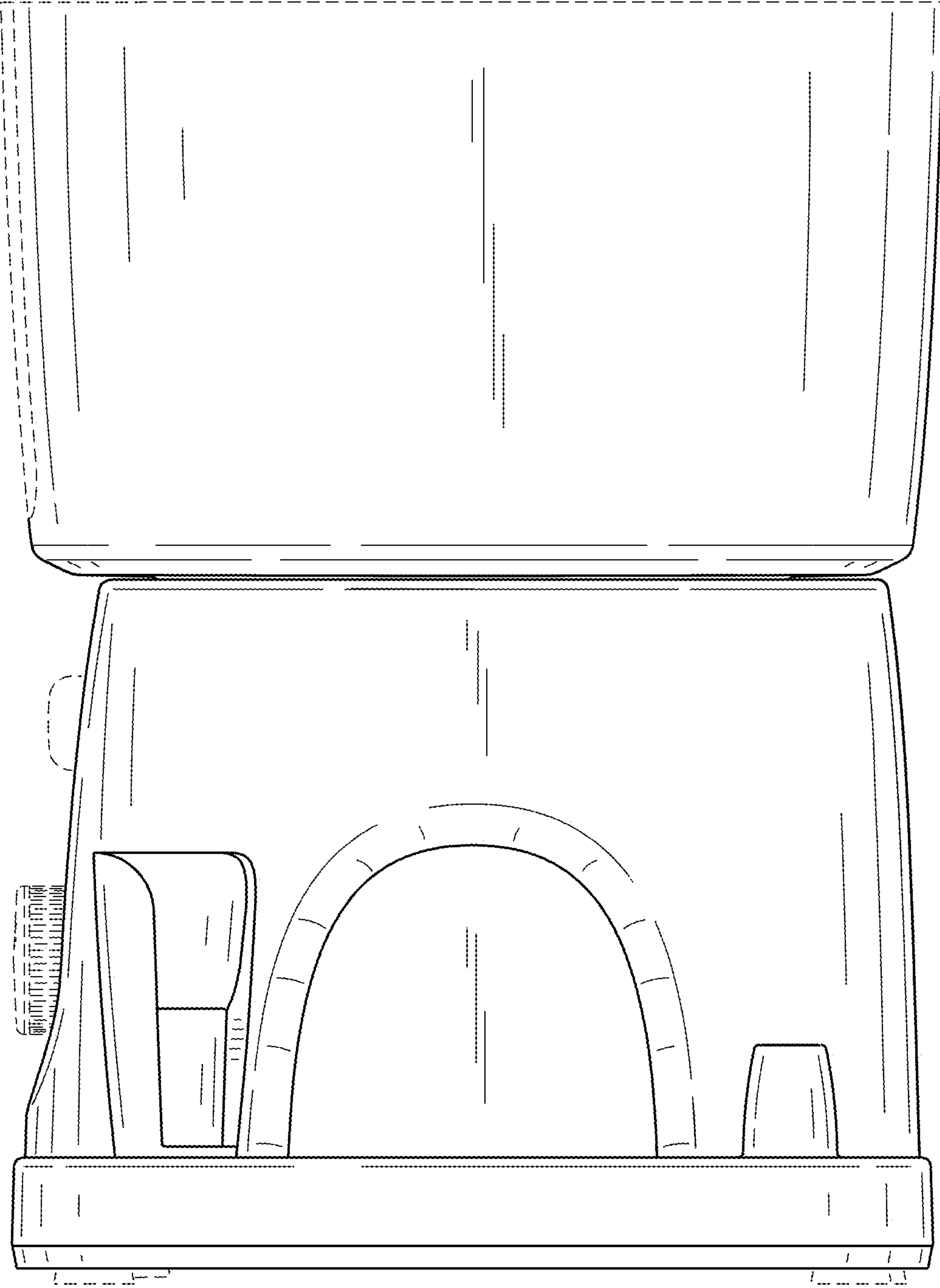

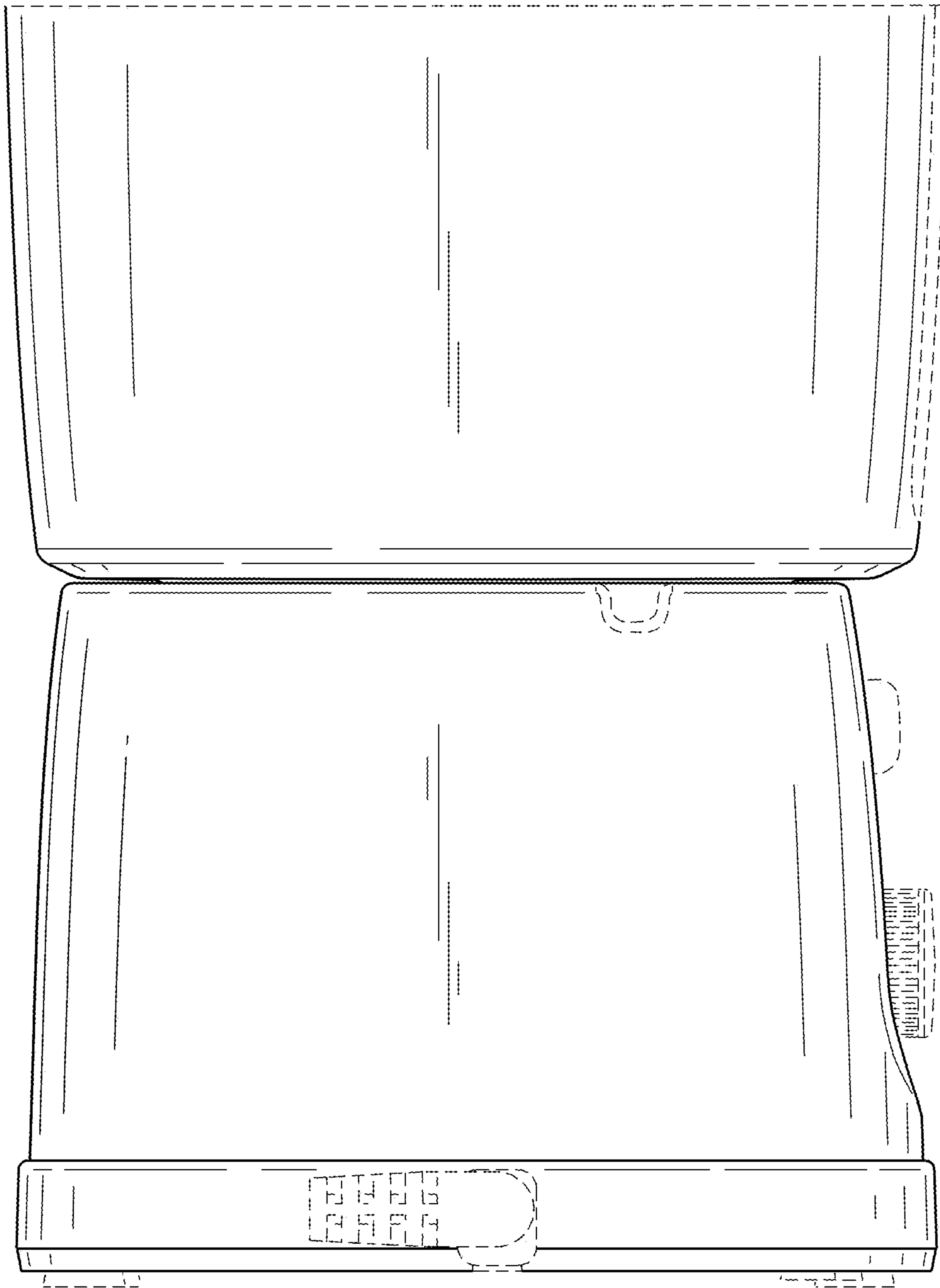

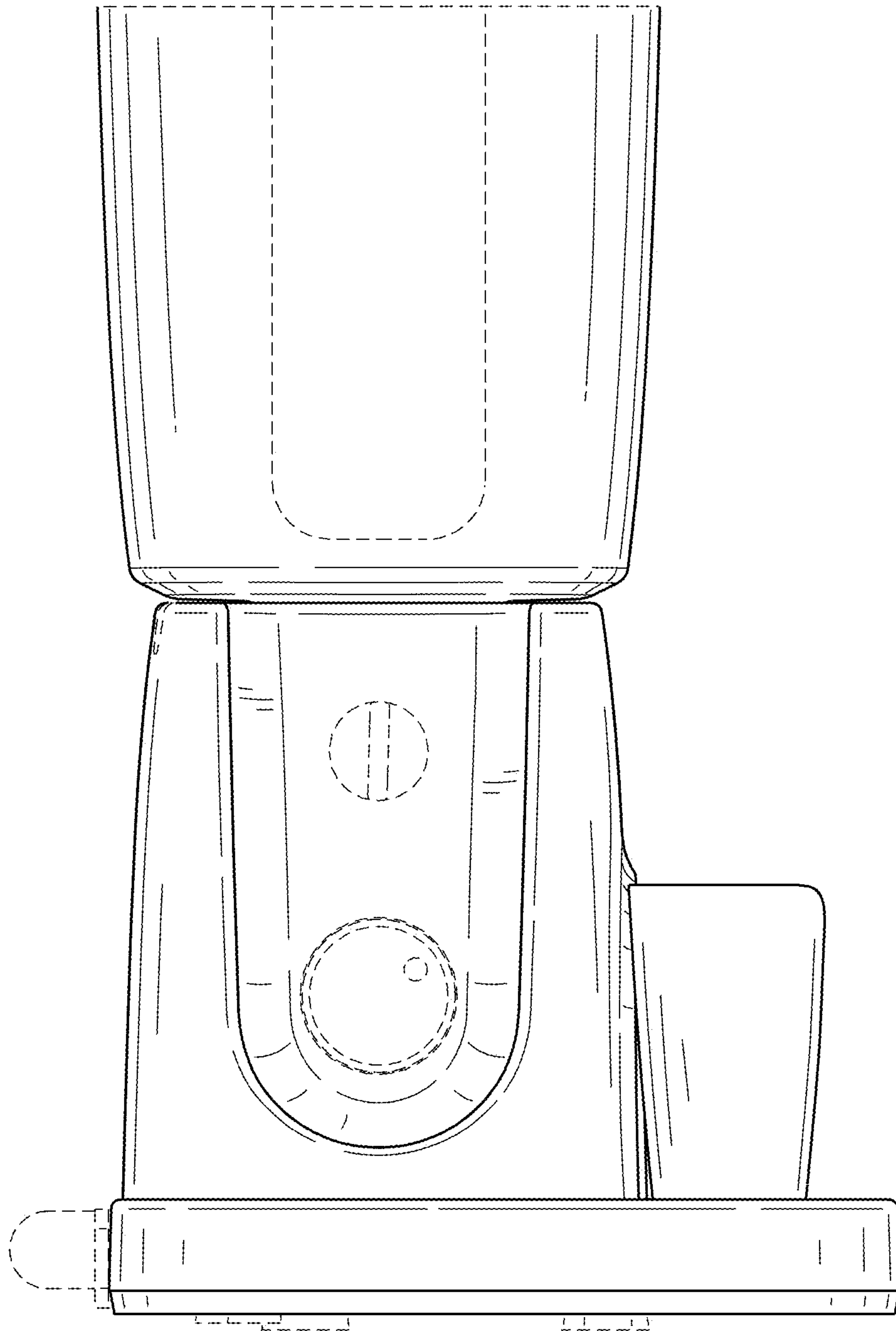

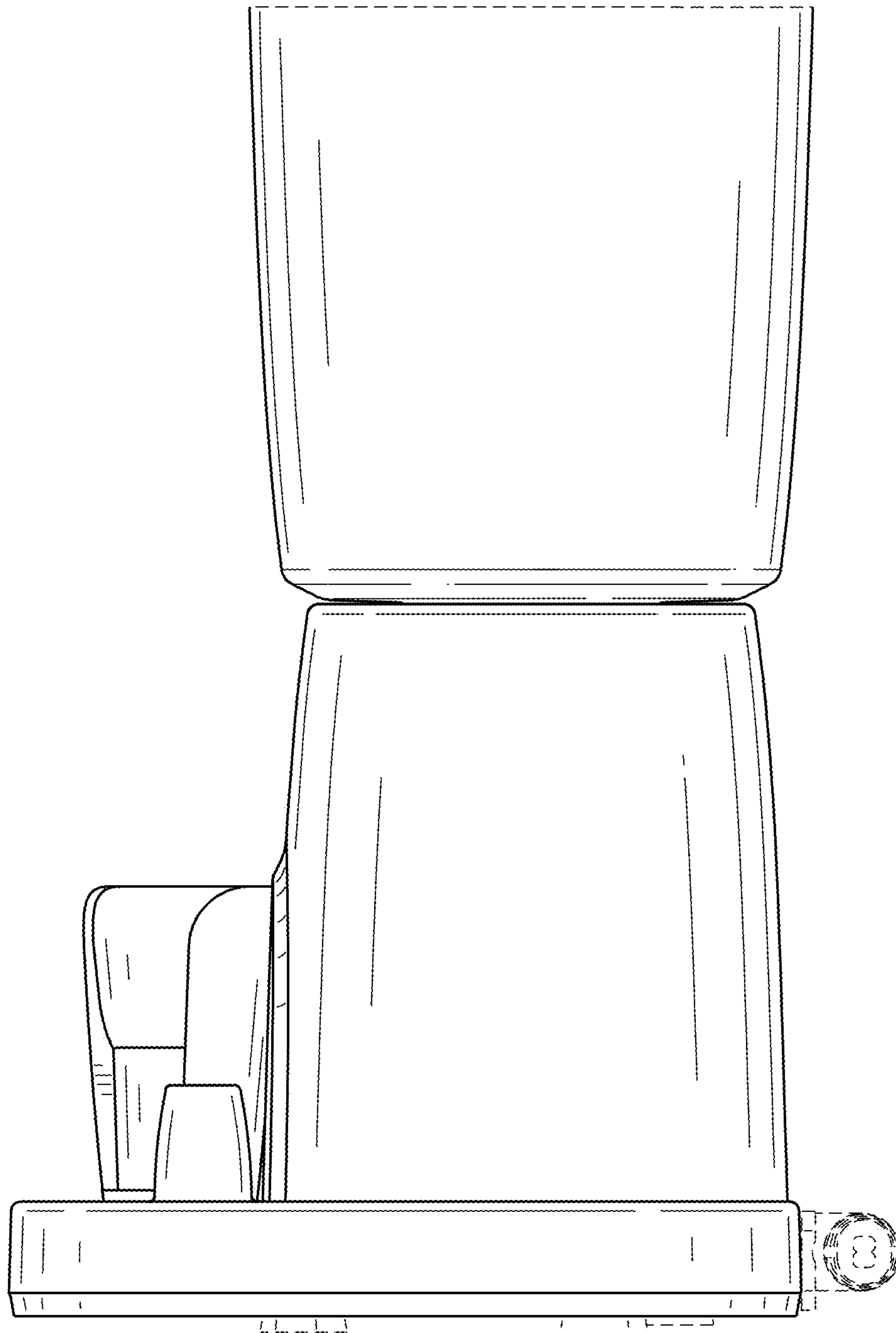

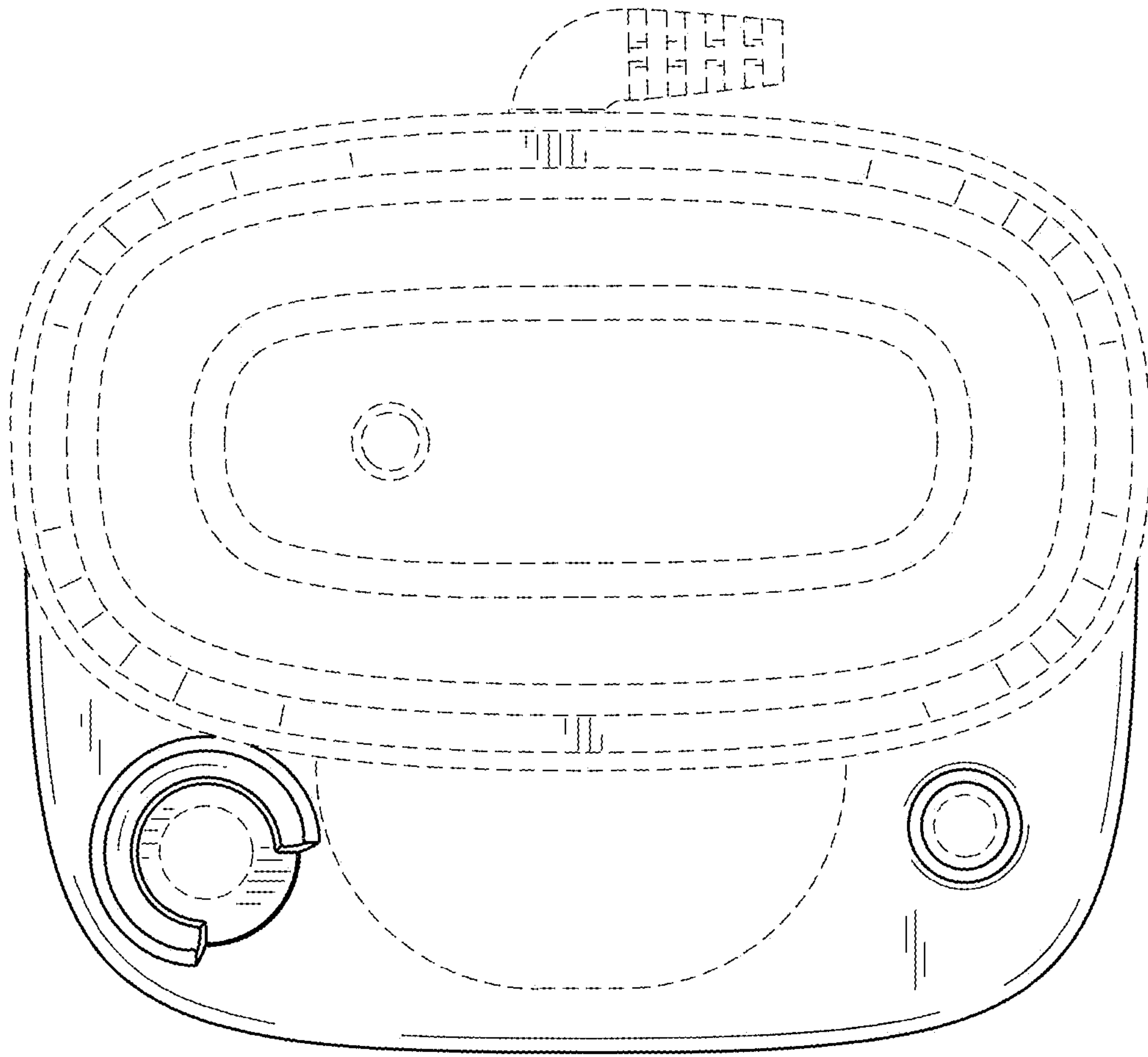

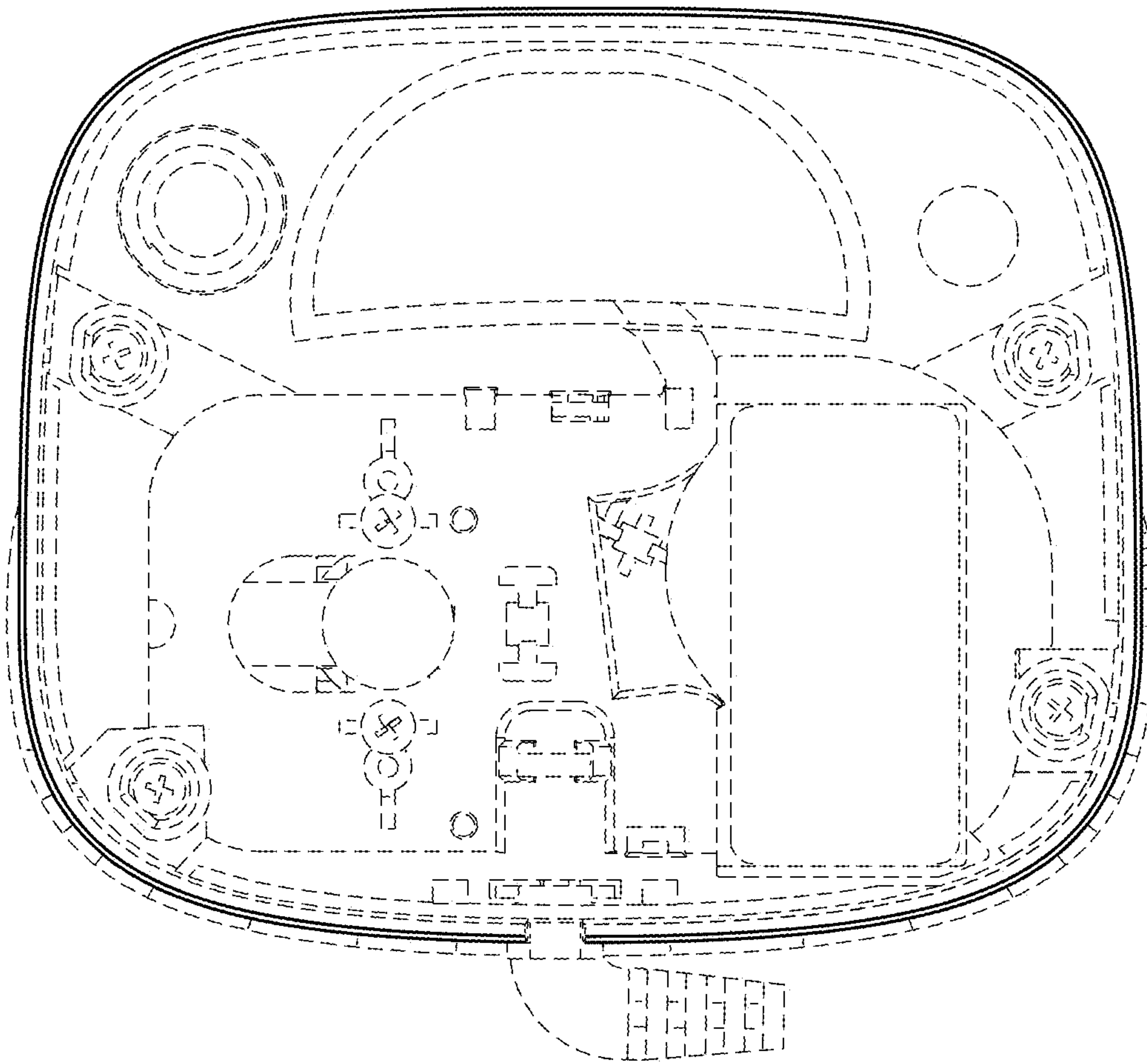
