FIG. 1 is a top plan view of a colostomy accessory of the present invention;

FIG. 2 is a bottom view thereof;

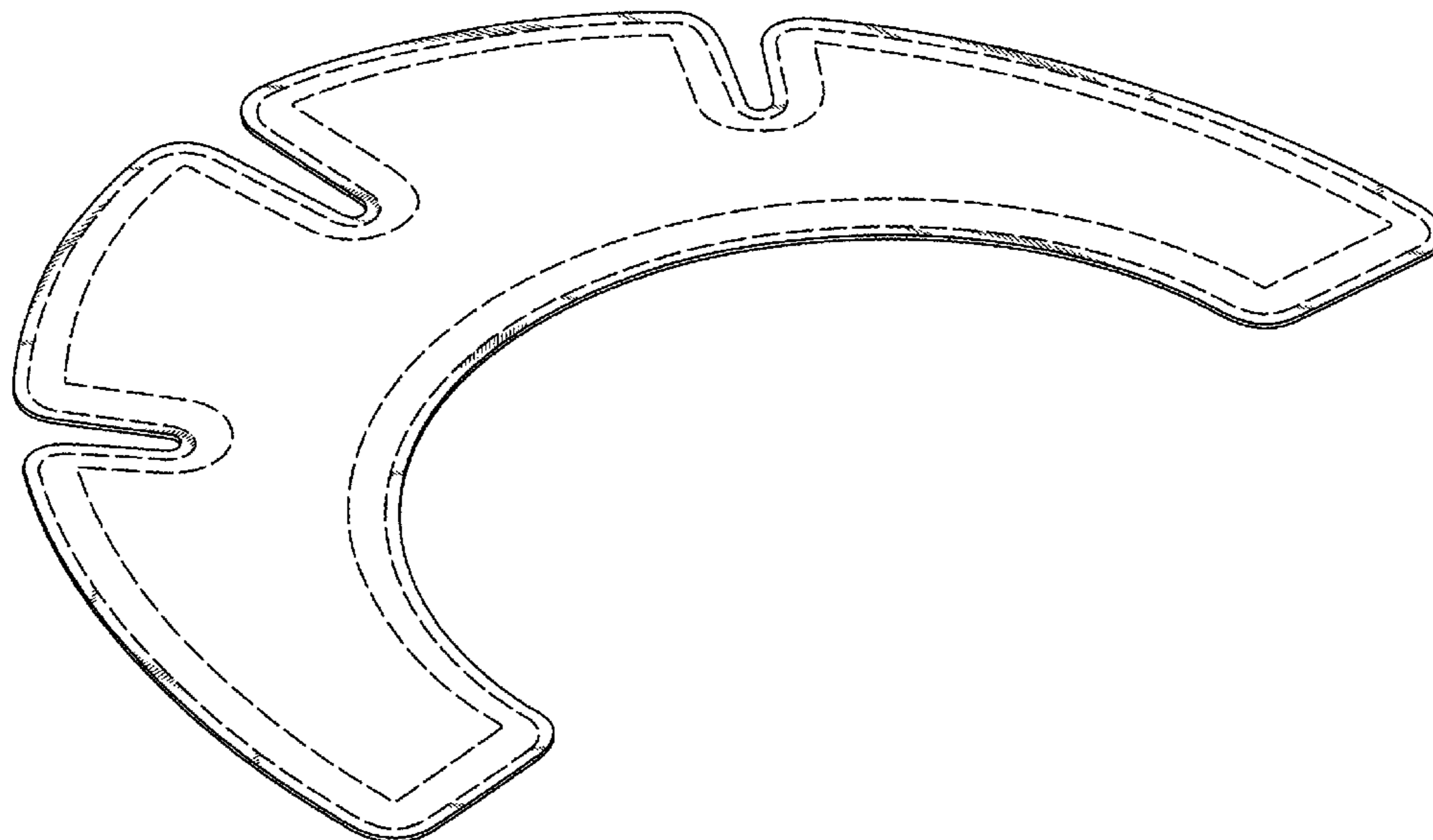
FIG. 3 is a side elevation thereof, the other side view being a mirror image thereof;

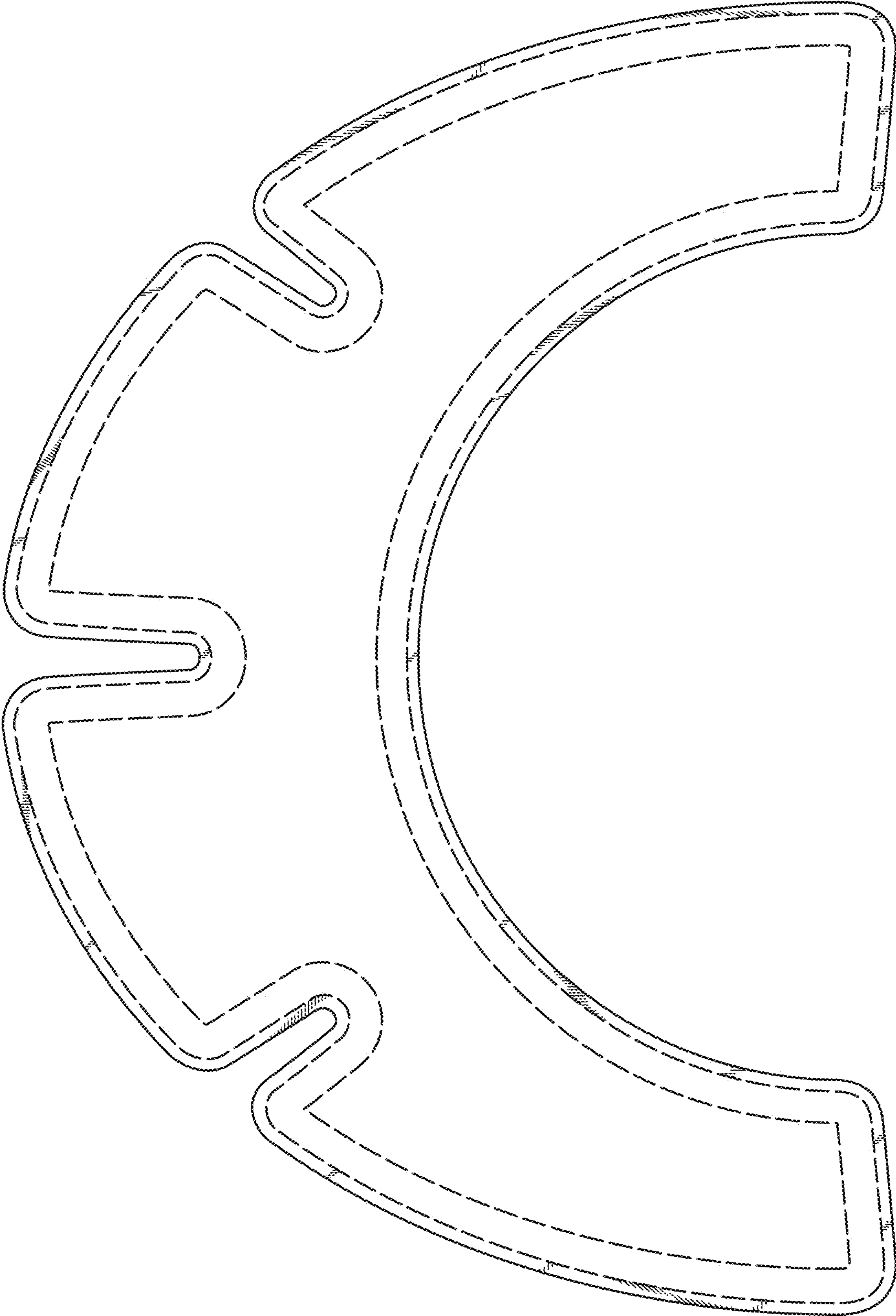

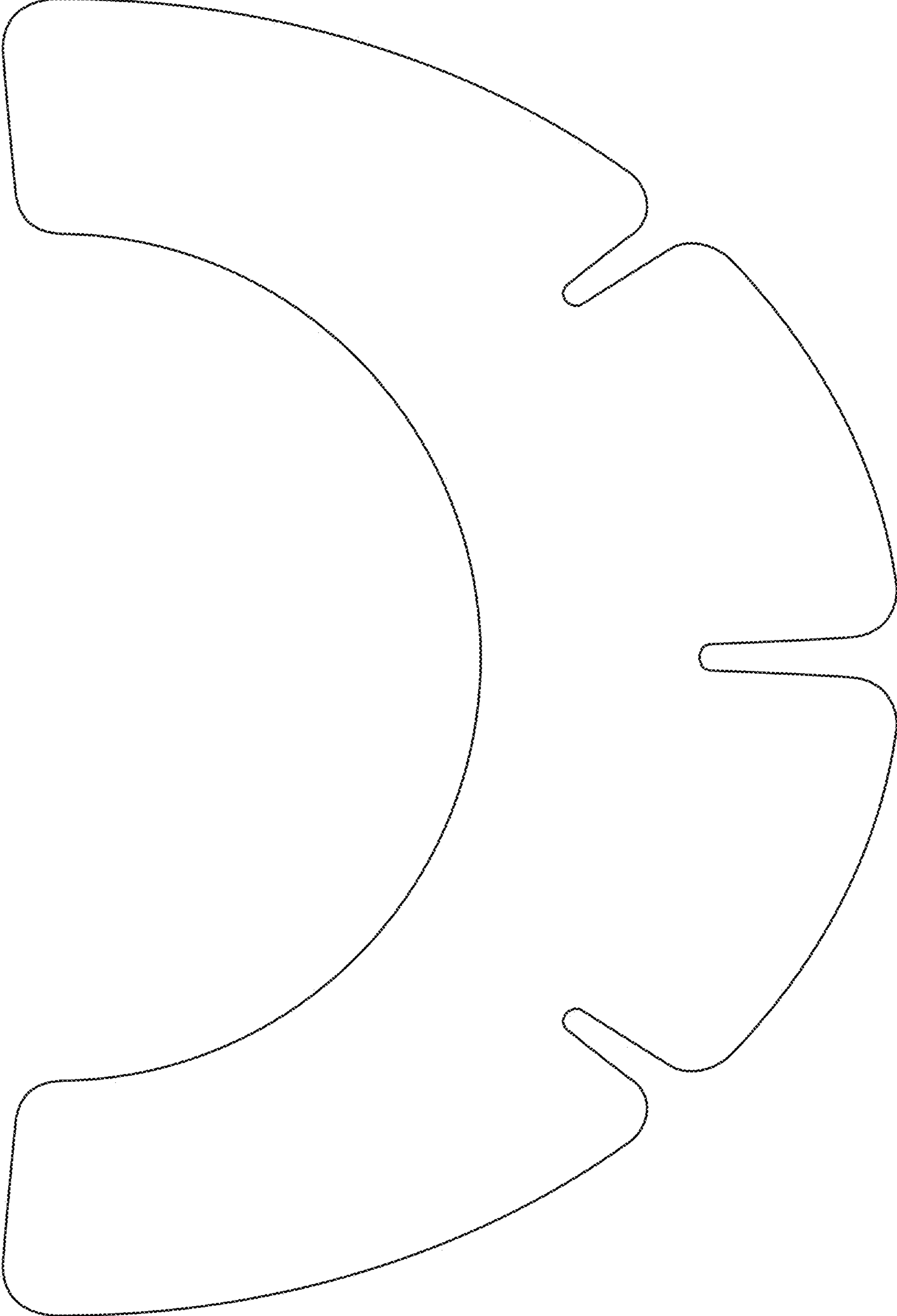

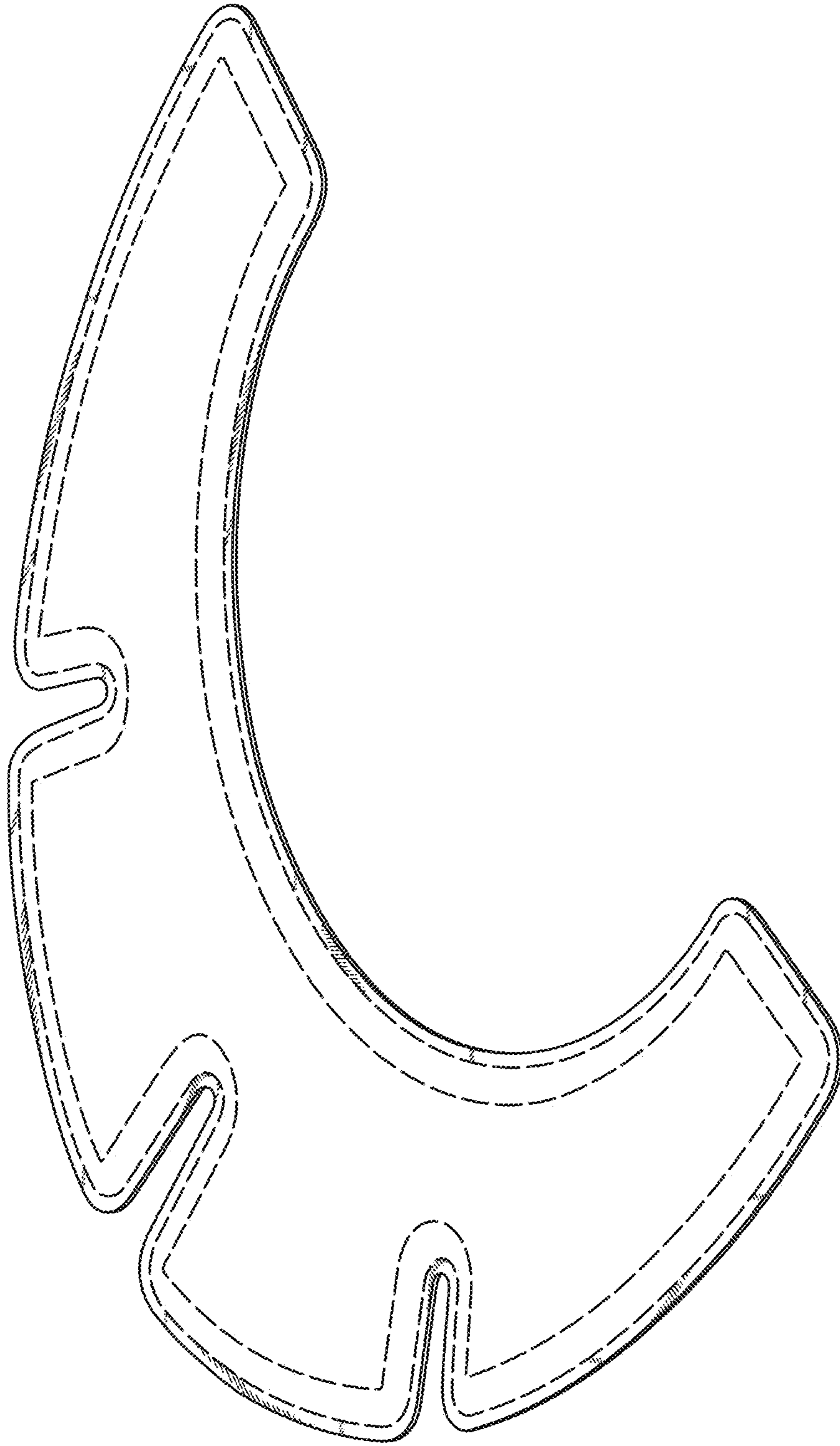
