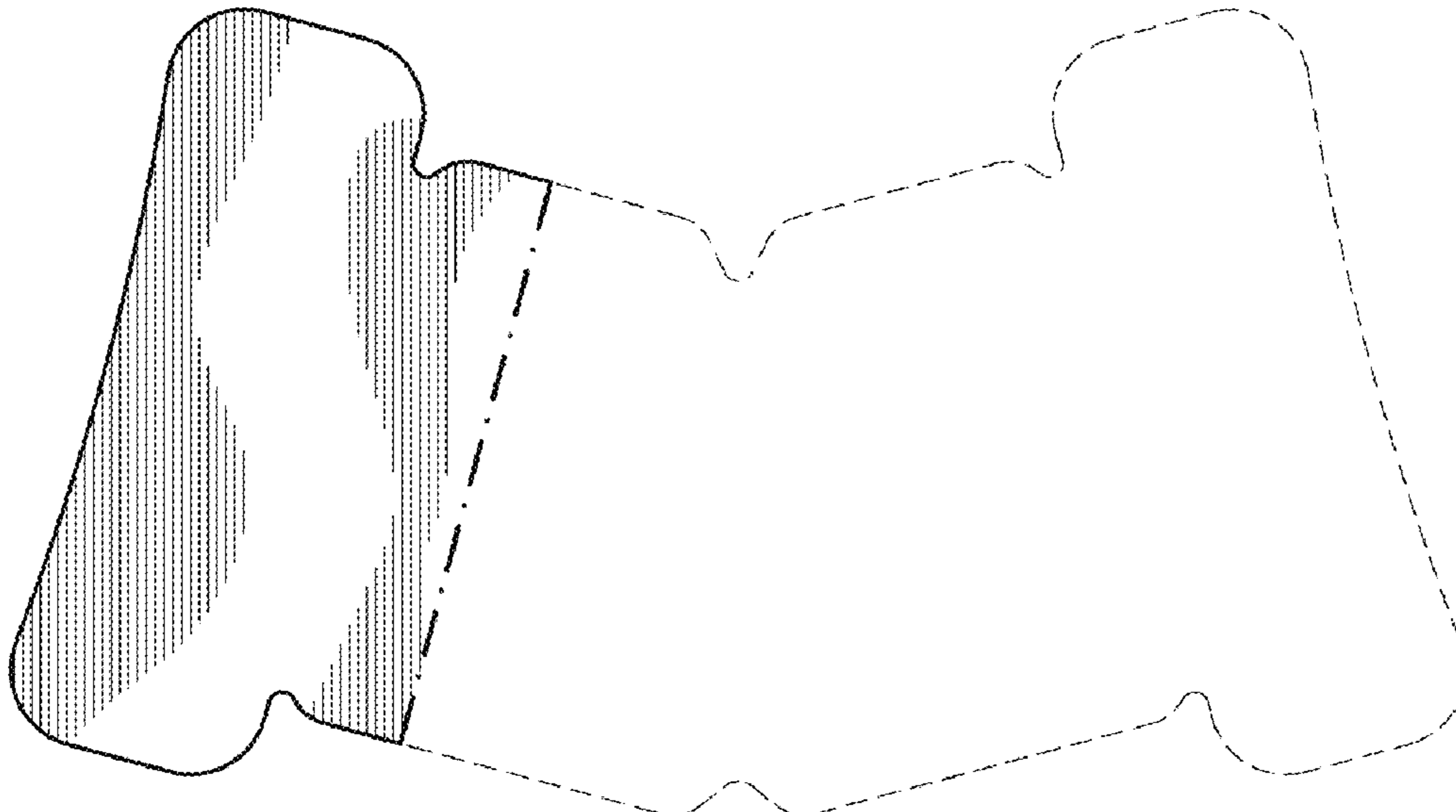
(57) **CLAIM**

The ornamental design for a bandage, as shown and described.

DESCRIPTION

FIG. 1 is a top view of a bandage of our design. FIG. 2 is a first side view of the bandage of FIG. 1. FIG. 3 is a second side view of the bandage of FIG. 1. FIG. 4 is a third side view of the bandage of FIG. 1. FIG. 5 is a fourth side view of the bandage of FIG. 1; and, FIG. 6 is a bottom view of the bandage of FIG. 1. The broken lines shown in FIGS. 1-6 illustrate portions of the bandage that form no part of the claimed design. The dash-dot-dot lines illustrate a boundary that forms no part of the claim.

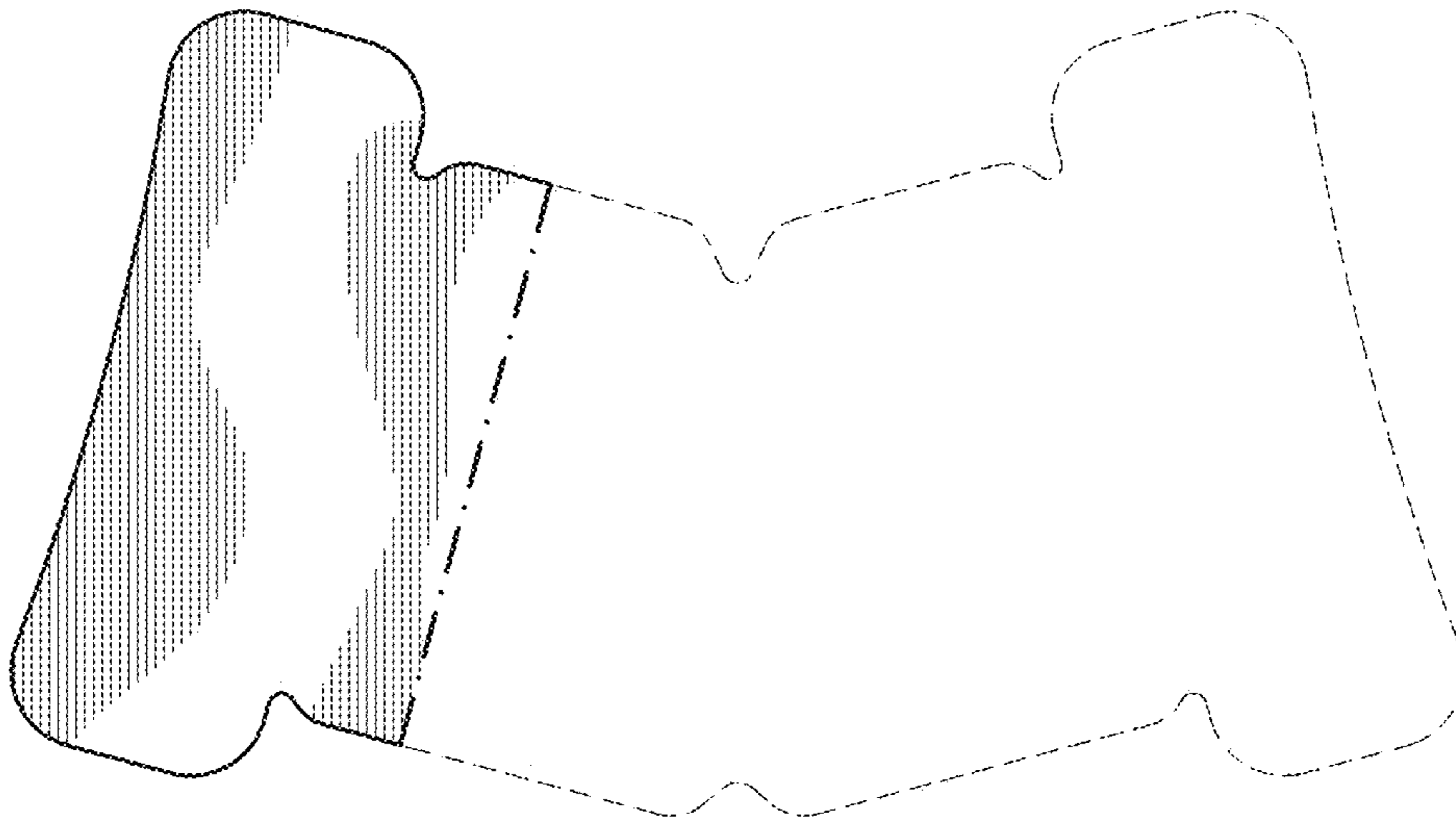

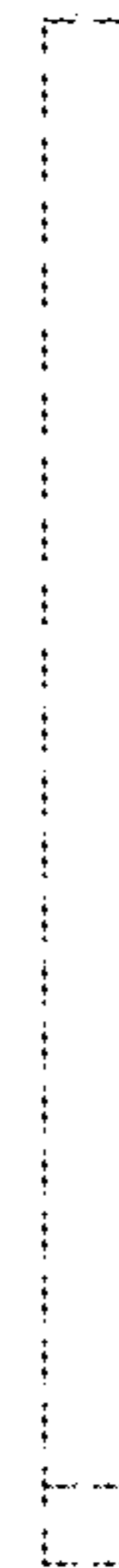

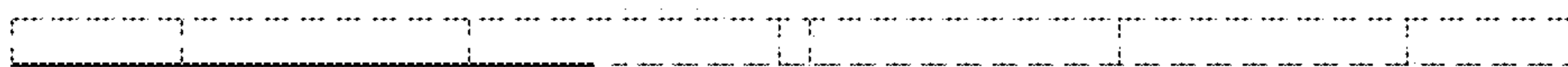

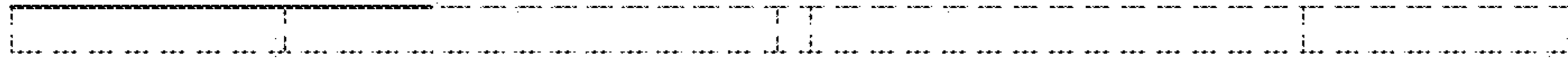

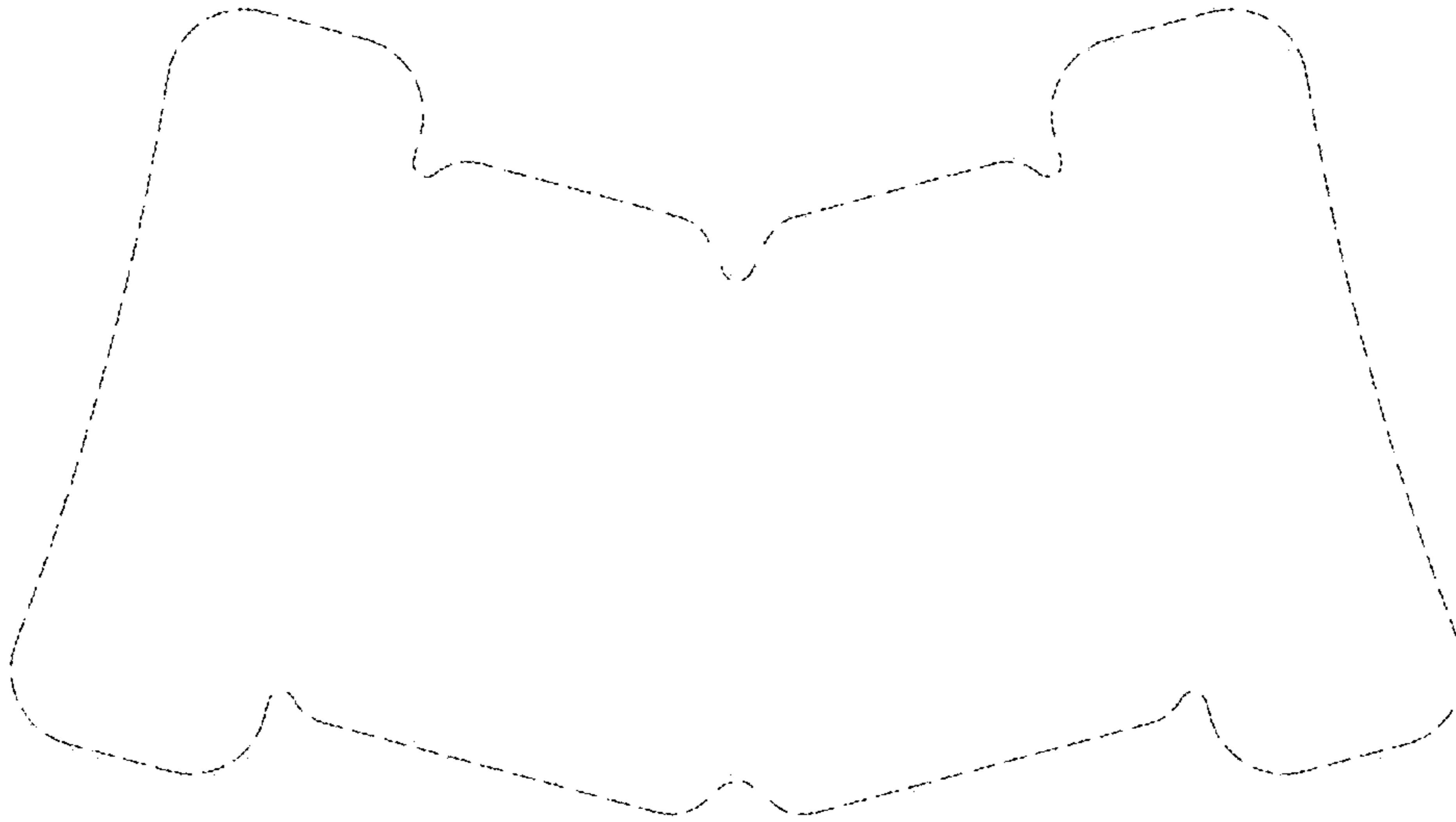
