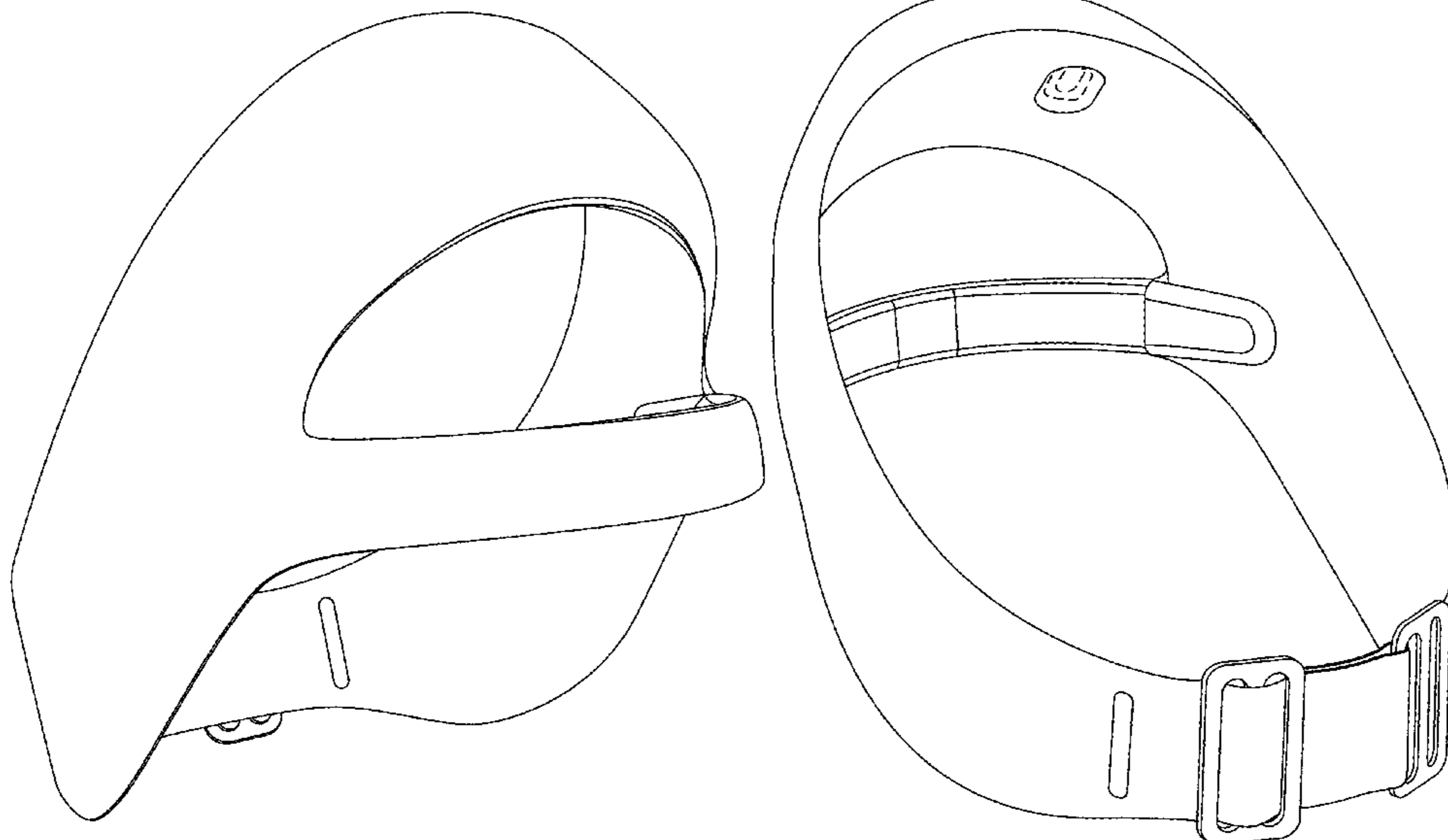

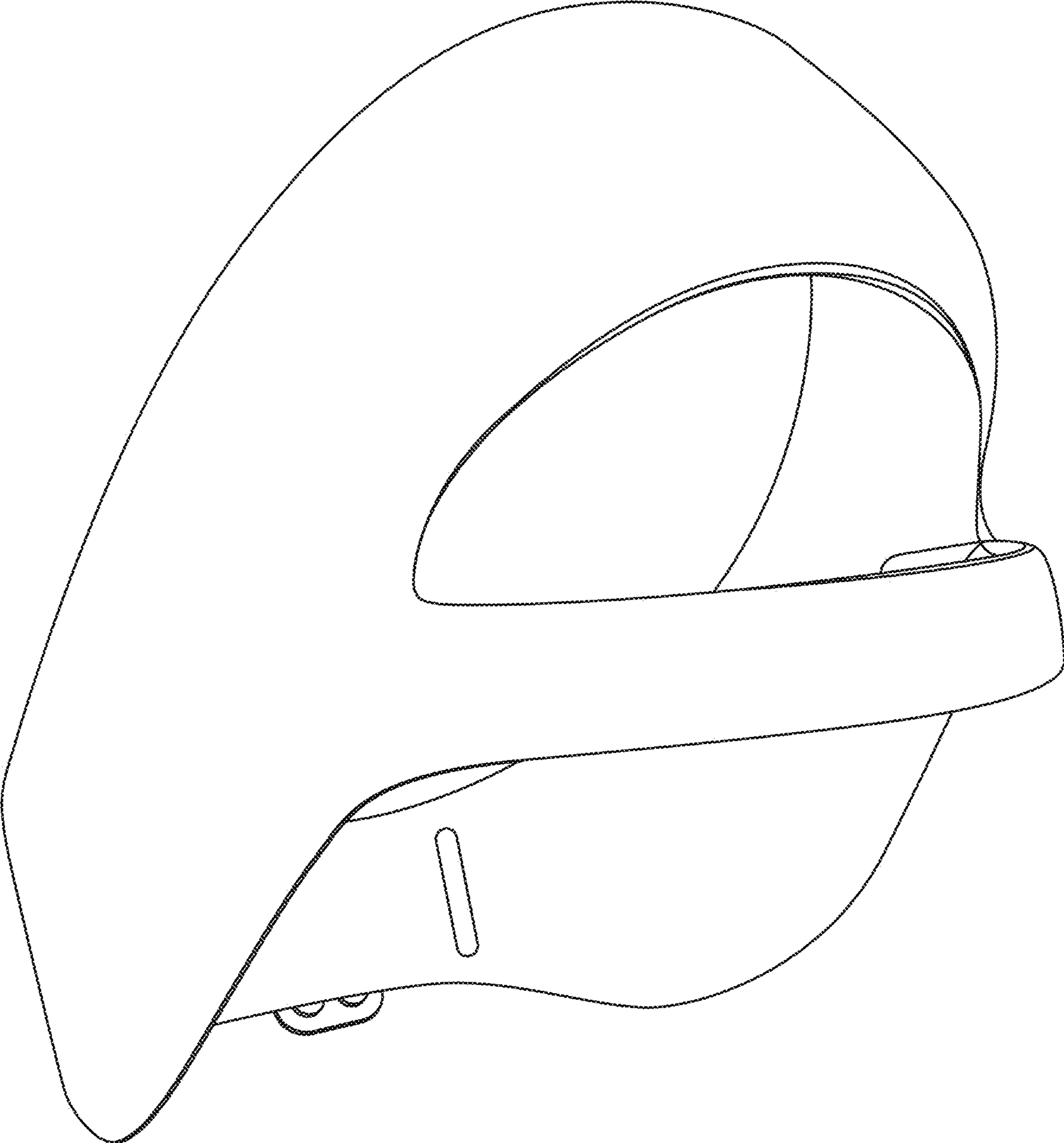

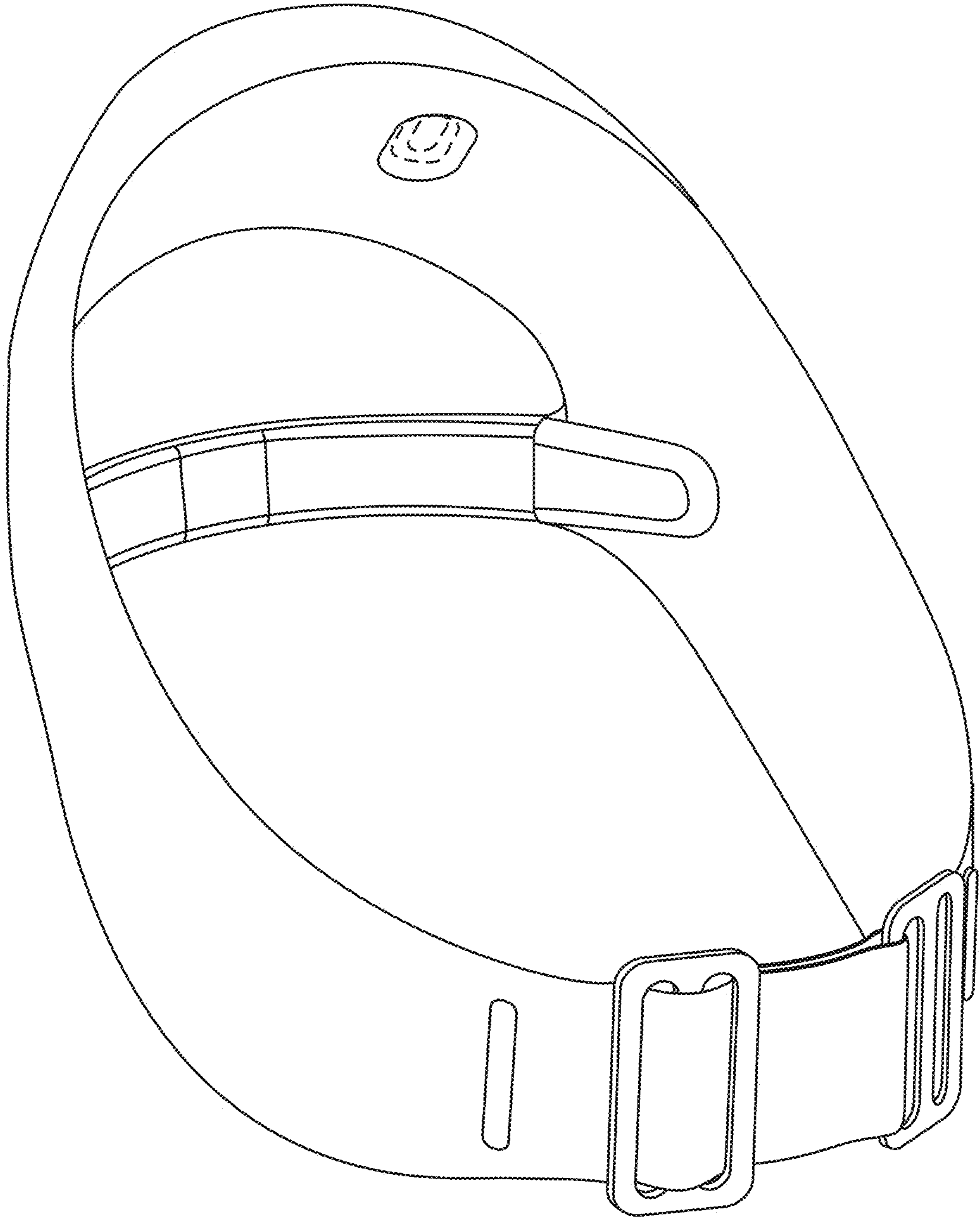
The broken lines in the figures illustrate portions of the sleep enhancement head mount that form no part of the claimed design.

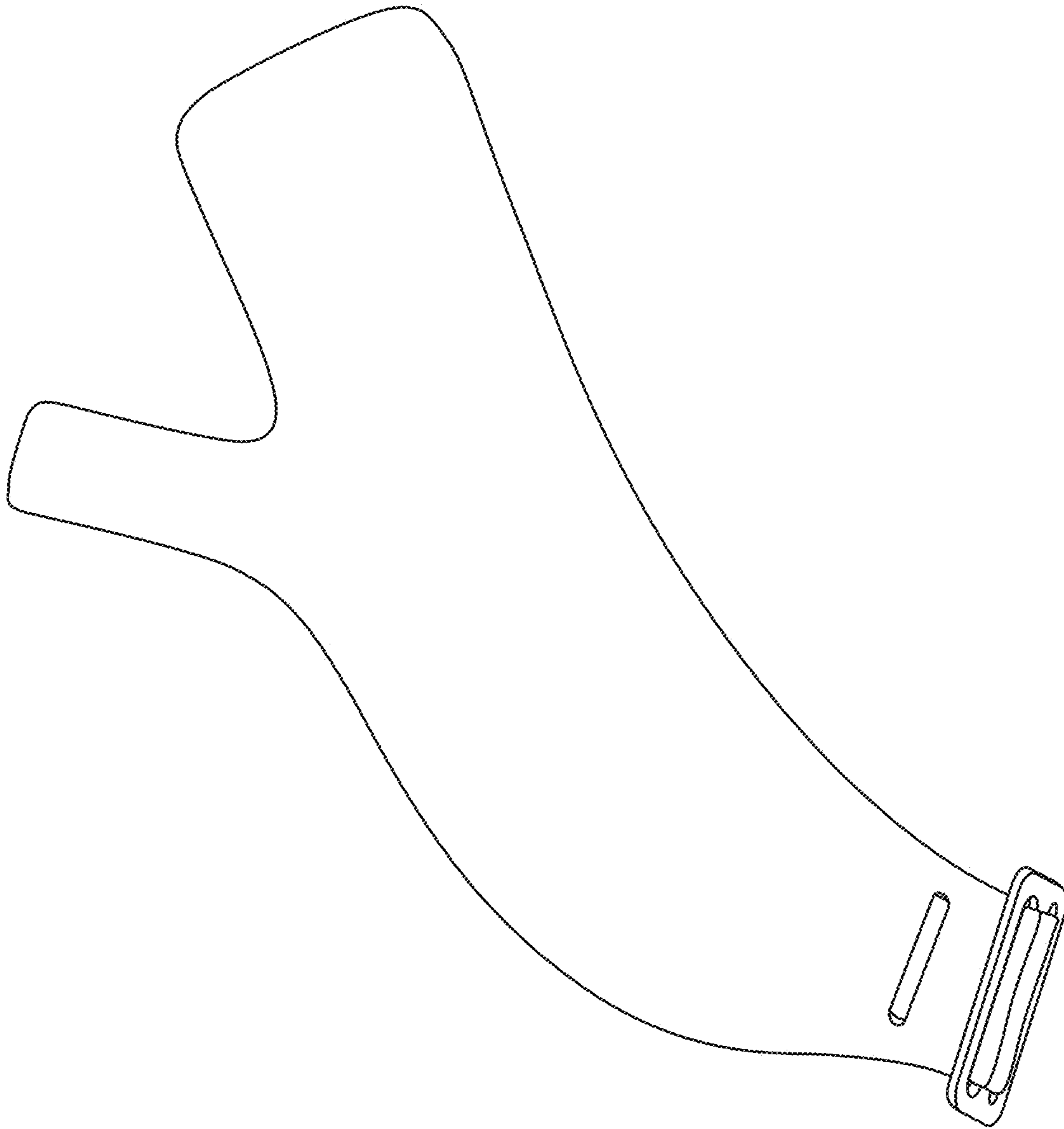




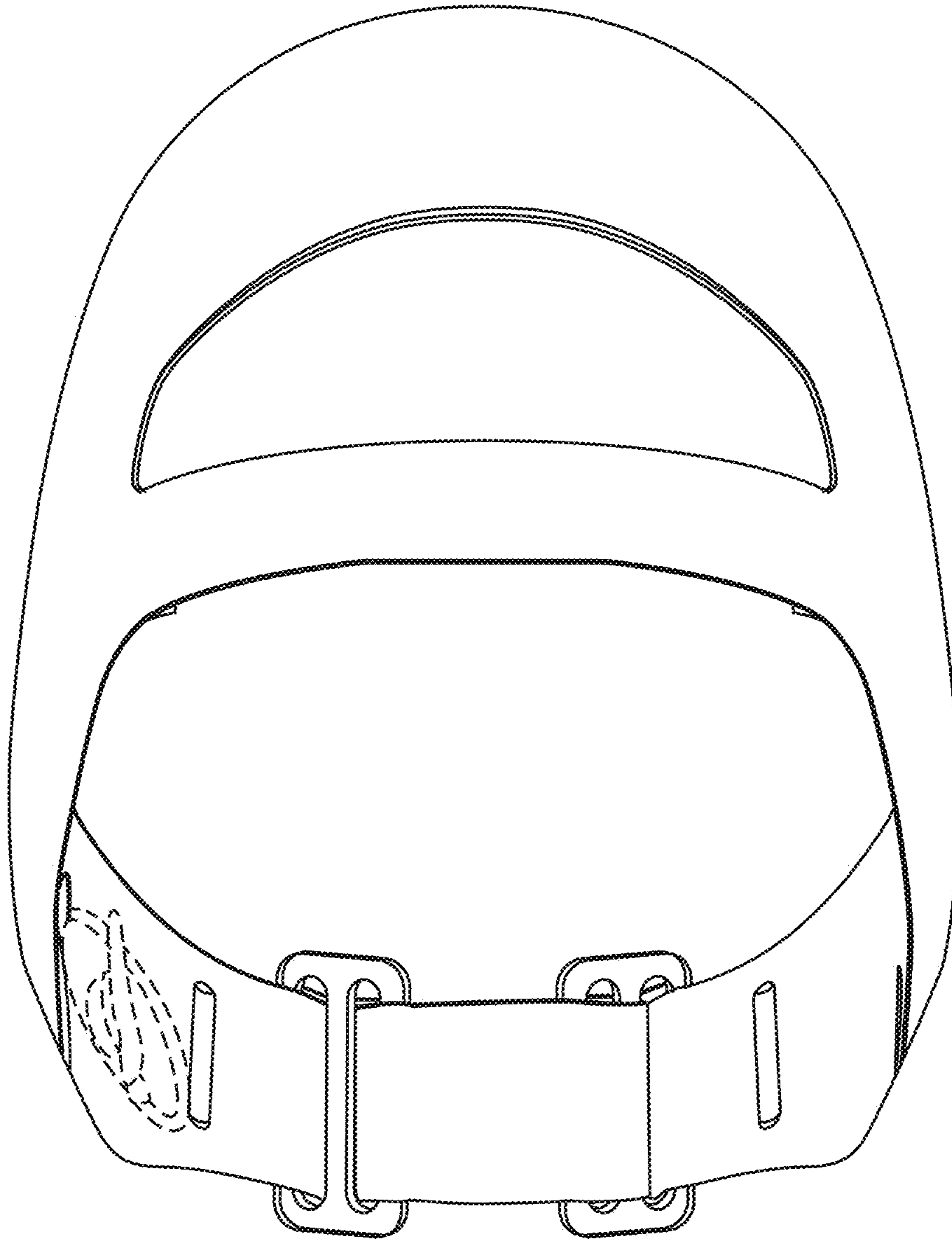

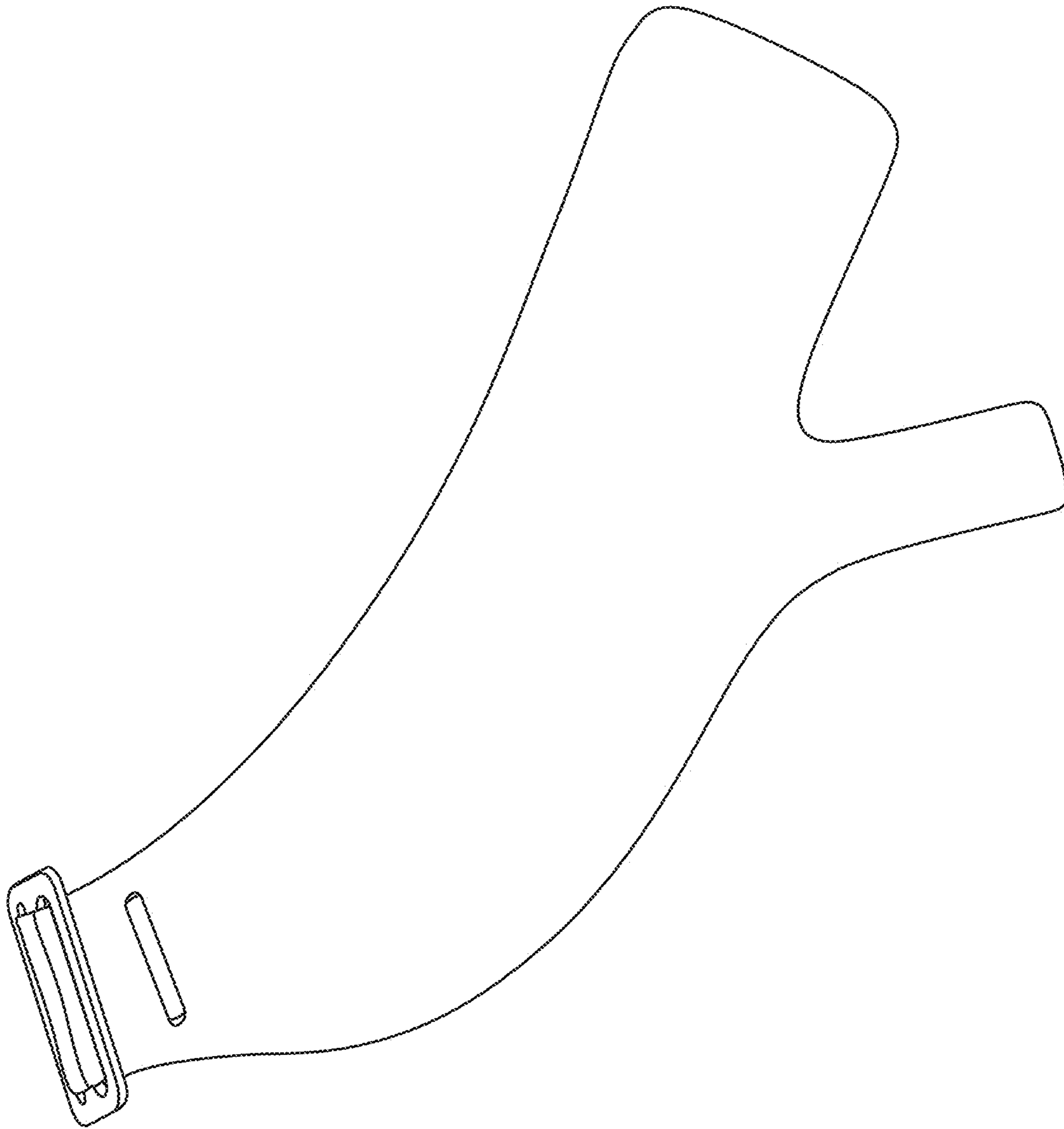

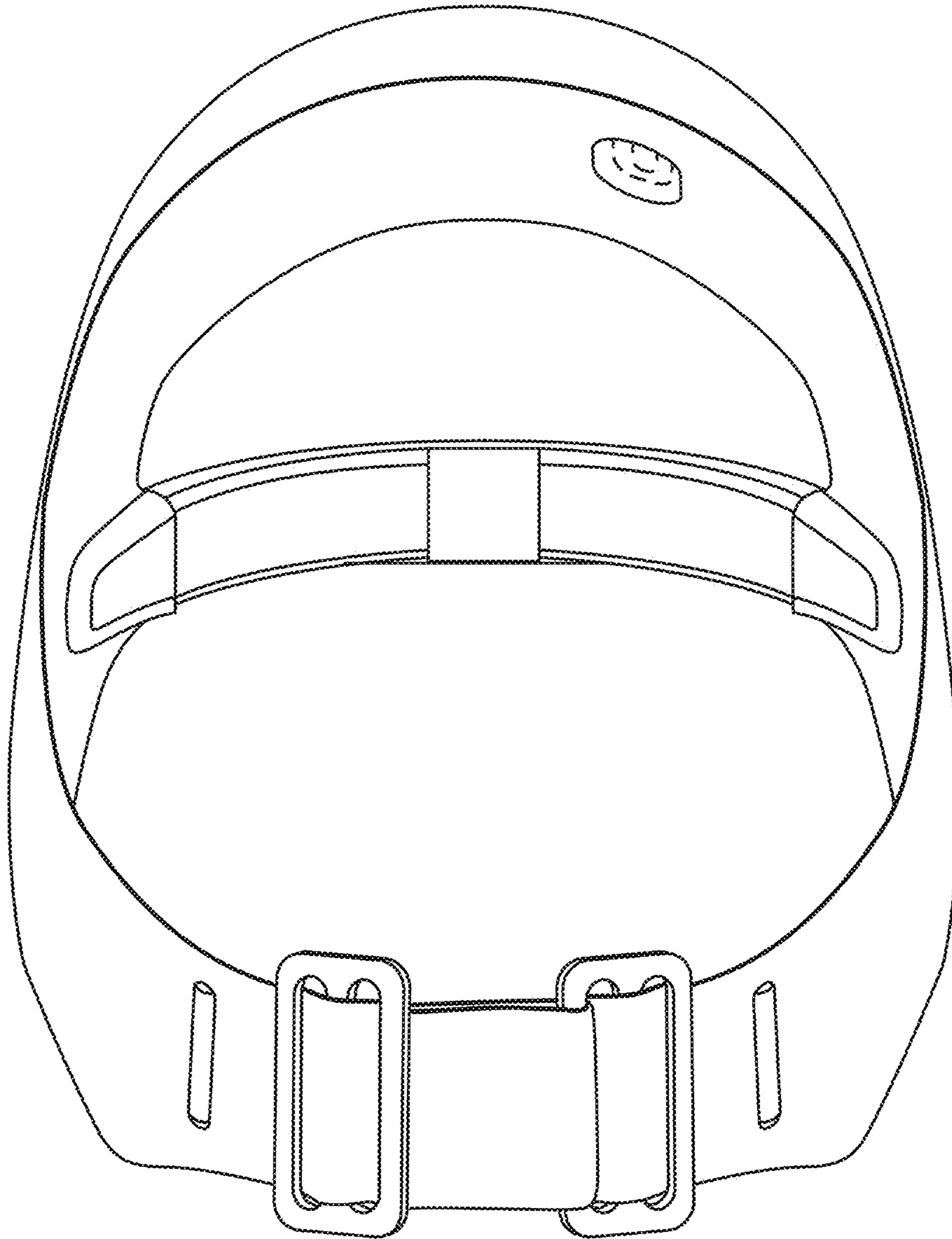

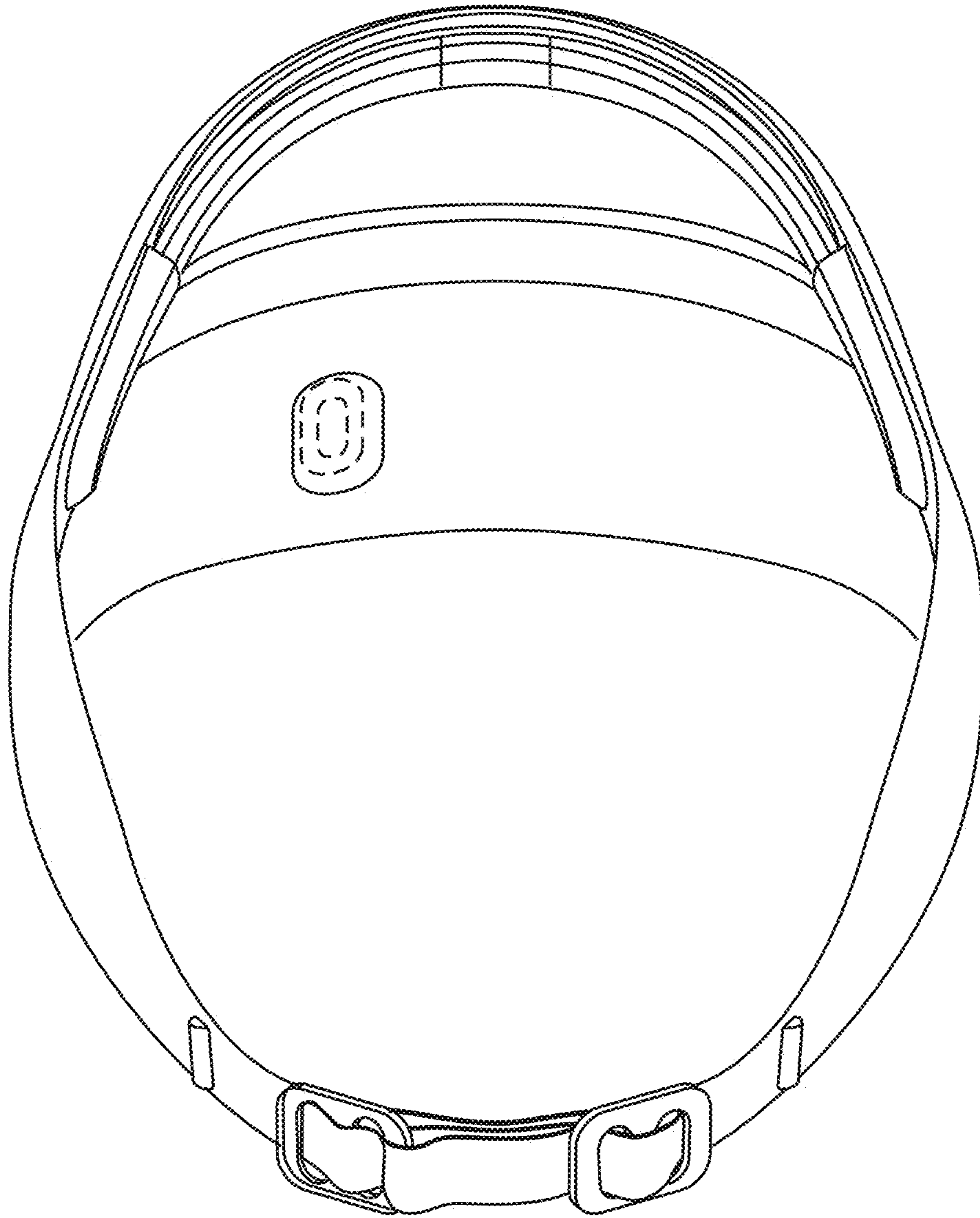

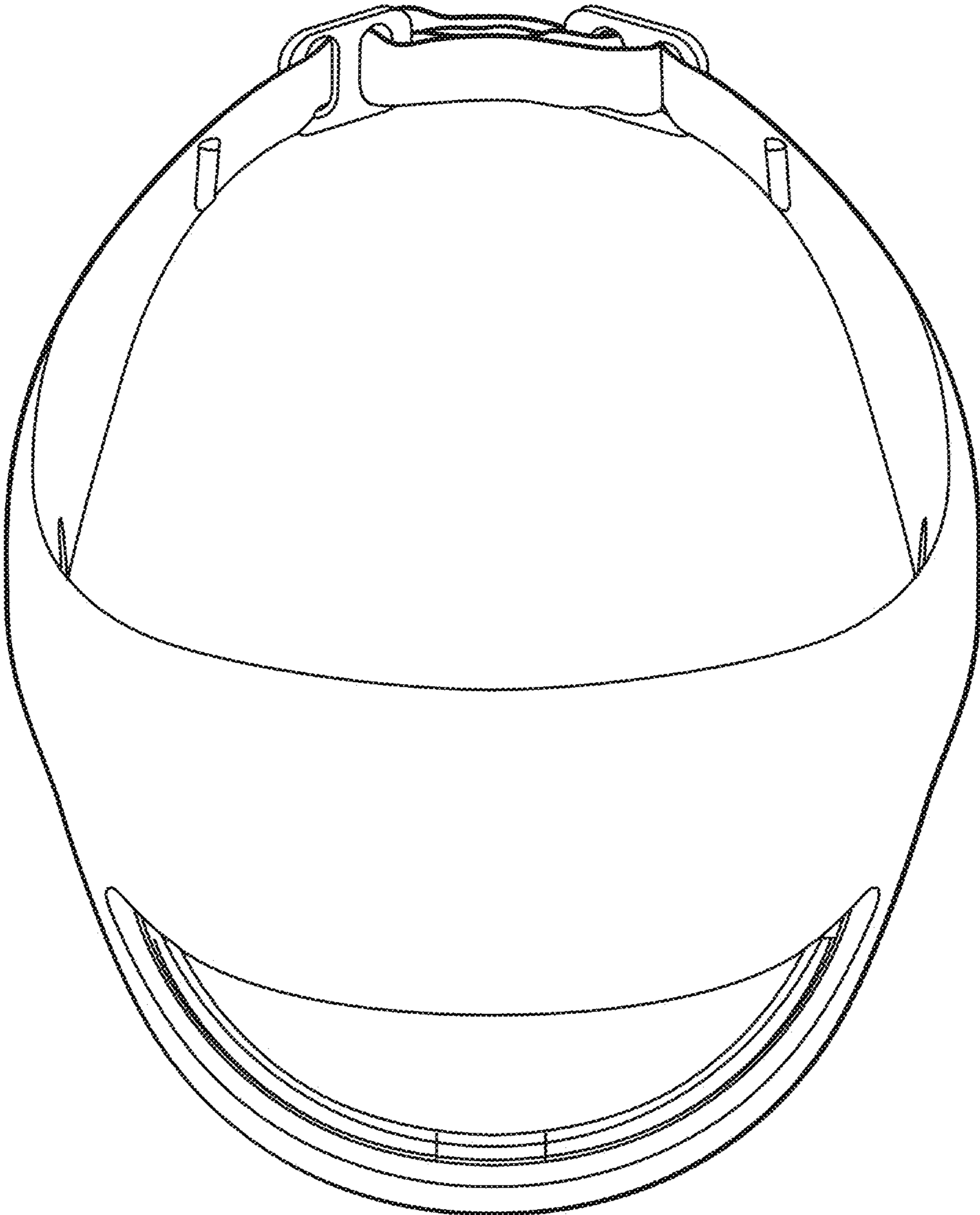
