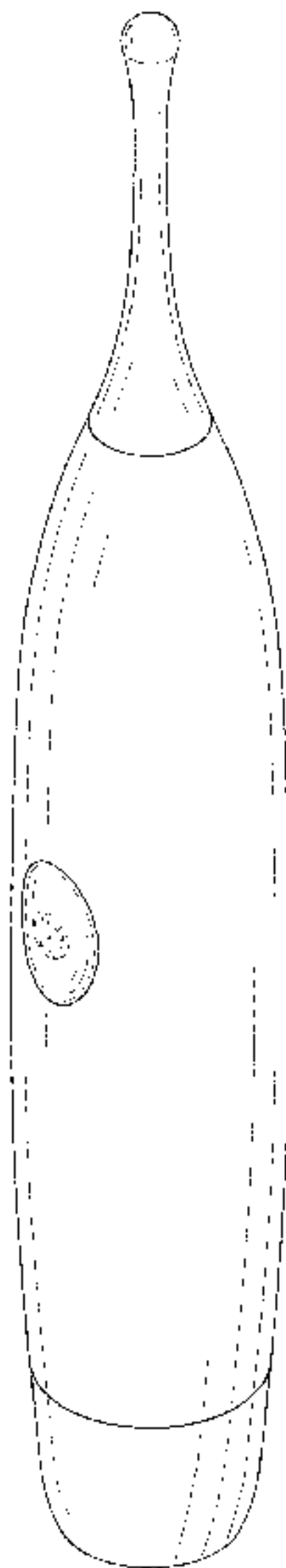
(57) CLAIM

The ornamental design for a vibration massager, as shown and described.

DESCRIPTION

FIG. 1 is a front top perspective view of a vibration massager, showing my new design;
FIG. 2 is a rear bottom perspective view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a left side elevational view thereof;
FIG. 6 is a right side elevational view thereof;

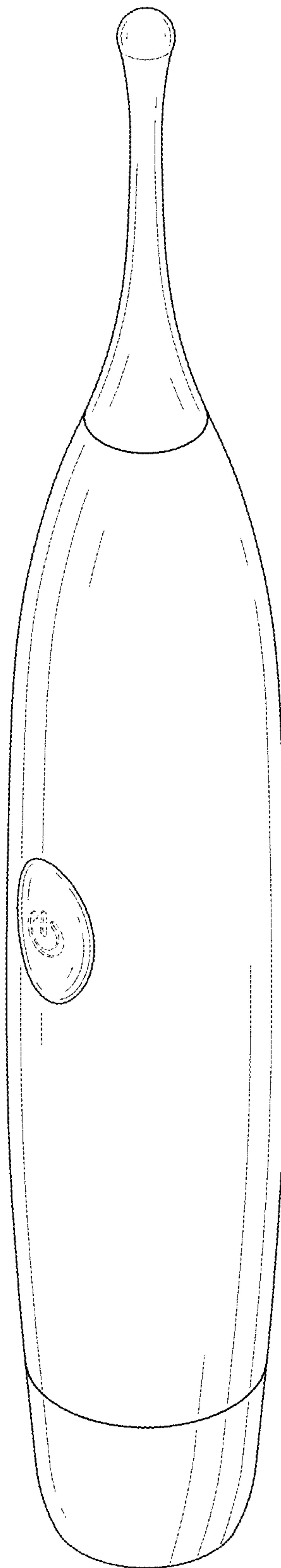

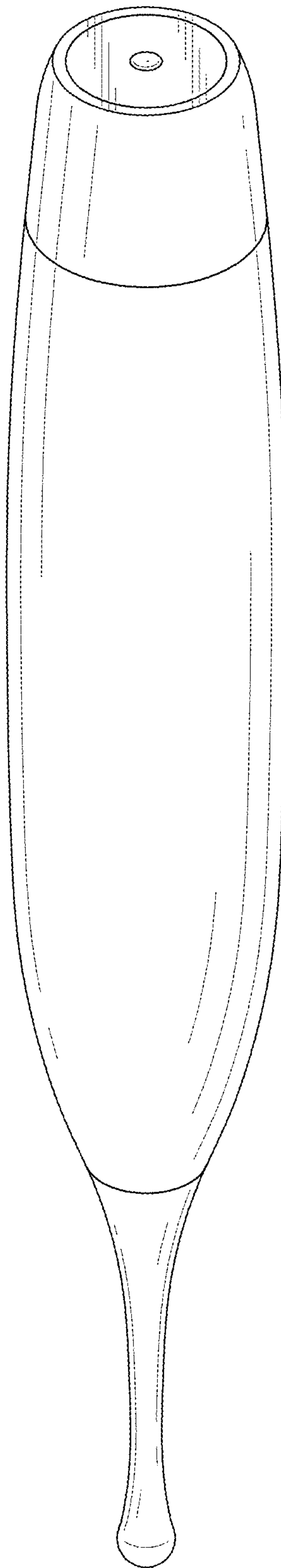

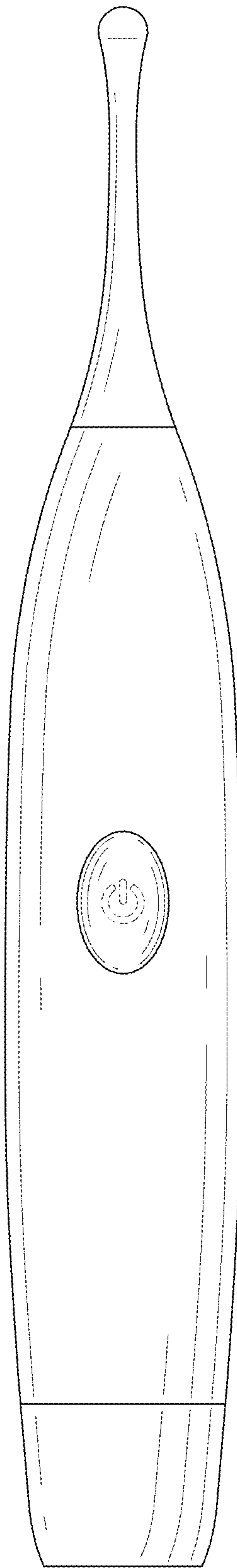

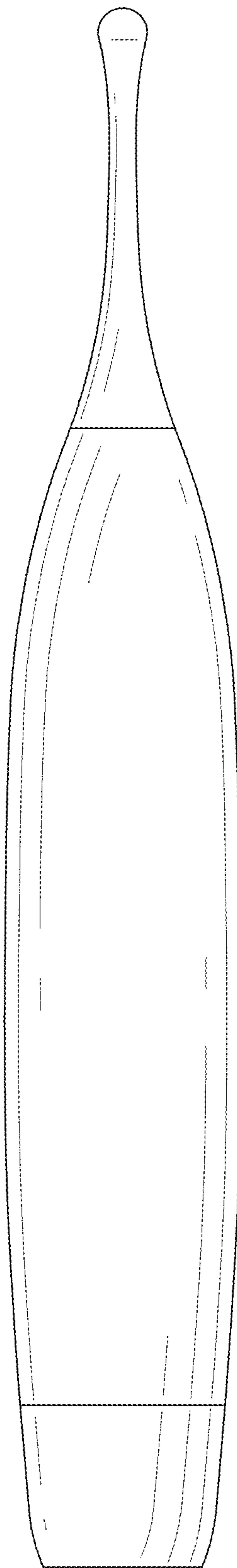

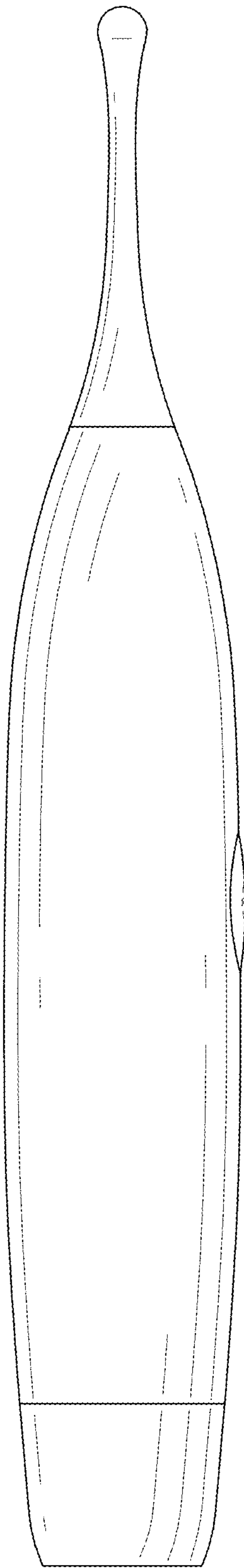

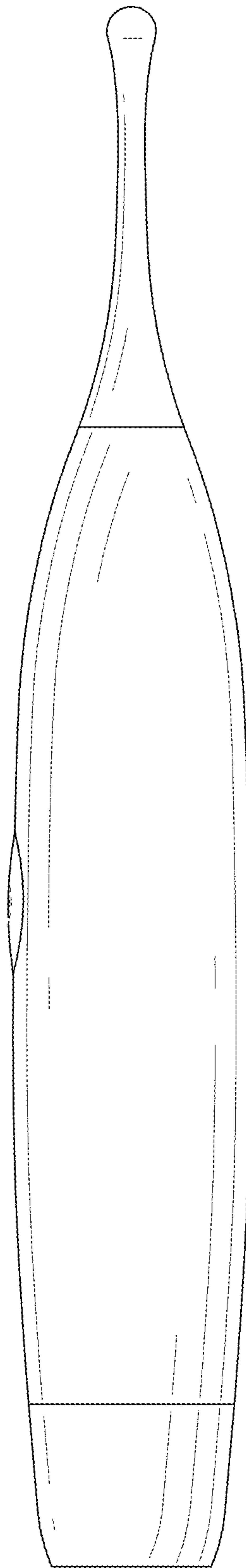

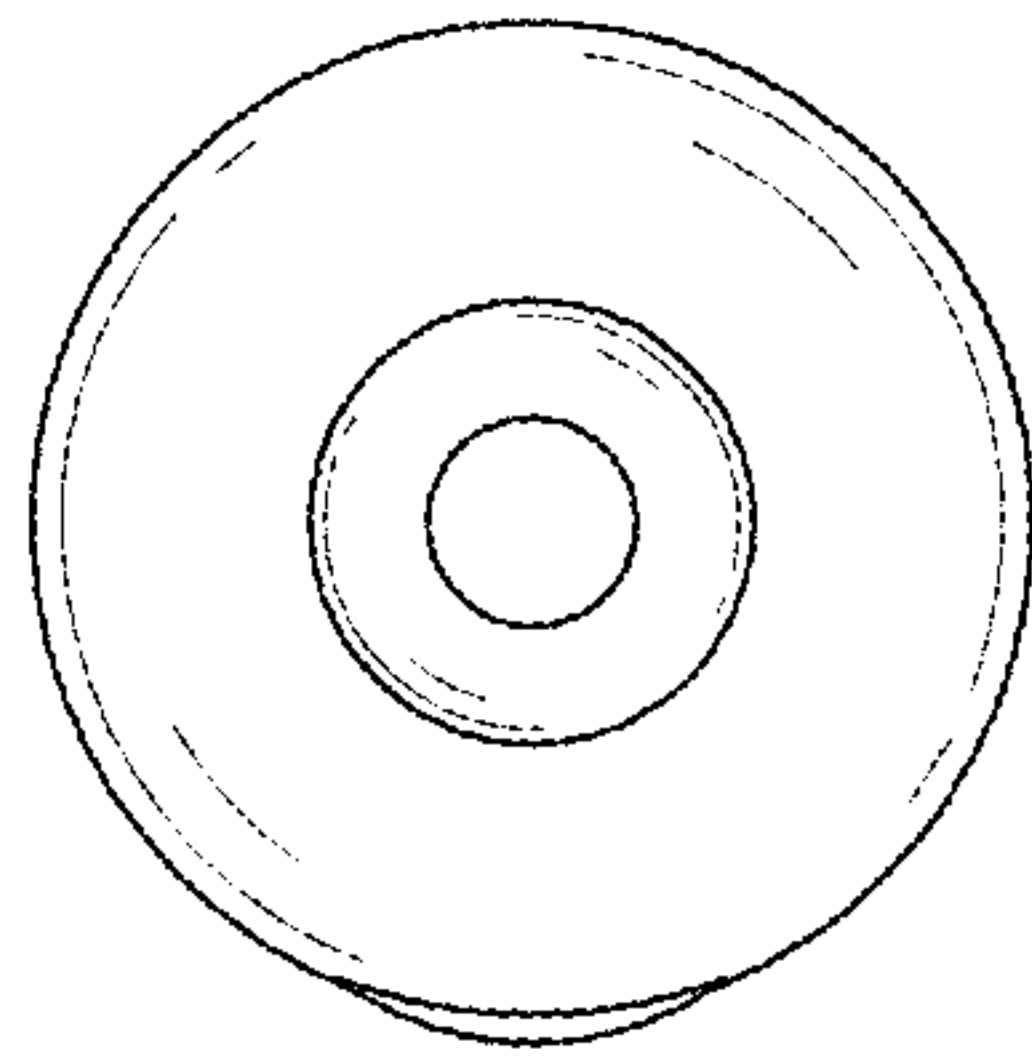

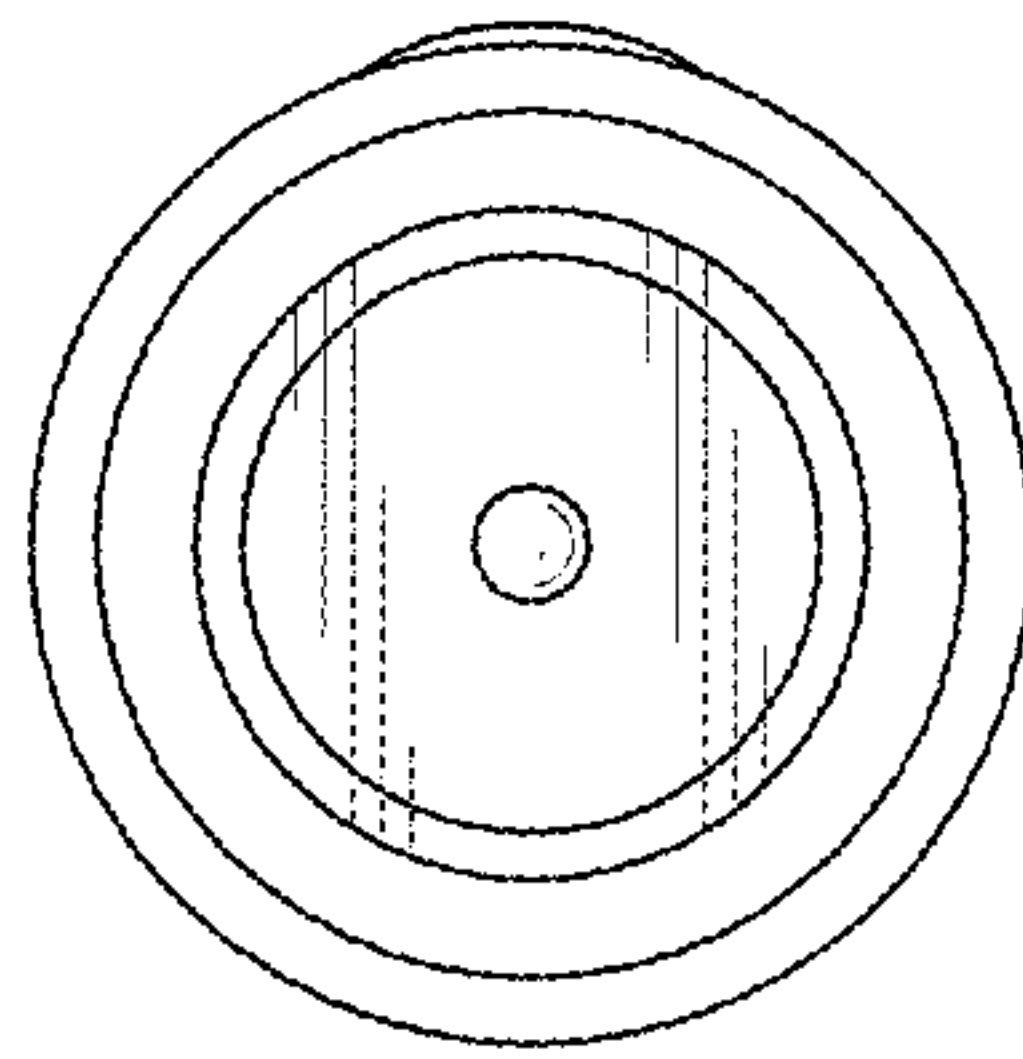
