(57) **CLAIM**

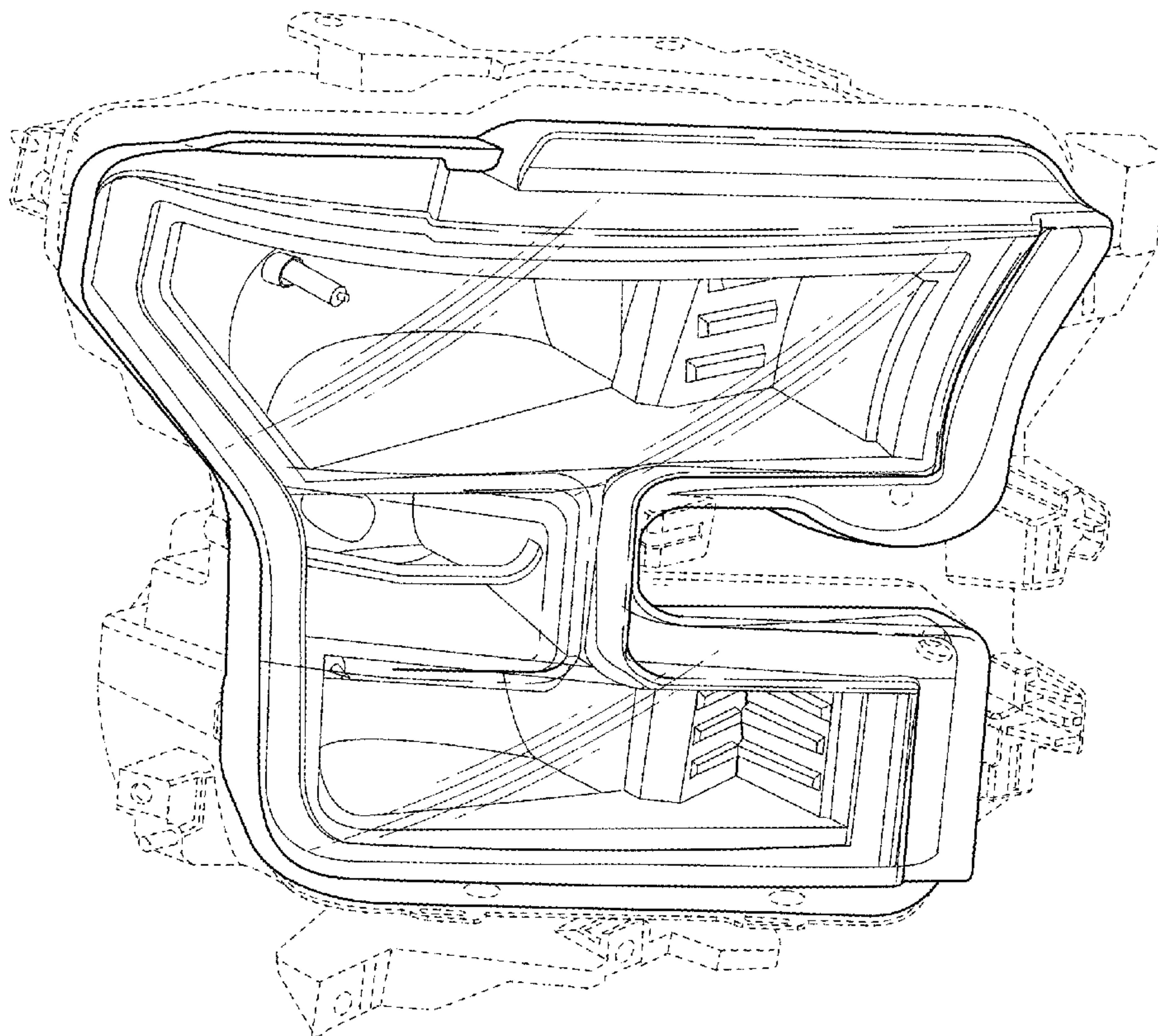
The ornamental design for an automobile headlight, as shown and described.

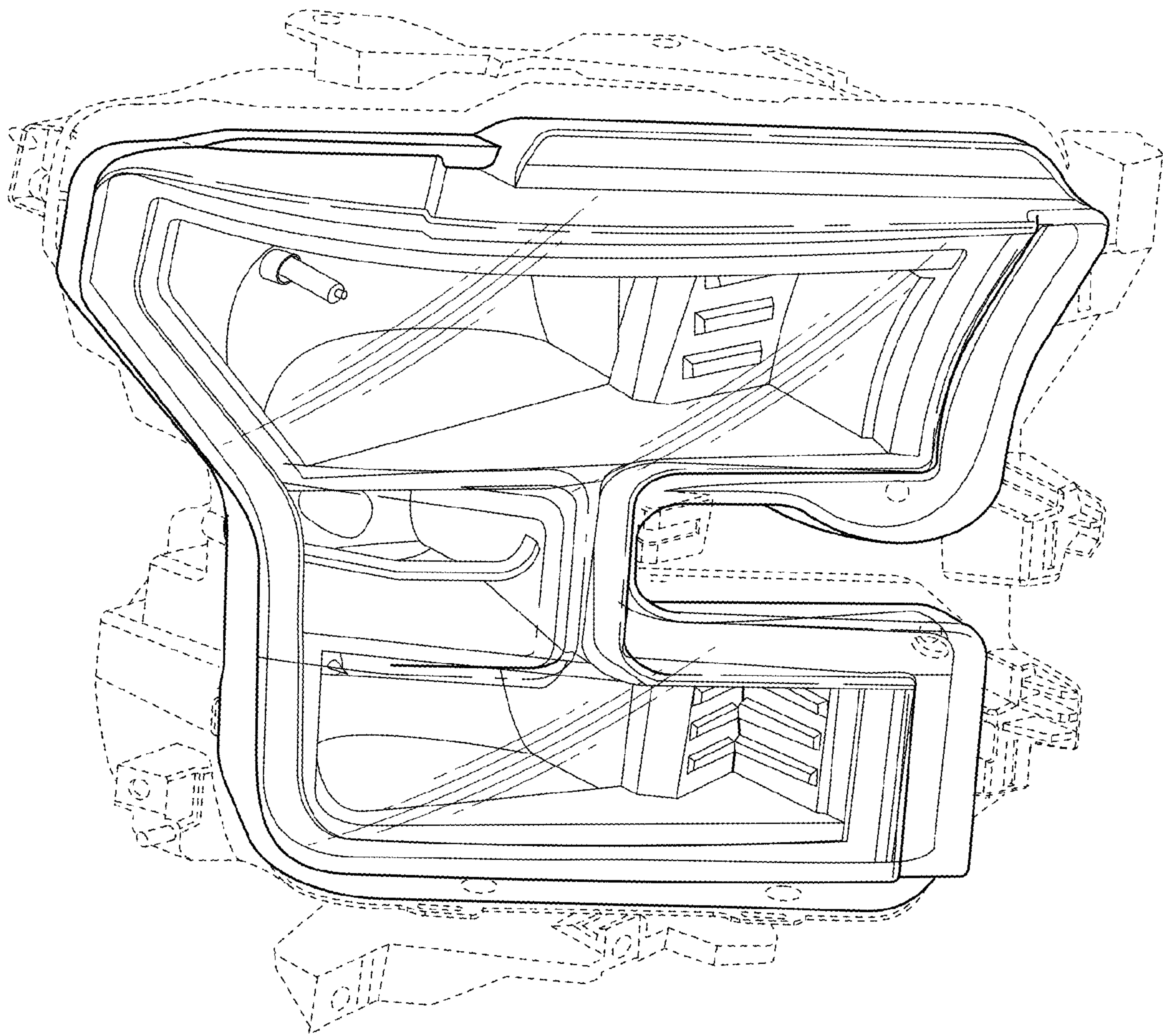

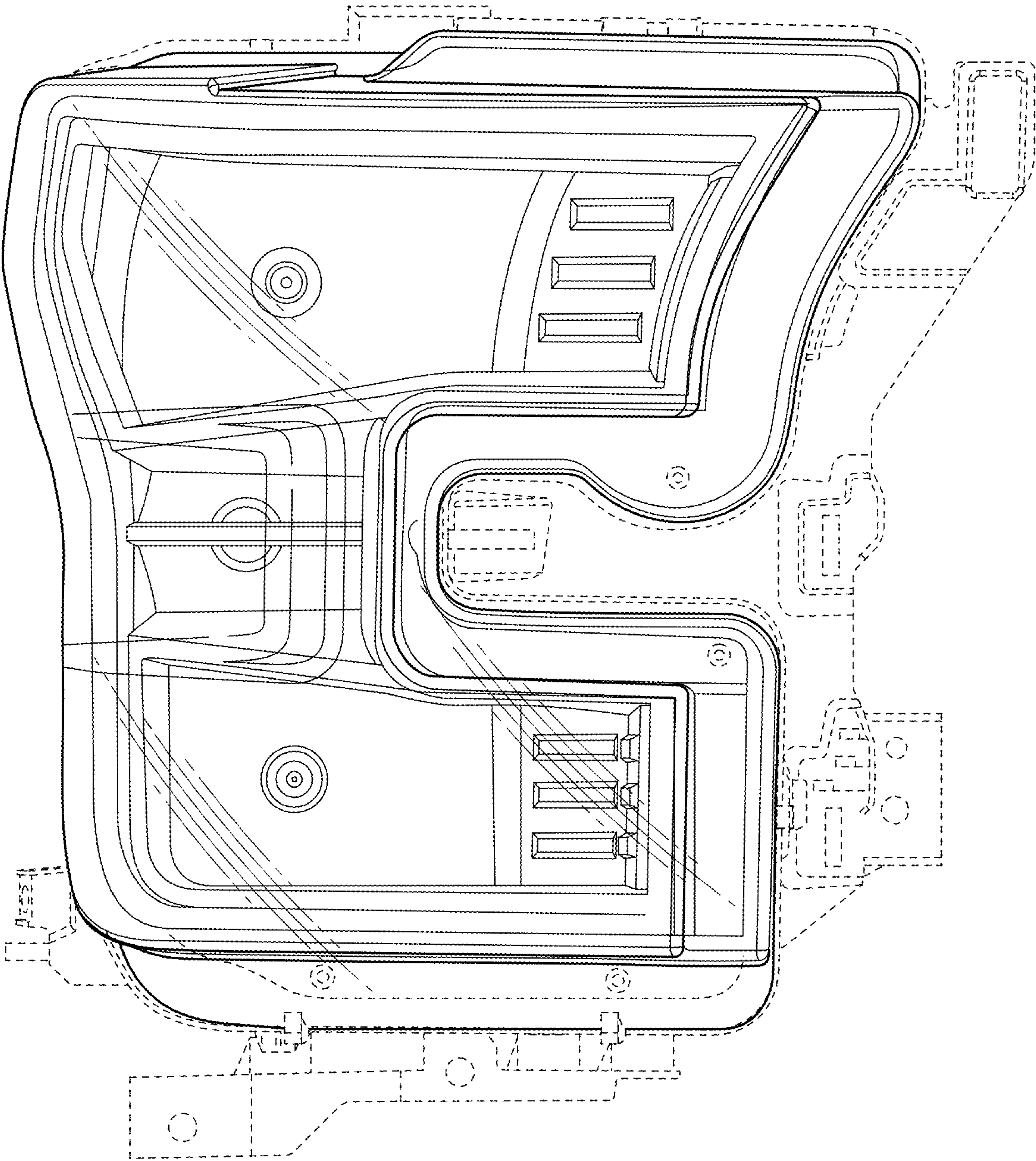

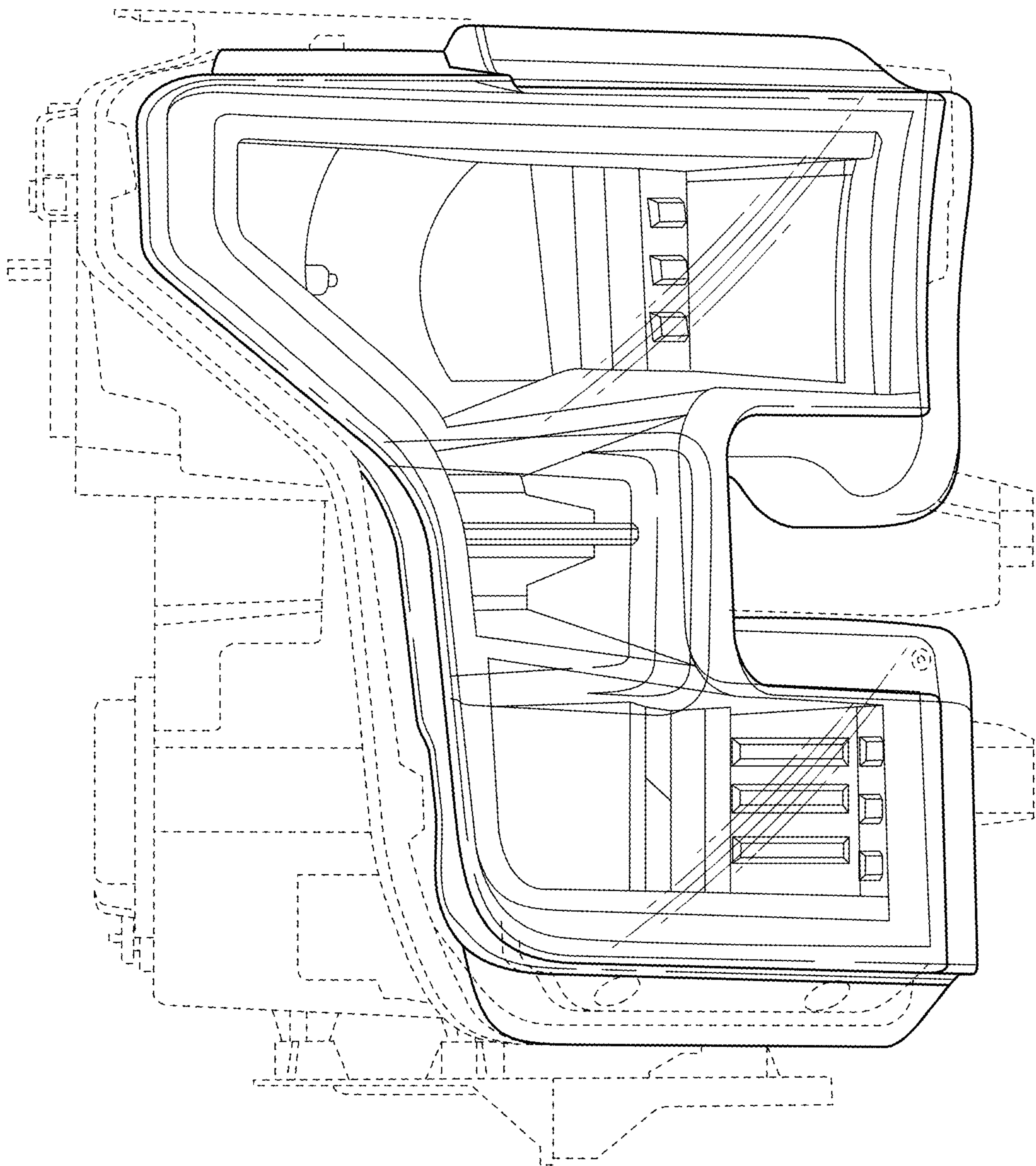
