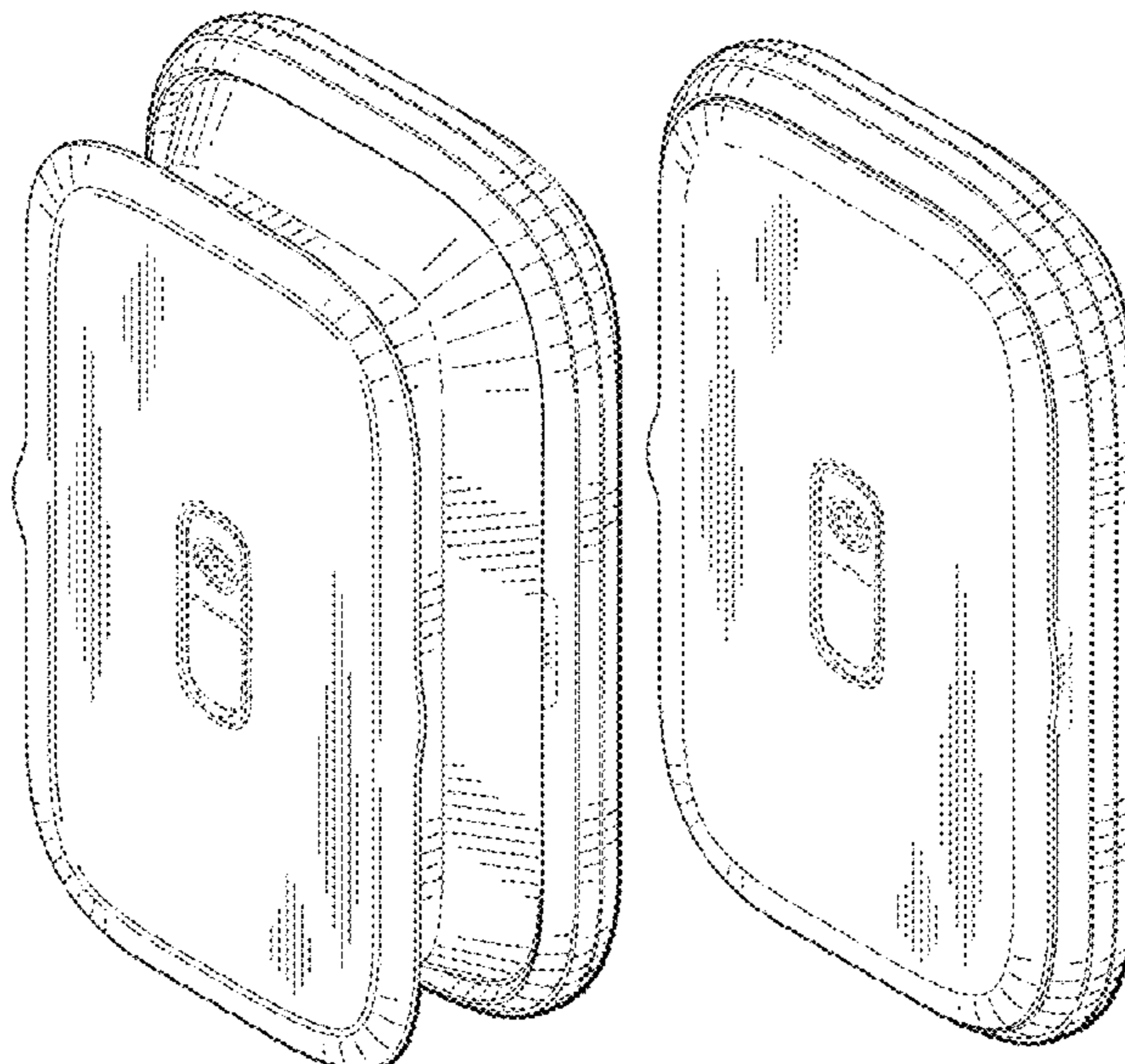
The ornamental design for a sanitizing case, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a sanitizing case showing our new design in an expanded configuration;
FIG. 2 is a front side view of the sanitizing case of FIG. 1;

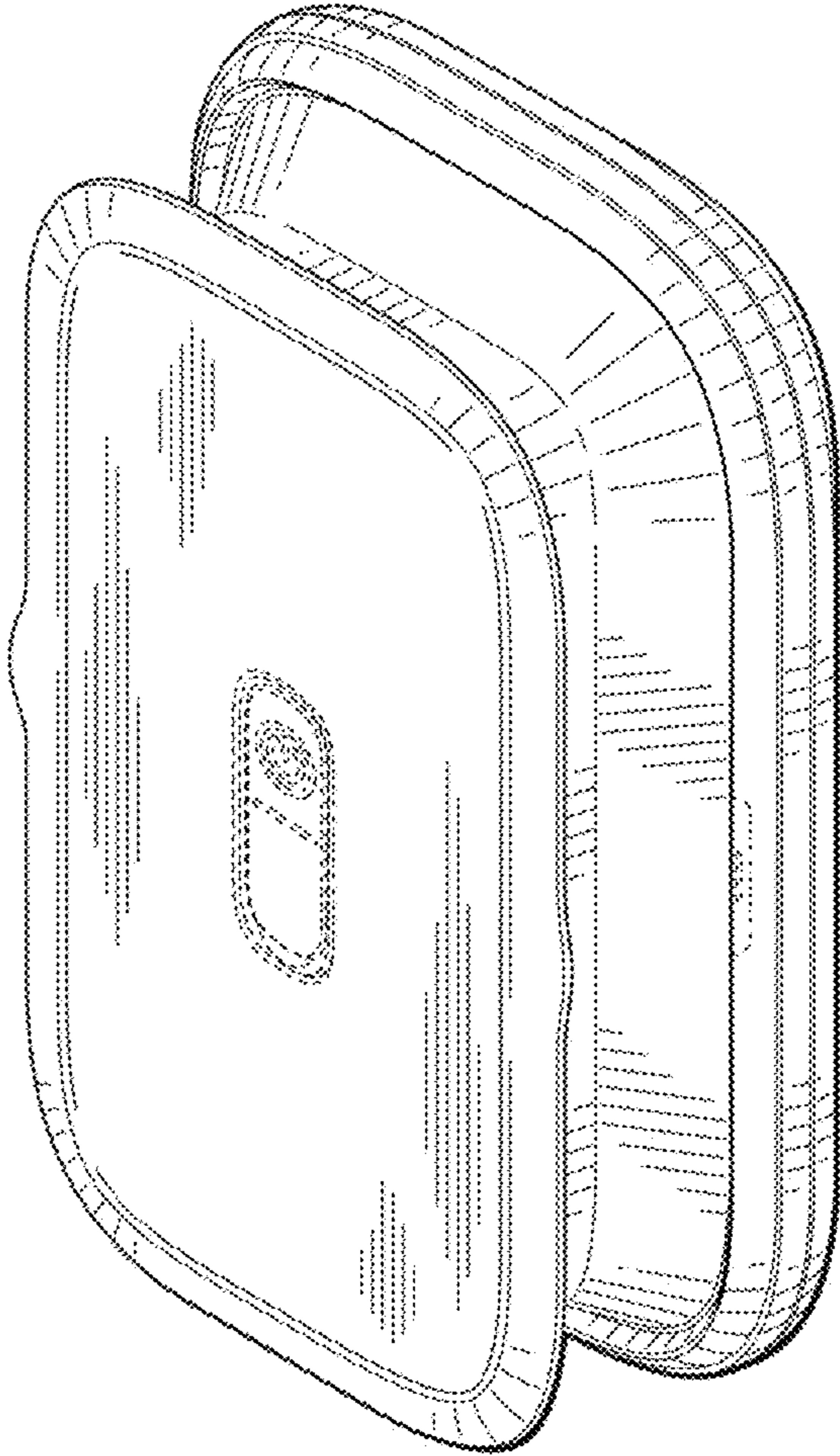

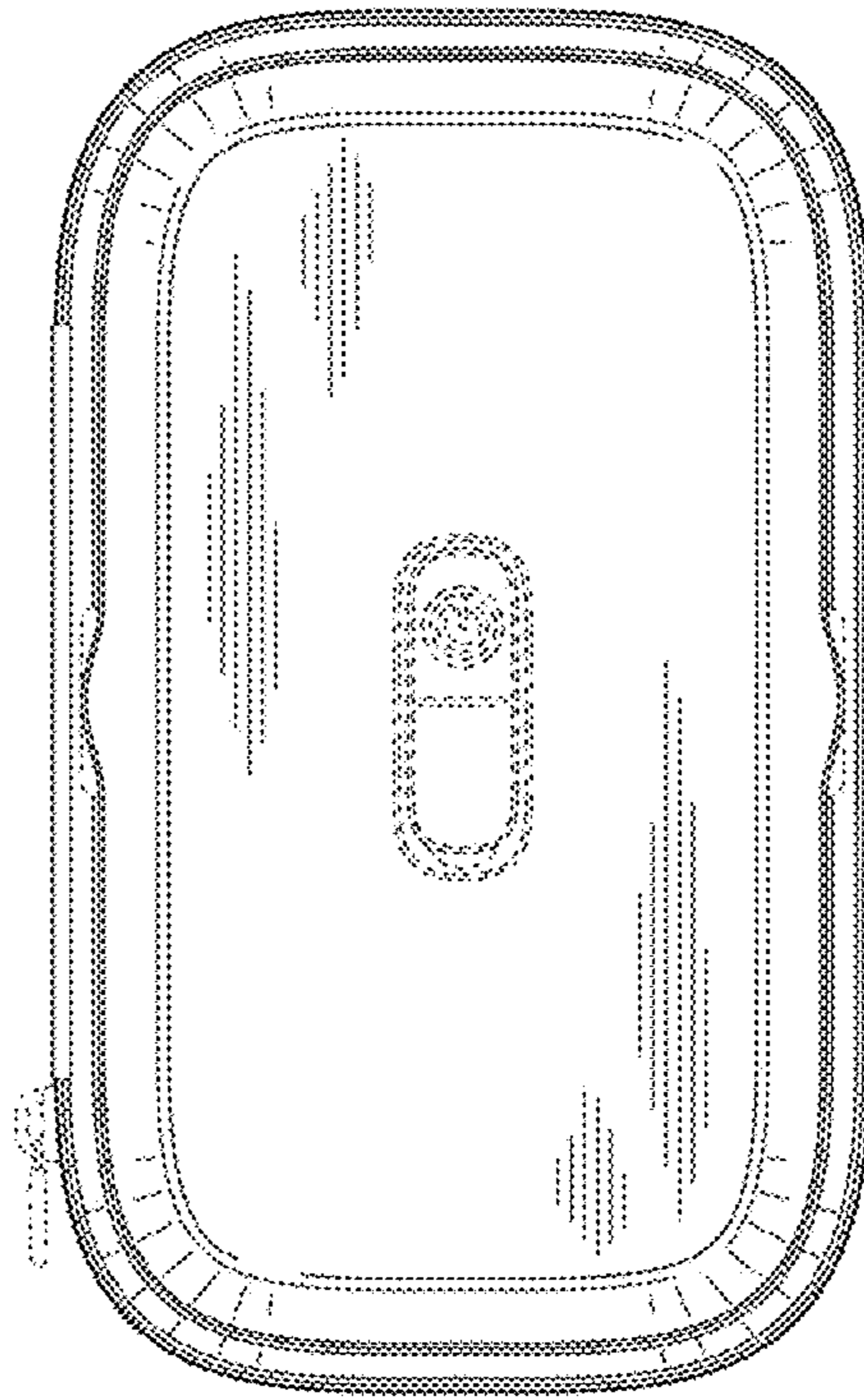

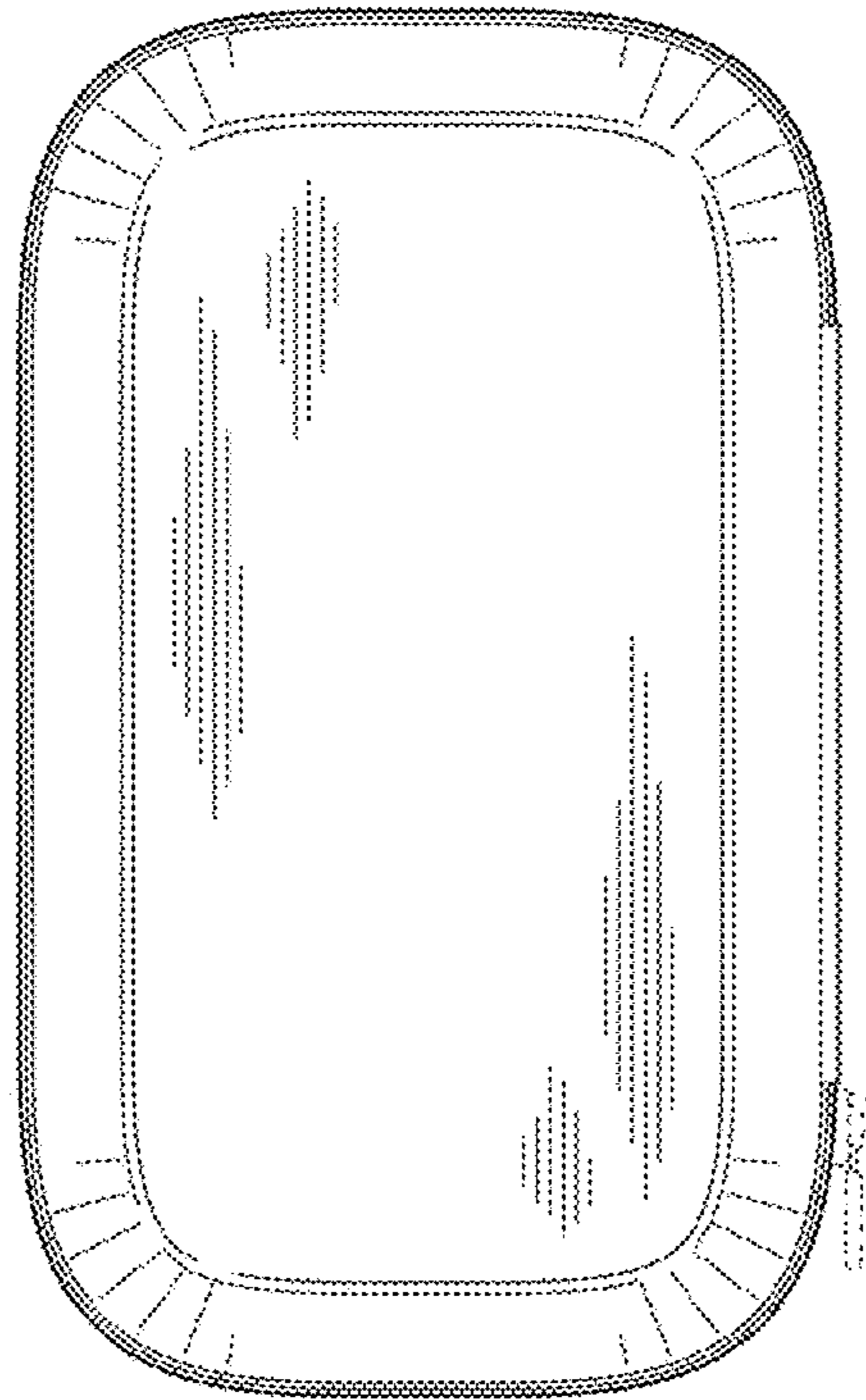

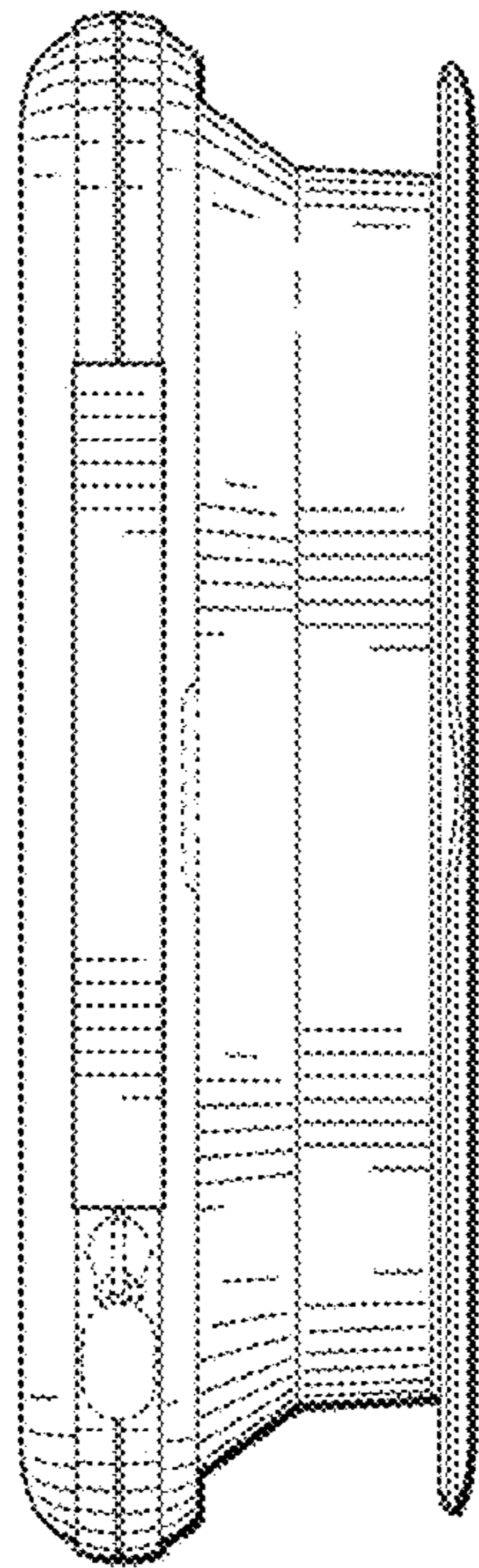

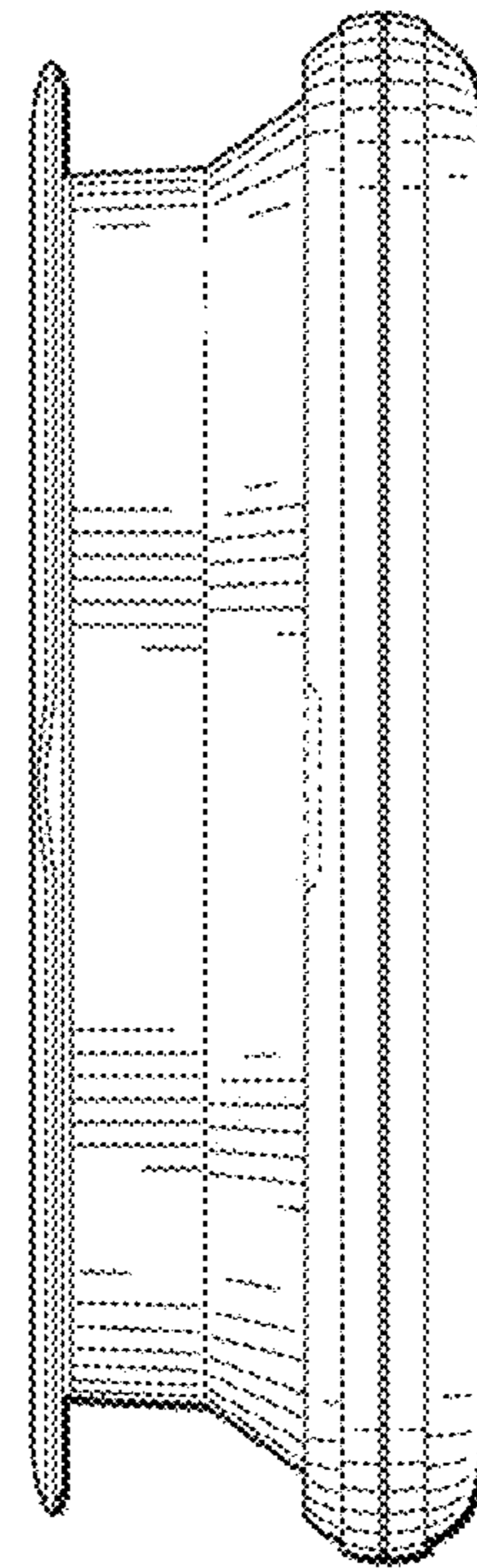

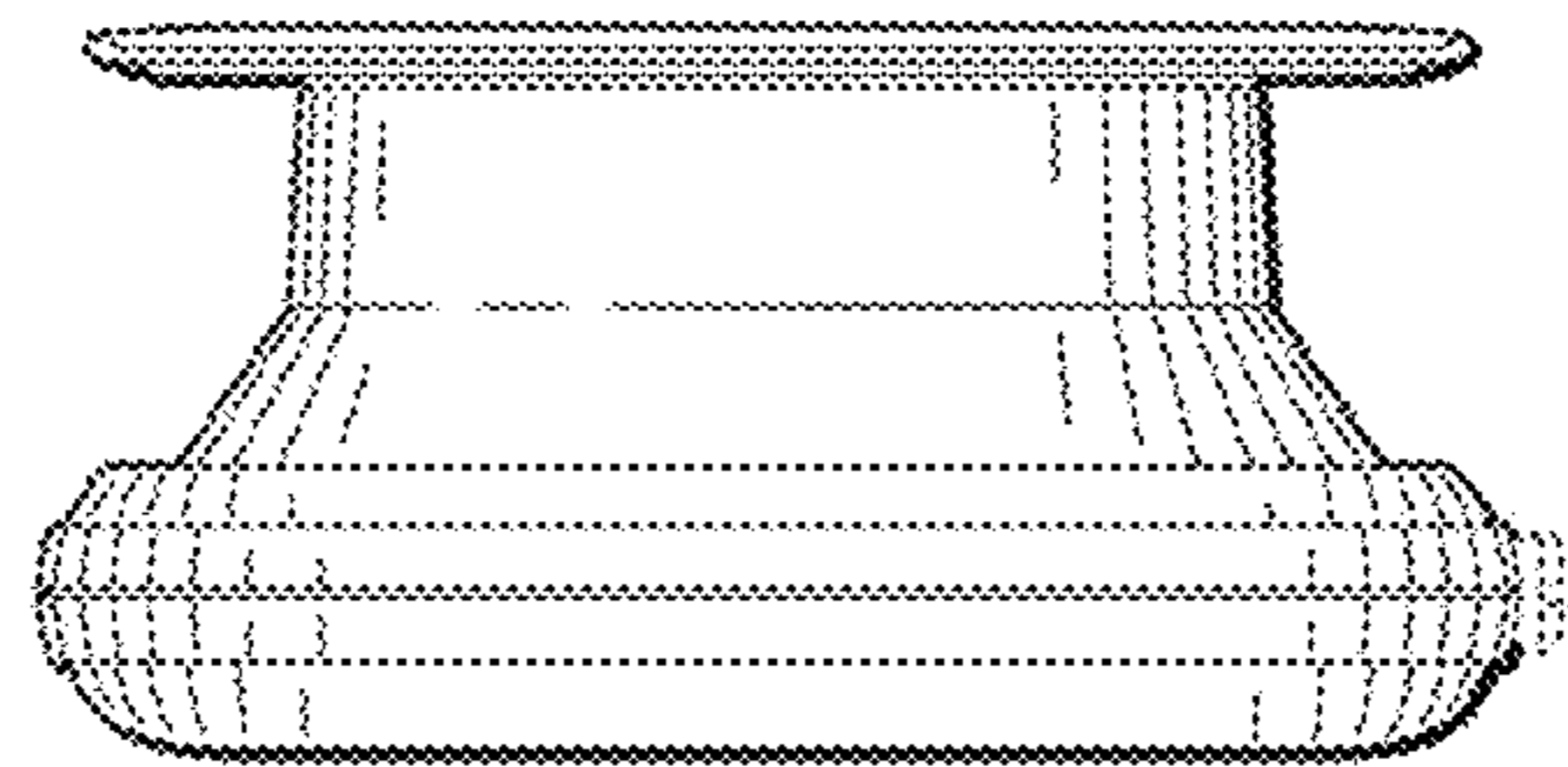

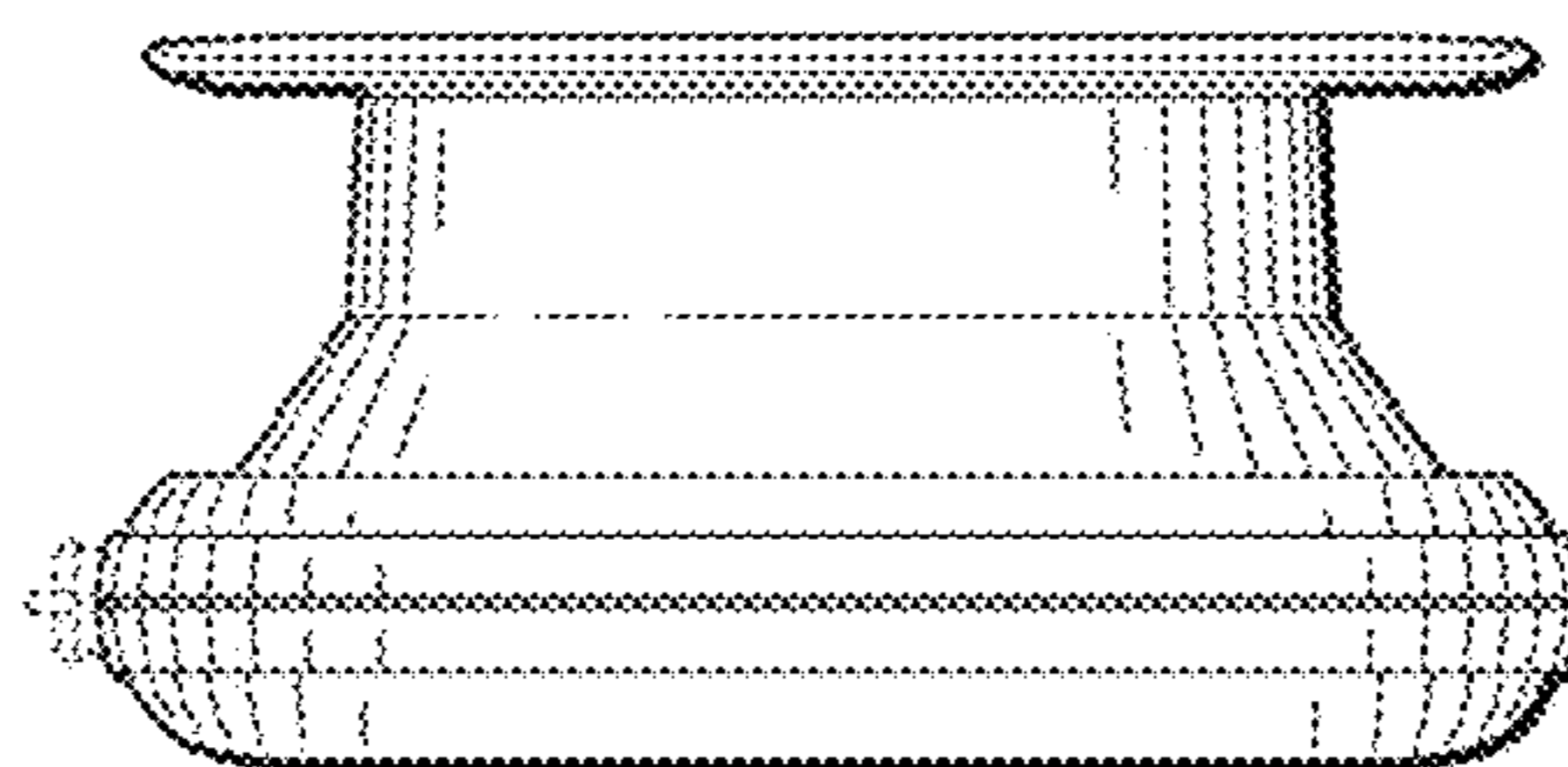

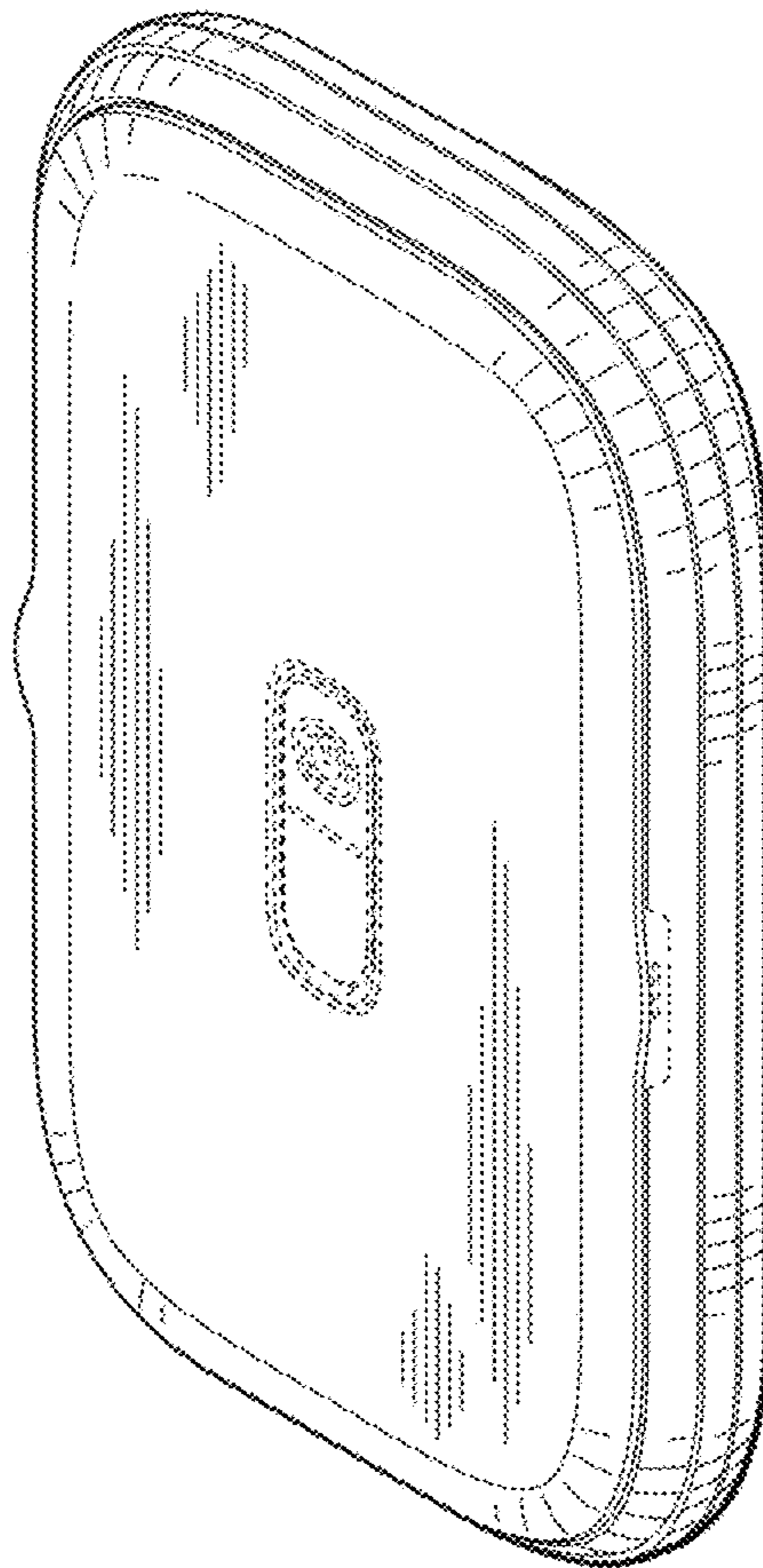

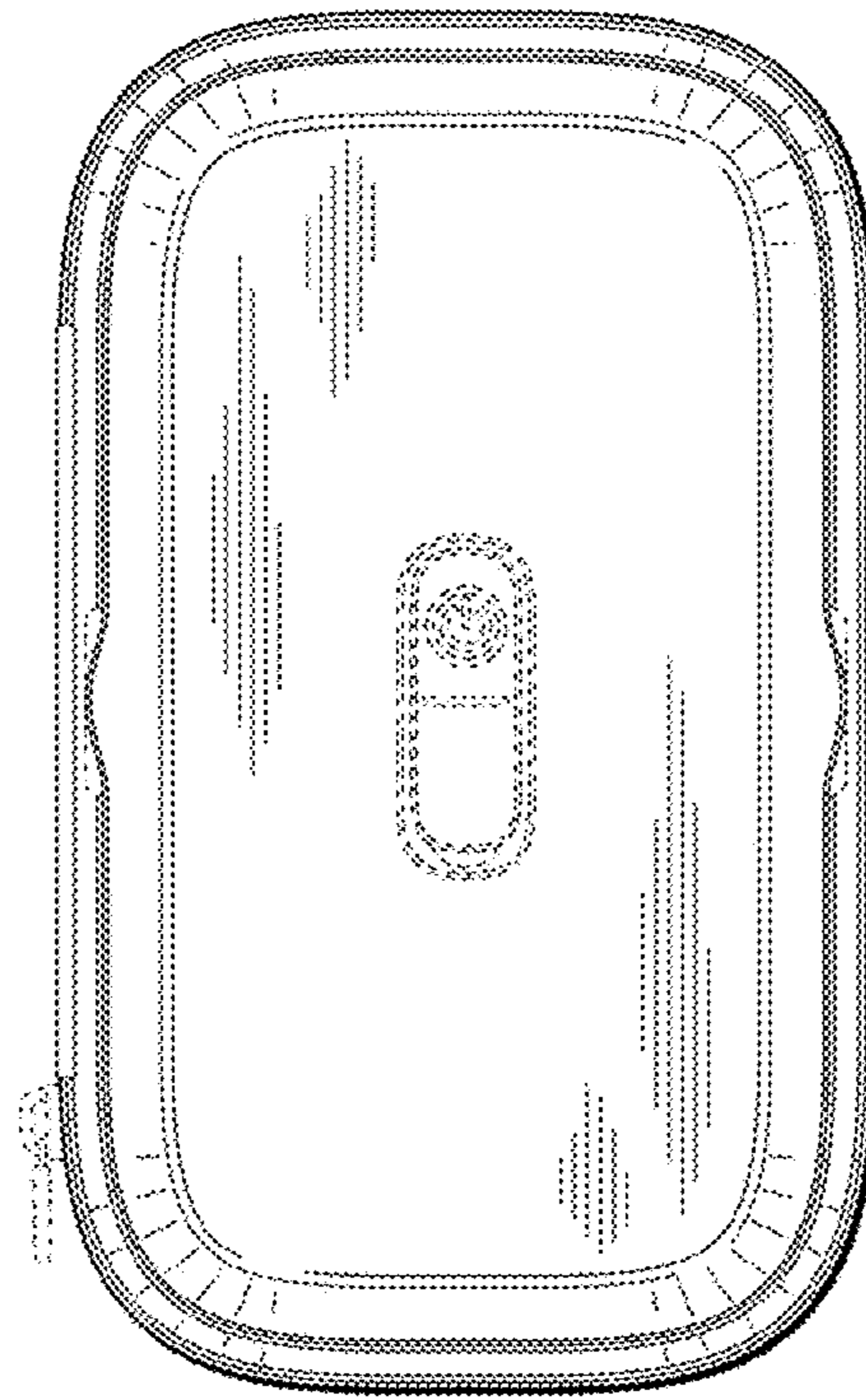

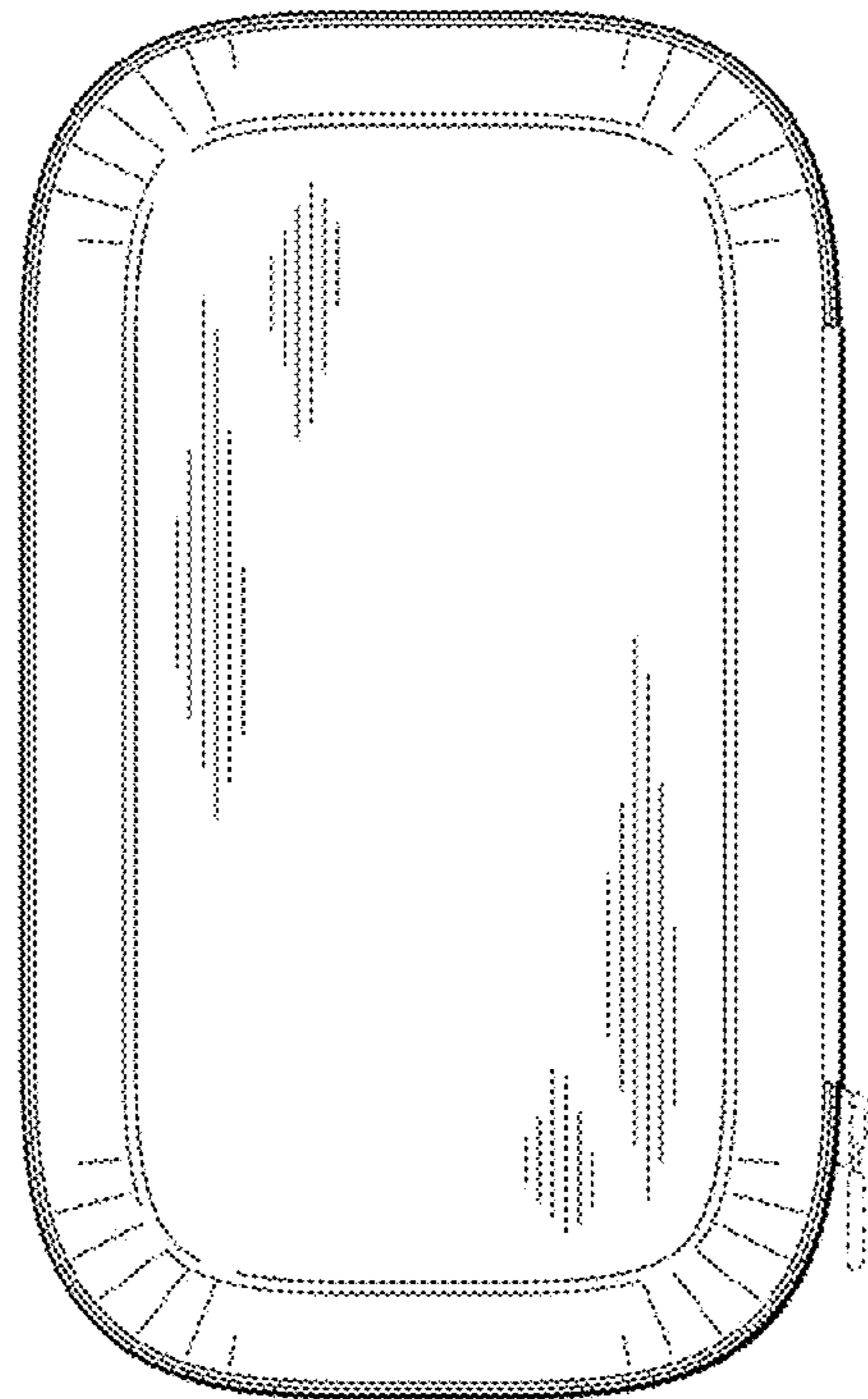

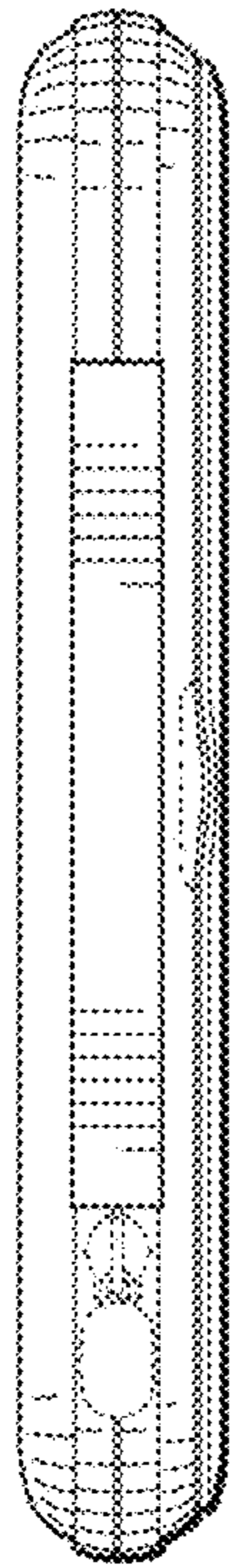

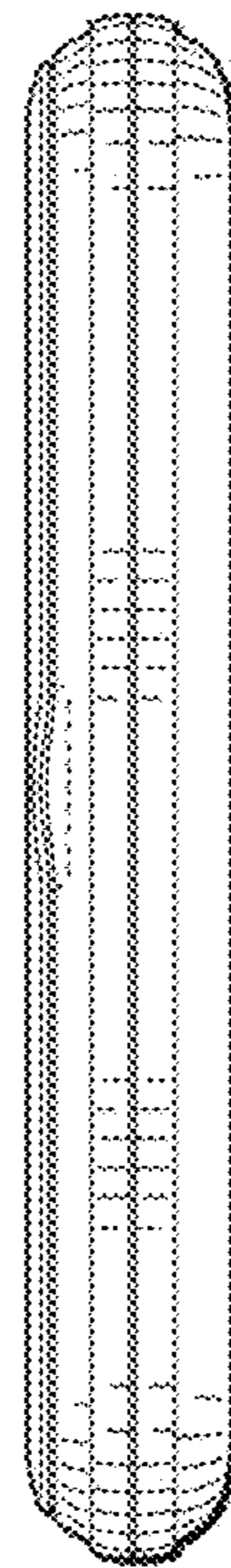

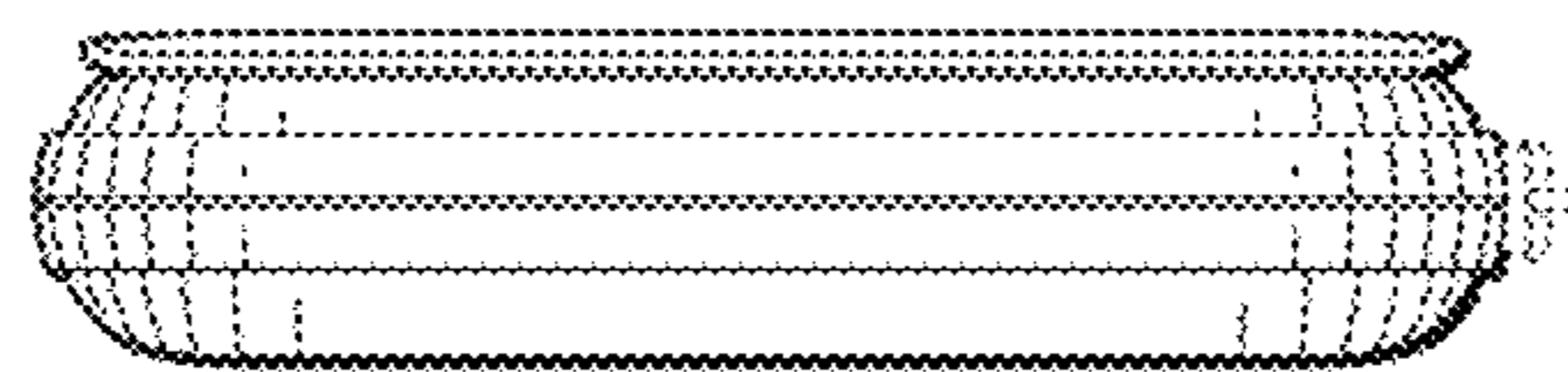

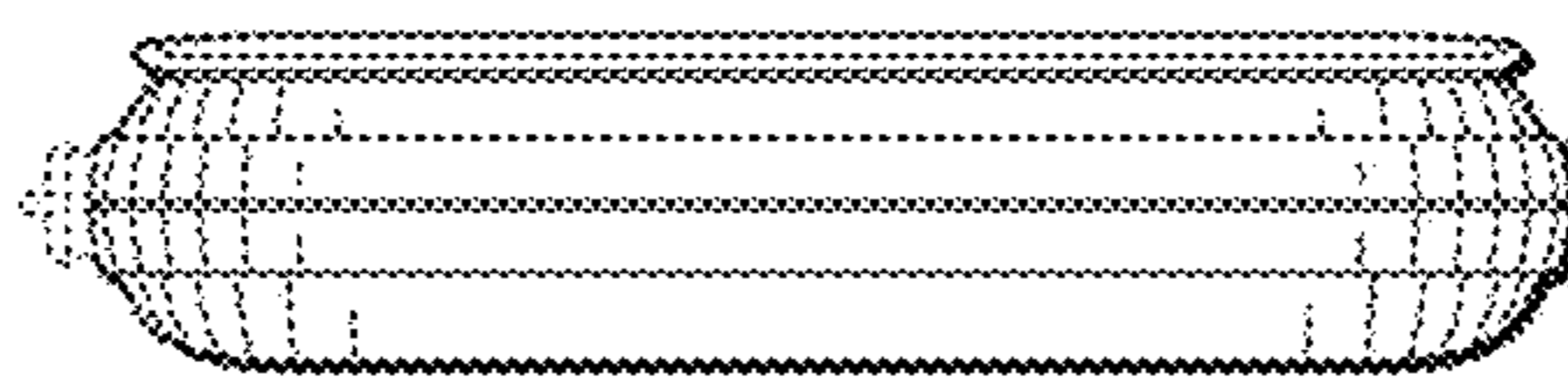
