(57) **CLAIM**

The ornamental design for a leggings, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, left side perspective view of leggings; FIG. 2 is a front elevation view of the leggings illustrated in FIG. 1; FIG. 3 is a rear elevation view of the leggings illustrated in FIG. 1; FIG. 4 is a left side elevation view of the leggings illustrated in FIG. 1; FIG. 5 is a right side elevation view of the leggings illustrated in FIG. 1; FIG. 6 is a top plan view of the leggings illustrated in FIG. 1, at an enlarged scale; and, FIG. 7 is a bottom plan view of the leggings illustrated in FIG. 1, at an enlarged scale. The broken lines illustrate portions of the leggings and stitching that form no part of the claim. The stippled and cross-hatch shading shown in the figures represent a contrasting appearance.

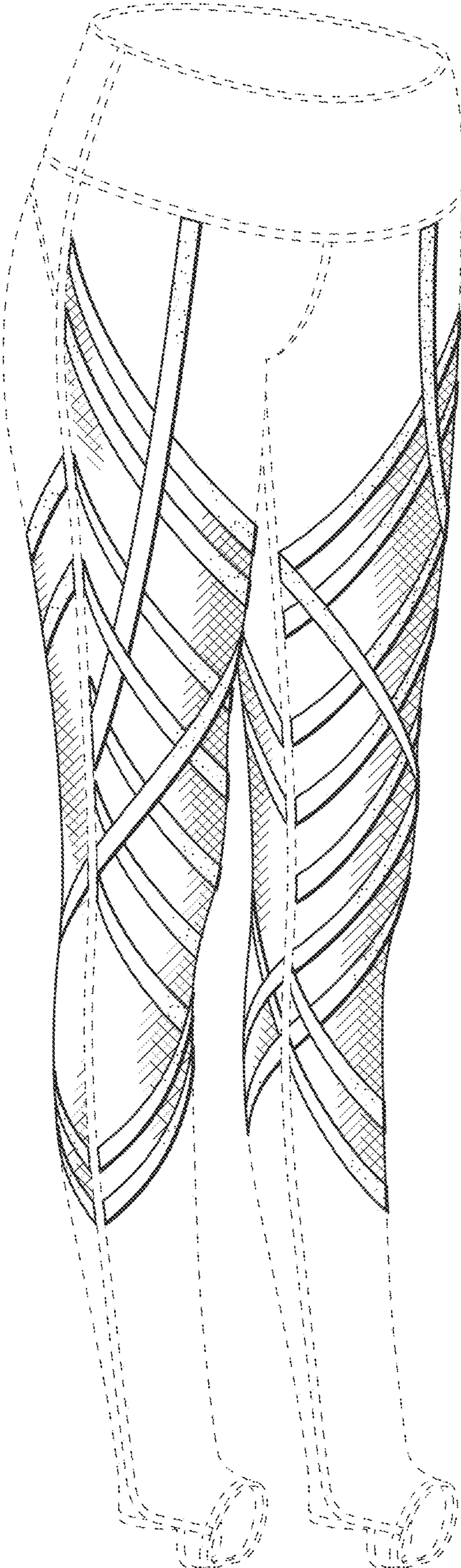

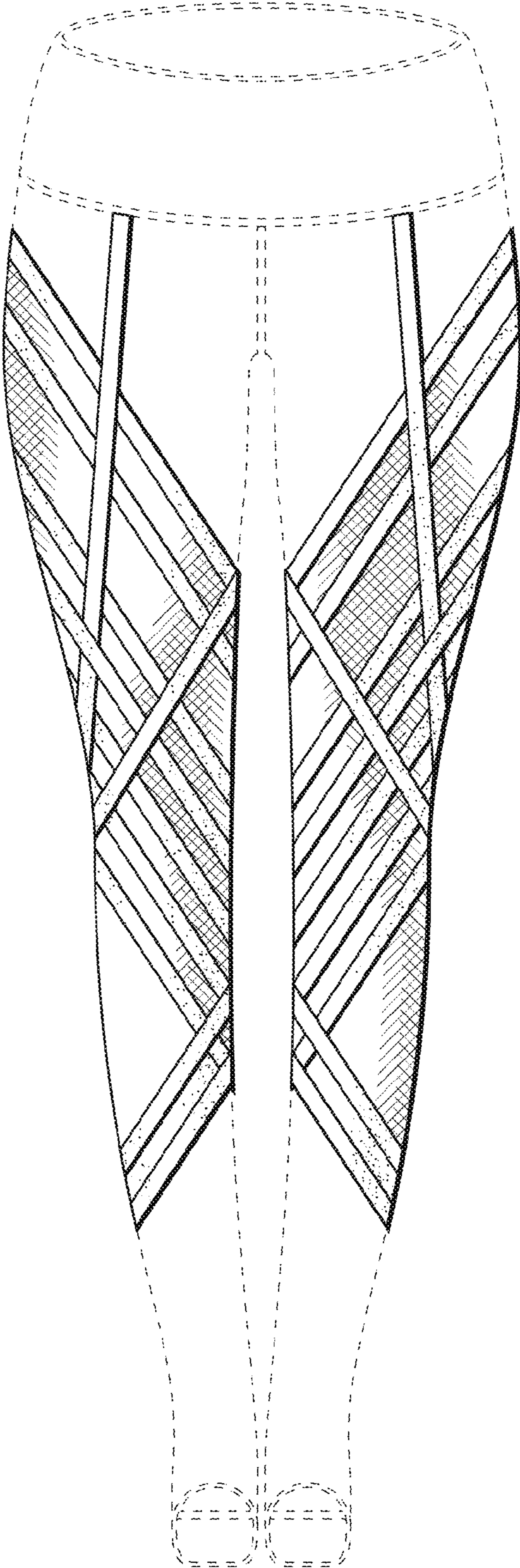

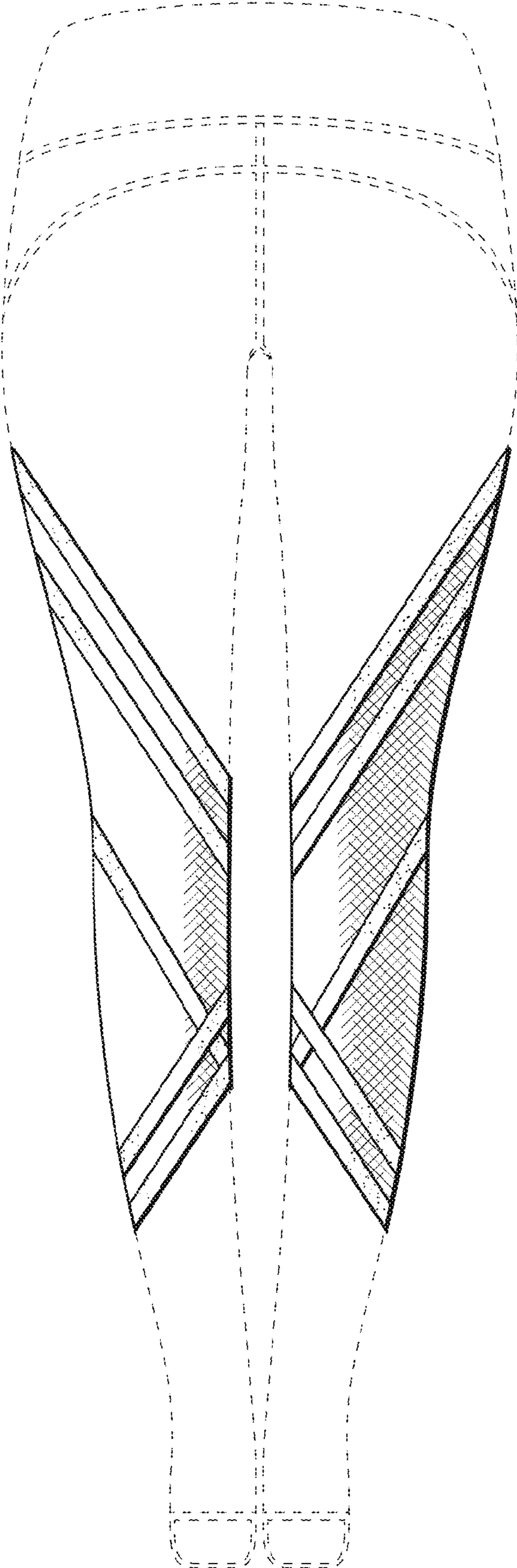

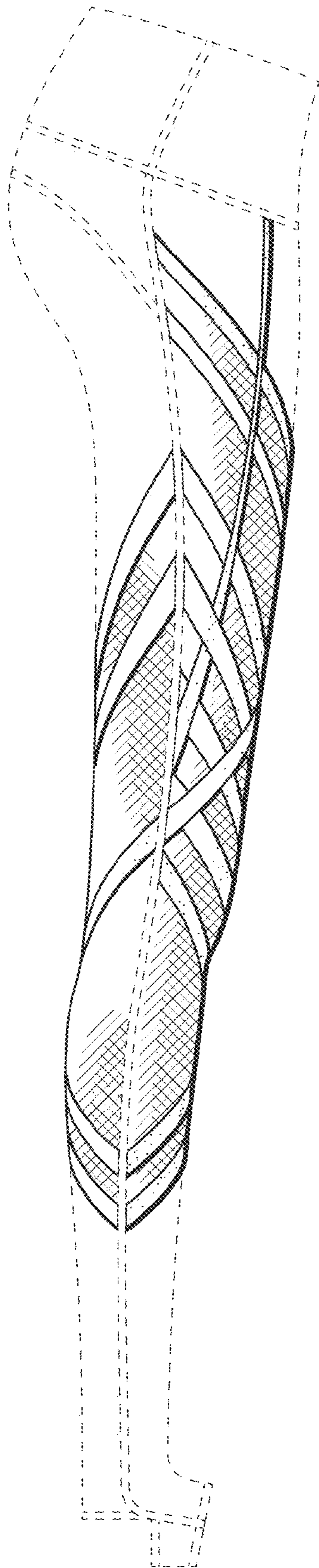

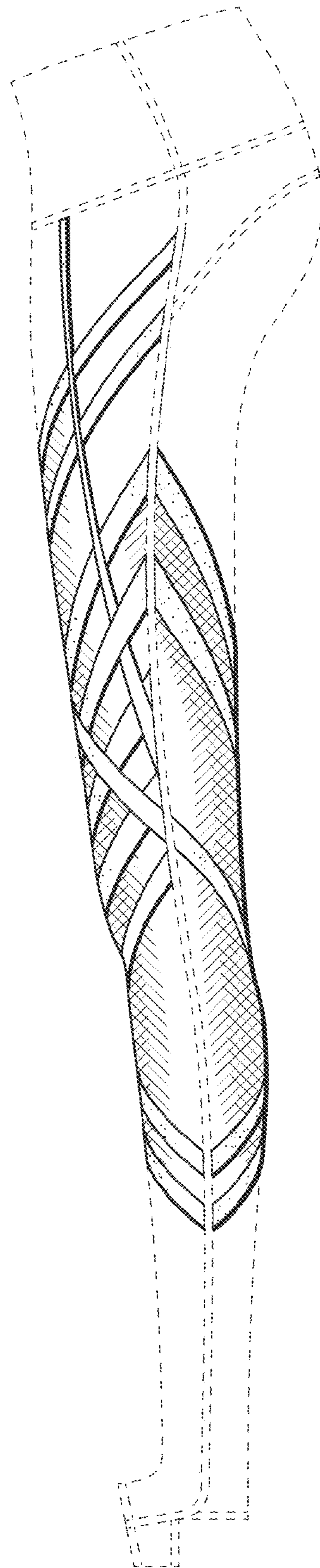

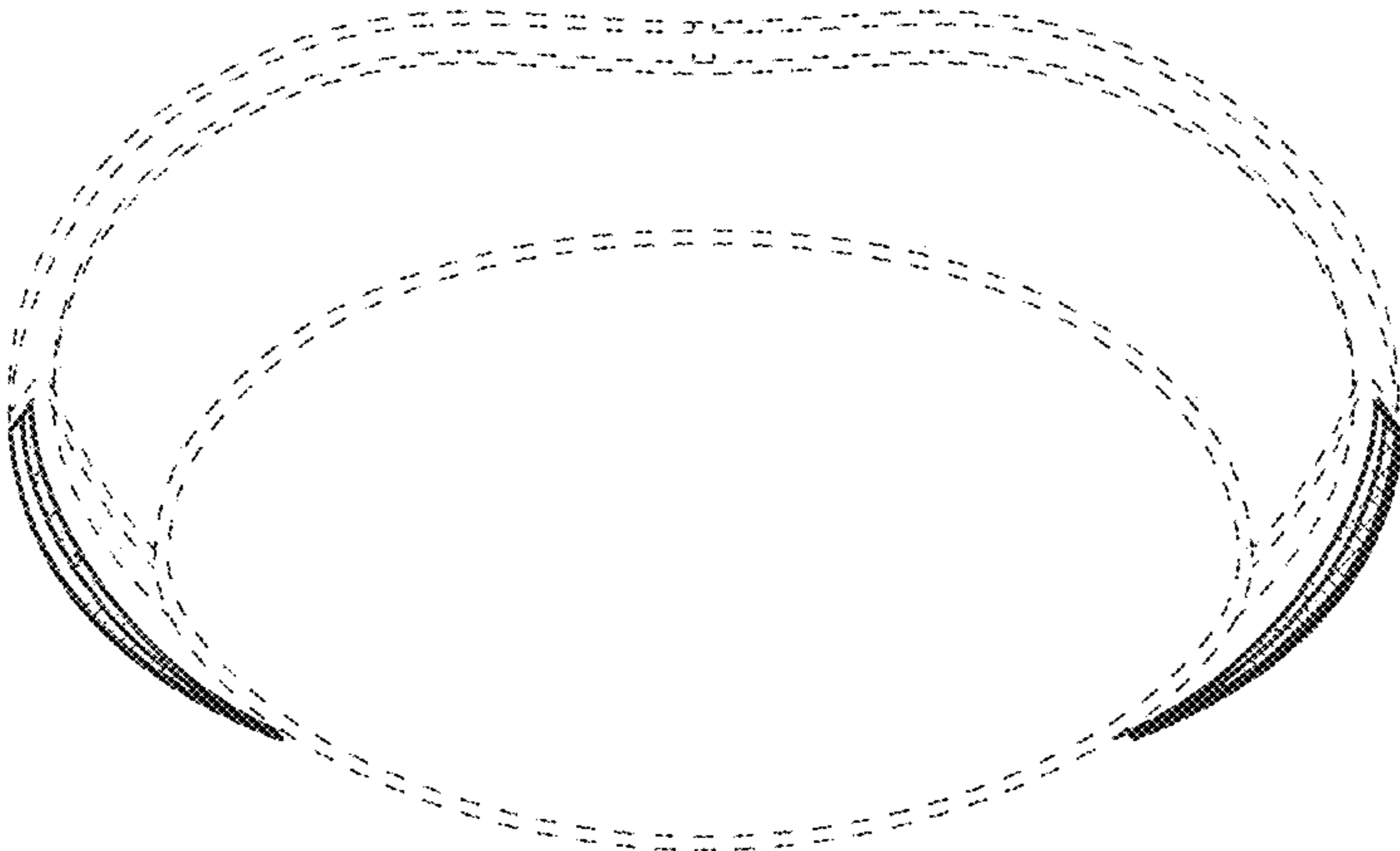

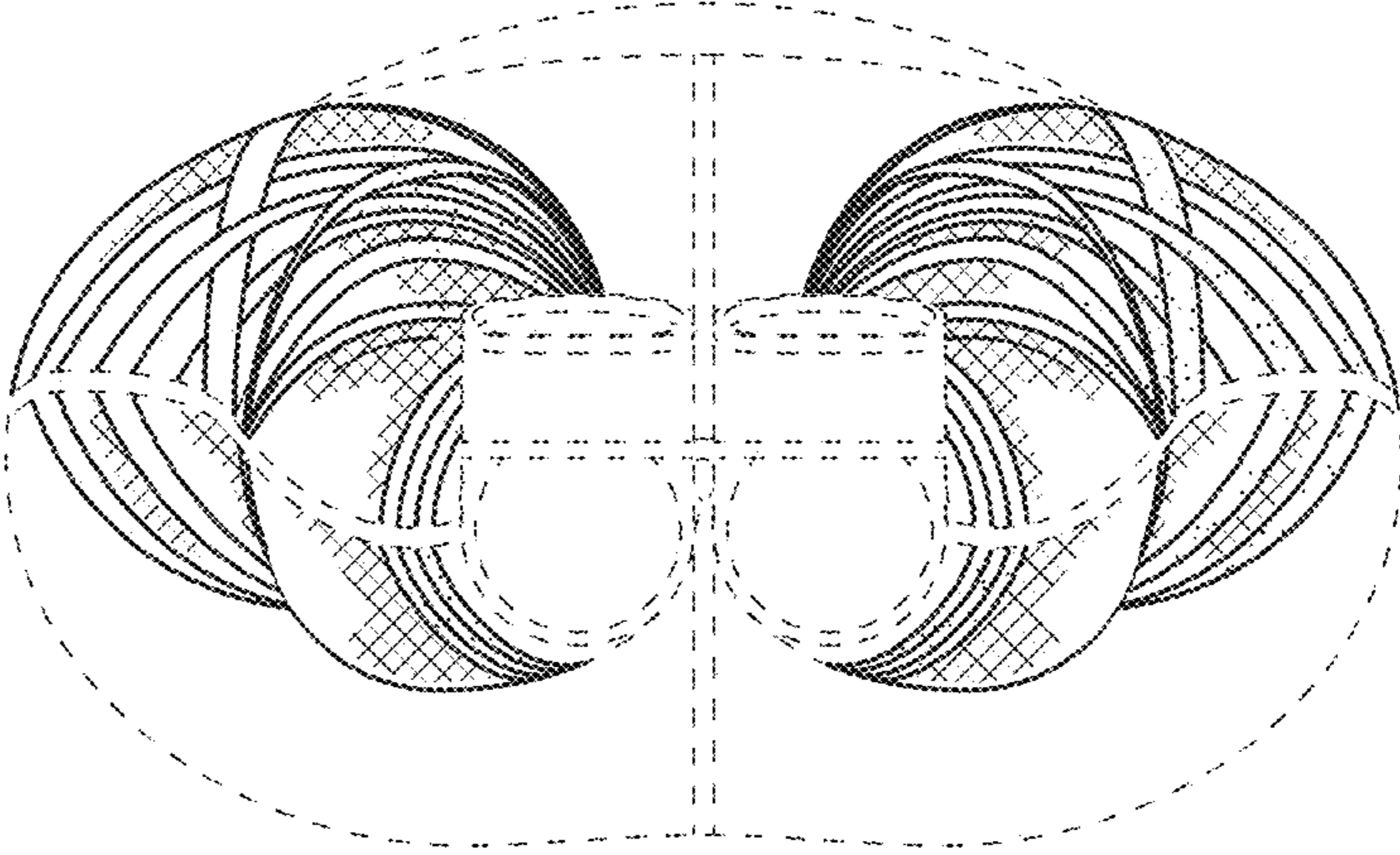
