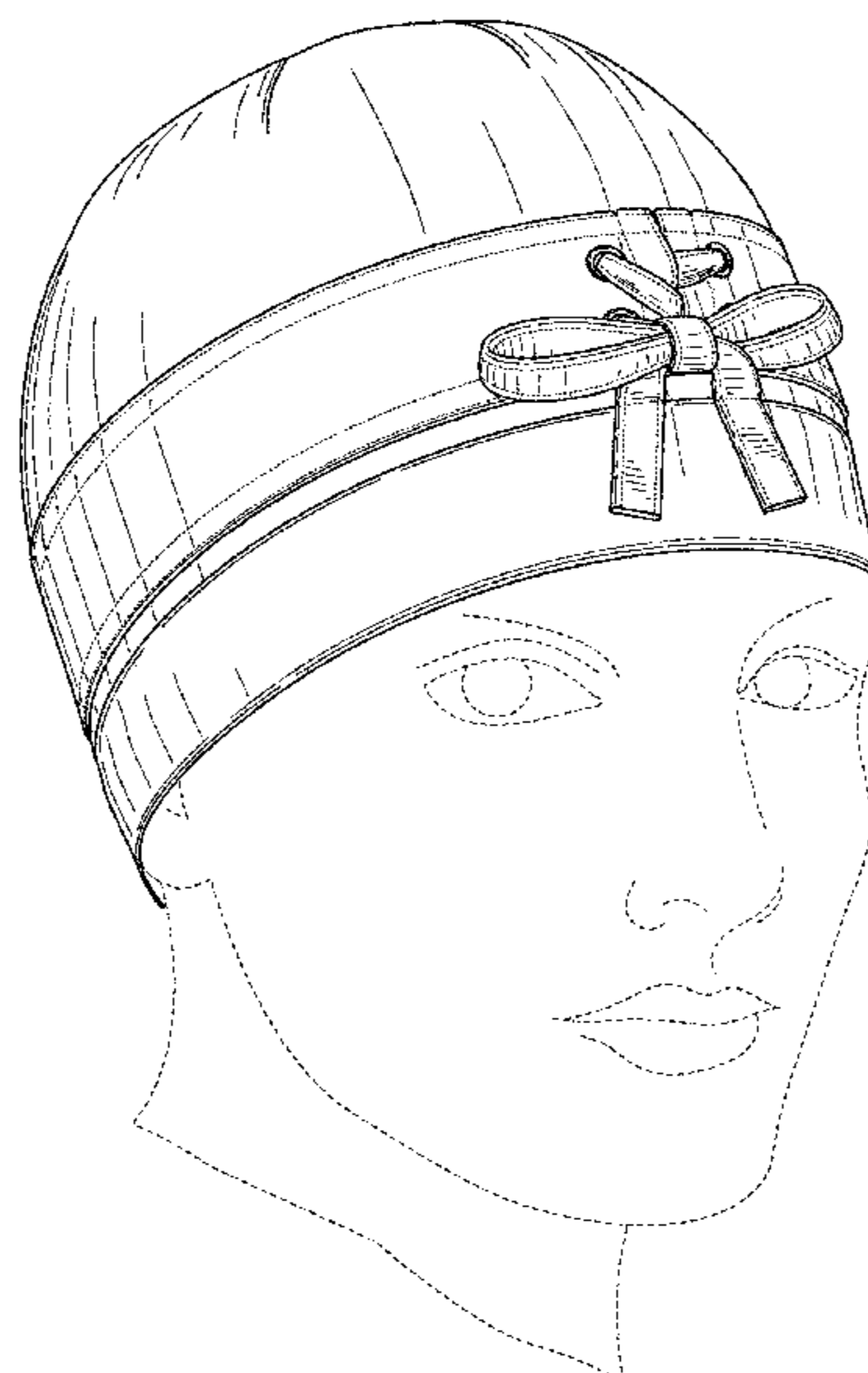
(57) **CLAIM**

The ornamental design for a headwear, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a headwear; FIG. 2 is a front elevation view of the headwear; FIG. 3 is a rear elevation view thereof; FIG. 4 is a left side elevation view thereof; FIG. 5 is a right side elevation view thereof; FIG. 6 is a top perspective view thereof; FIG. 7 is a right side perspective view thereof; and, FIG. 8 is a left side perspective view thereof. The partial human figure shown in broken lines in FIG. 1 is environmental subject matter included to show the headwear in a position of use and forms no part of the claimed design. The long dashed broken lines along the interior headwear opening defines the bounds of the claim and forms no part of the claimed design. The short dashed broken lines along the surface of the headwear depict claimed stitching.

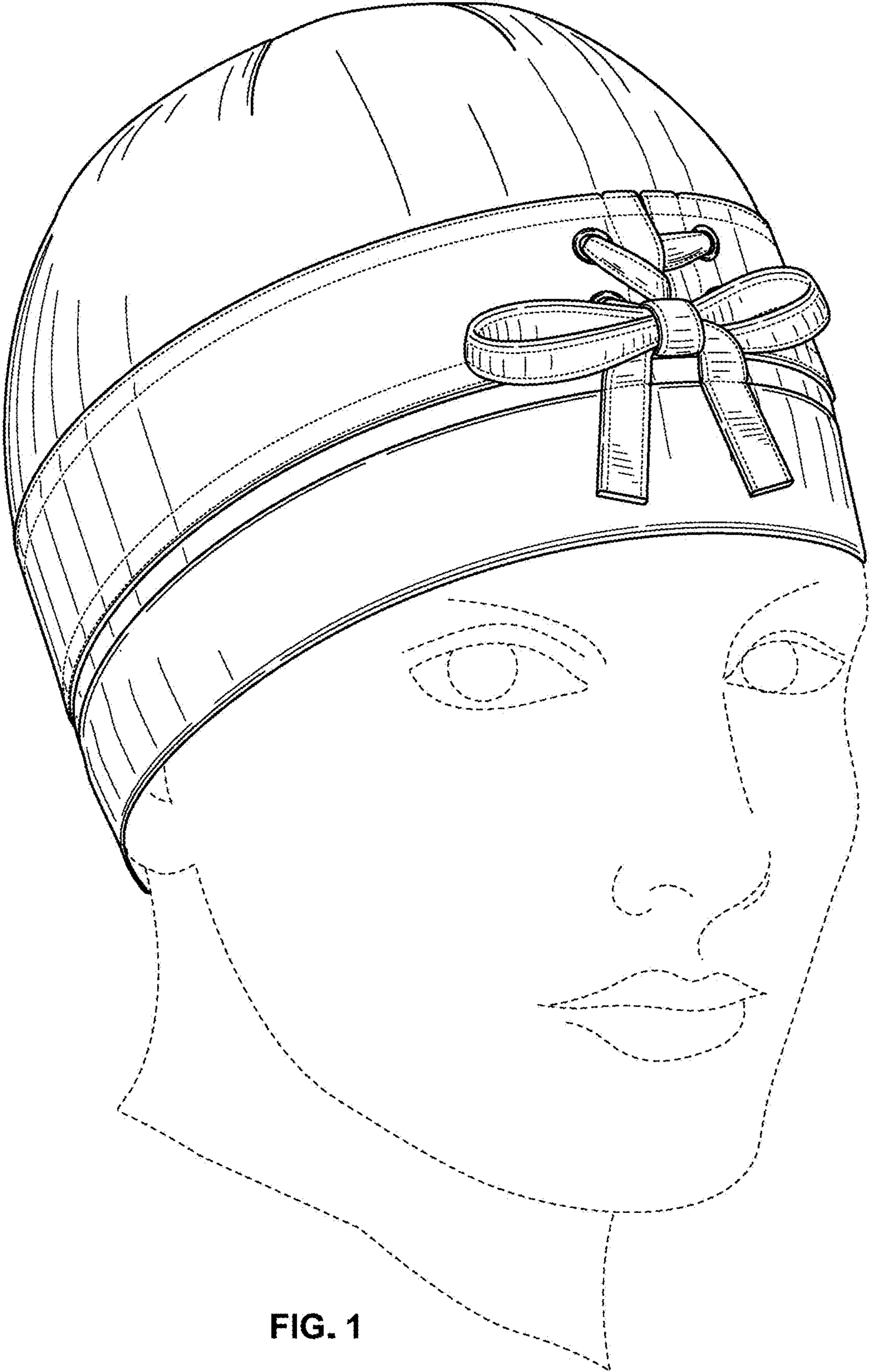

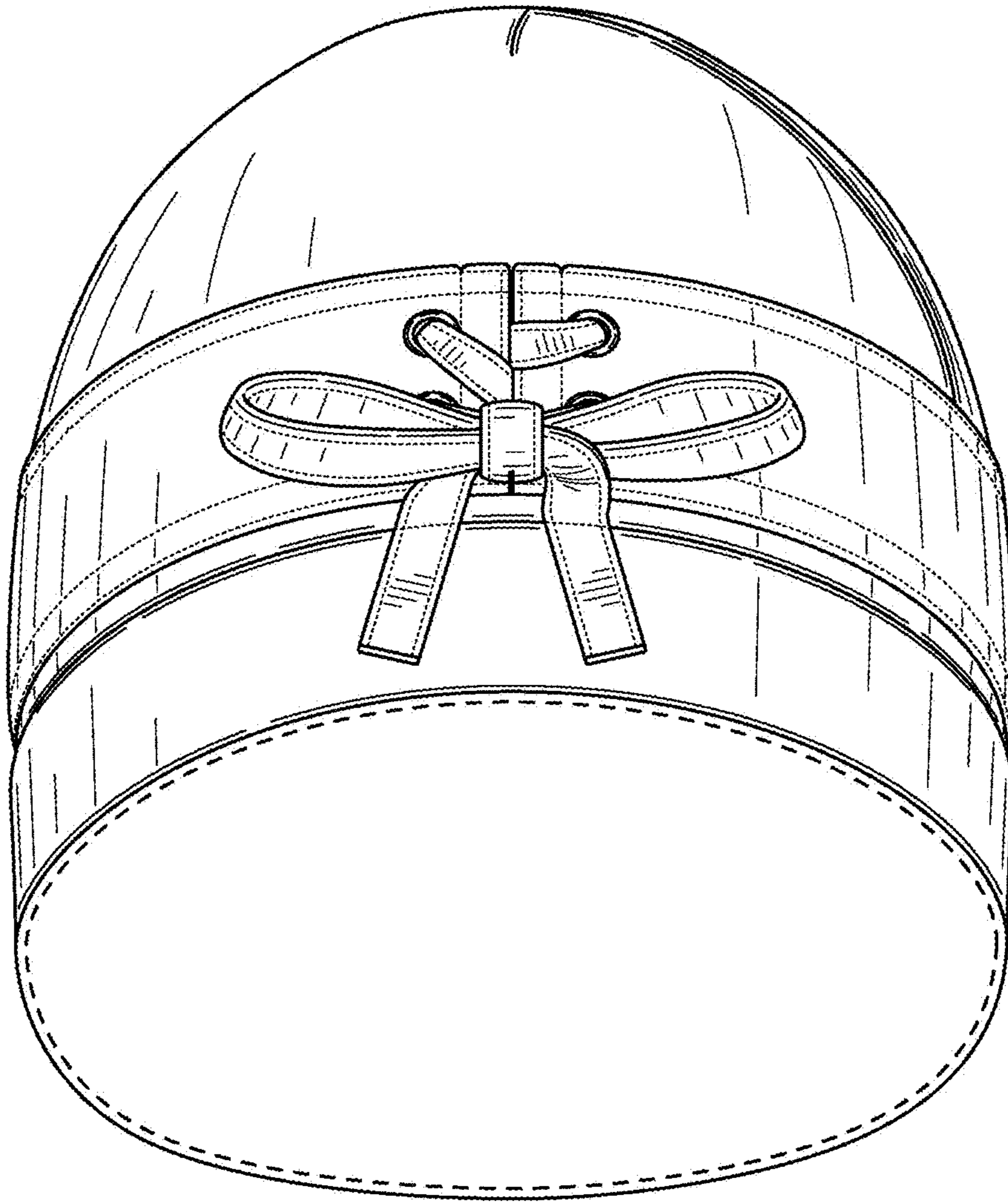

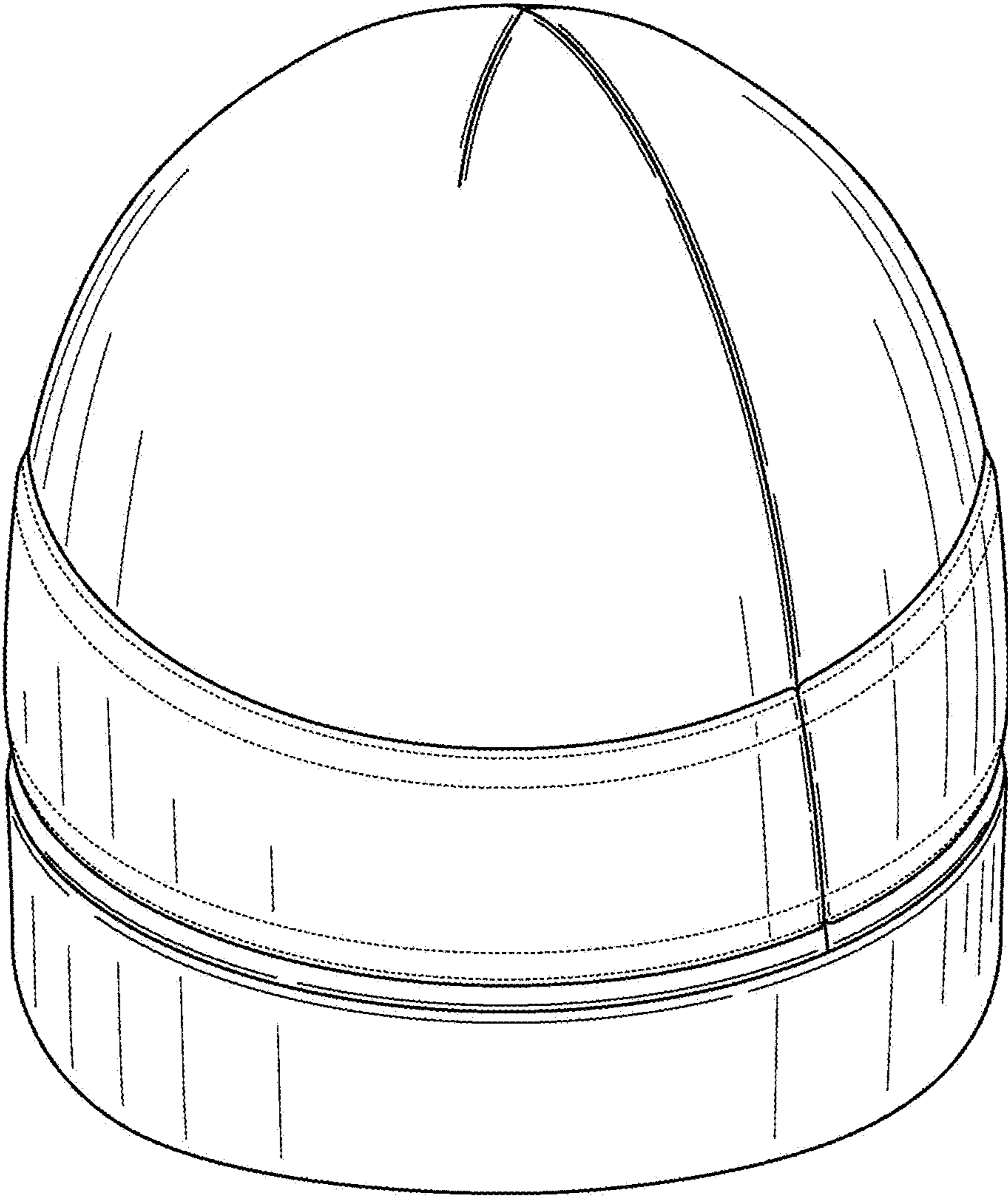

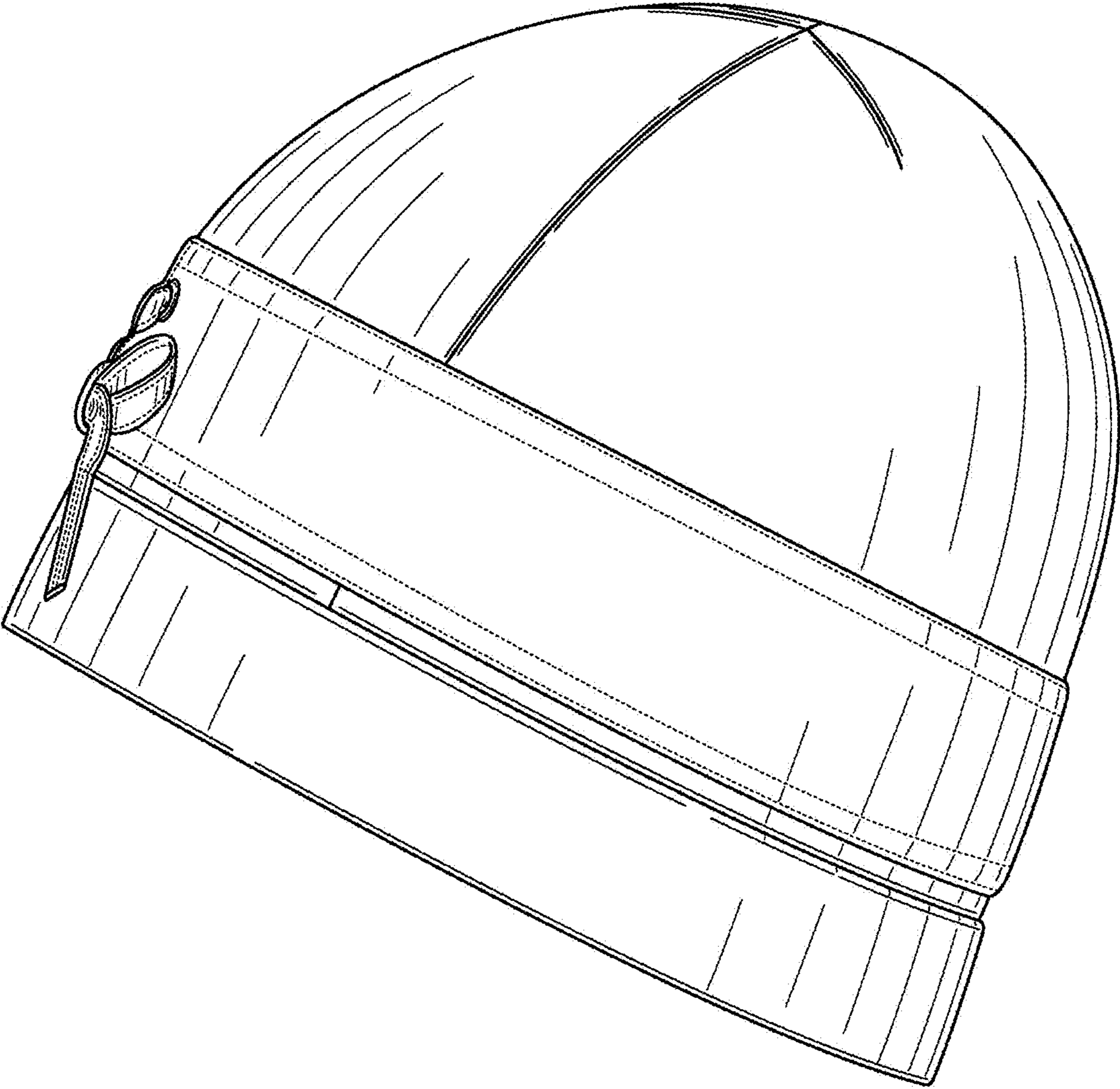

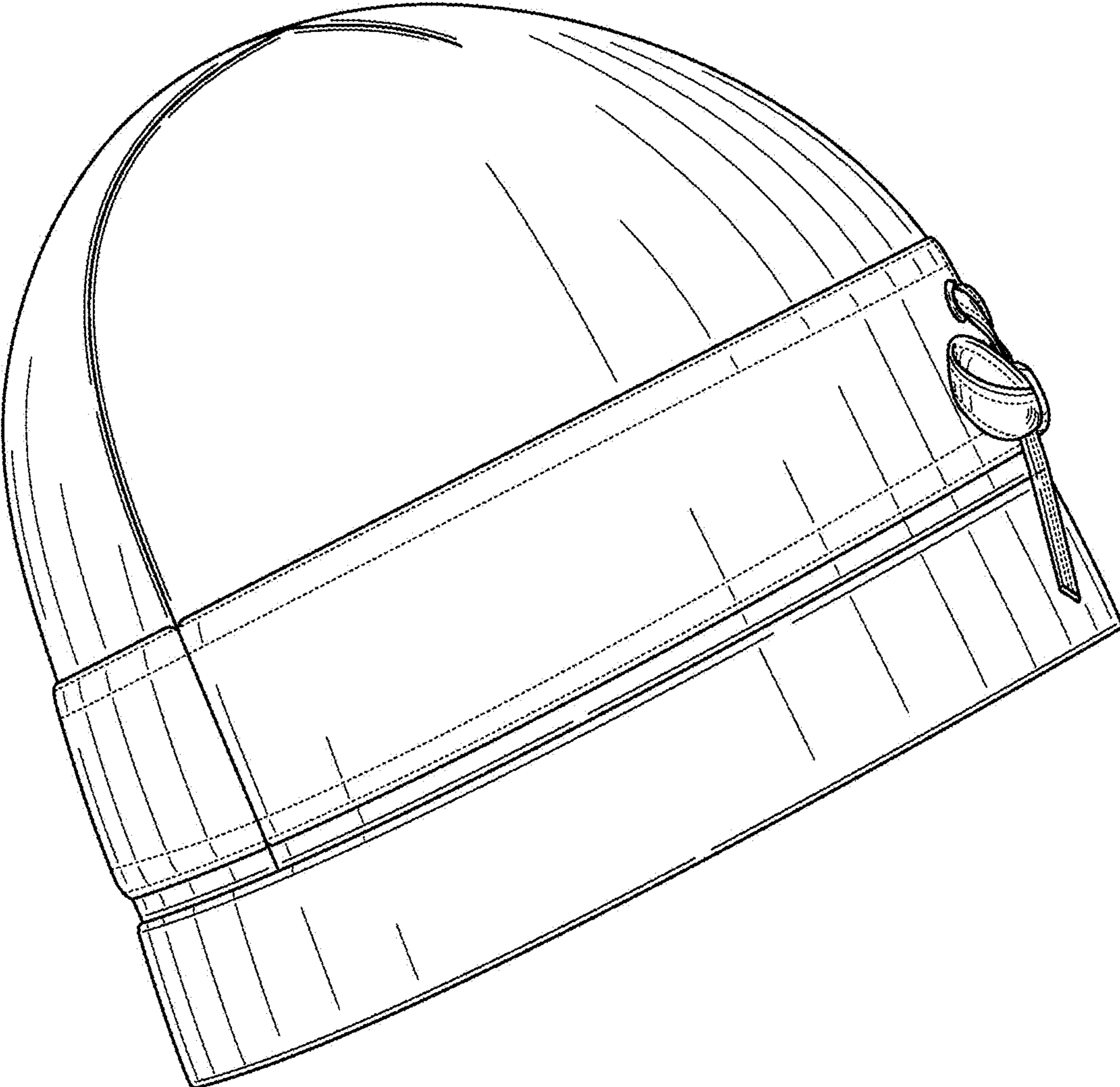

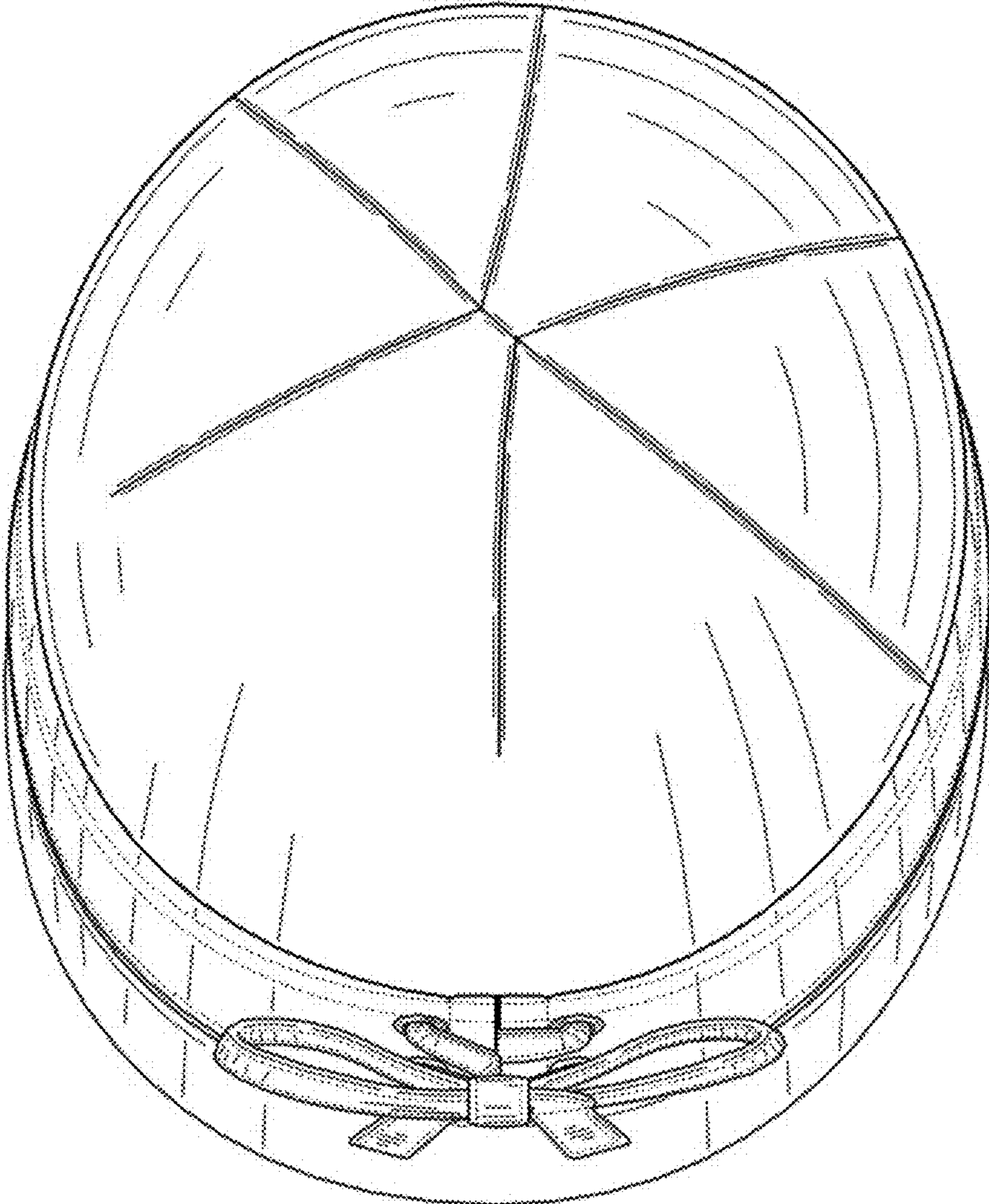

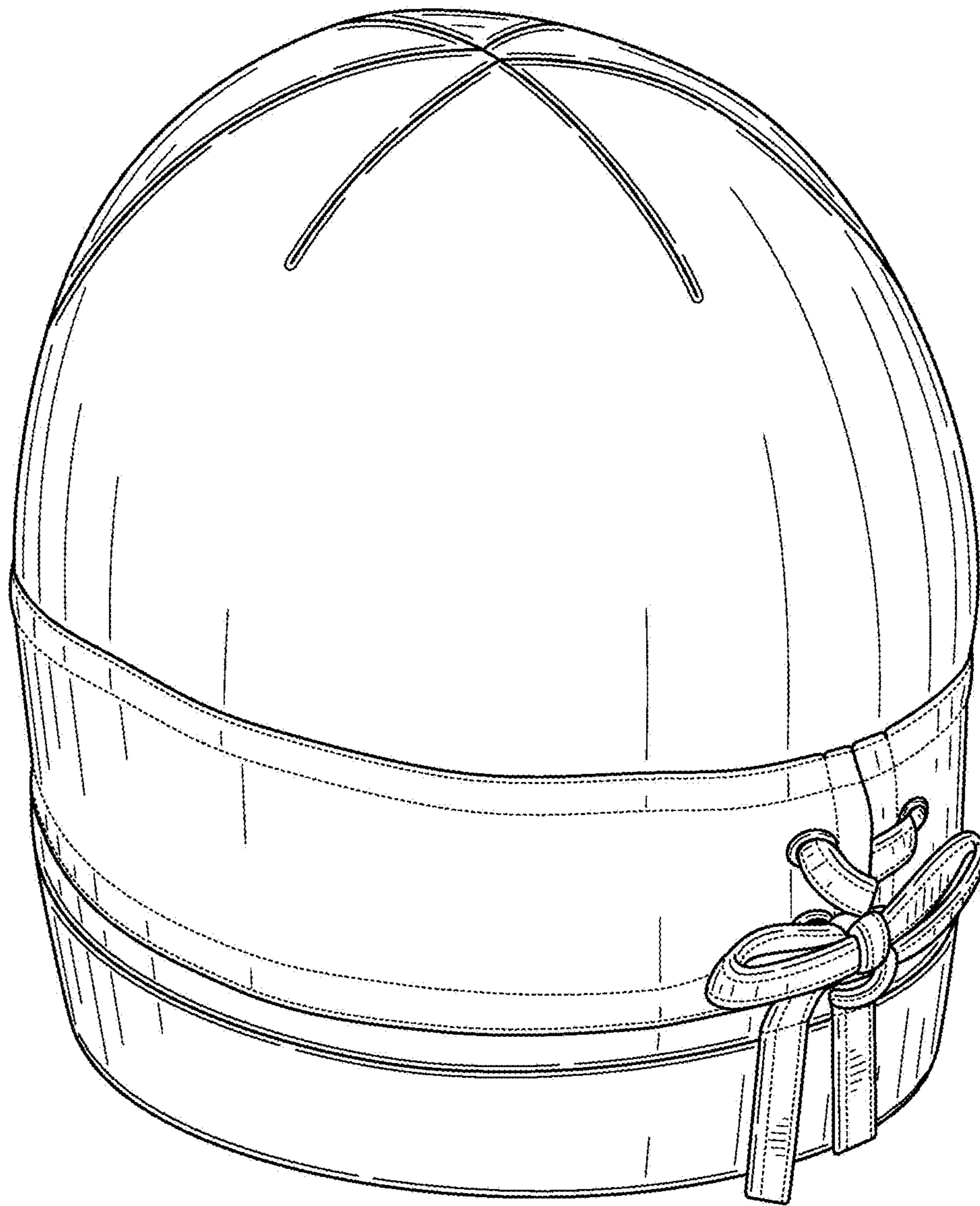

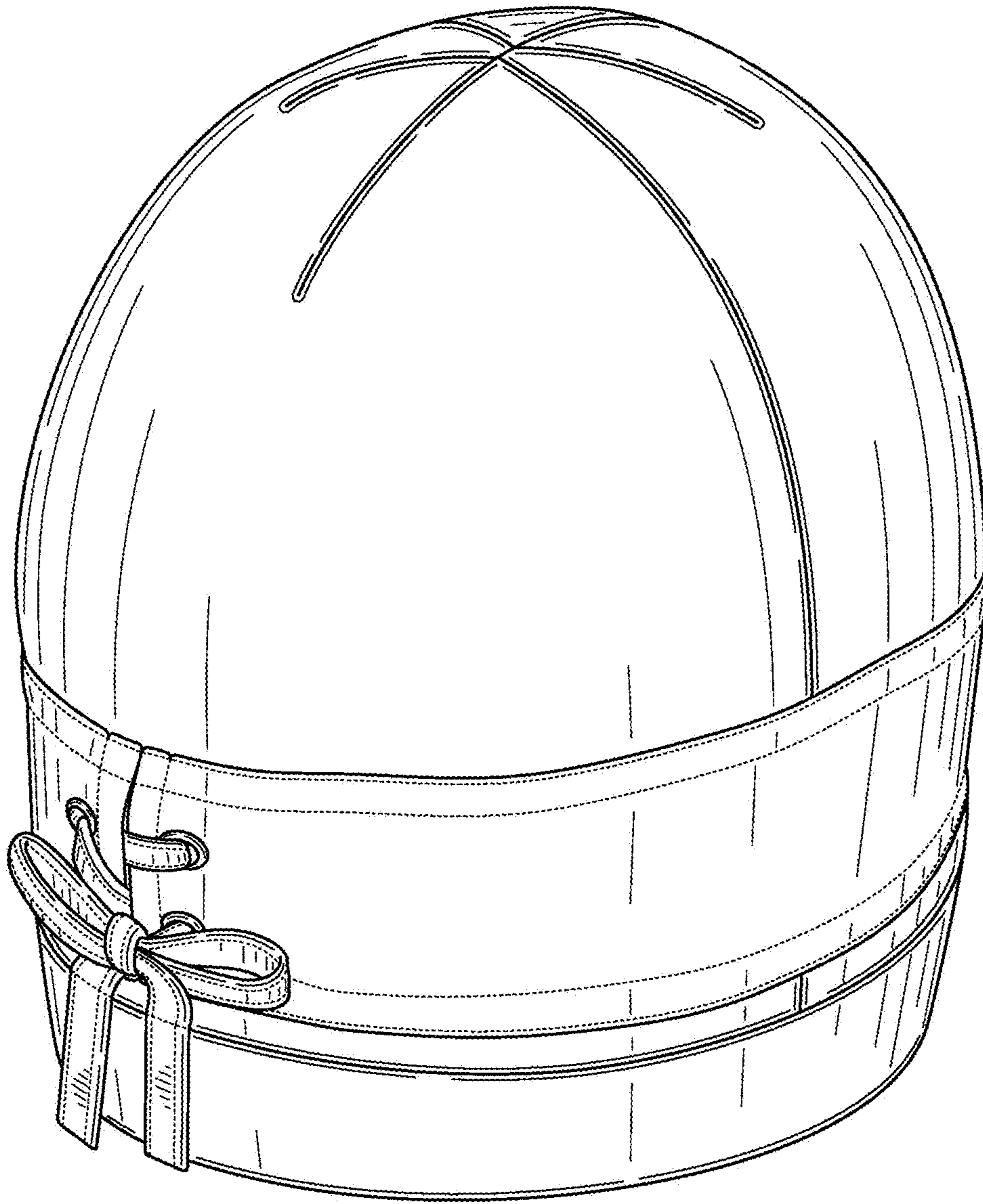
