DESCRIPTION

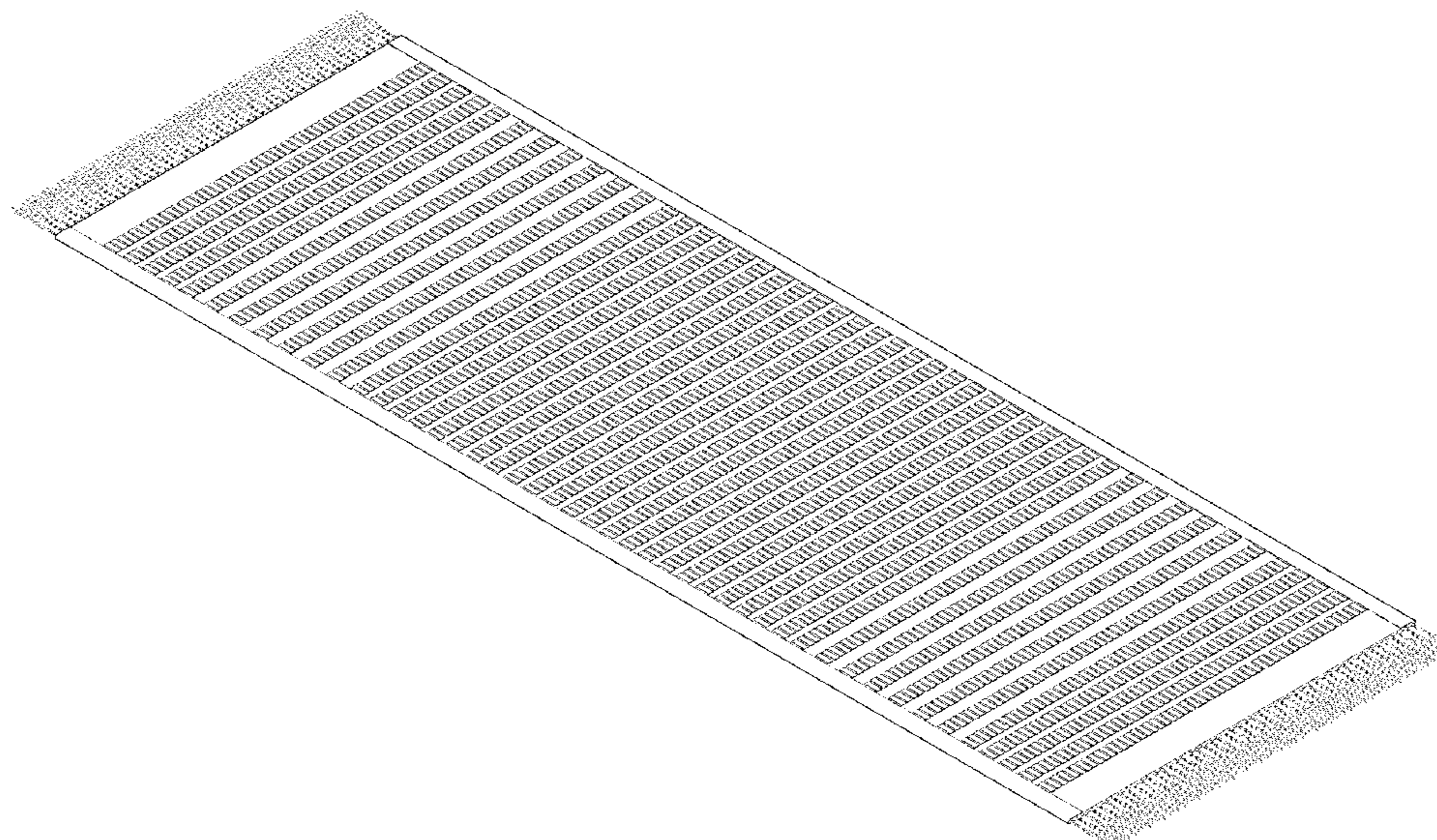
FIG. 1 is an isometric view showing my new ornamental design for a textile in the form of a flexible mat that can be rolled up.

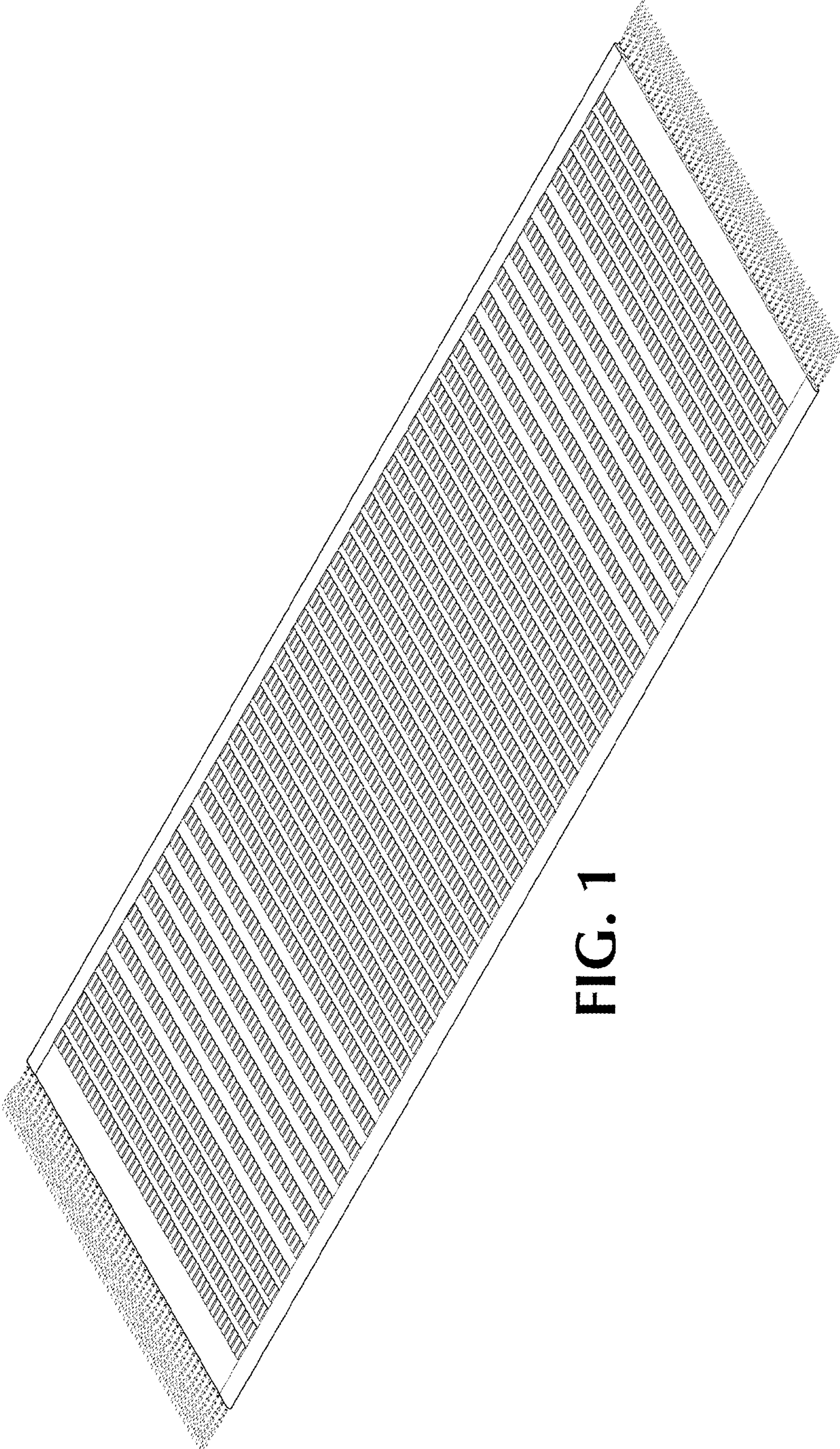

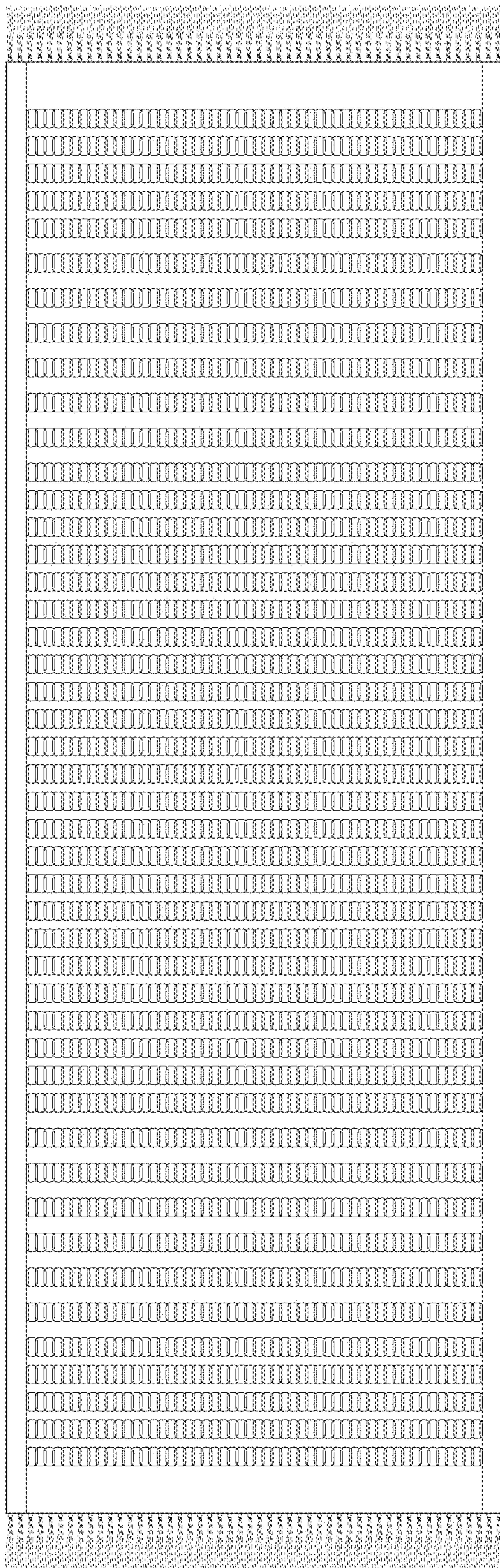
