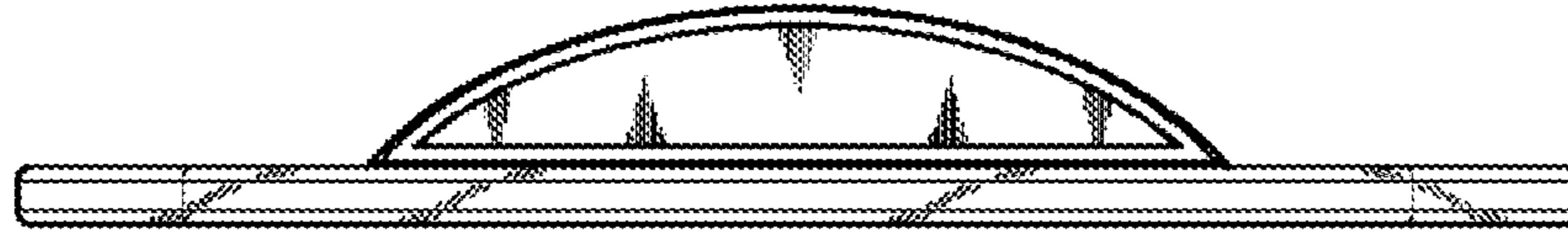
The ornamental design for serving platter, substantially as shown and described.

**DESCRIPTION**

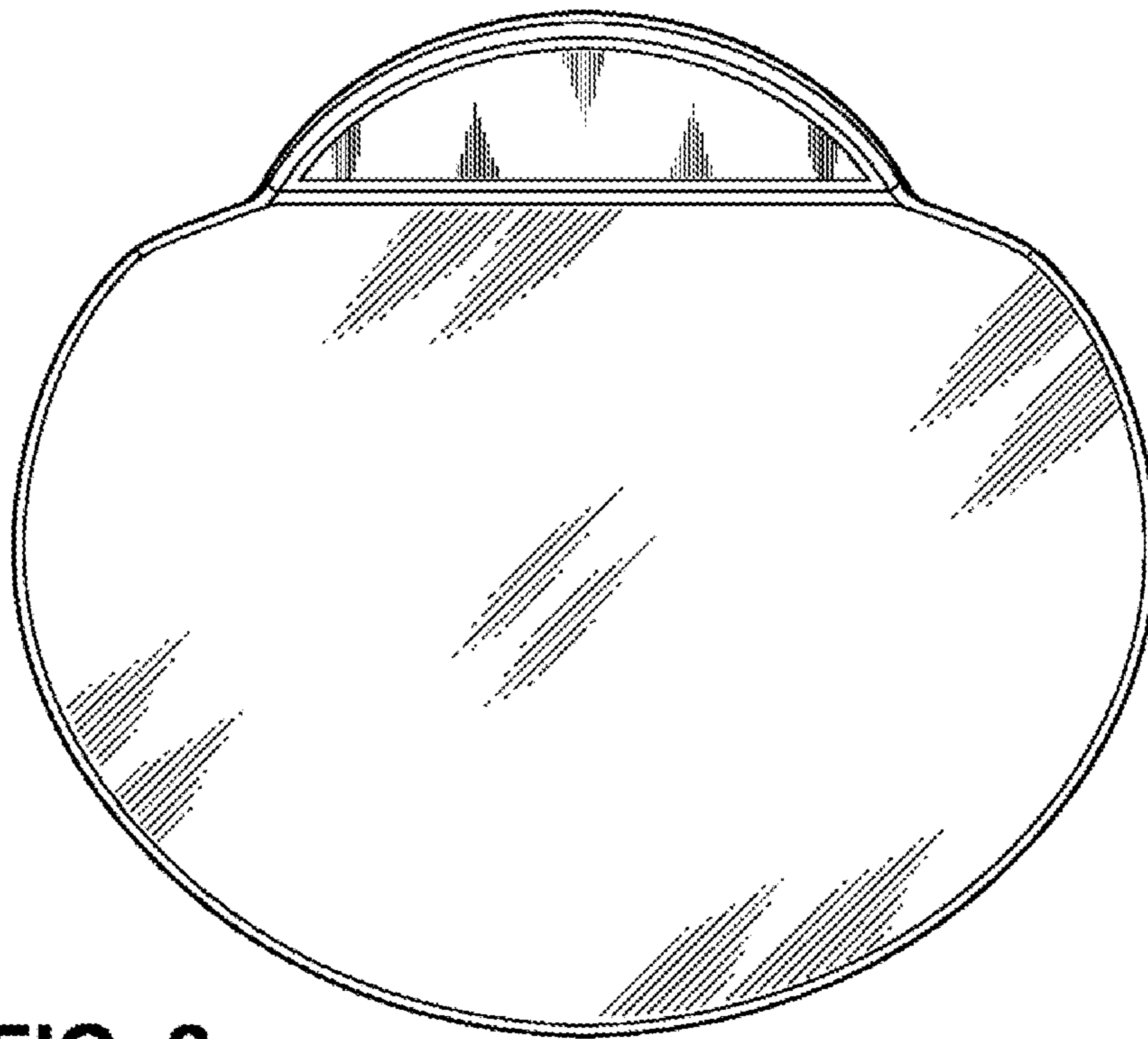
FIG. 1 is a front elevation view of a serving platter showing our new design;

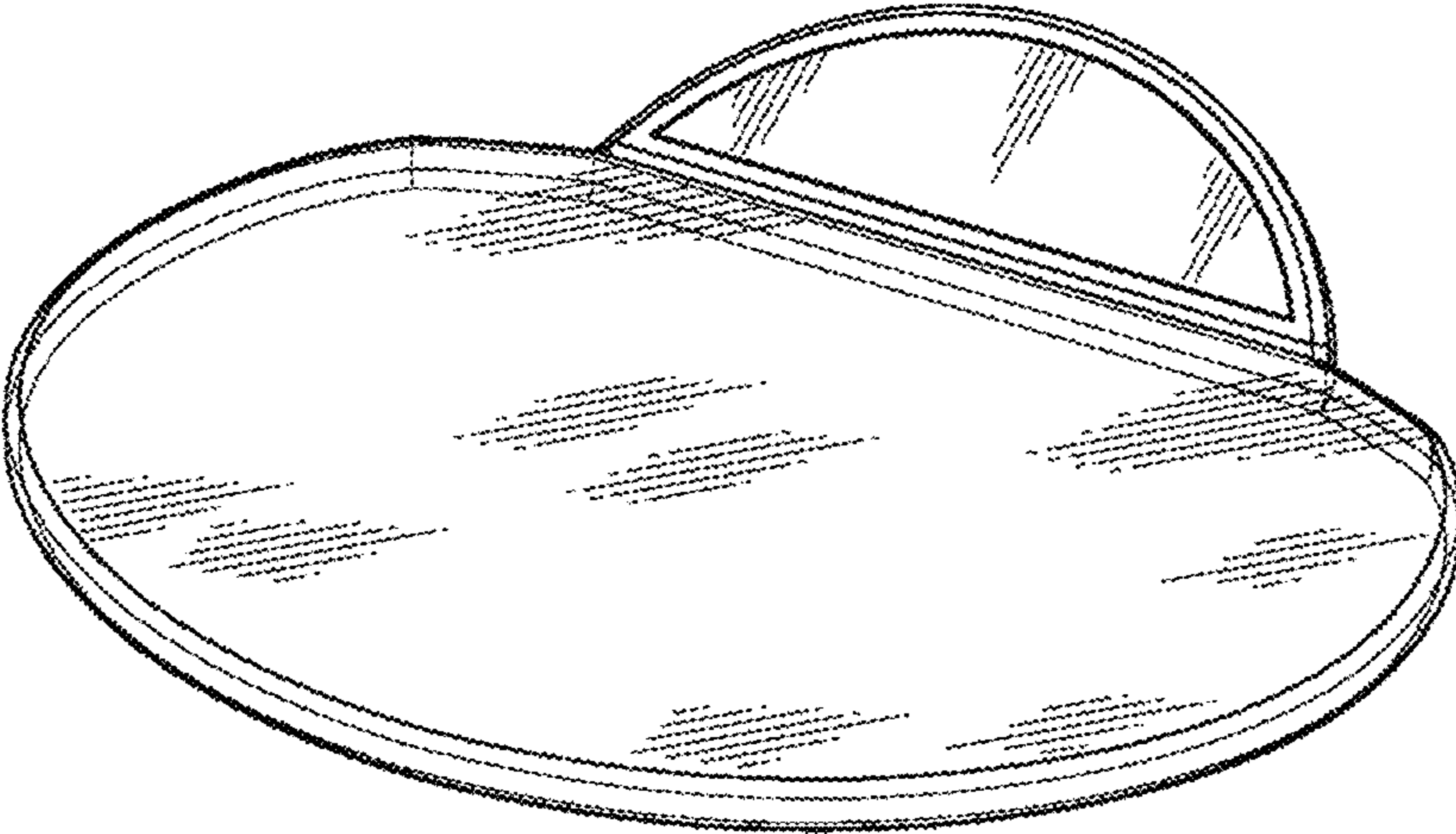

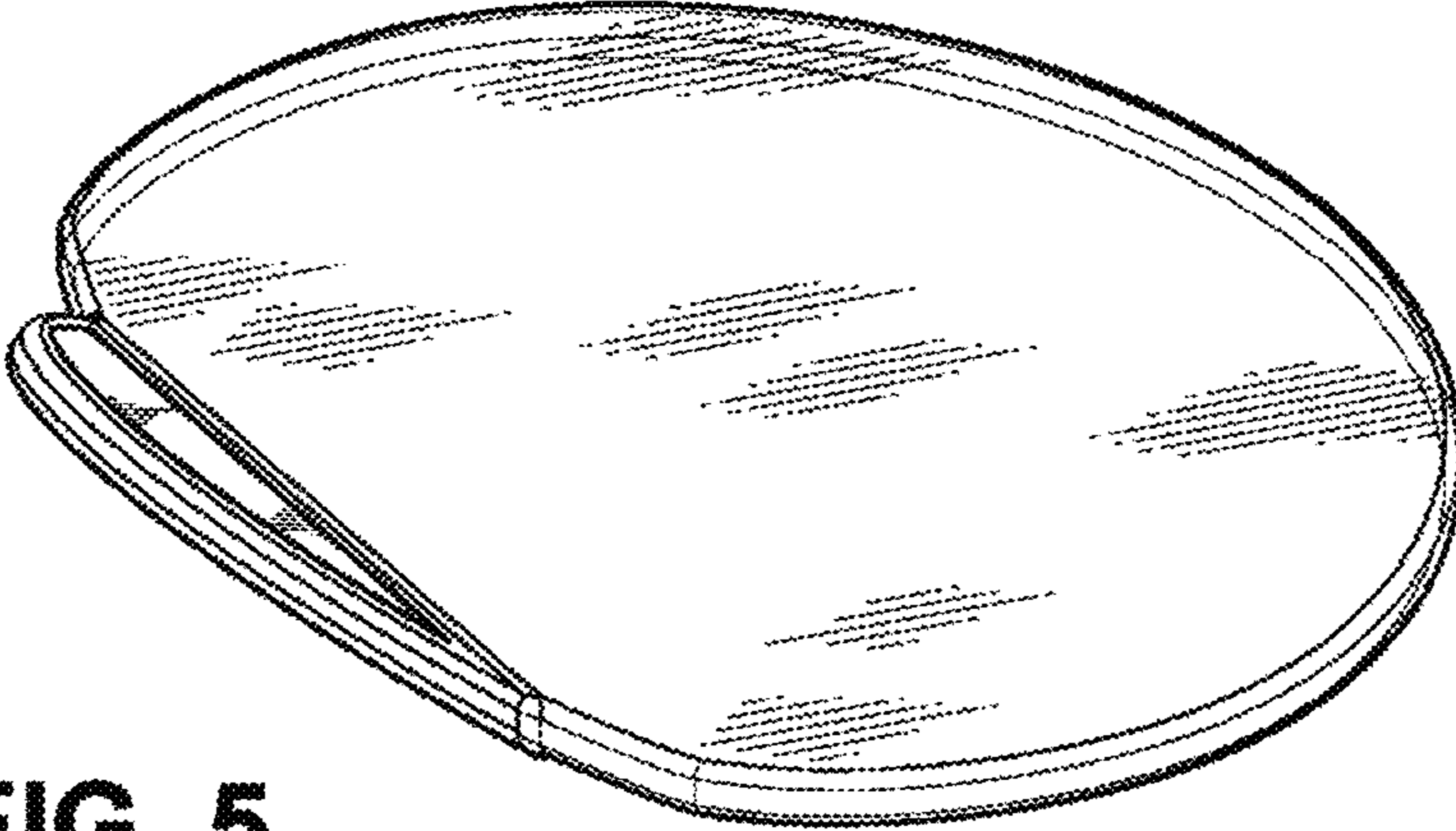

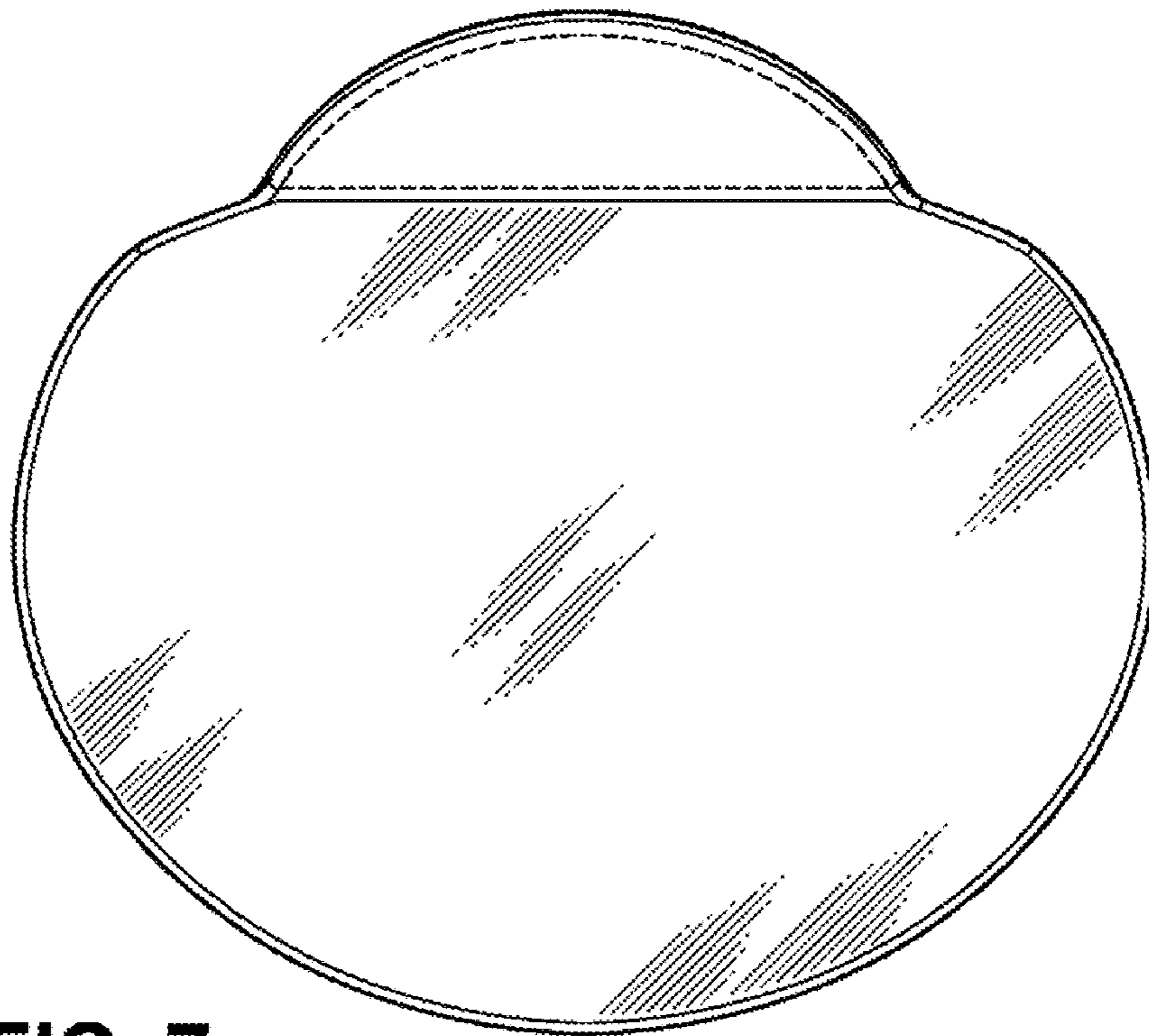

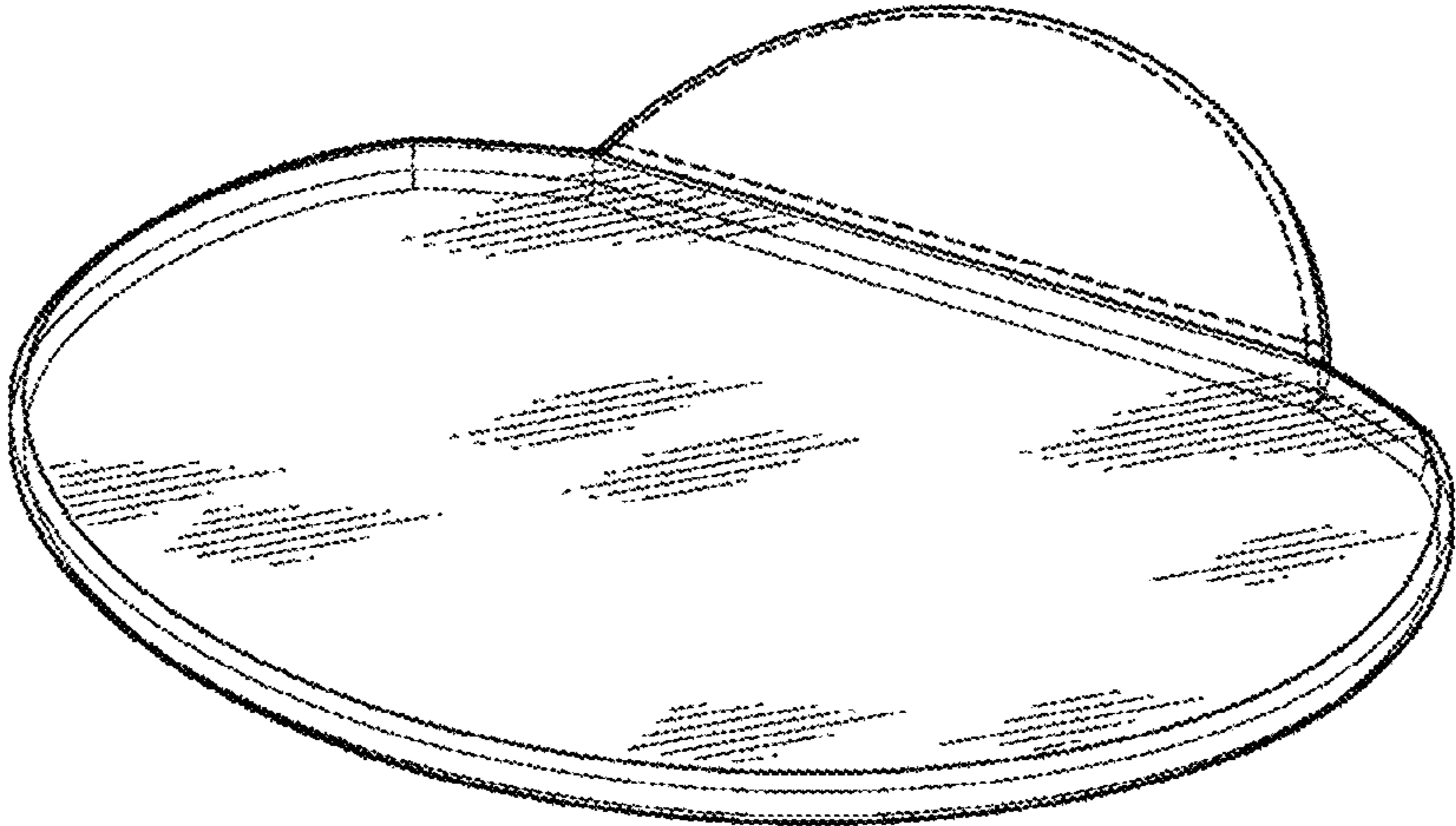

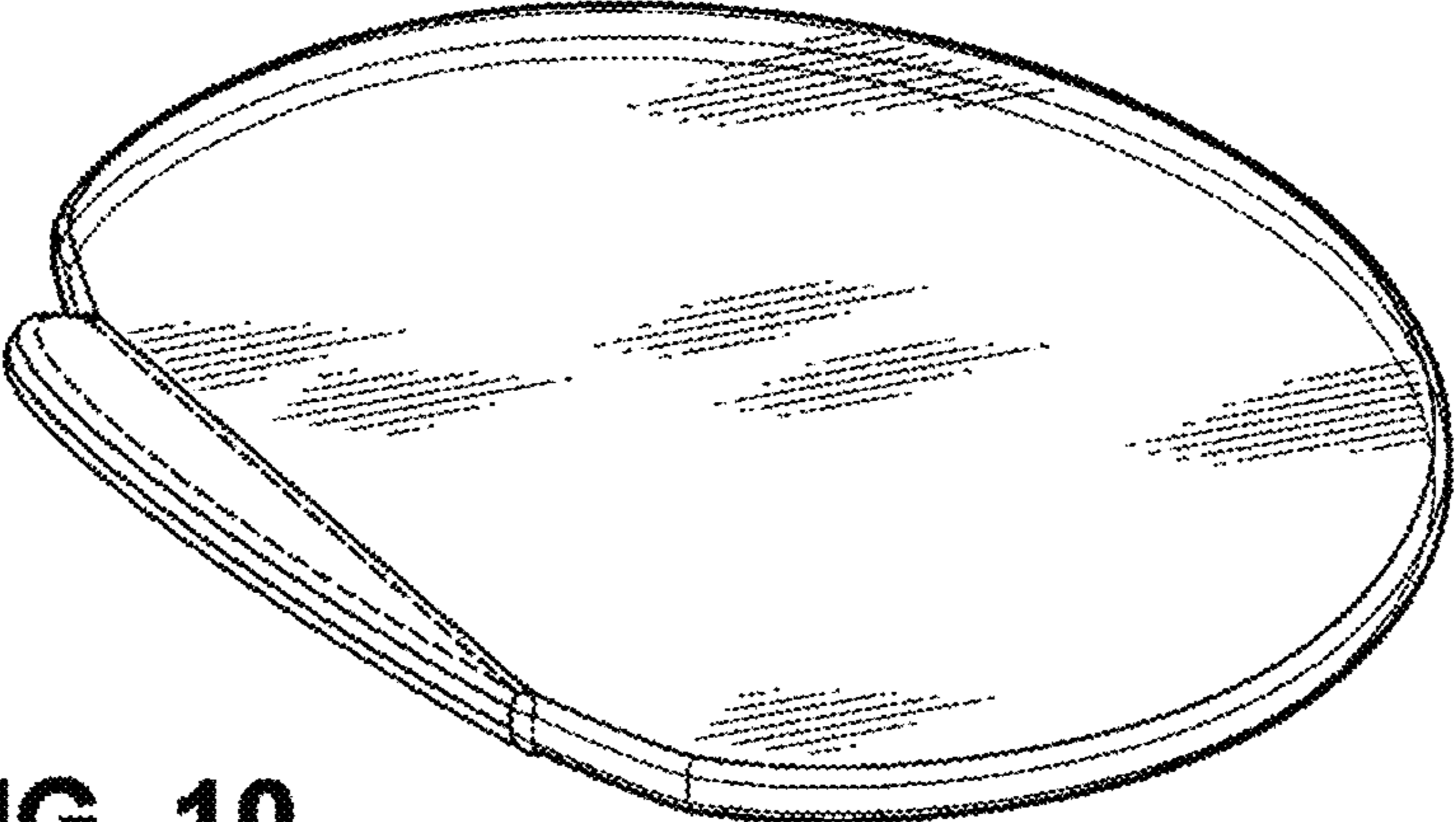
