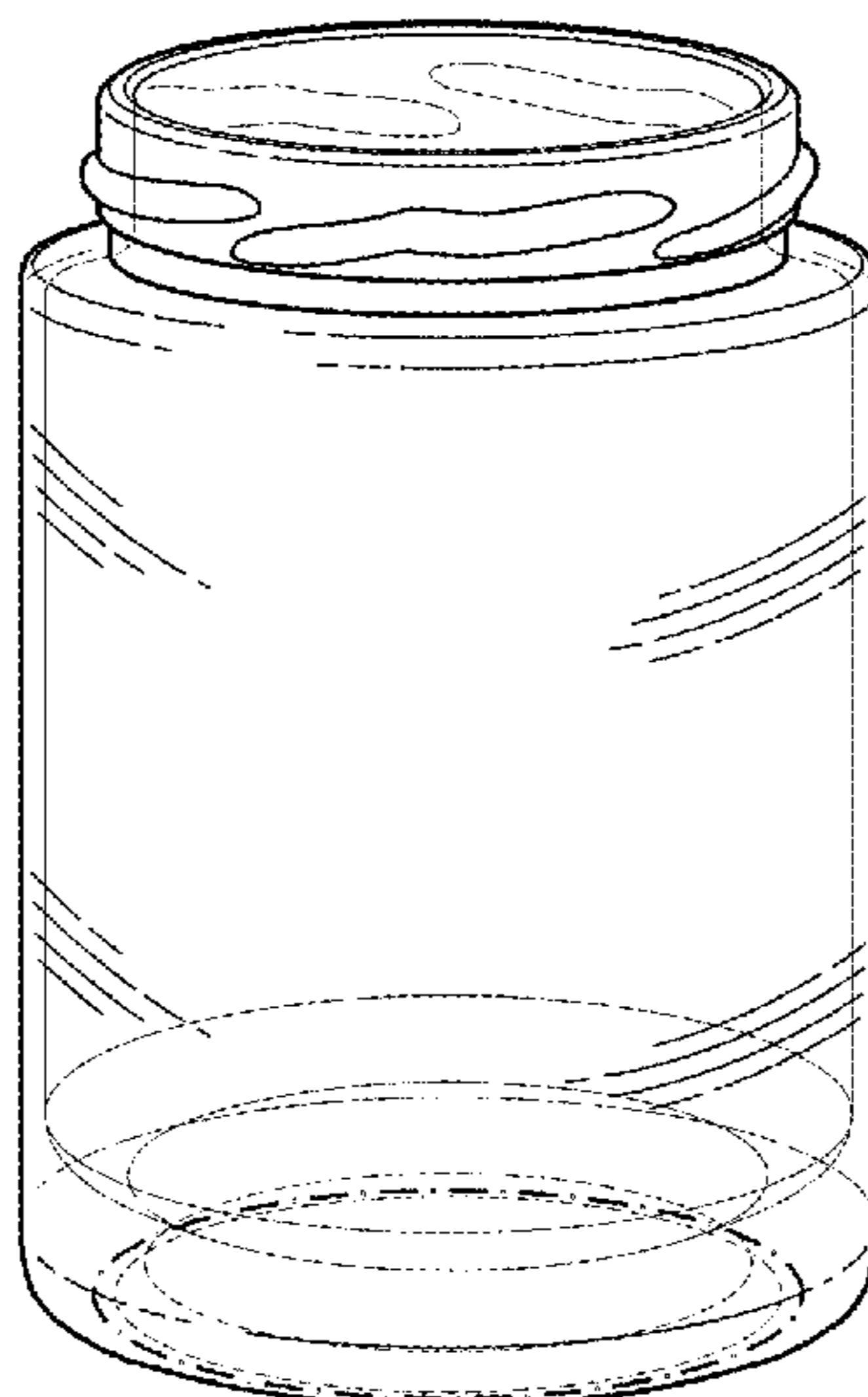
(57) **CLAIM**

The ornamental design for a container, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a container in accordance with our new claimed design.  
FIG. 2 is a front side view of the container in FIG. 1.  
FIG. 3 is a right side view of the container in FIG. 1.  
FIG. 4 is a rear side view of the container in FIG. 1.  
FIG. 5 is a left side view of the container in FIG. 1.  
FIG. 6 is a top view of the container in FIG. 1; and, FIG. 7 is a bottom view of the container in FIG. 1.  
The dash-dash-dash broken lines show the portions of the container that are not part of the claimed design.  
Dash-dot-dash broken lines shown in the drawings represent boundaries of the claimed design and are not part of the claimed design.

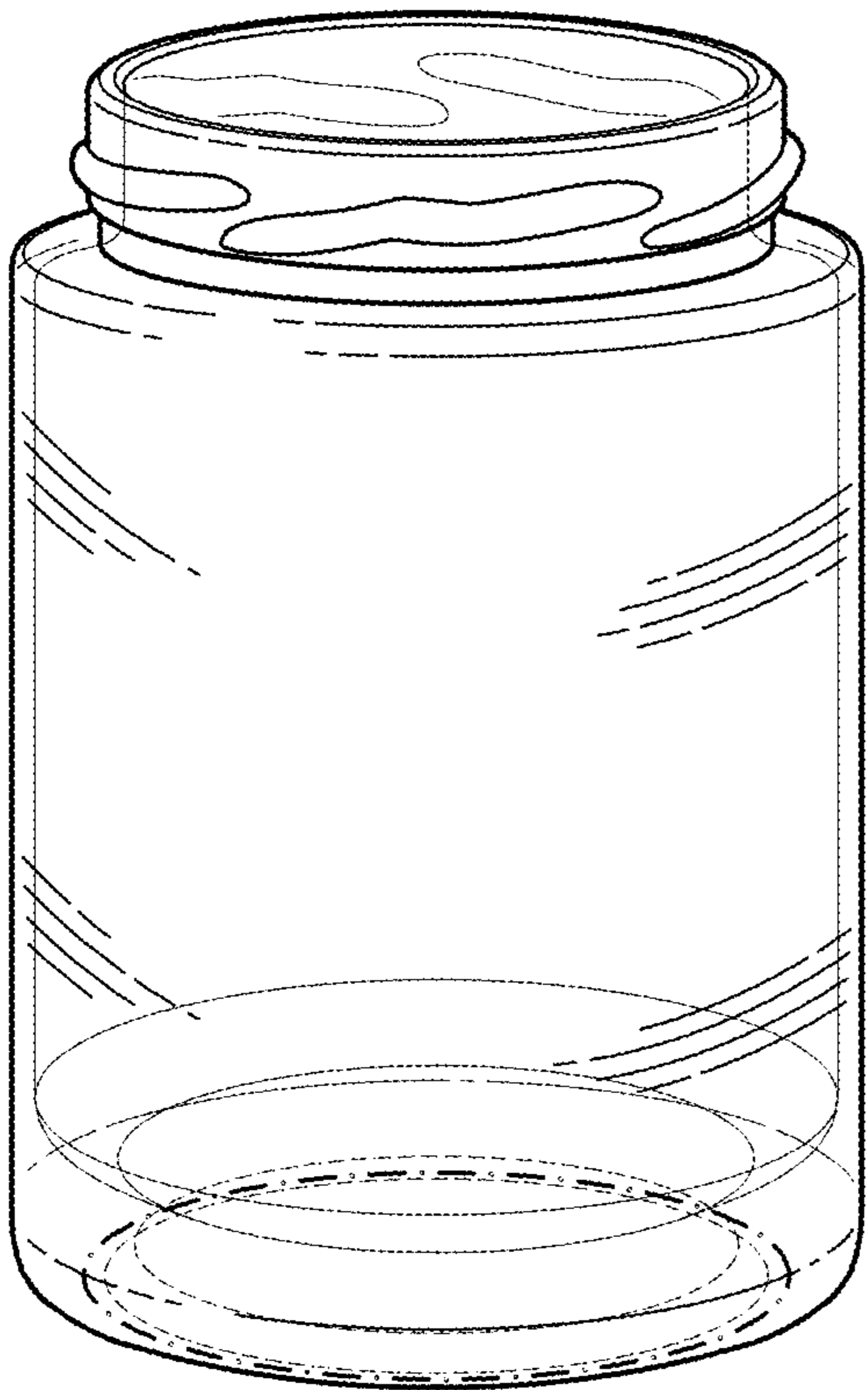

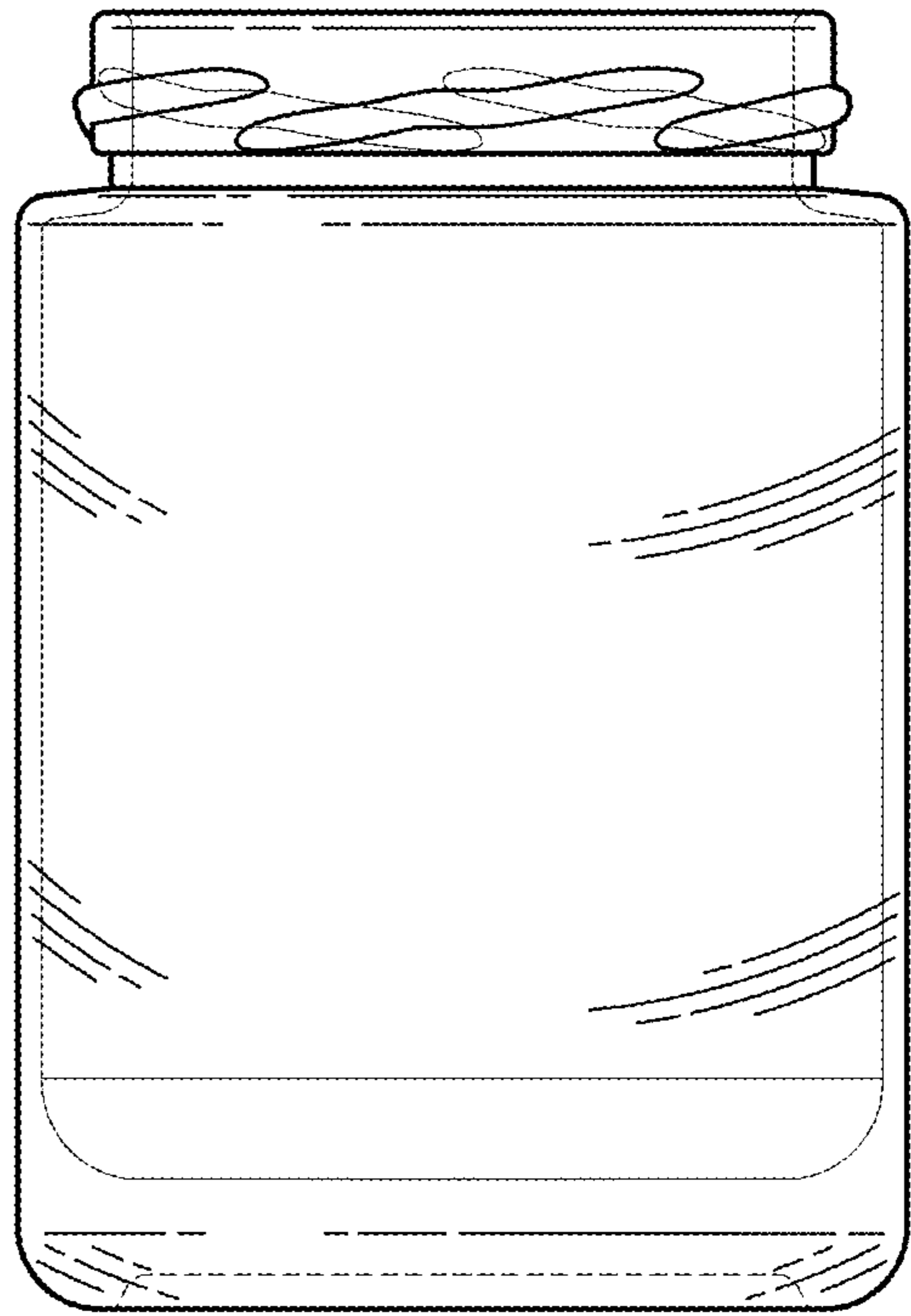

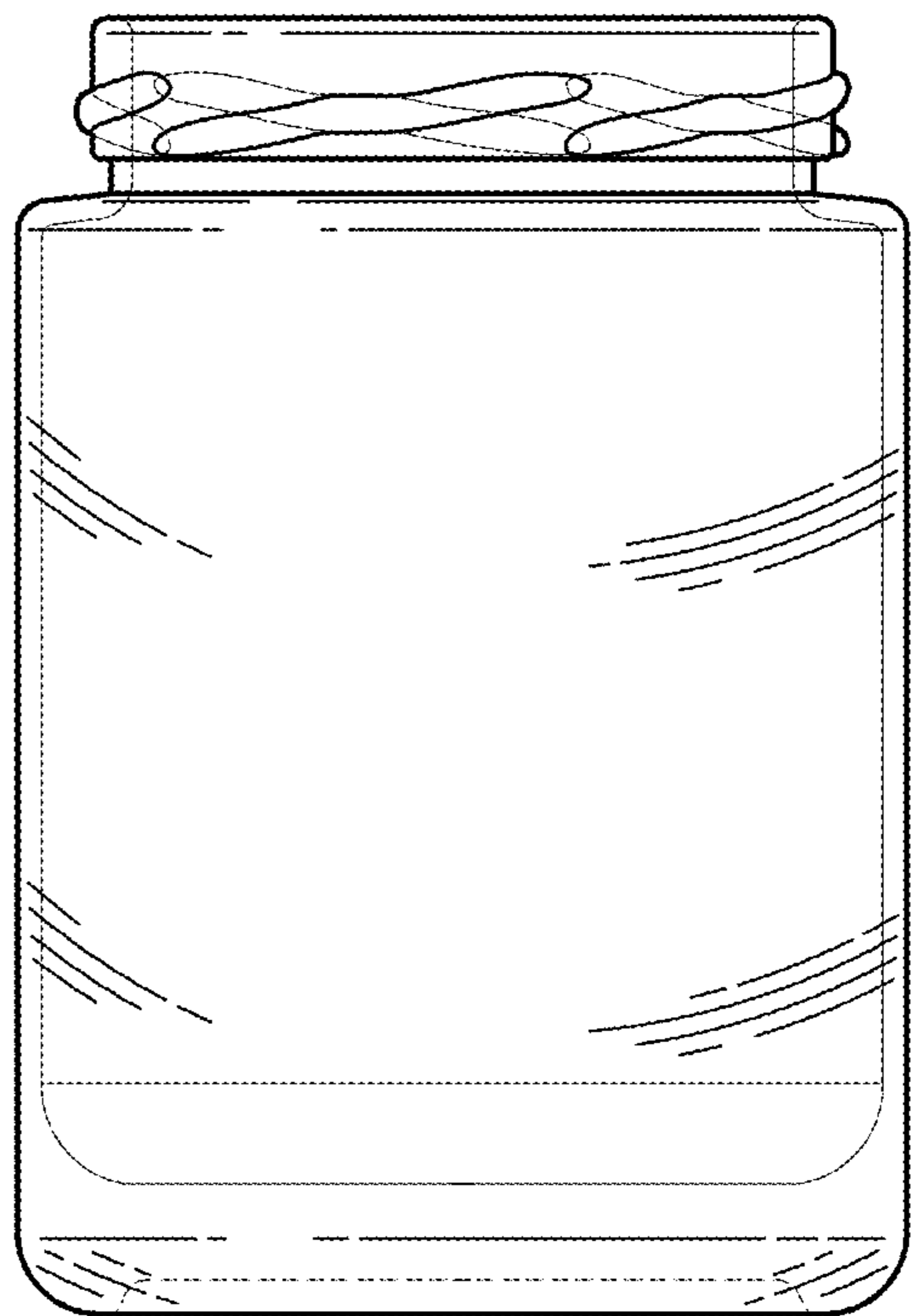

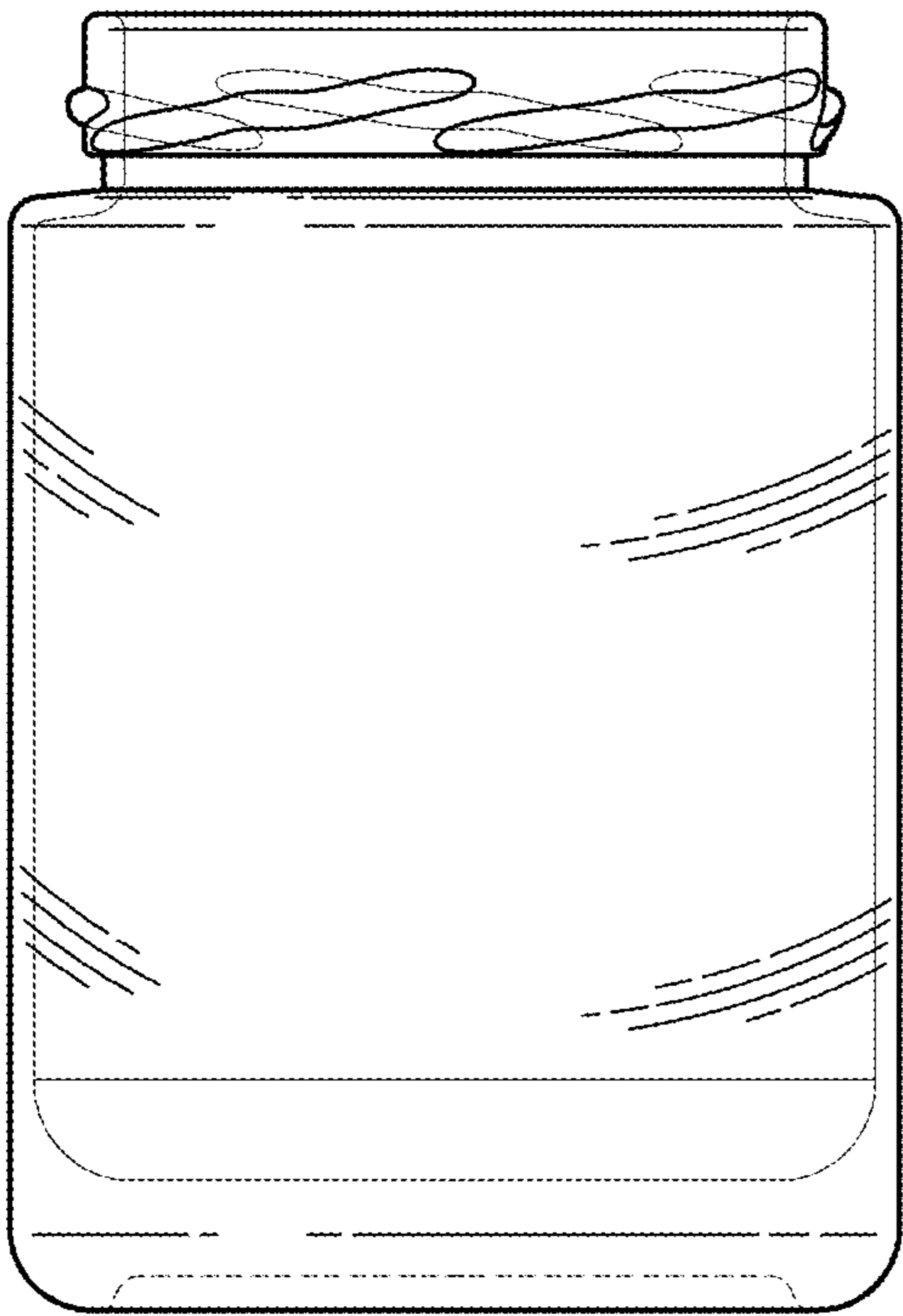

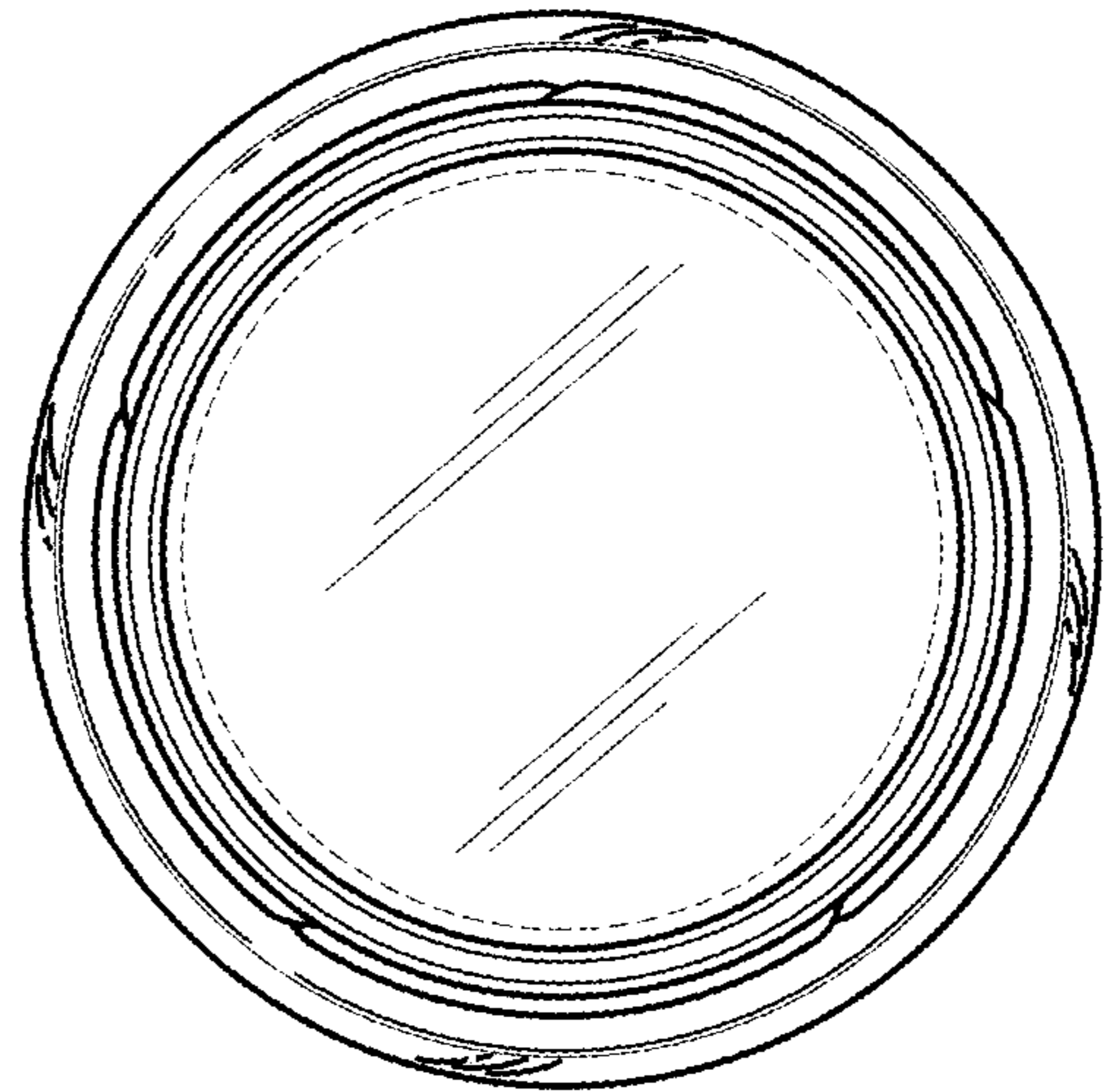

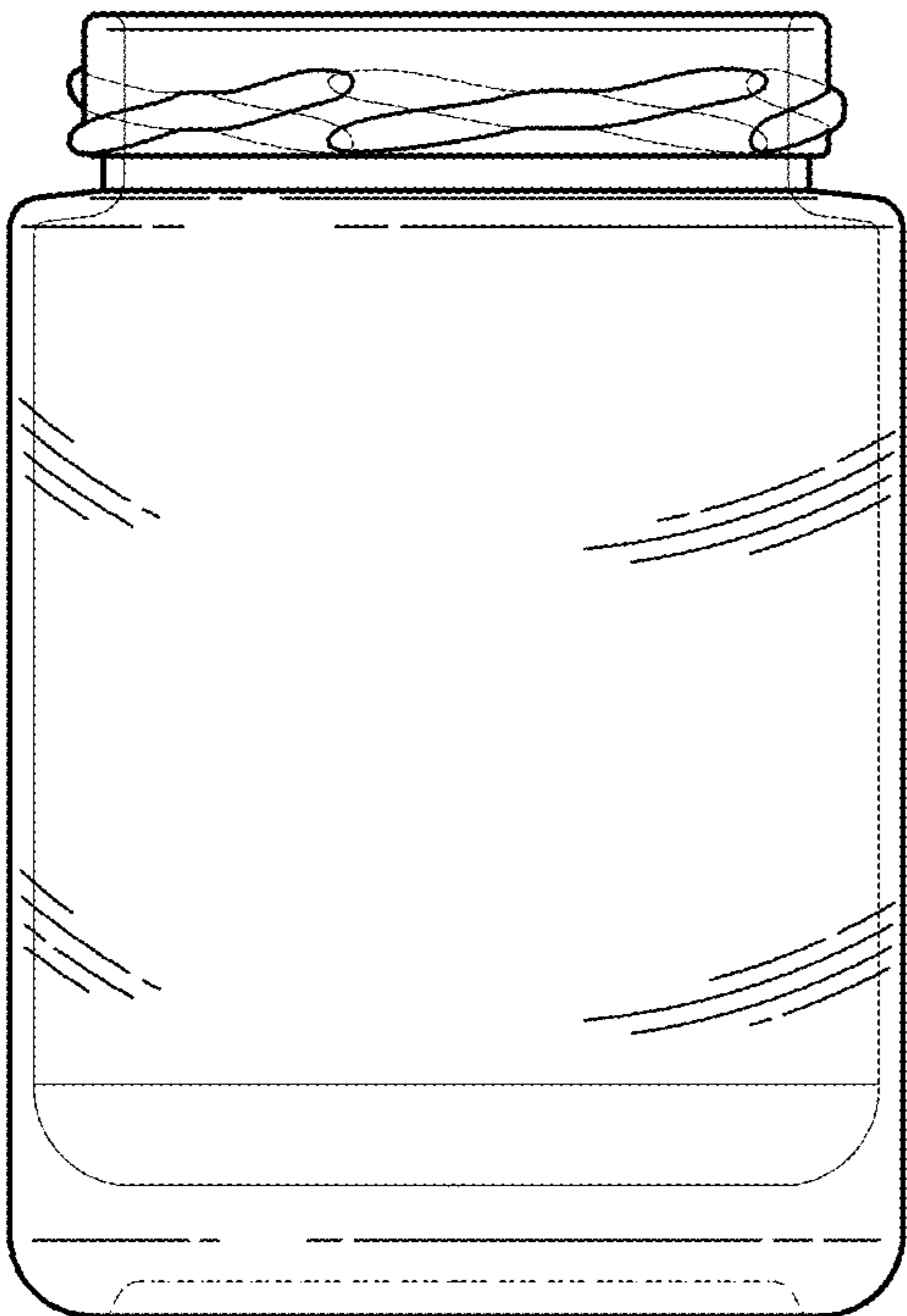

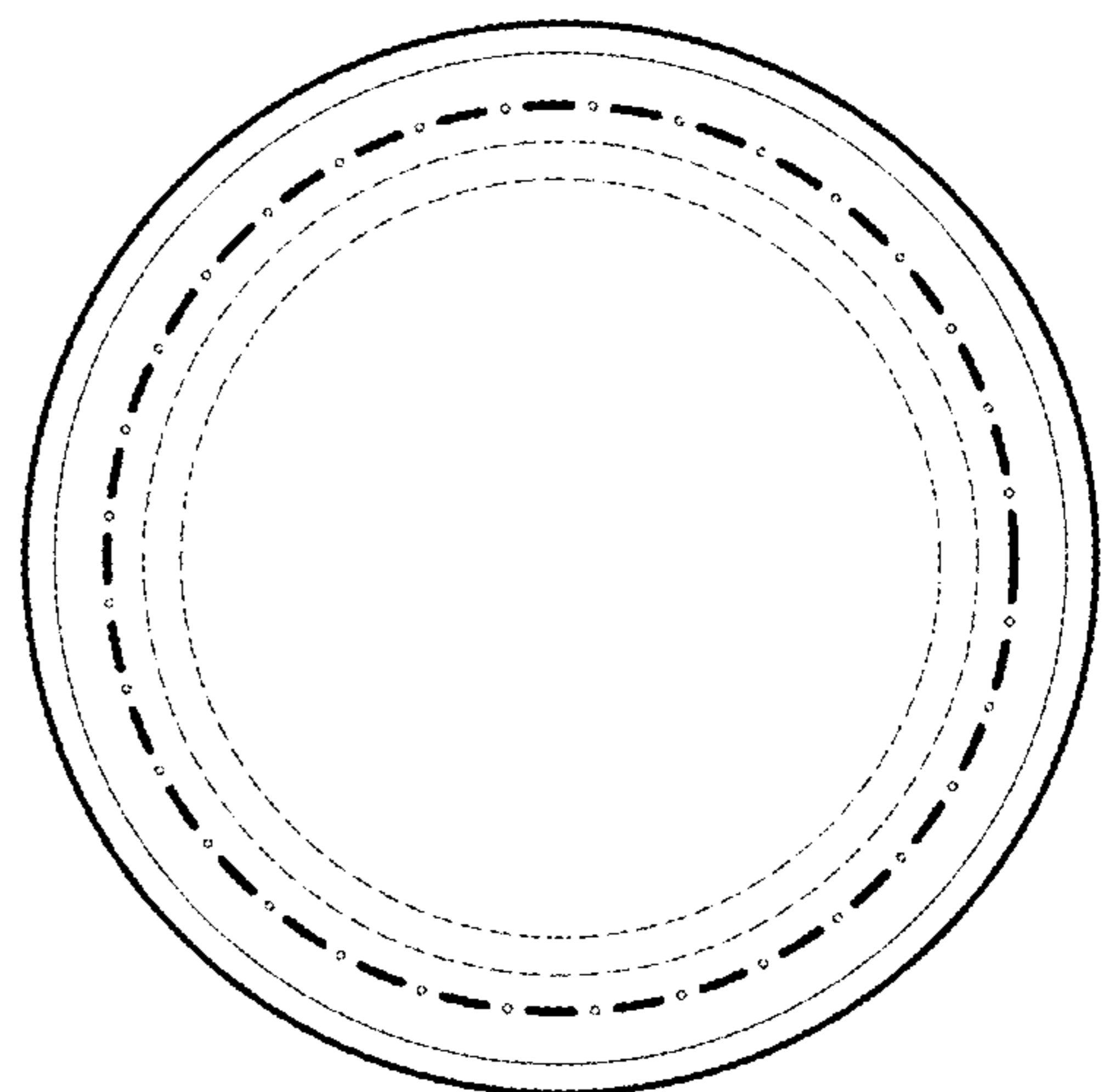
